DESCRIPTION

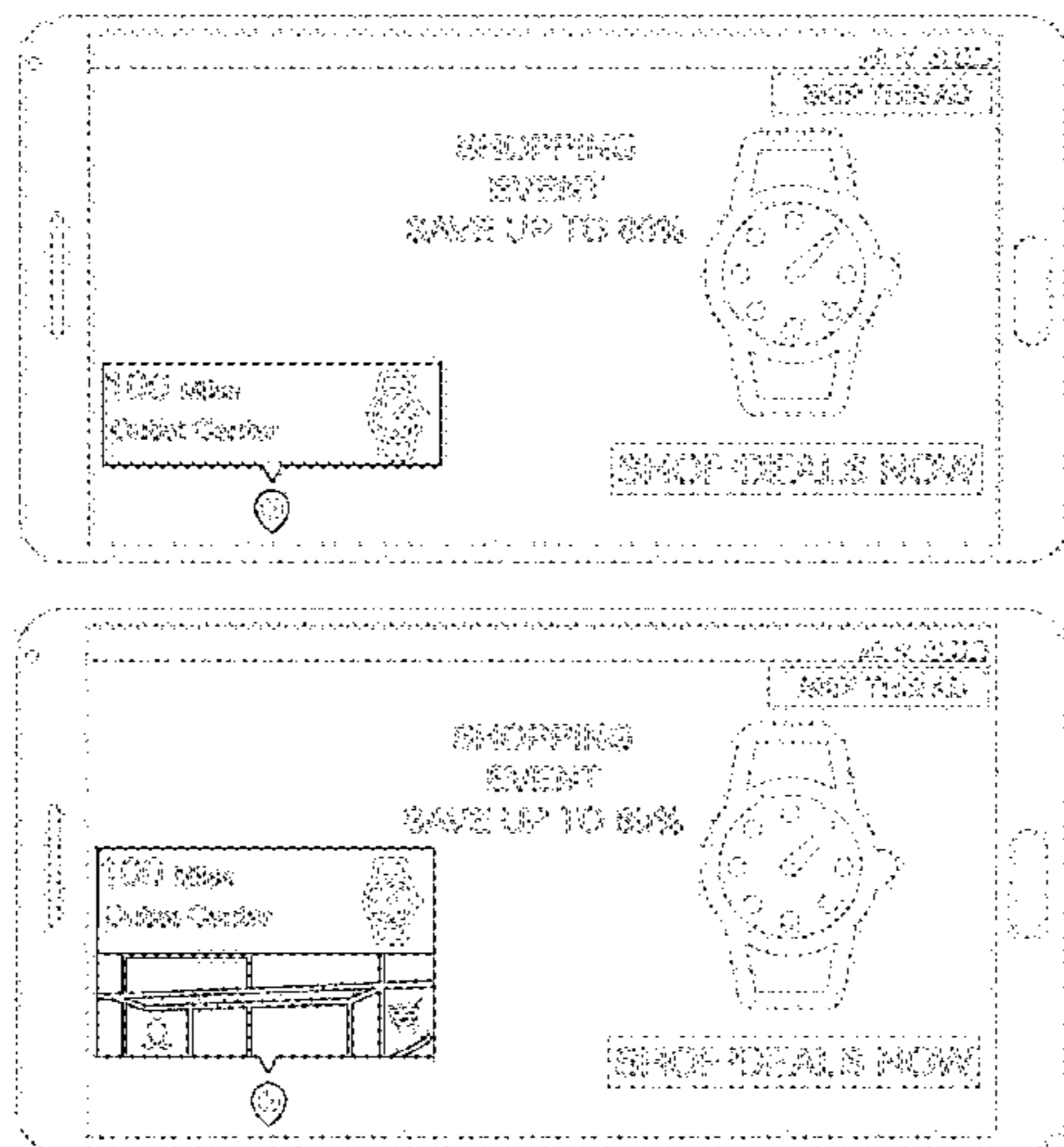
FIG. 1 is a front view of a display screen with animated graphical user interface showing our new design; and, FIG. 2 is a front view of a second image thereof. The appearance of the transitional image sequentially transitions between the images shown in FIGS. 1 and 2. The process or period in which one image transitions to another image forms no part of the claimed design. The broken lines showing a display screen, text, and portions of the graphical user interface illustrate portions of the article, and form no part of the claimed design. The device shown in broken lines illustrates environmental subject matter, and forms no part of the broken lines.

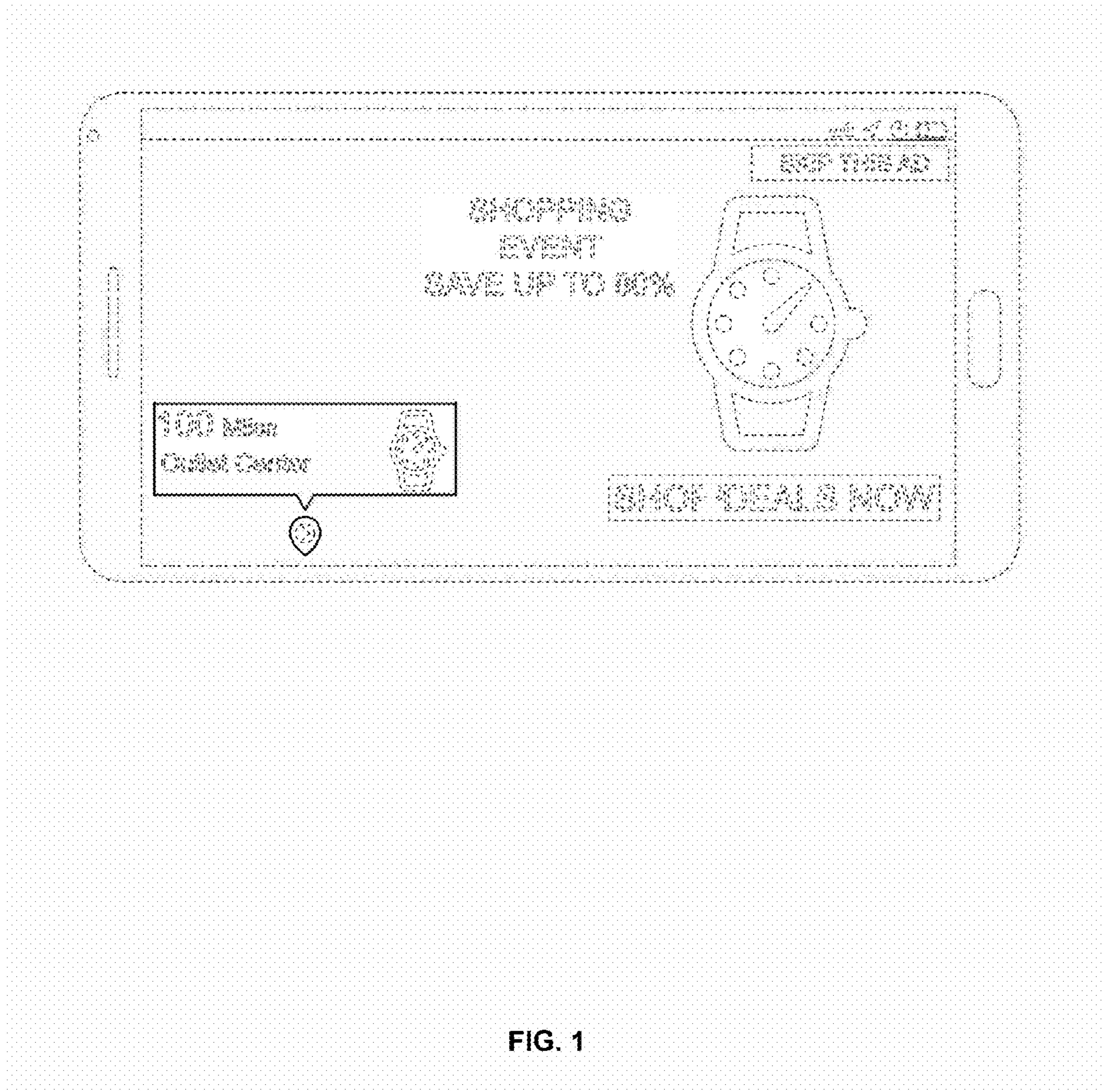

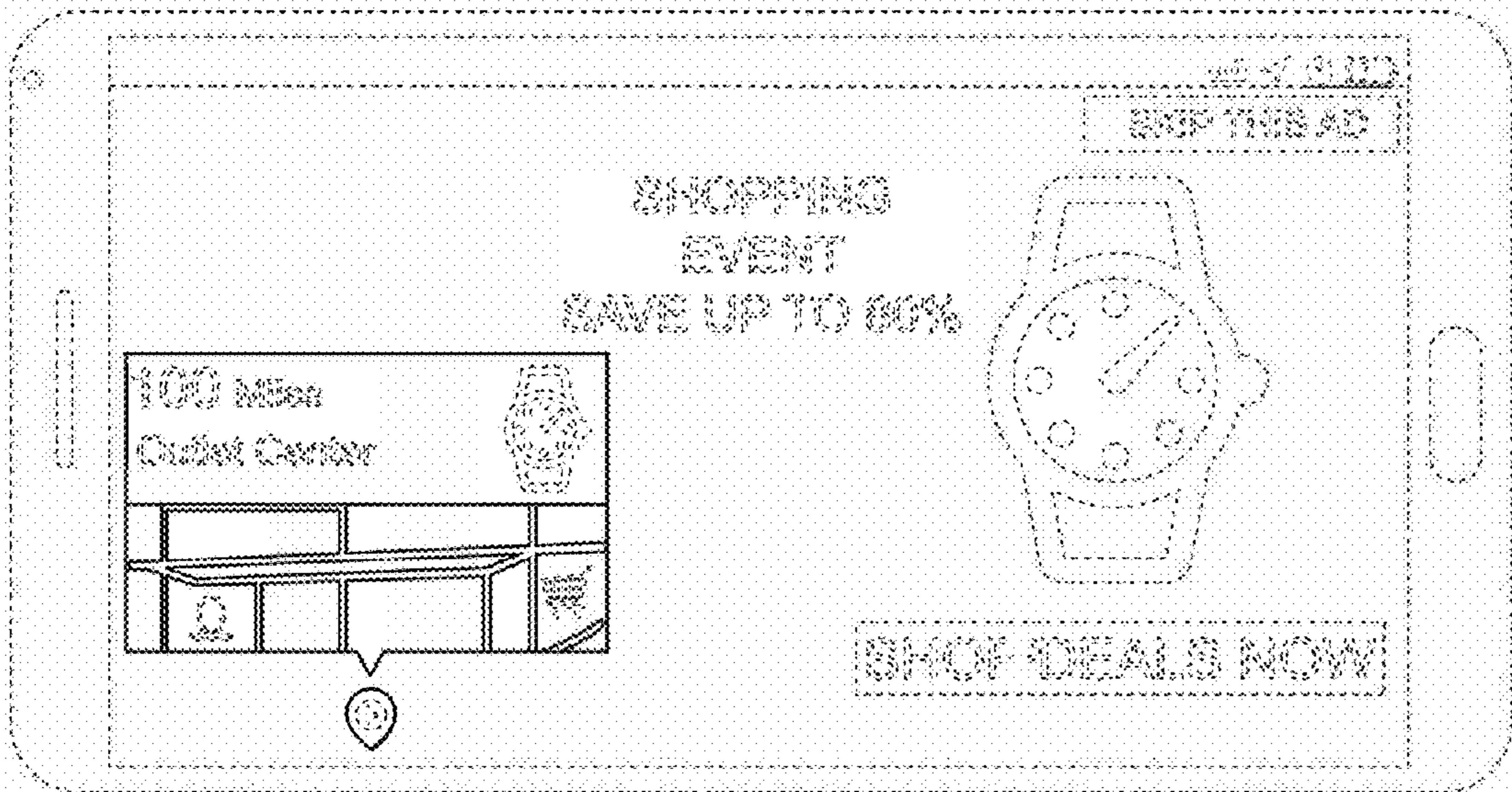
