FIG. 3 is a left side view thereof.

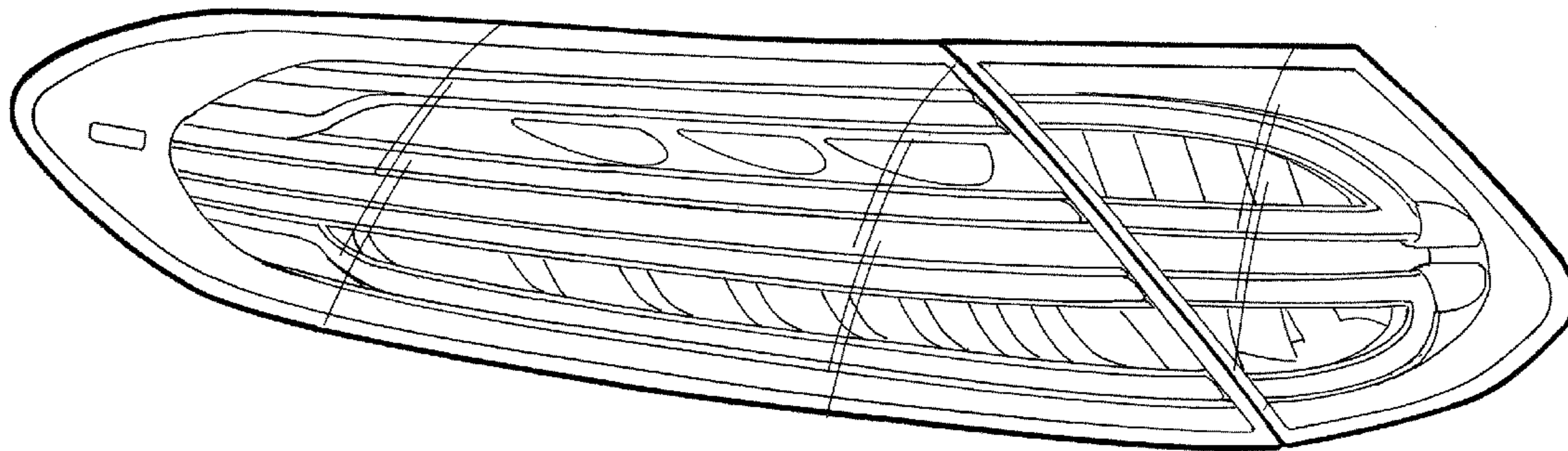
FIG. 4 is a right perspective view of a second embodiment of the taillight for a vehicle according to the design;

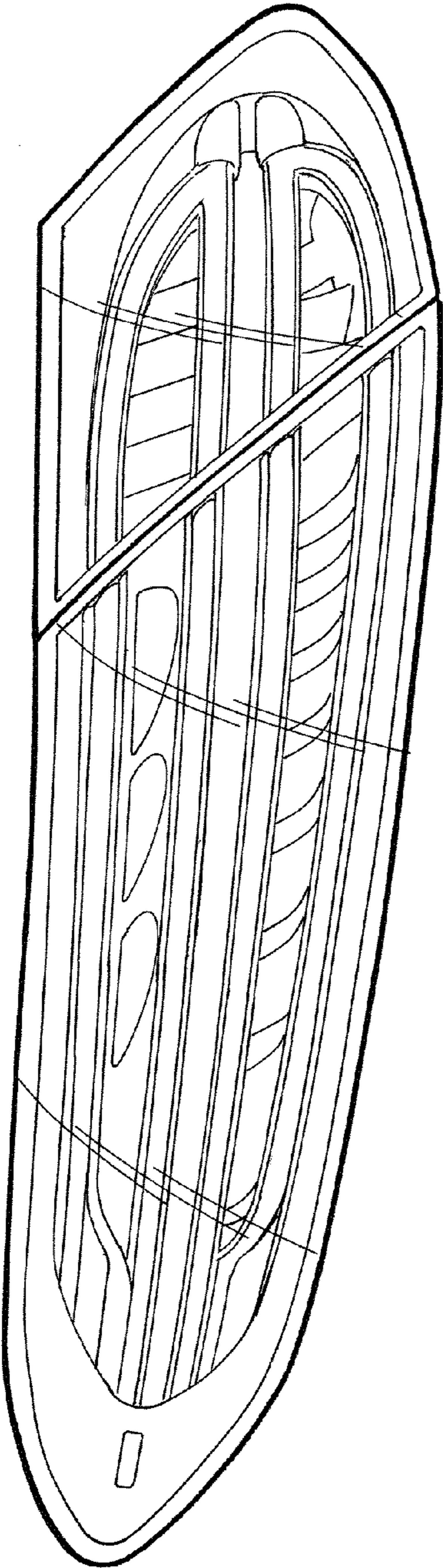

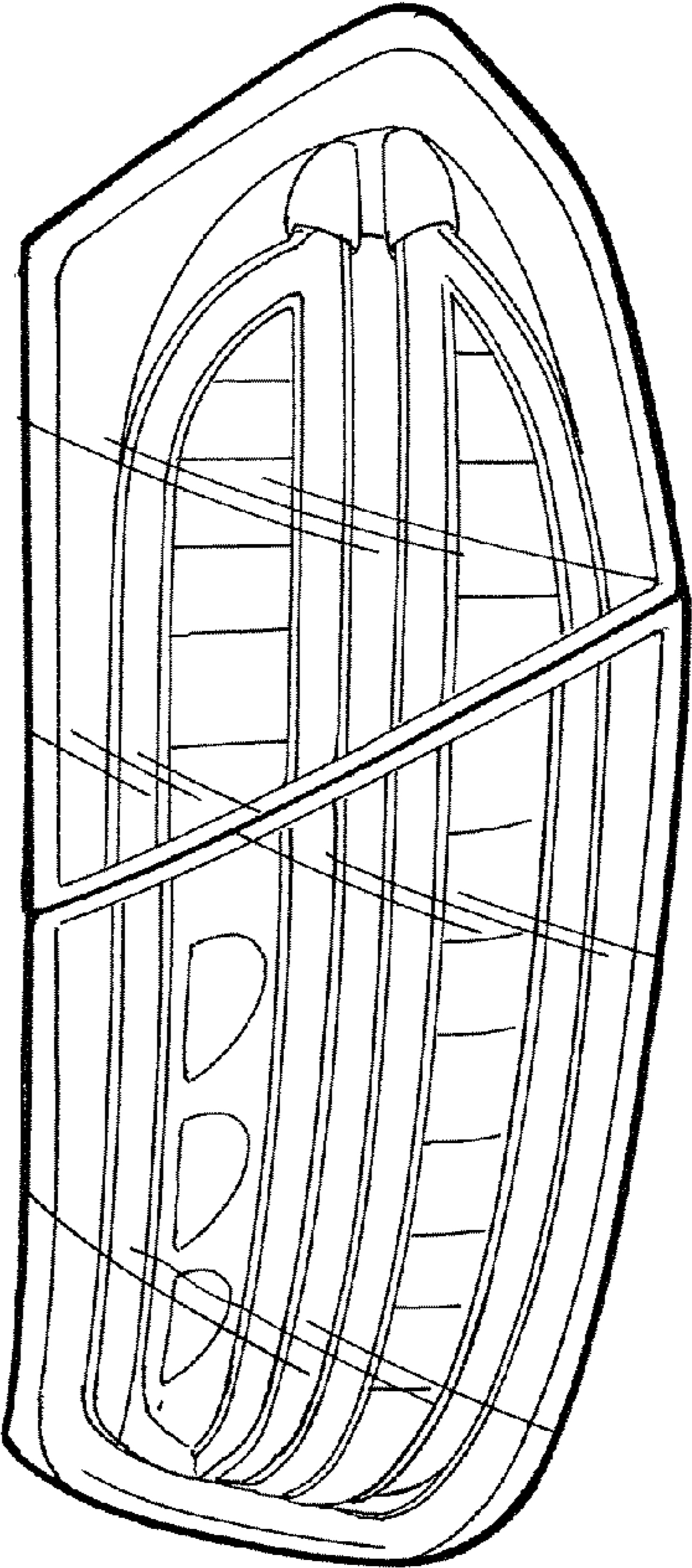

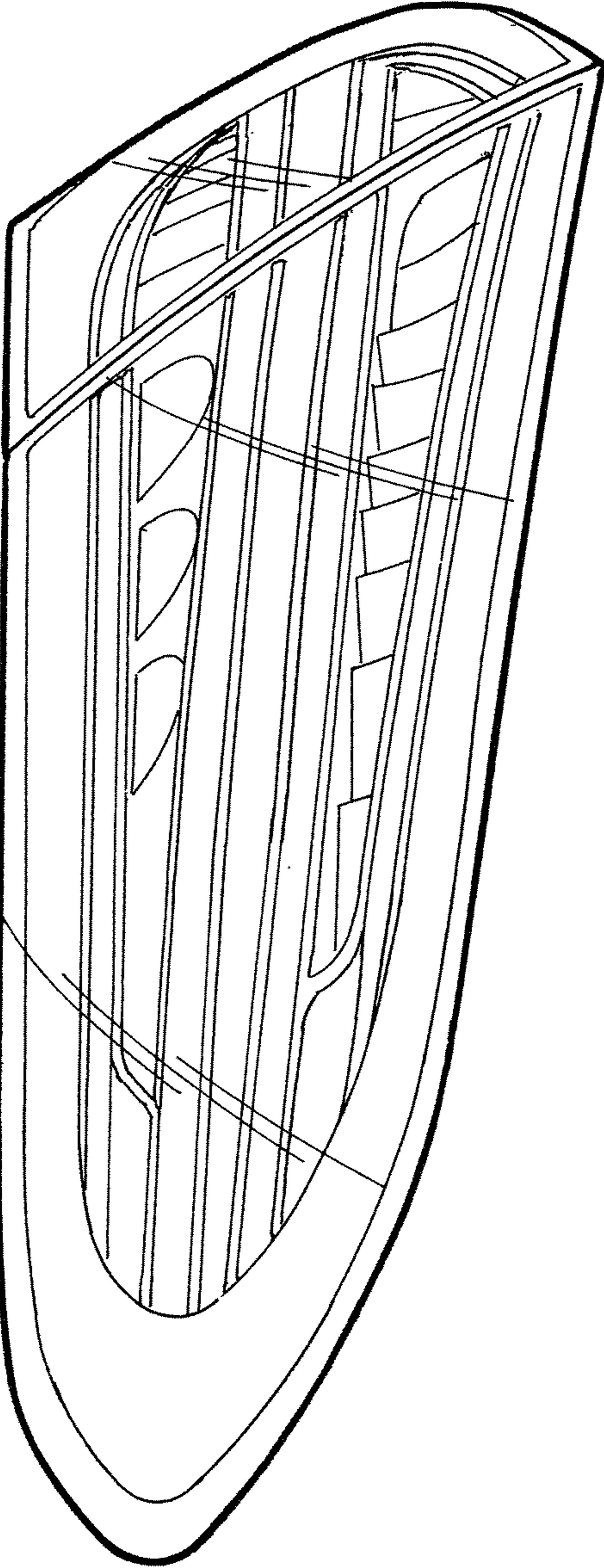

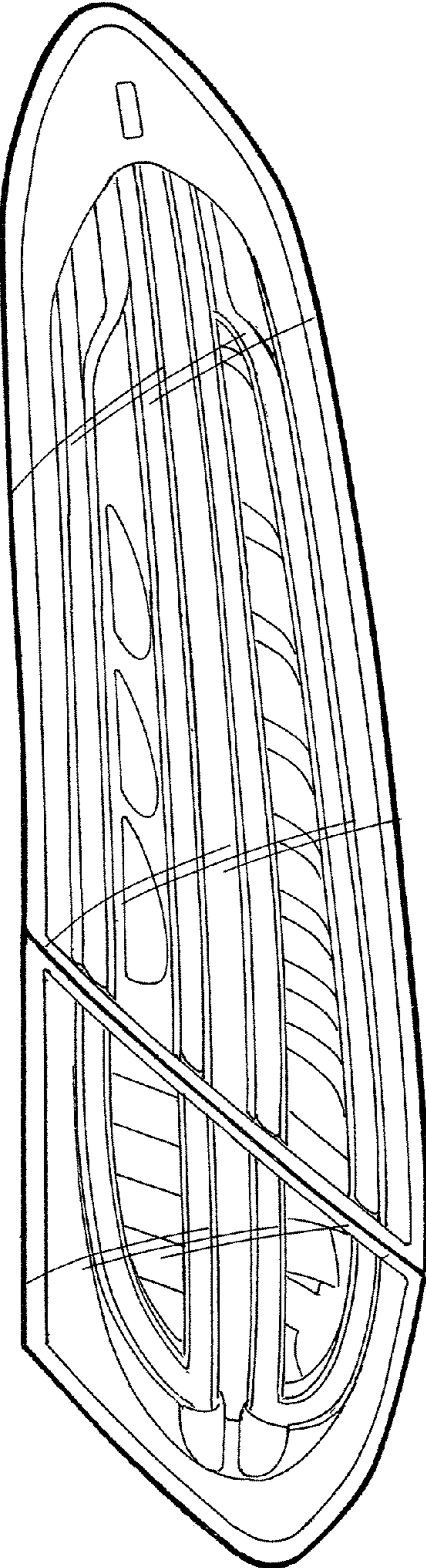

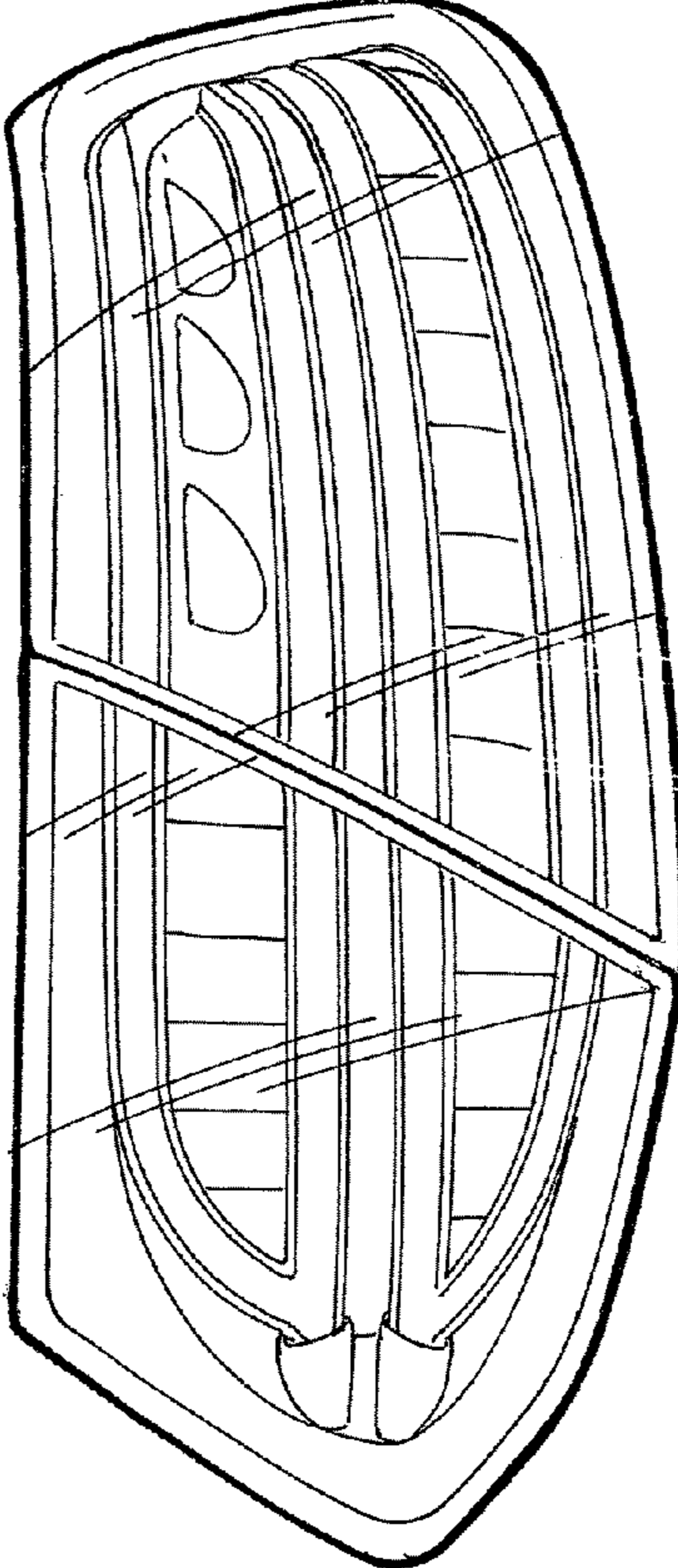
