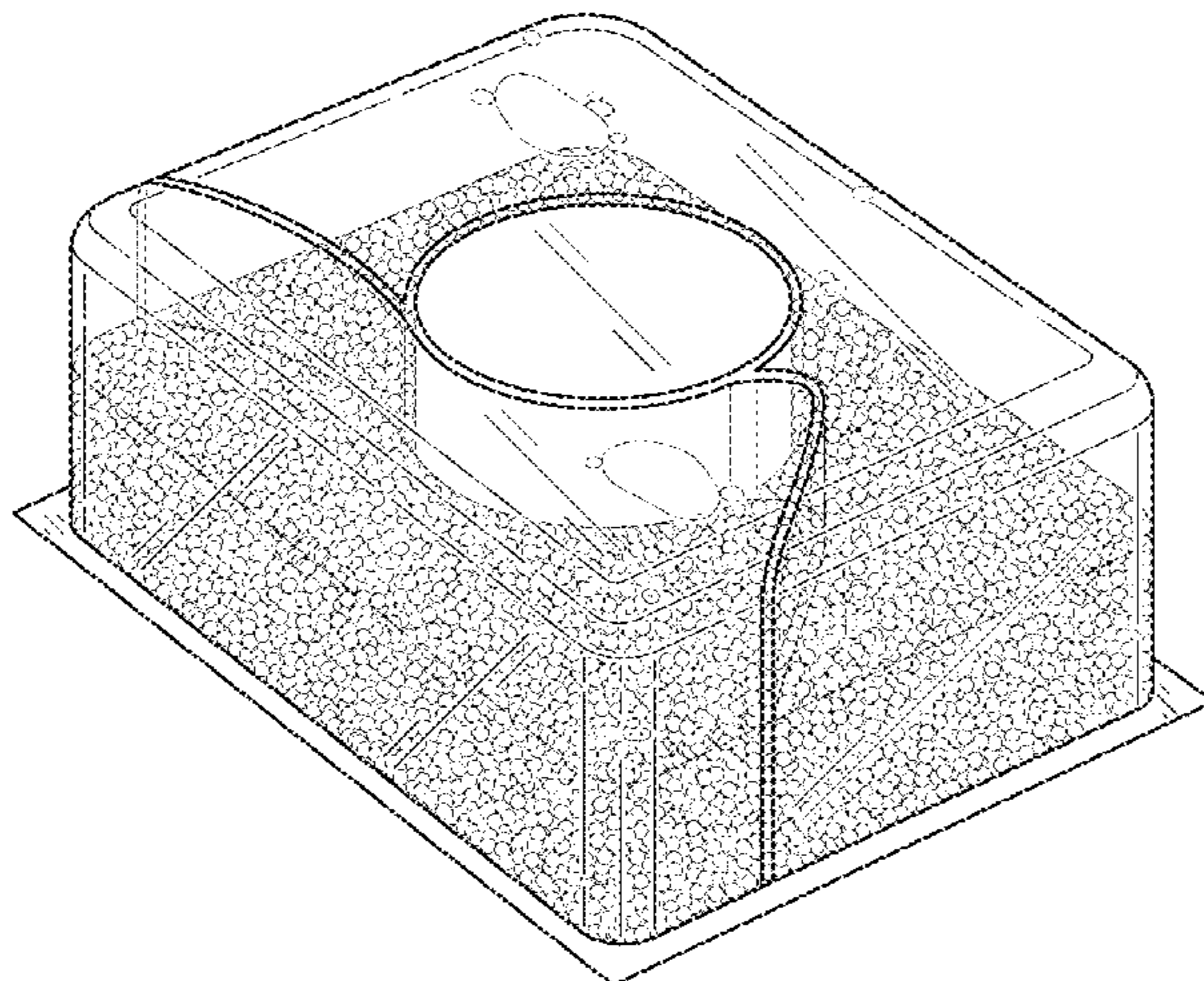
(57) **CLAIM**

DESCRIPTION

FIG. 1 is an isometric view of a capsule containing washing products of the present invention;
FIG. 2 is a front view of the capsule containing washing products of FIG. 1;

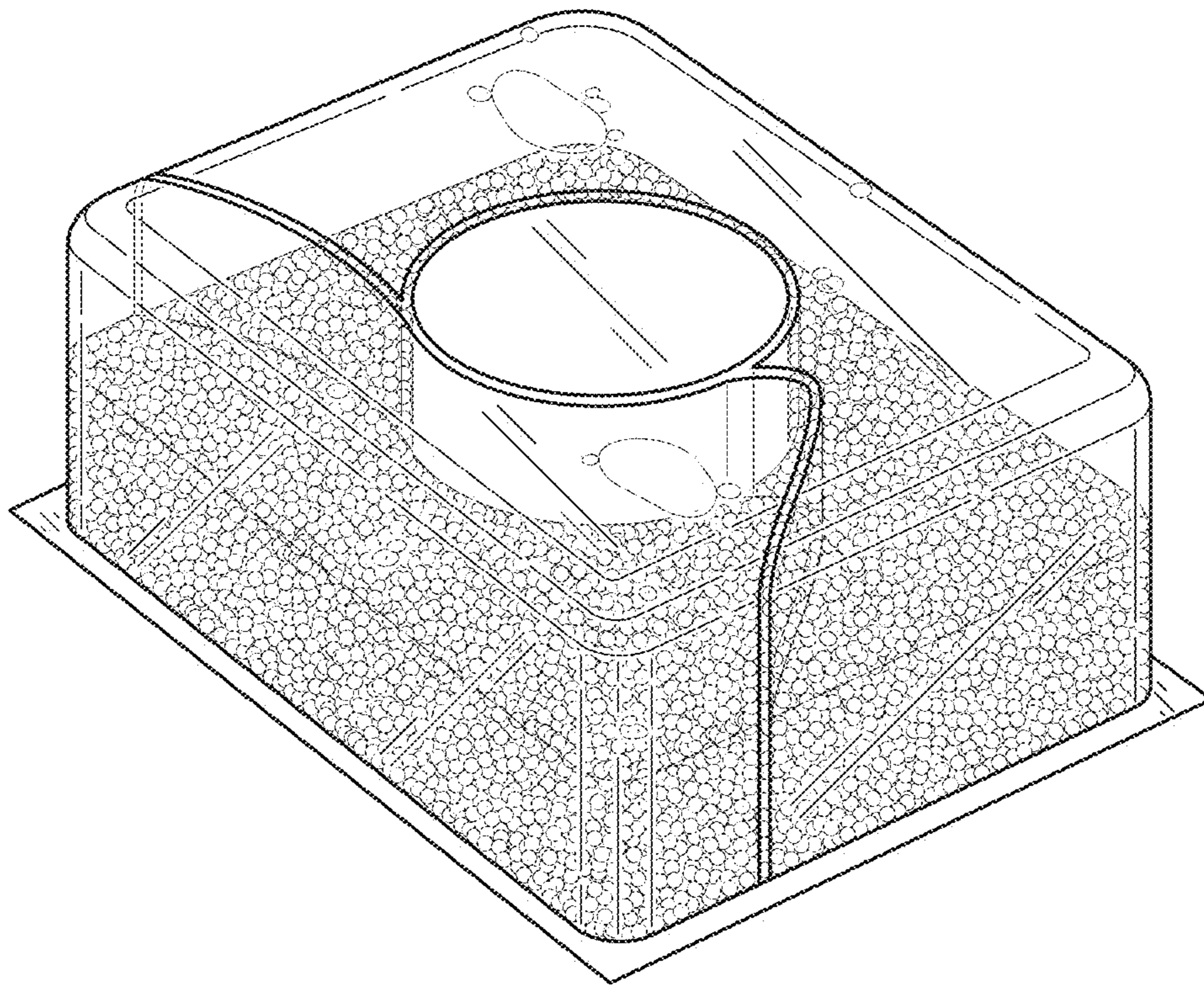

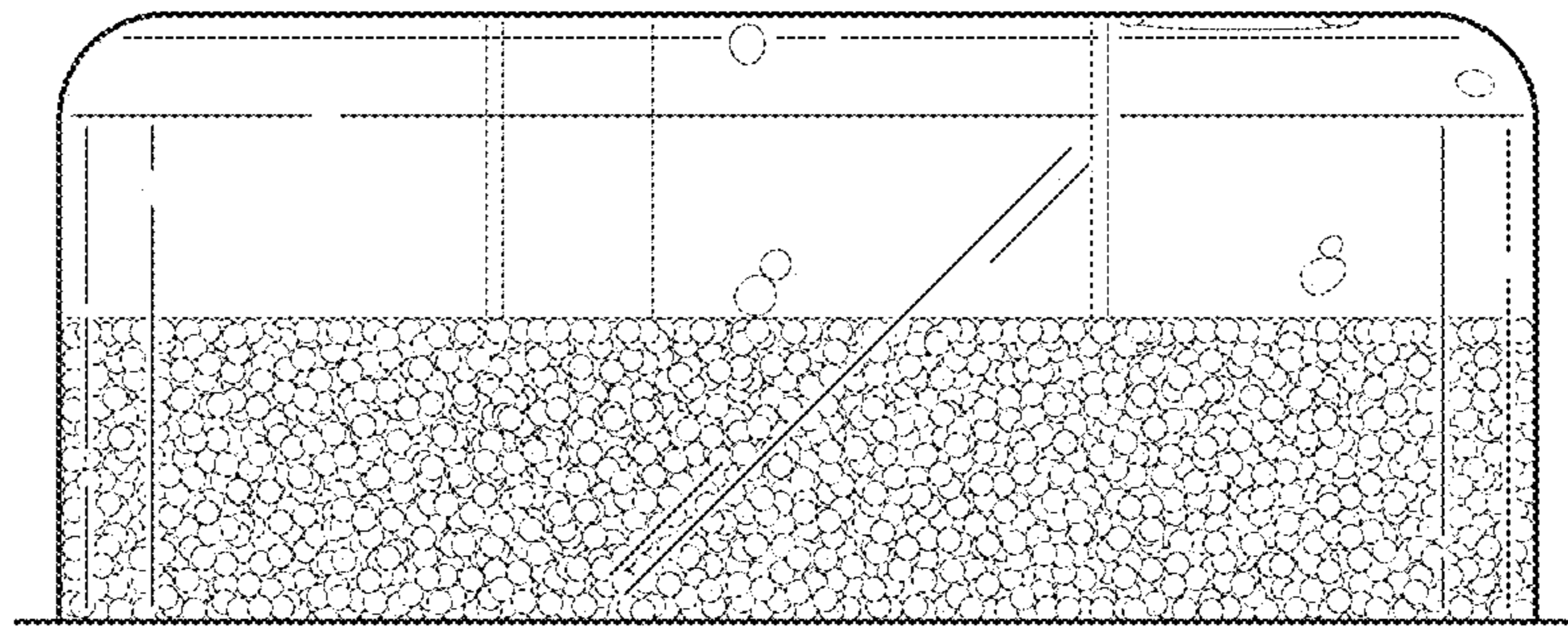

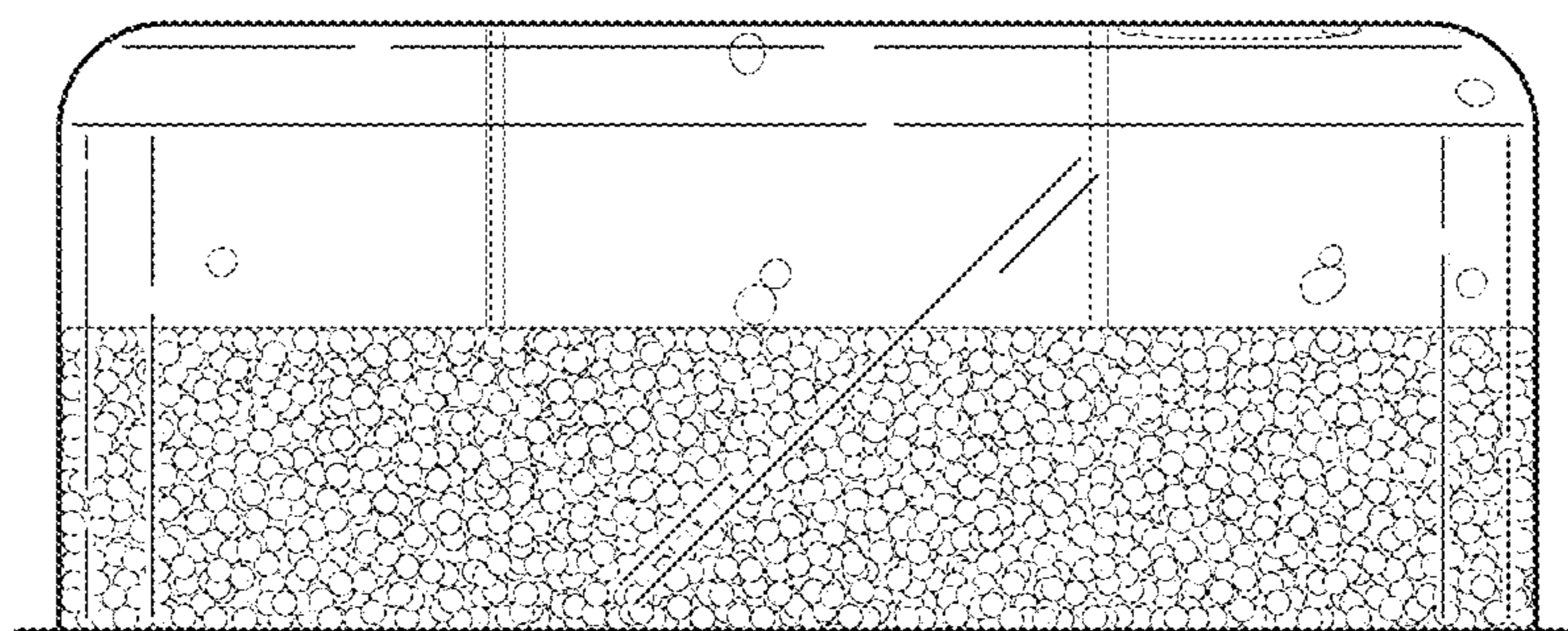

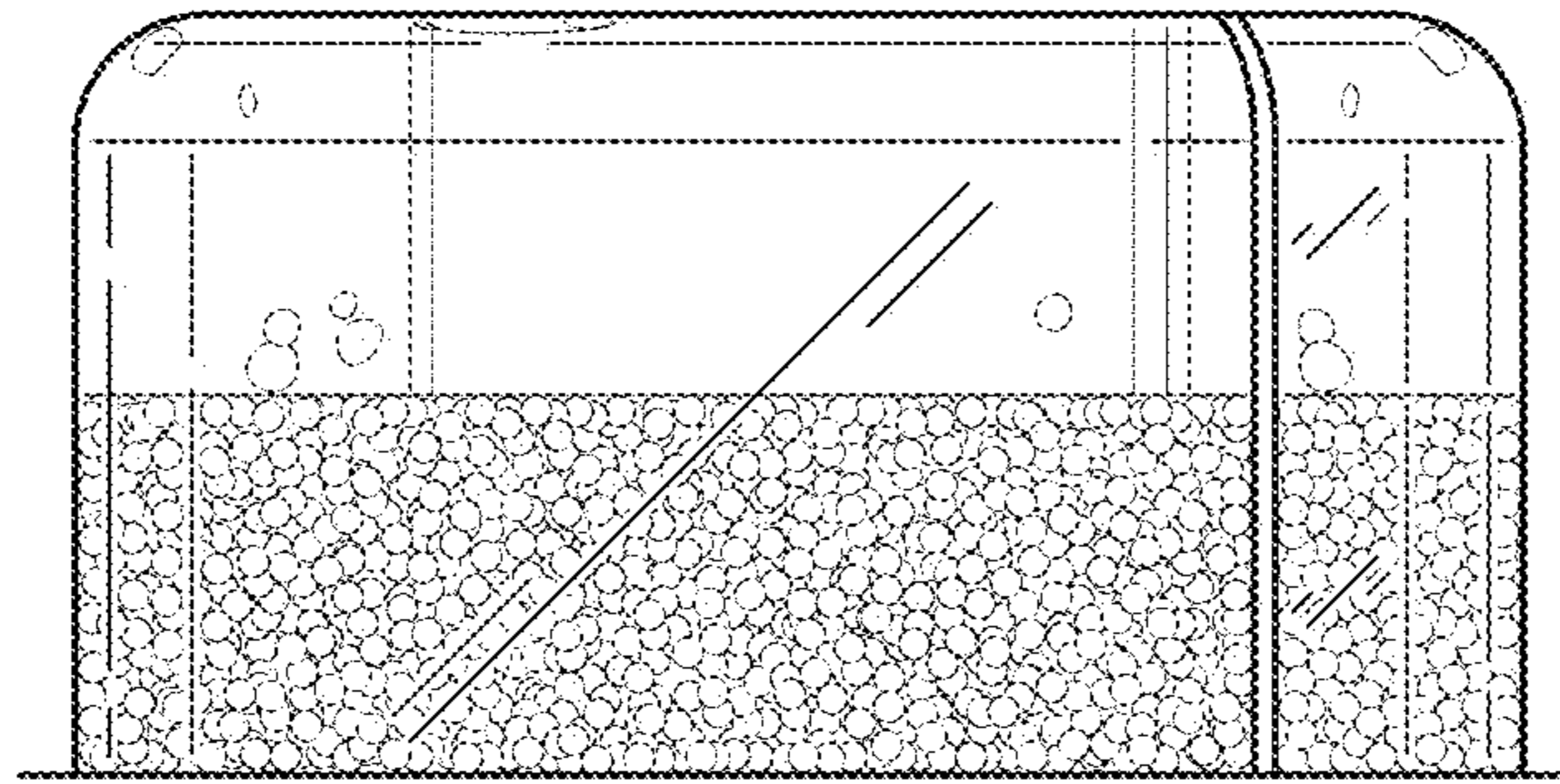

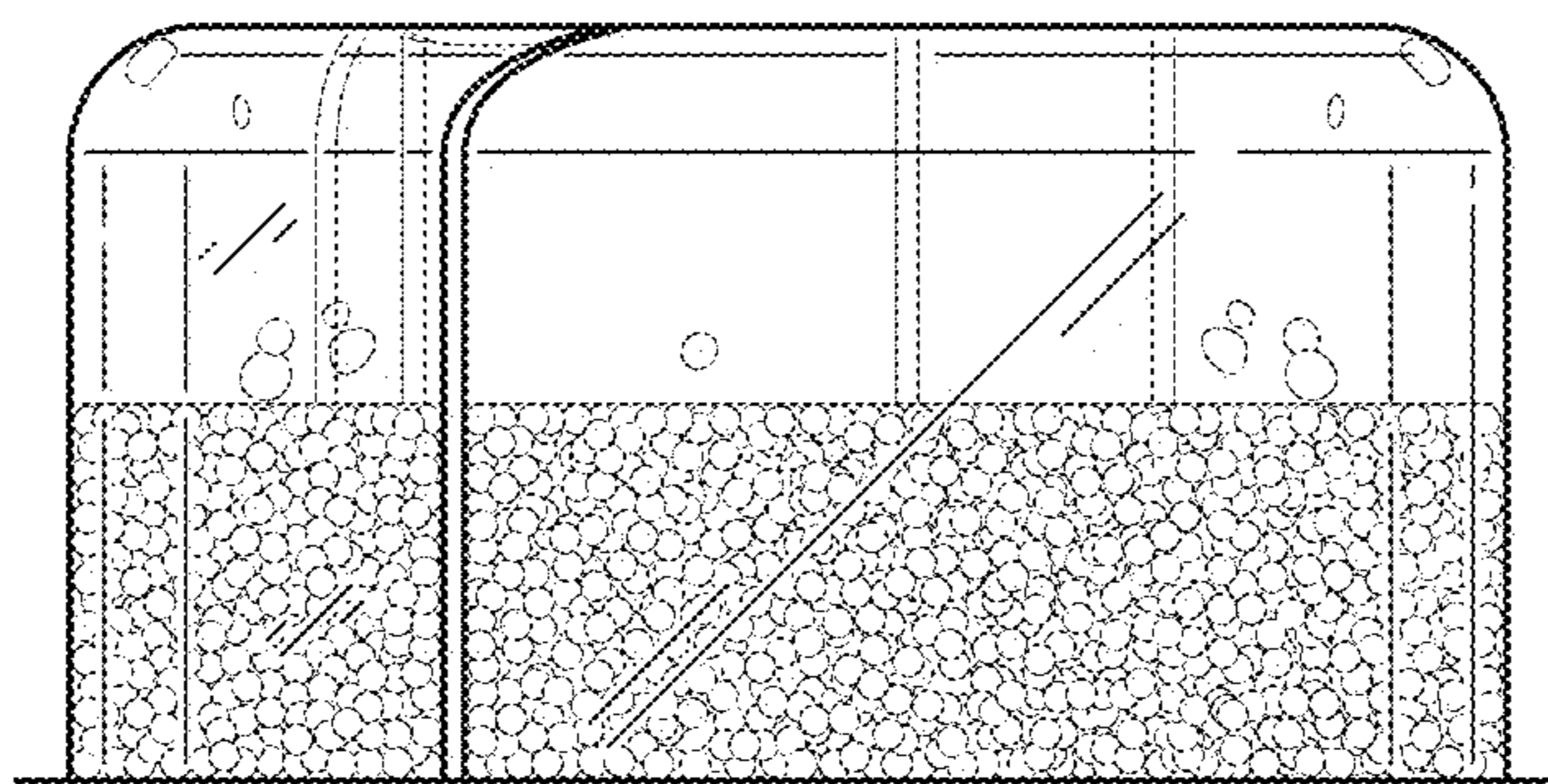

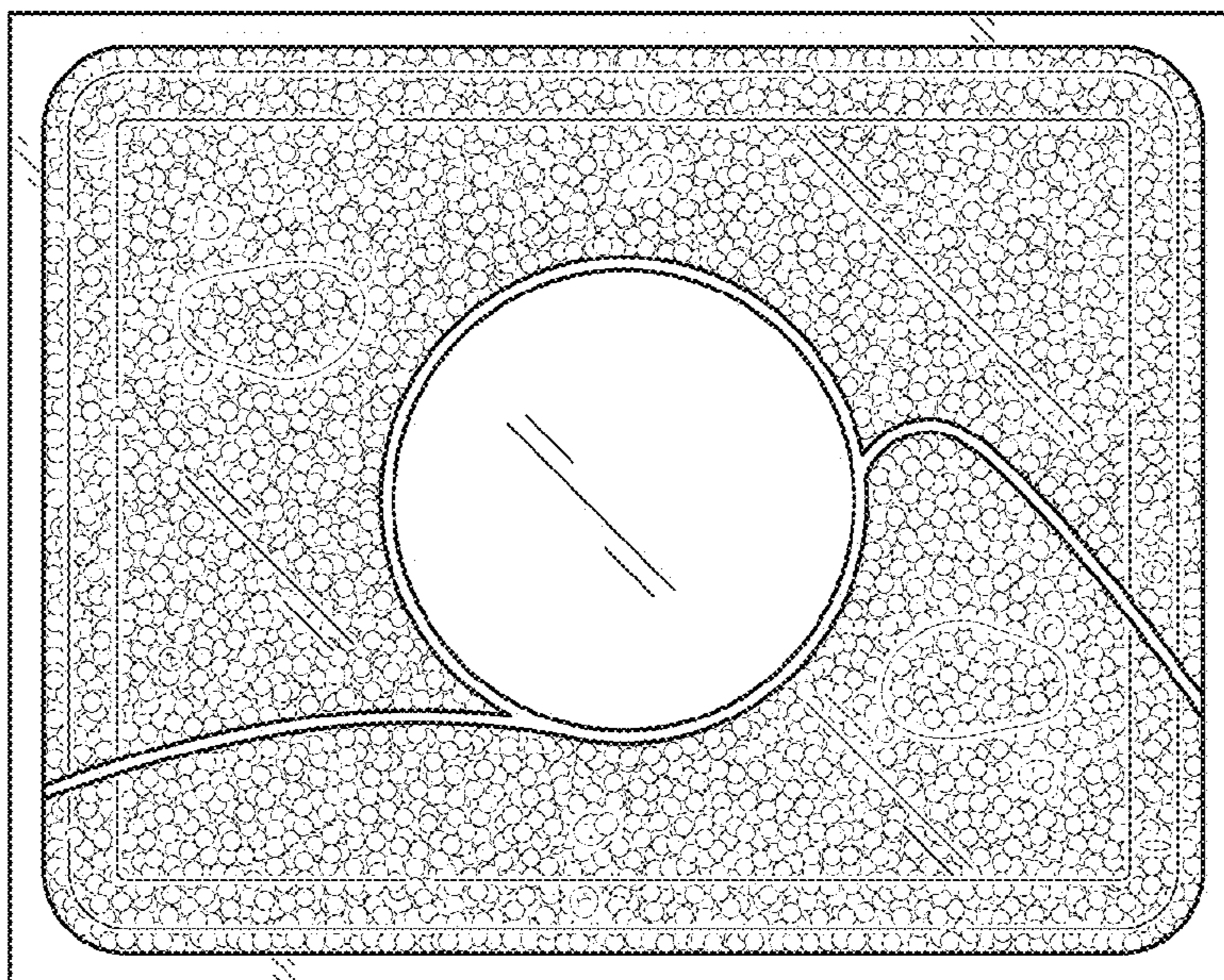

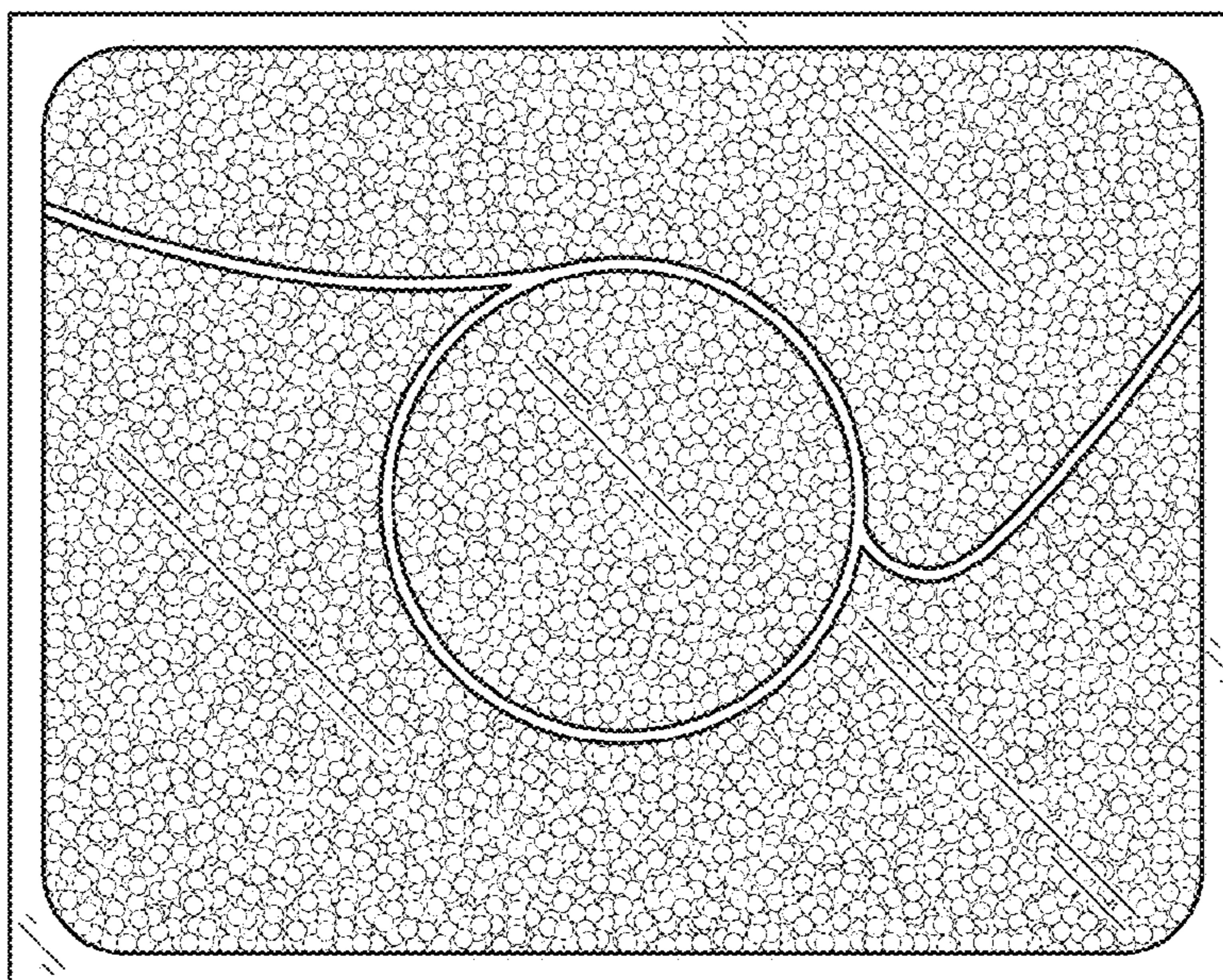
