(57) **CLAIM**

I claim the ornamental design for the expandable pouch combined with dog leash, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of an expandable pouch combined with dog leash showing my new design.

FIG. 2 is a rear perspective view thereof;

FIG. 3 is an enlarged partial detail view of my design of FIG. 1;

FIG. 4 is a front elevational view of FIG. 3;

FIG. 5 is a rear elevational view of FIG. 3; and,

FIG. 6 is a side perspective view of FIG. 3.

The structural features depicted by broken lines in the drawings have been shown for the purpose of illustrating portions of the expandable pouch combined with dog leash that form no part of the claimed design.

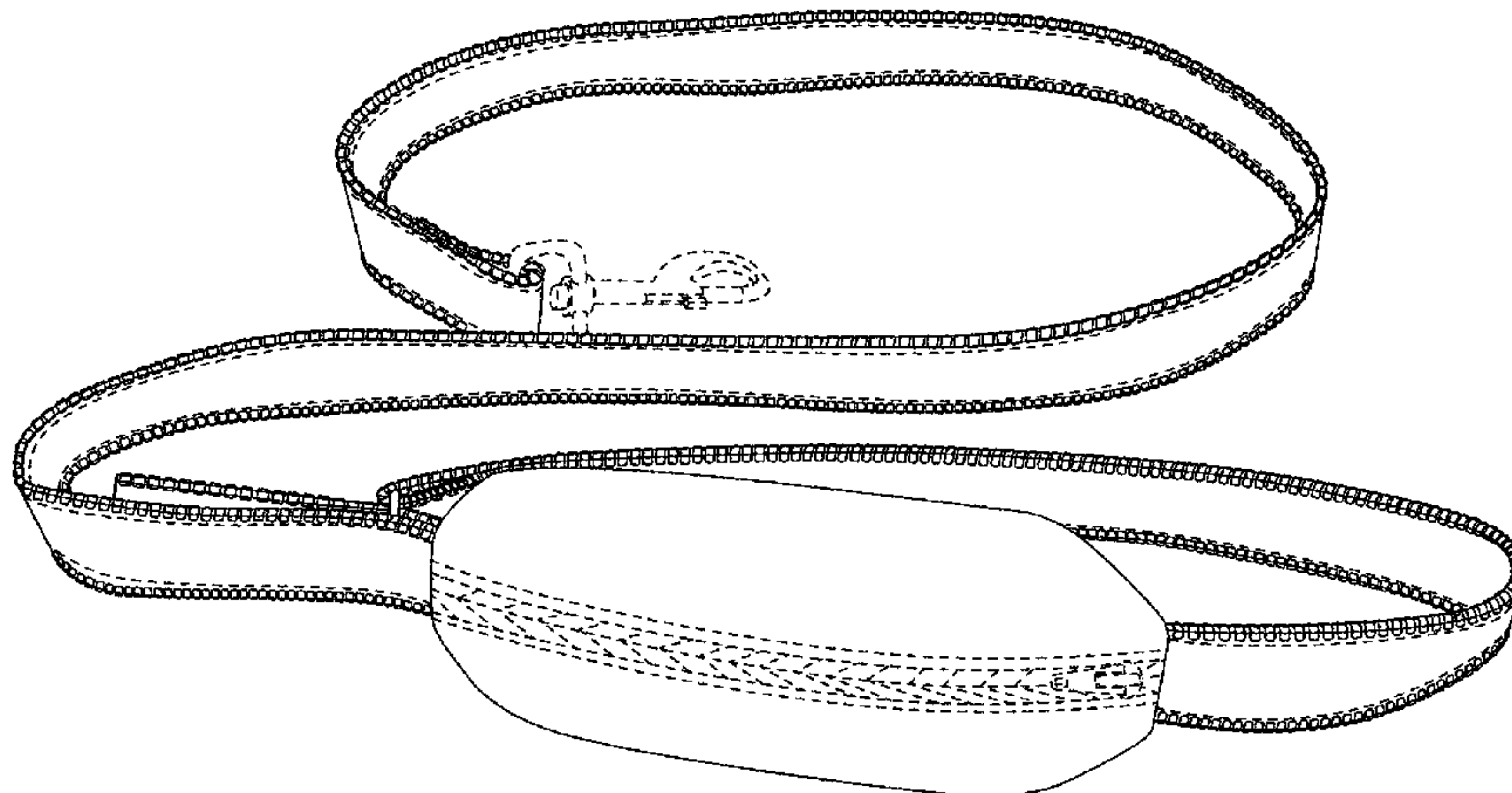
The hand fragment depicted by broken lines has been shown for the purpose of illustrating environment that forms no part of the claimed design.

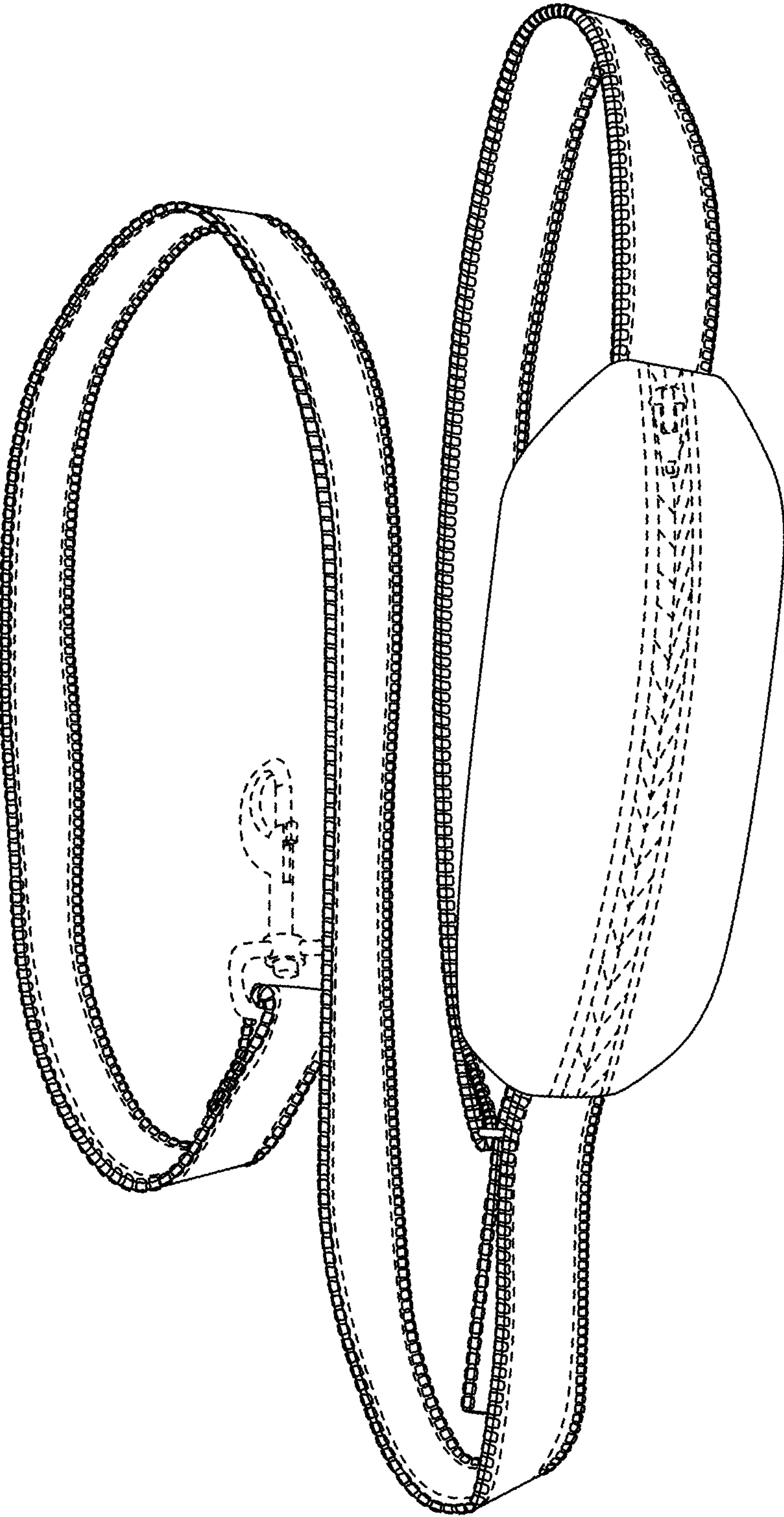

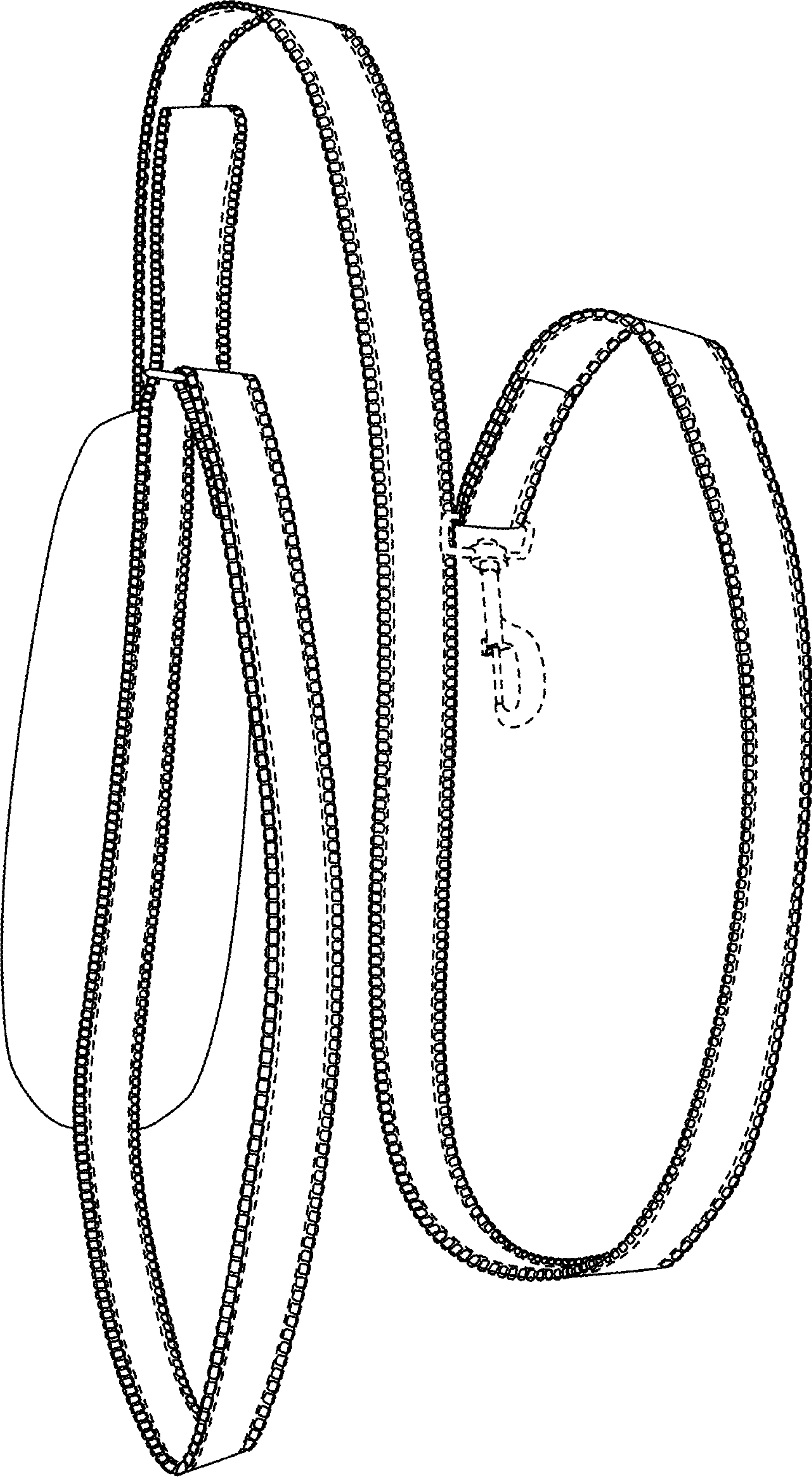

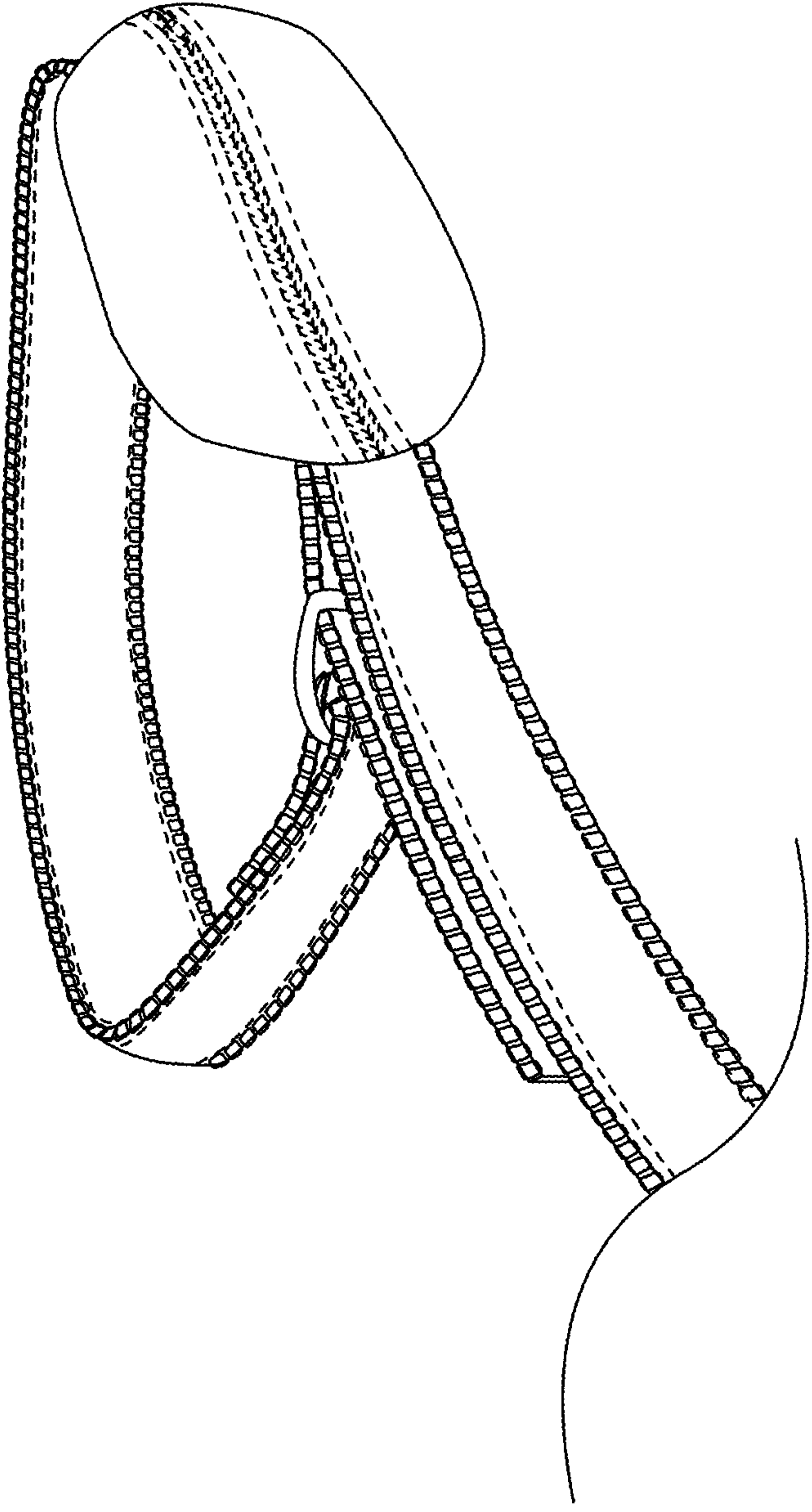

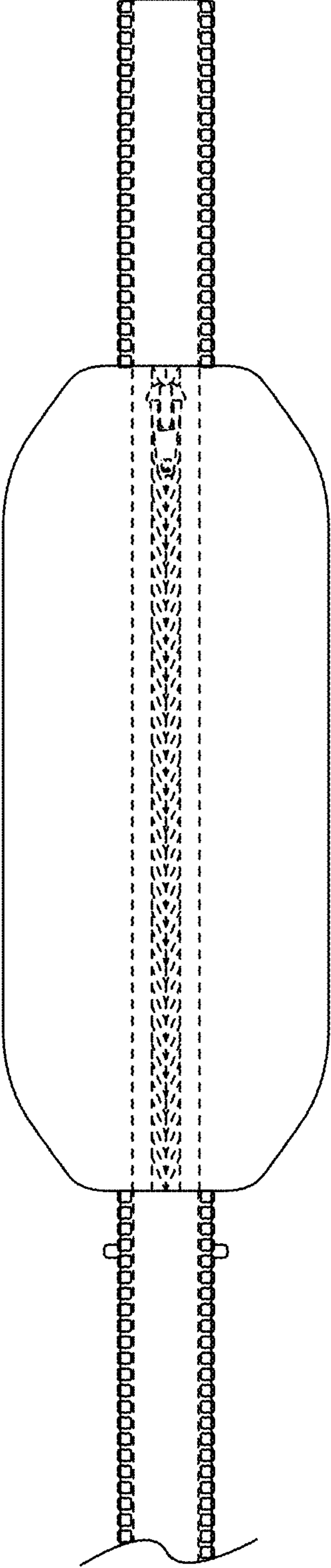

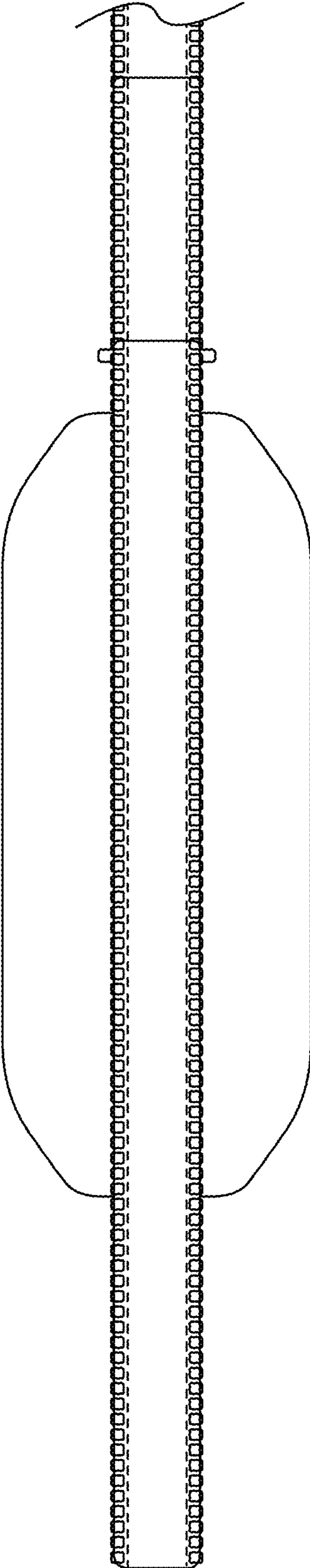

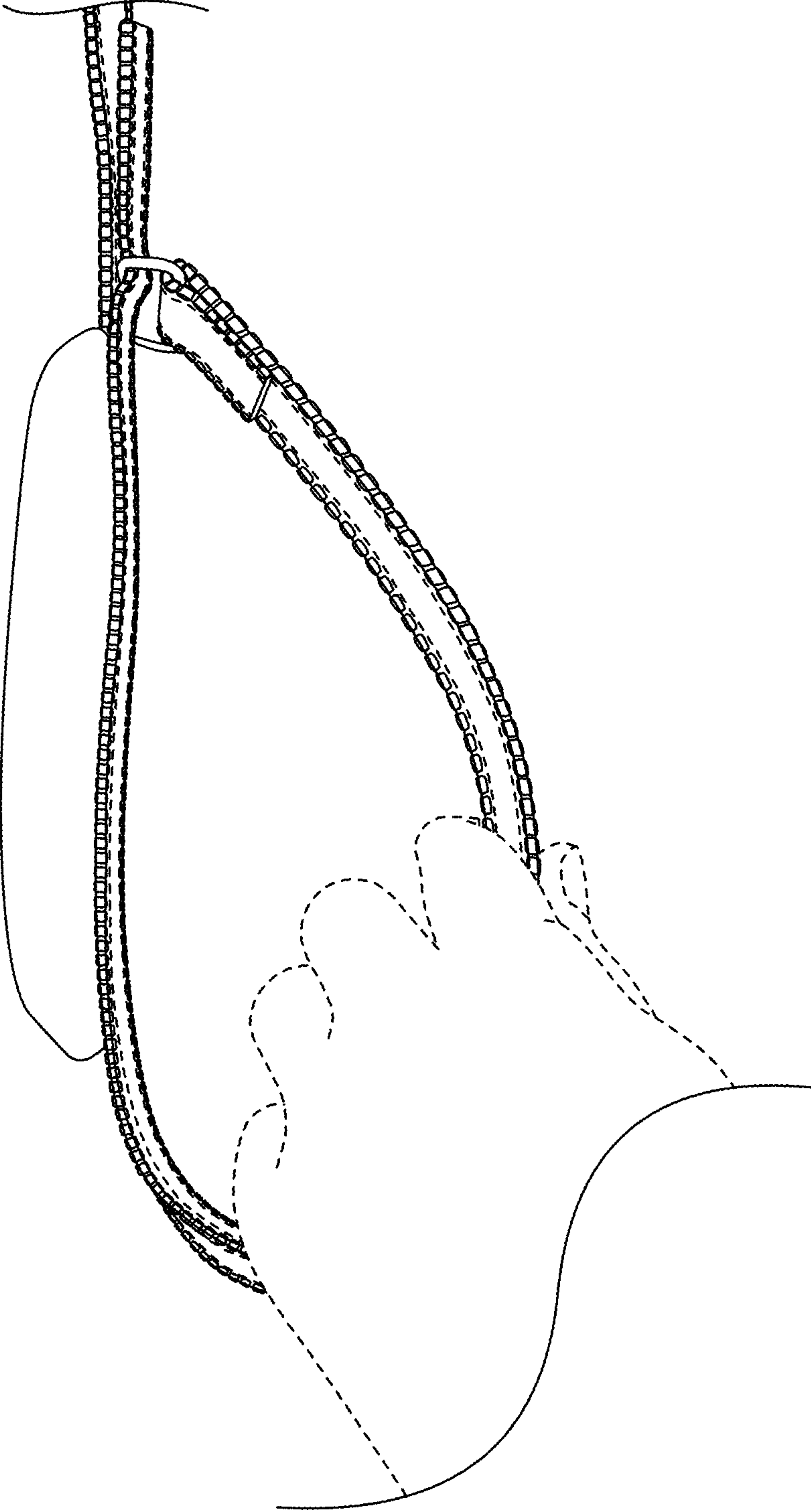
