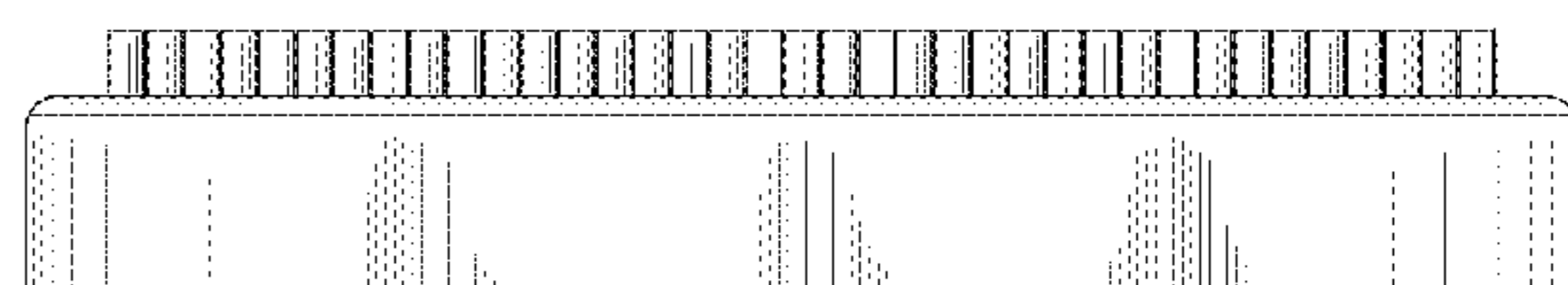
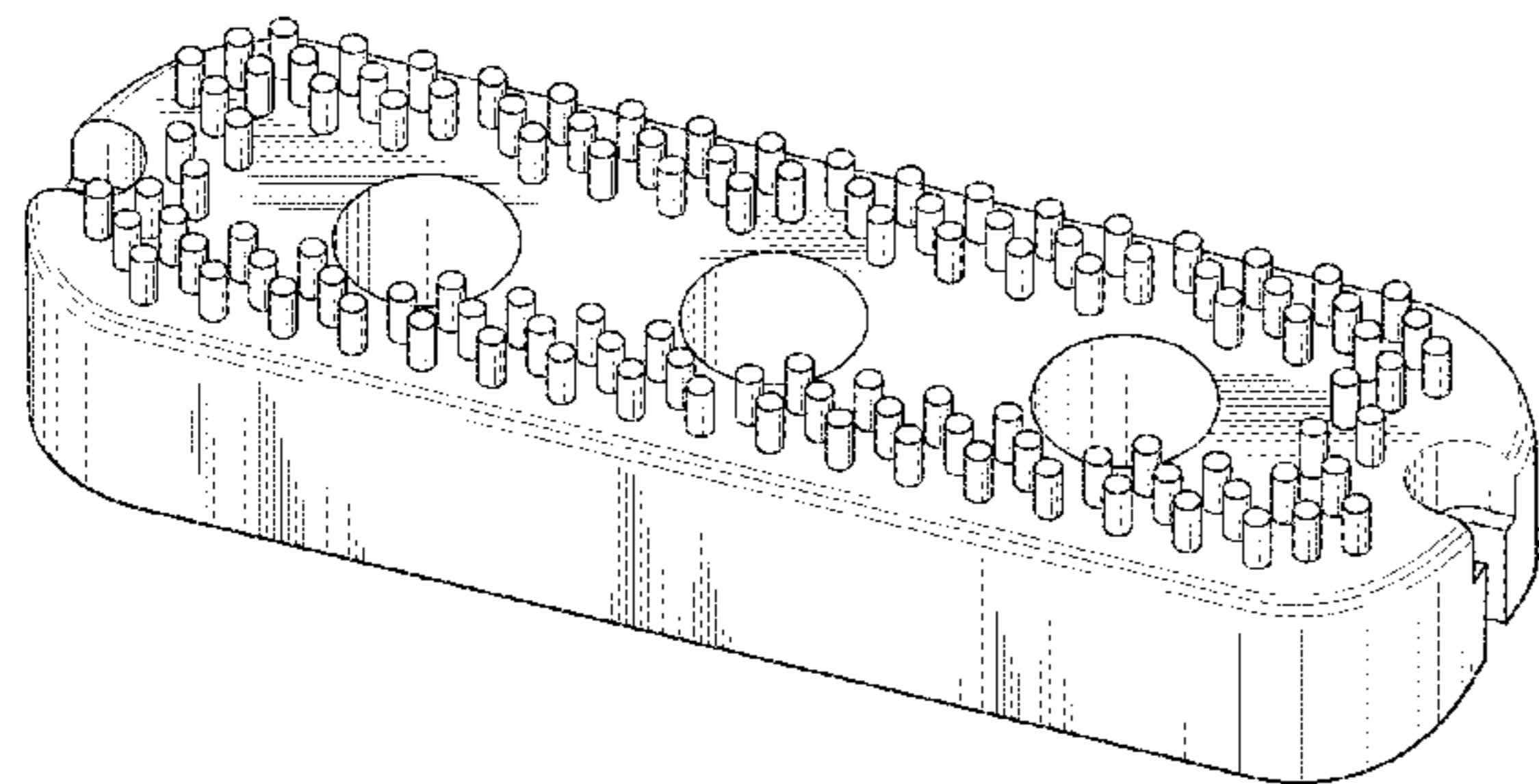
(57) **CLAIM**

The ornamental design for a brush for cleaning semiconductor polishing disk, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a brush for cleaning semiconductor polishing disk showing my new design;
FIG. 2 is a top view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a right side view thereof; and,
FIG. 6 is a reference view showing a usable state thereof.

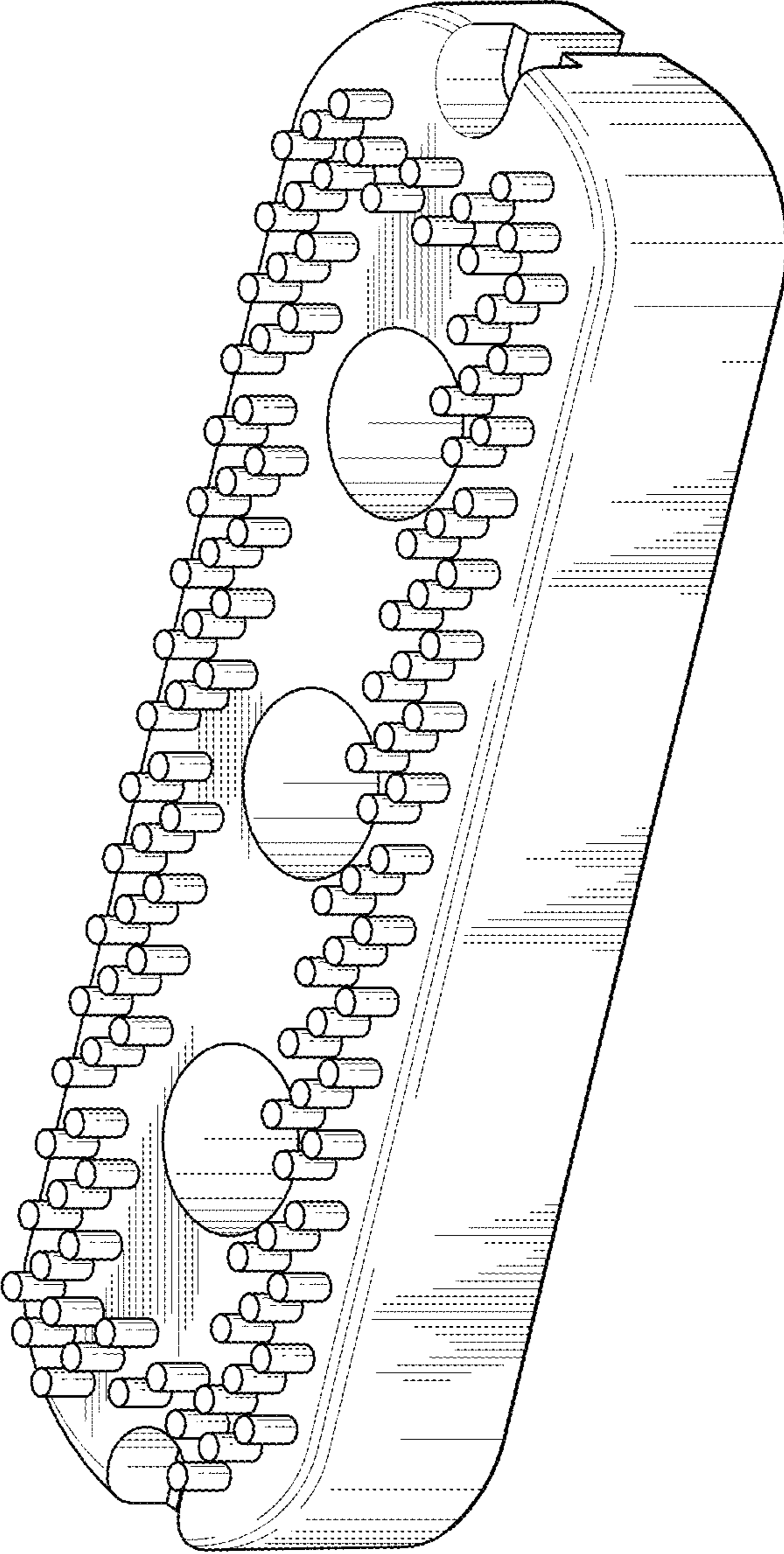

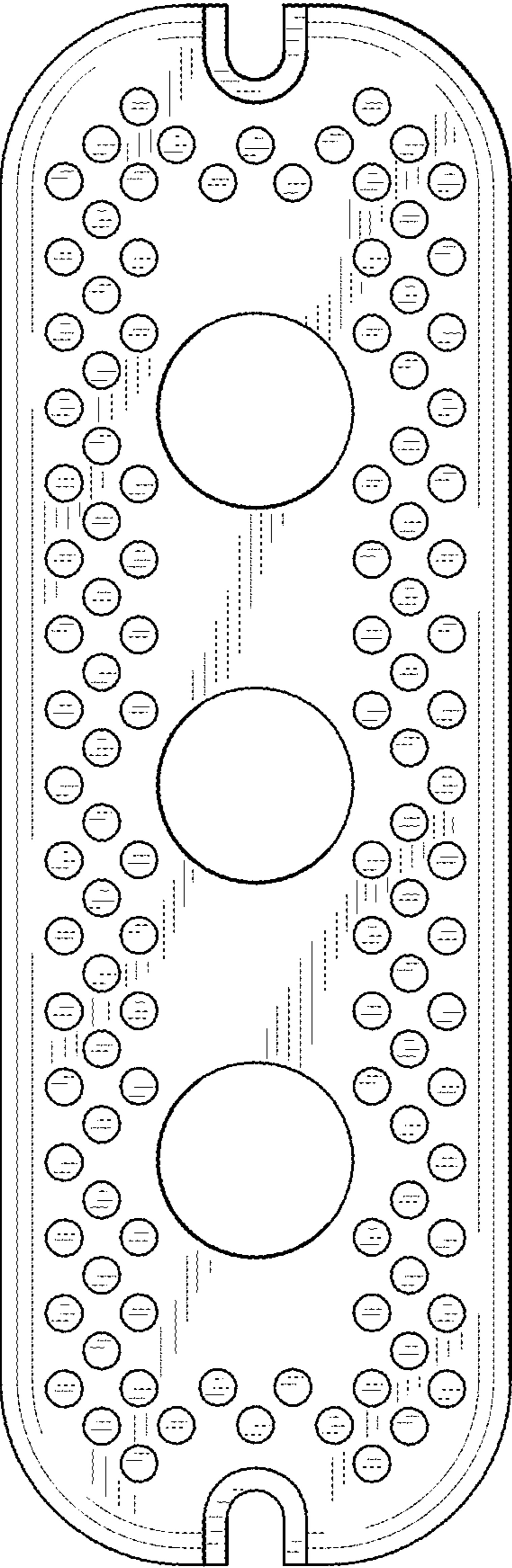

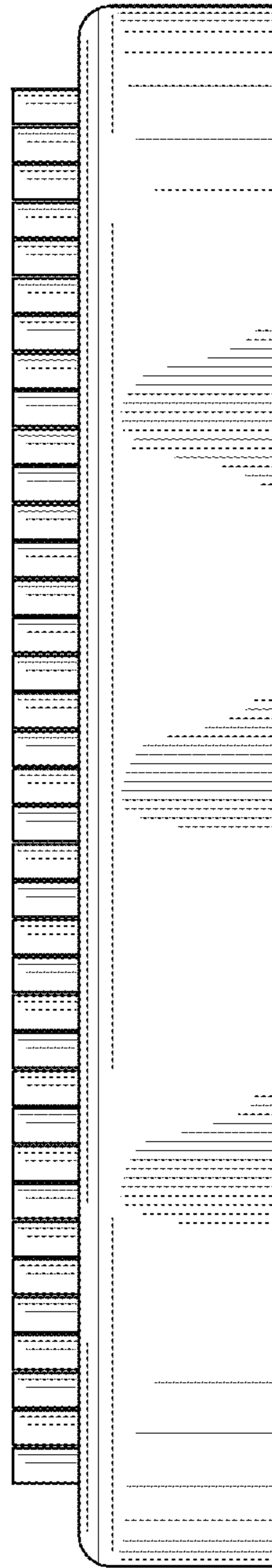

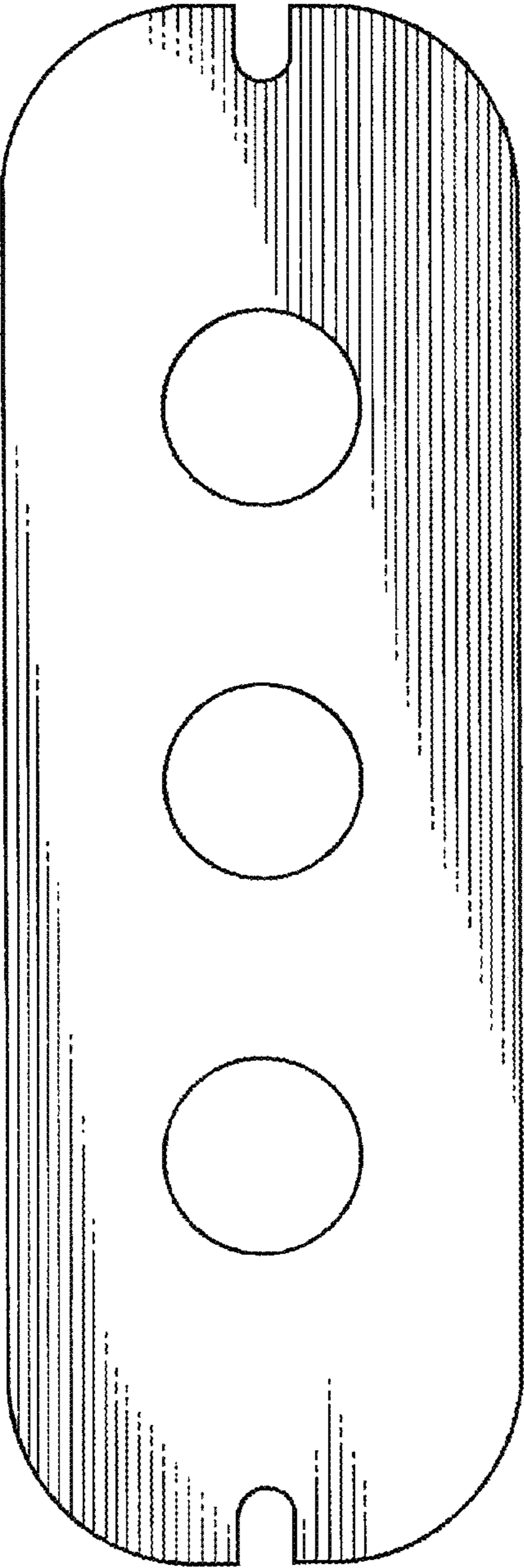
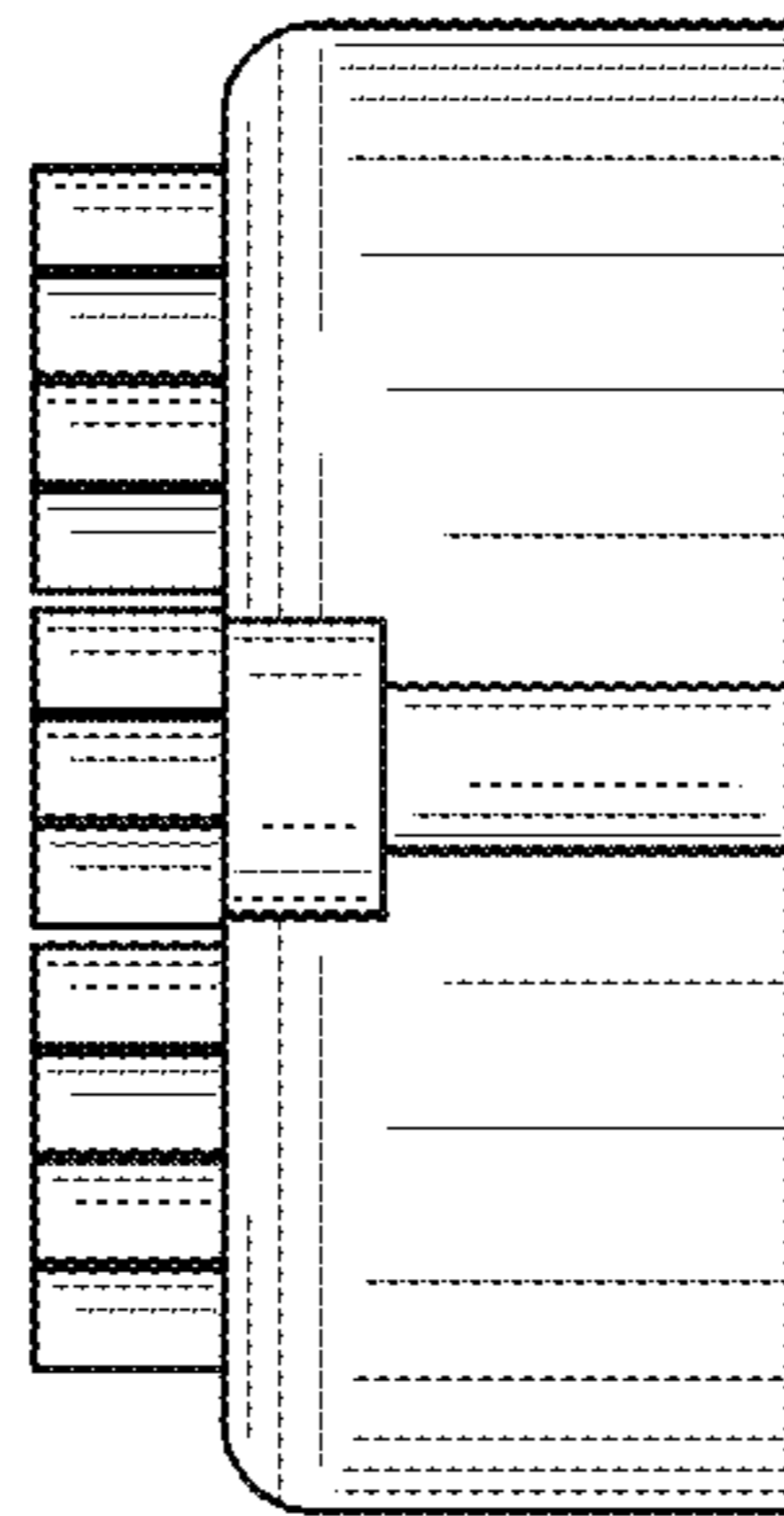

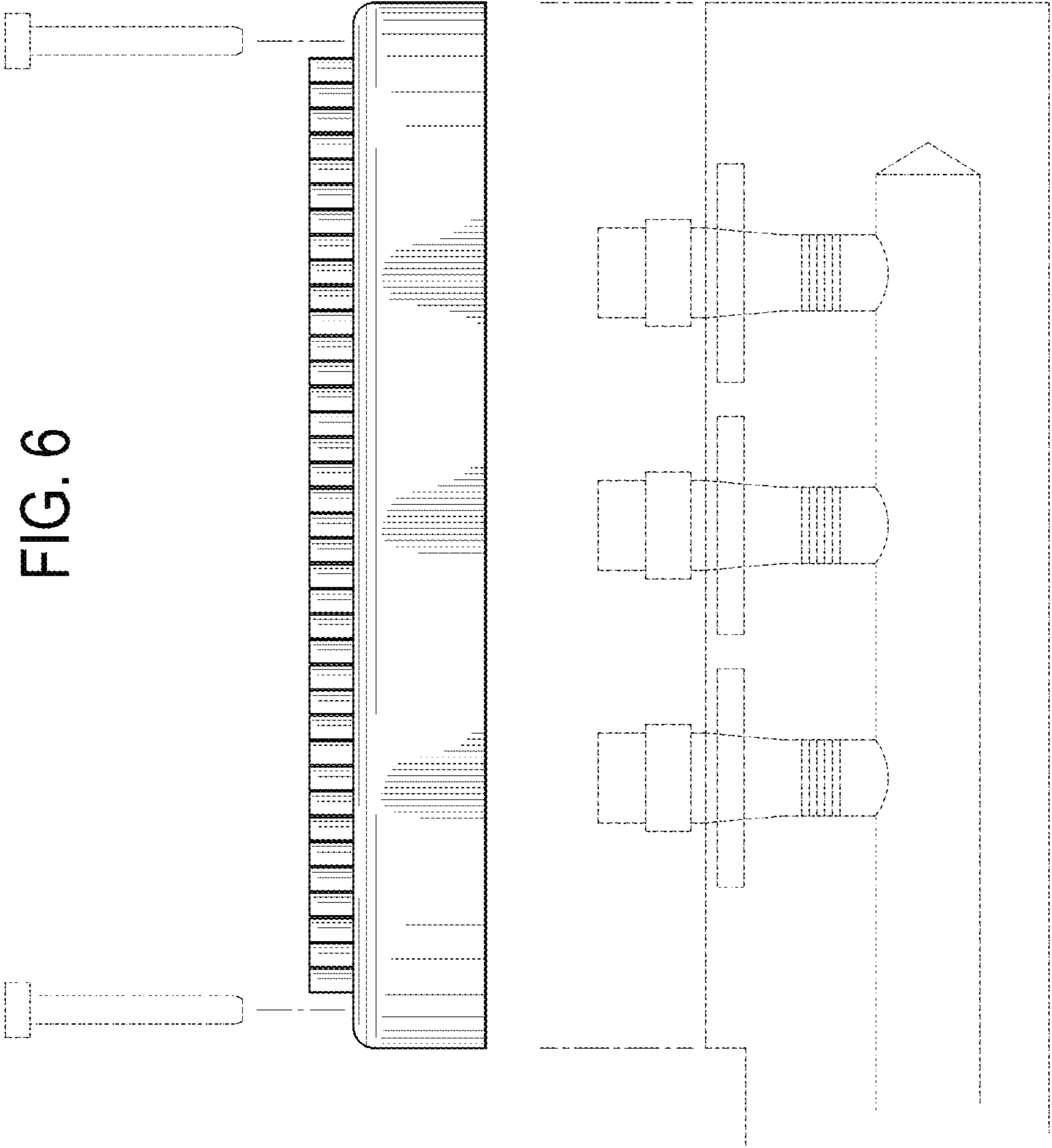
