(57) **CLAIM**  
The ornamental design for a picnic basket chair, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a picnic basket chair of my design in a first configuration displaying the picnic basket feature;

FIG. 2 is a top plan view of the picnic basket chair thereof;

FIG. 3 is a bottom plan view of the picnic basket chair thereof;

FIG. 4 is a side elevation view of the picnic basket chair thereof, the opposite side being a mirror image thereof;

FIG. 5 is a front elevation view of the picnic basket chair thereof;

FIG. 6 is a back elevation view of the picnic basket chair thereof, showing the chair components thereof;

FIG. 7 is a top perspective view of the picnic basket chair showing the top sliding lid removed thereof;

FIG. 8 is a perspective view of a picnic basket chair of my design in a second configuration displaying the picnic chair feature;

FIG. 9 is a front perspective view of the picnic basket chair thereof;

FIG. 10 is a back perspective view of the picnic basket chair thereof;

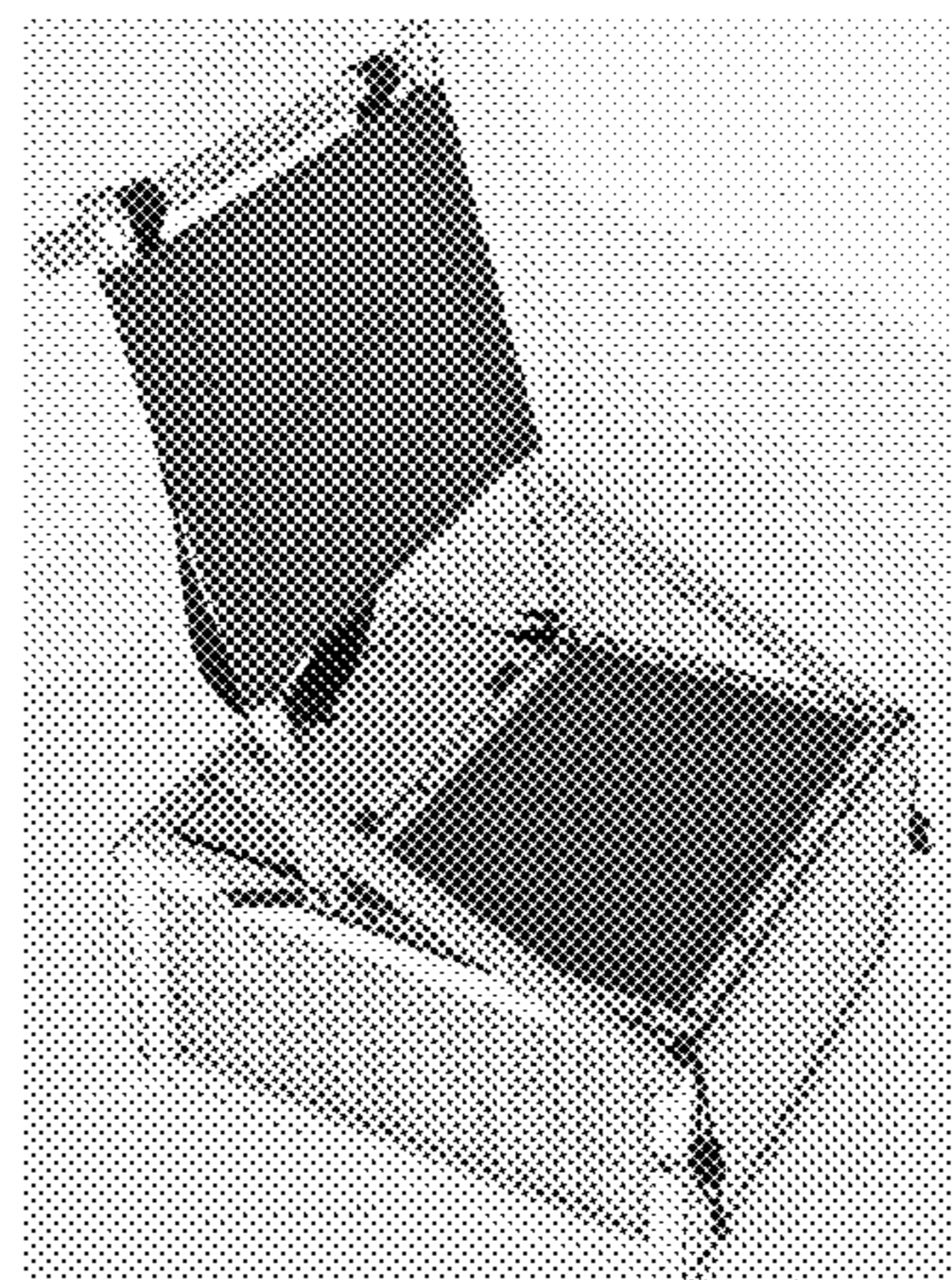
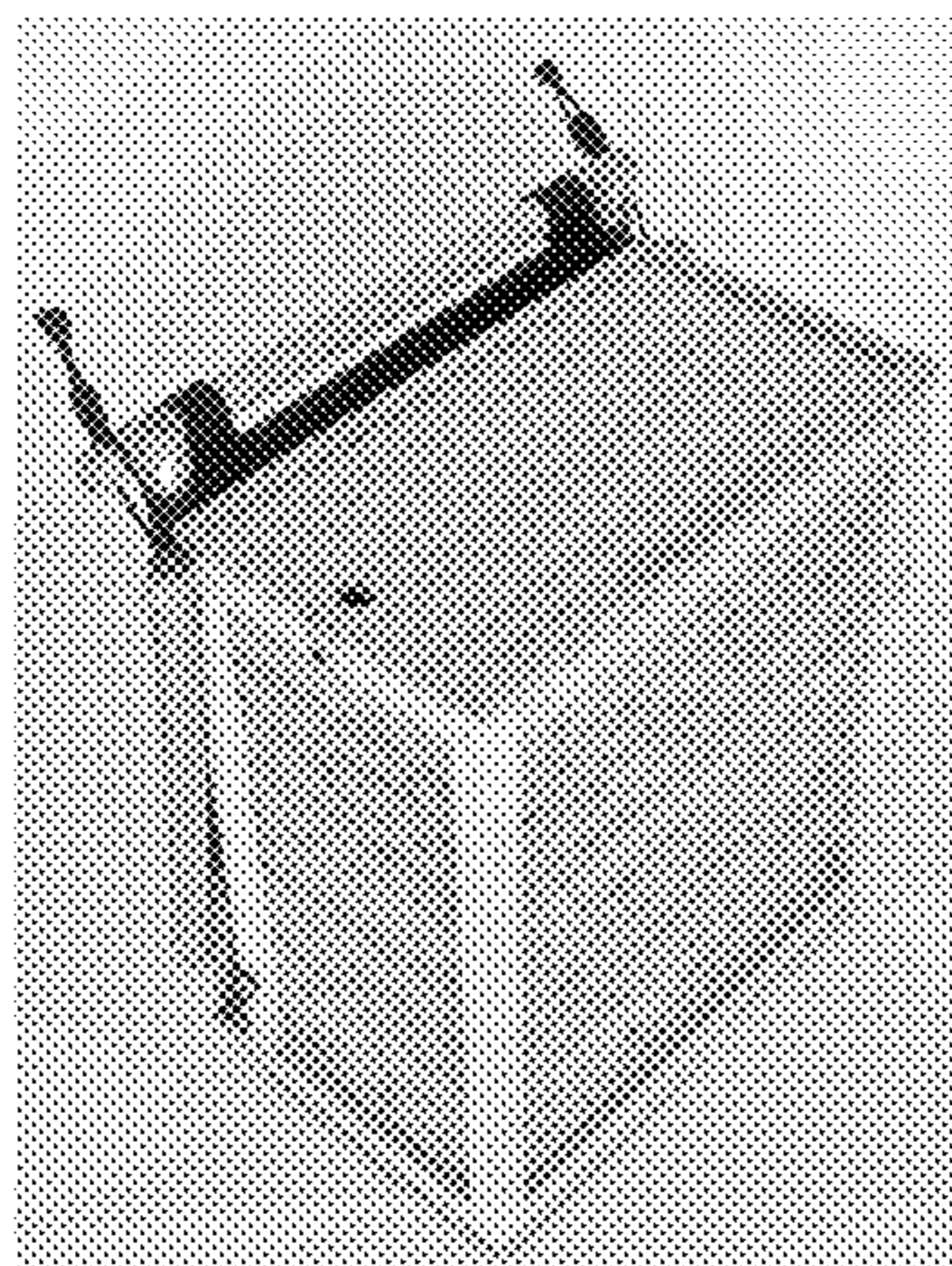
FIG. 11 is a side perspective view of the picnic basket chair thereof, the opposite side being a mirror image thereof;

FIG. 12 is a front perspective view of the picnic basket chair showing the sliding lid removed thereof; and,

FIG. 13 is a back perspective view of the picnic basket chair showing the hinged door open thereof.

The intended use for the picnic basket chair embodies a distinct design serving as both a picnic basket and as a picnic chair.

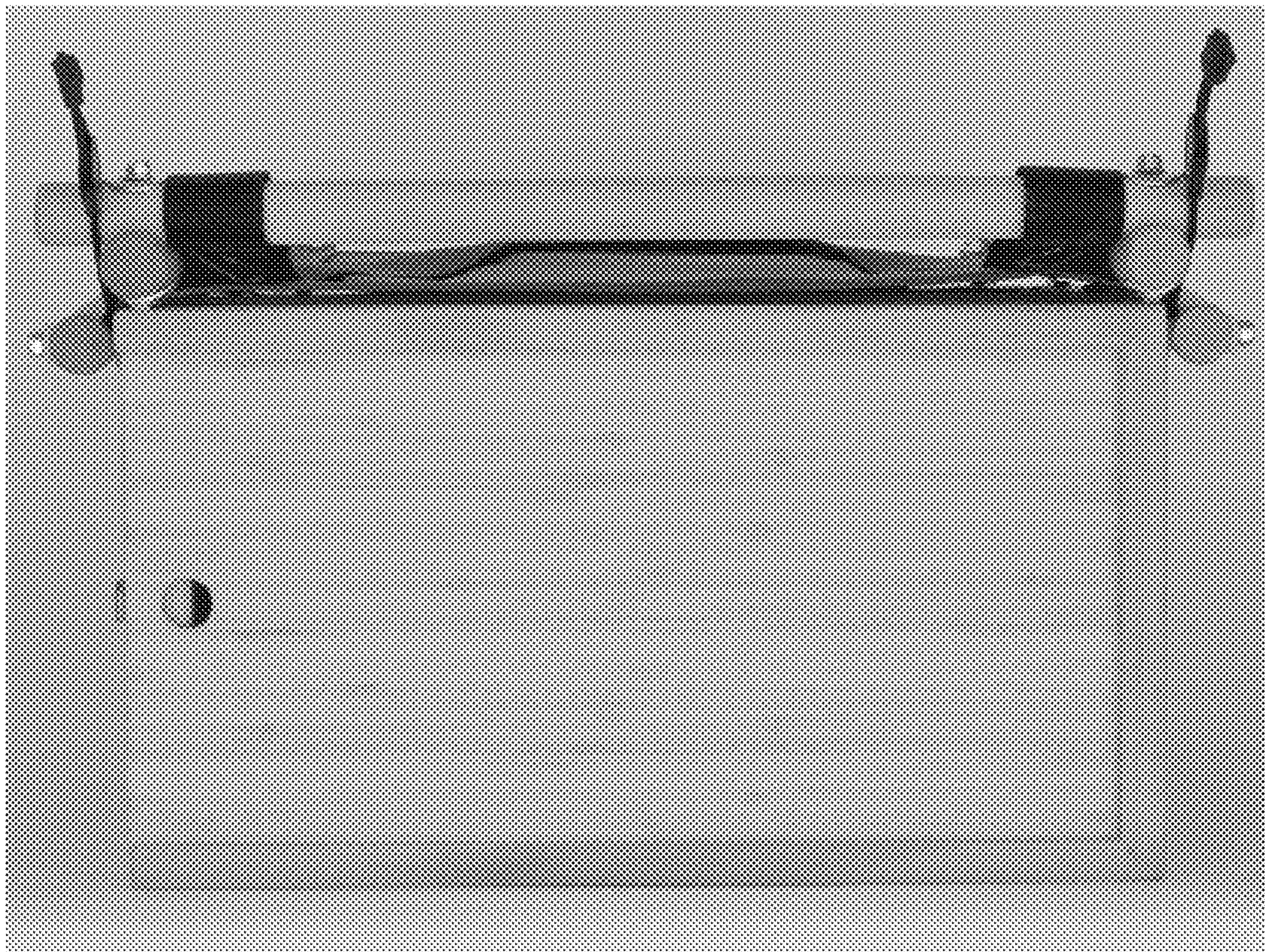

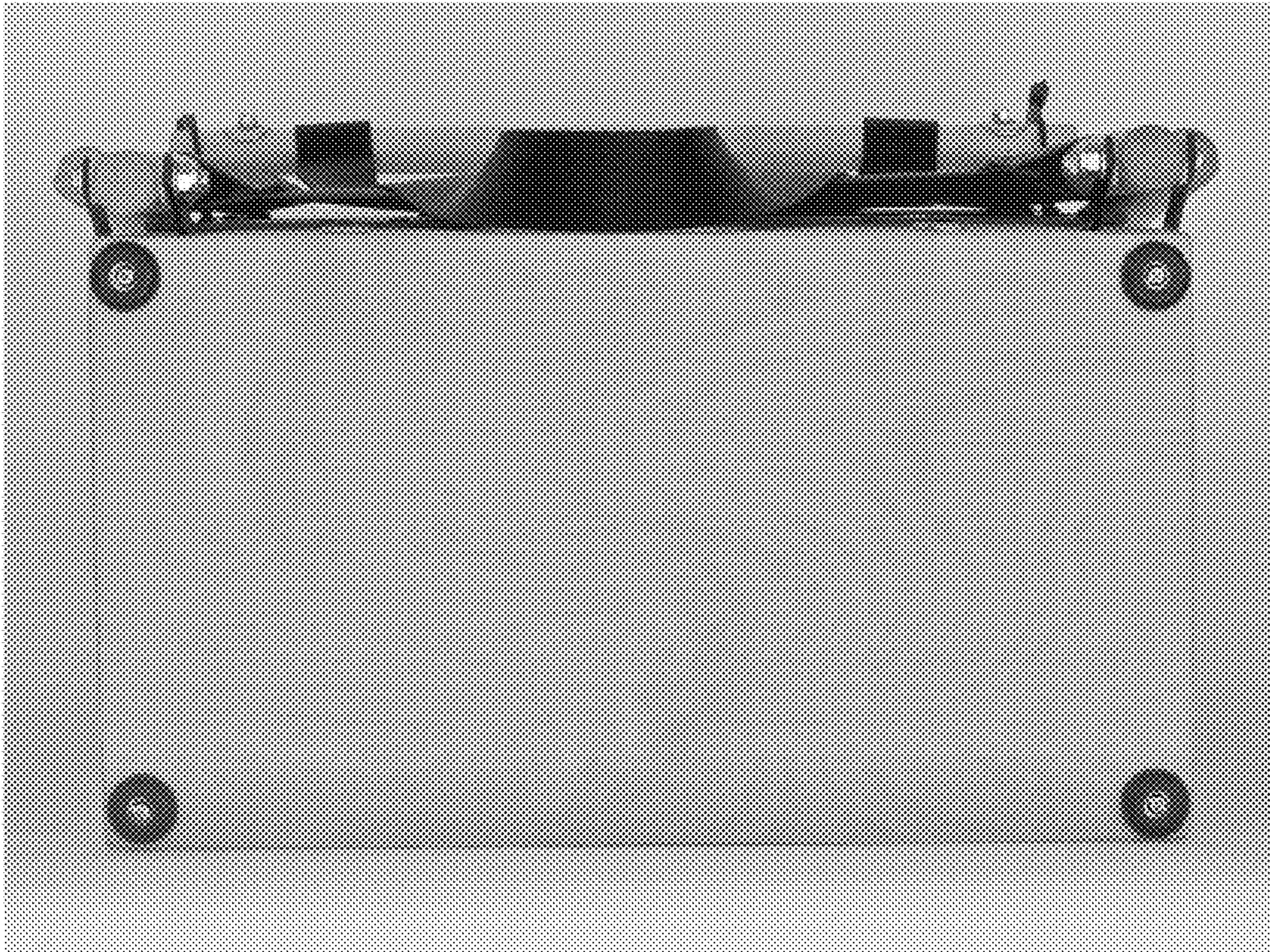

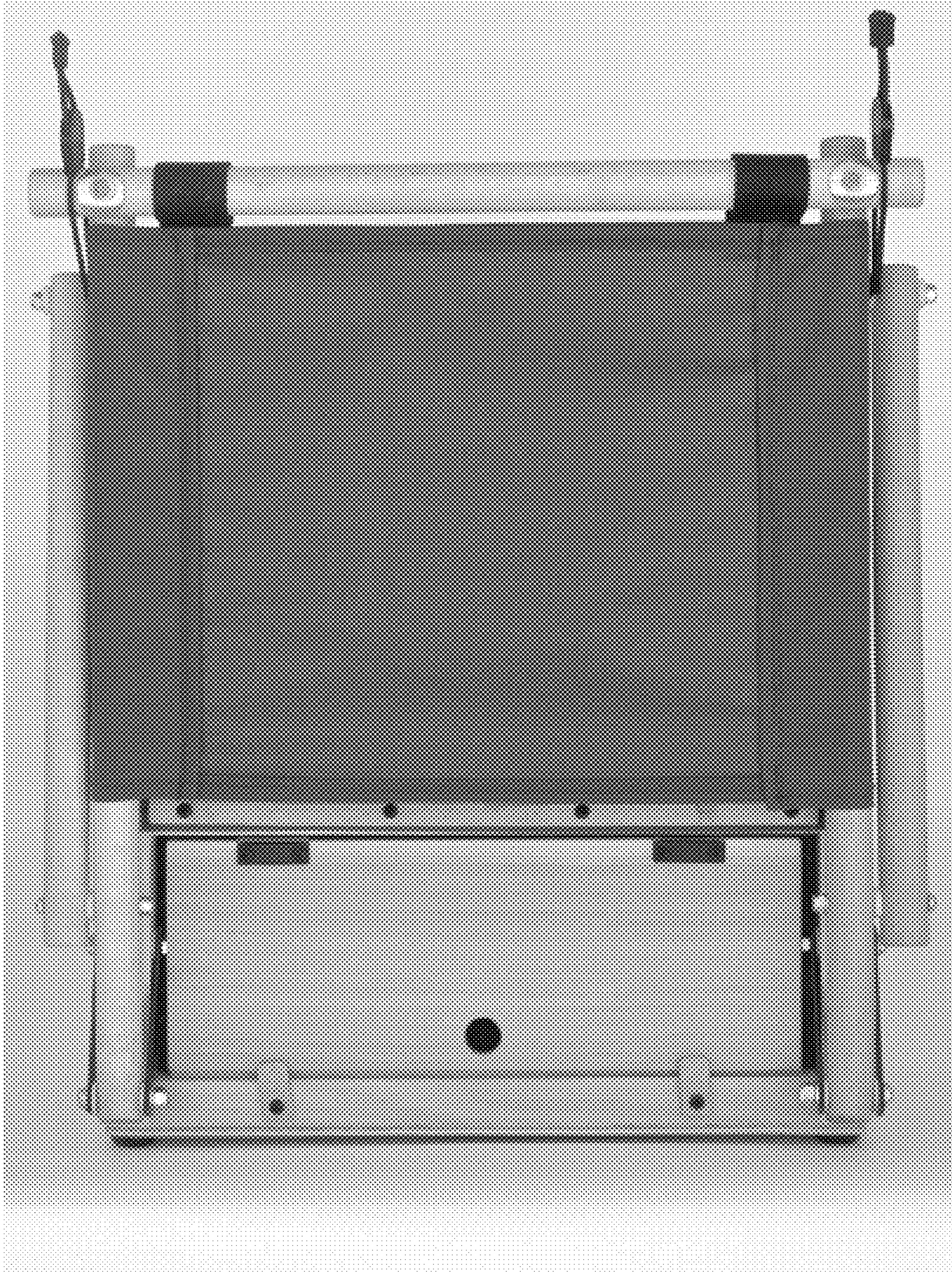

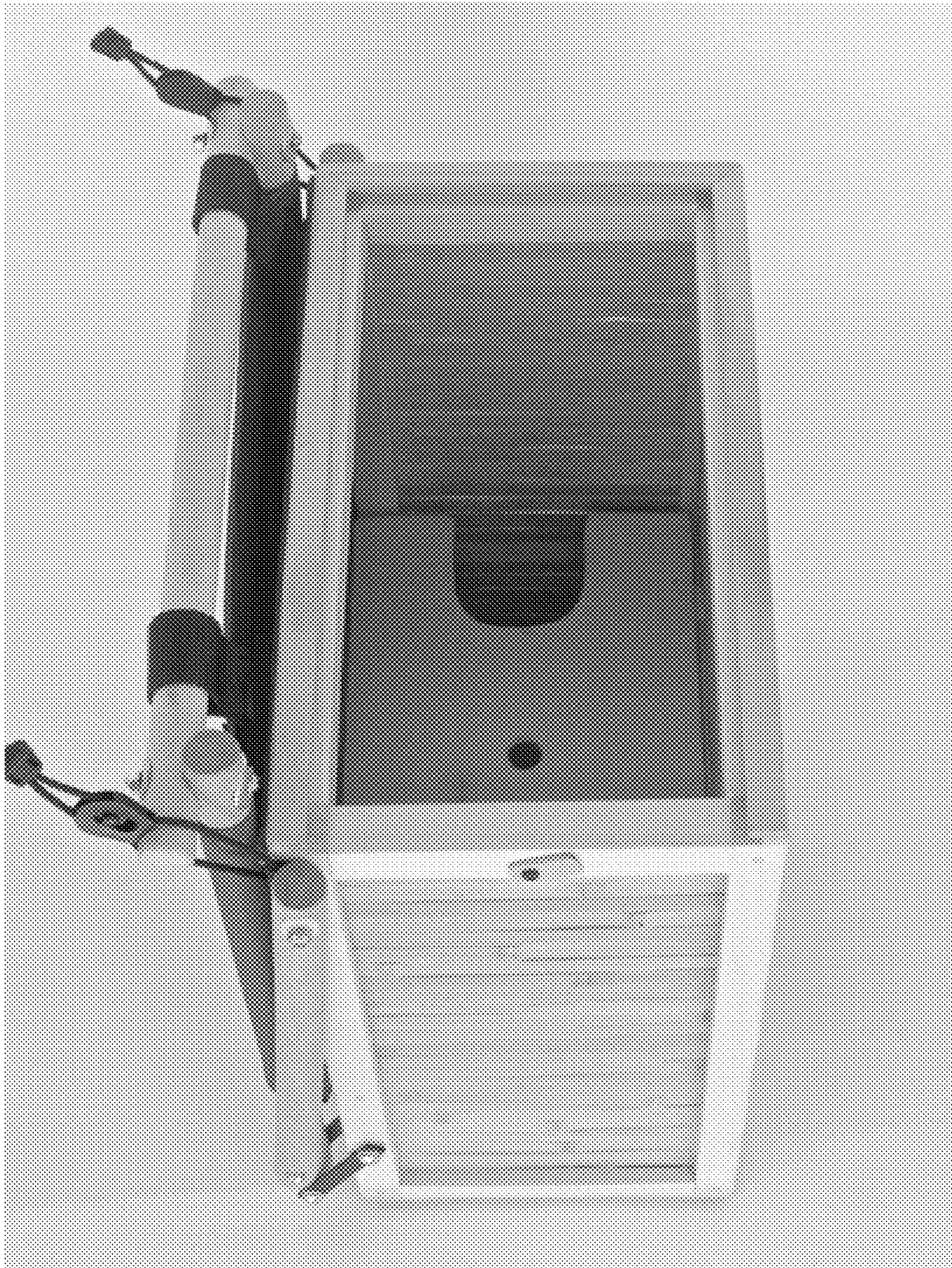

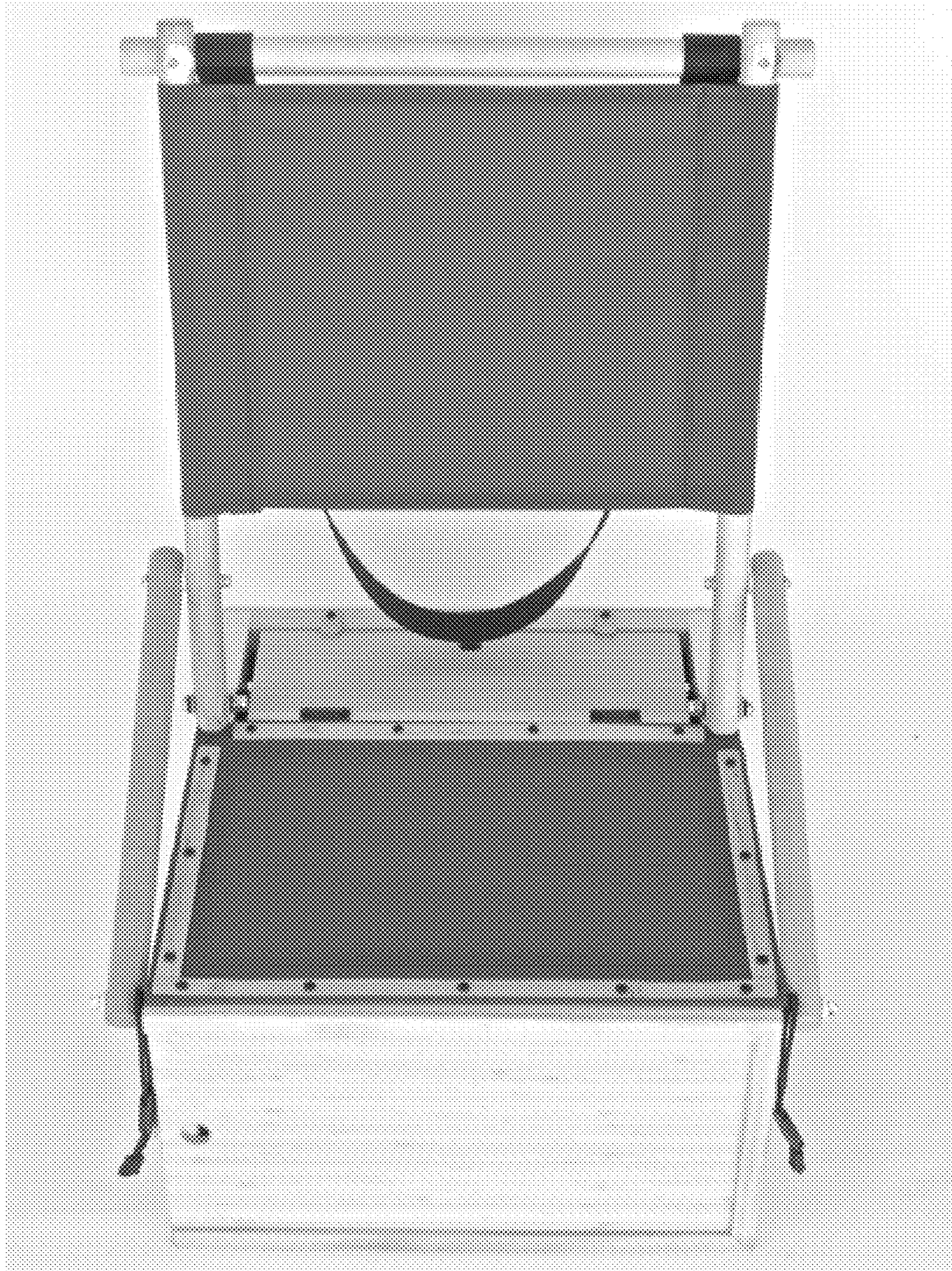

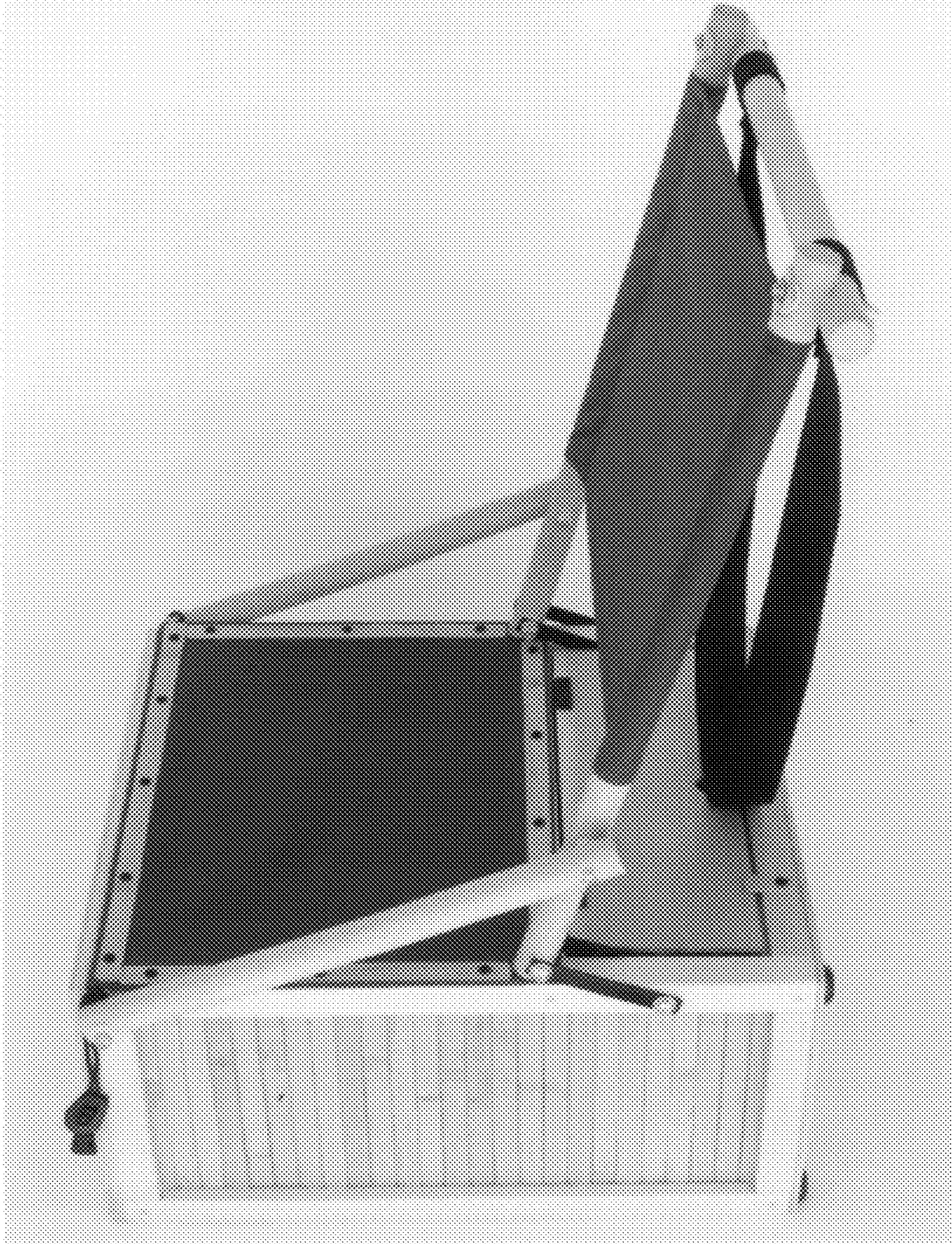

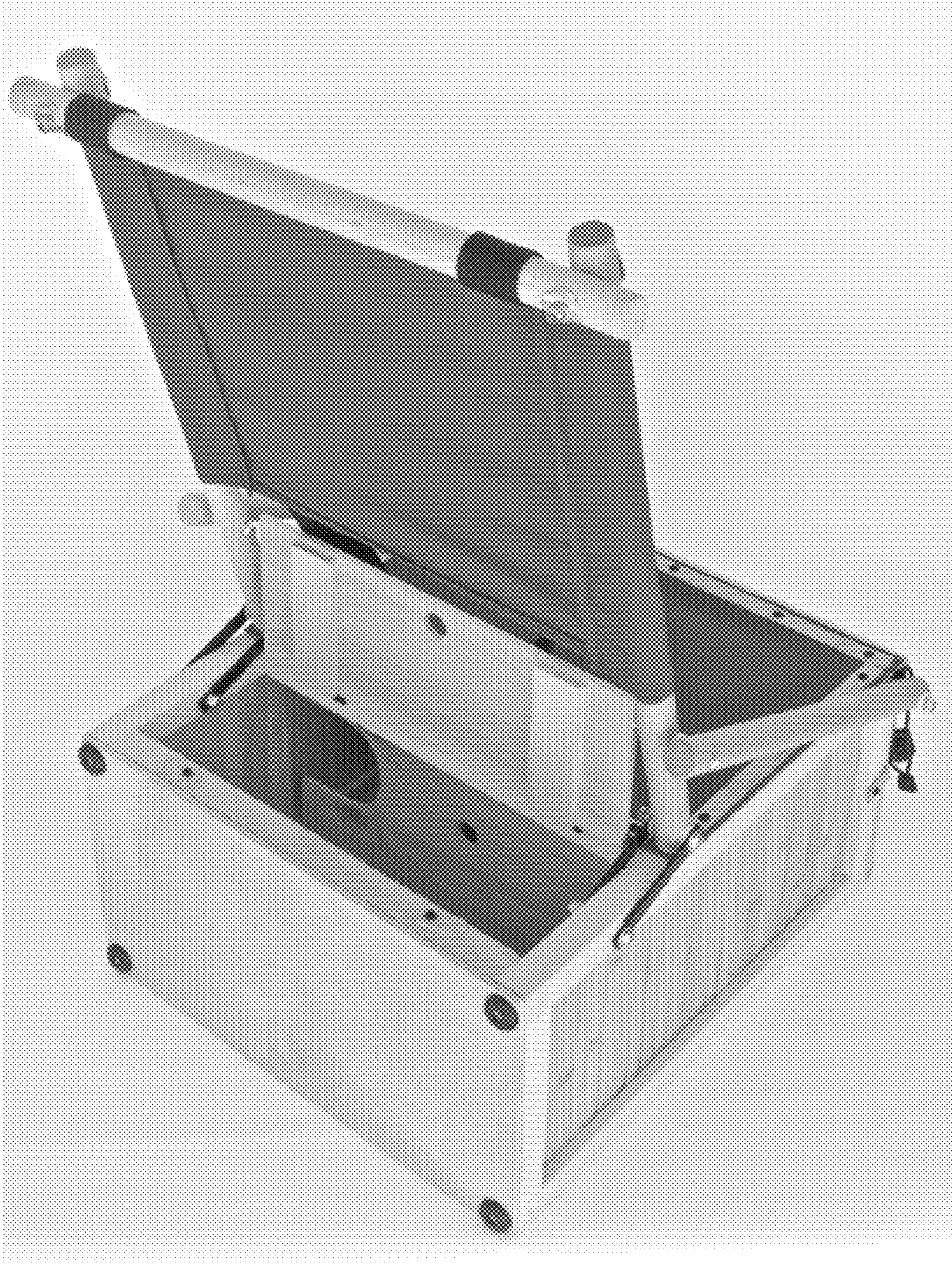
