(57) **CLAIM**

The ornamental design for a seat for two wheeled vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of a seat for two wheeled vehicle showing our new design.

FIG. 2 is a rear perspective view thereof.

FIG. 3 is a front elevational view thereof.

FIG. 4 is a rear elevational view thereof.

FIG. 5 is a left side elevational view thereof.

FIG. 6 is a right side elevational view thereof.

FIG. 7 is a top plan view thereof.

FIG. 8 is a right side elevational view thereof showing its orientation on a two wheeled vehicle.

FIG. 9 is a front perspective view of a second embodiment of a seat for two wheeled vehicle showing our new design.

FIG. 10 is a rear perspective view thereof.

FIG. 11 is a front elevational view thereof.

FIG. 12 is a rear elevational view thereof.

FIG. 13 is a left side elevational view thereof.

FIG. 14 is a right side elevational view thereof.

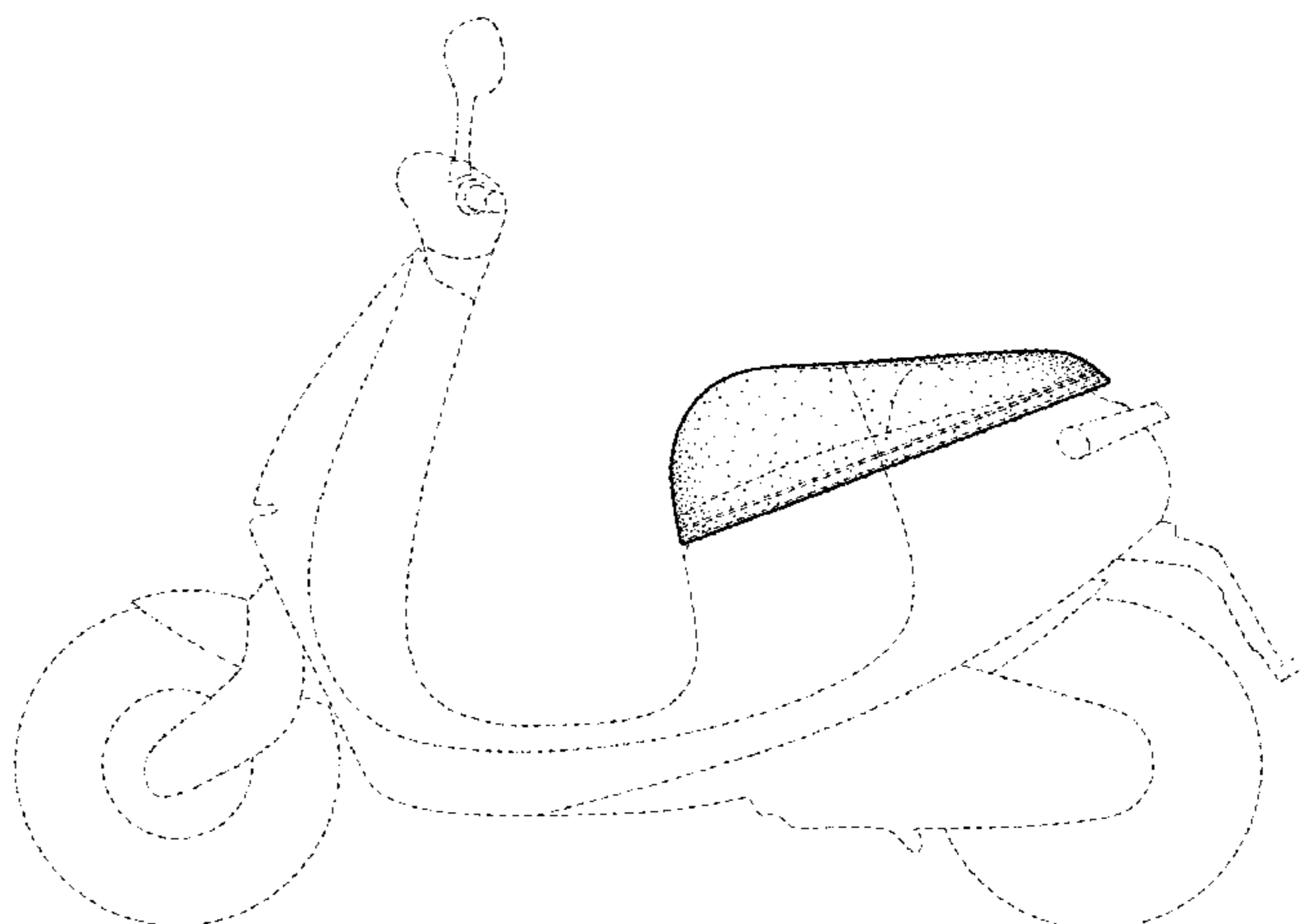
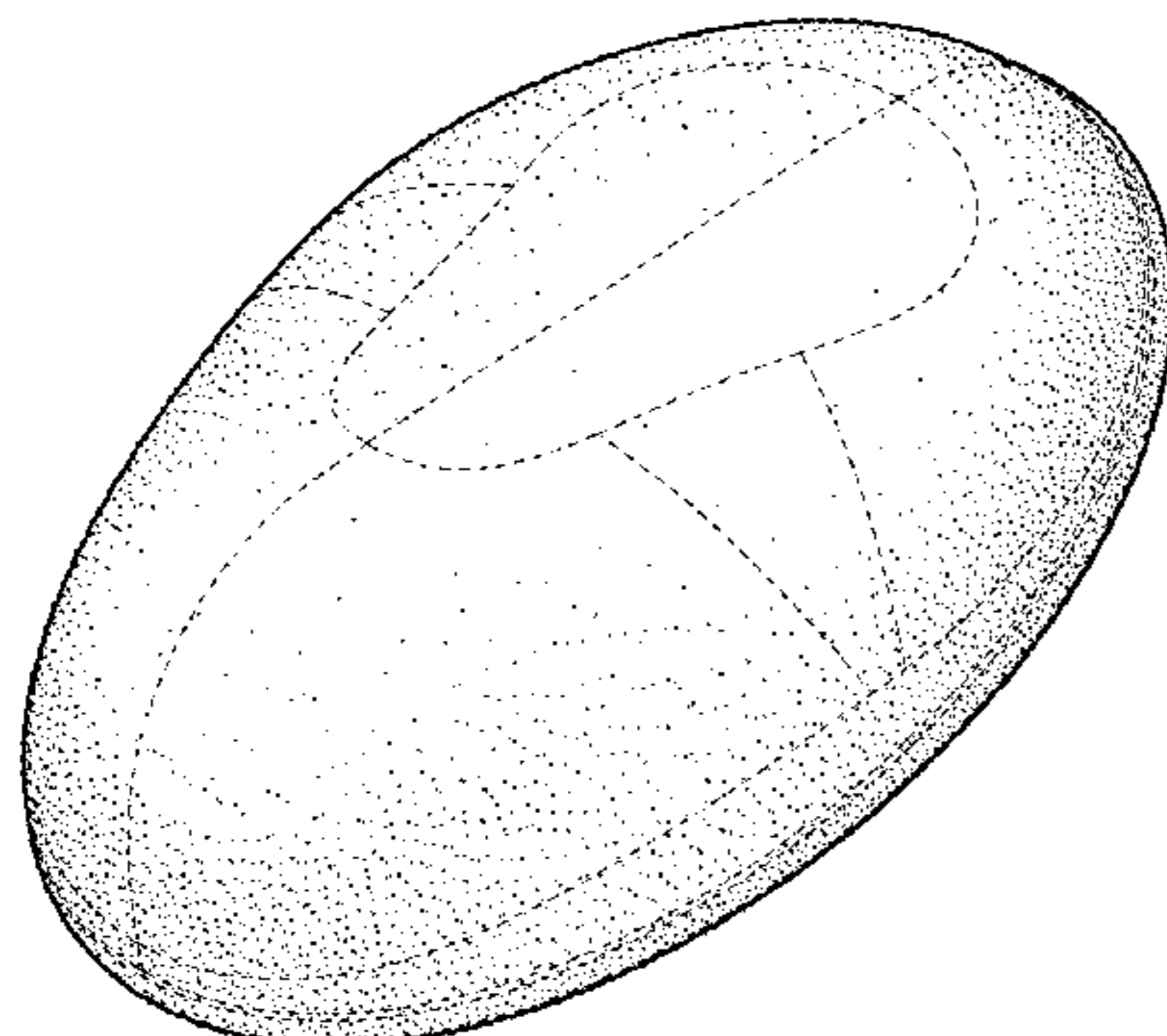
FIG. 15 is a top plan view thereof; and,

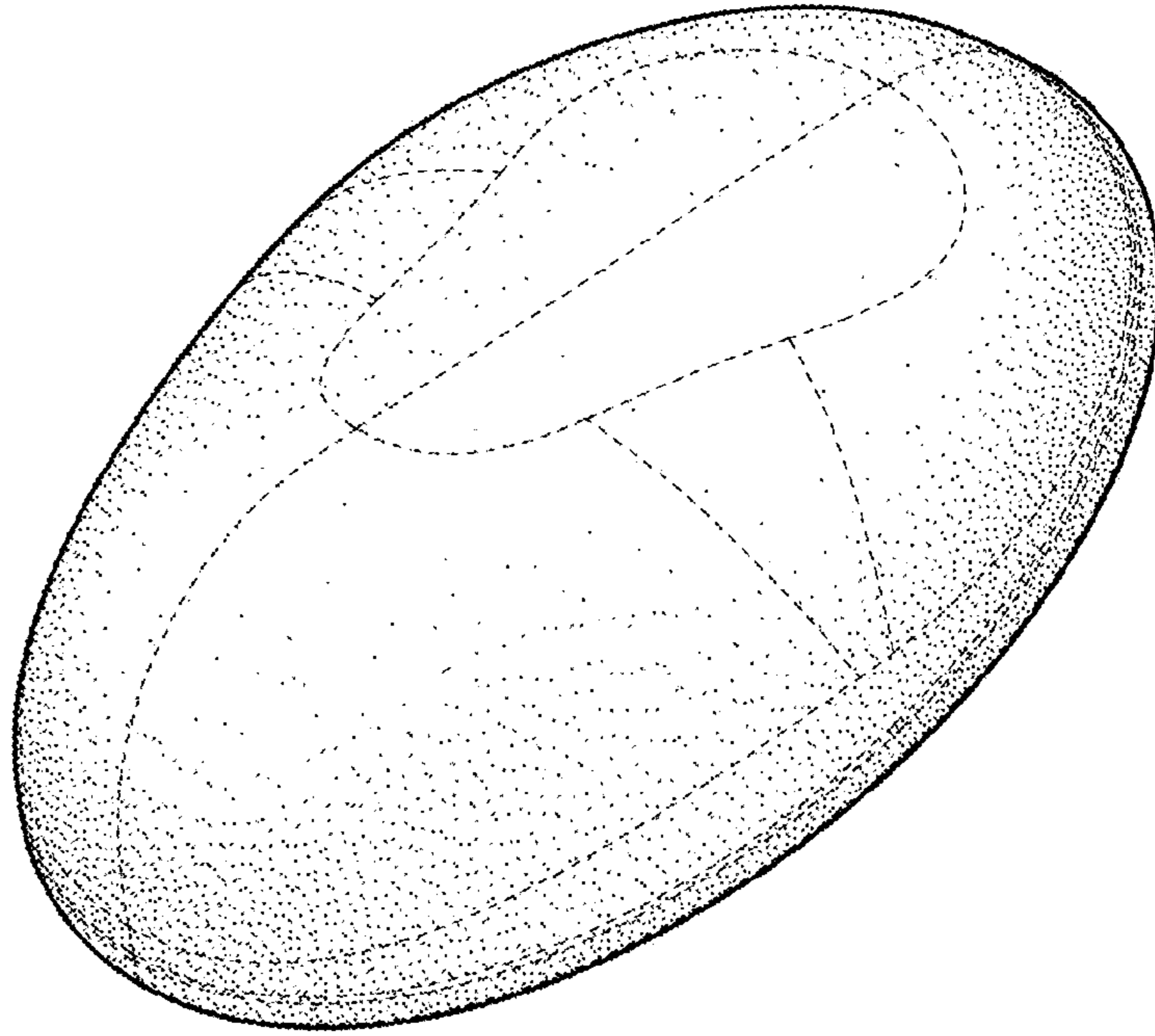

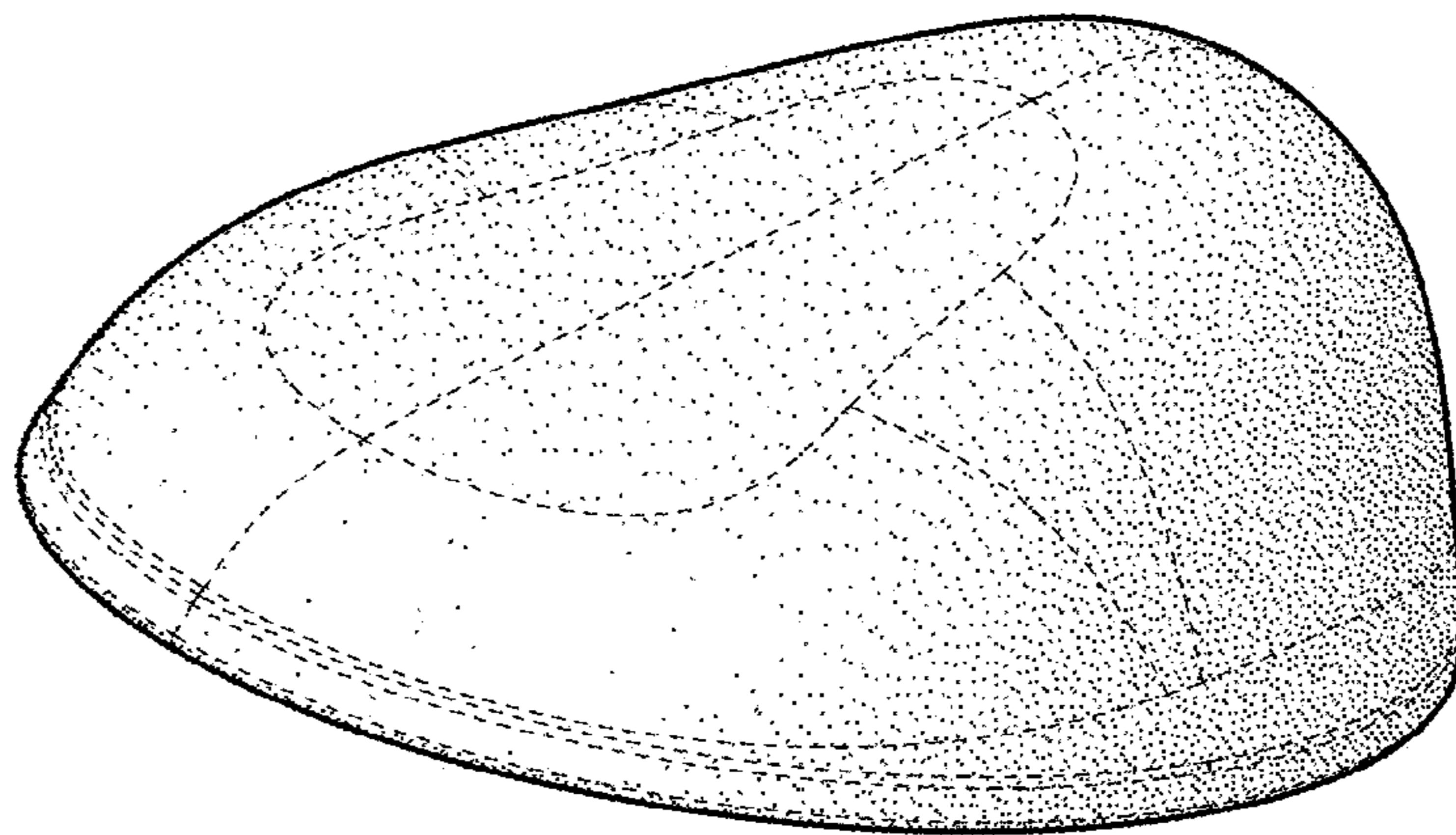

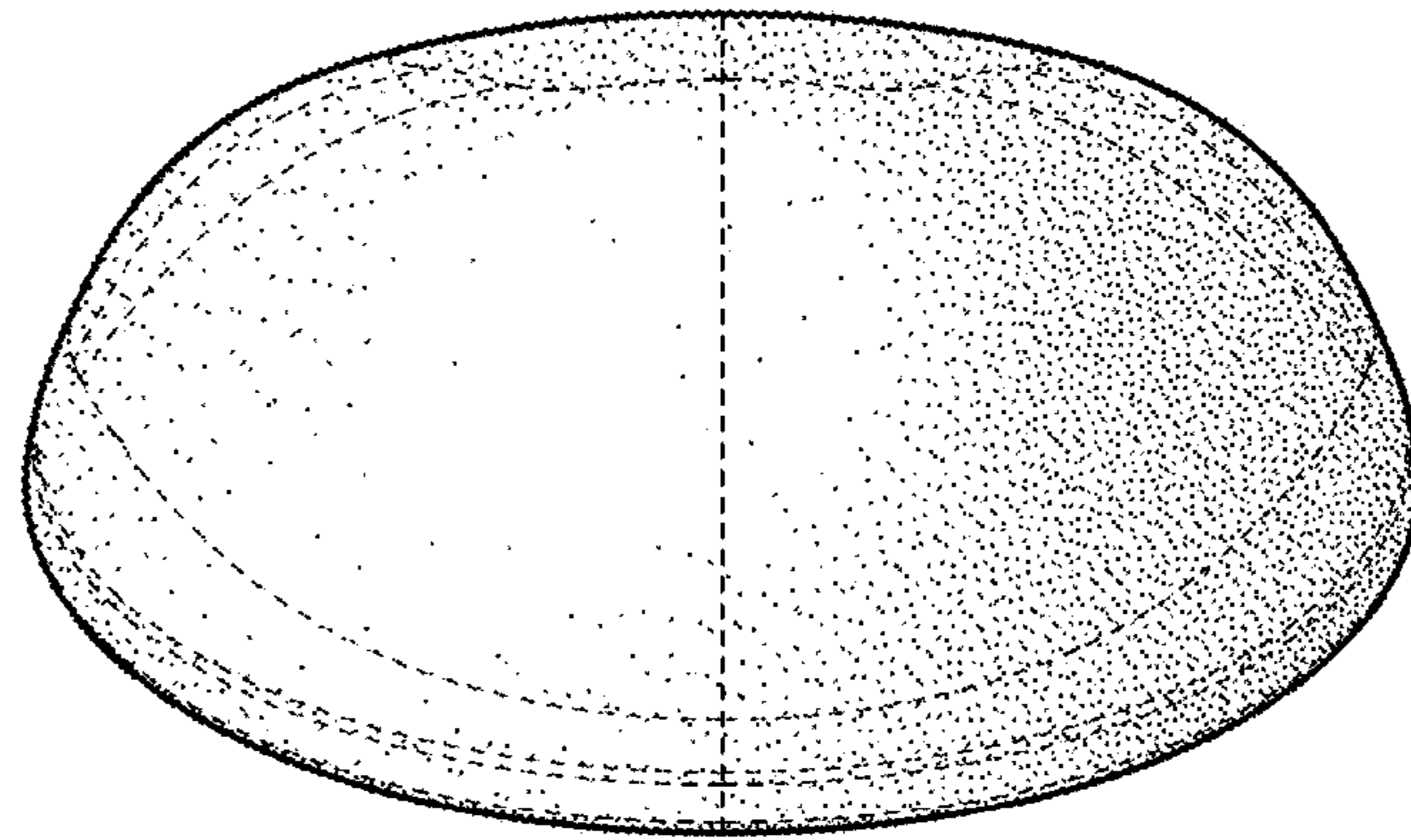

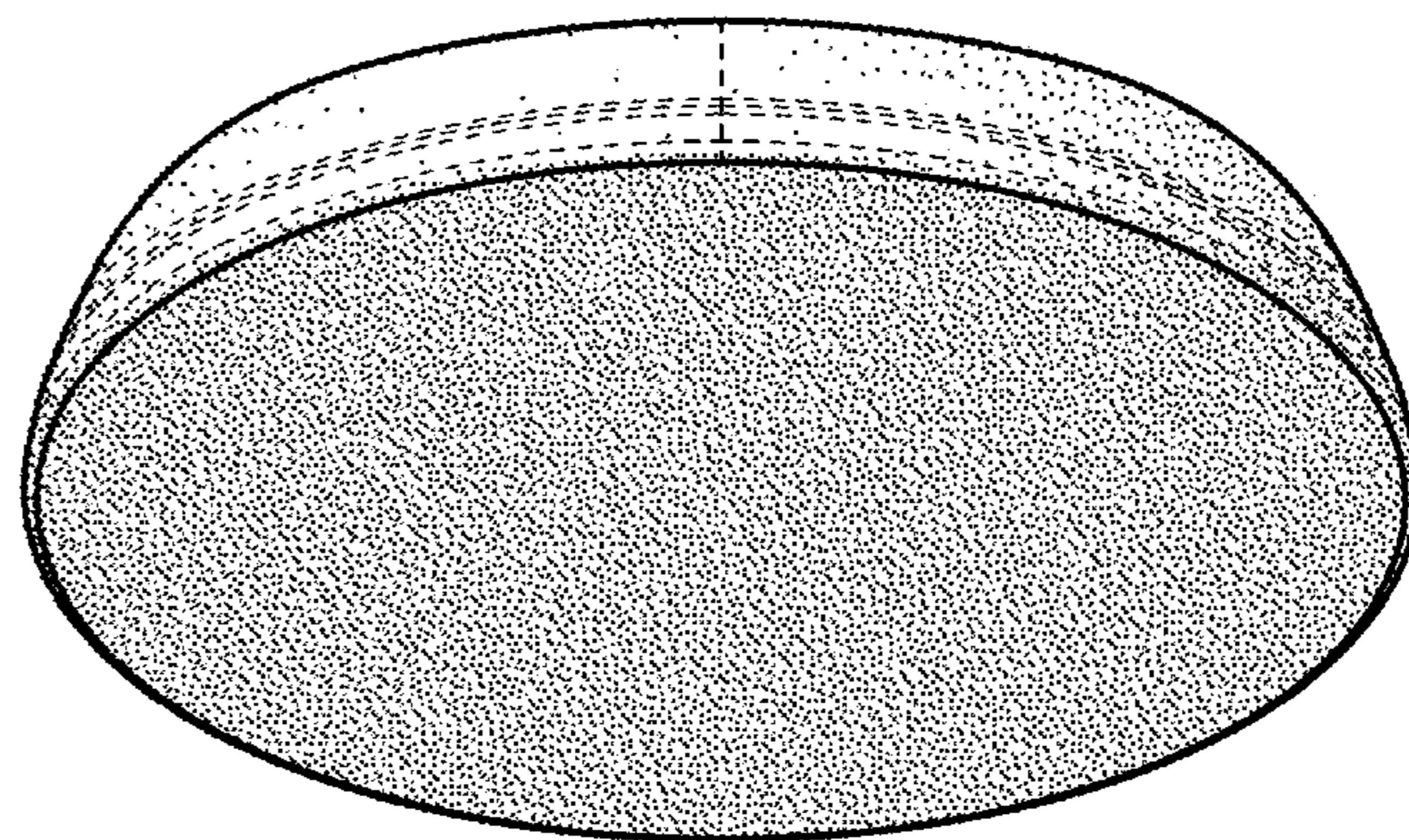

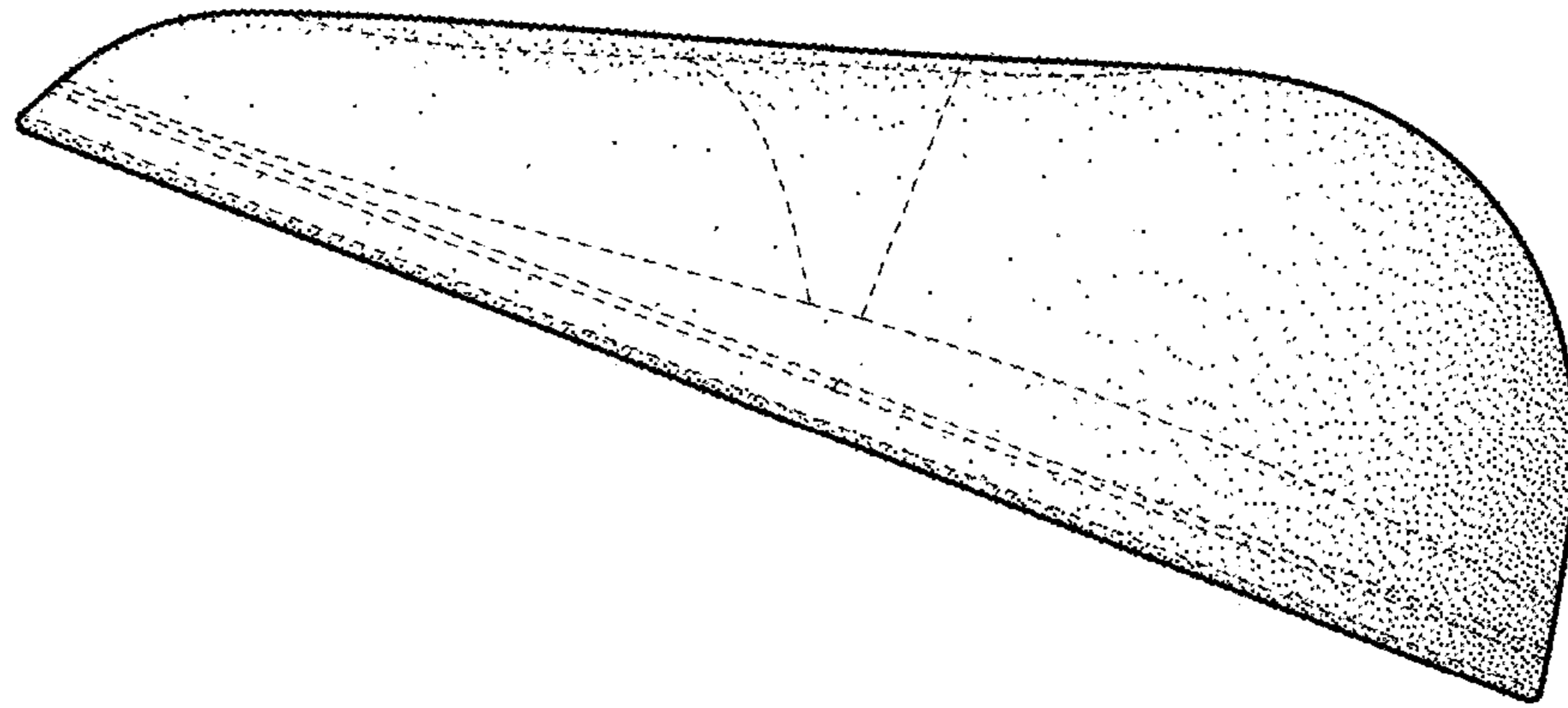

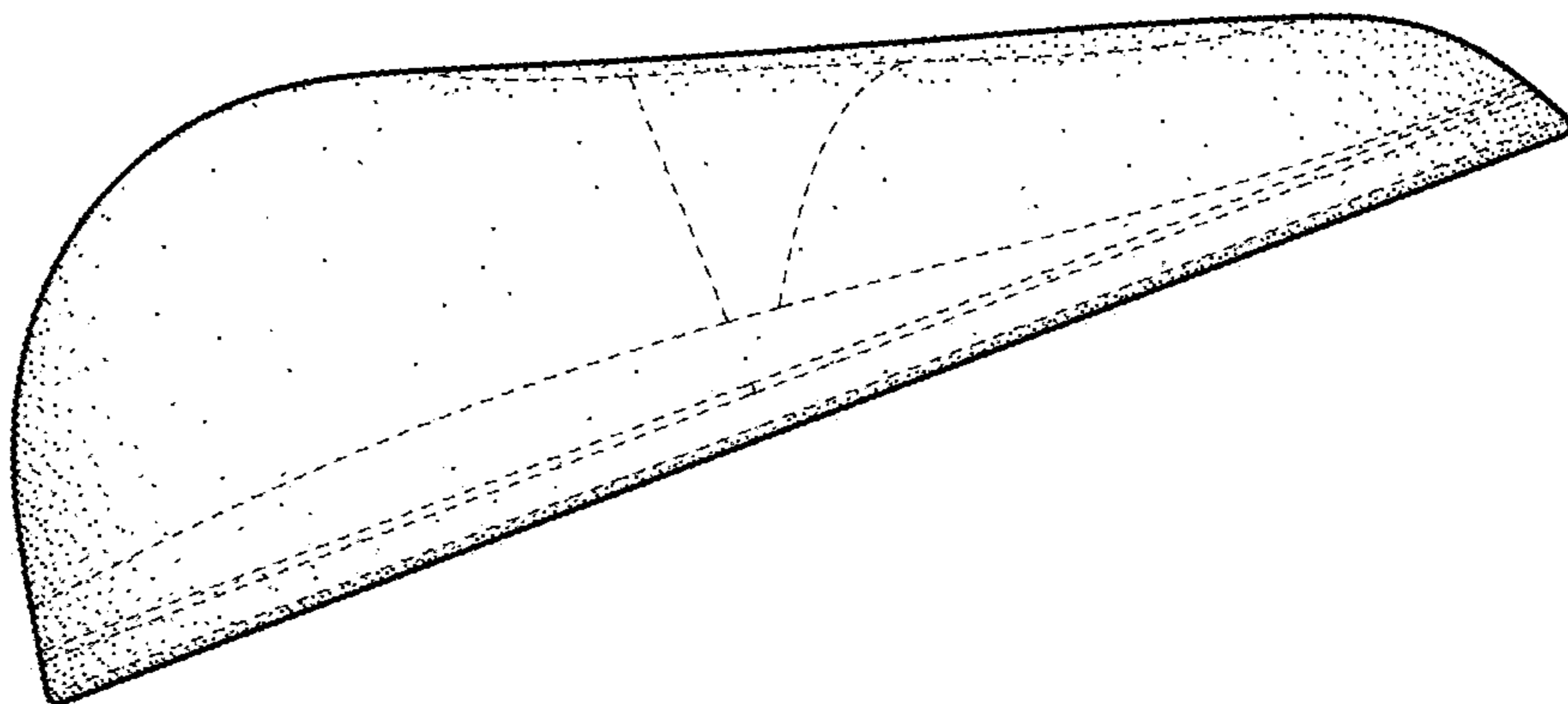

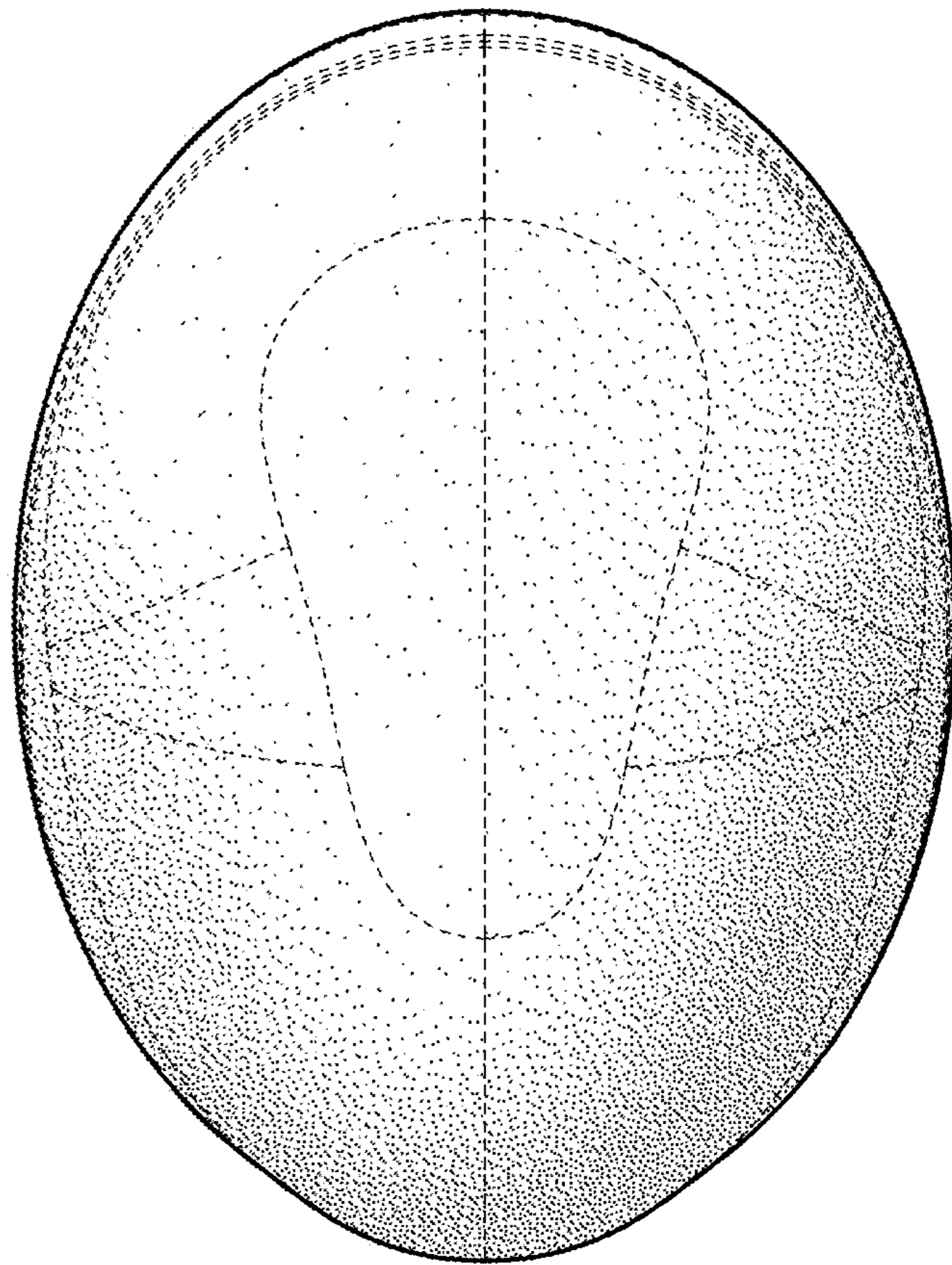

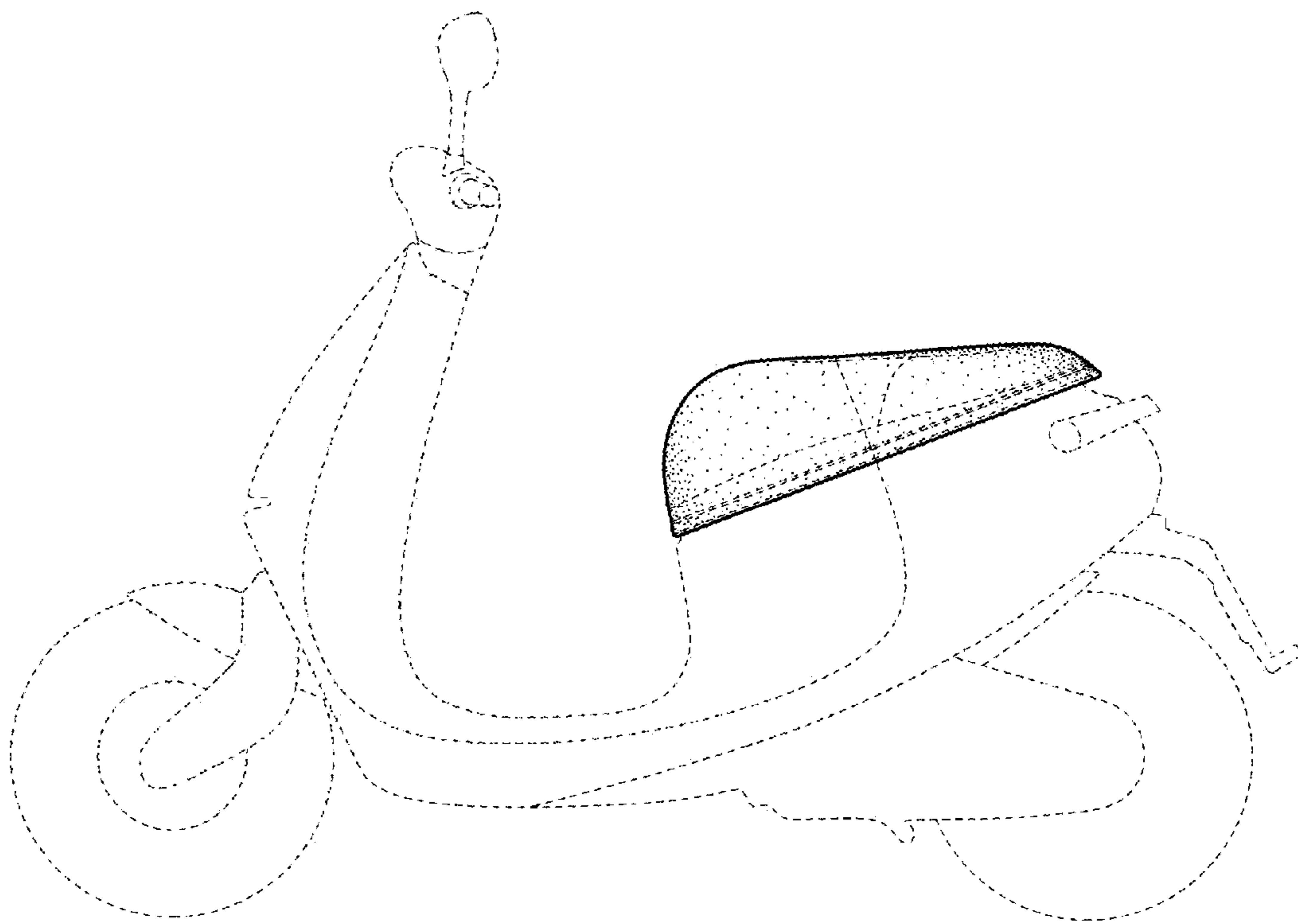

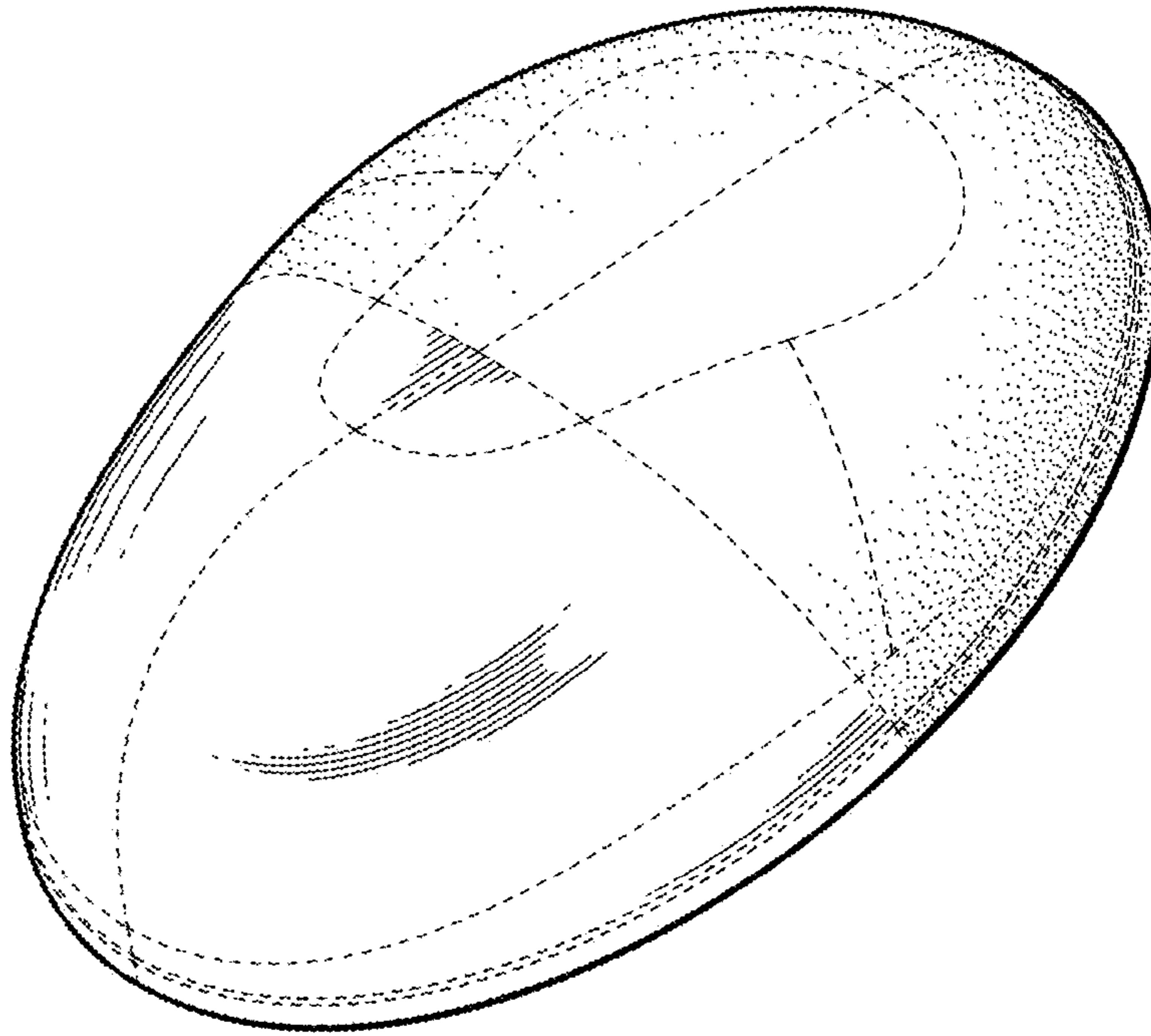

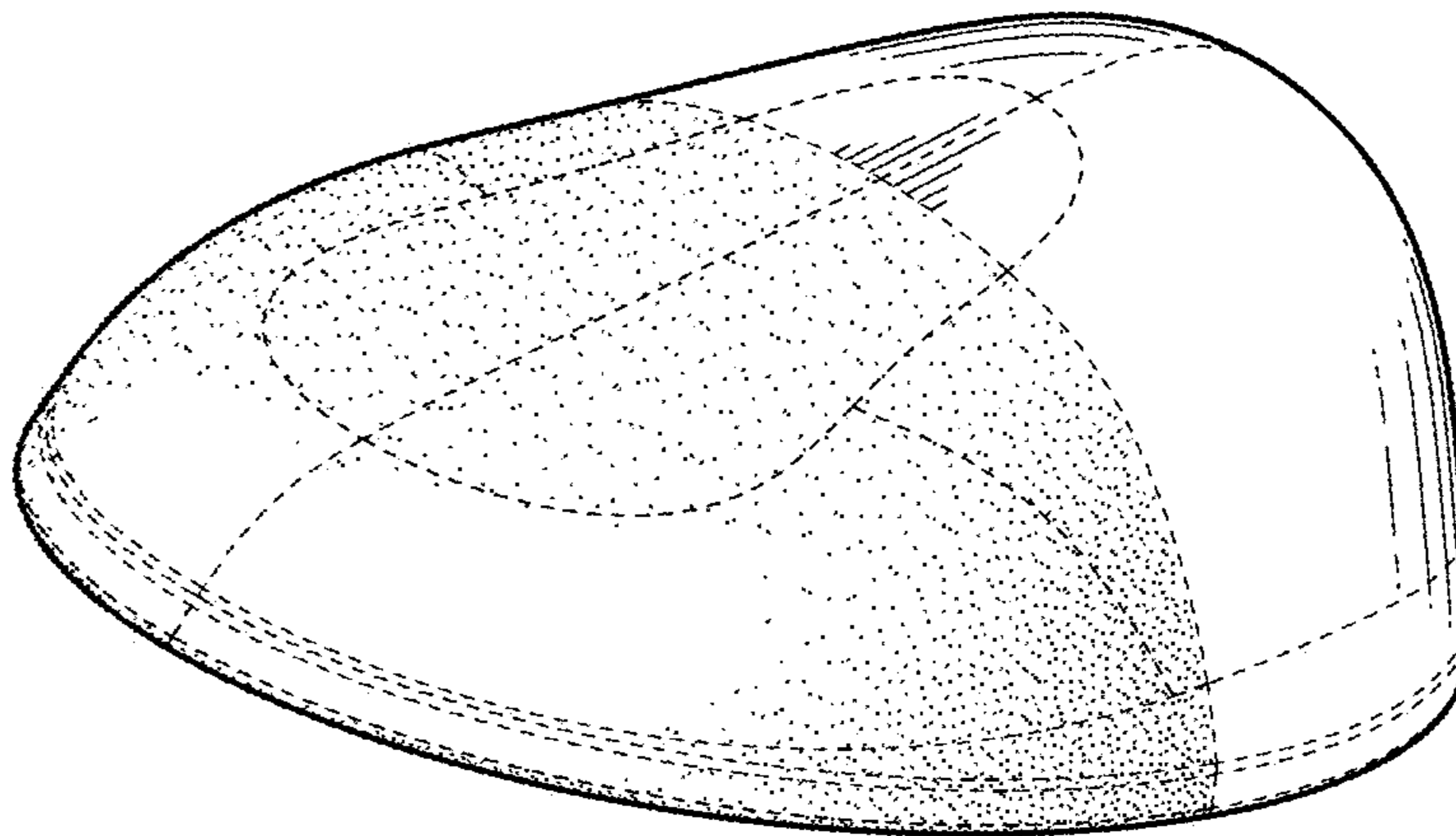

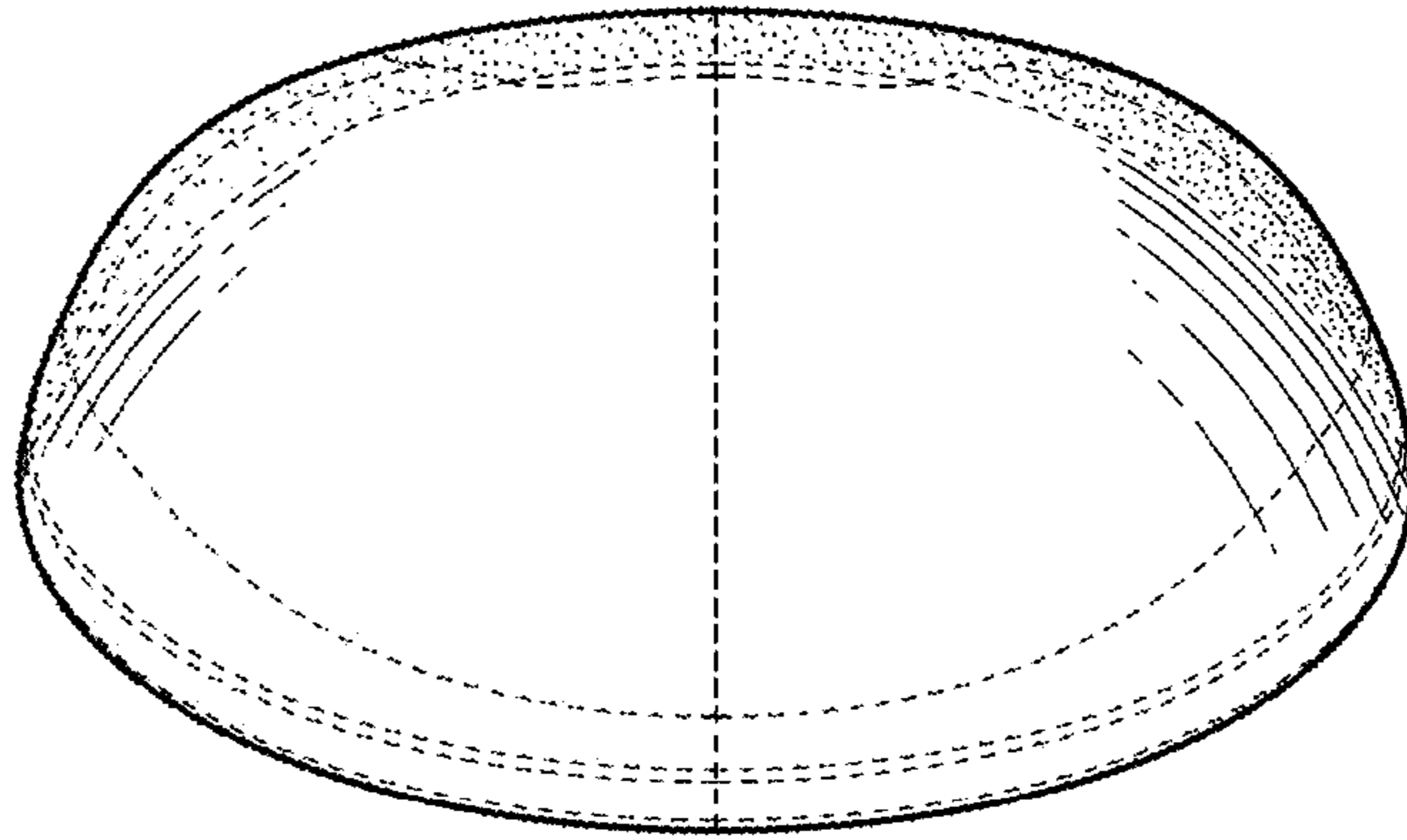

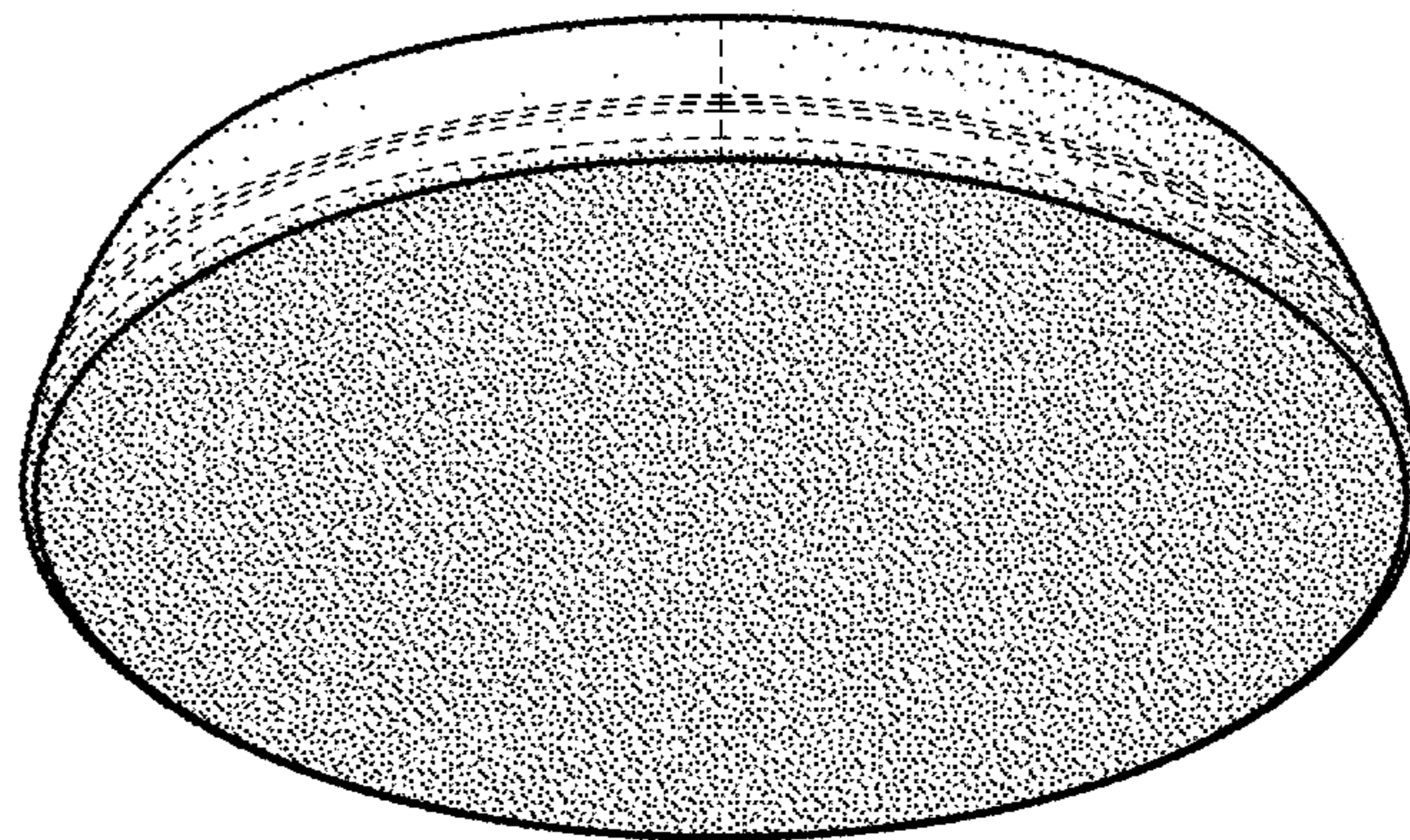

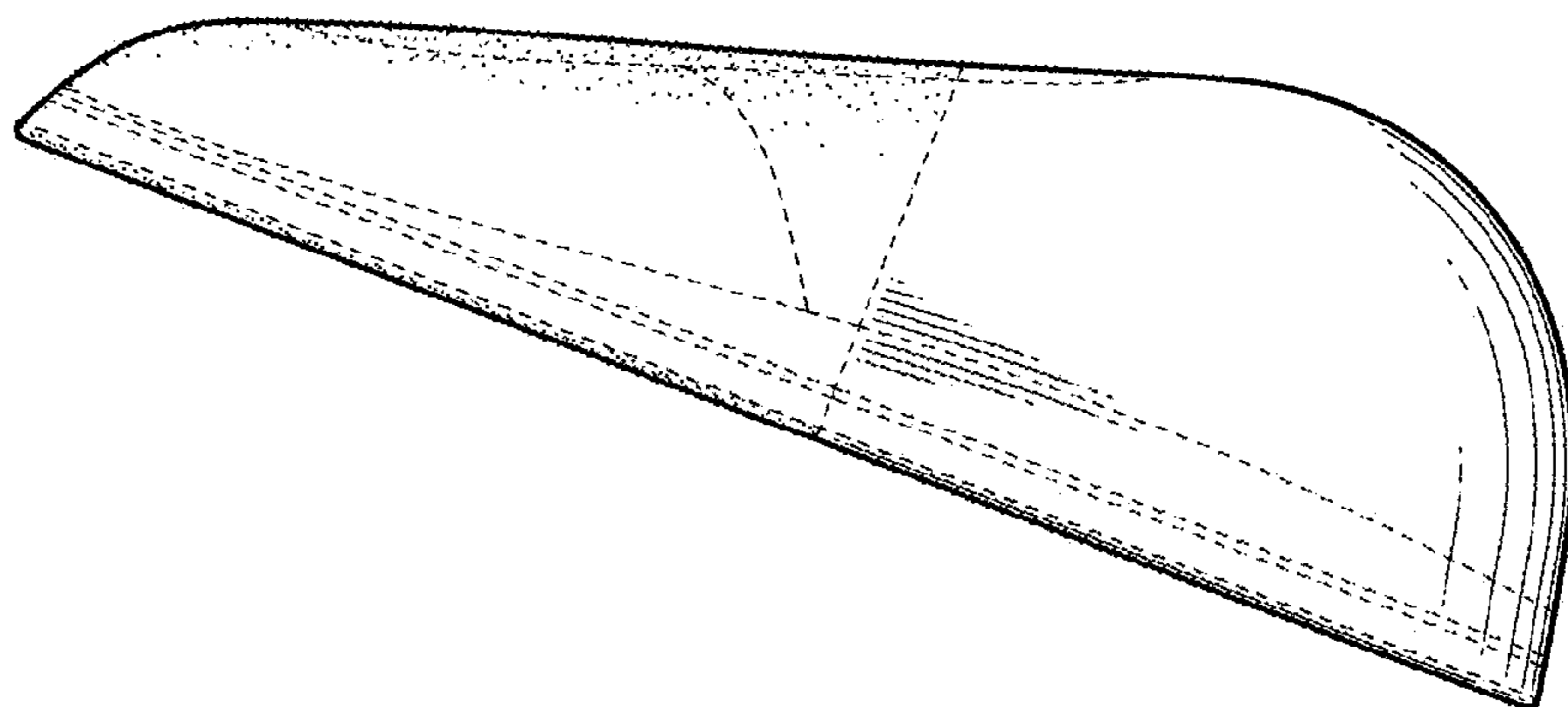

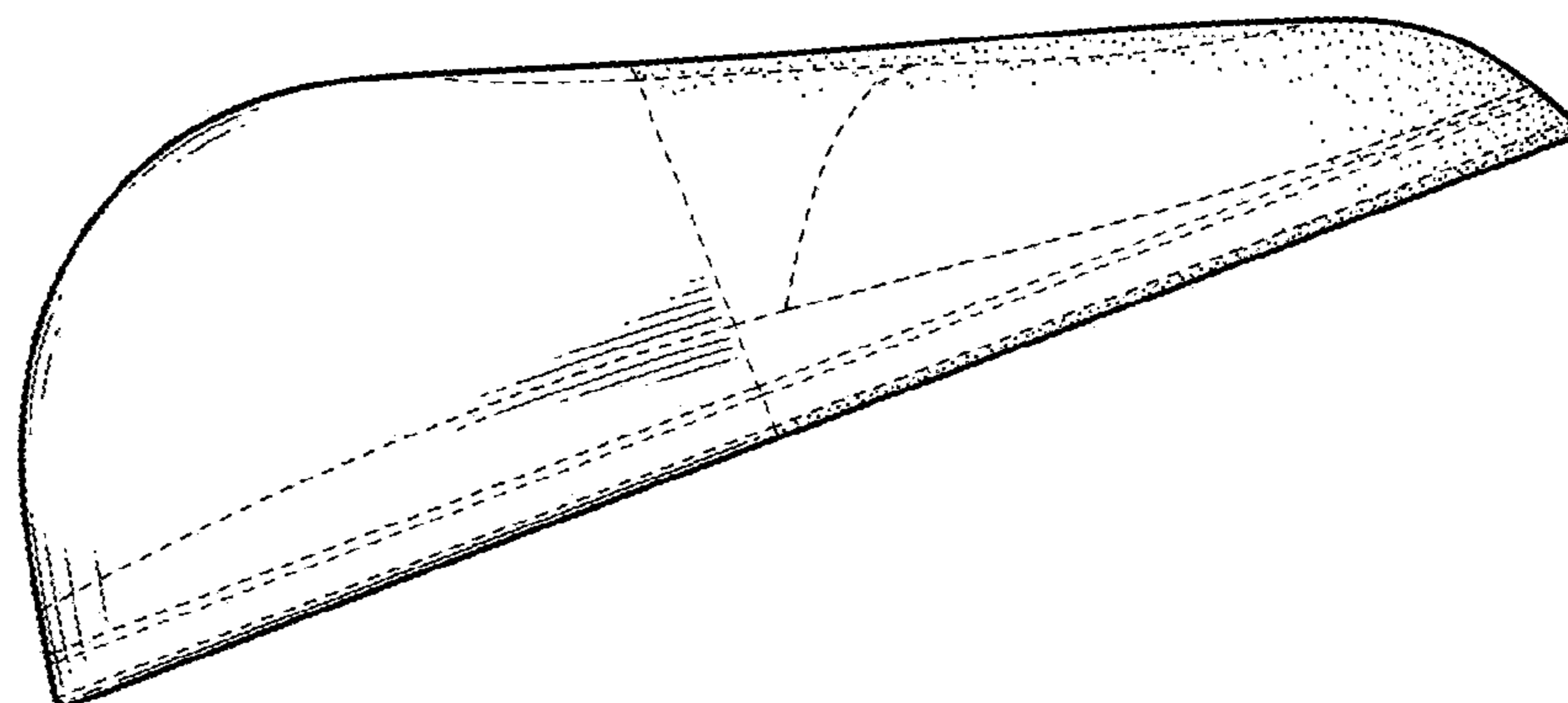

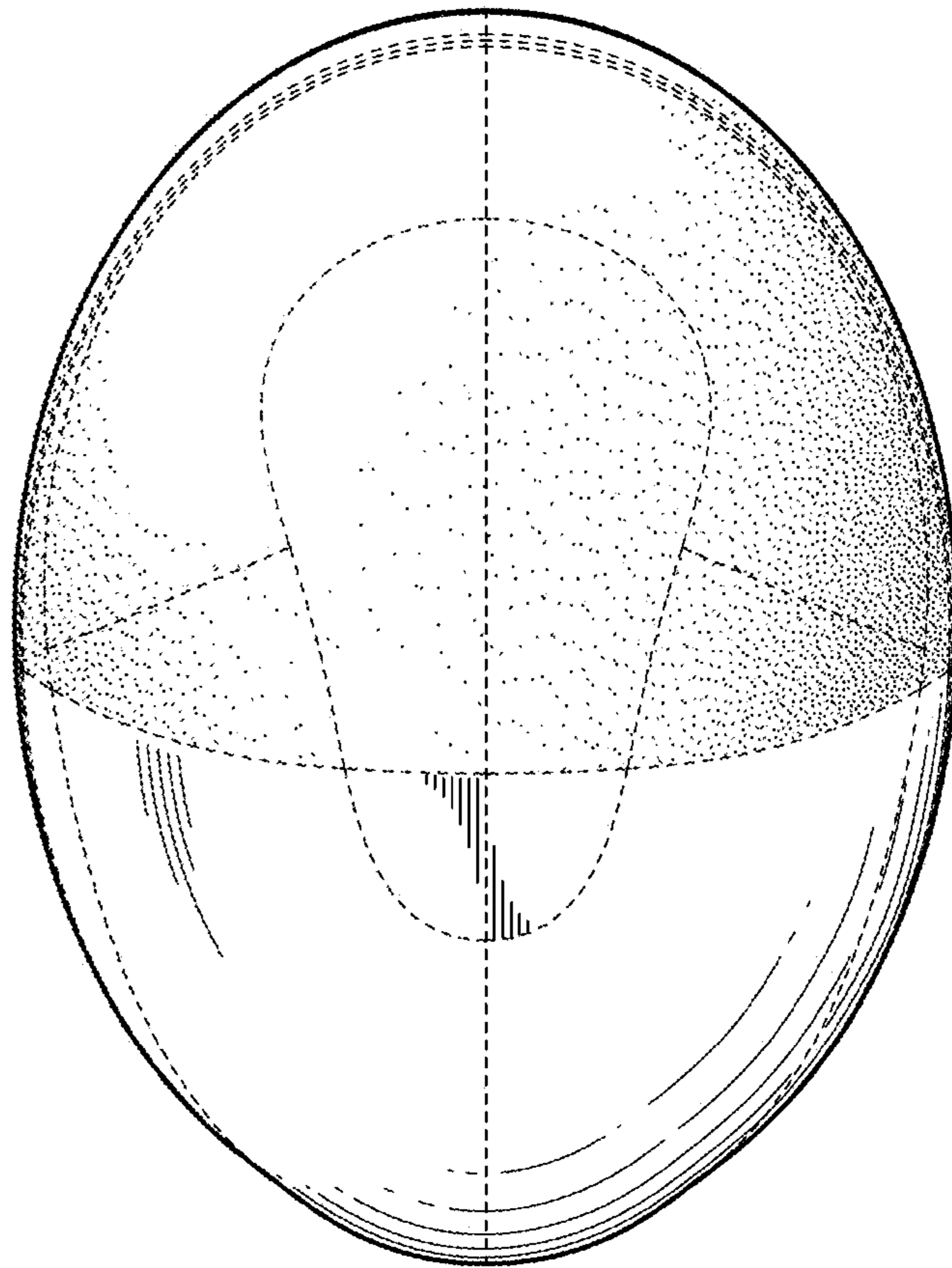

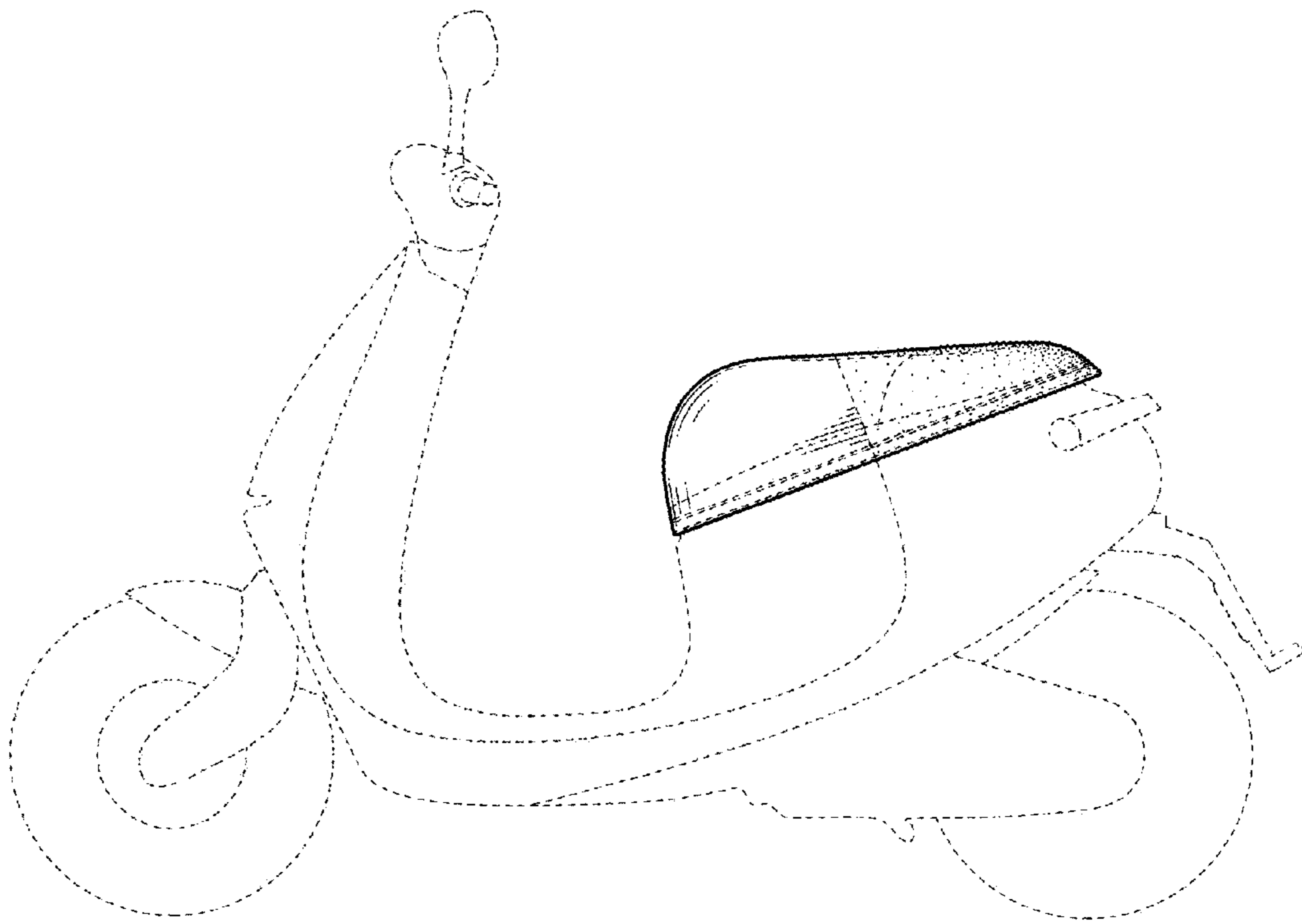
