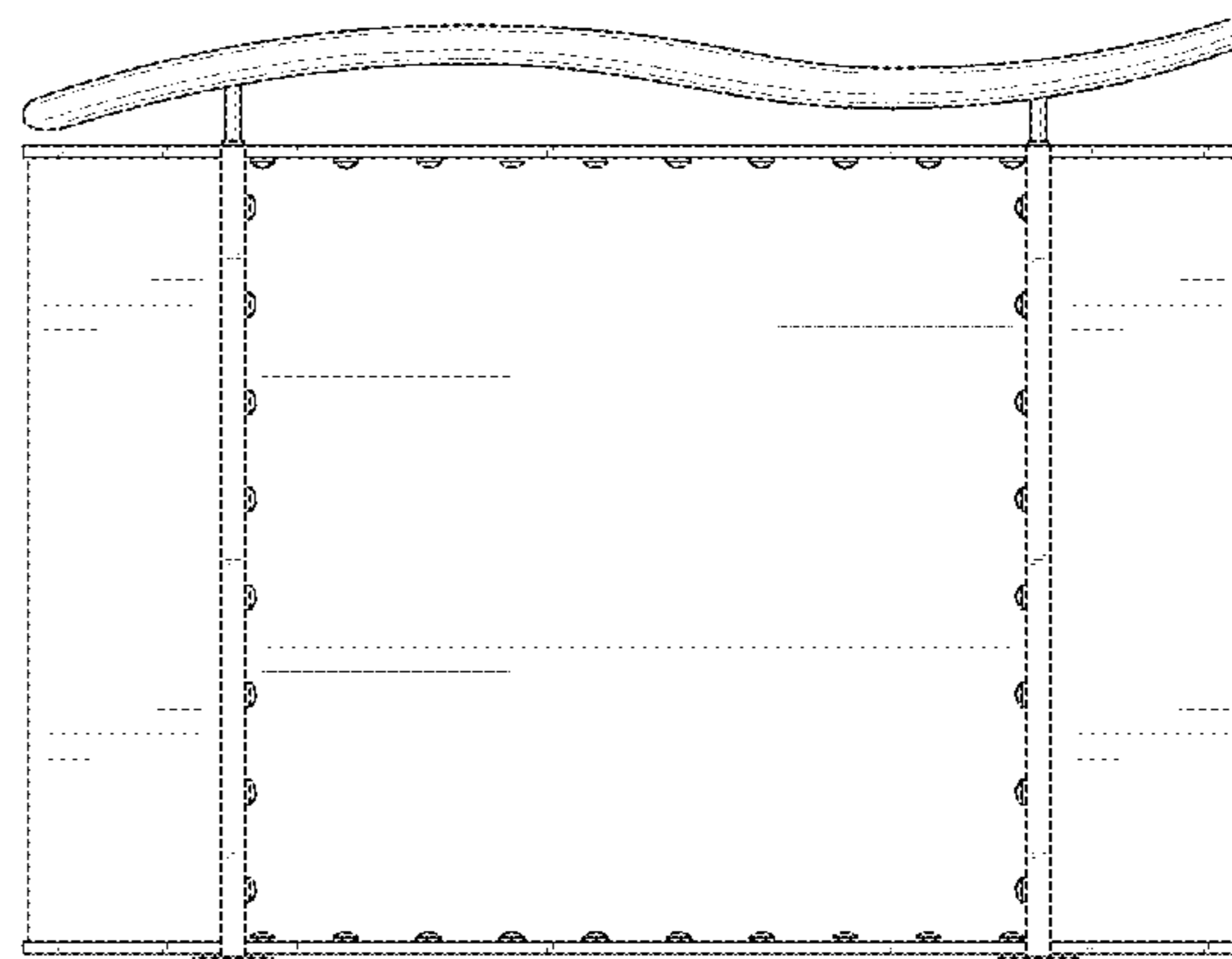
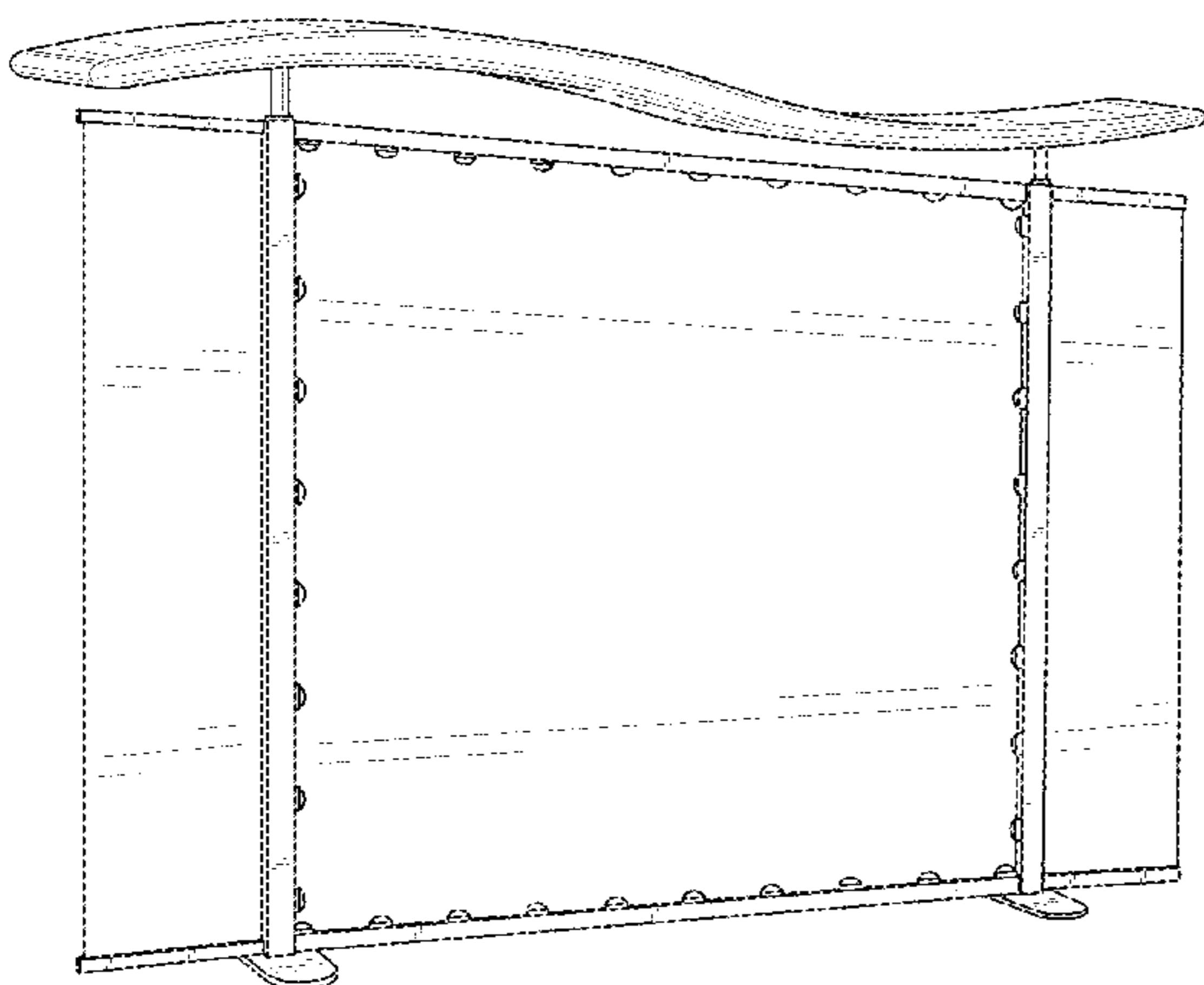
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a combined light box and display, showing our new design;

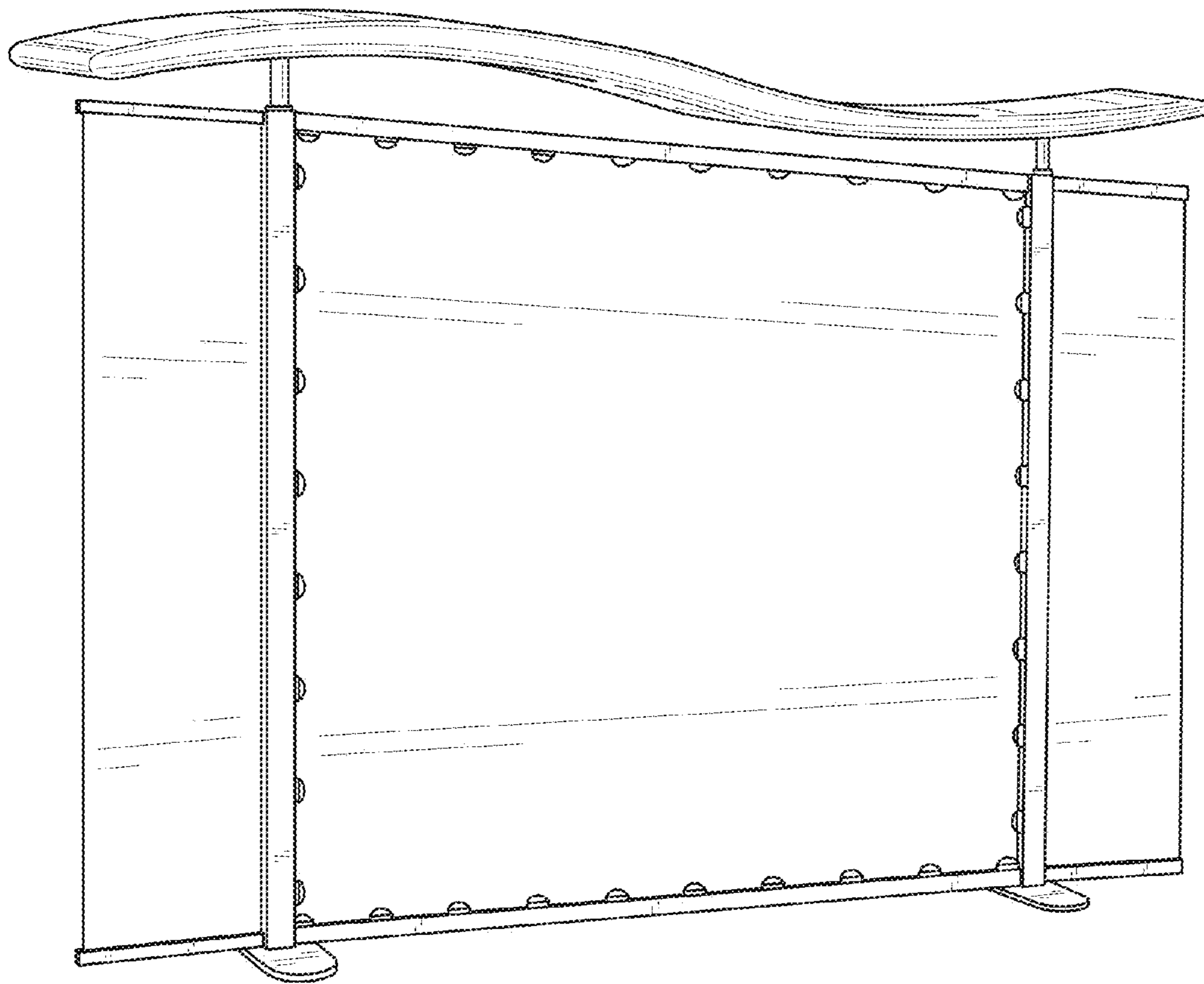

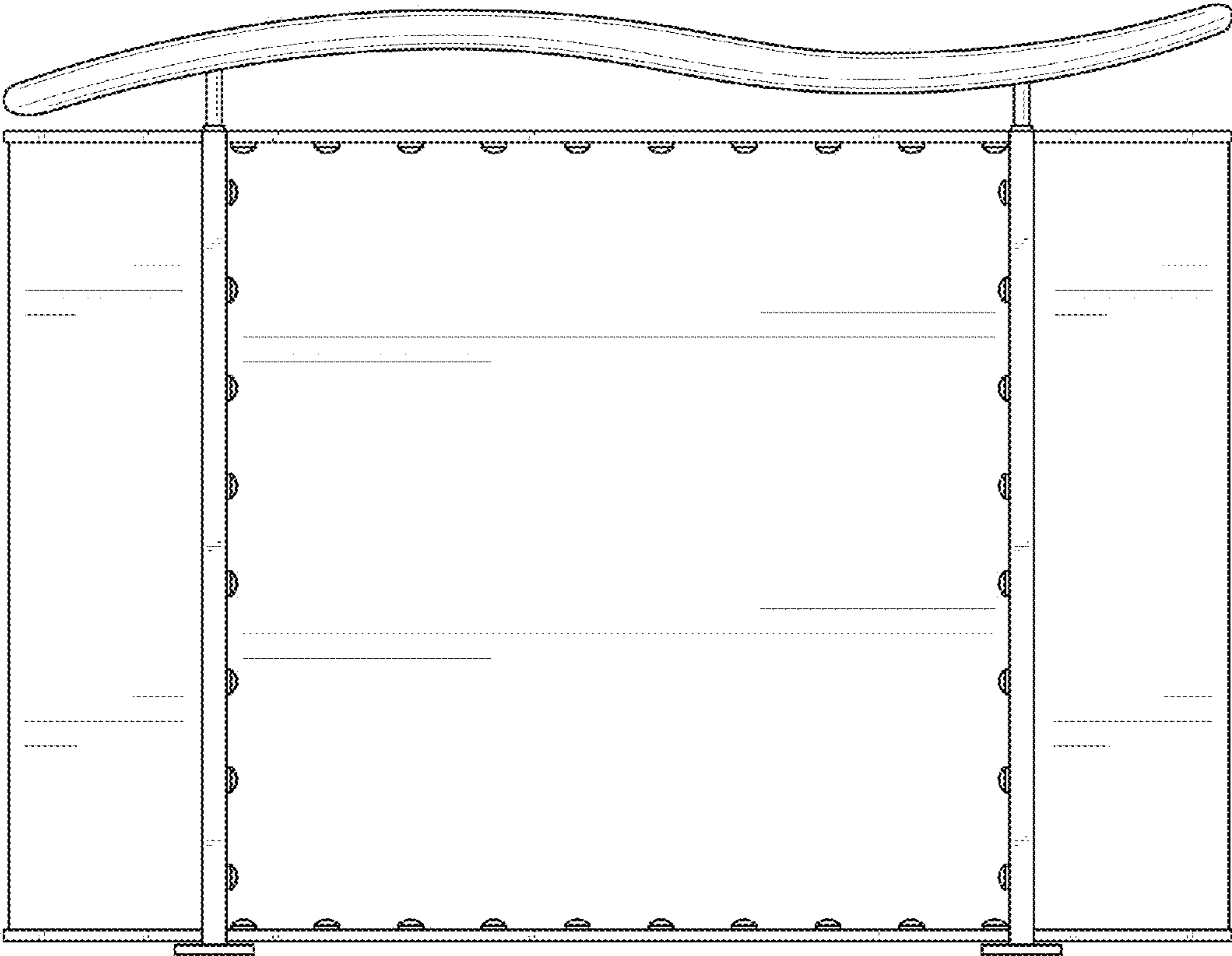

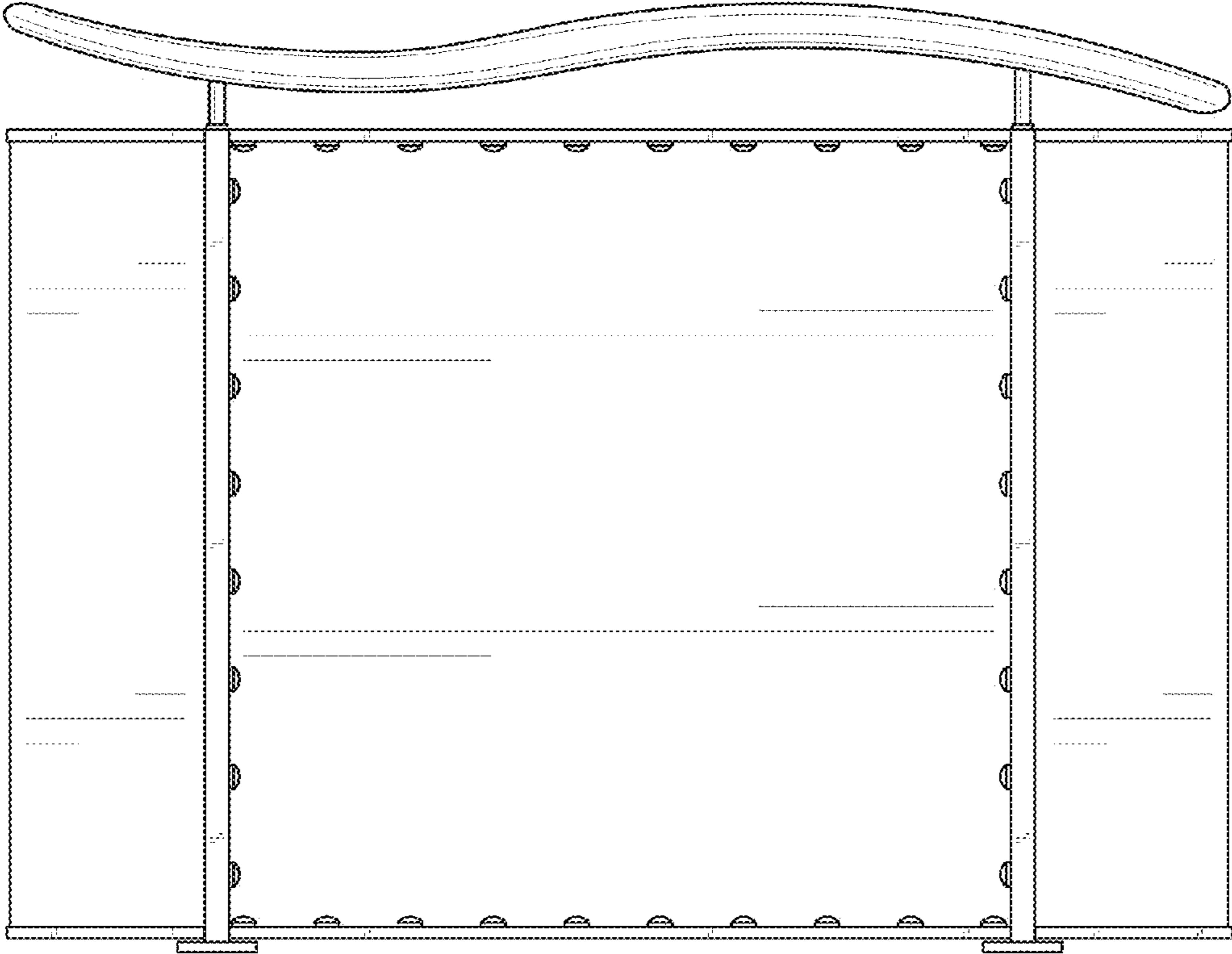

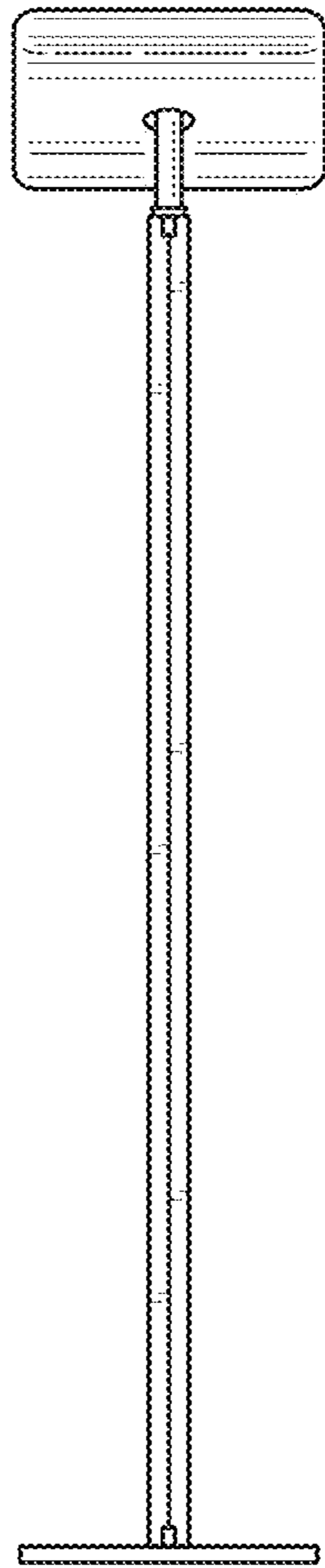

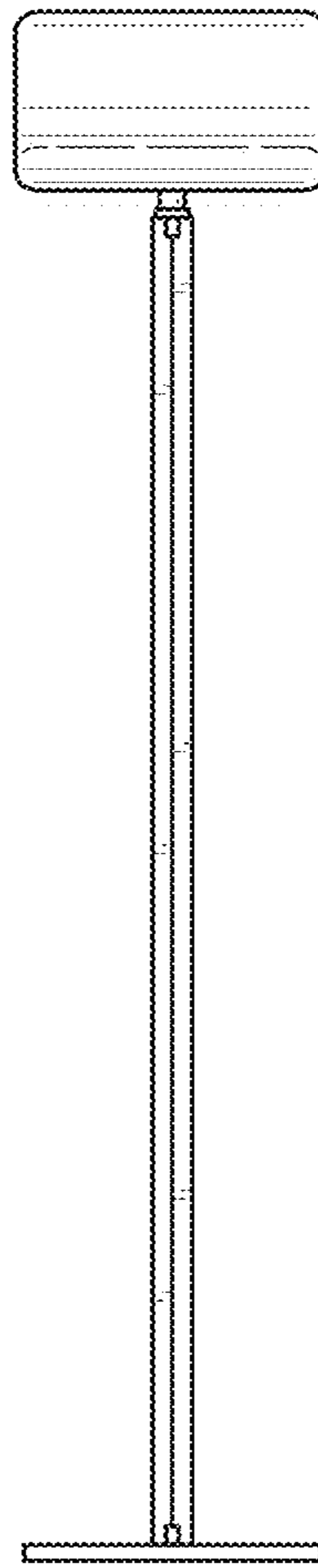

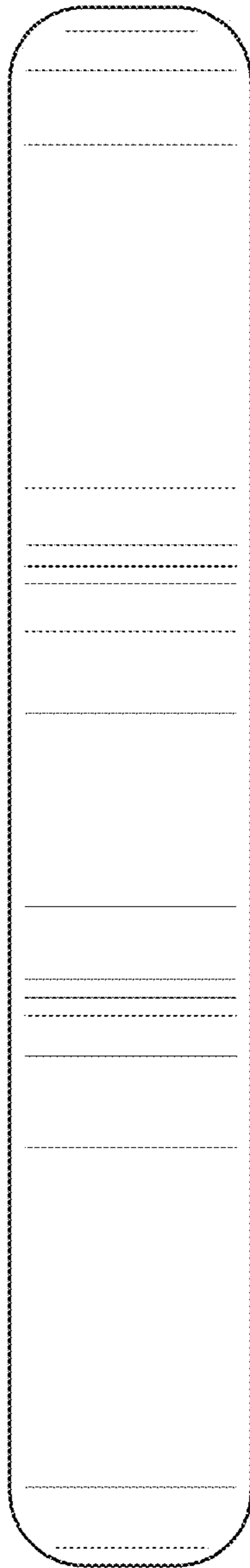

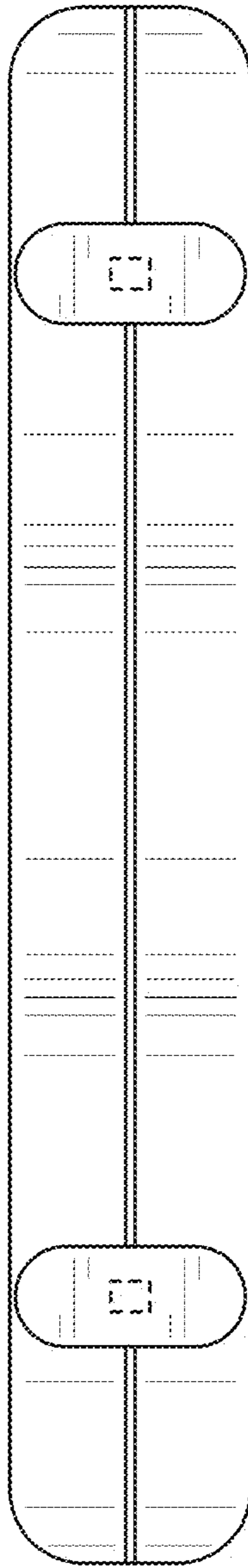
