DESCRIPTION

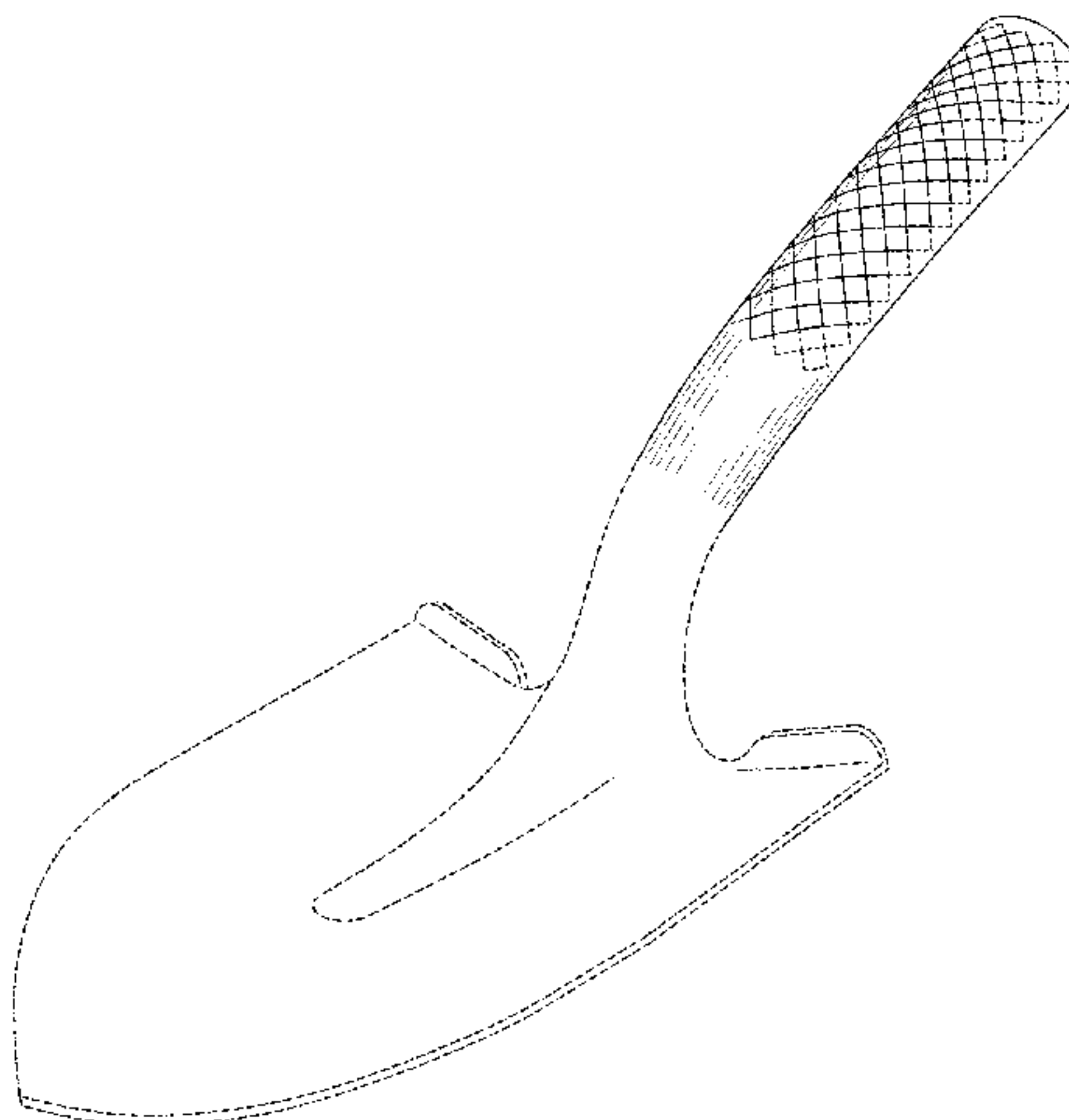
FIG. 1 is an isometric view of the cross hatched socket for garden tool head;

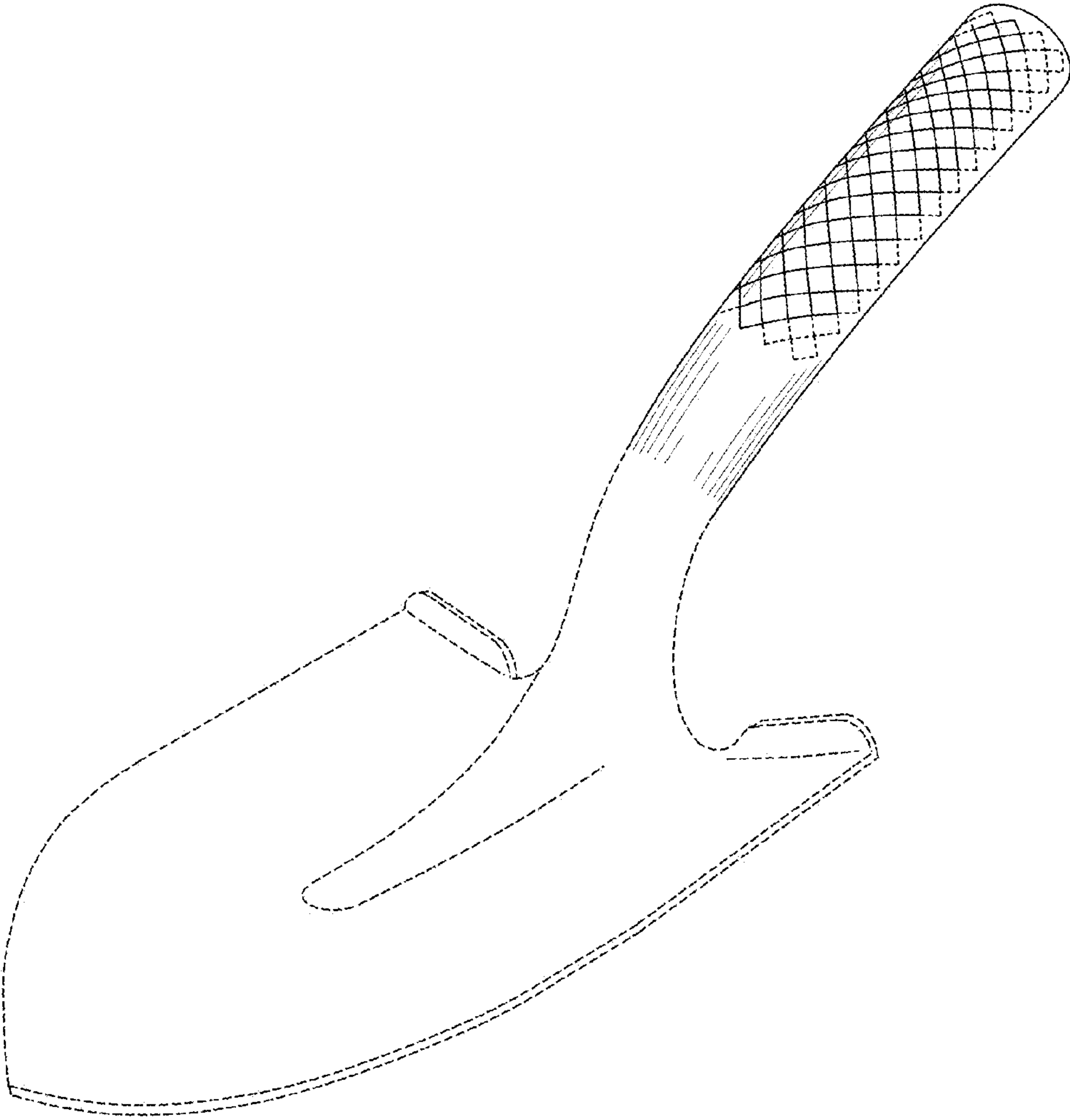

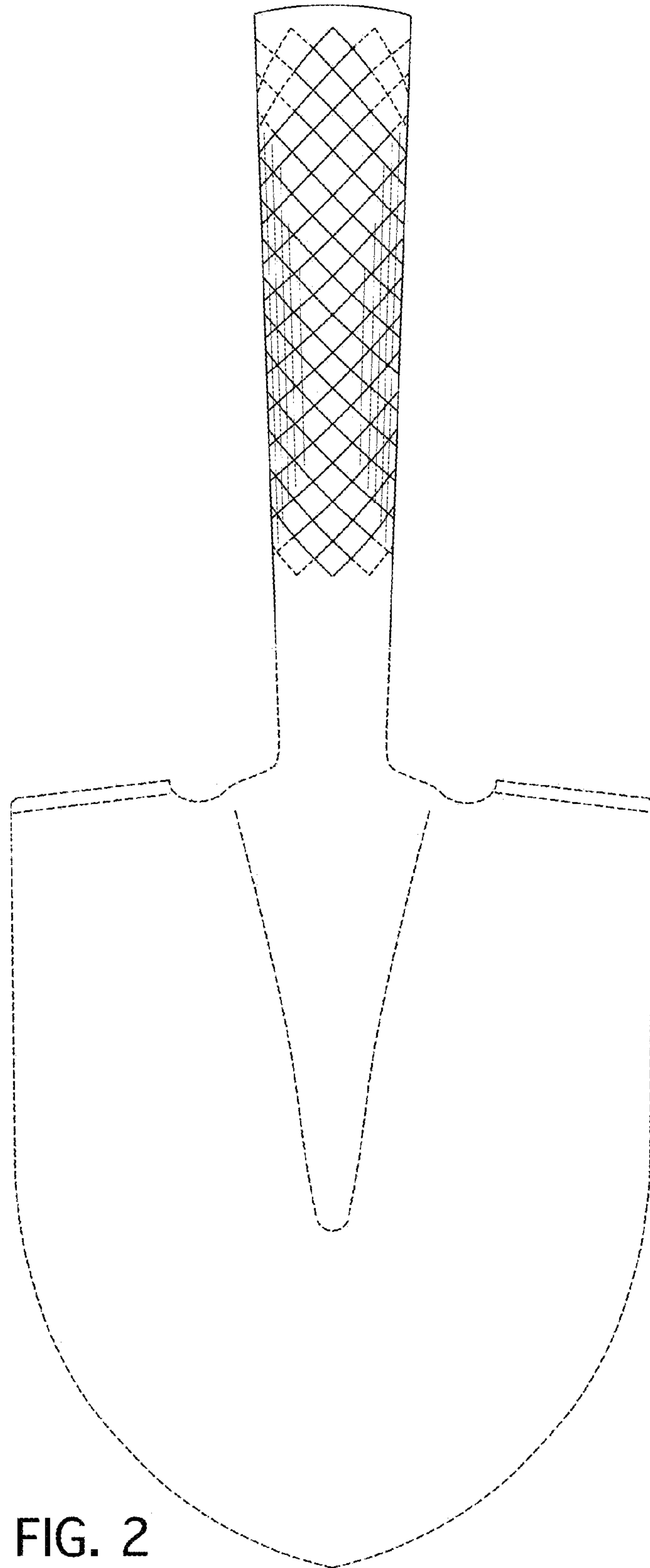

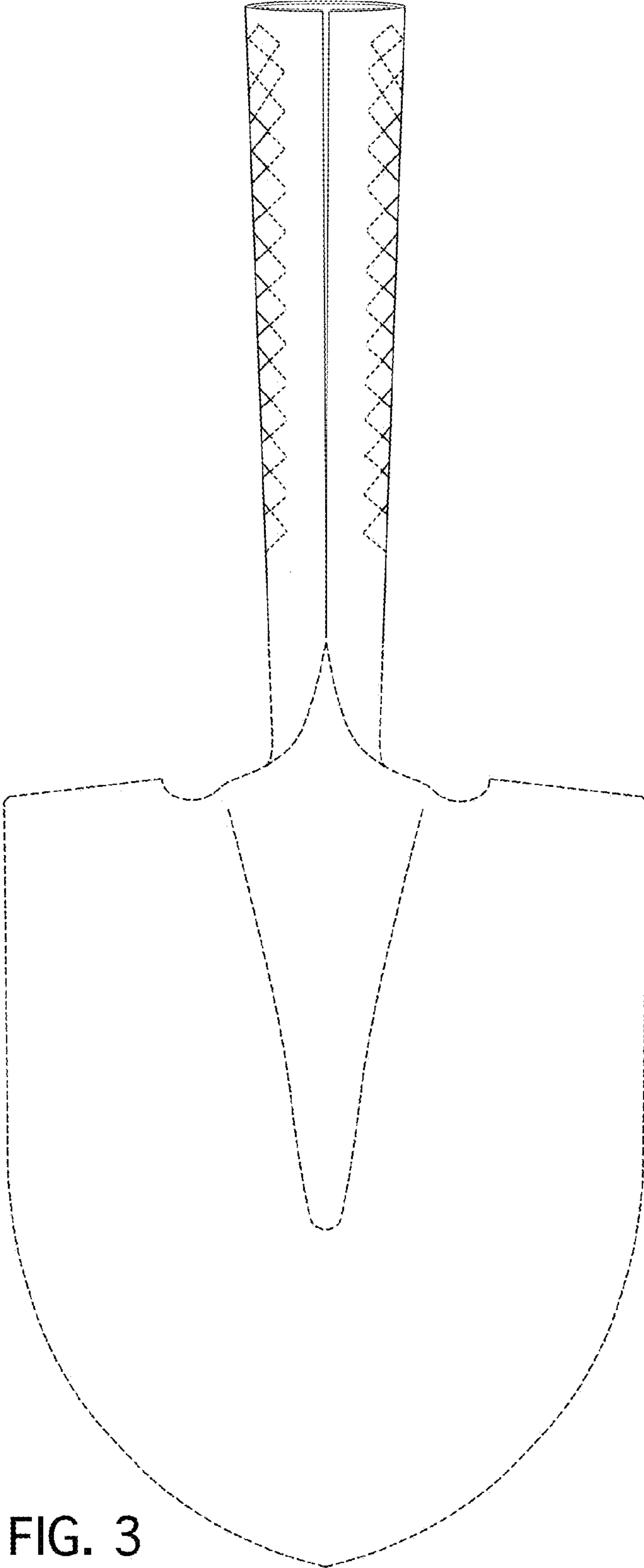

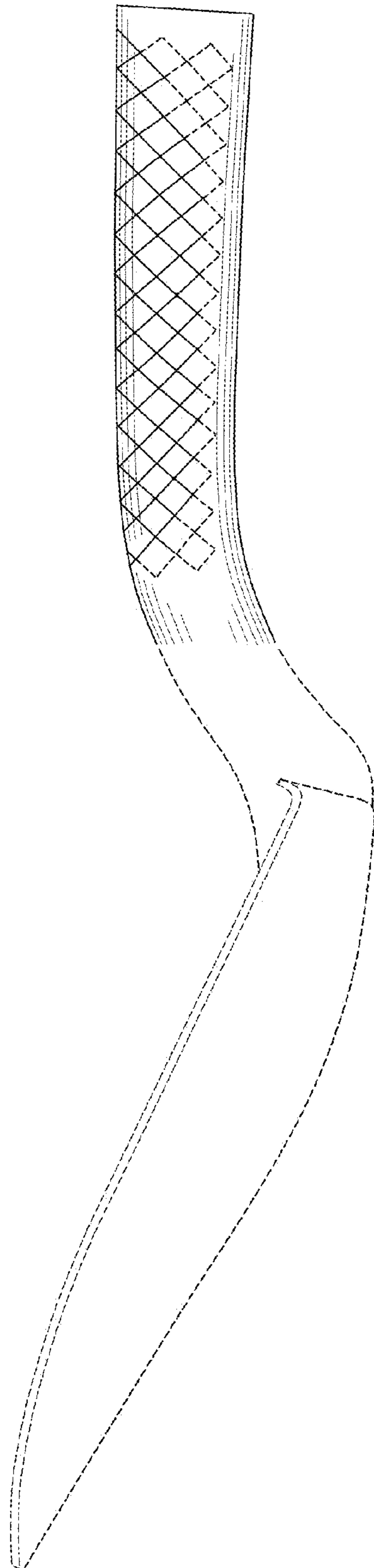

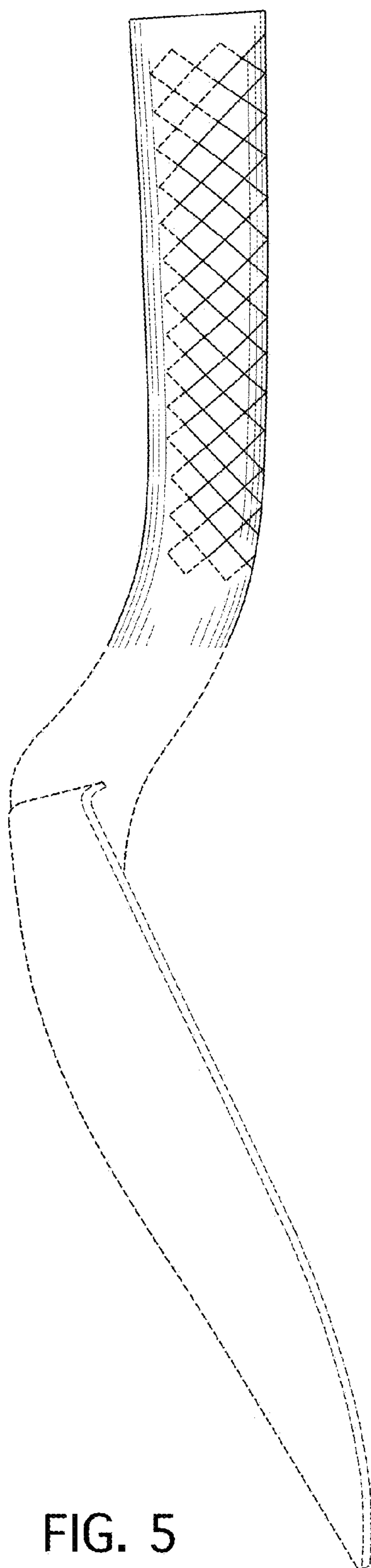

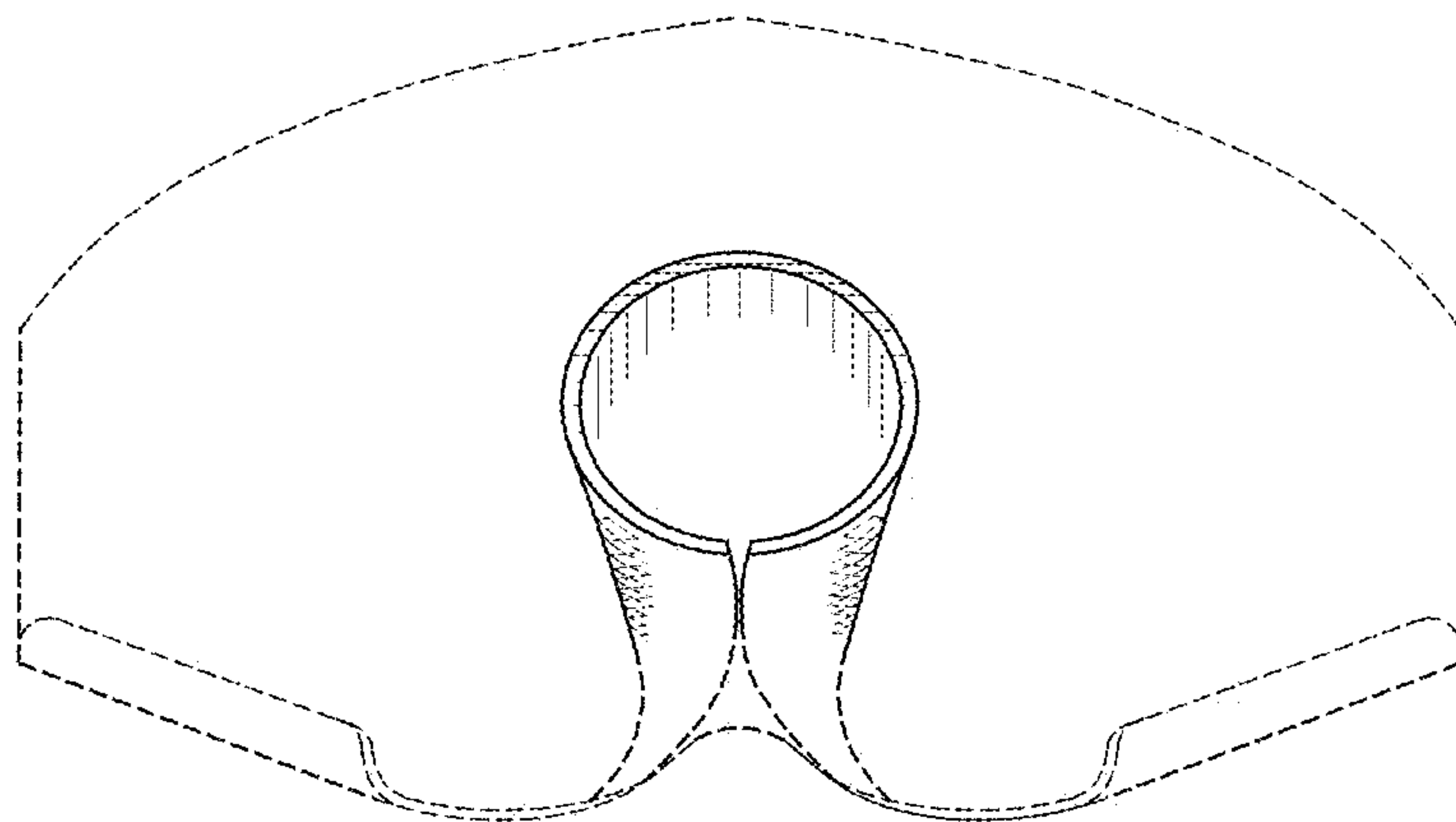
