DESCRIPTION

FIG. 12 is a second side view thereof;

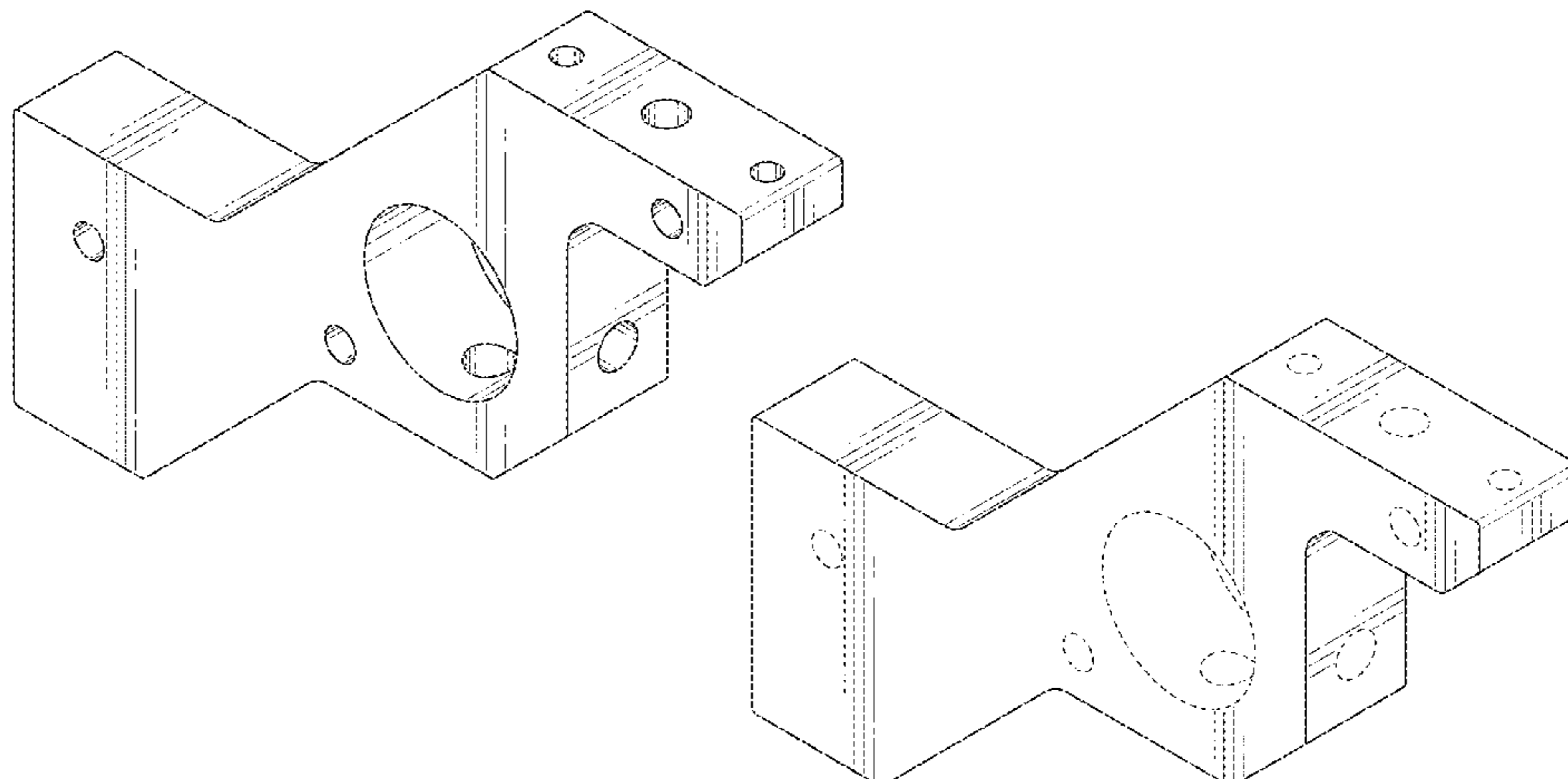
FIG. 13 is a top view thereof; and,

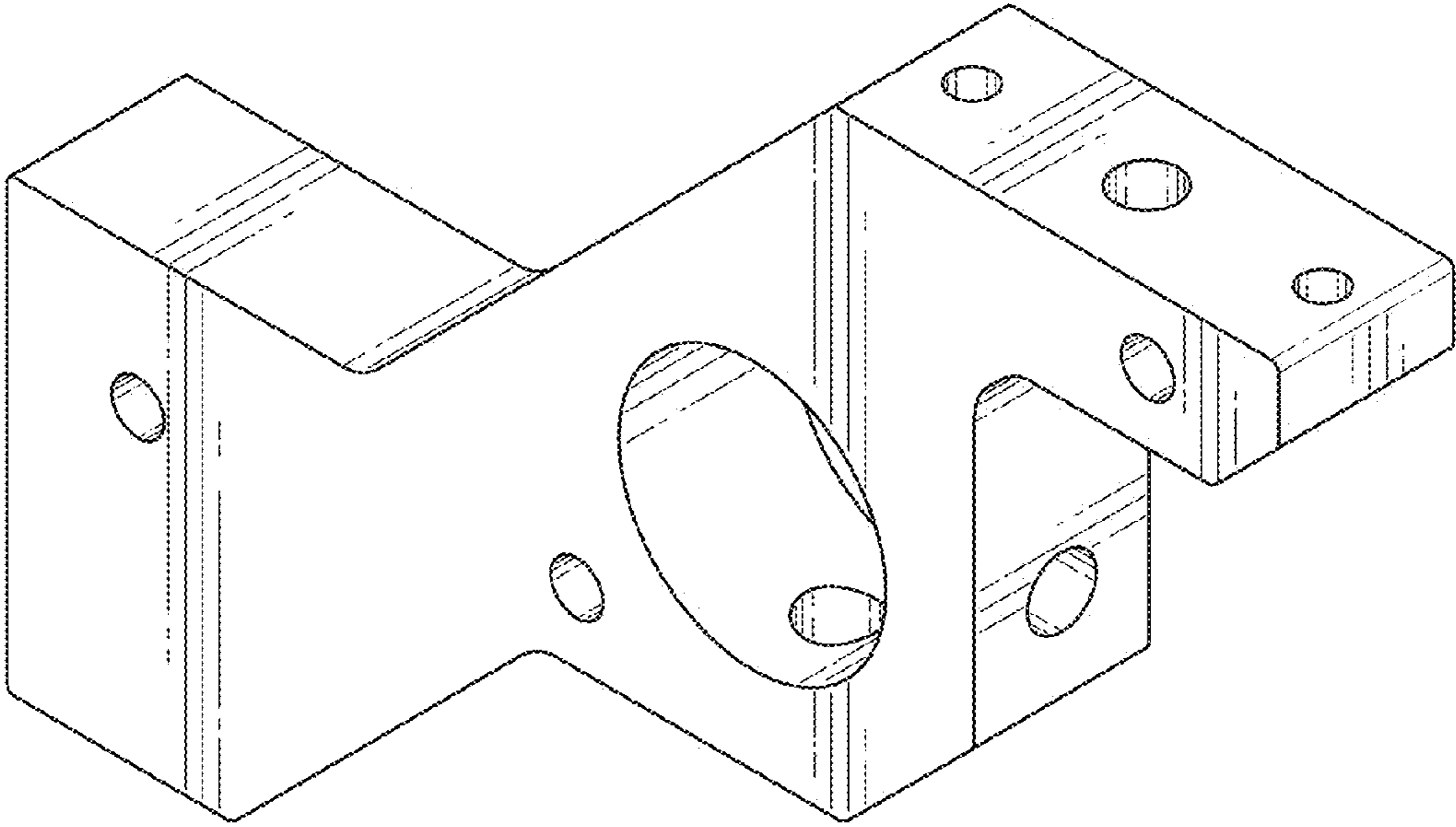

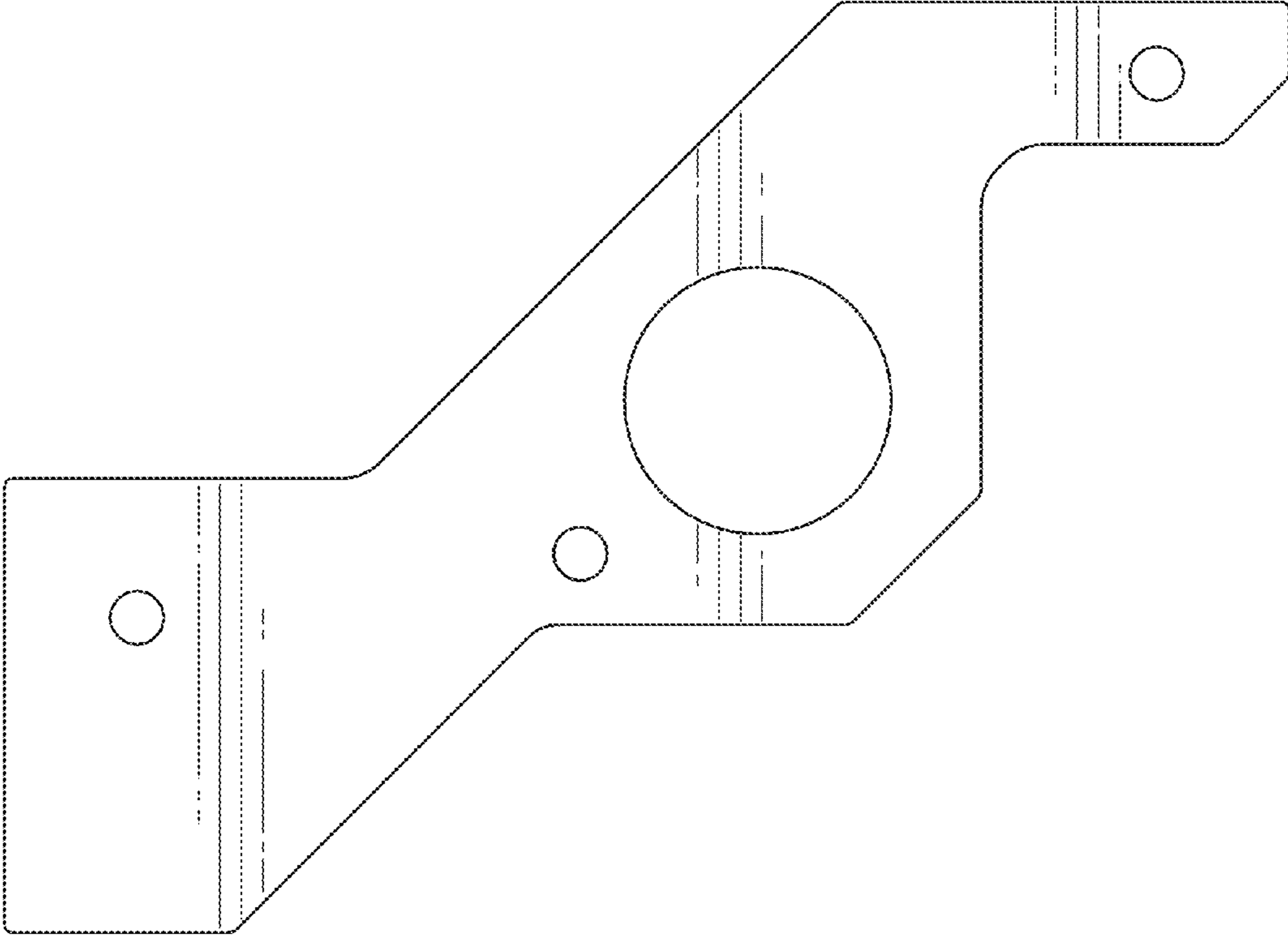

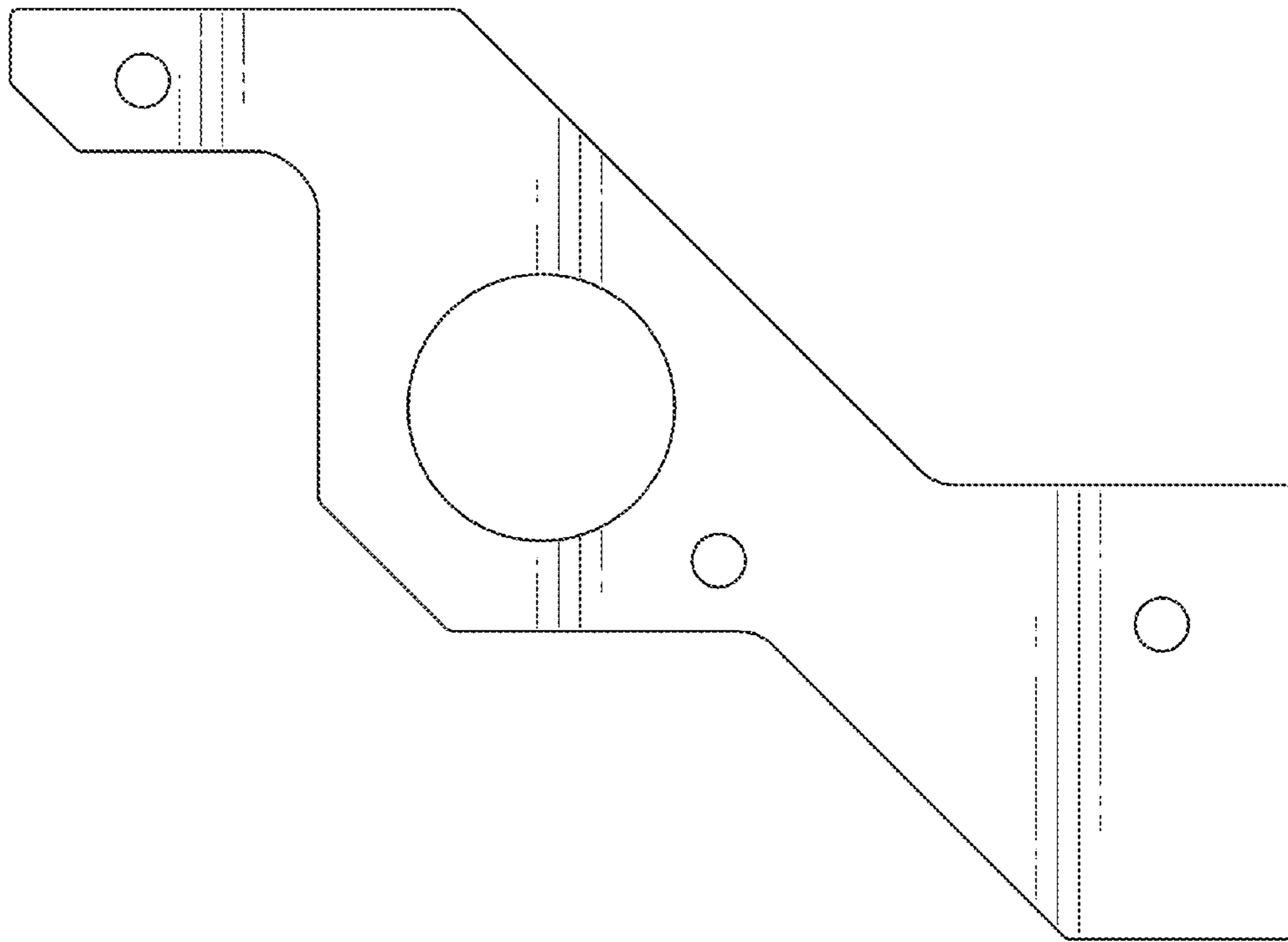

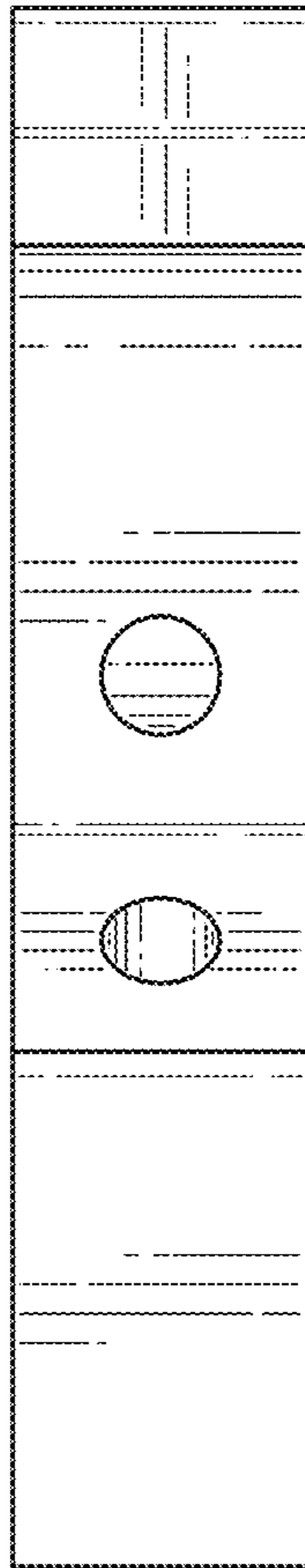

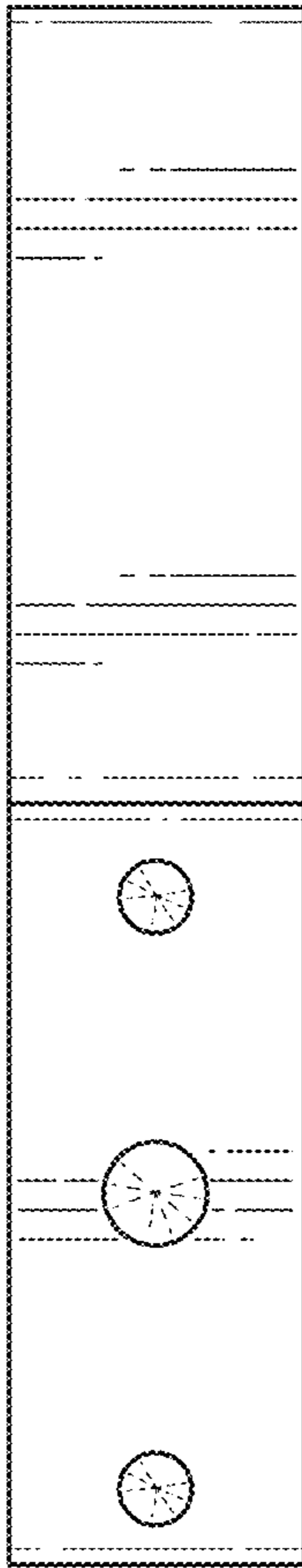

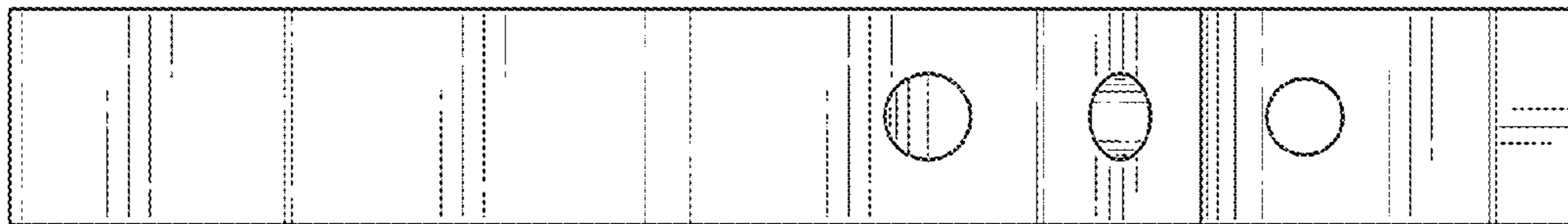

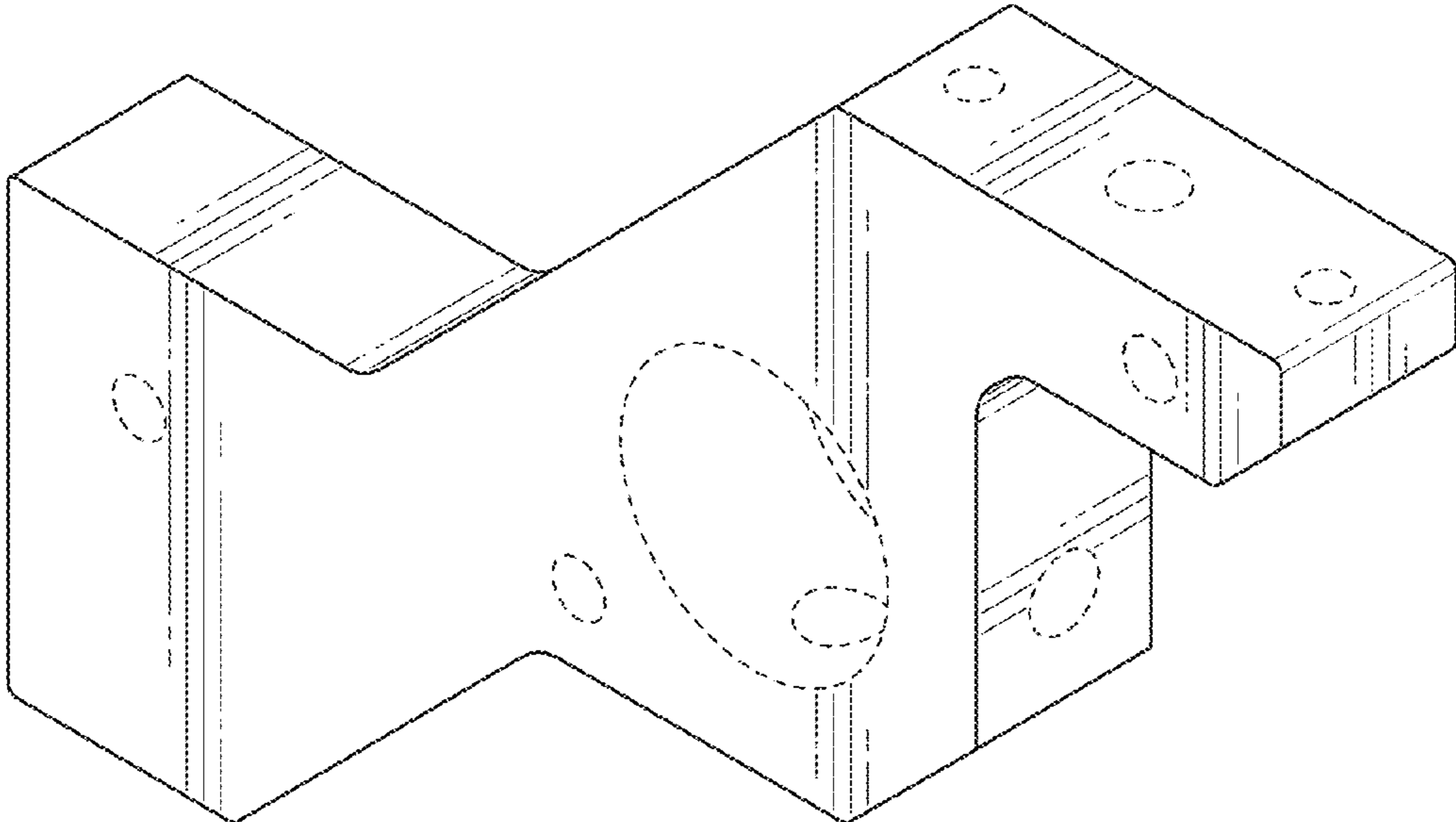

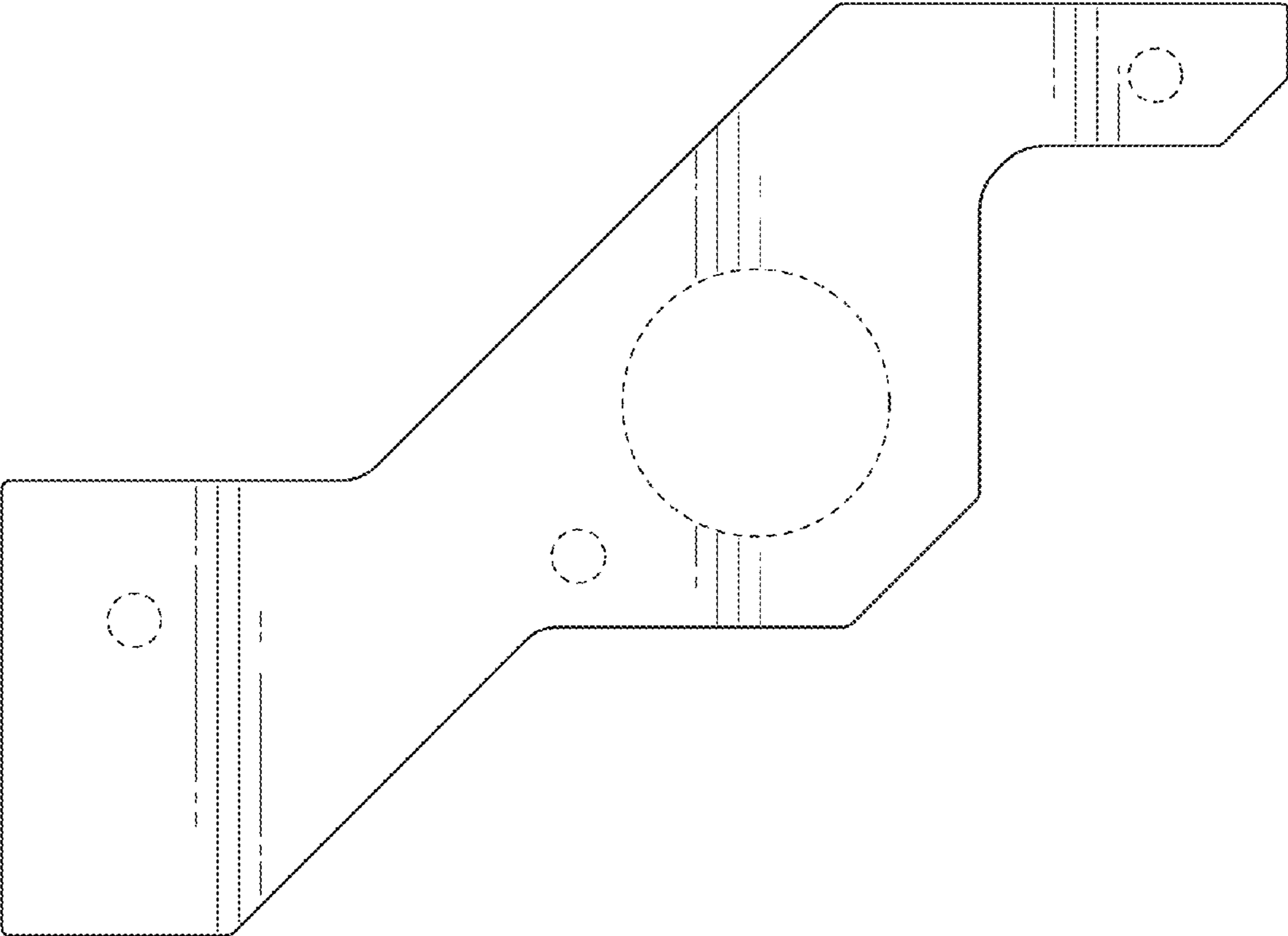

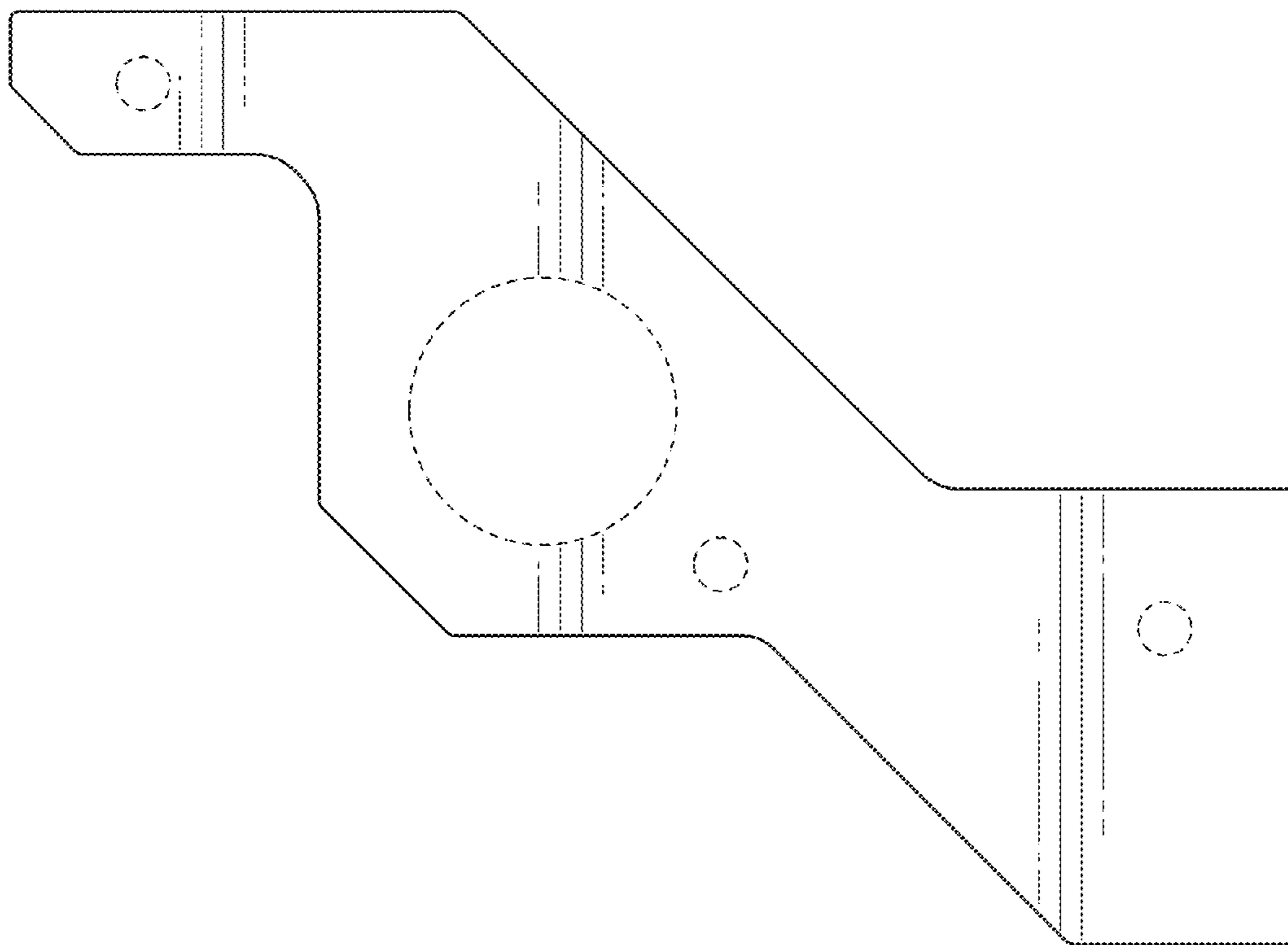

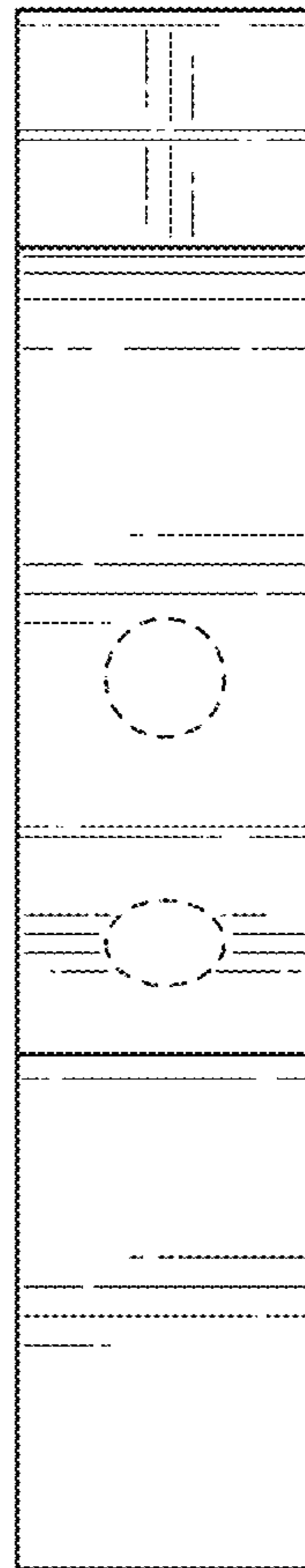

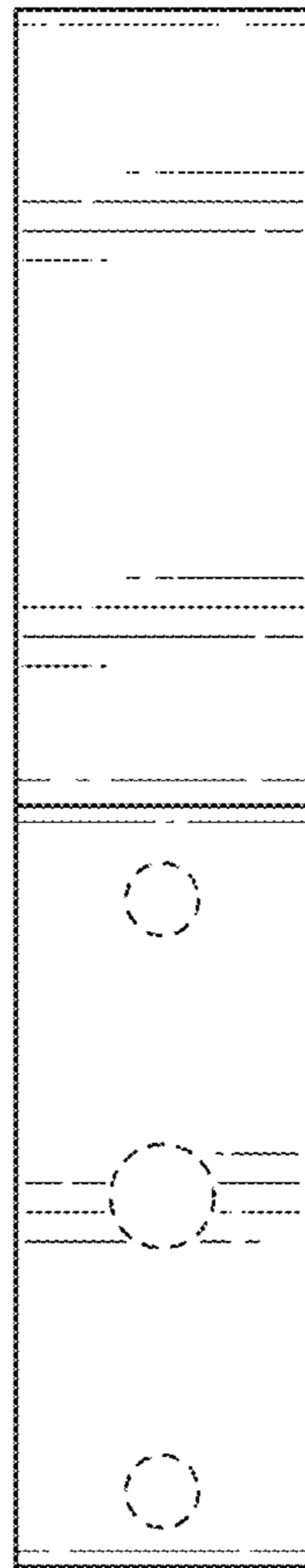

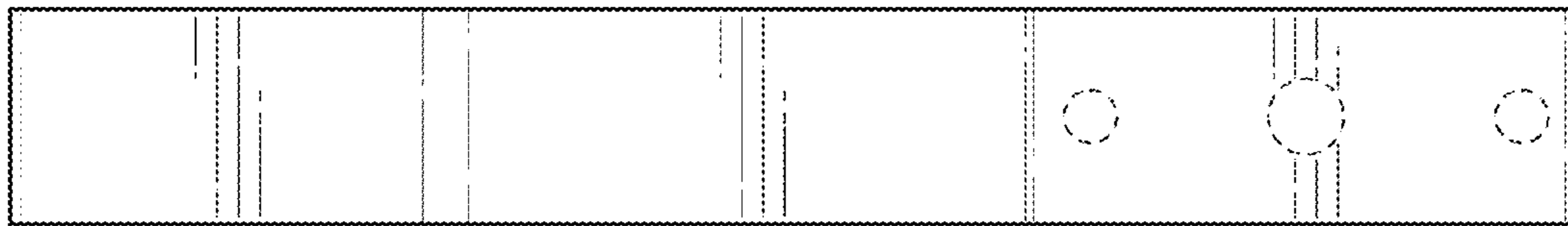

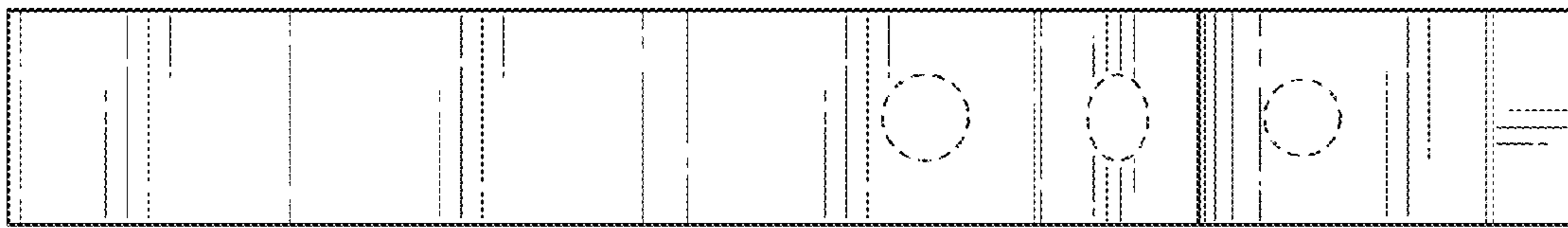
