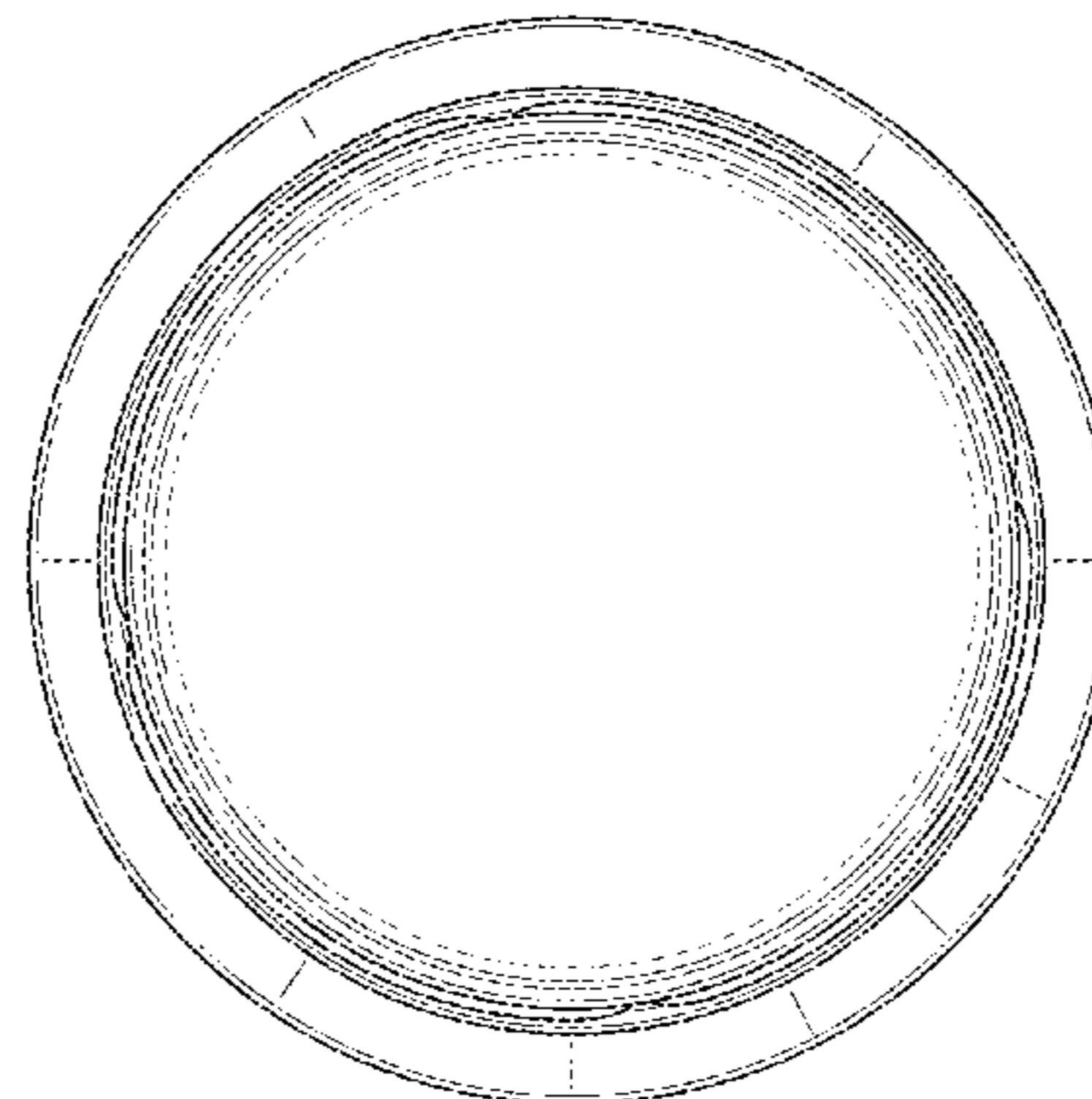
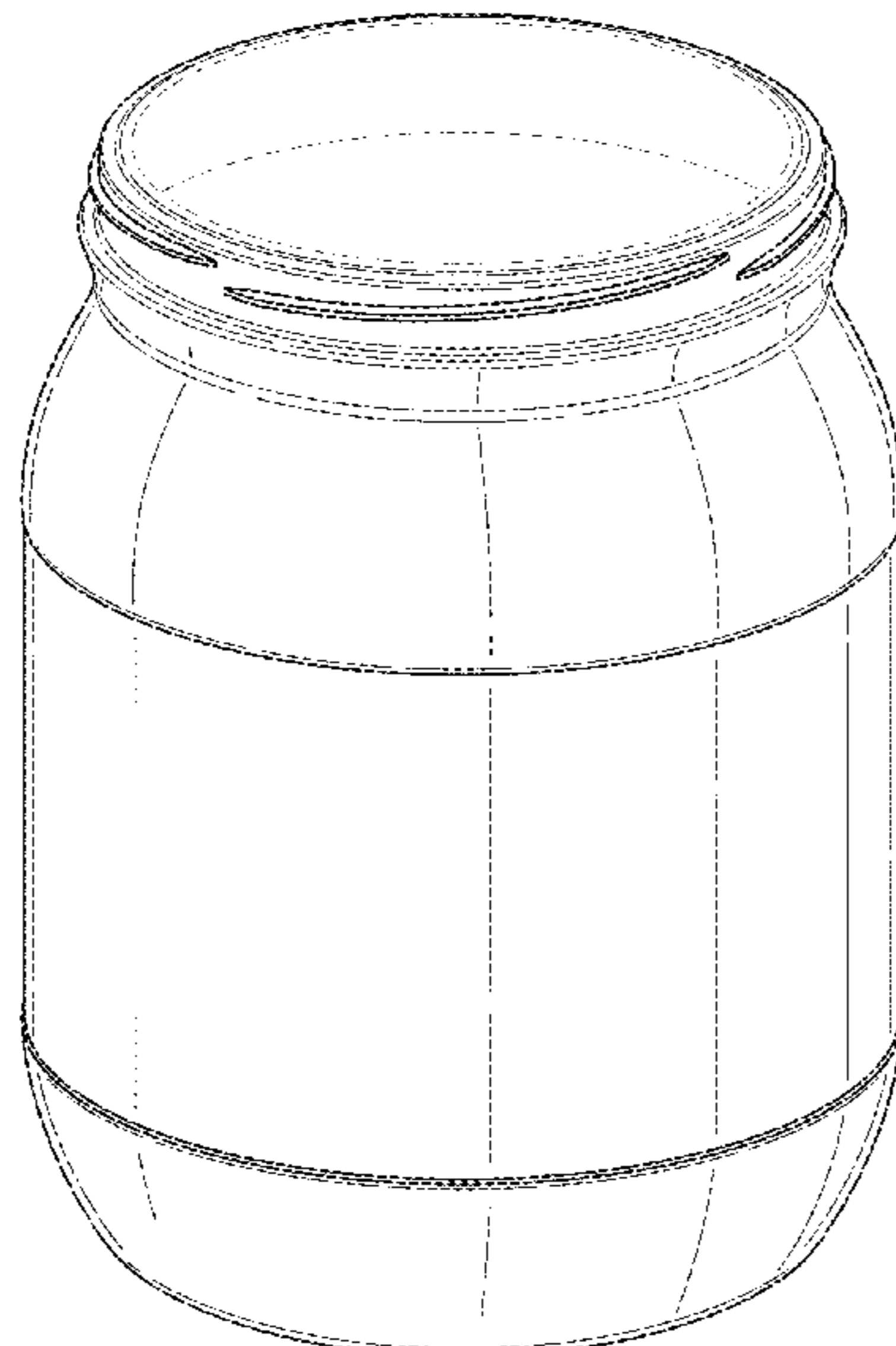
The ornamental design for a jar, as shown and described.

DESCRIPTION

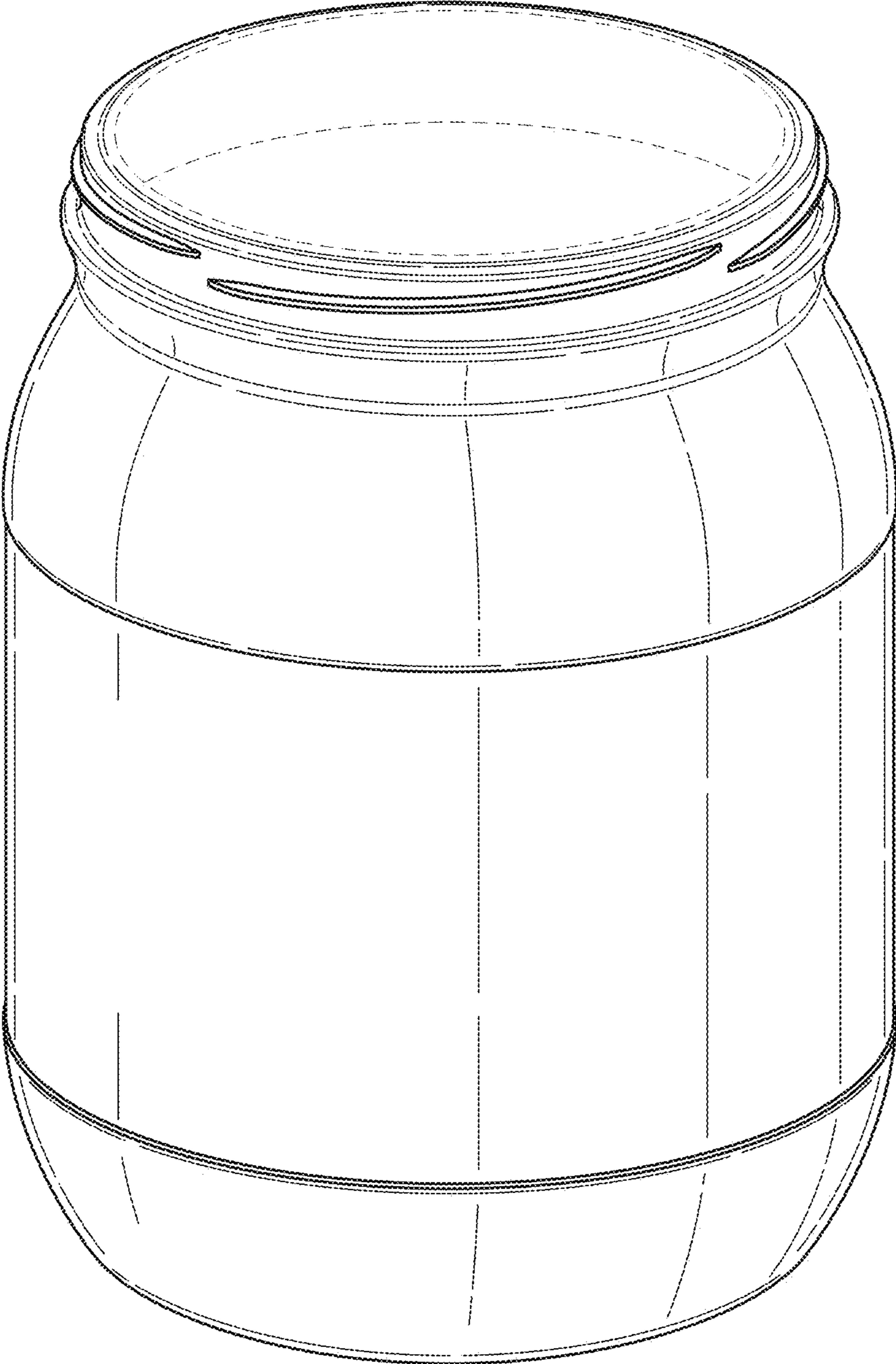

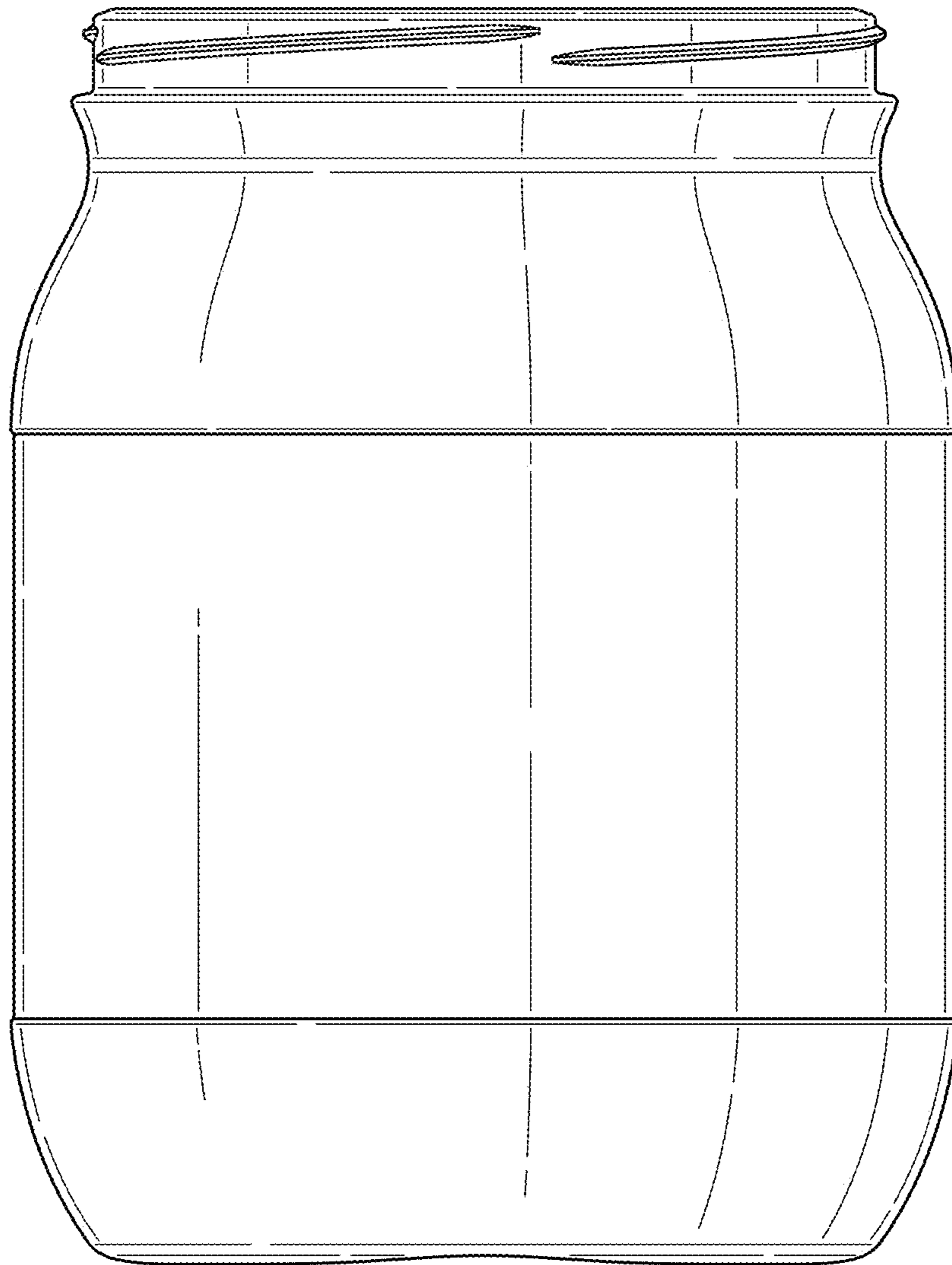

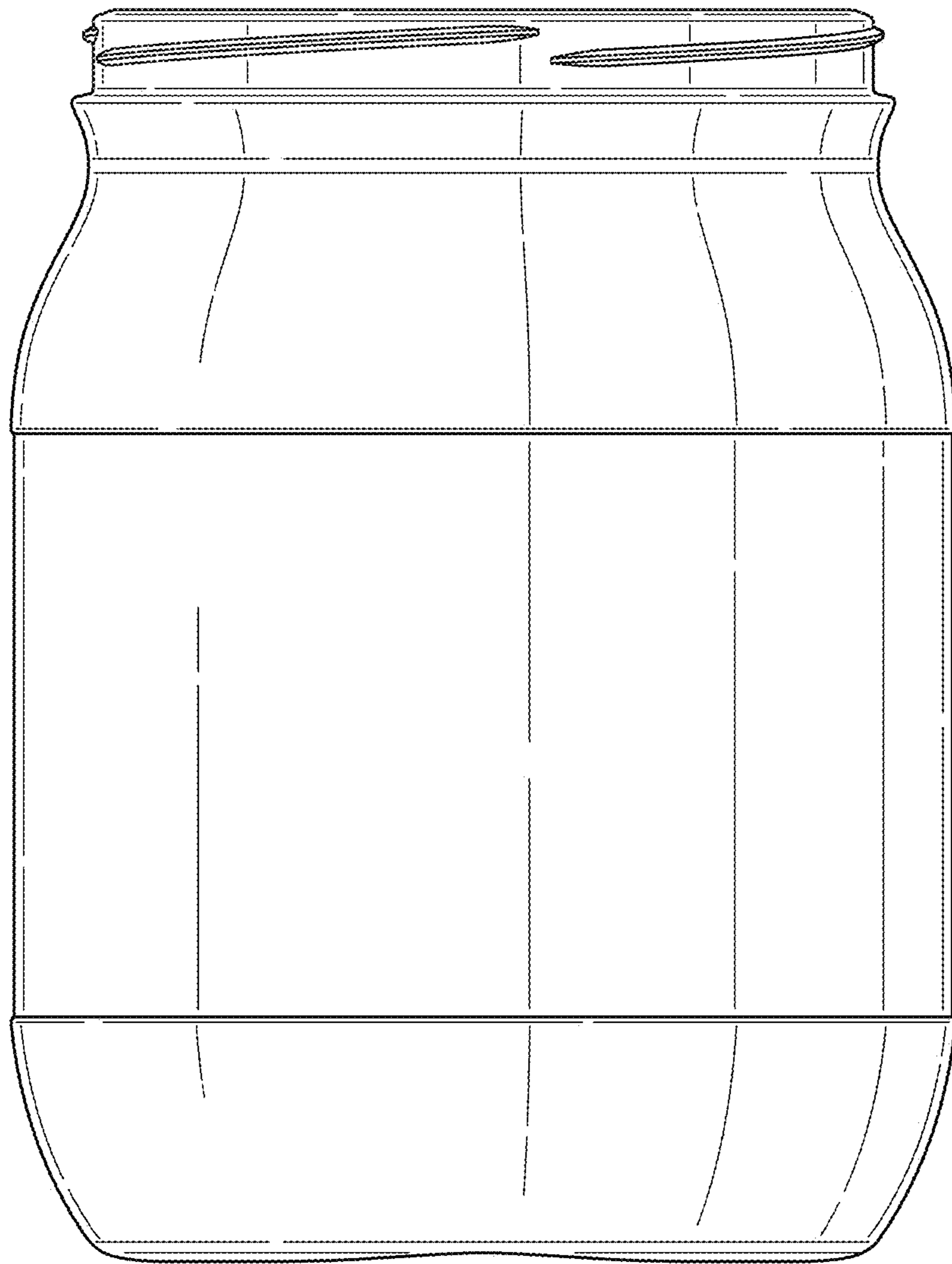

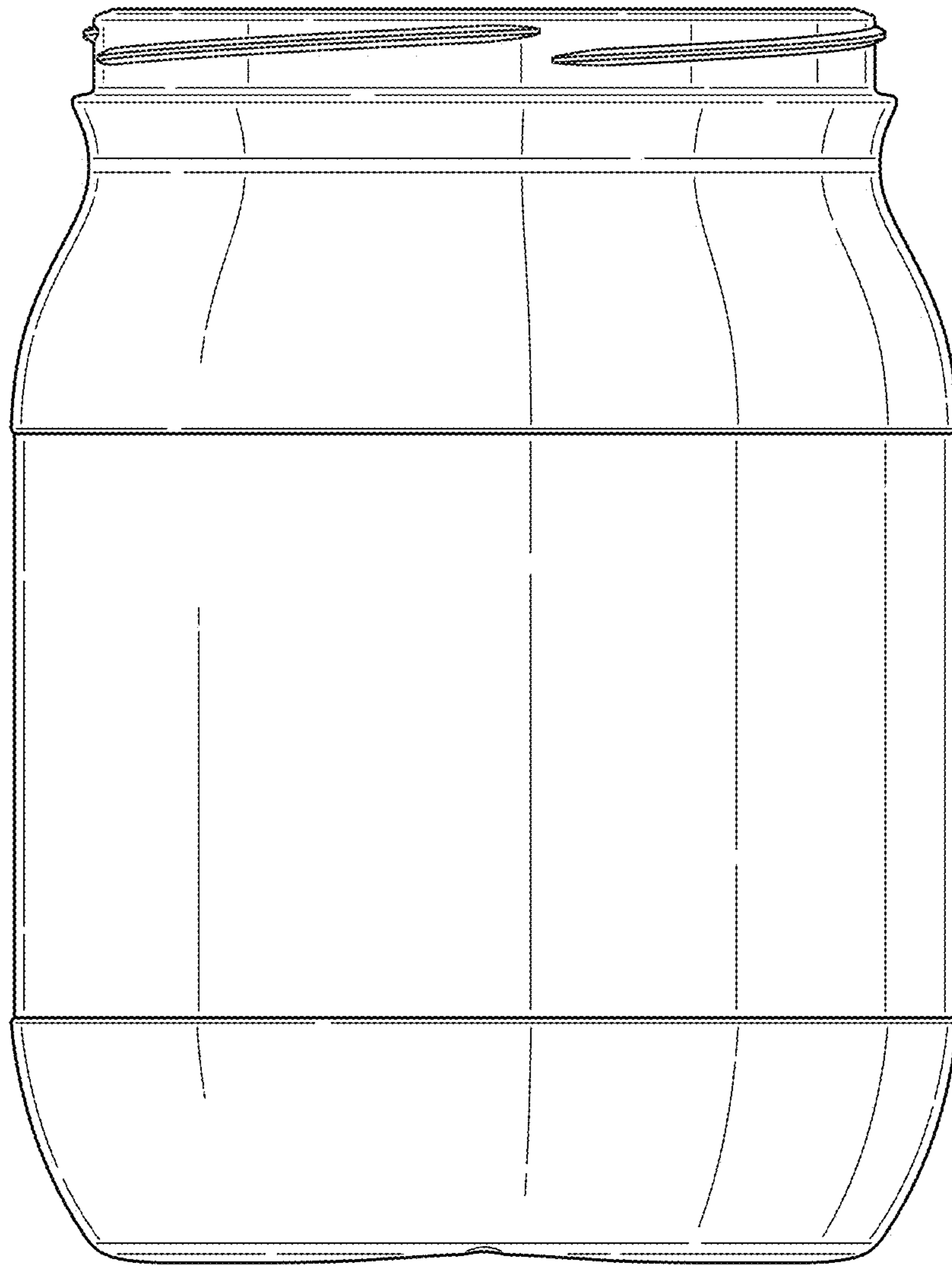

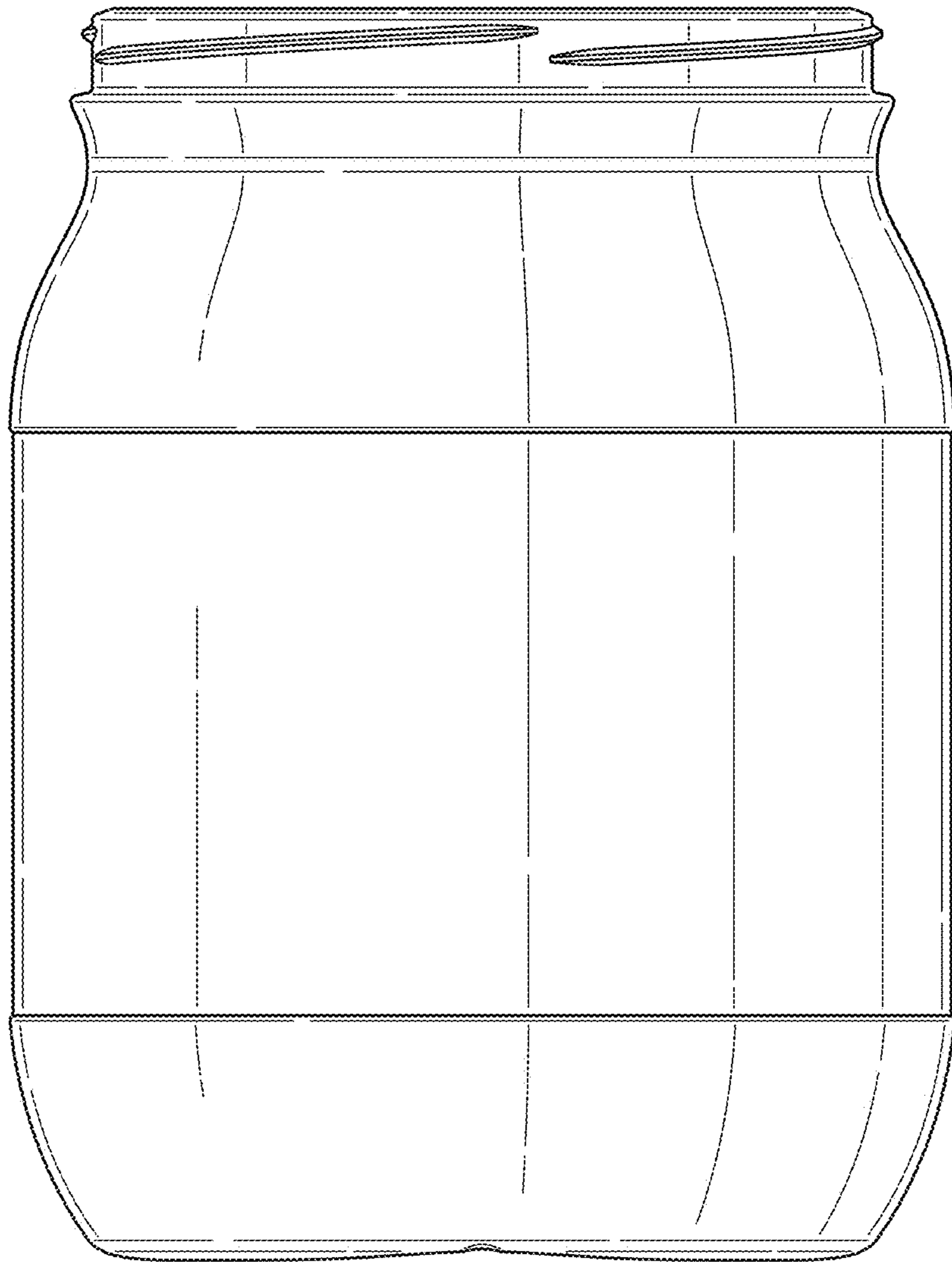

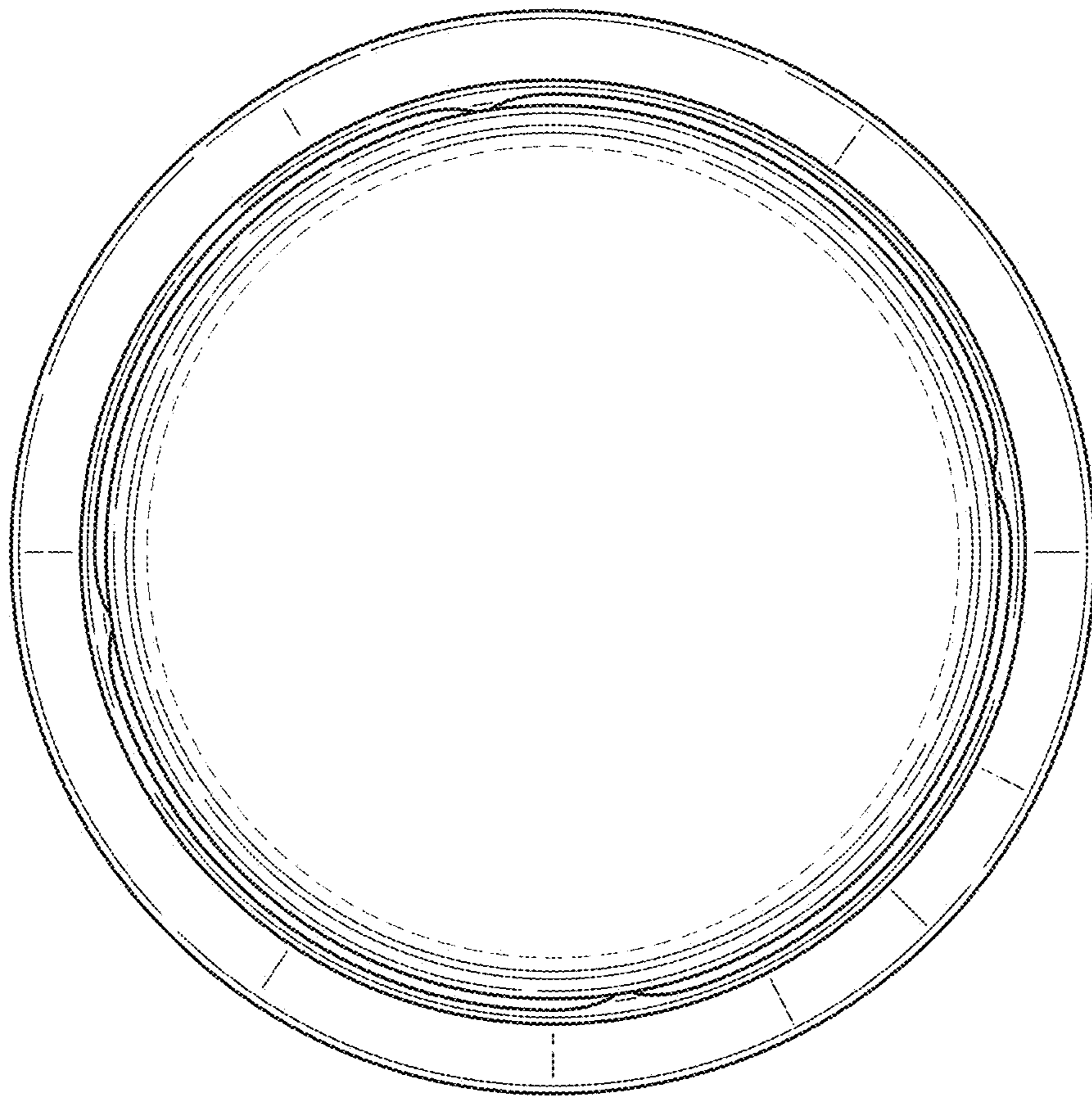

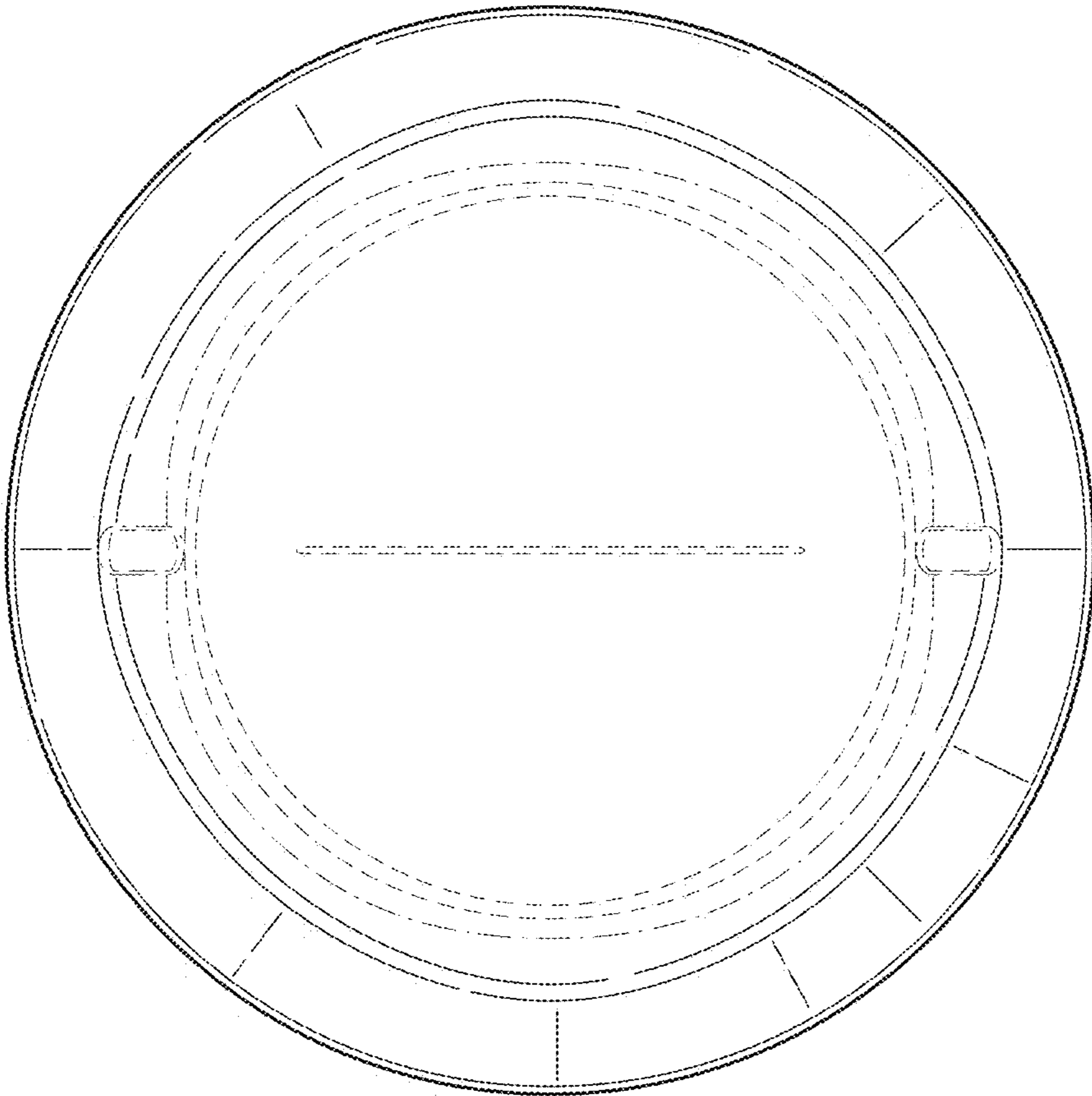
