We claim the ornamental design for a pattern for package, as shown and described.

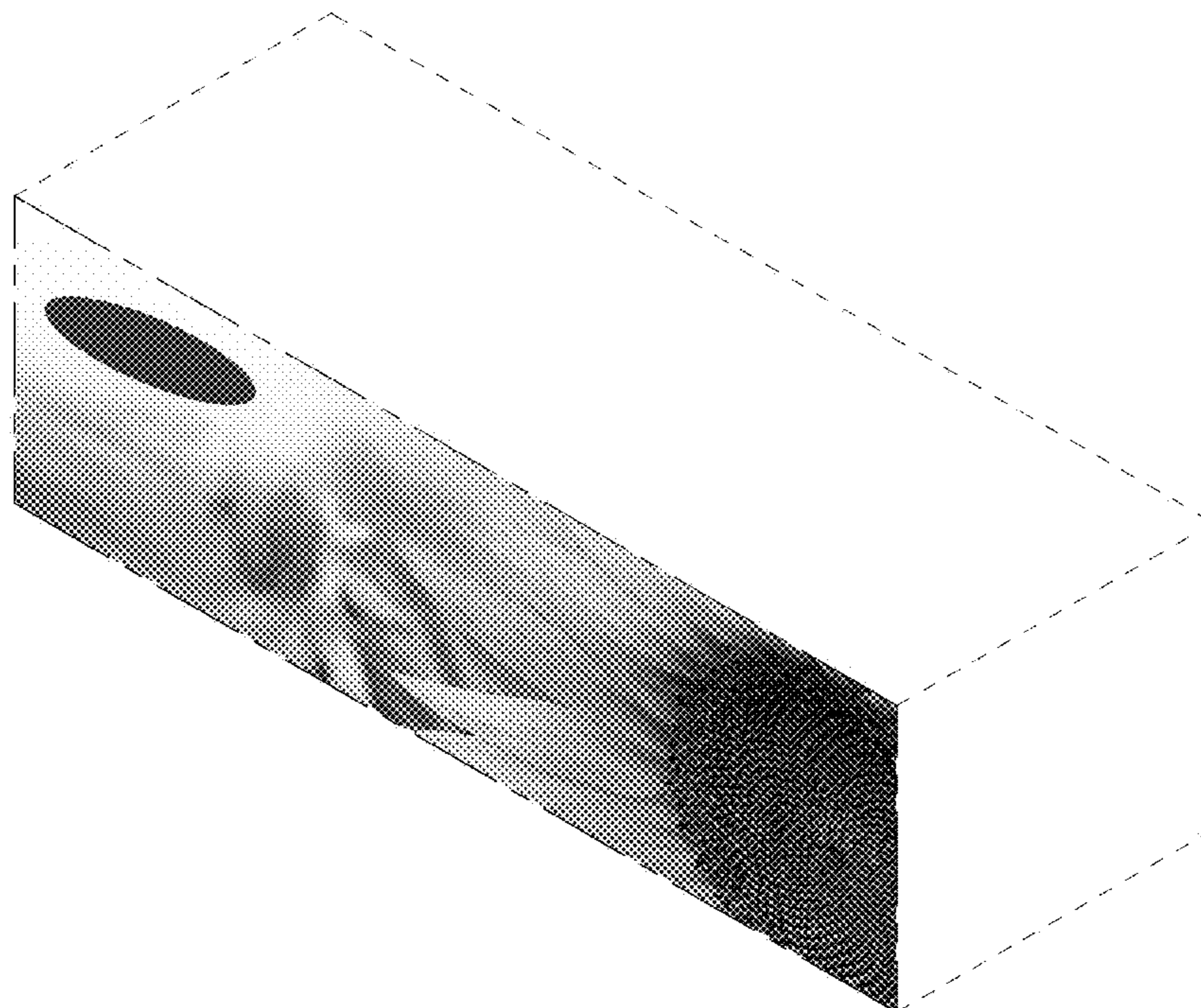
