The ornamental design for a bottle tote, as shown and described.

DESCRIPTION

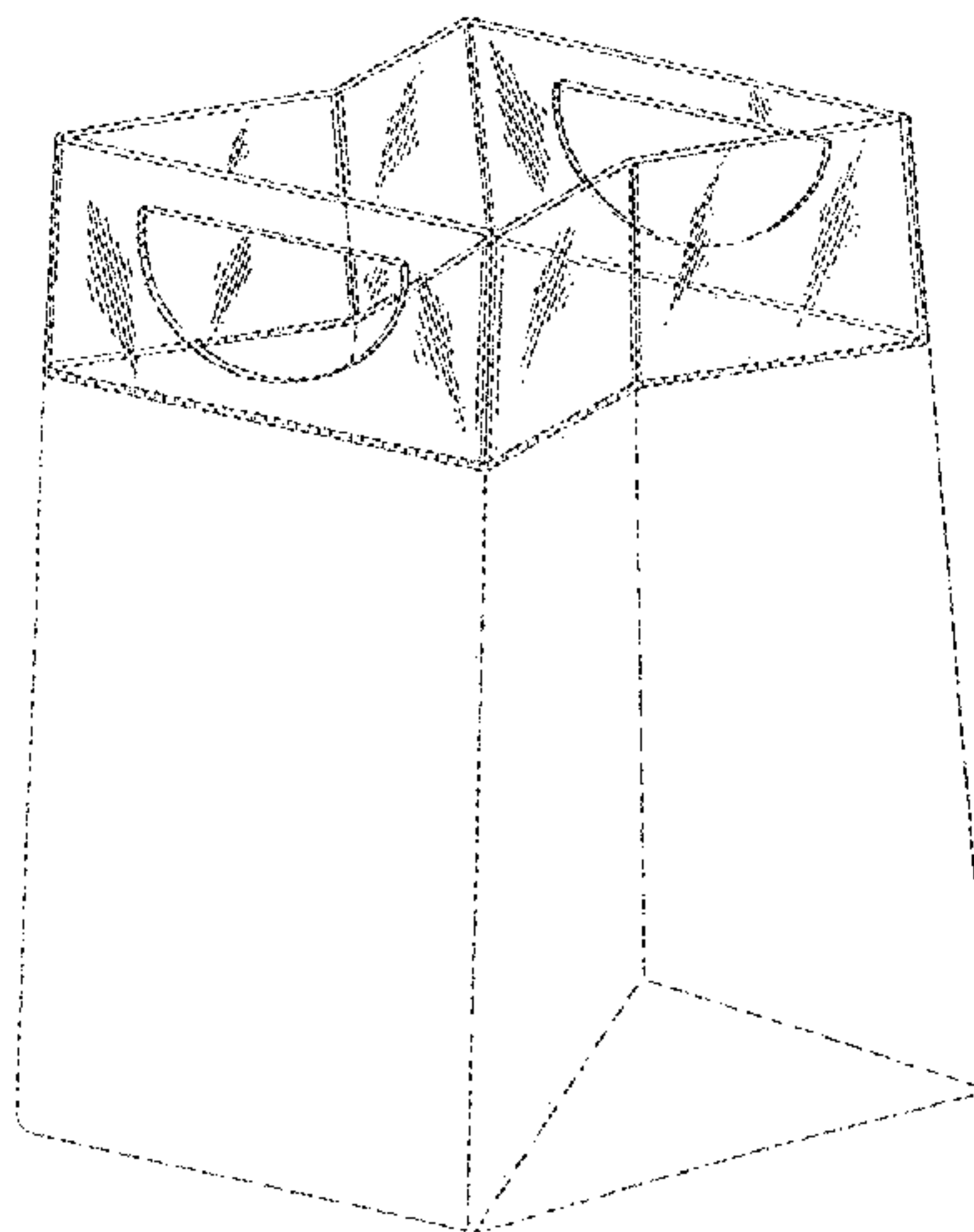
FIG. 1 is a top, front and right side perspective views of the bottle tote, the top, rear and left side perspective view being a mirror image thereof;

FIG. 2 is a front elevation view, the rear elevational view being a mirror image thereof; and,

FIG. 3 is a bottom, front and left side perspective view of the bottle tote in a folded configuration, the bottom, rear and right side perspective view being a mirror image thereof.

The broken lines showing structural features are included for the purpose of illustrating non-claimed subject matter and form no part of the claimed design.

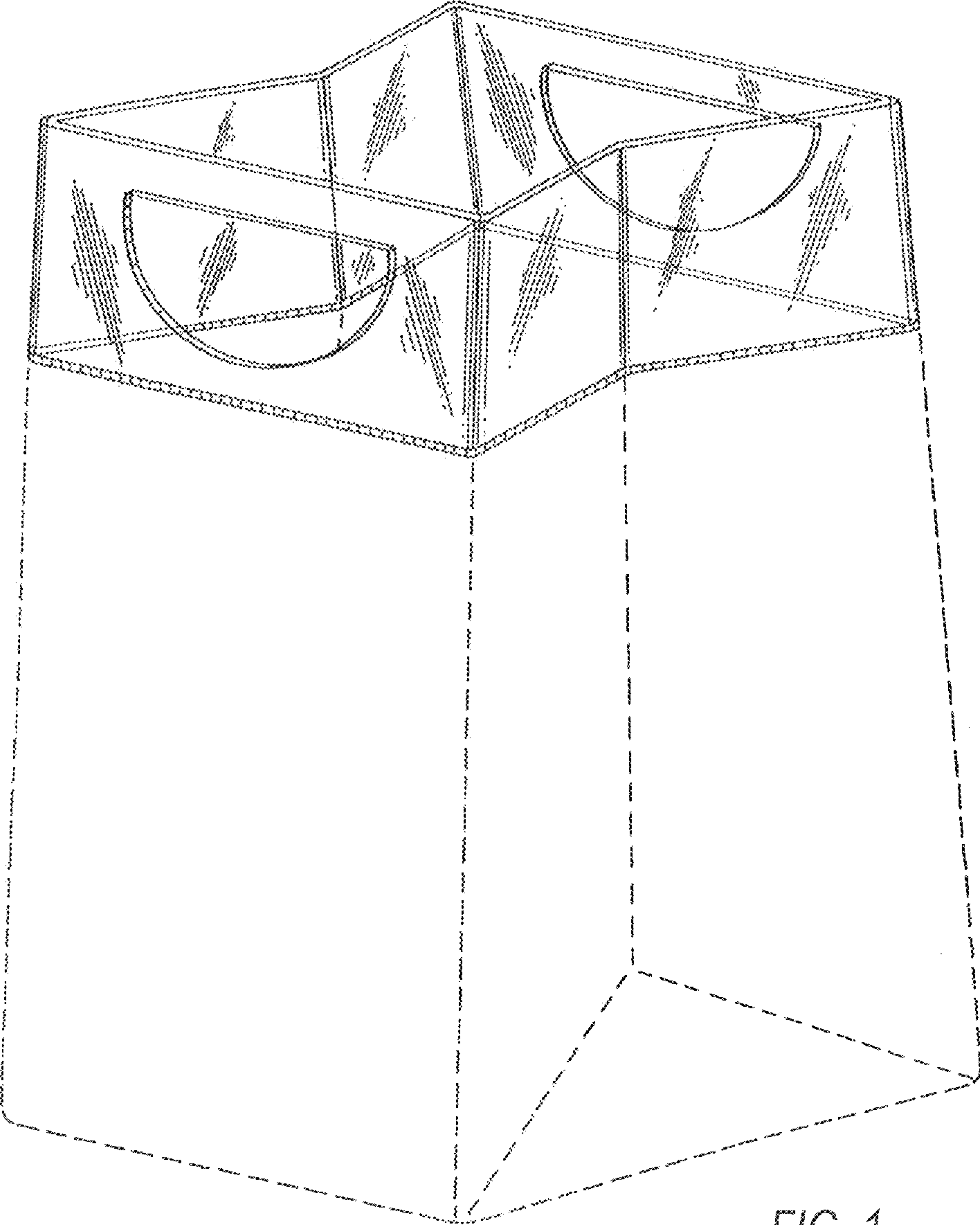

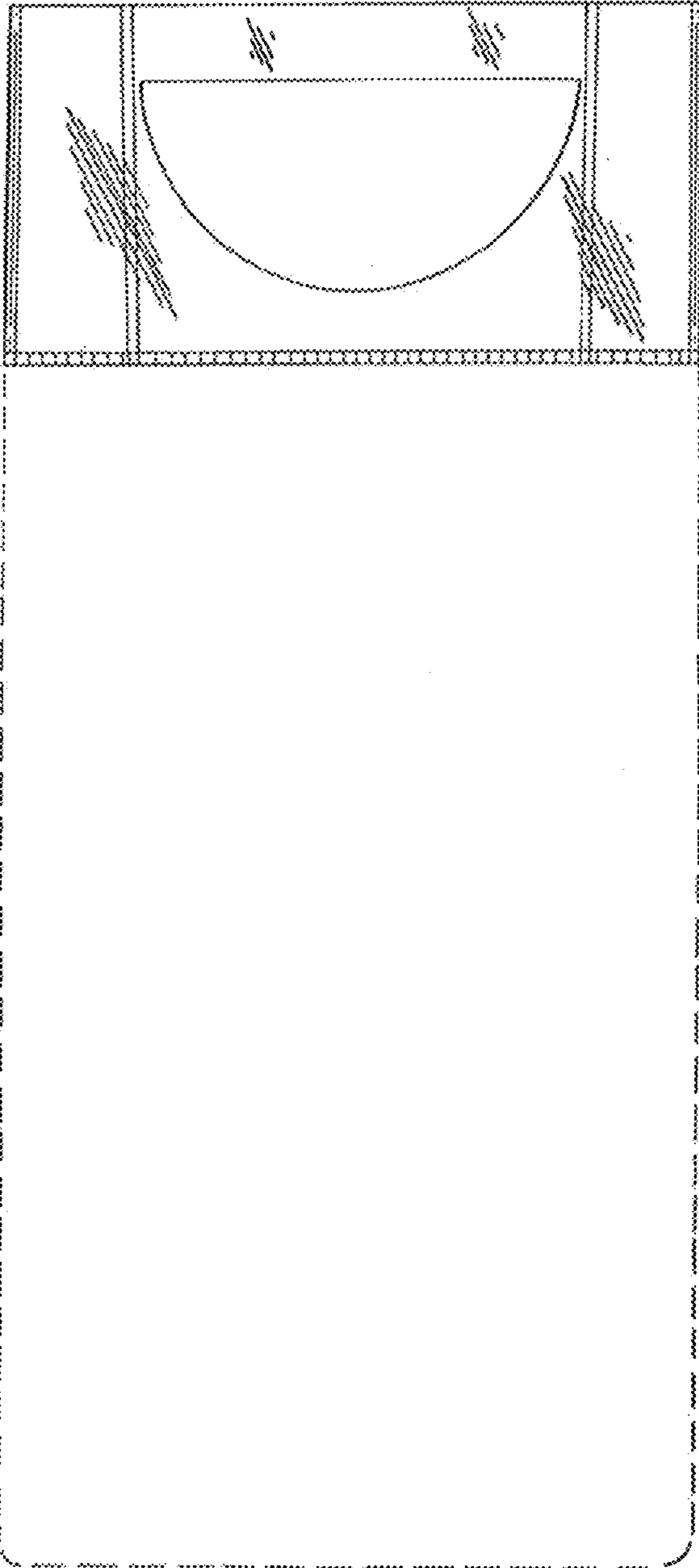
