(57) **CLAIM**

The ornamental design for a gift bag, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the gift bag showing our new design;
FIG. 2 is a front view thereof, the rear view being identical to the front view;
FIG. 3 is a right side view thereof, the left side view being identical to the right side view;
FIG. 4 is a top view thereof;
FIG. 5 is a bottom view thereof; and,
FIG. 6 is a partially folded perspective view thereof.
The broken line showing of portions of the gift bag is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

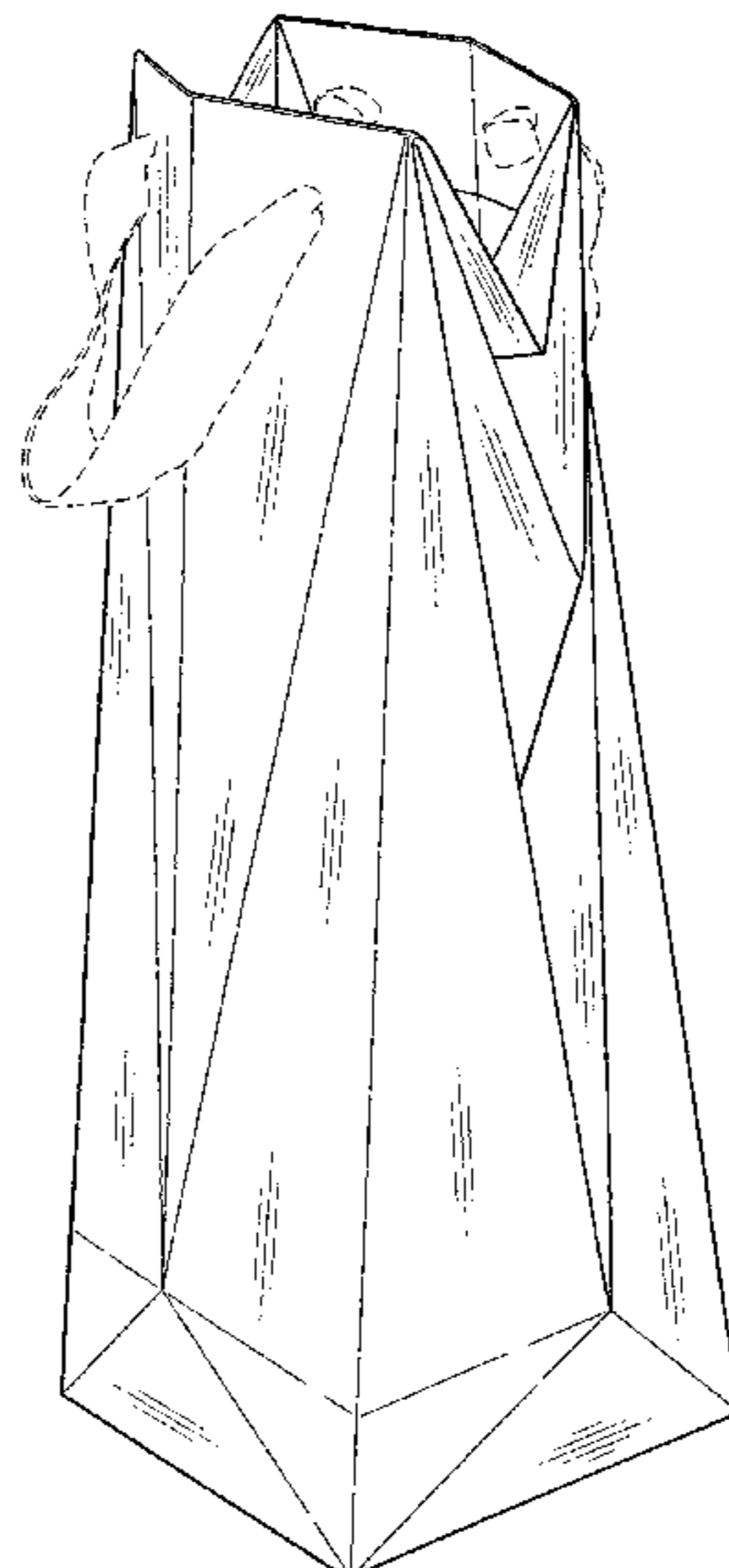

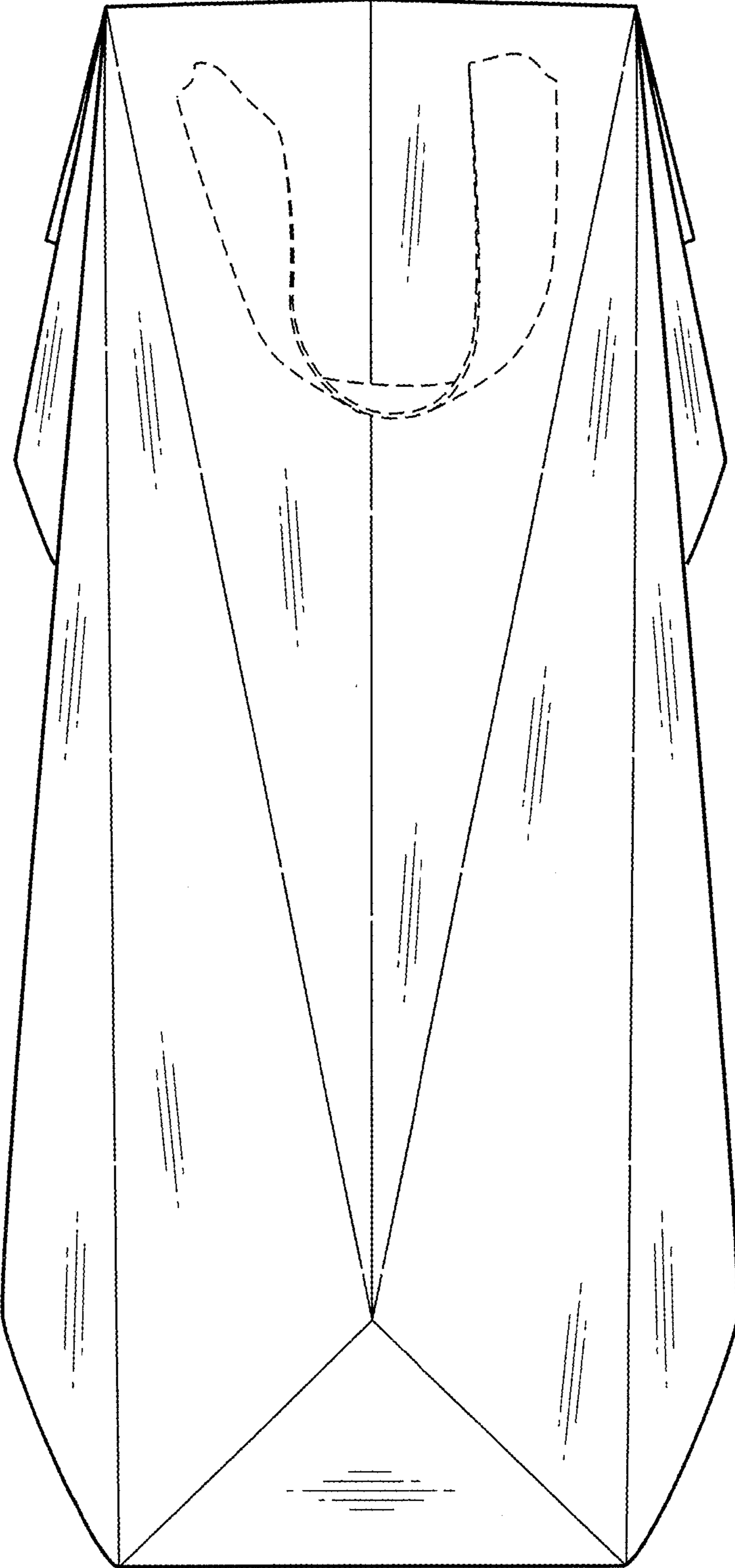

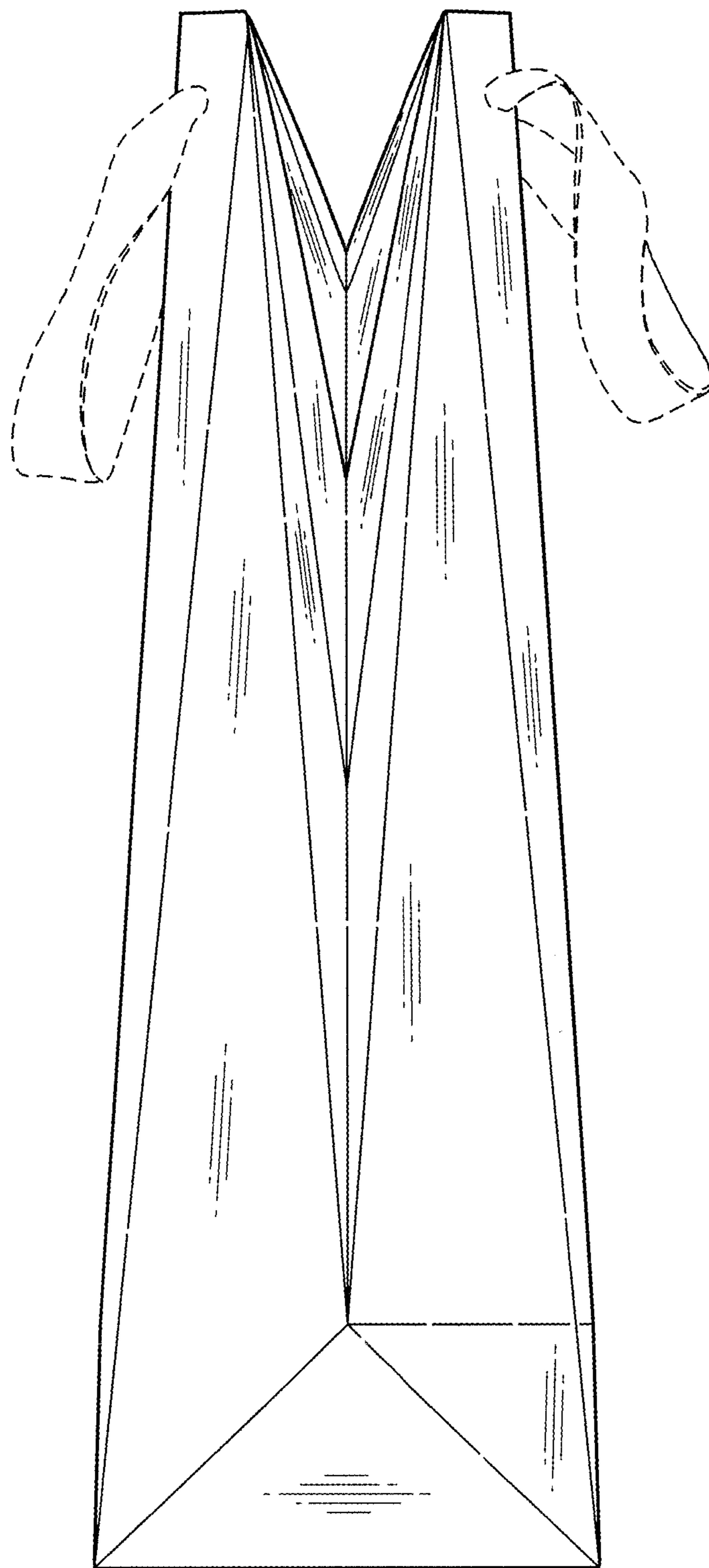

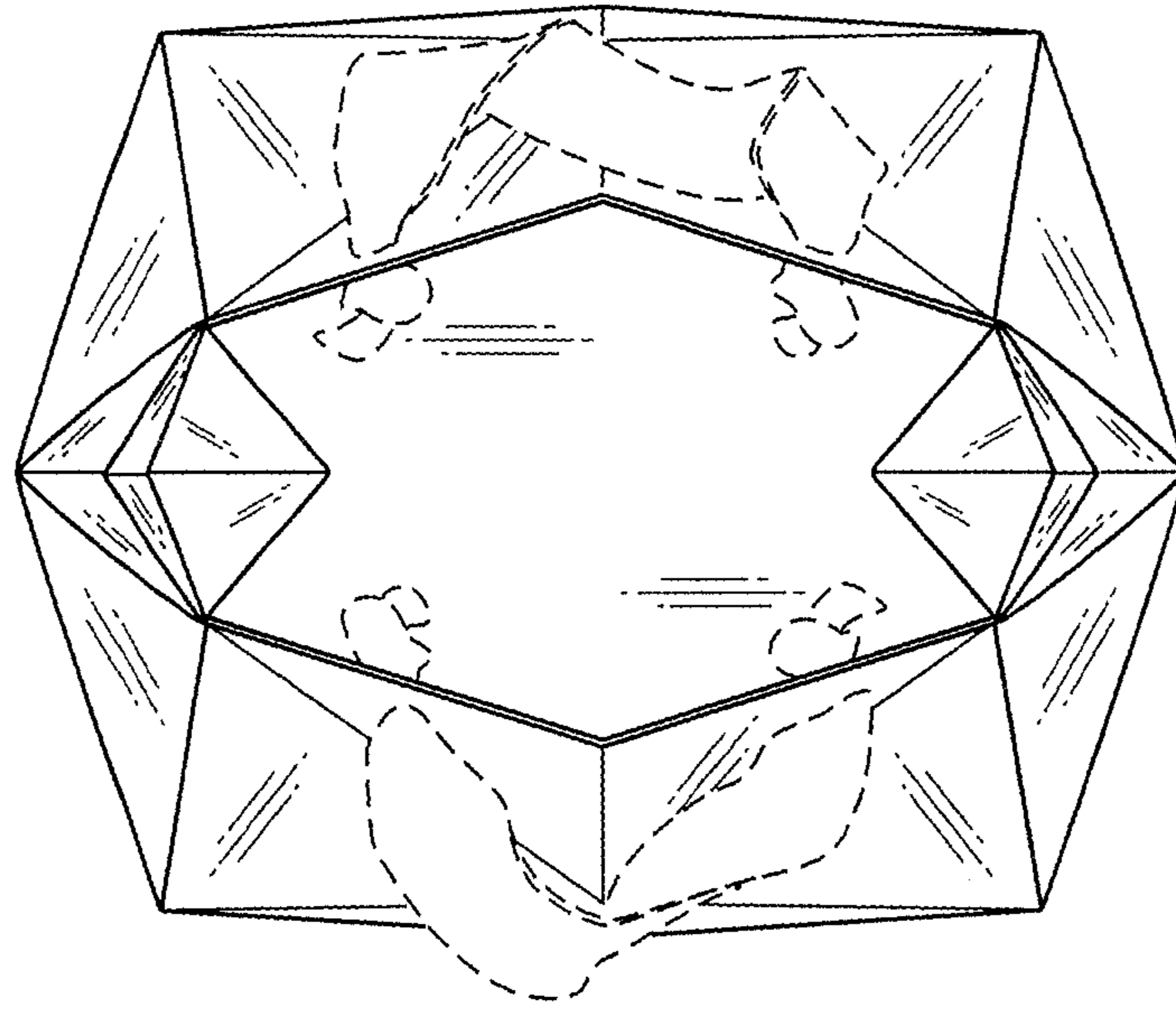

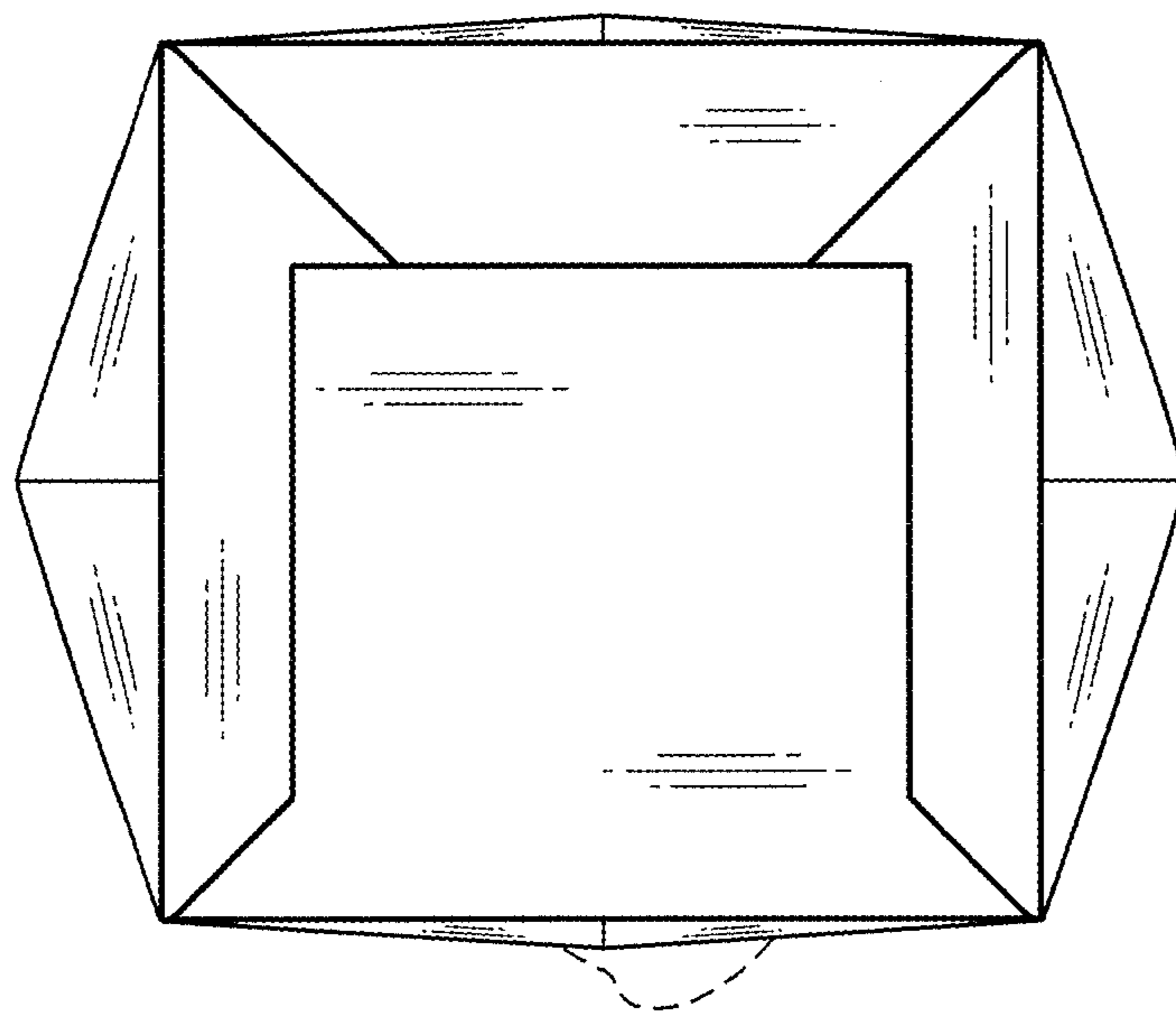

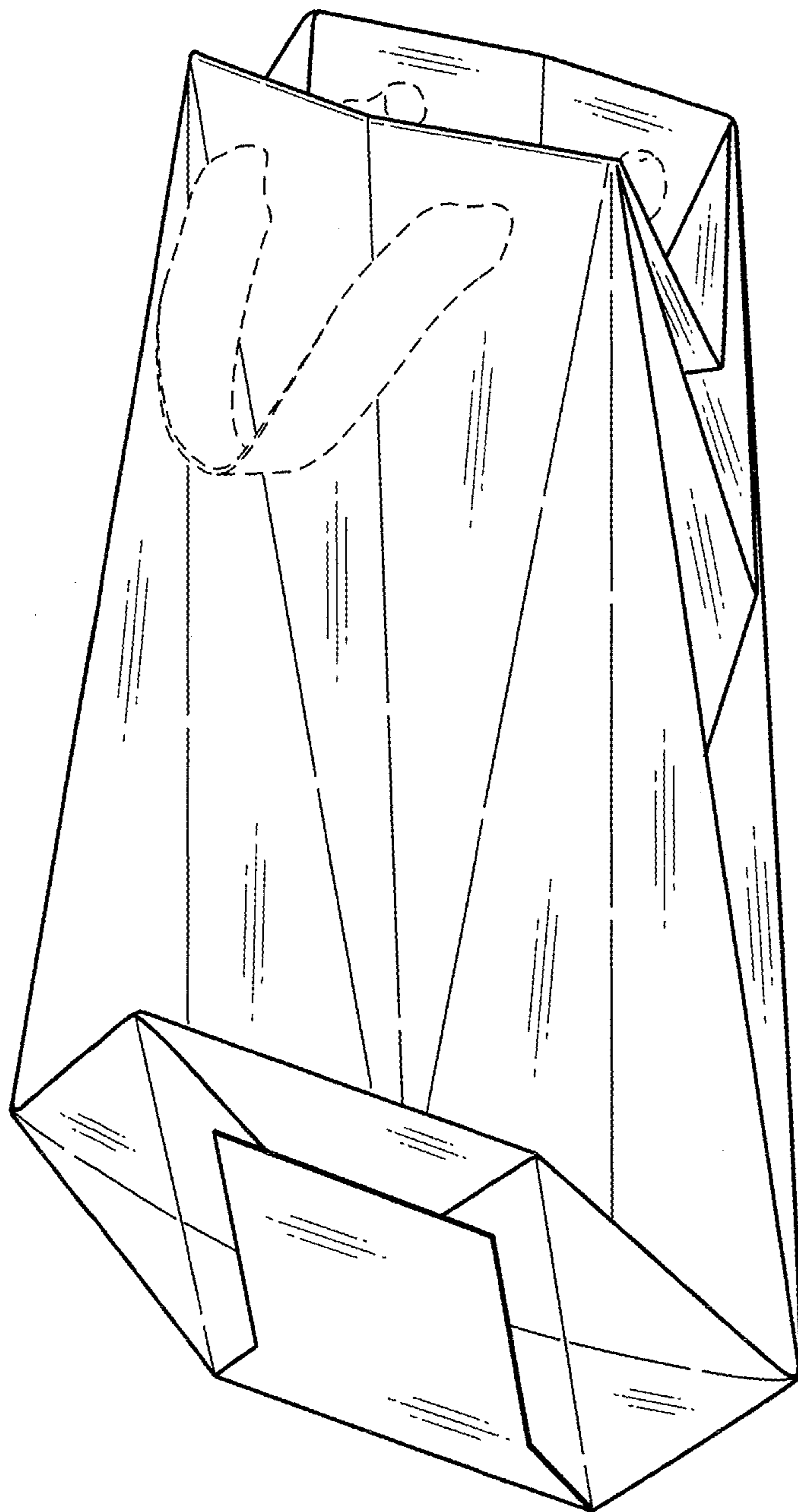
