I claim the ornamental design for an article of jewelry, as shown and described.

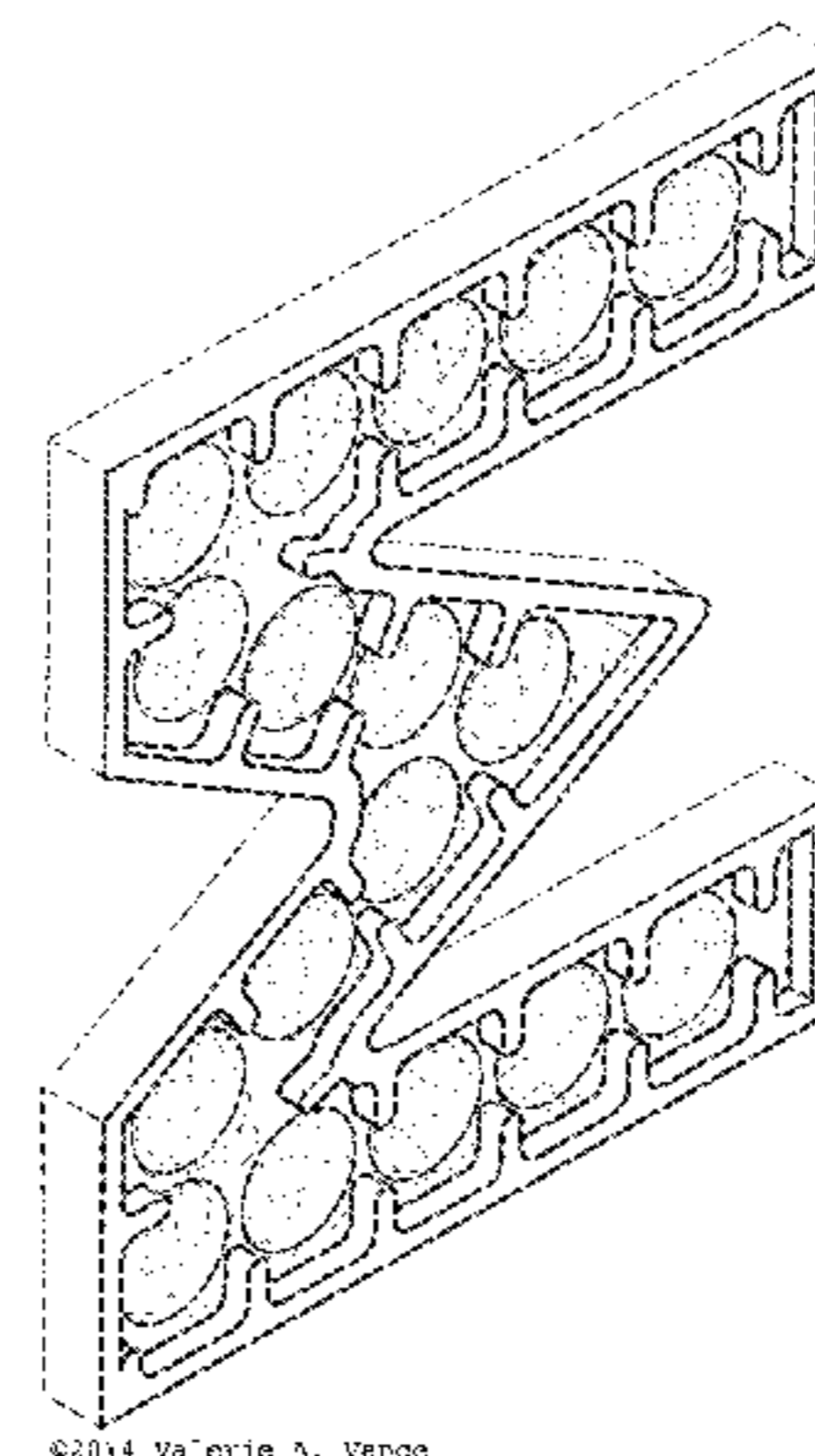
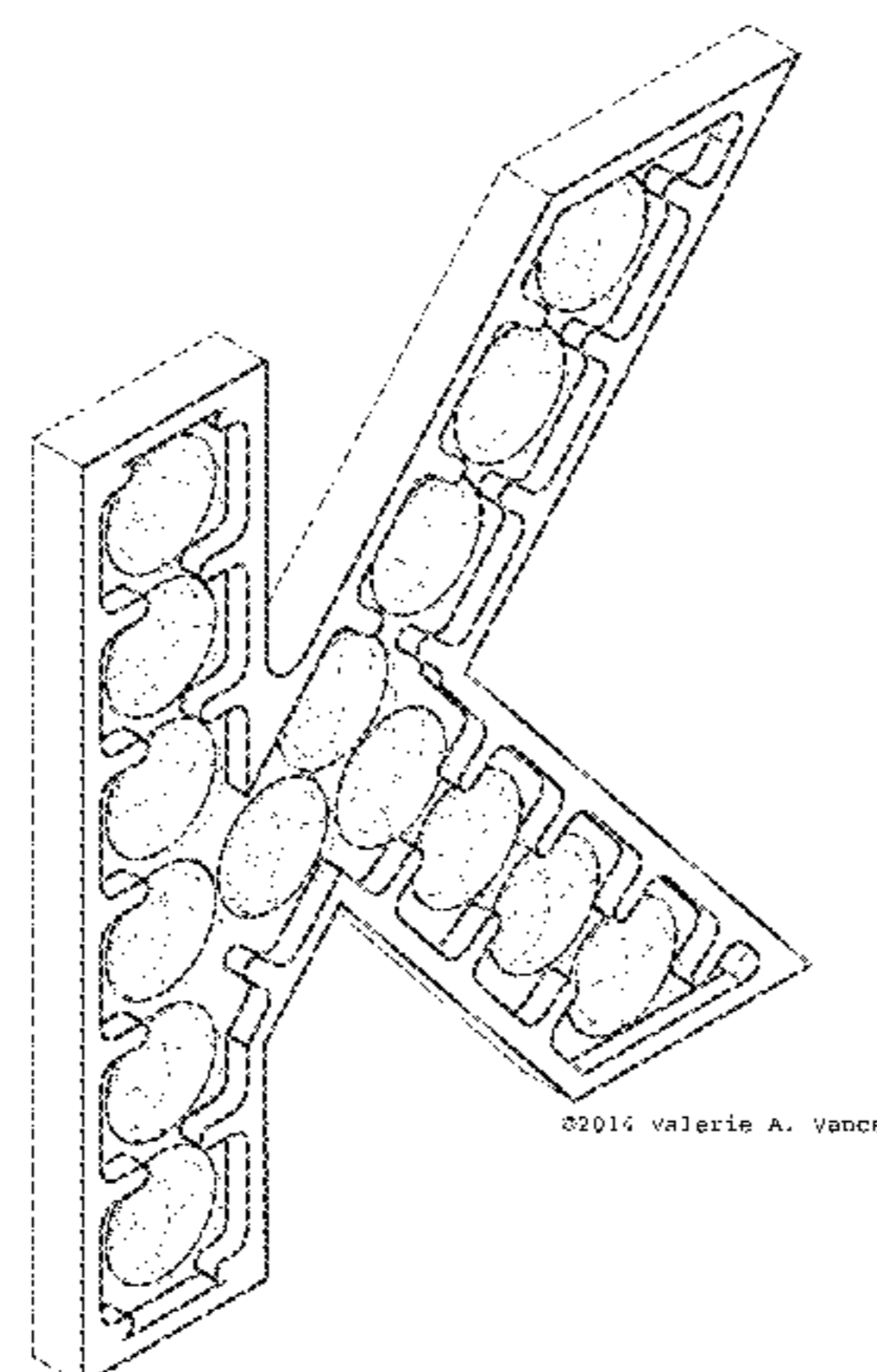
**DESCRIPTION**

FIG. 15 is a front view of an eighth embodiment of an article of jewelry according to my design; and,

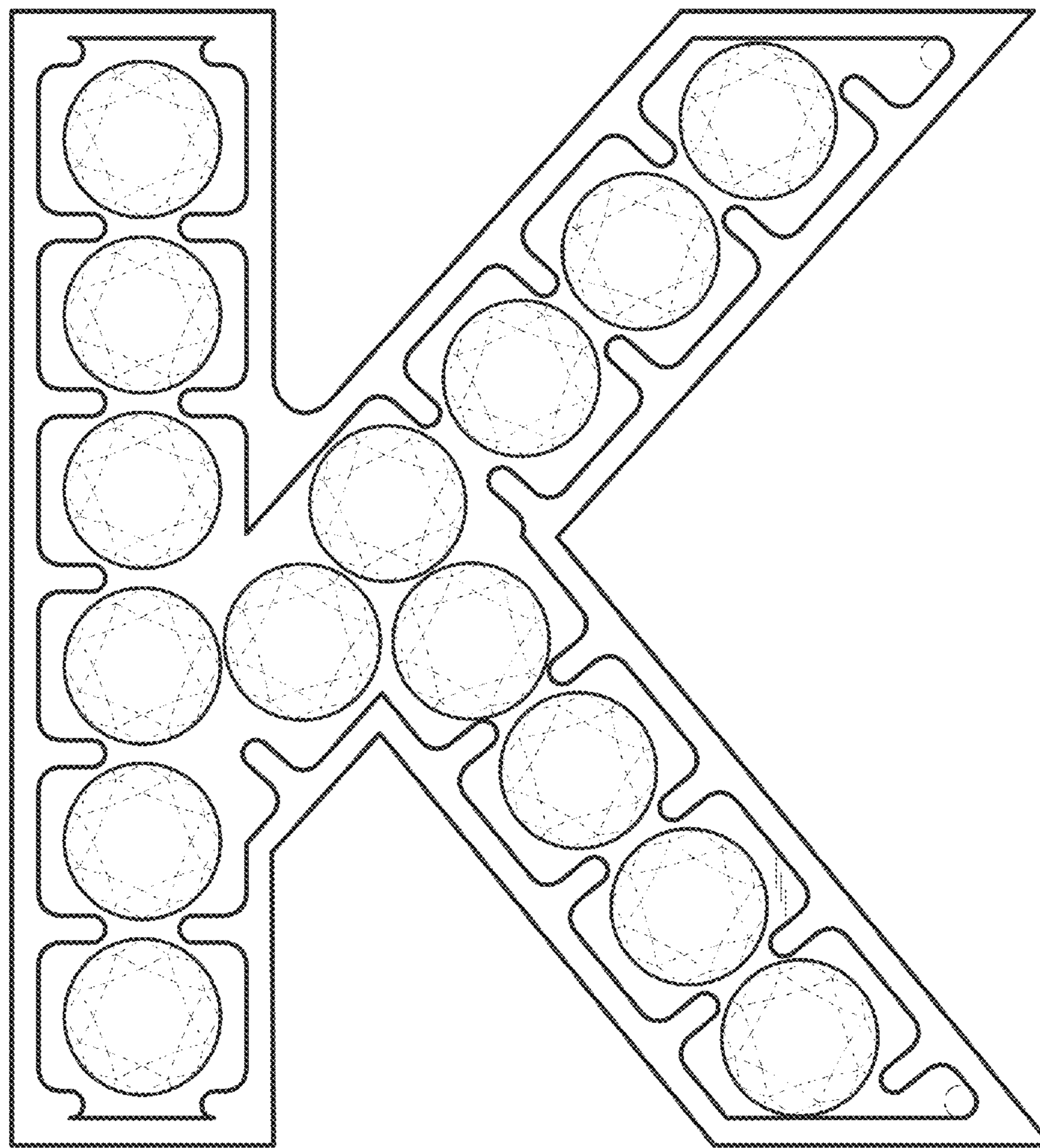
FIG. 16 is a left perspective view of the article of jewelry of FIG. 15.

FIG. 18 is a left perspective view of the article of jewelry of FIG. 17.

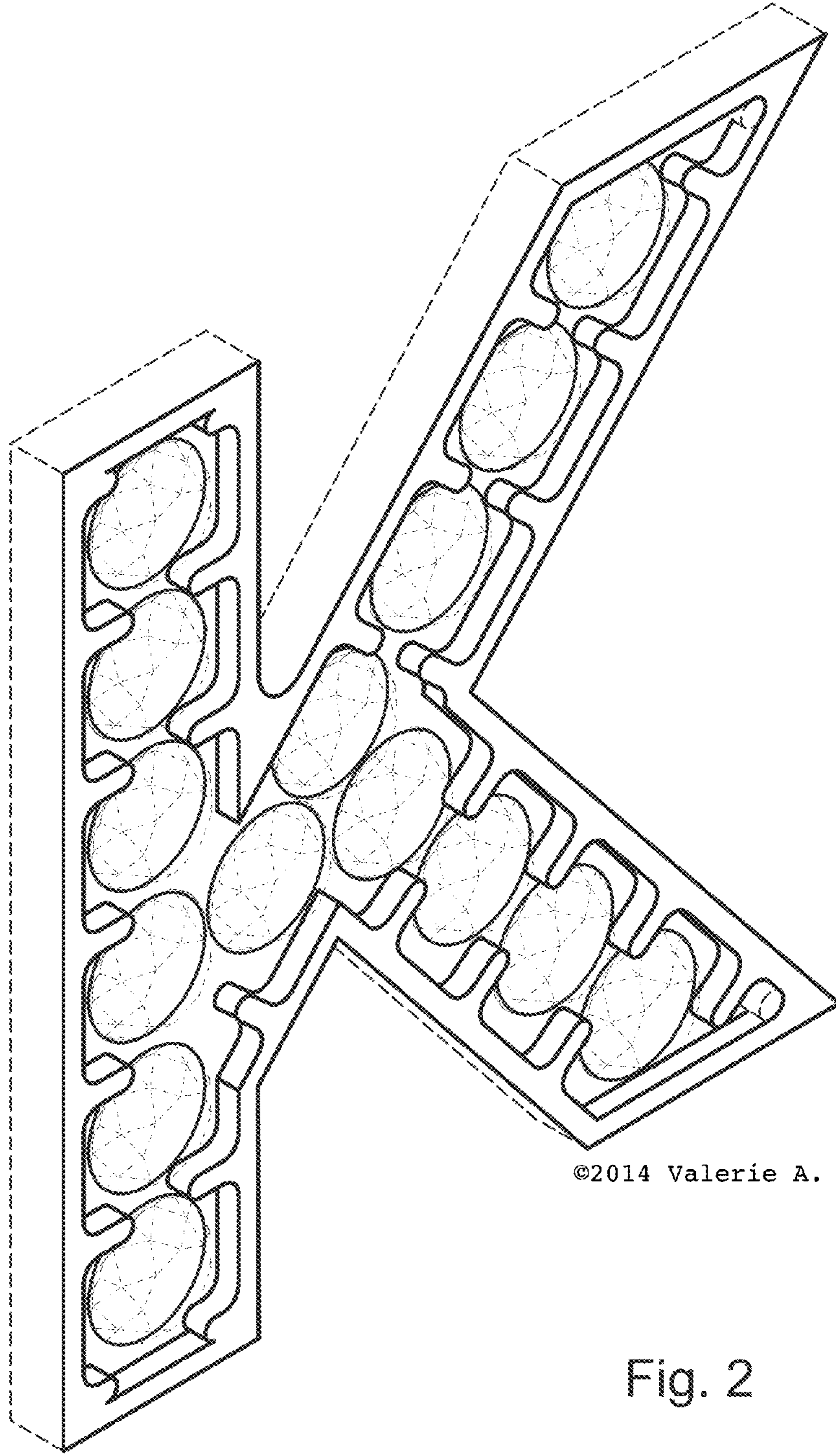

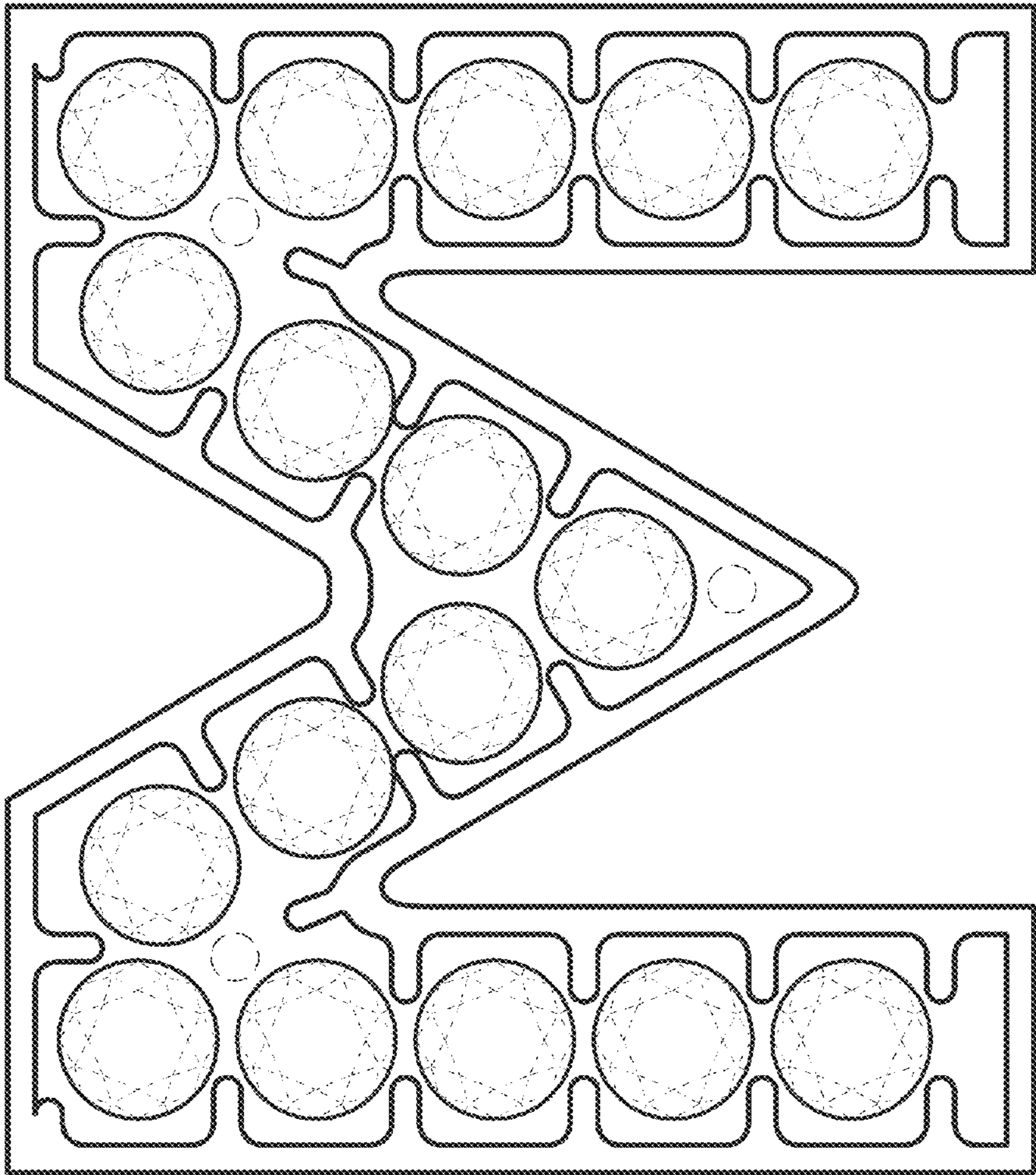

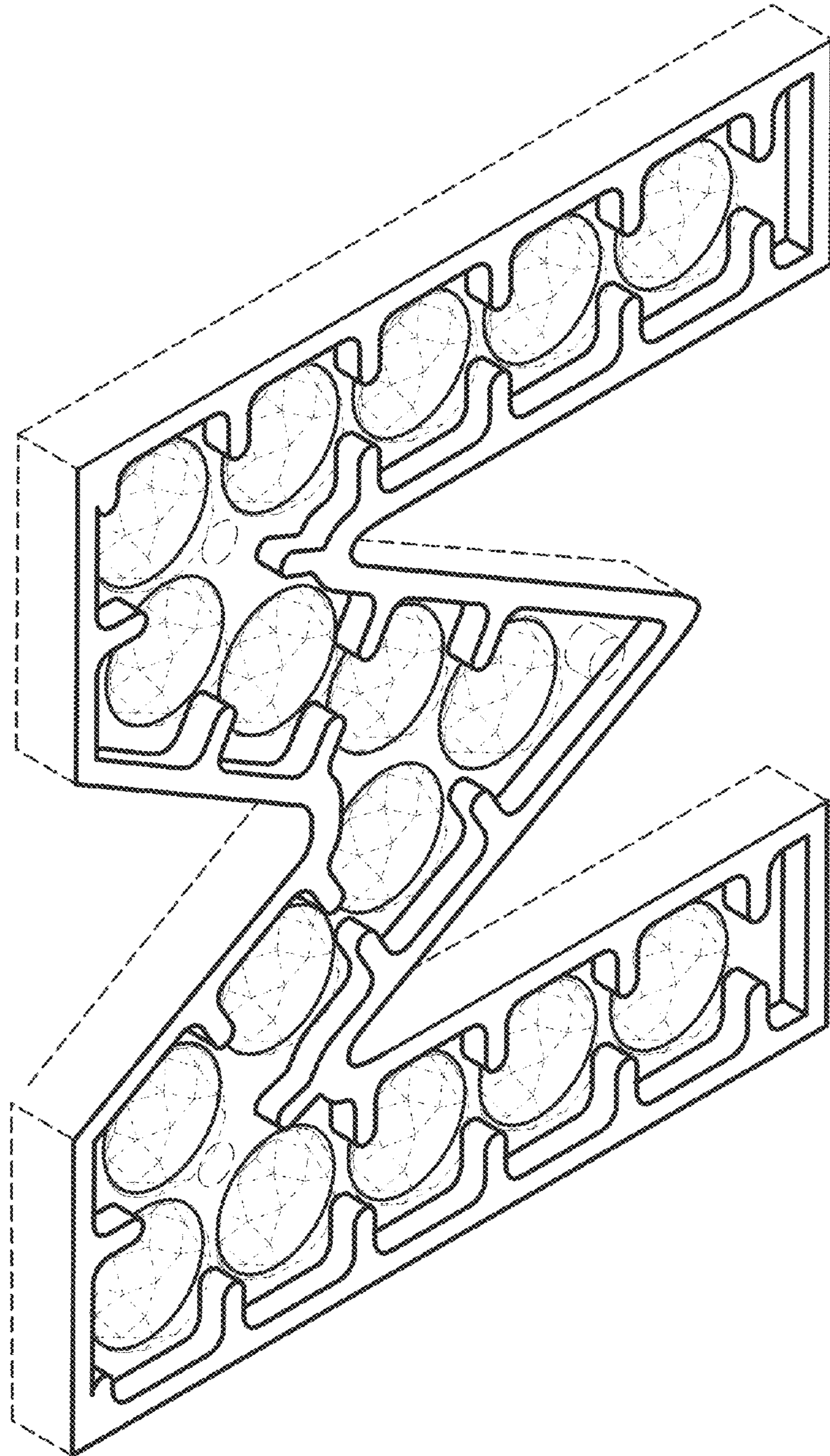

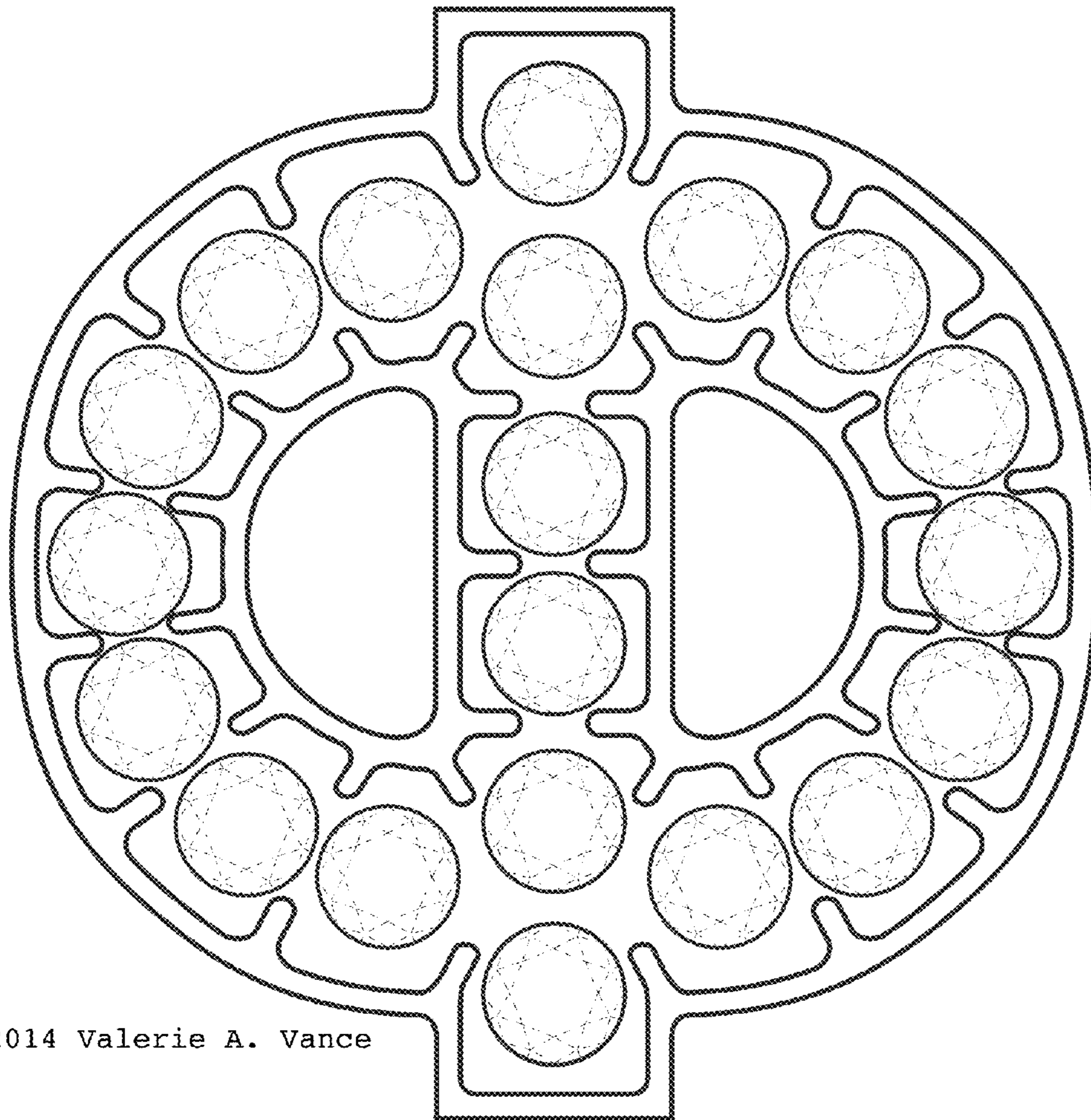

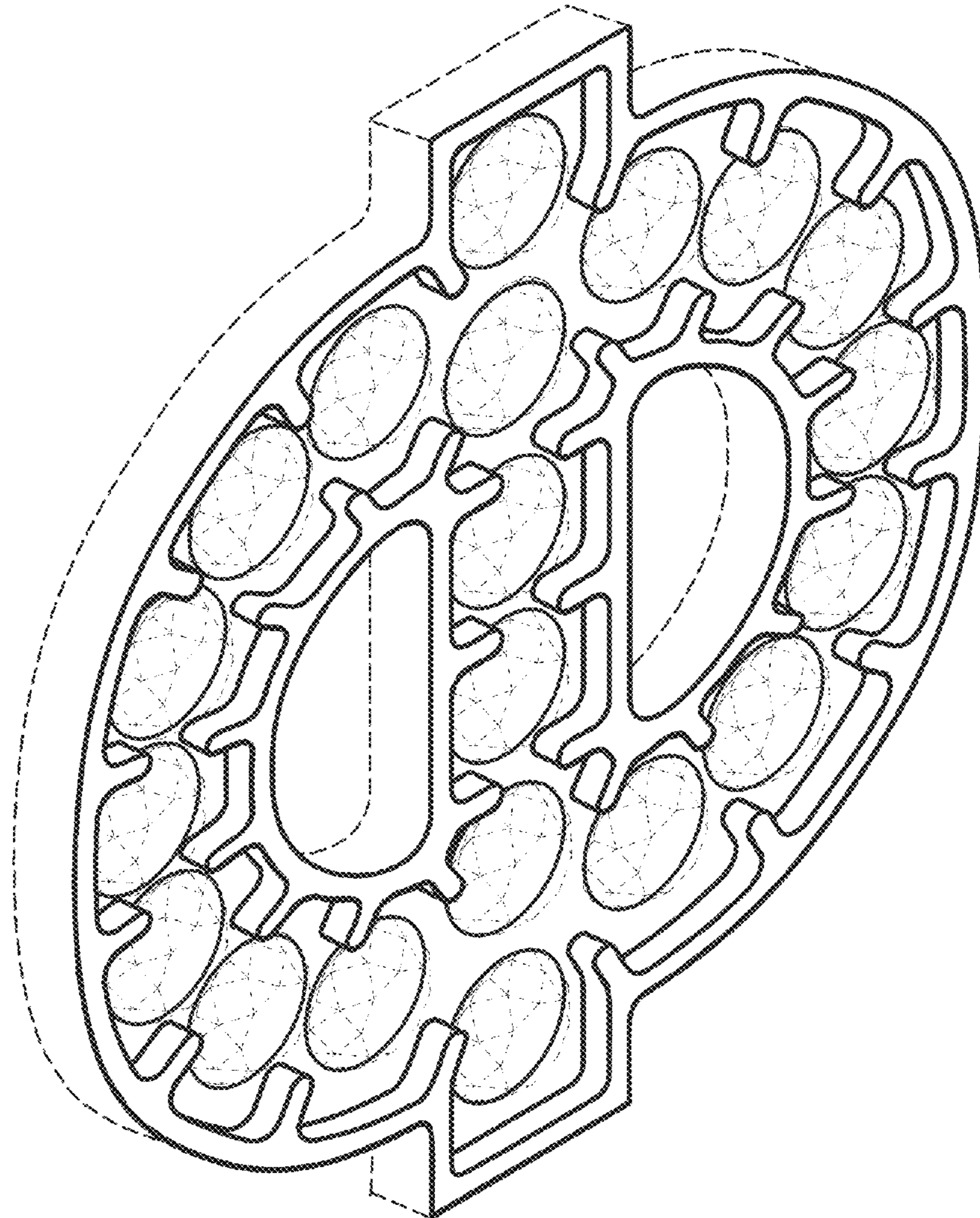

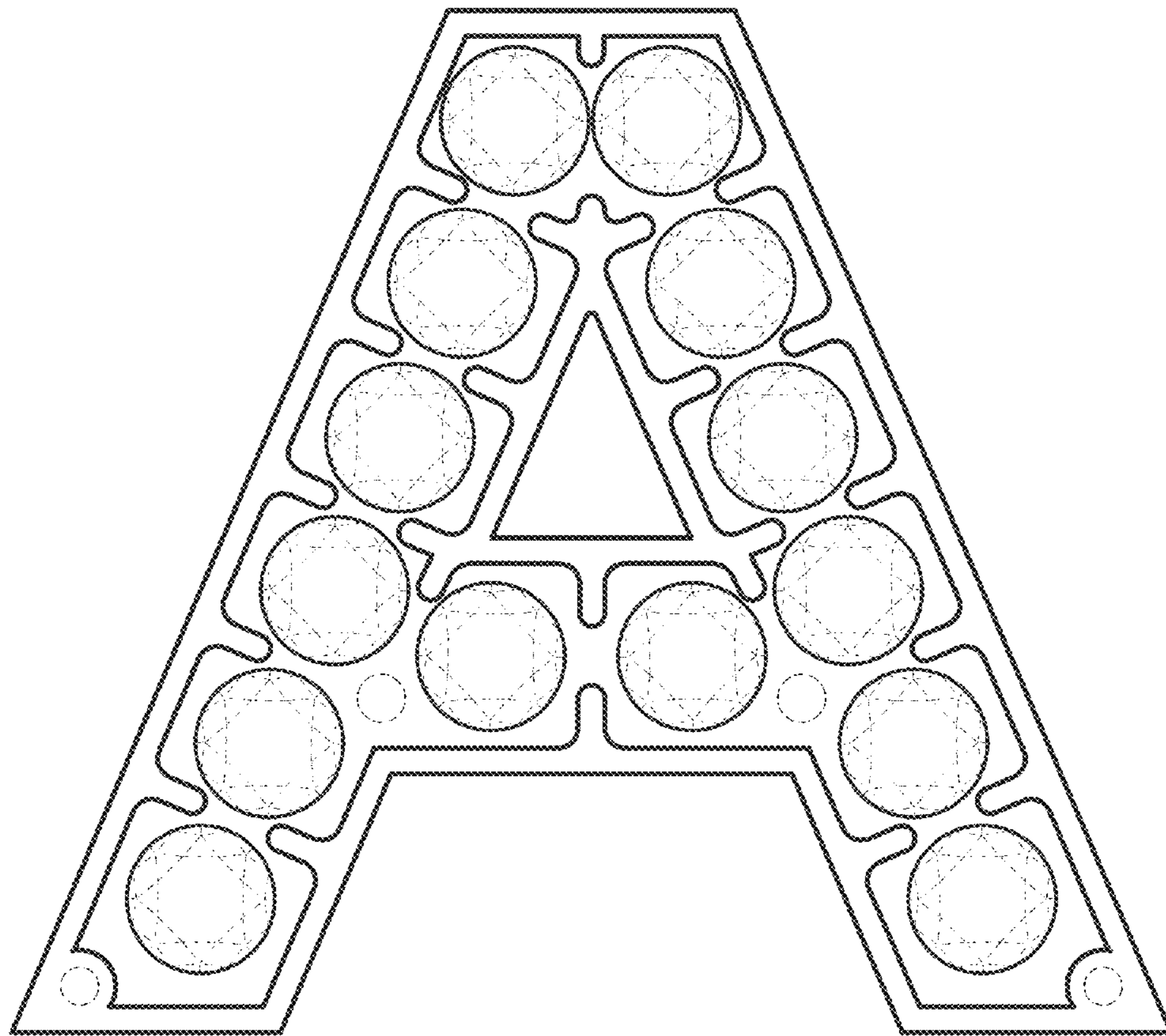

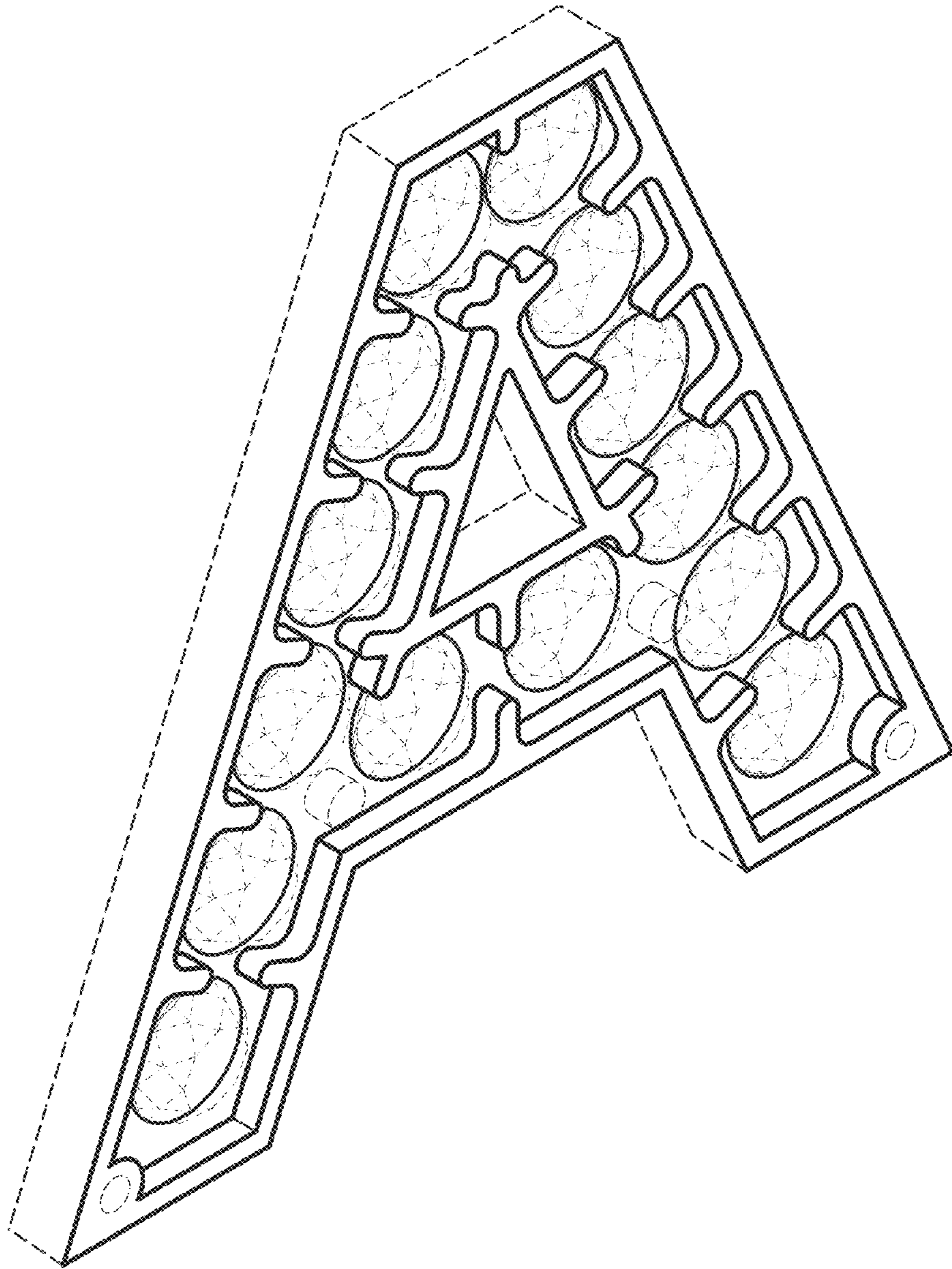

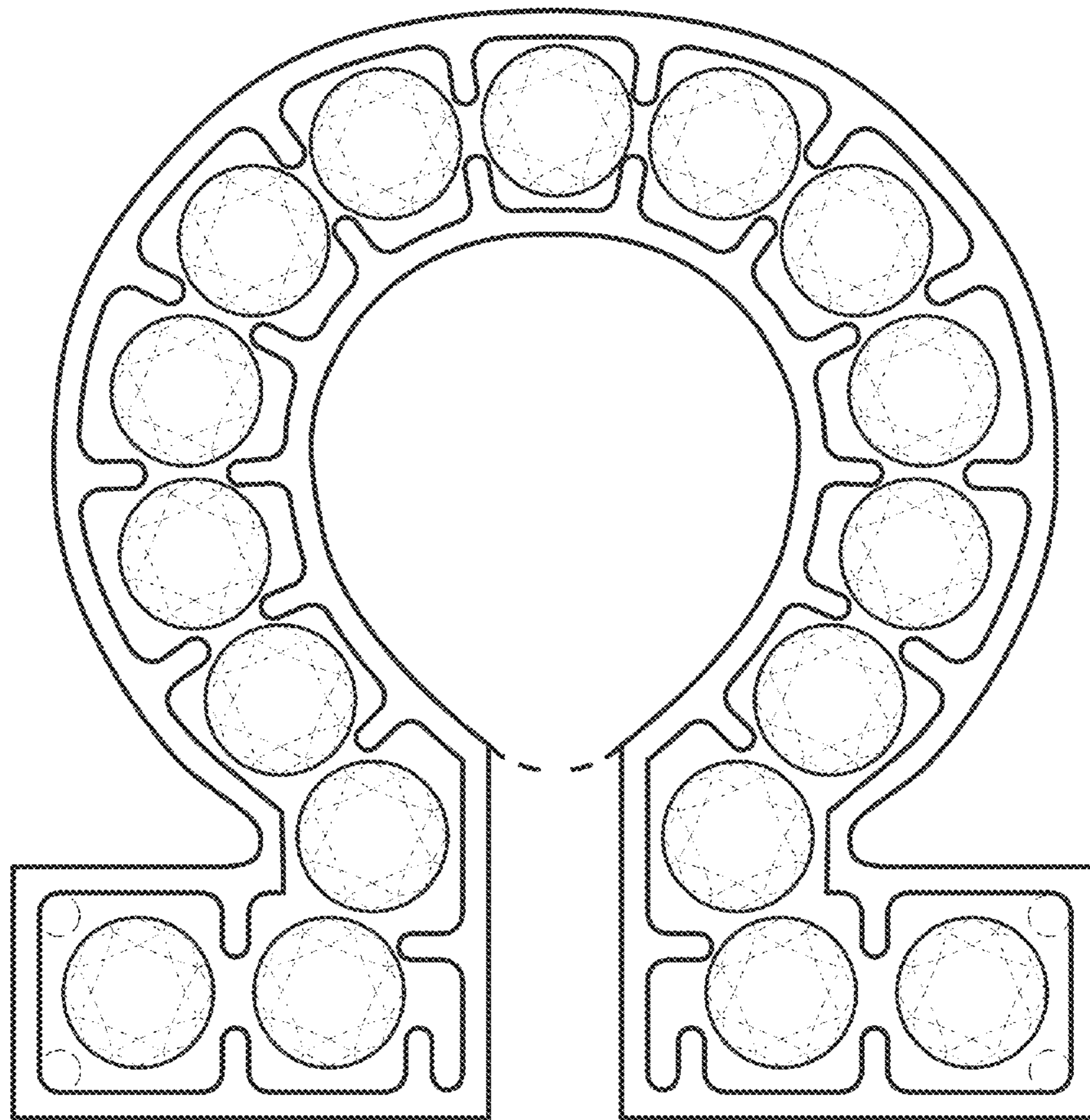

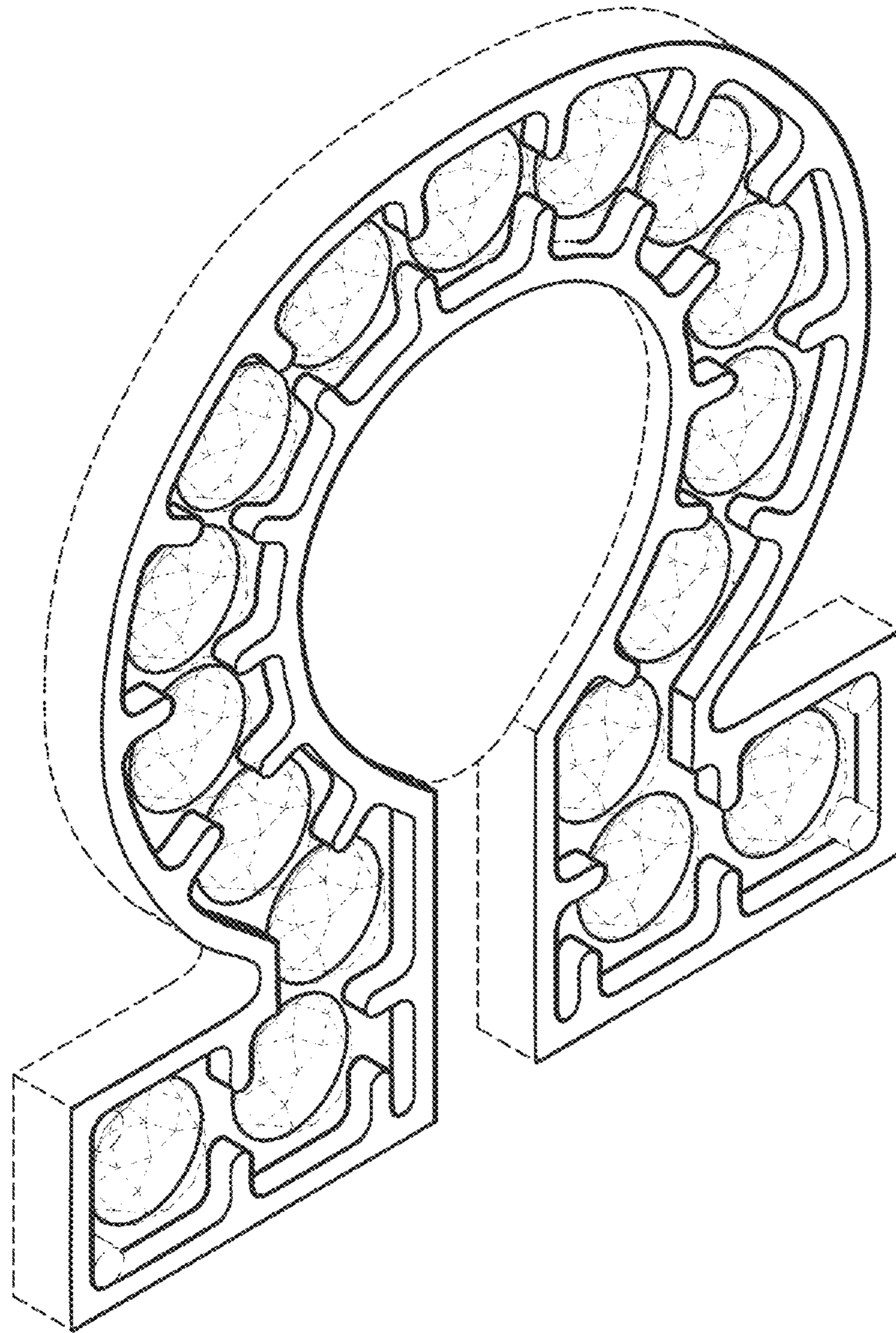

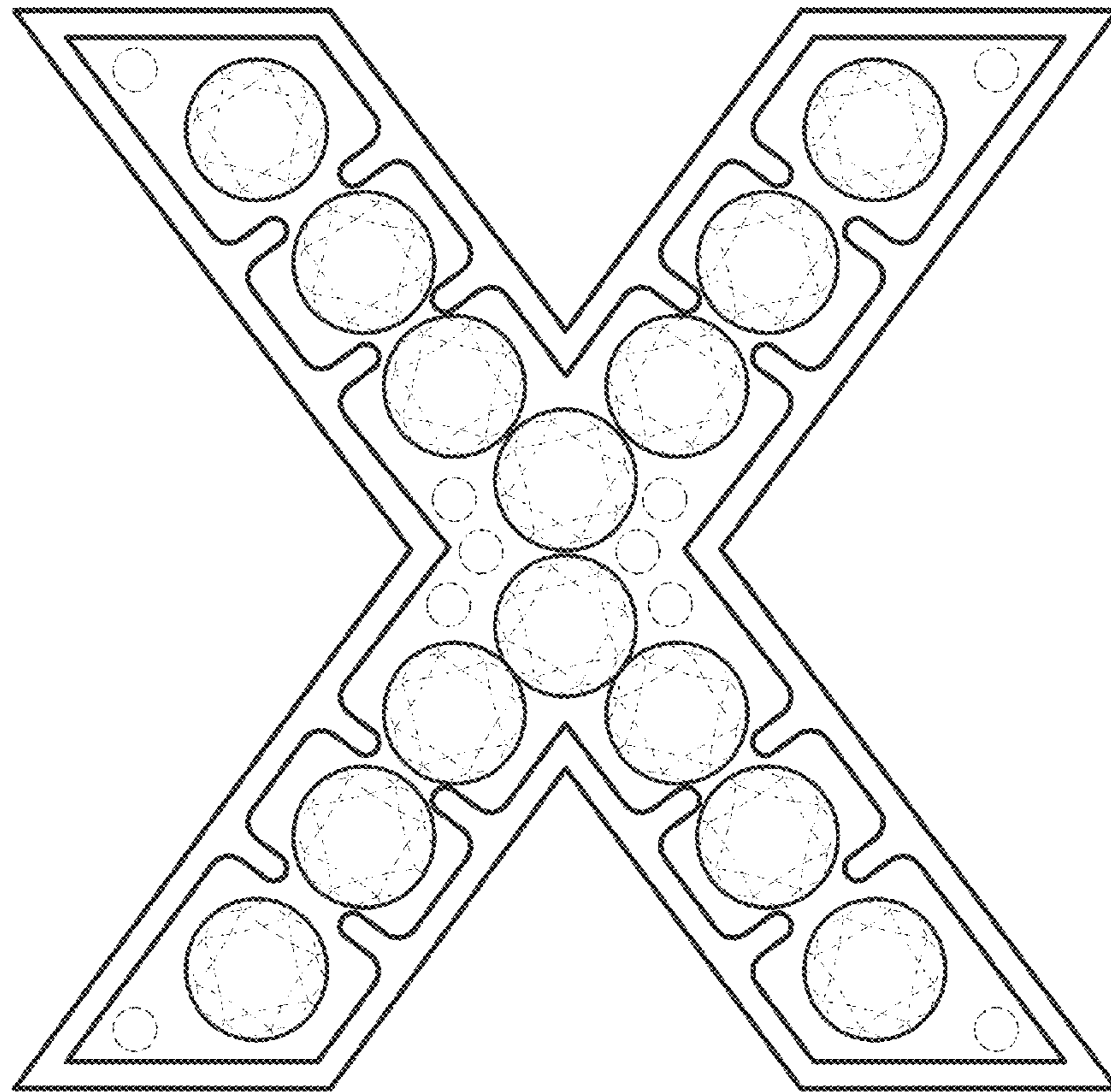

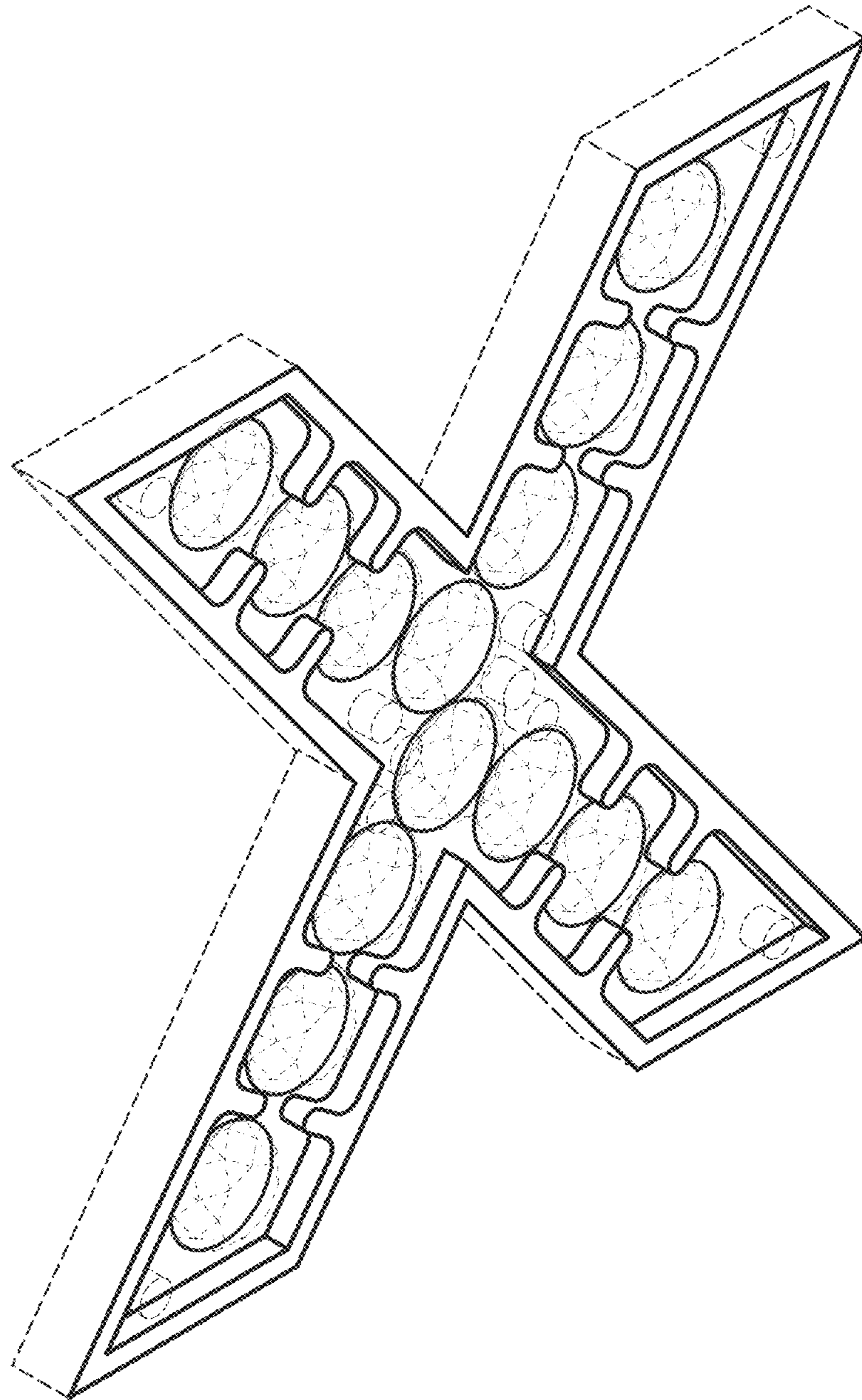

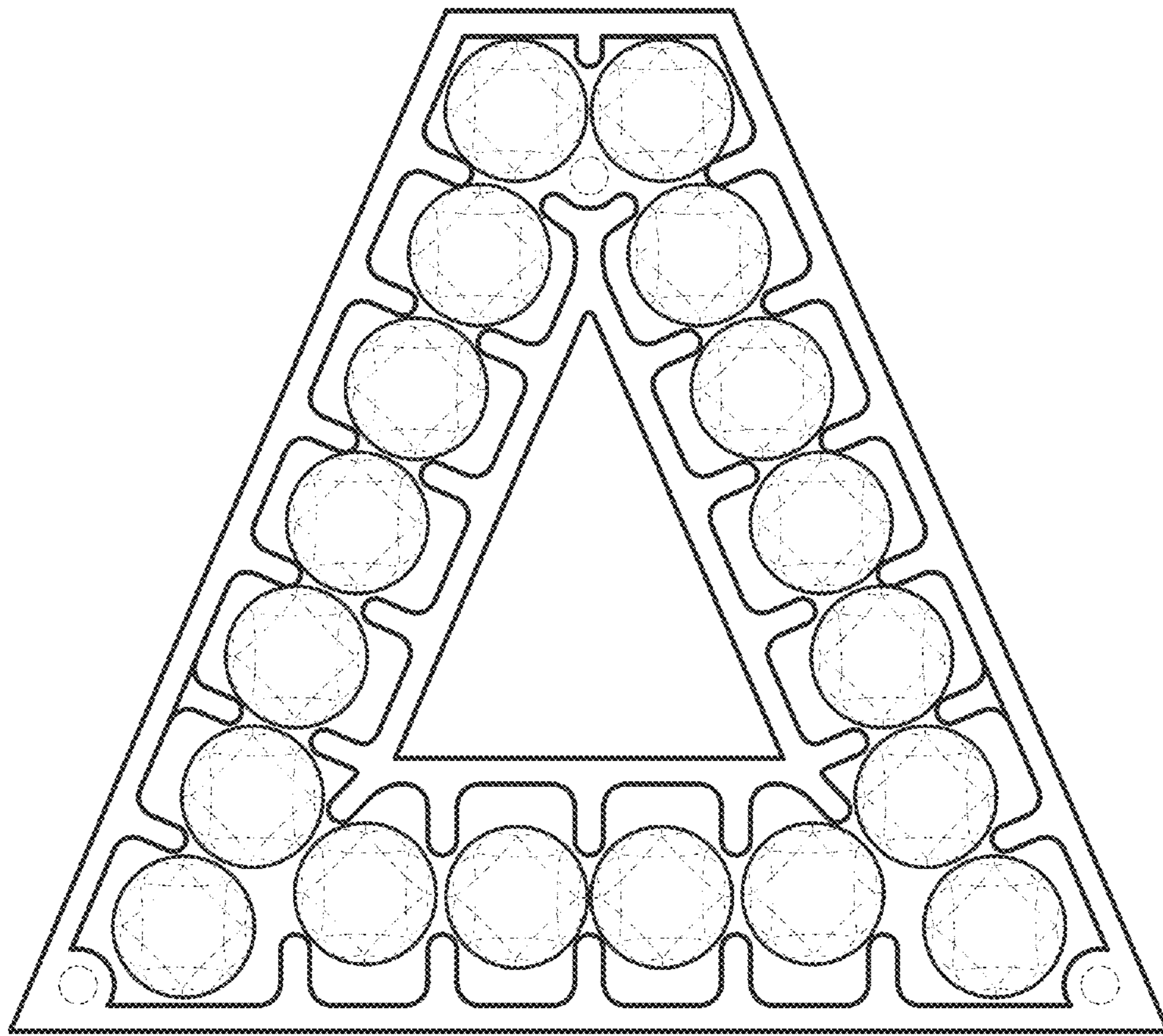

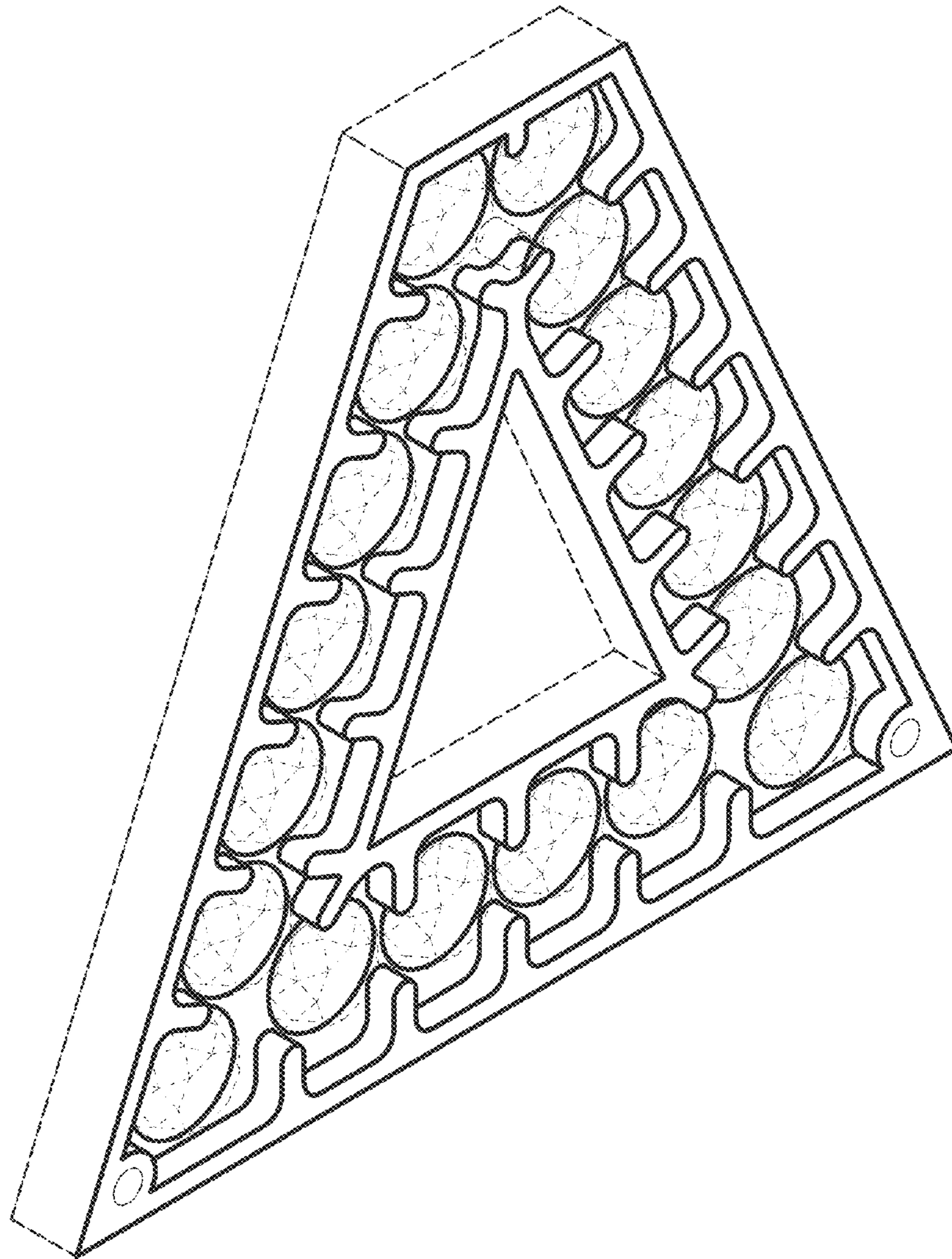

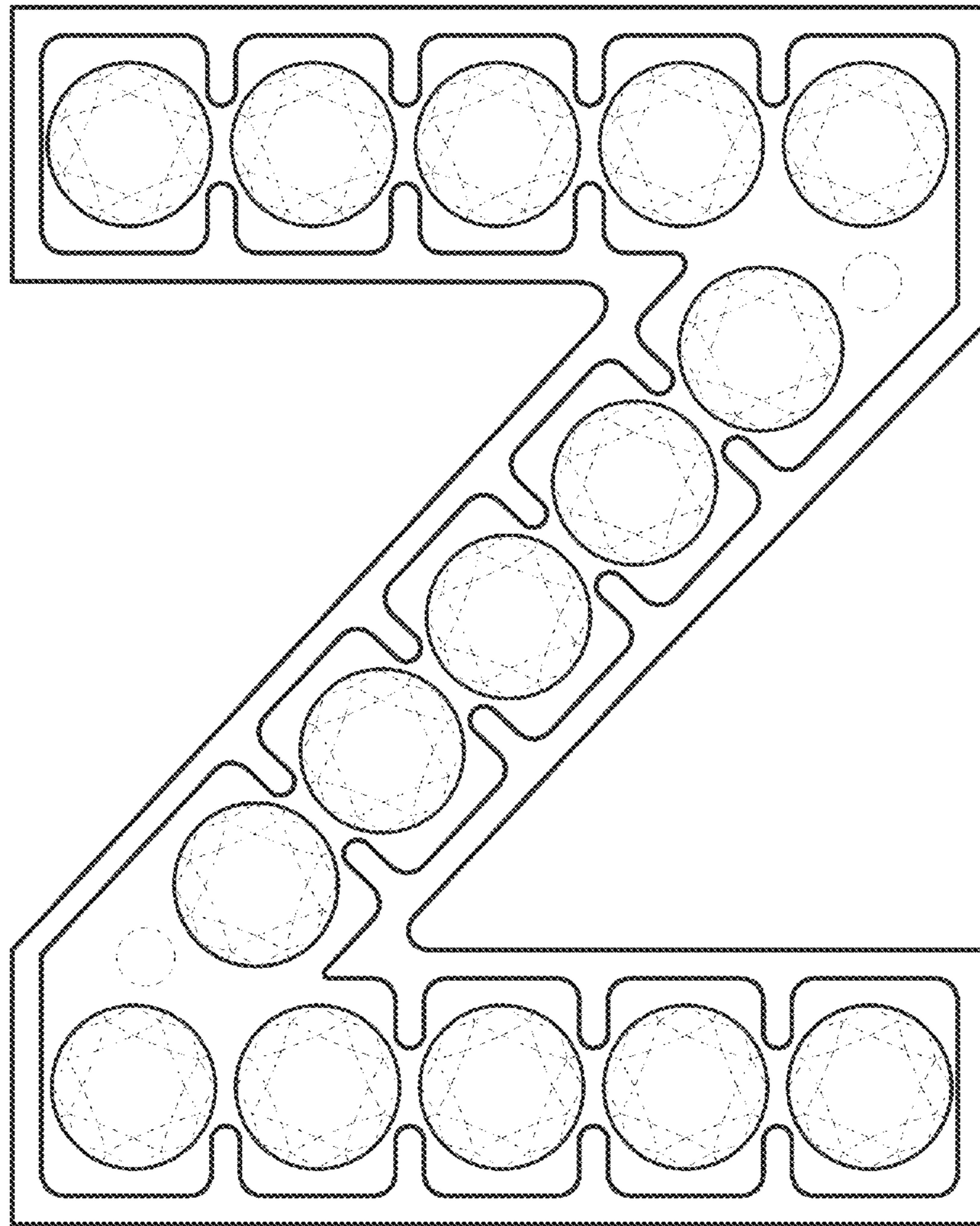

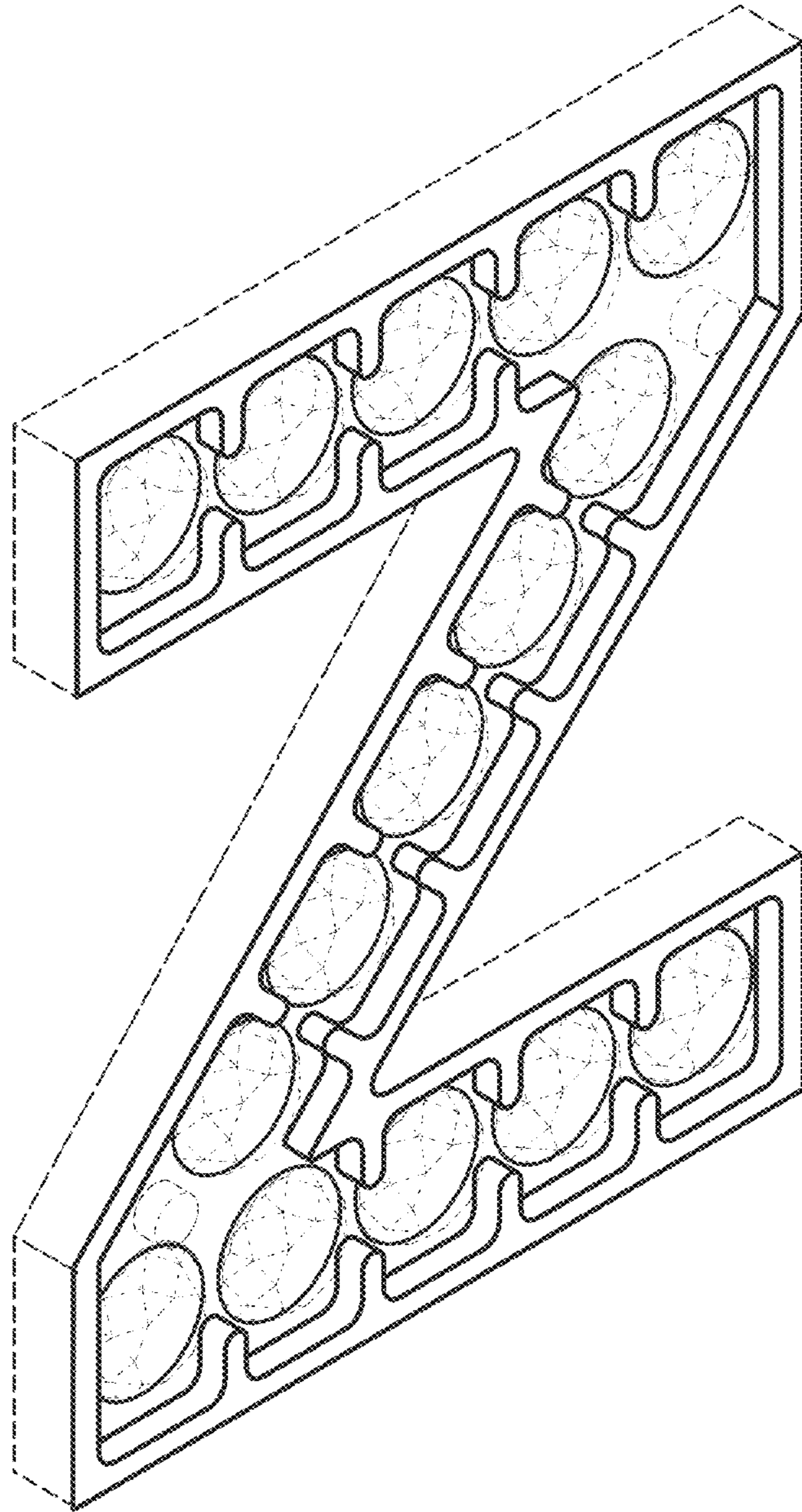

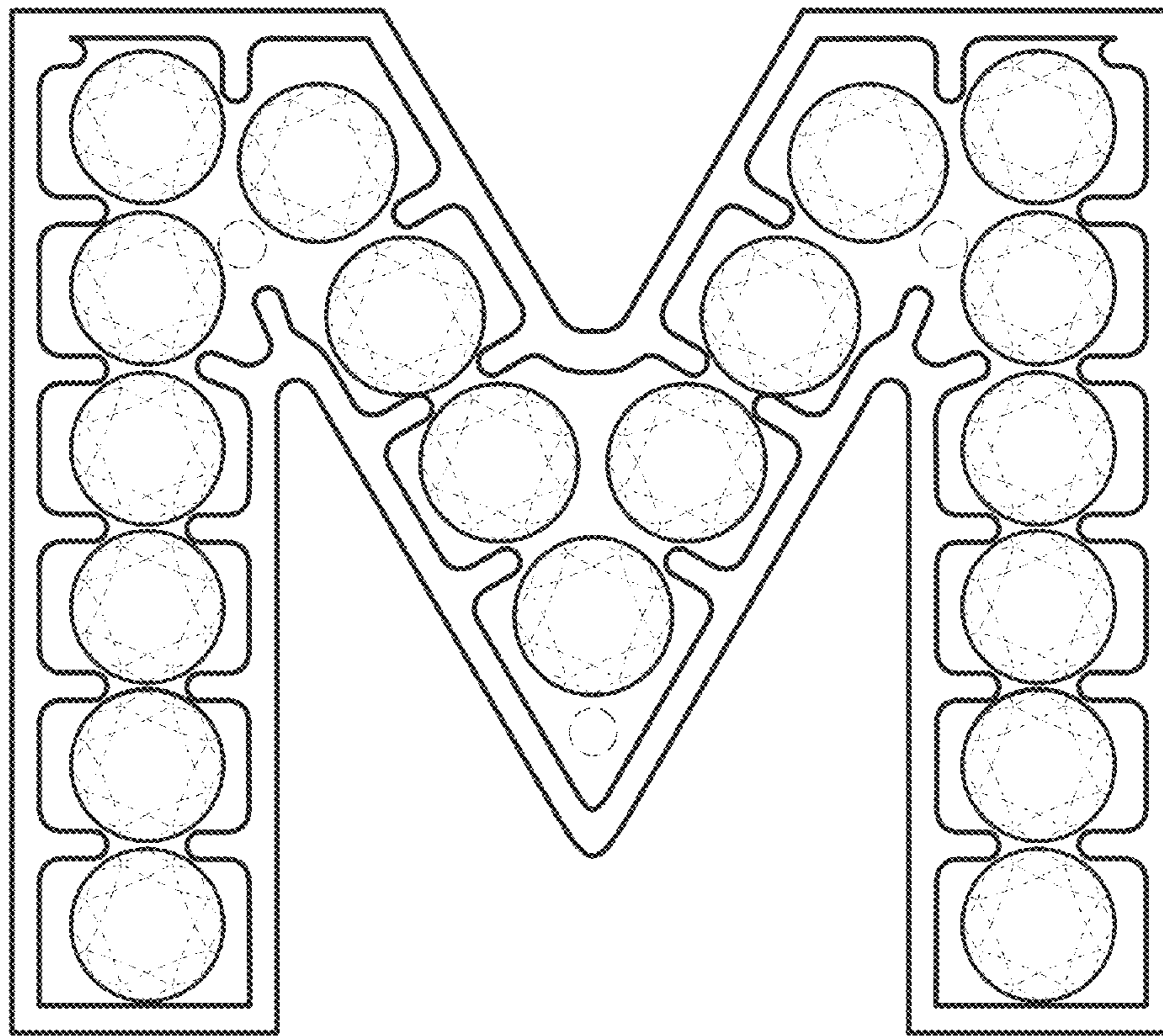

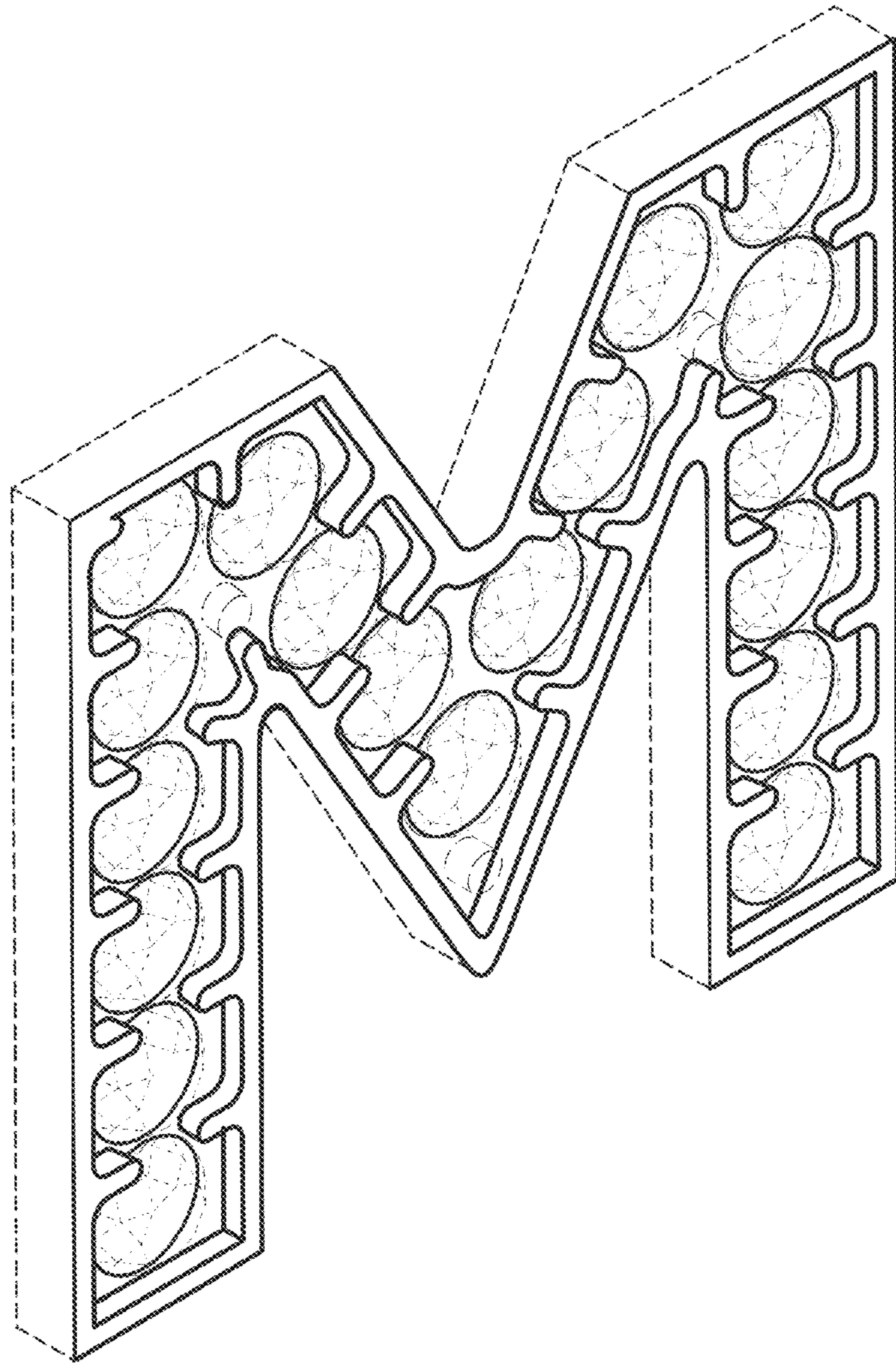
