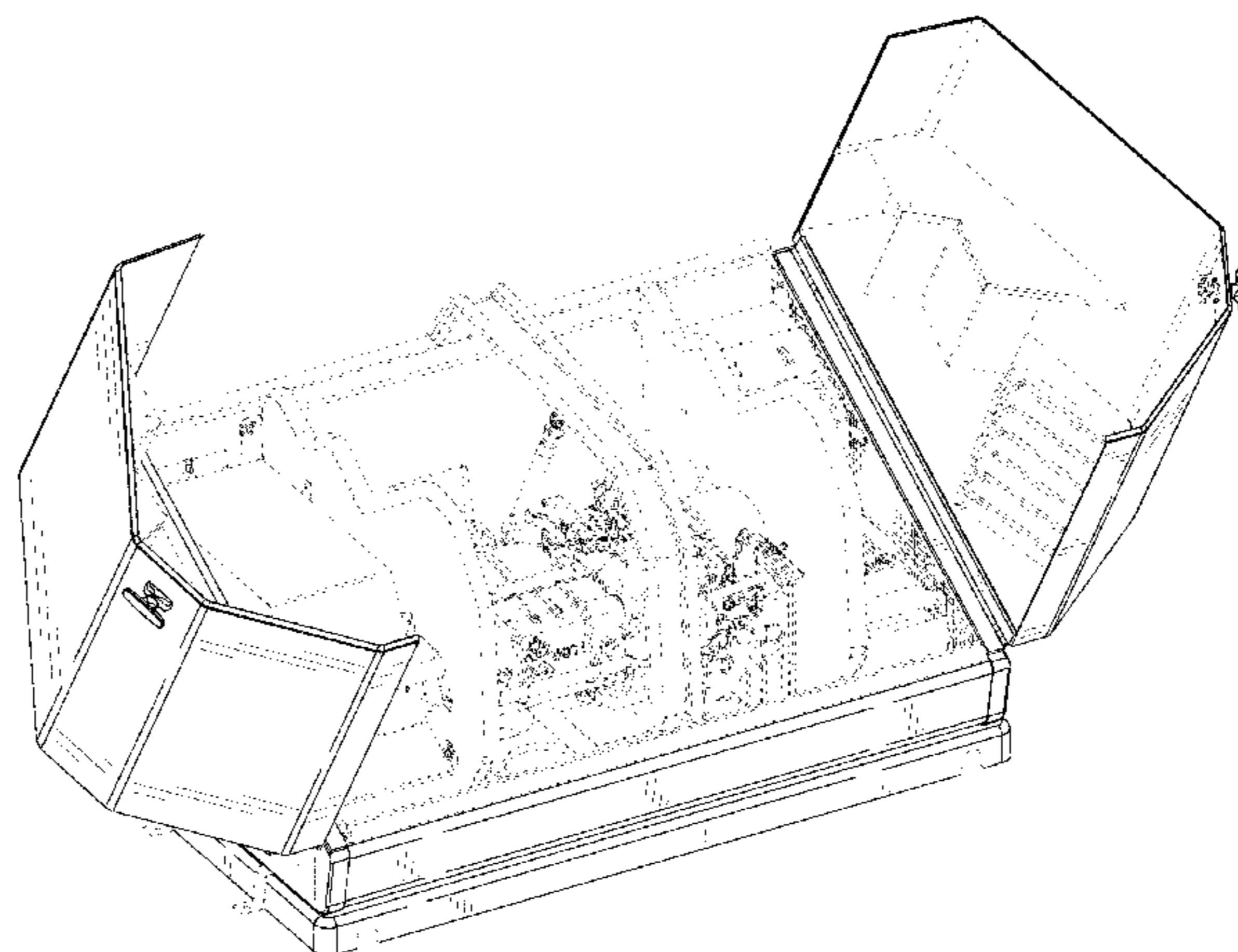
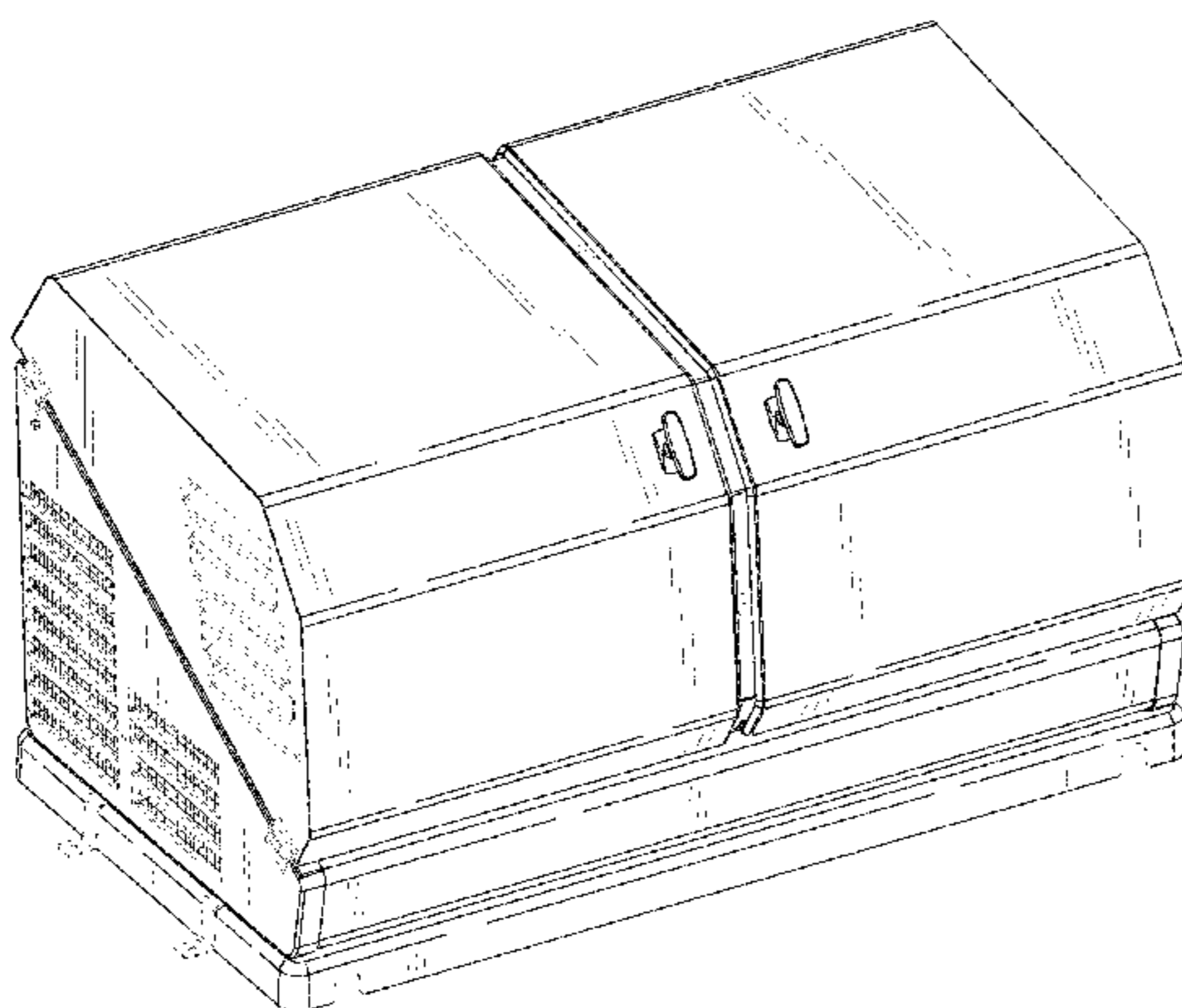
The ornamental design for an electrical generator, as shown and described.

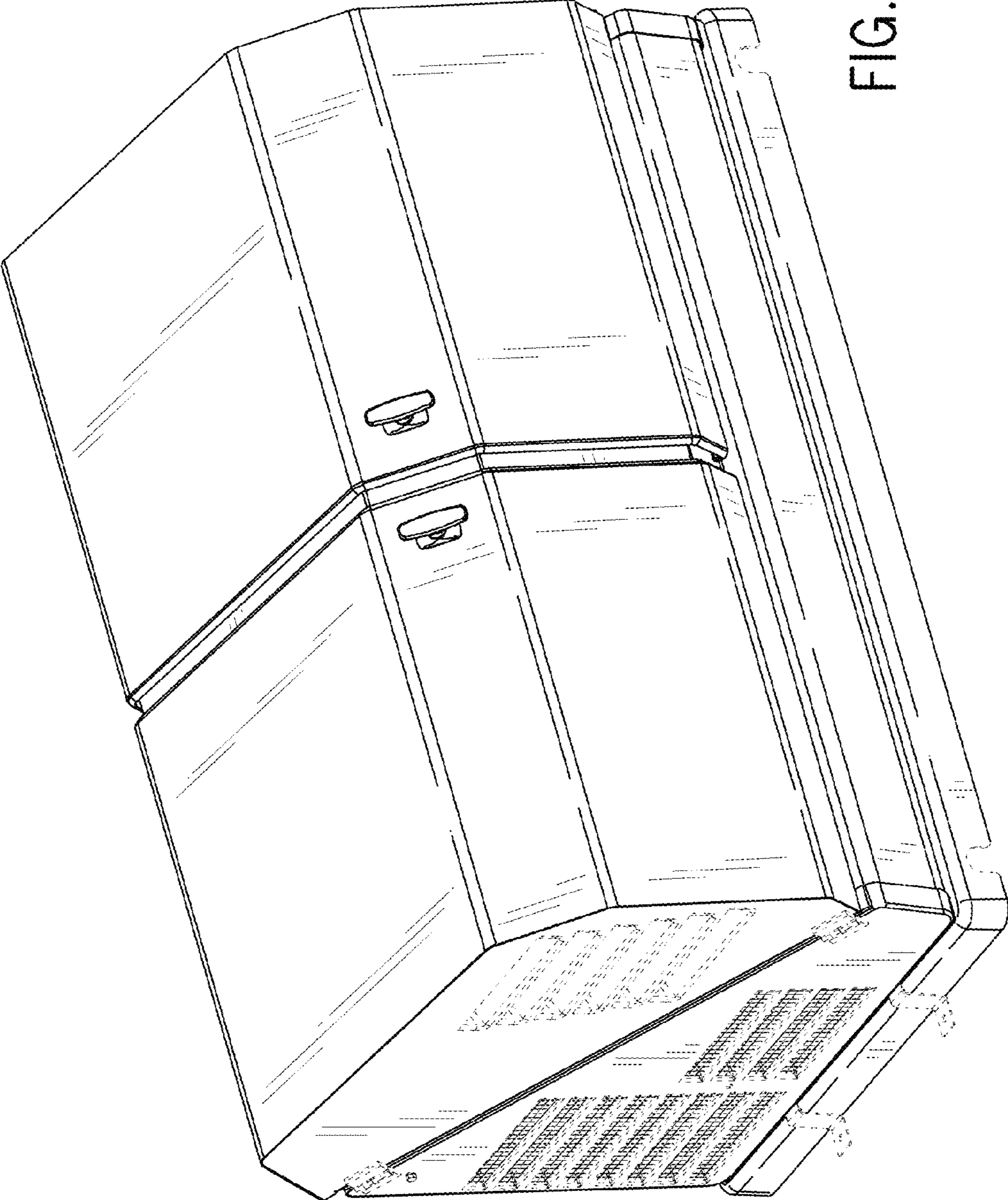

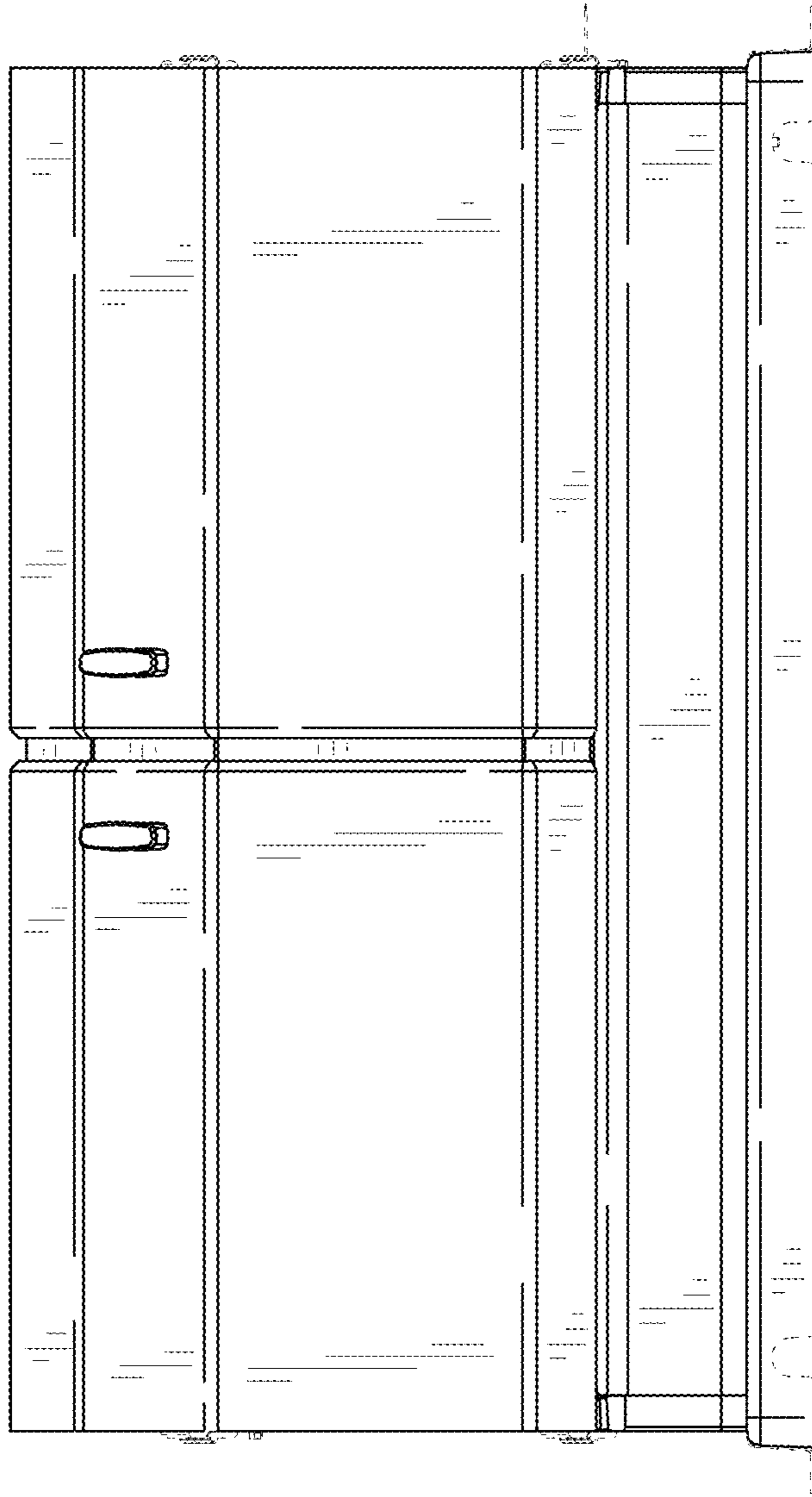

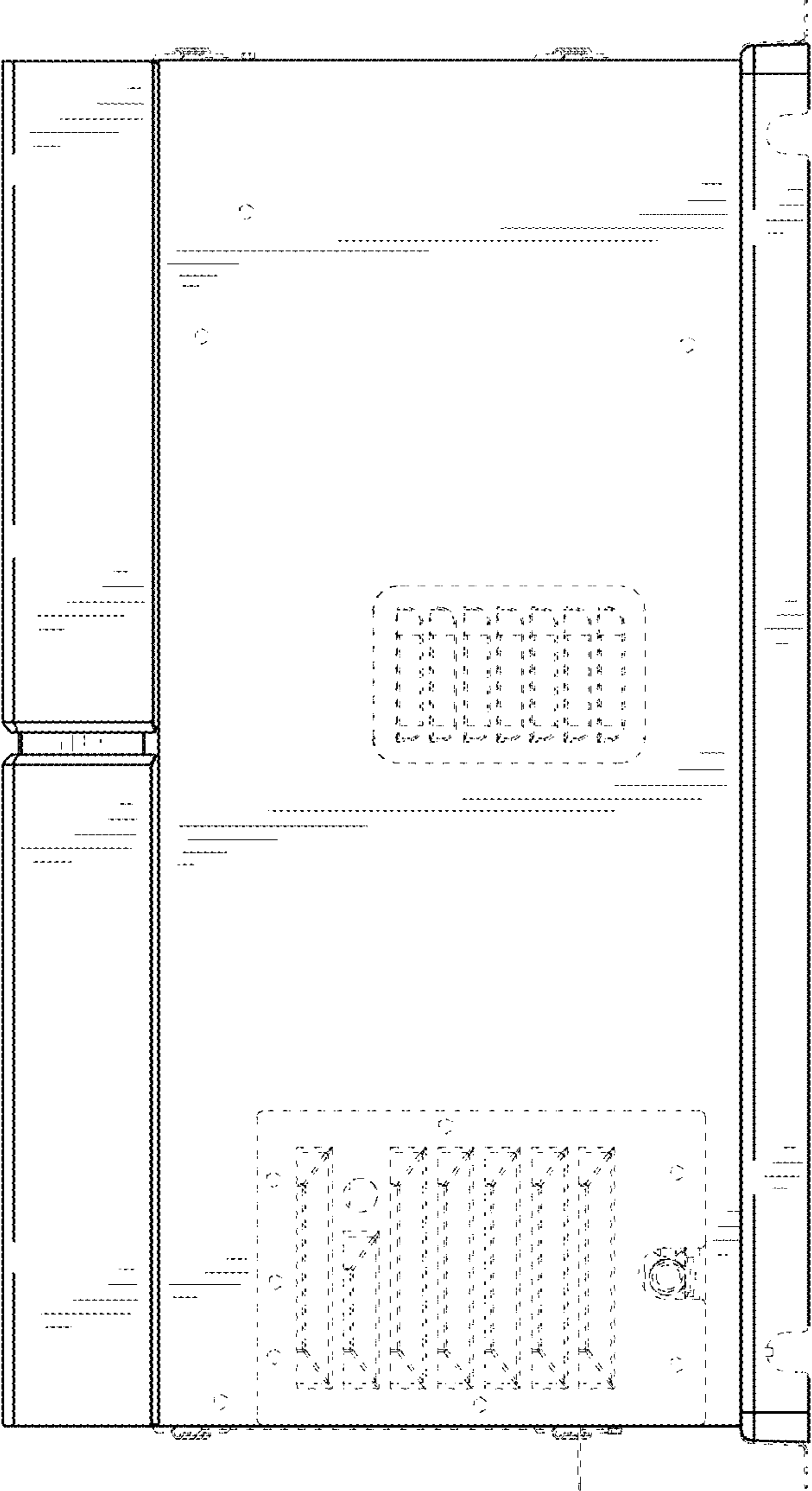

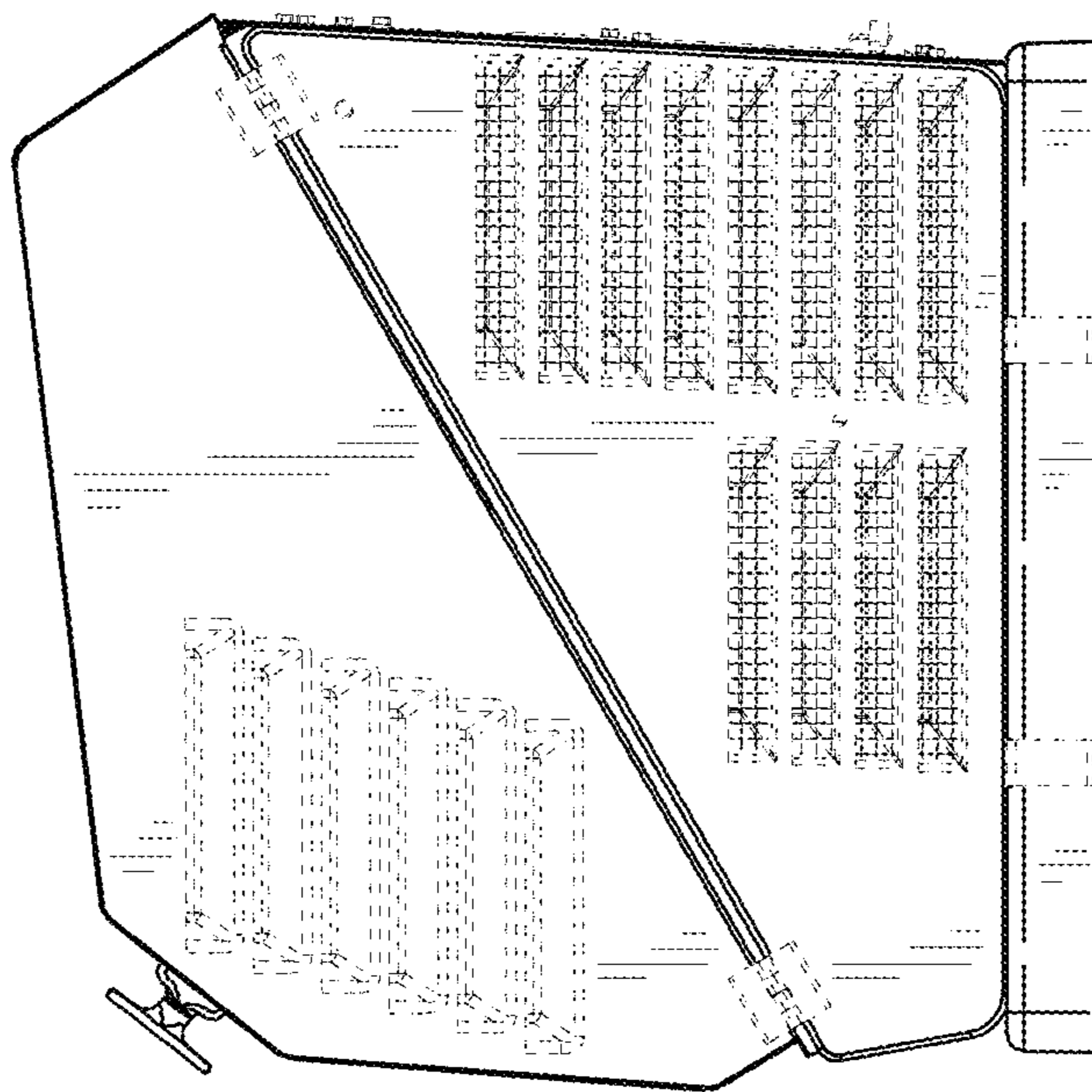

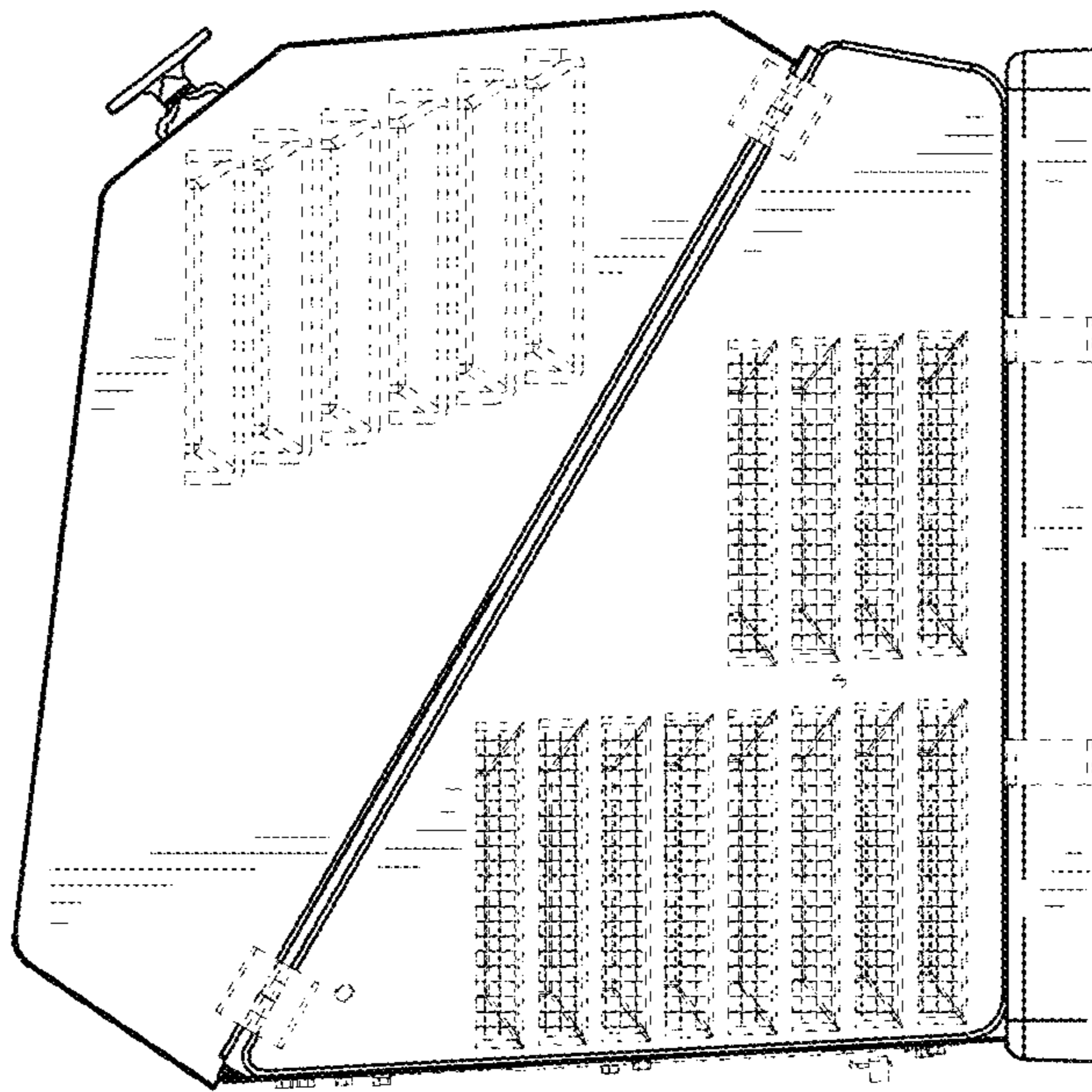

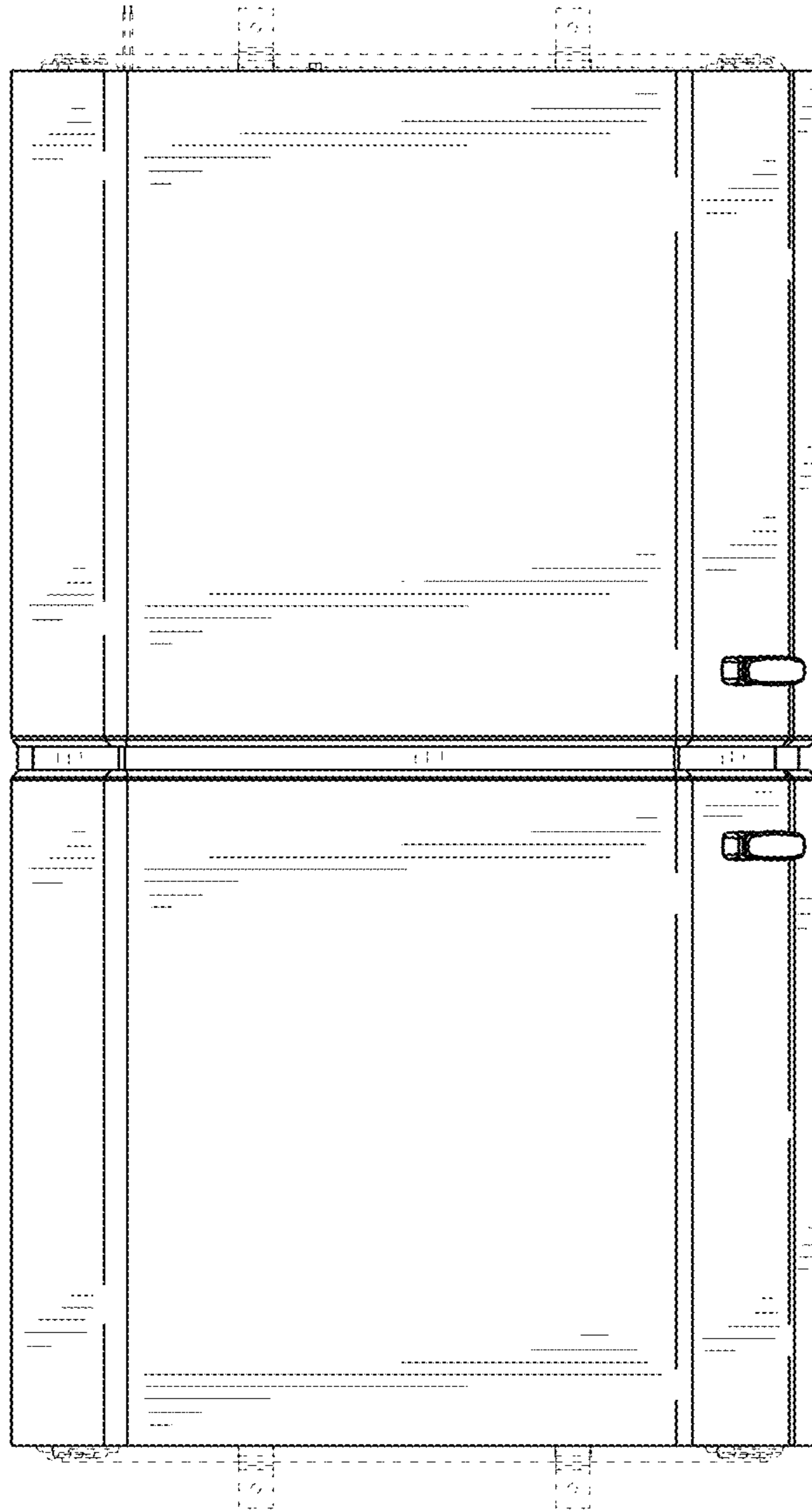

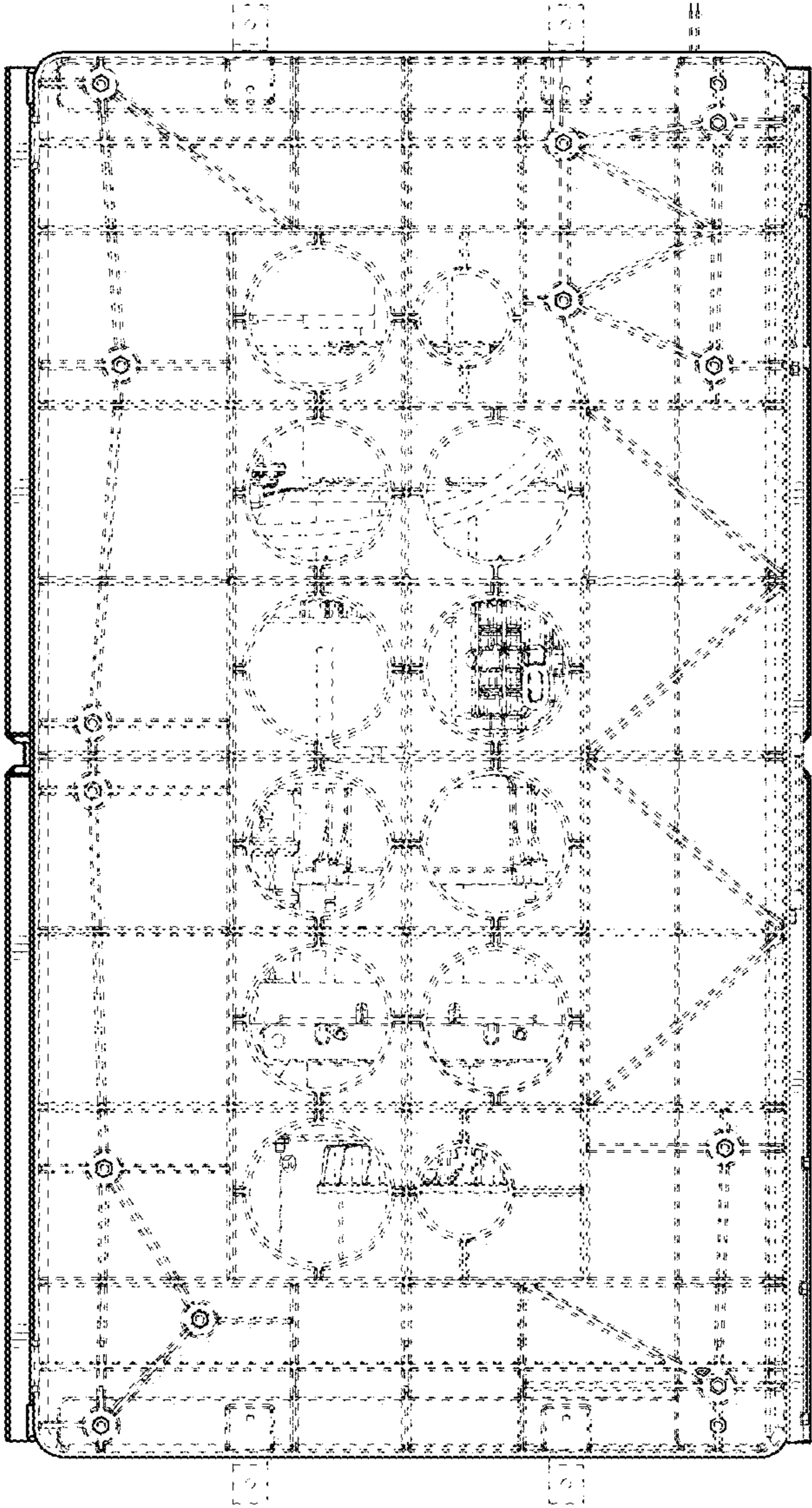

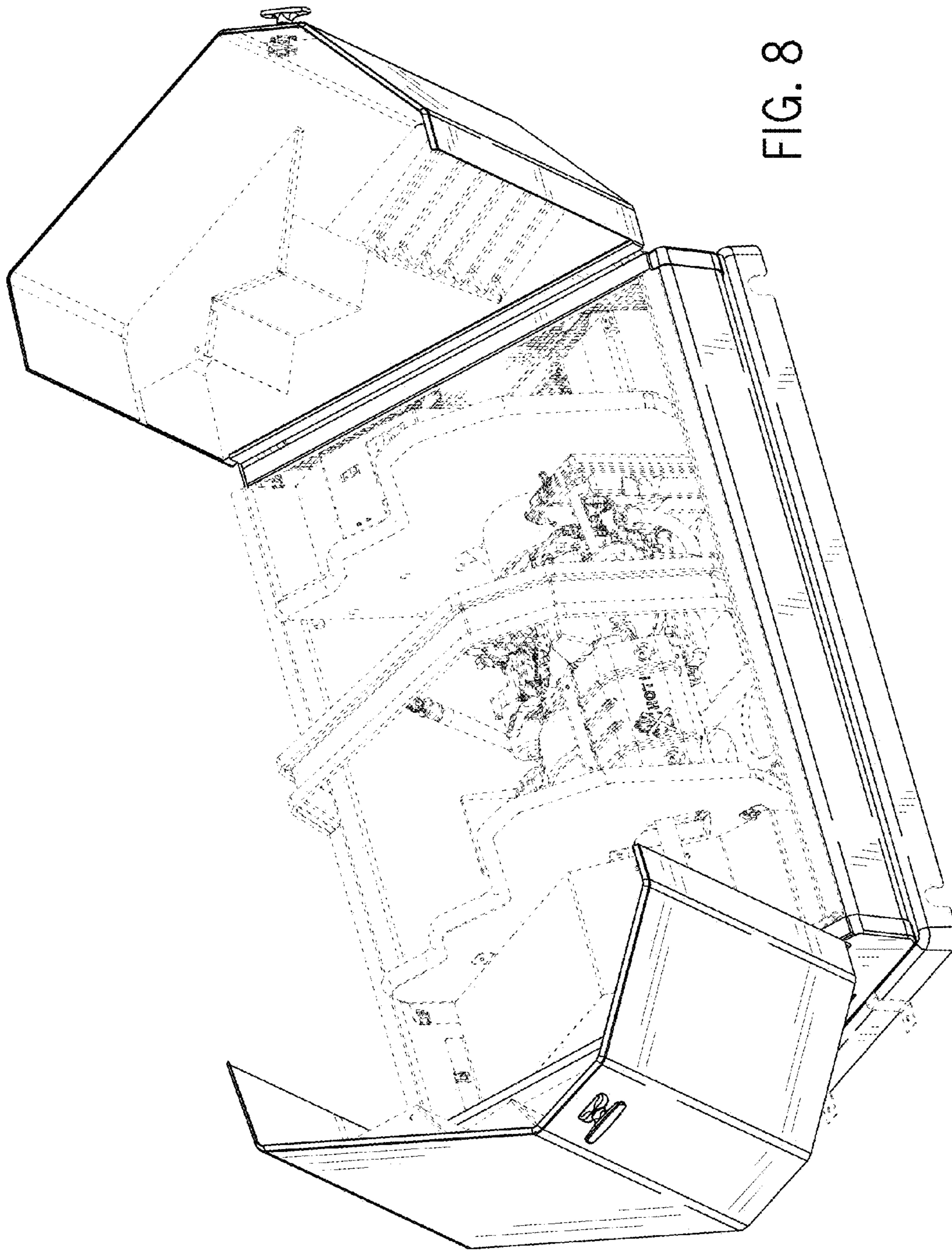

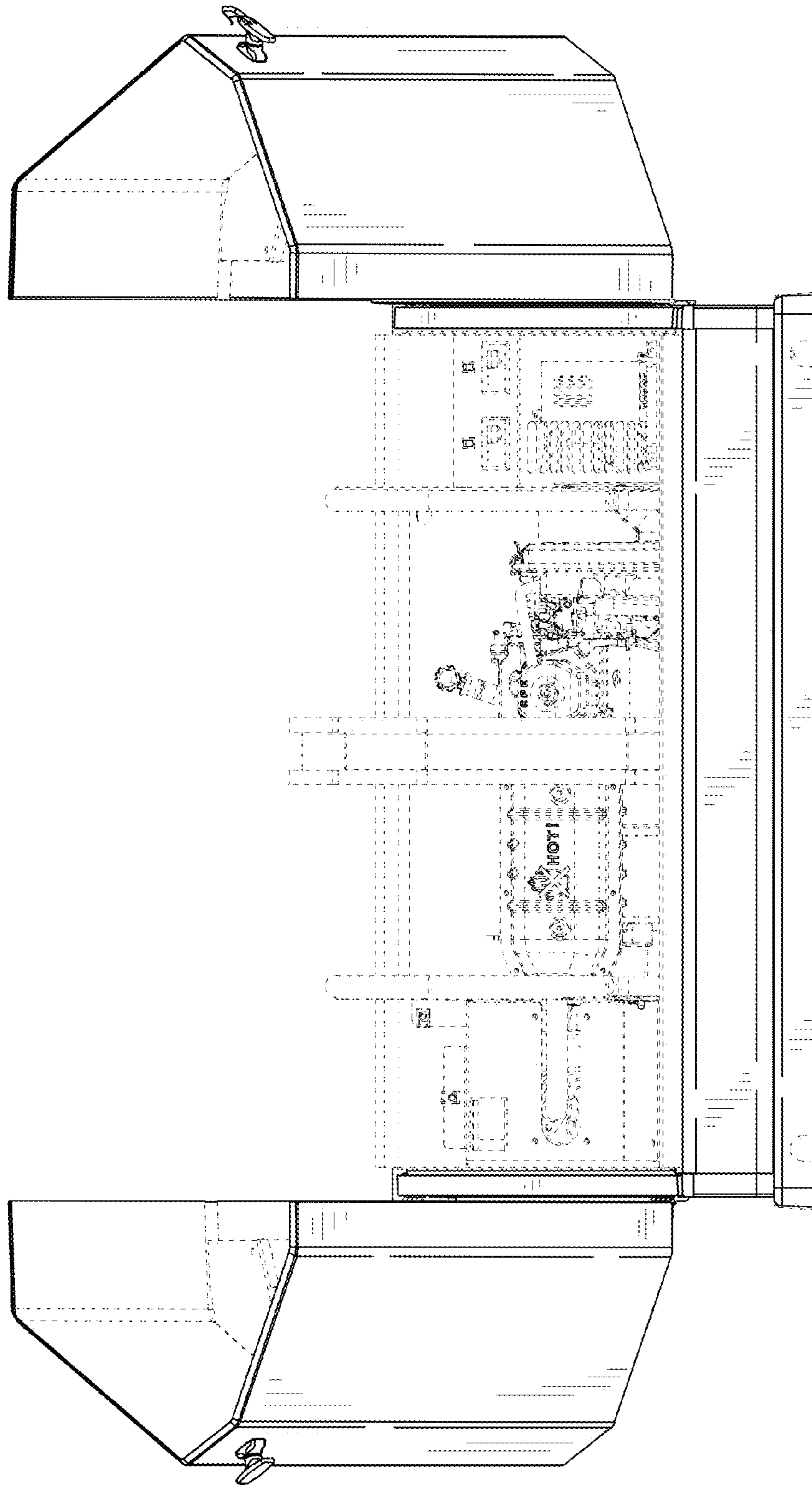

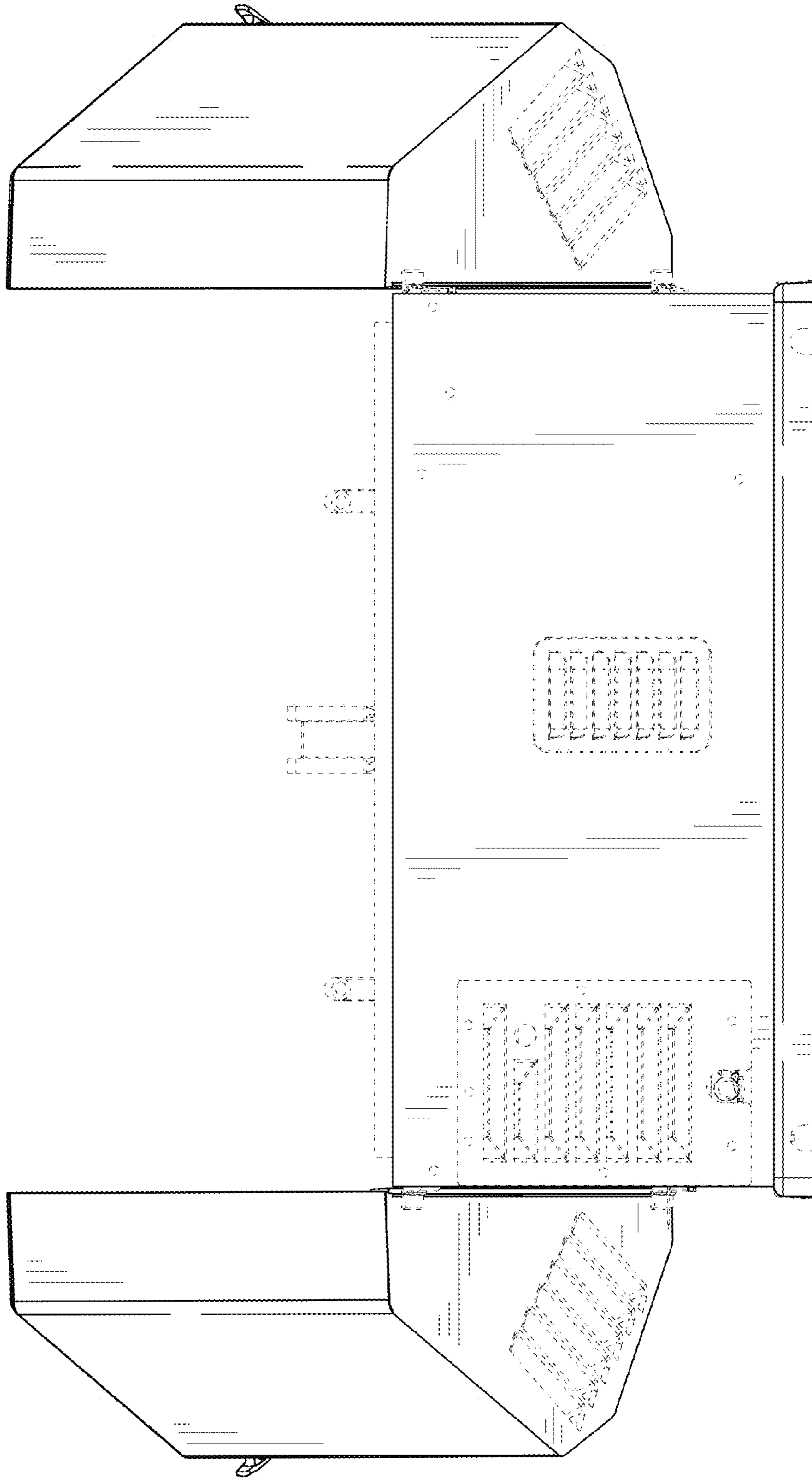

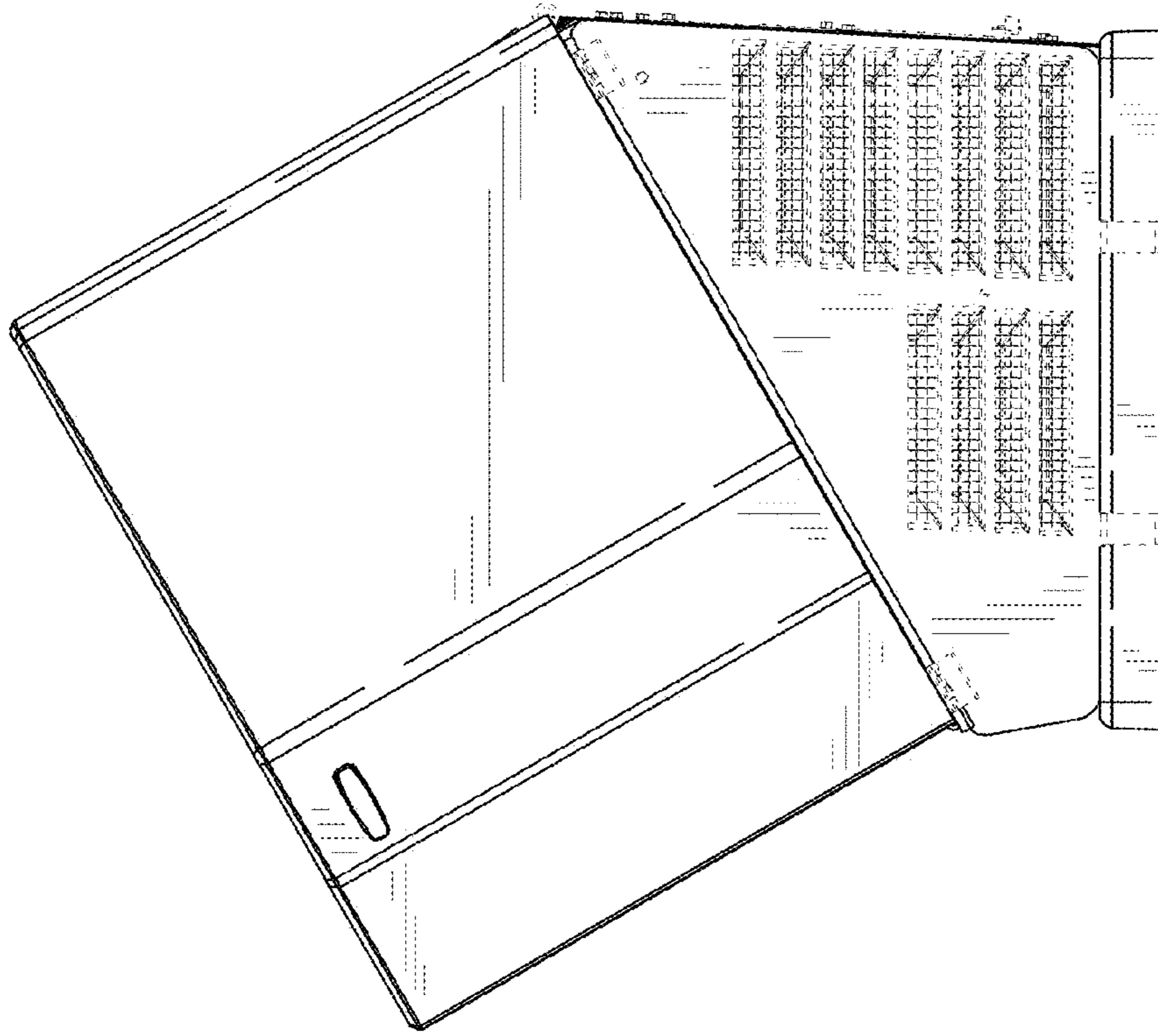

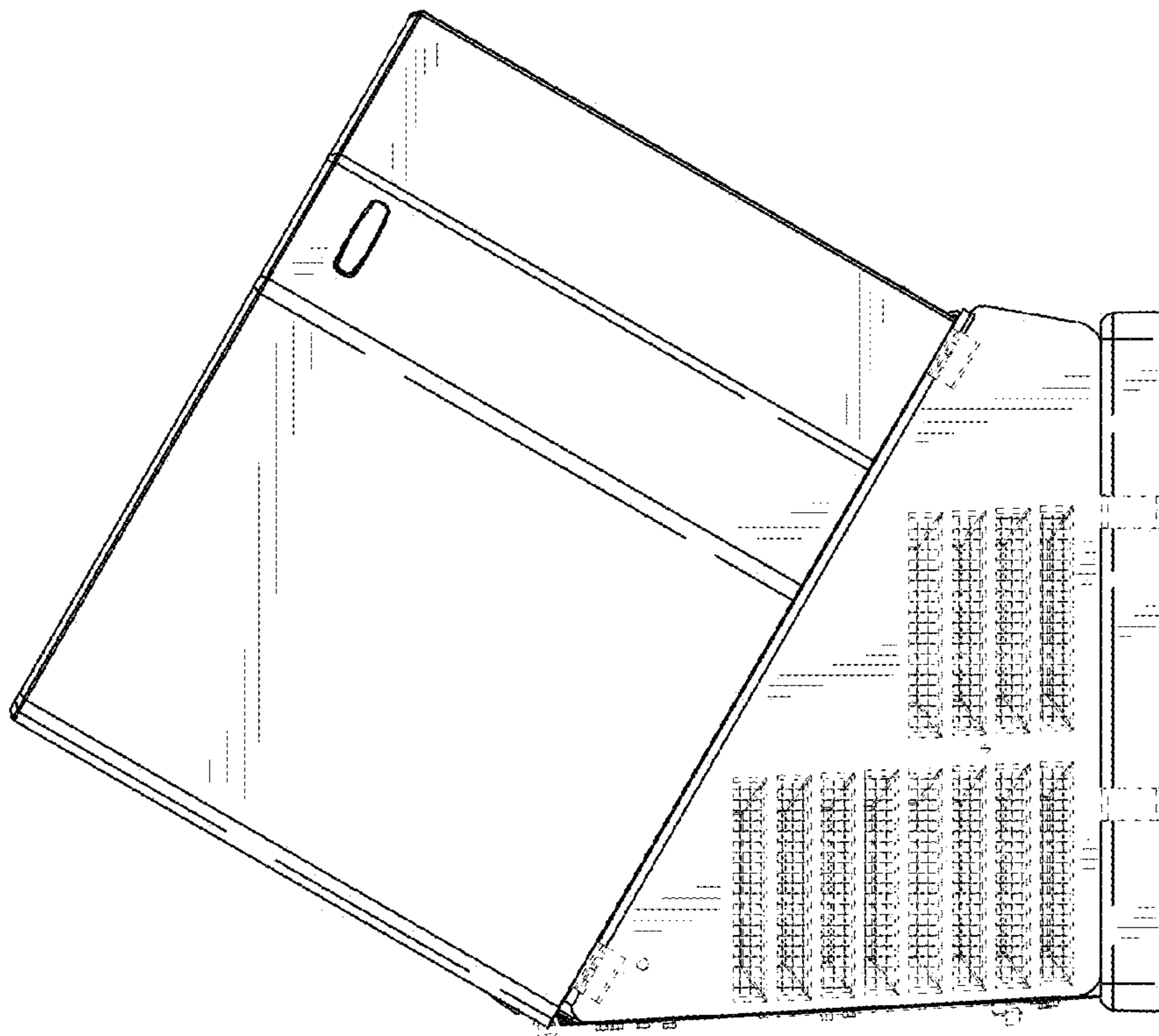

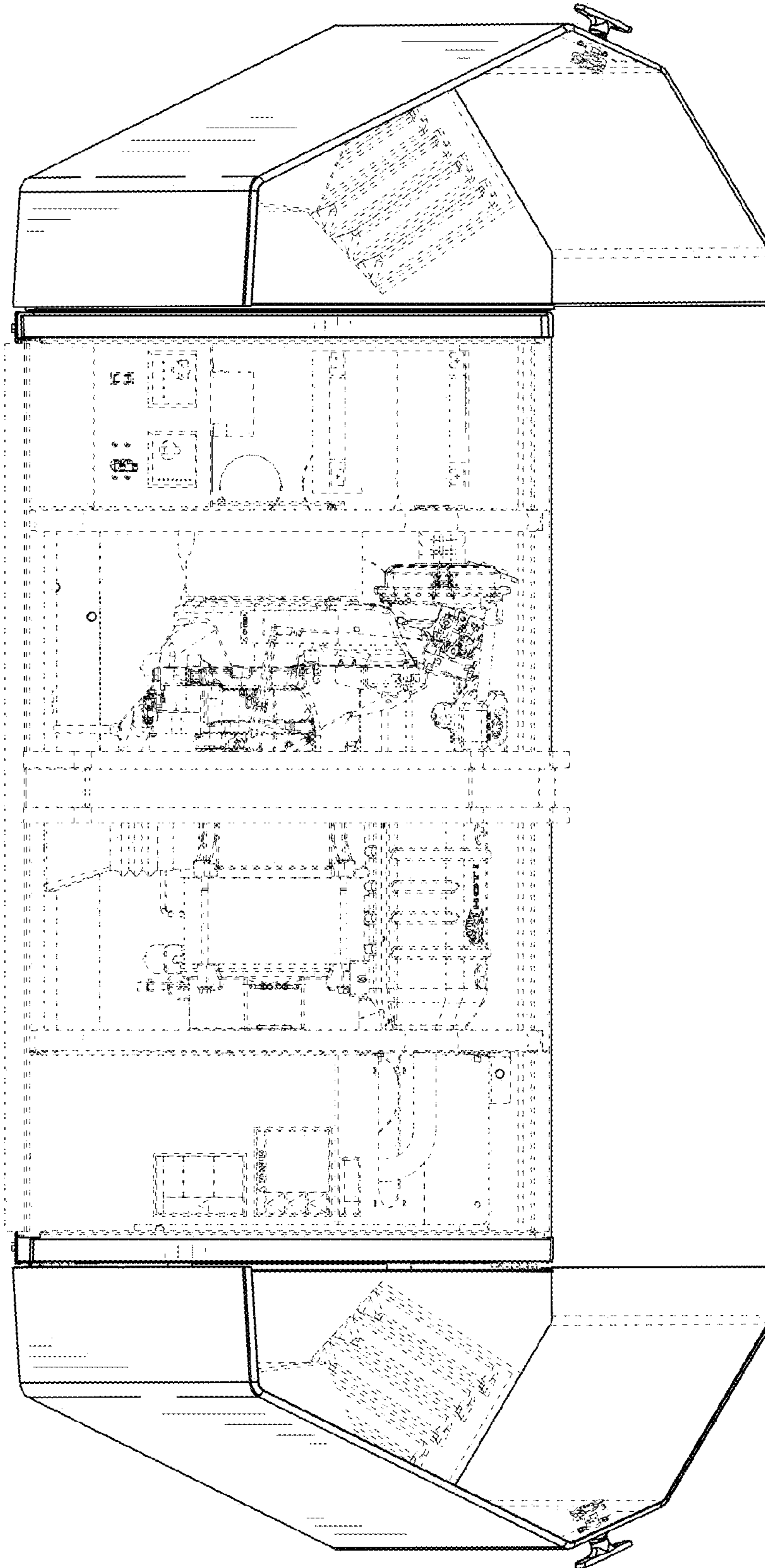

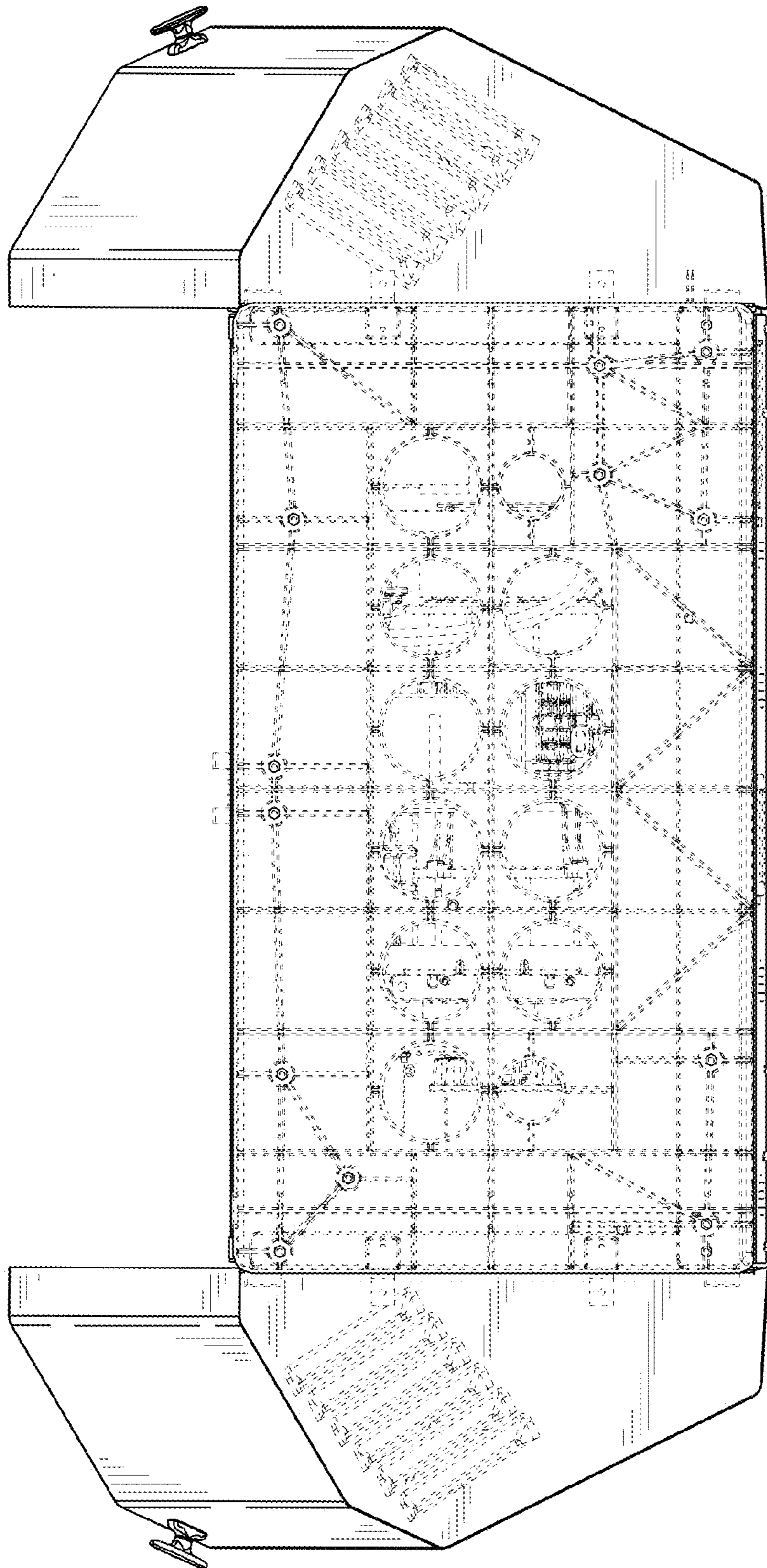
