We claim the ornamental design for stand for television, as shown and described.

DESCRIPTION

FIG. 1 is the front perspective view of stand for television showing our new design;

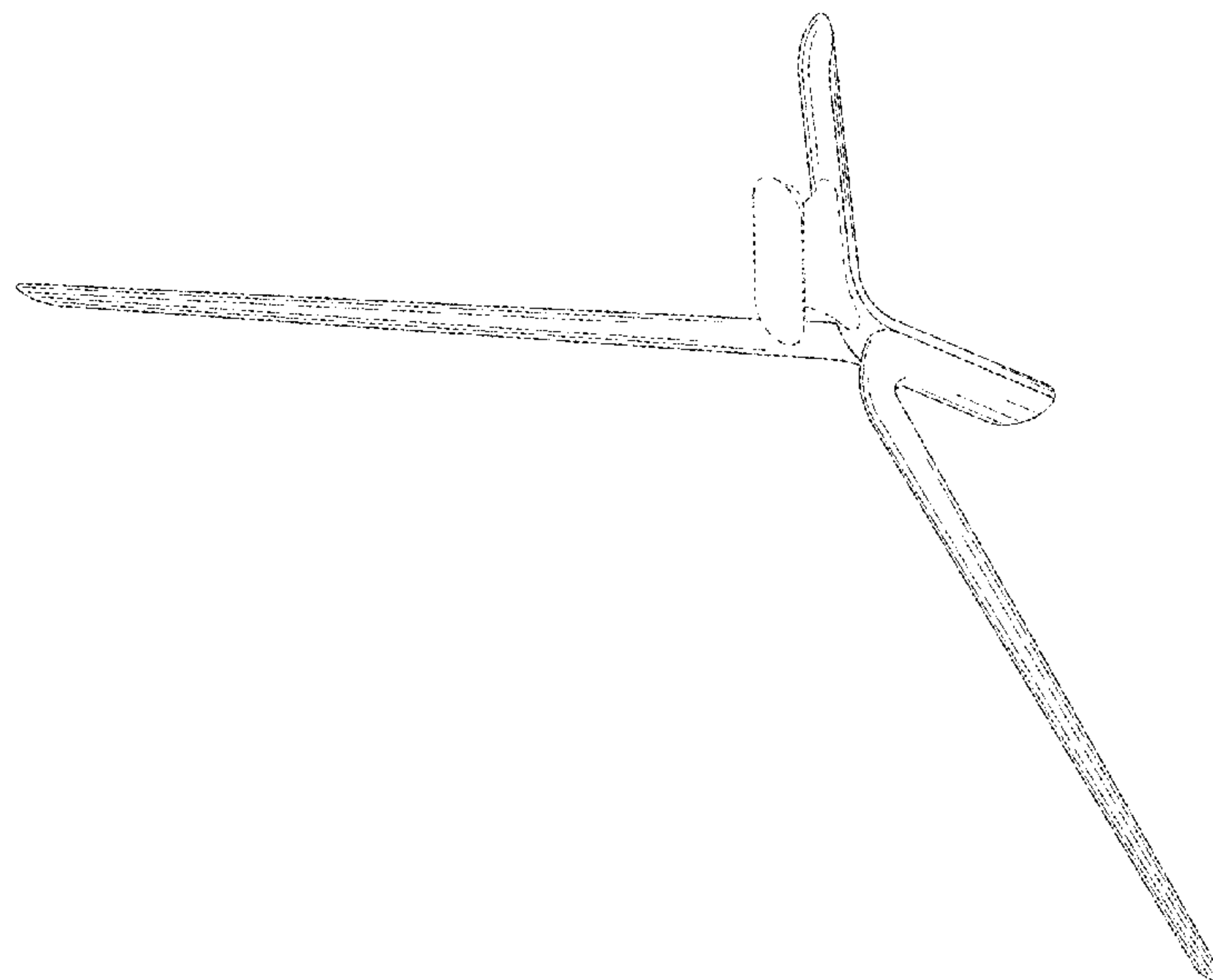

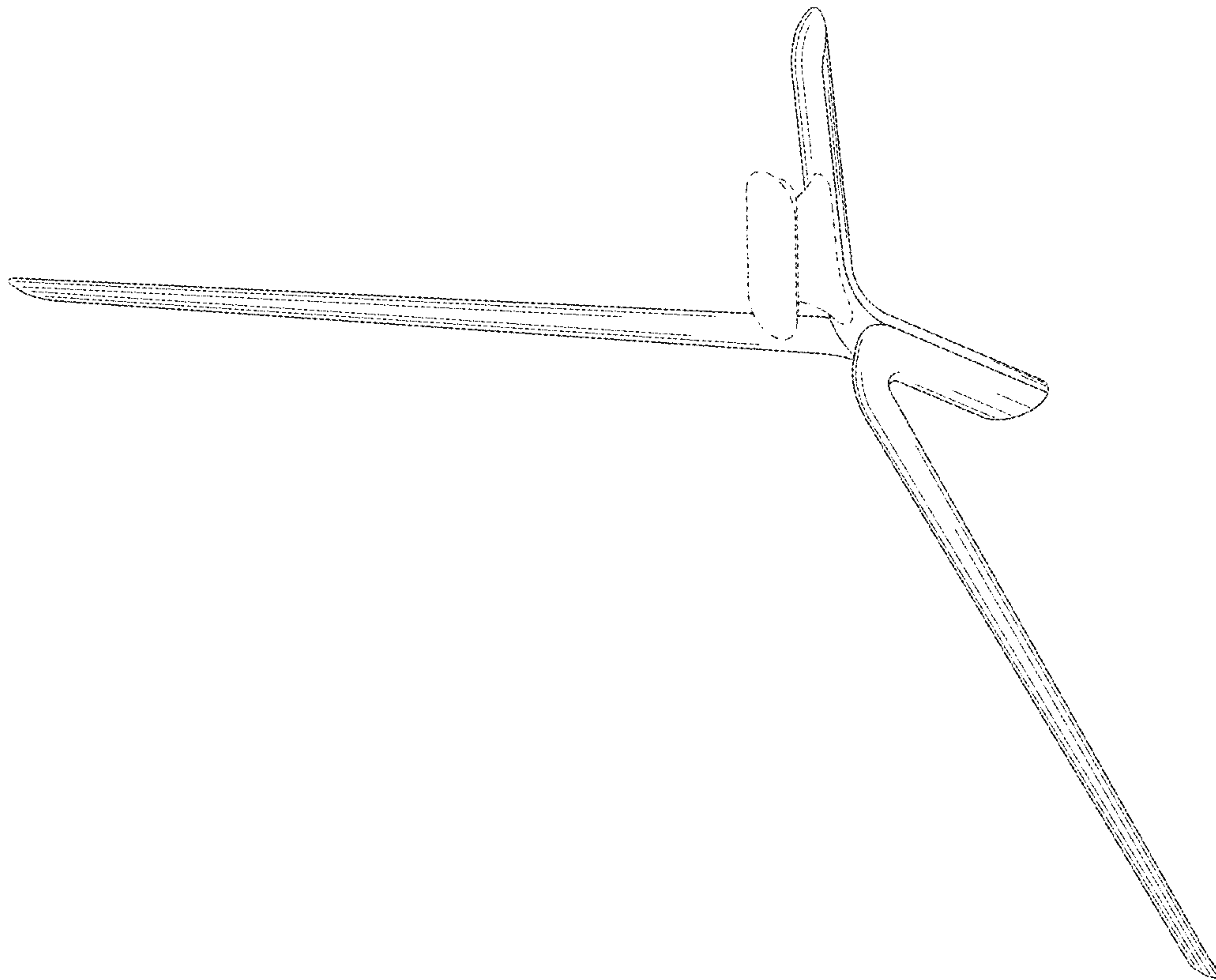

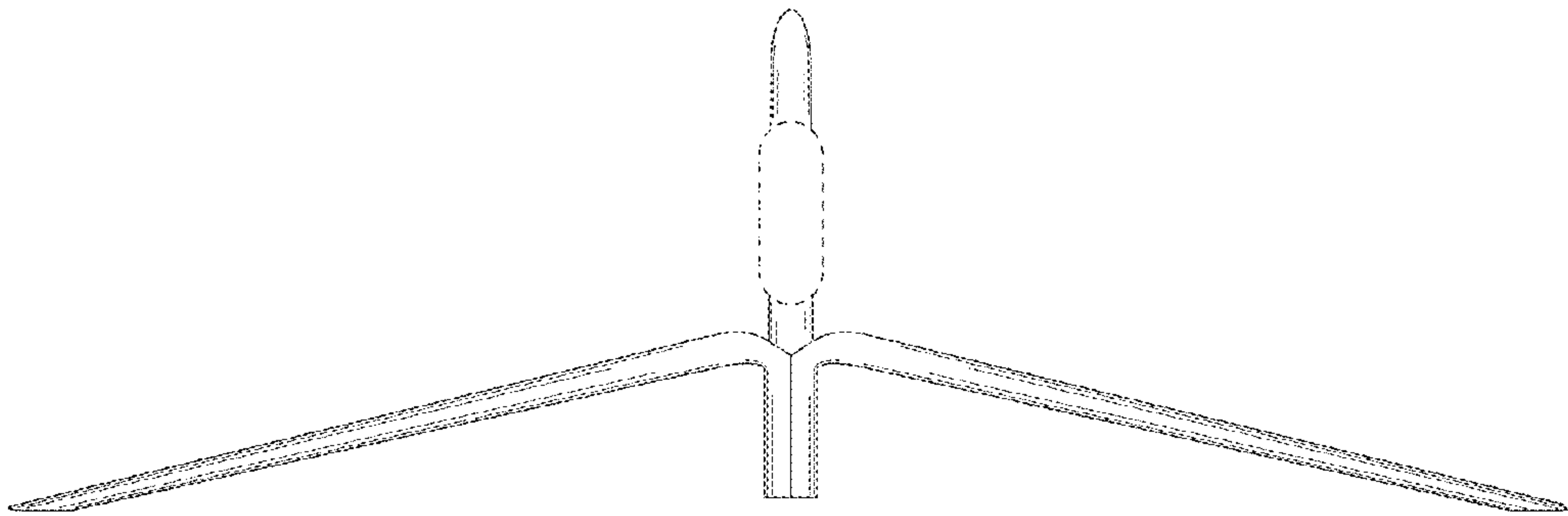

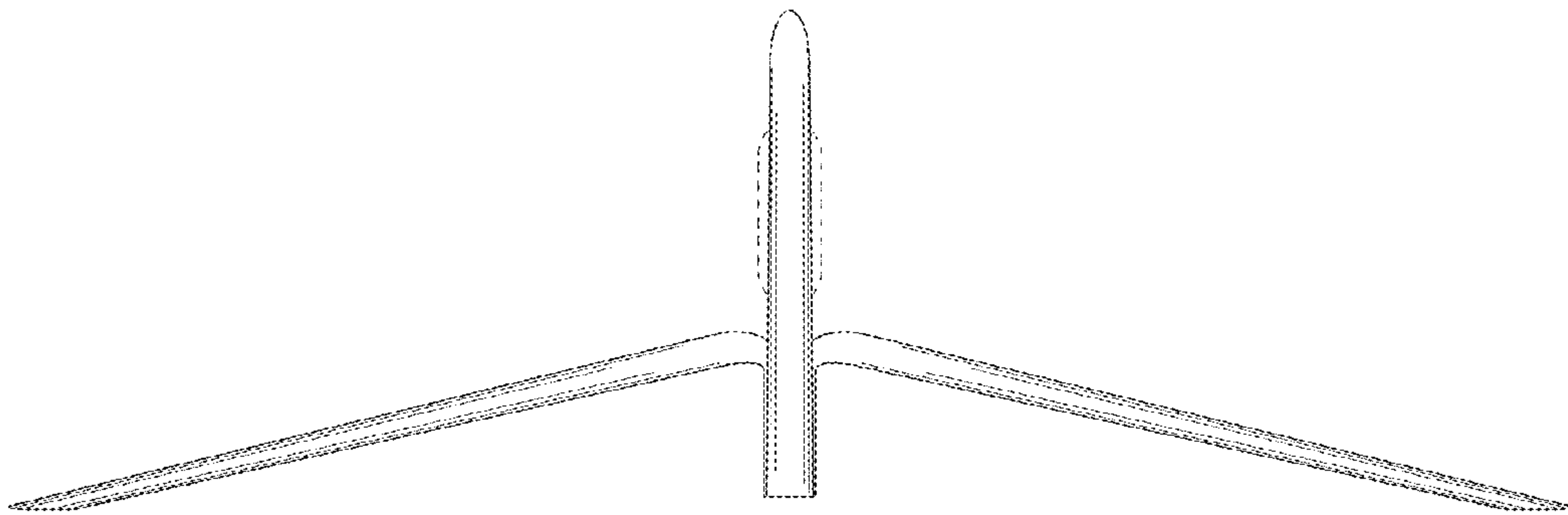

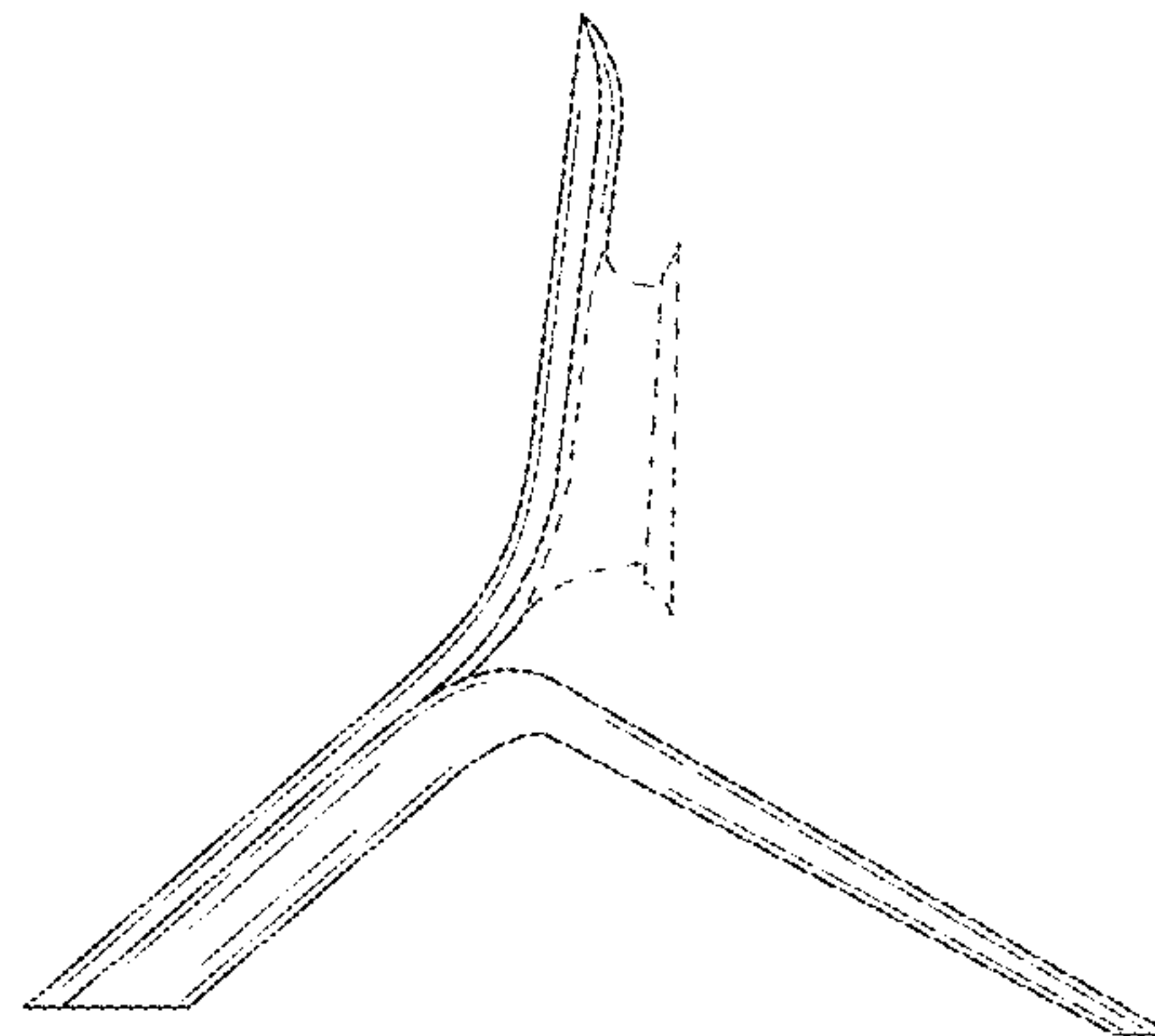

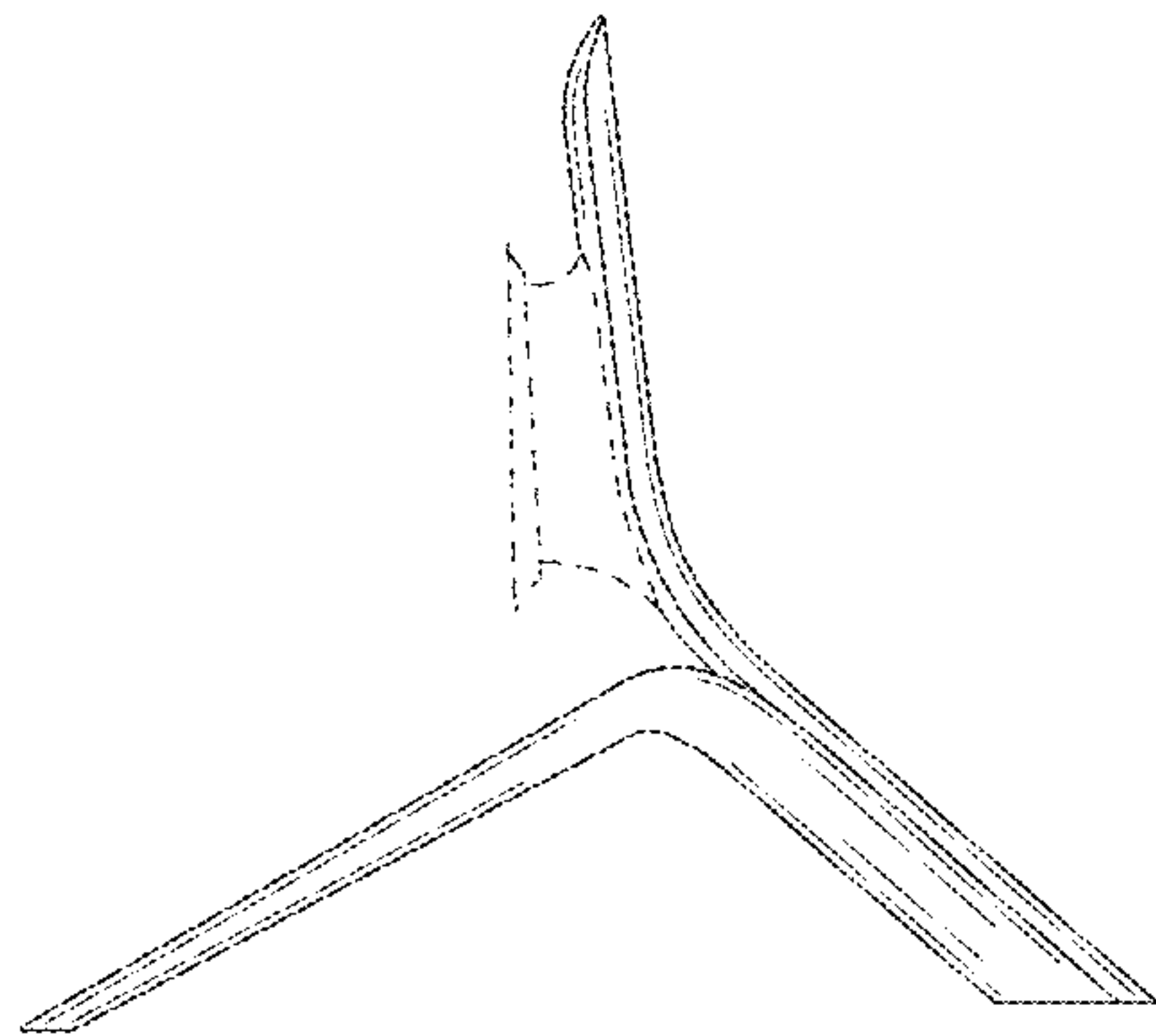

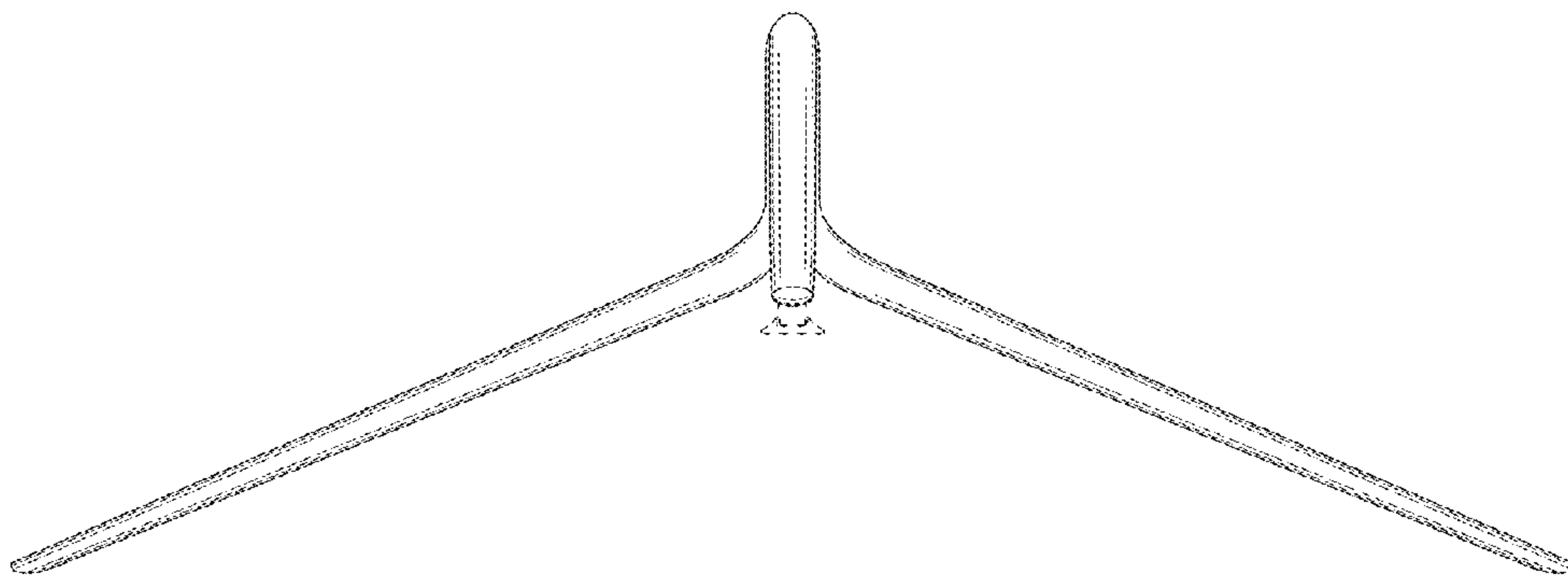

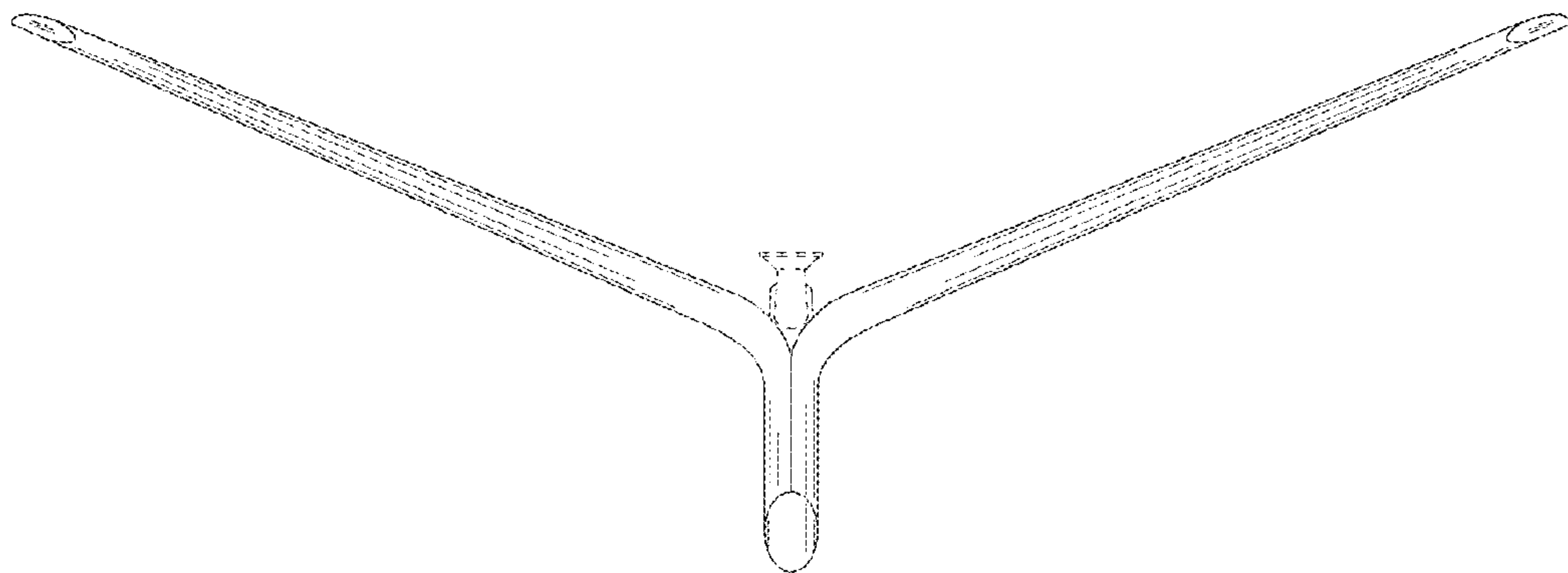

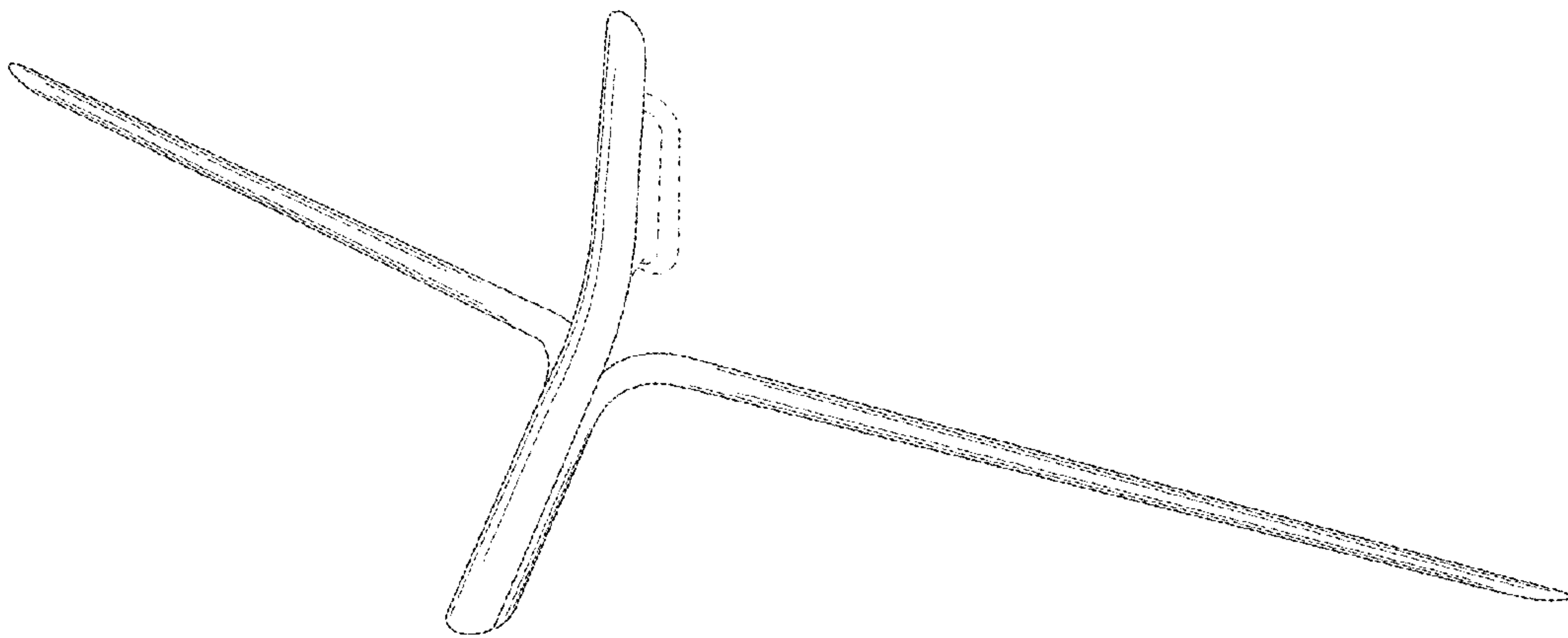
