(57) **CLAIM**

The ornamental design for a mobile phone hardshell case, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a mobile phone hardshell case showing the new design;
 FIG. 2 is front elevation of the case shown in FIG. 1;
 FIG. 3 is rear view of the case in relation to FIG. 2;
 FIG. 4 is a left side view of the case in relation to FIG. 2;
 FIG. 5 is a right side view of the case in relation to FIG. 2;
 FIG. 6 is a top view of the case in relation to FIG. 2;
 FIG. 7 is a bottom view of the case in relation to FIG. 2;
 FIG. 8 is a front perspective view of the case in an open position;

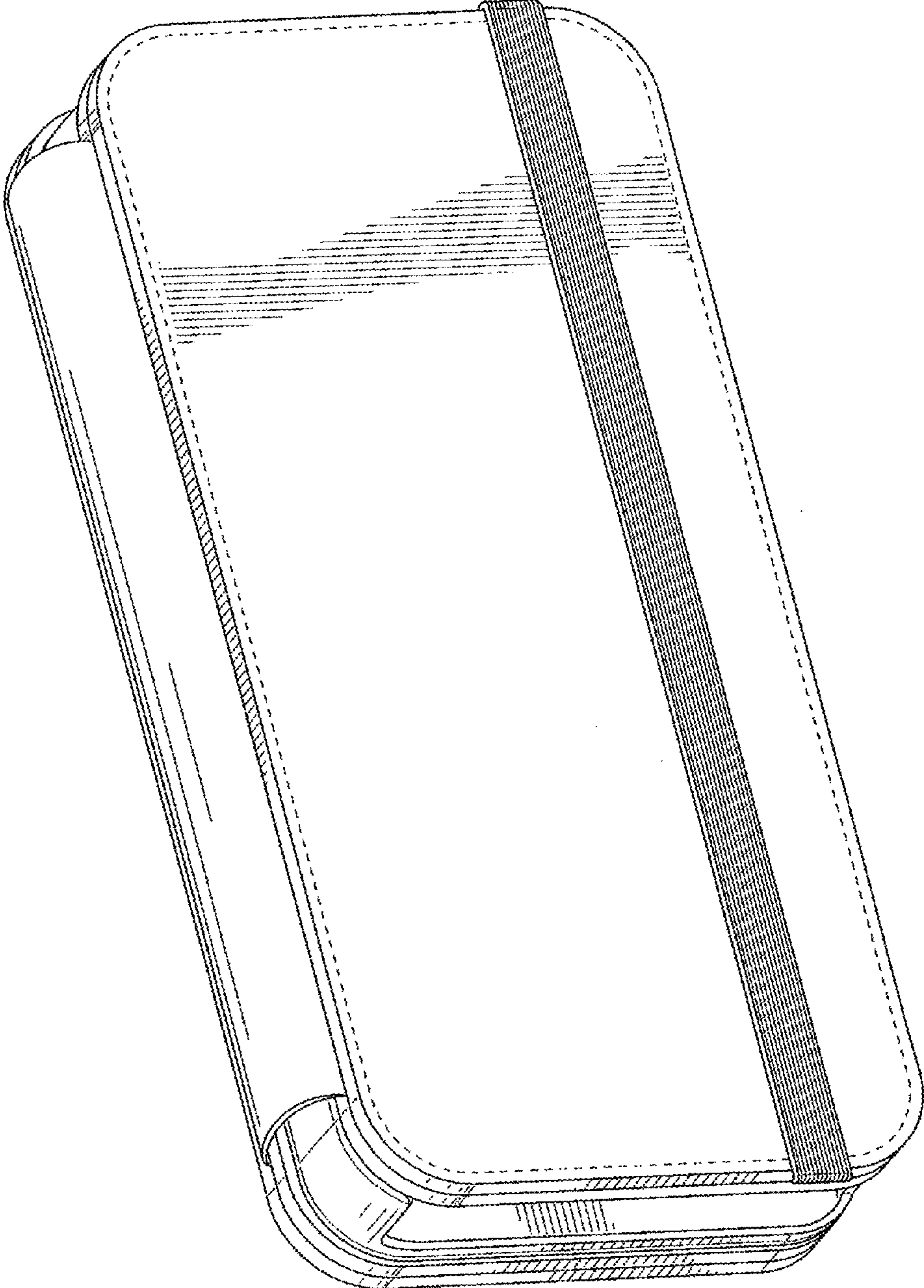

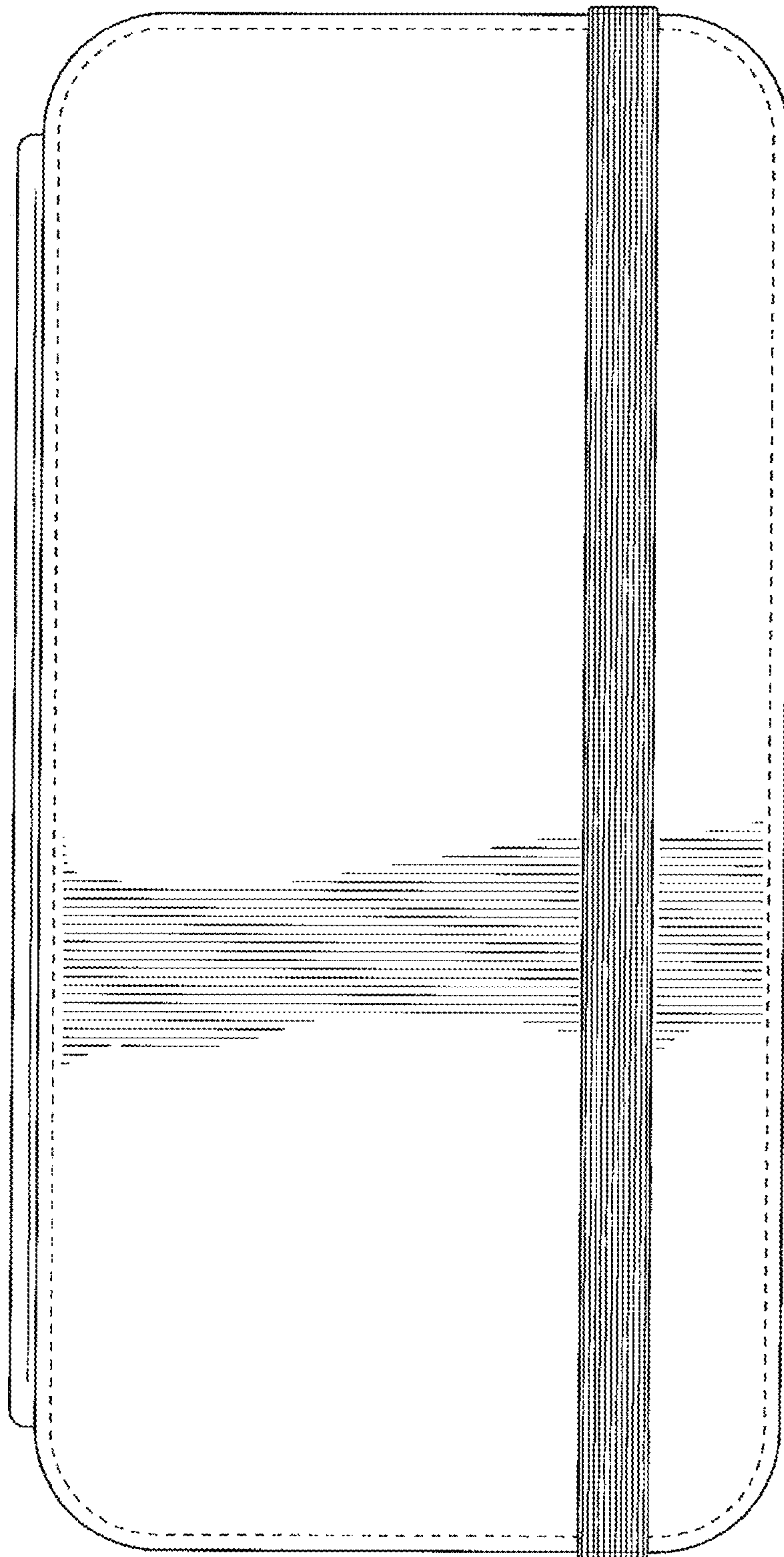

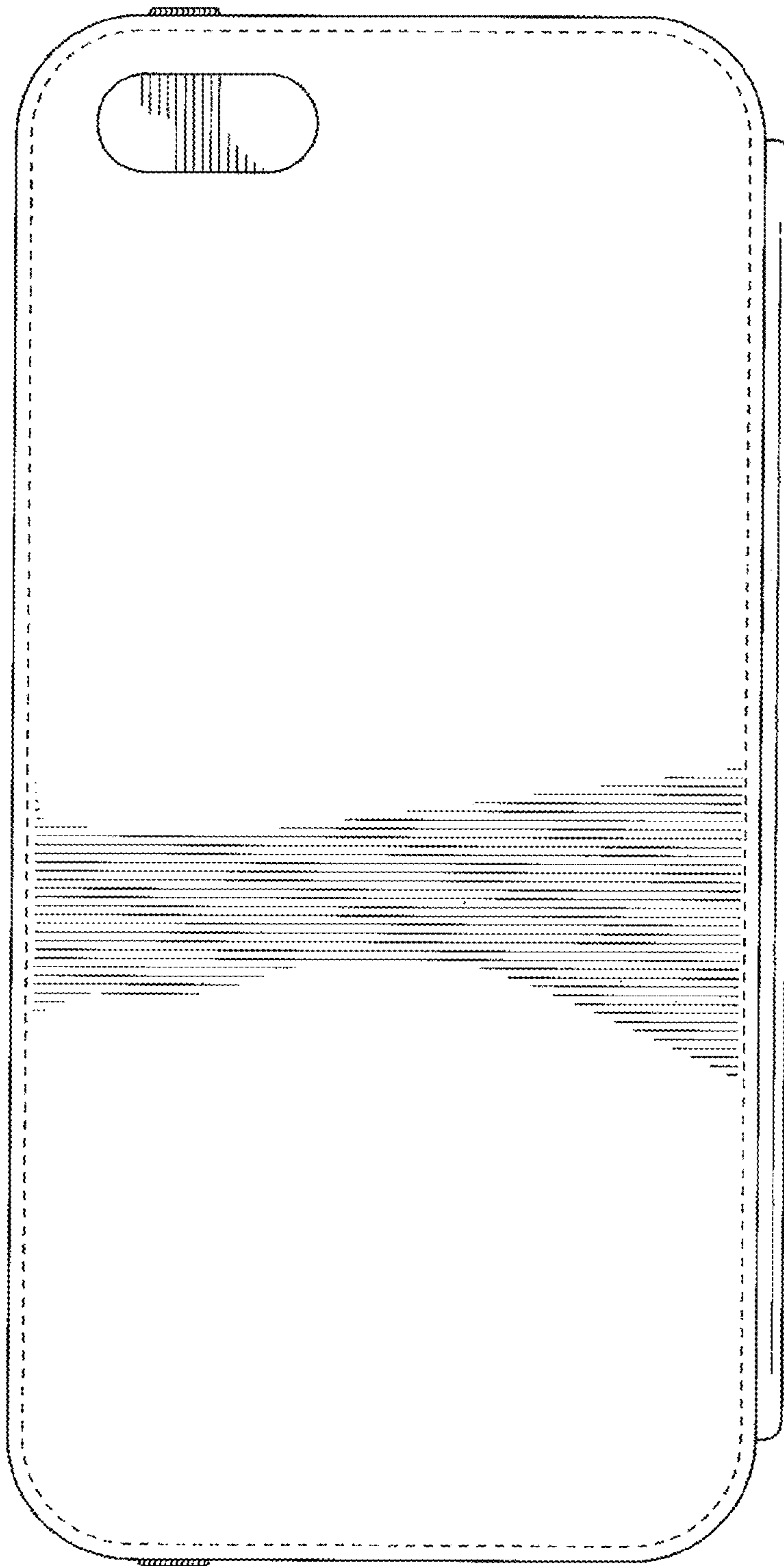

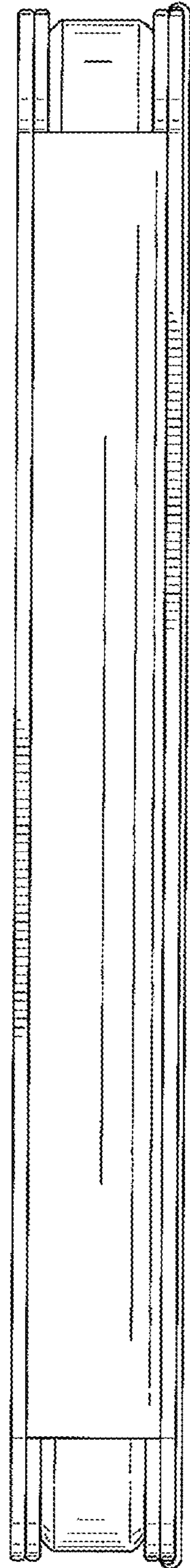

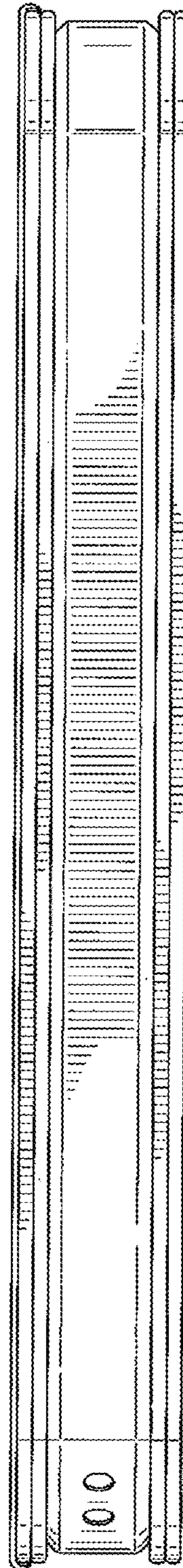

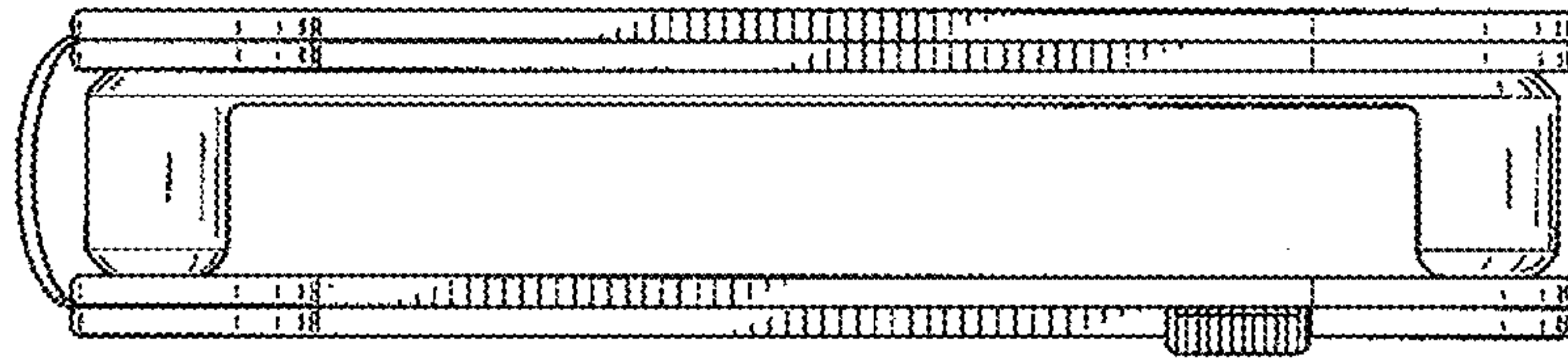

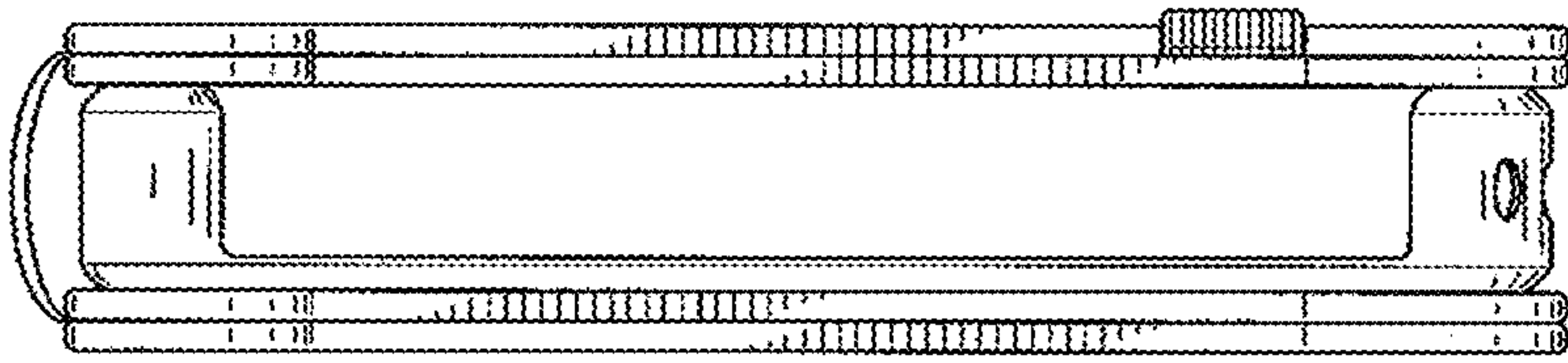

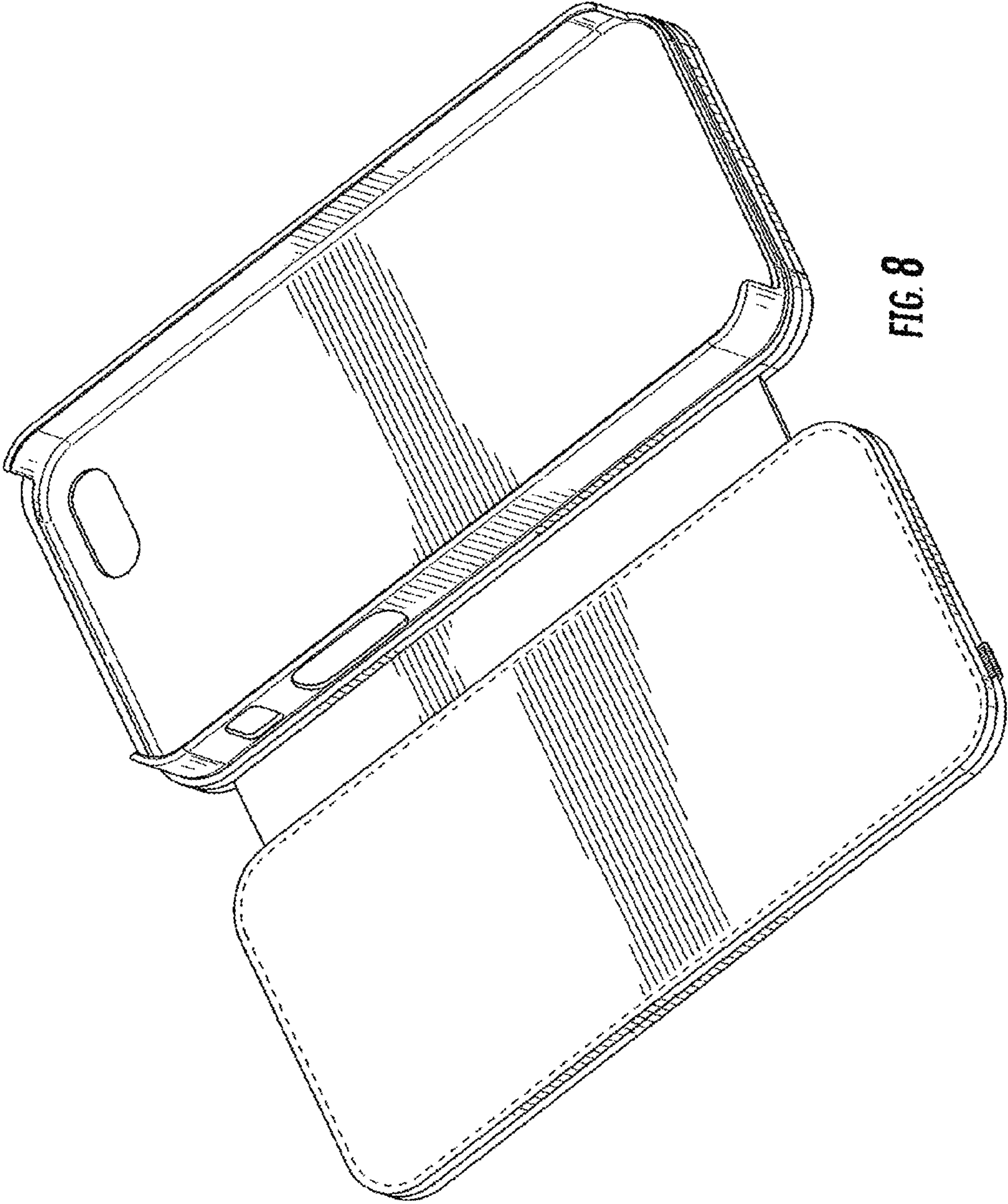

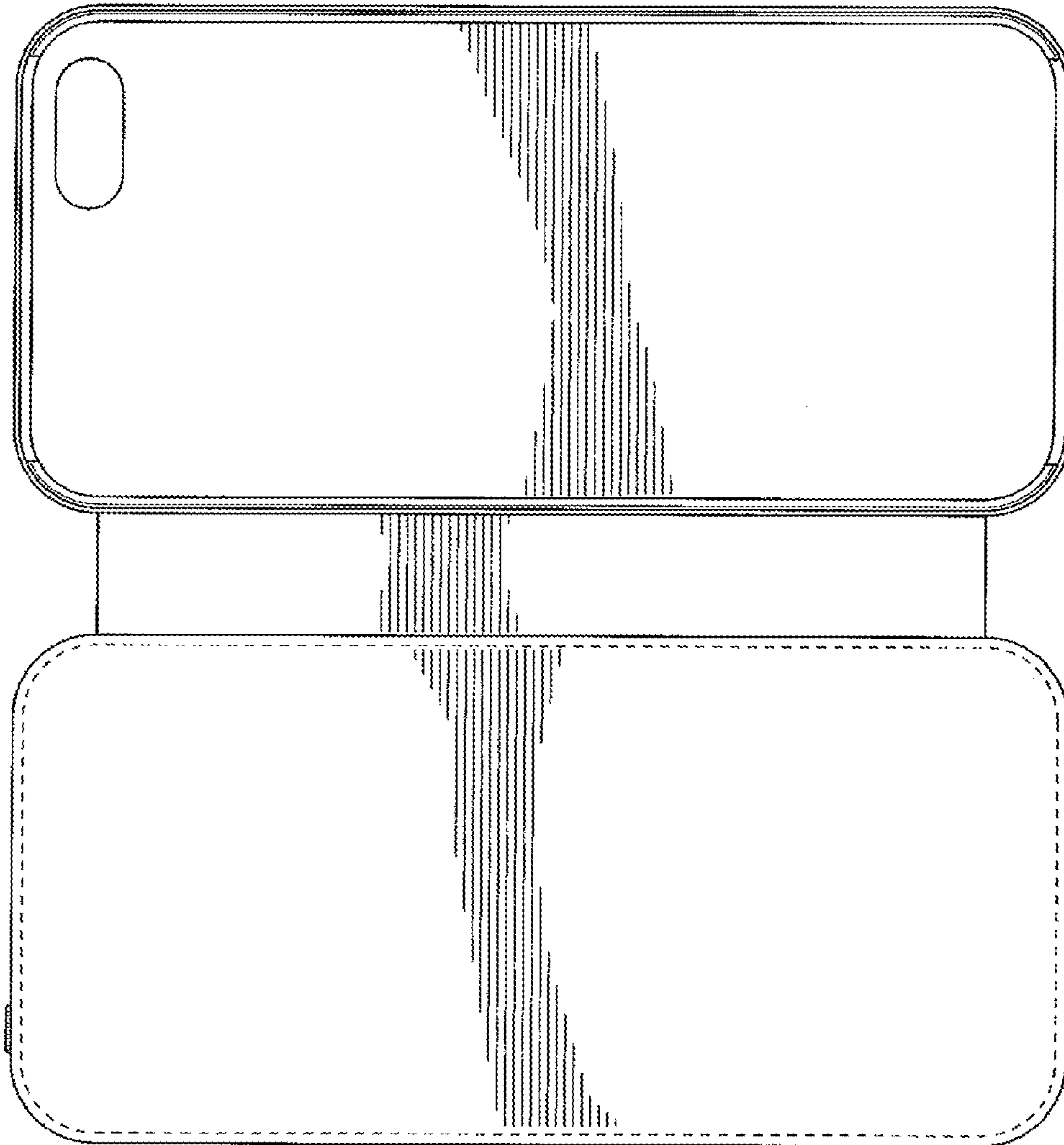

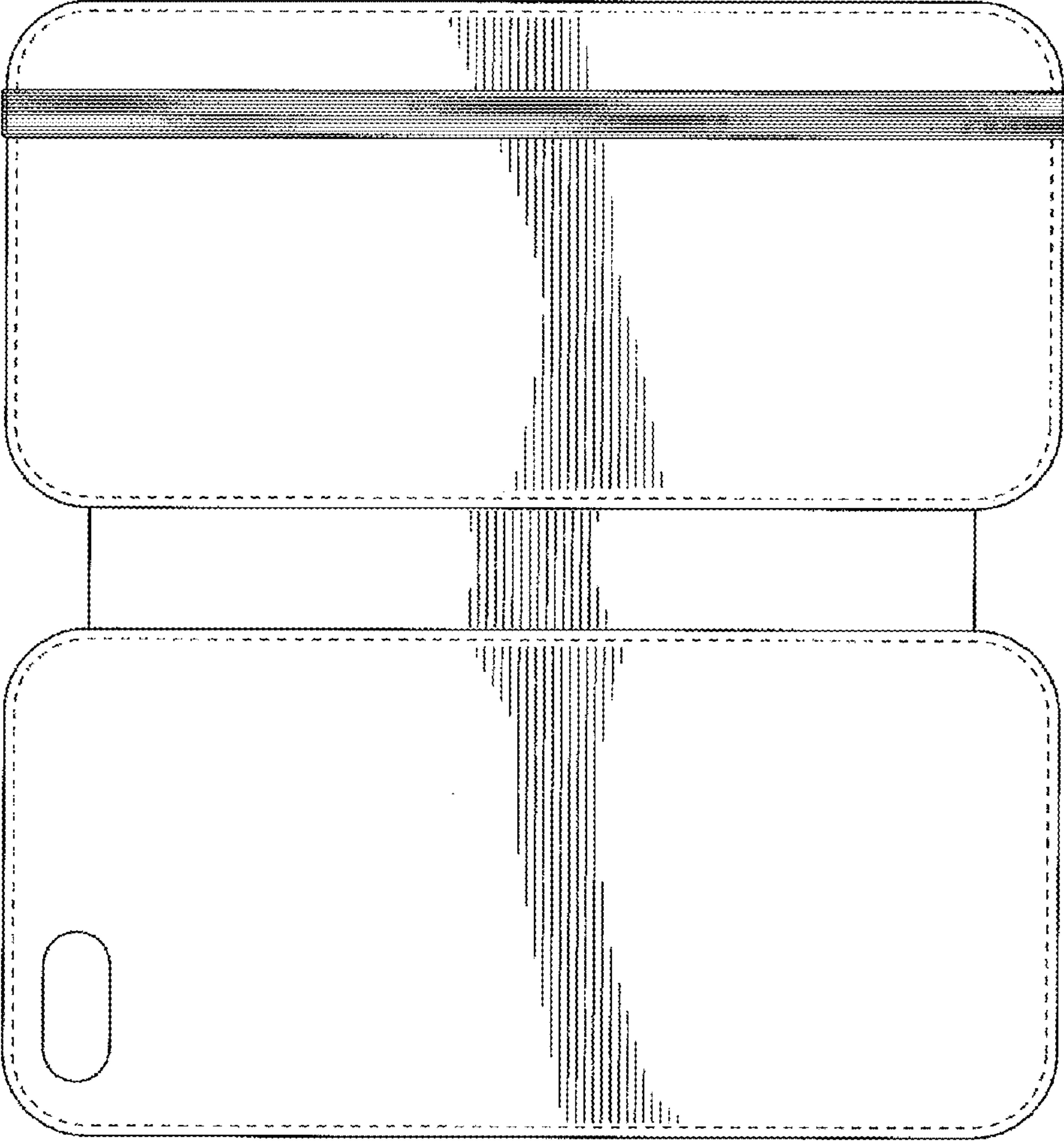

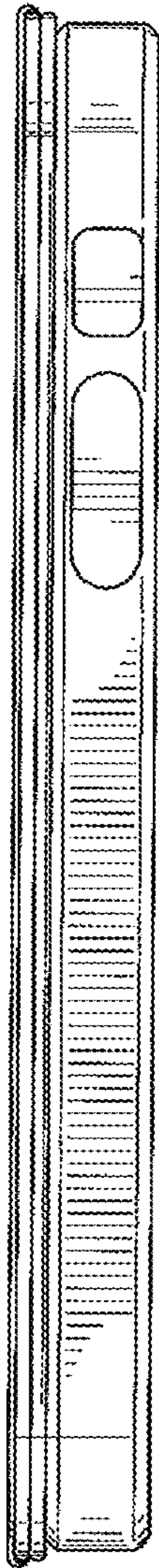

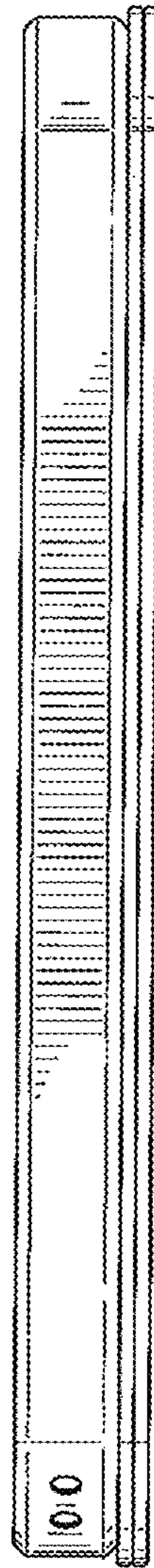

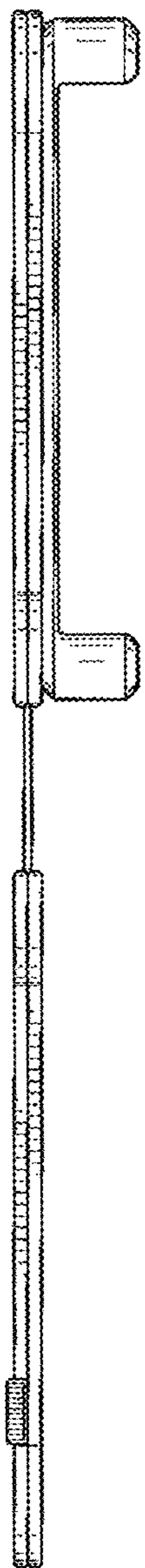

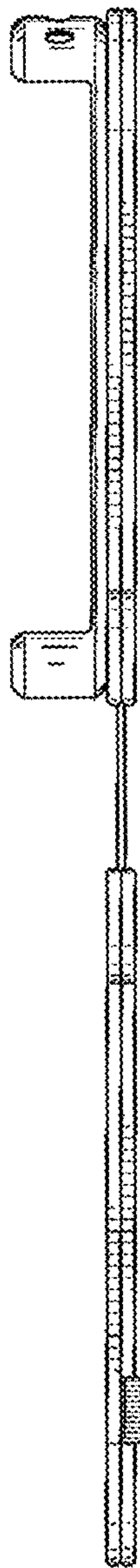
