(57) **CLAIM**

We claim the ornamental design for a refrigerator, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a refrigerator showing my new design with its double door closed;

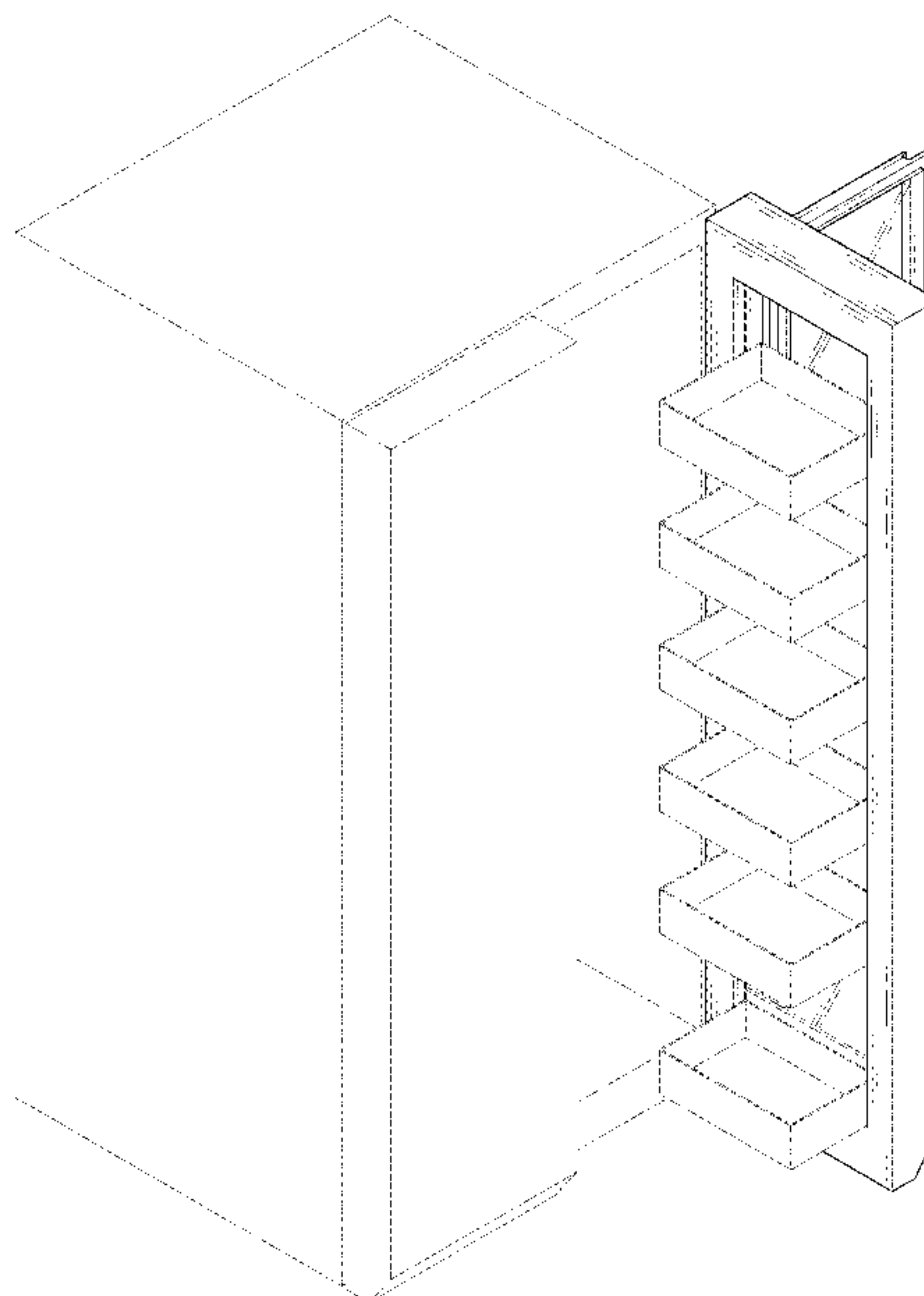
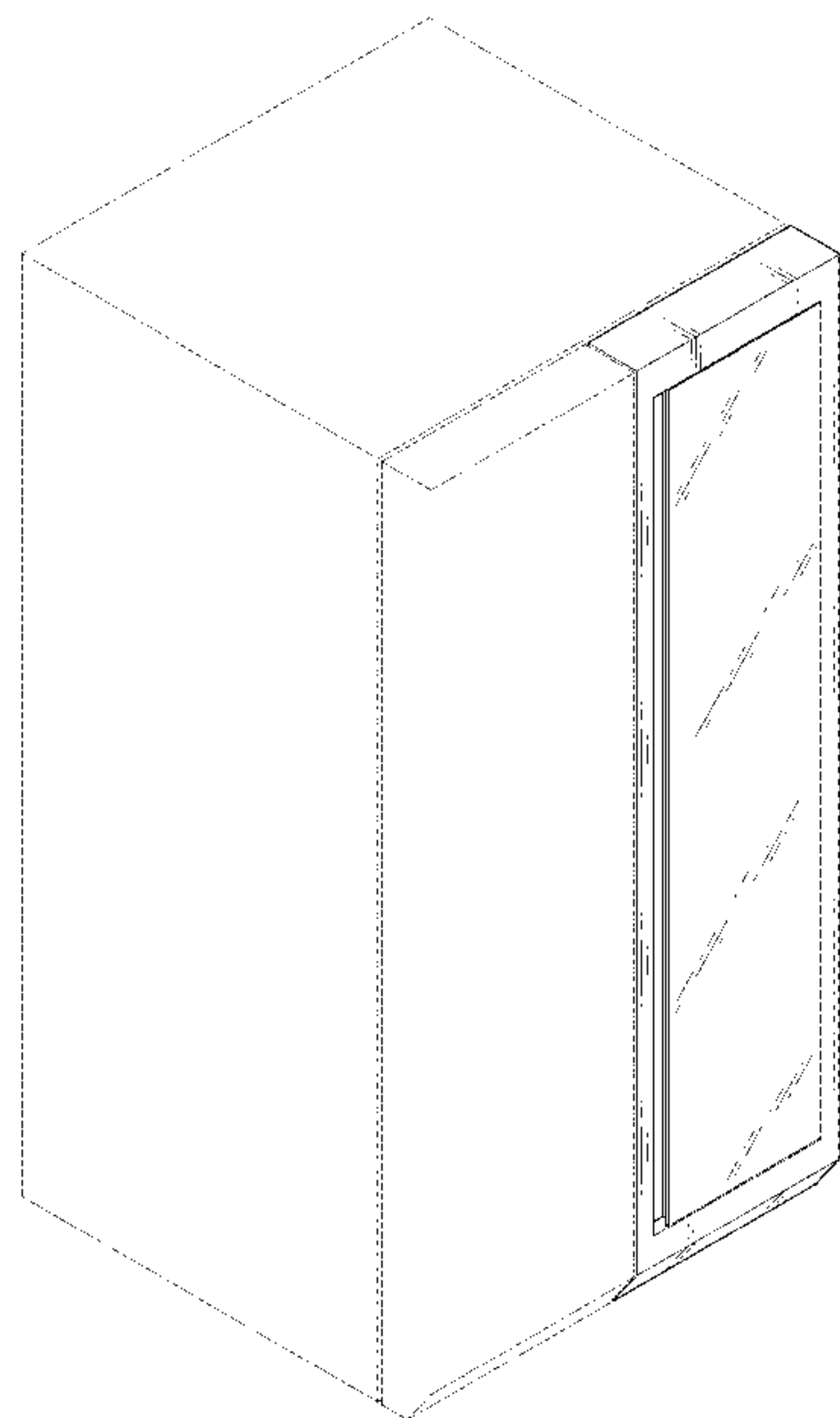

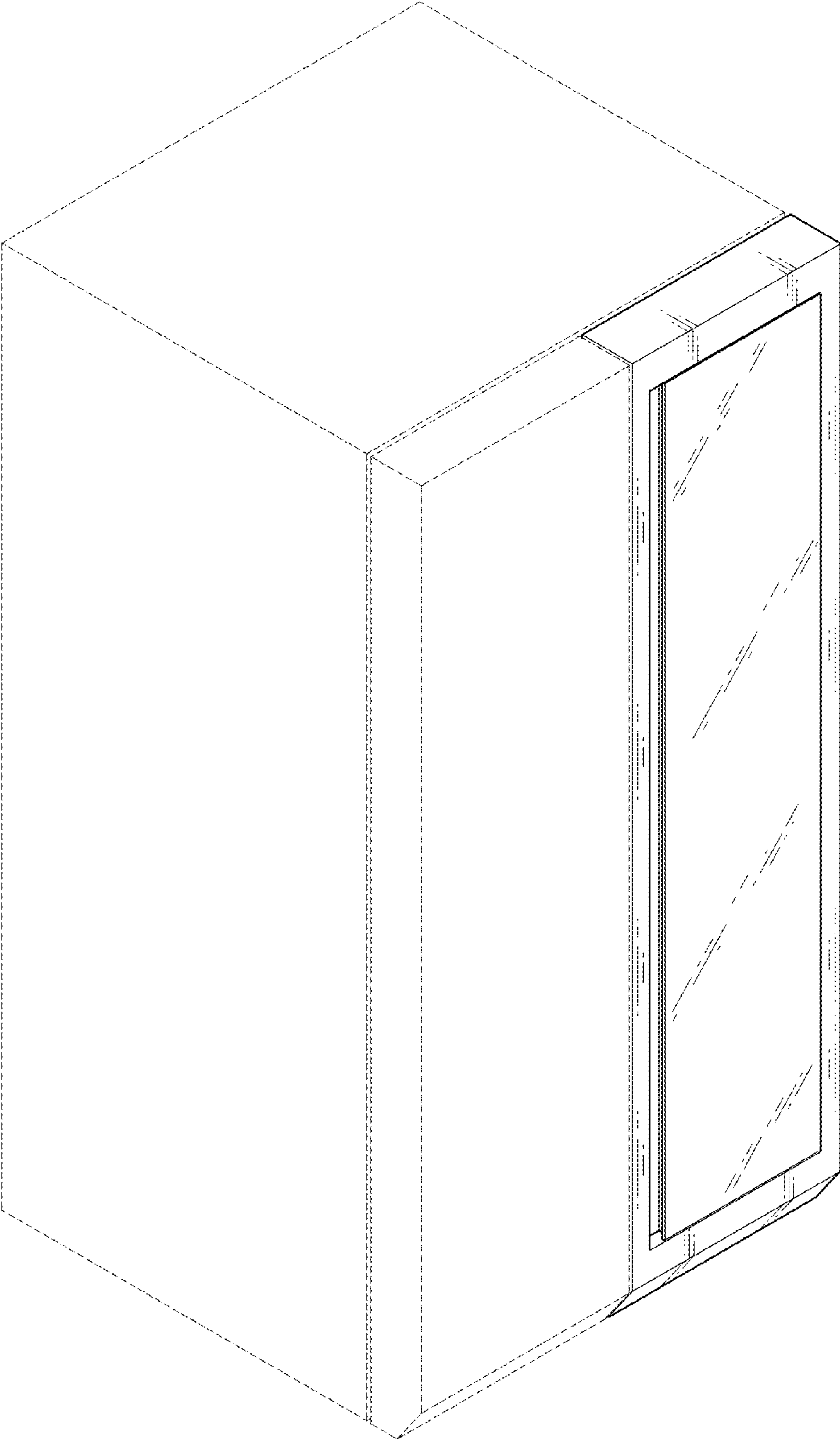

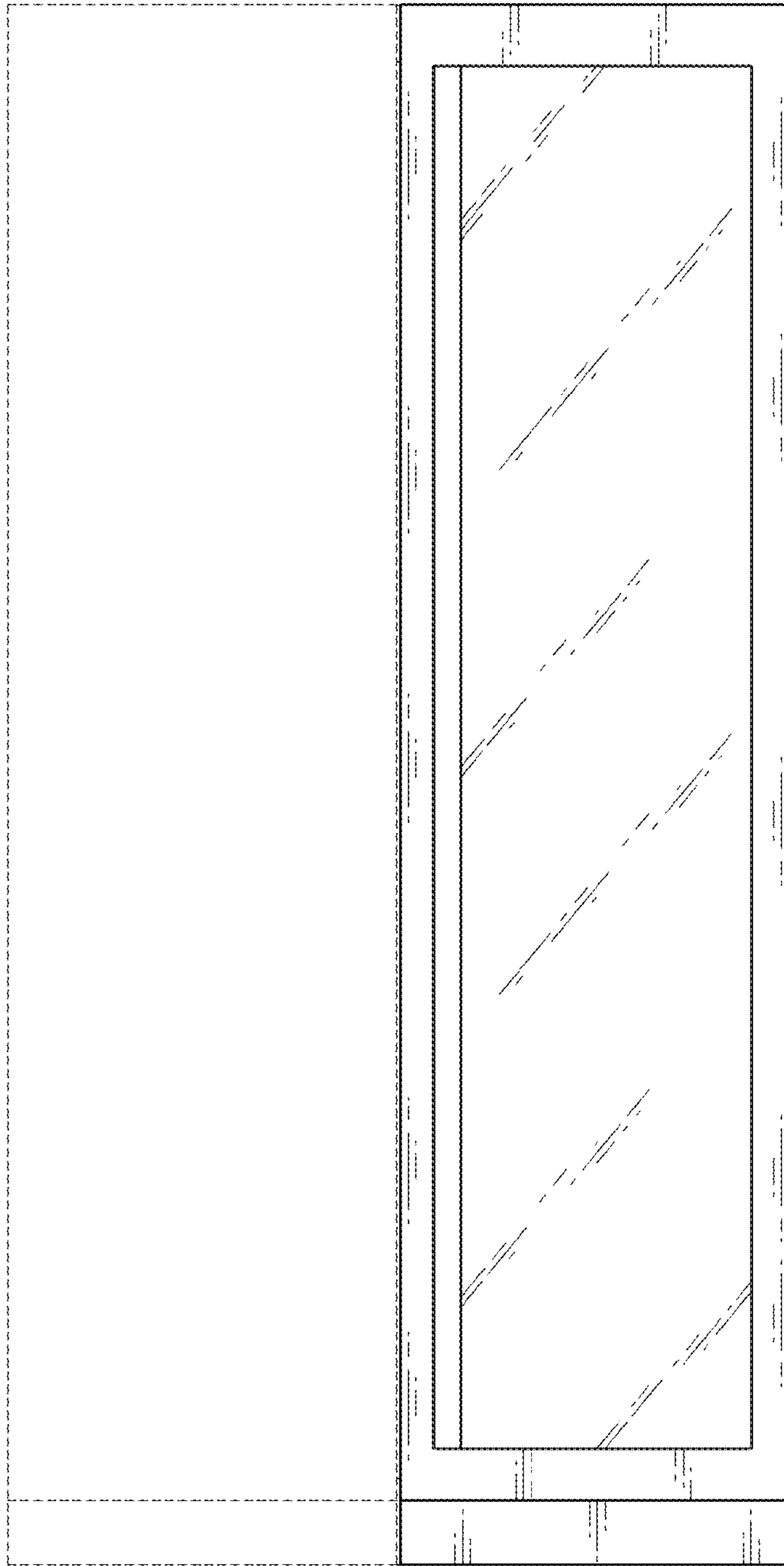

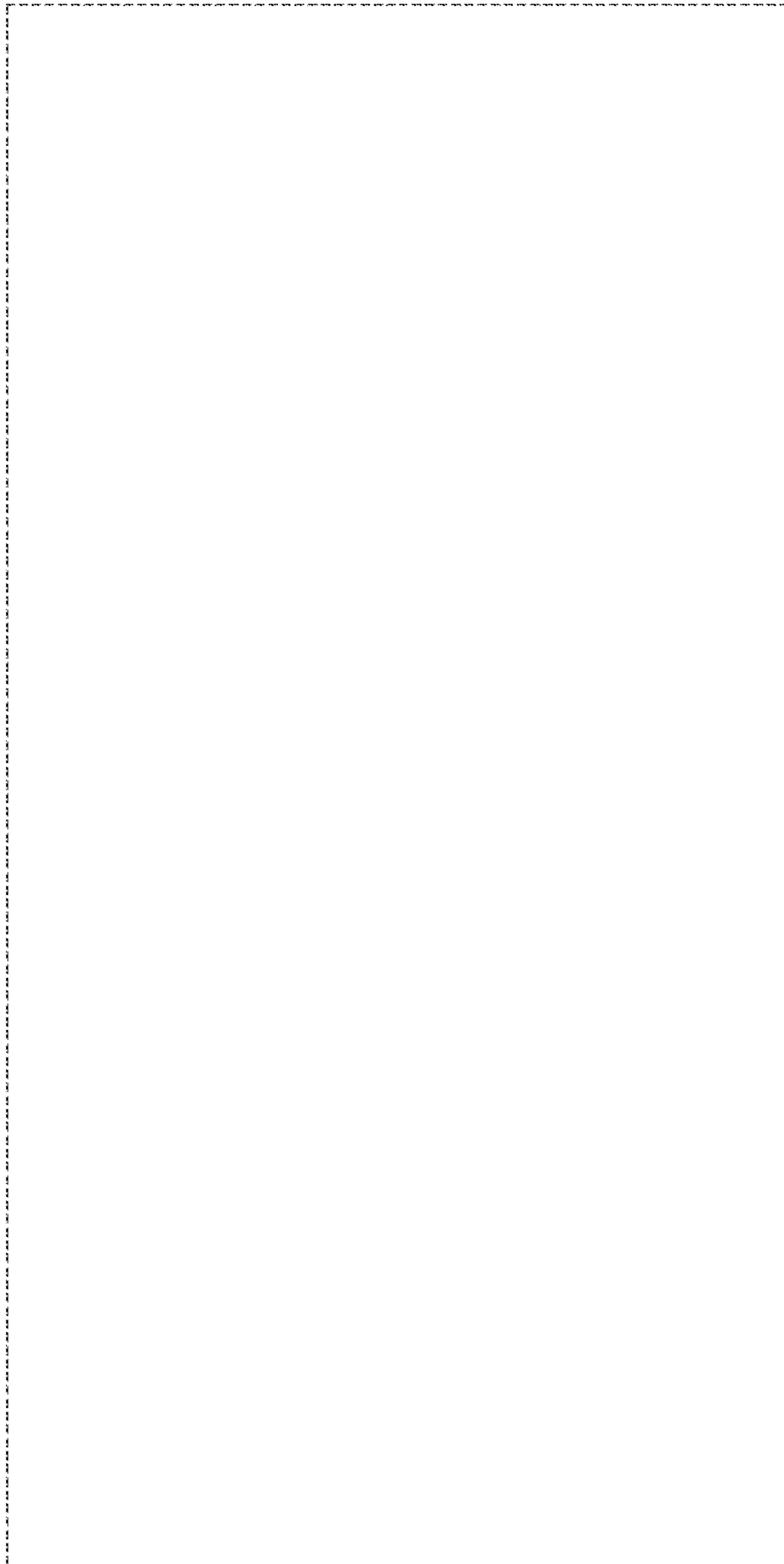

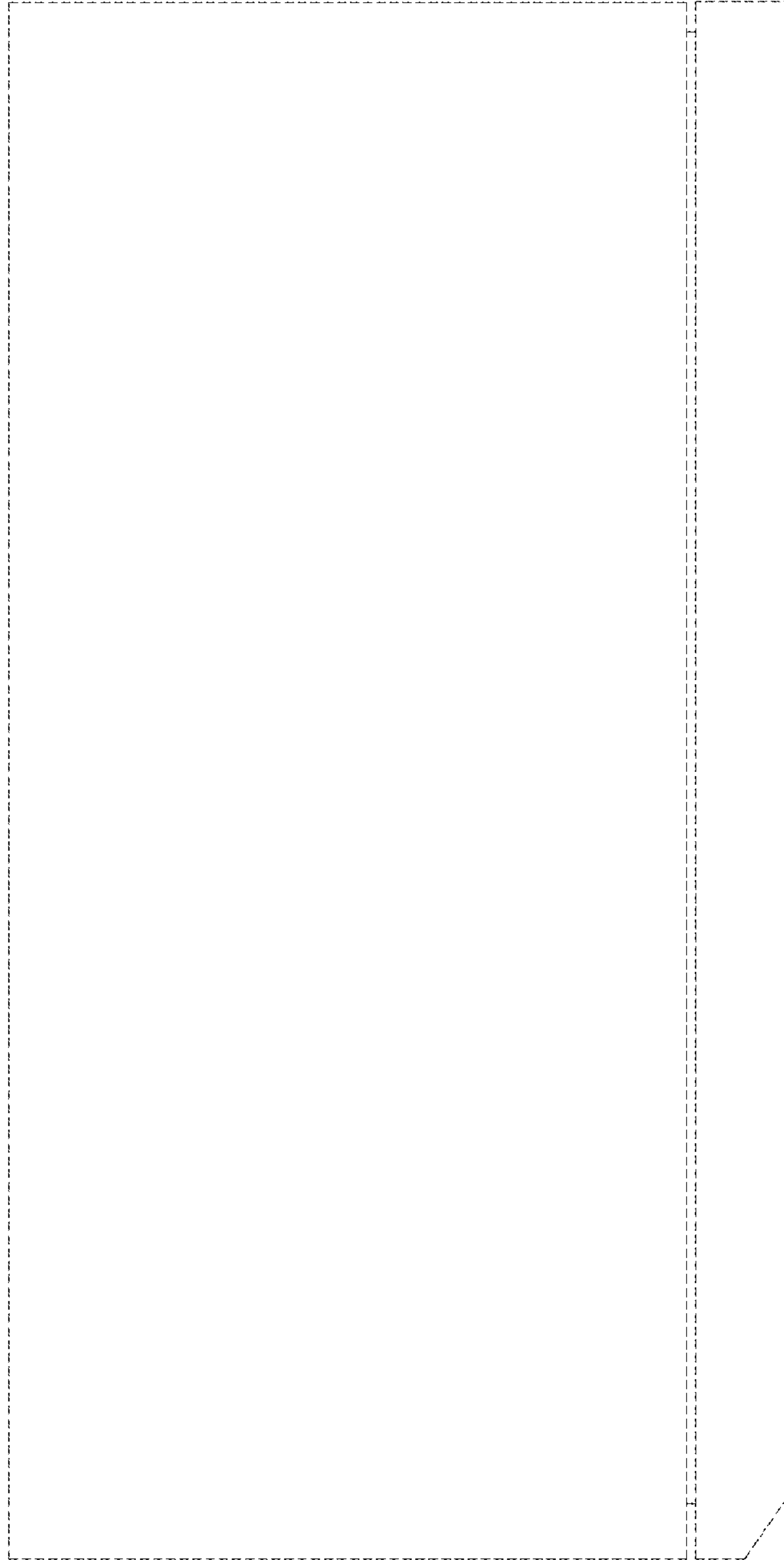

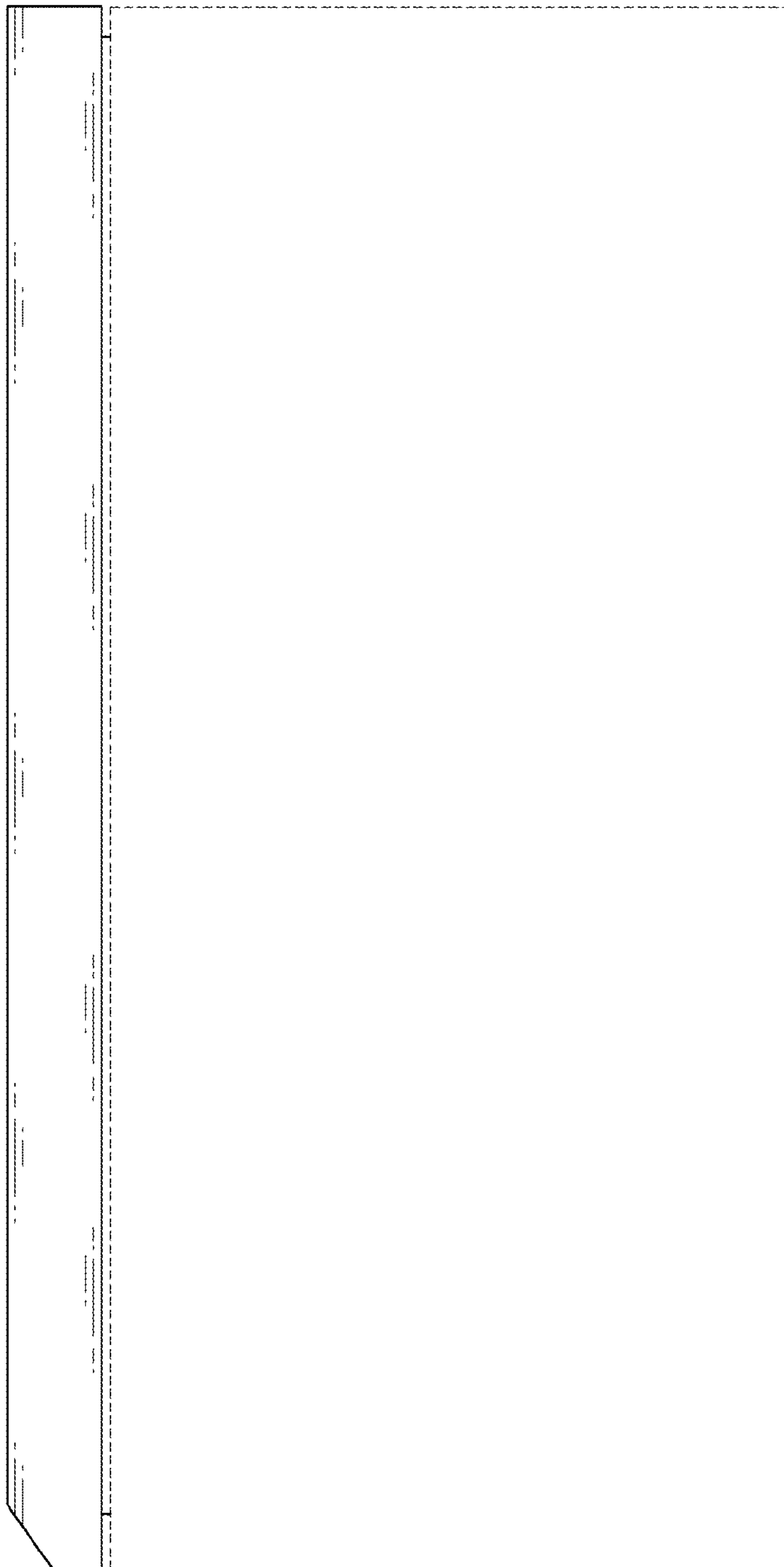

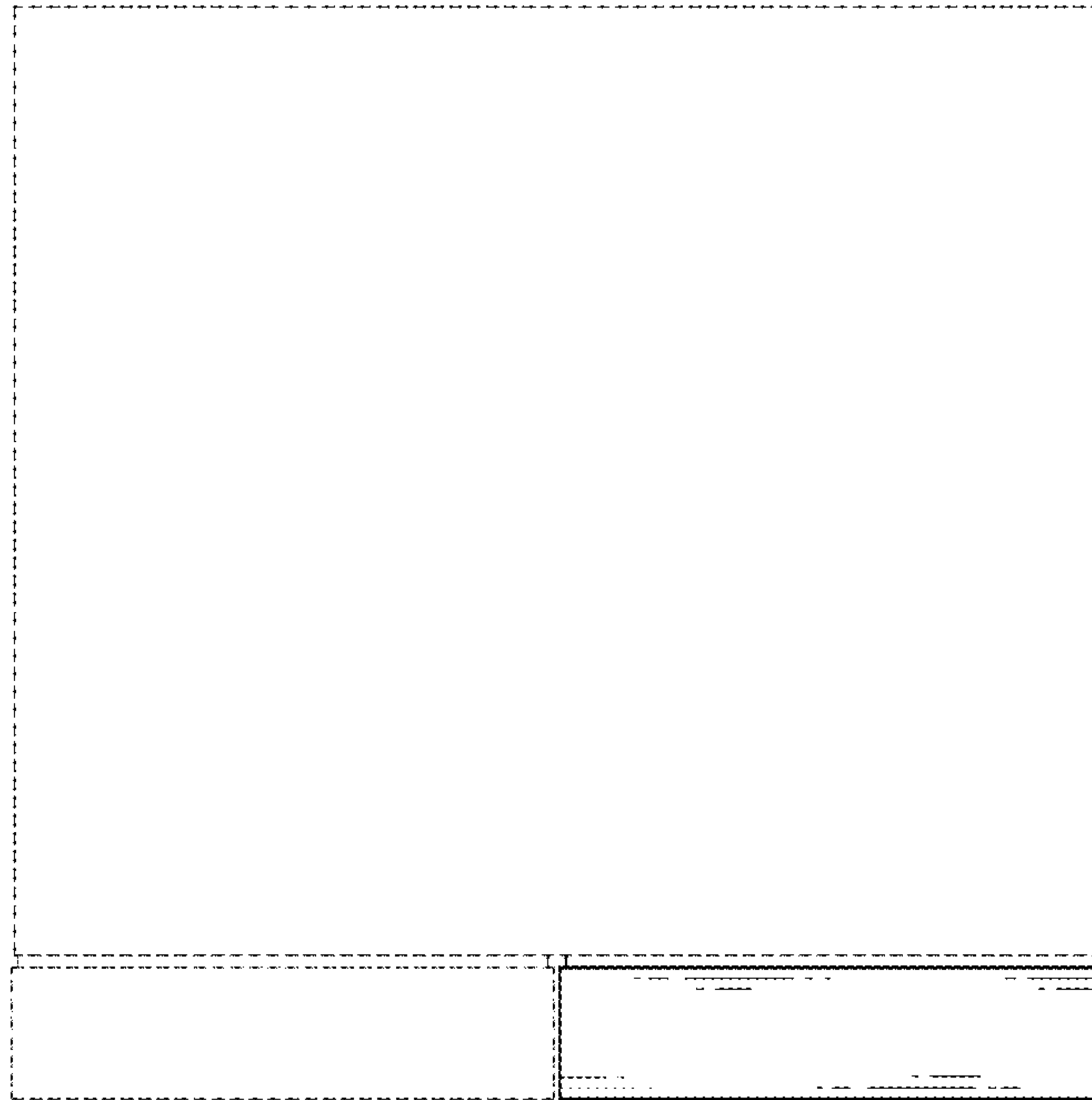

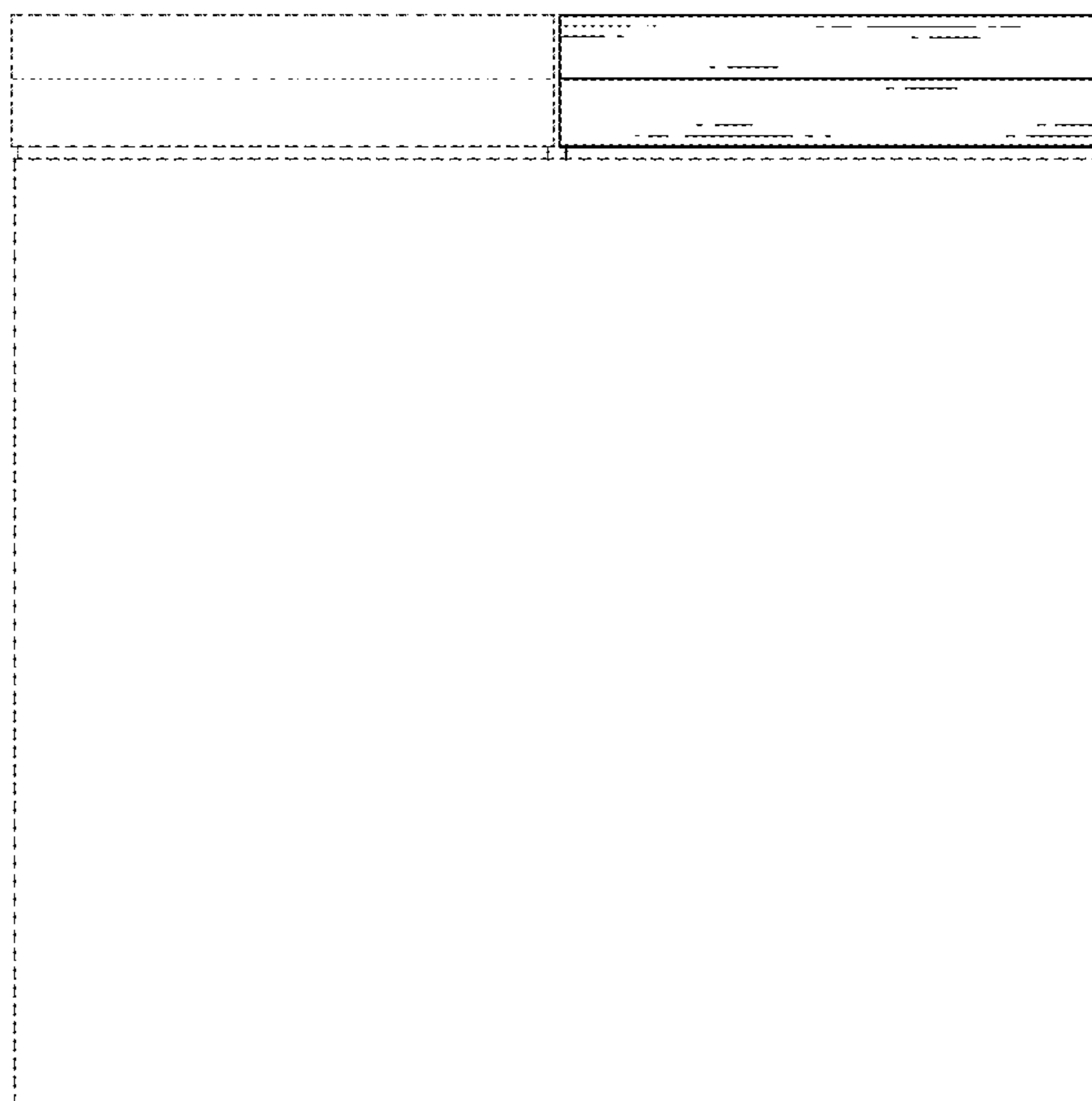

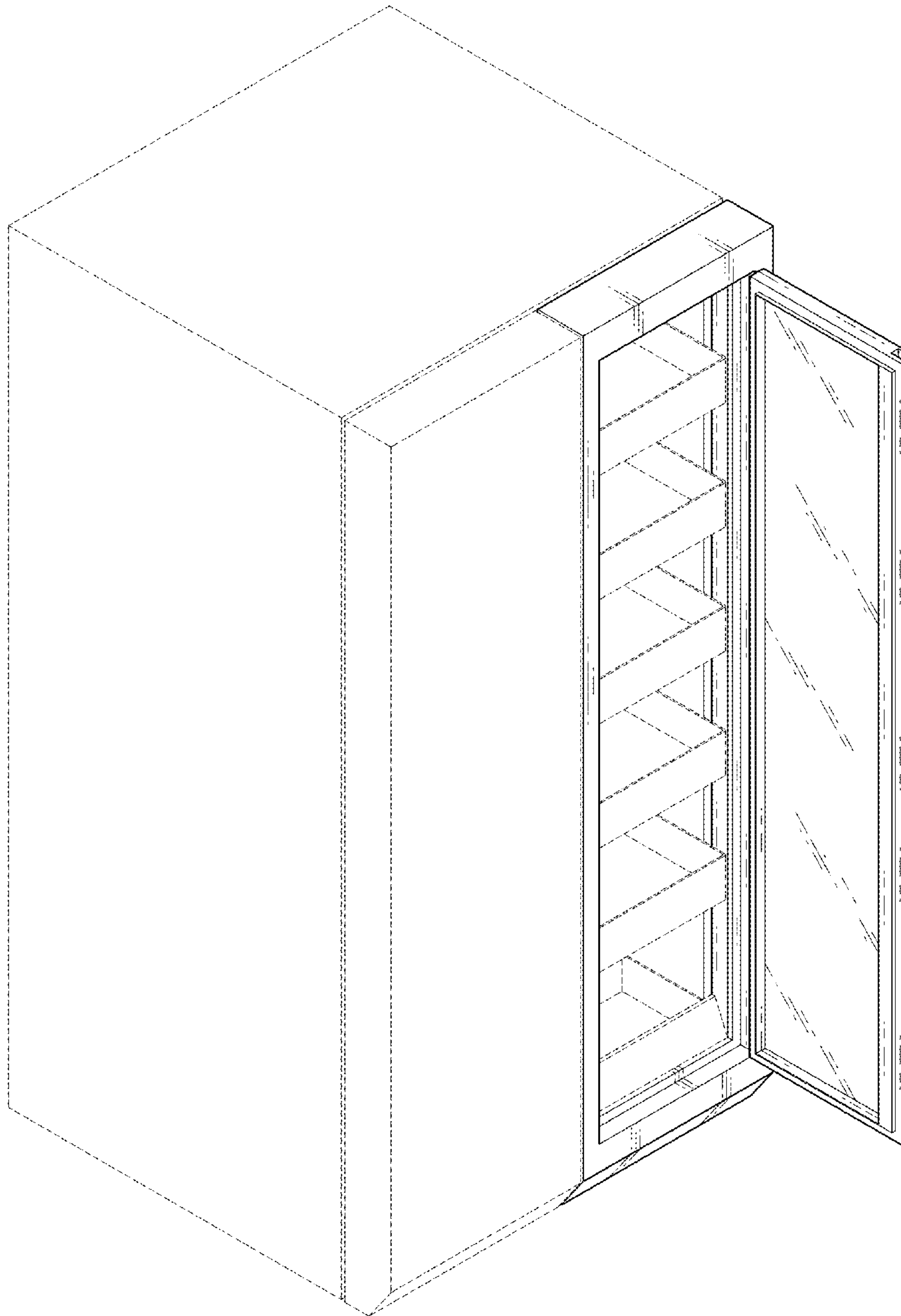

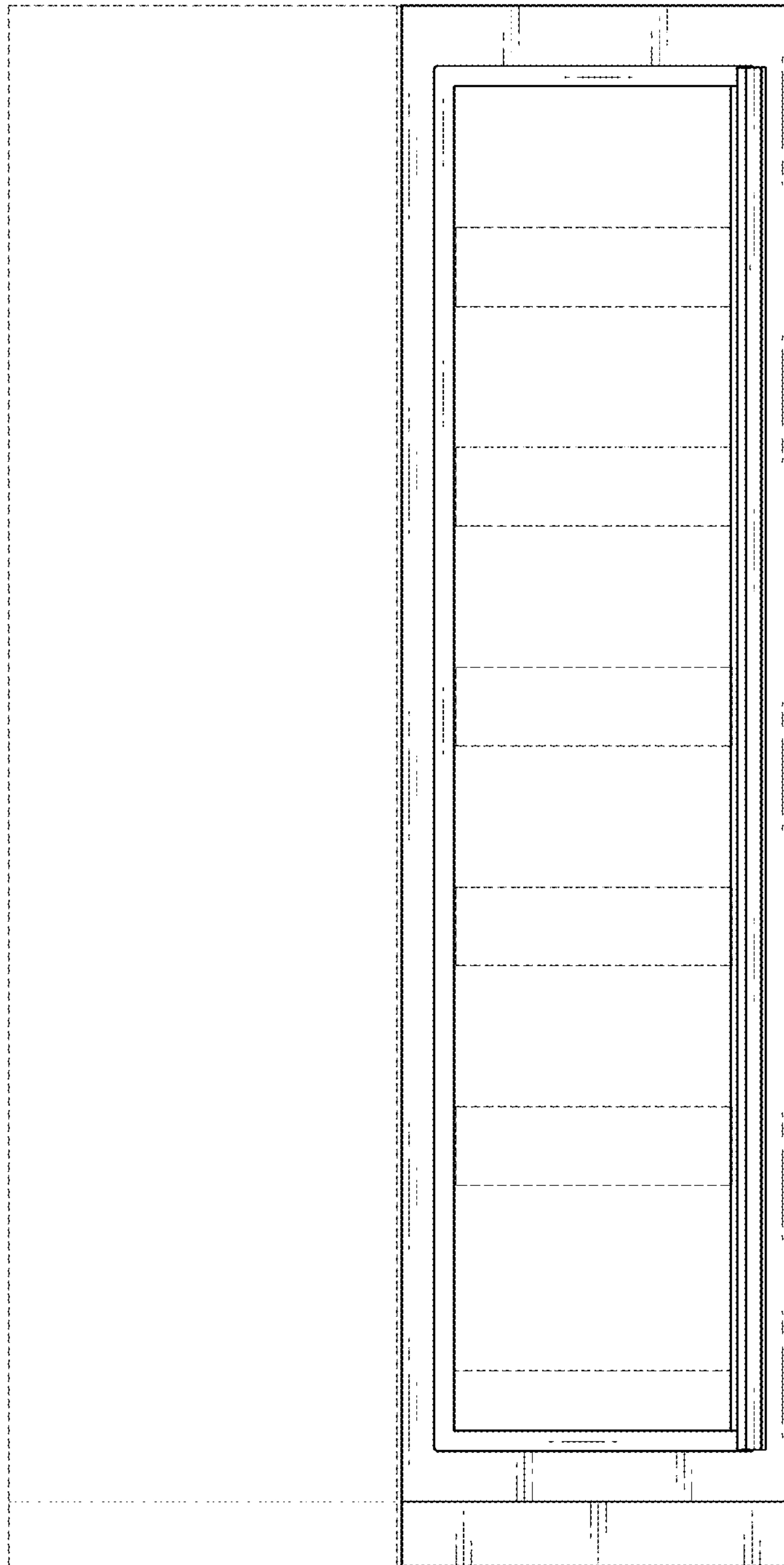

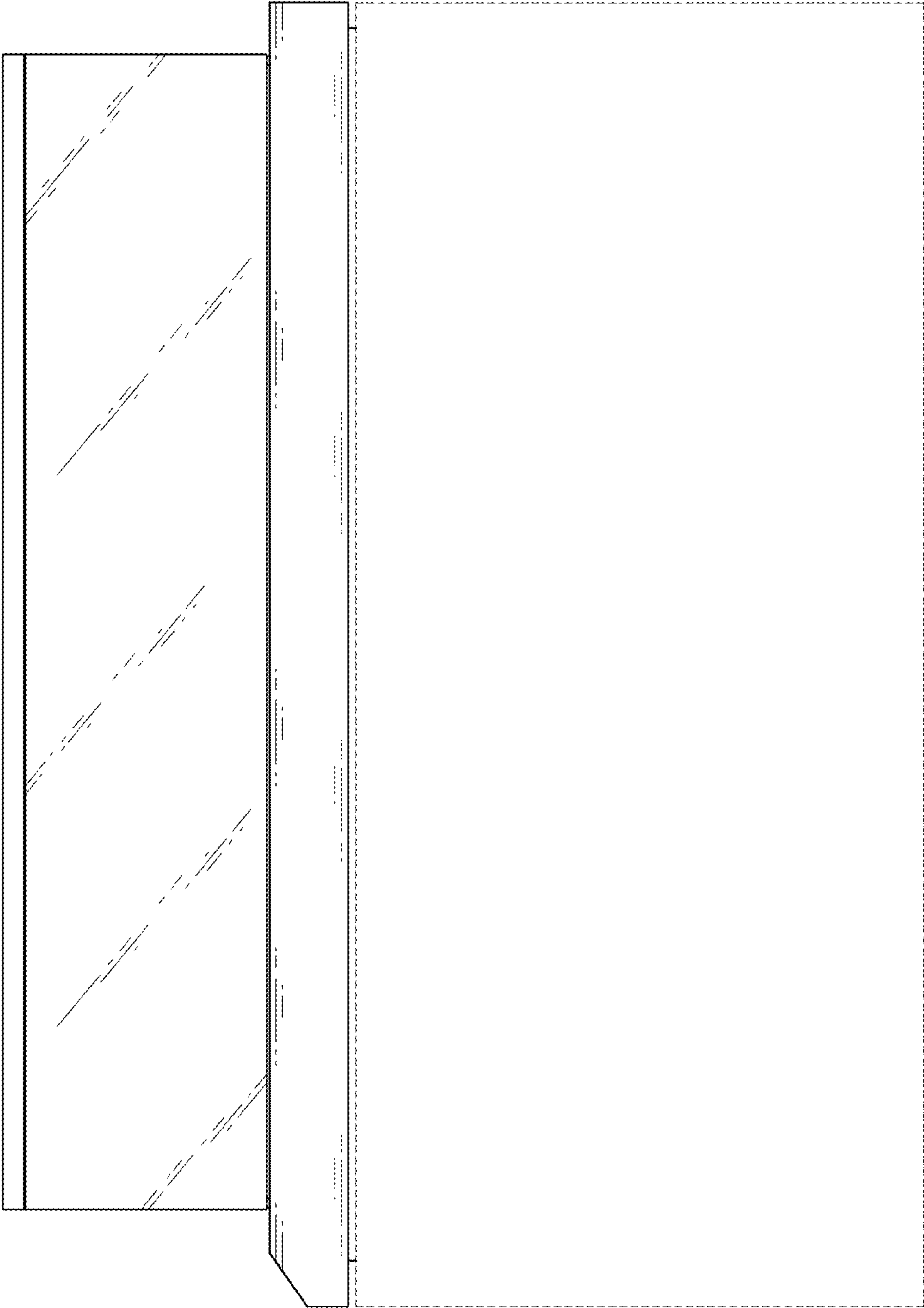

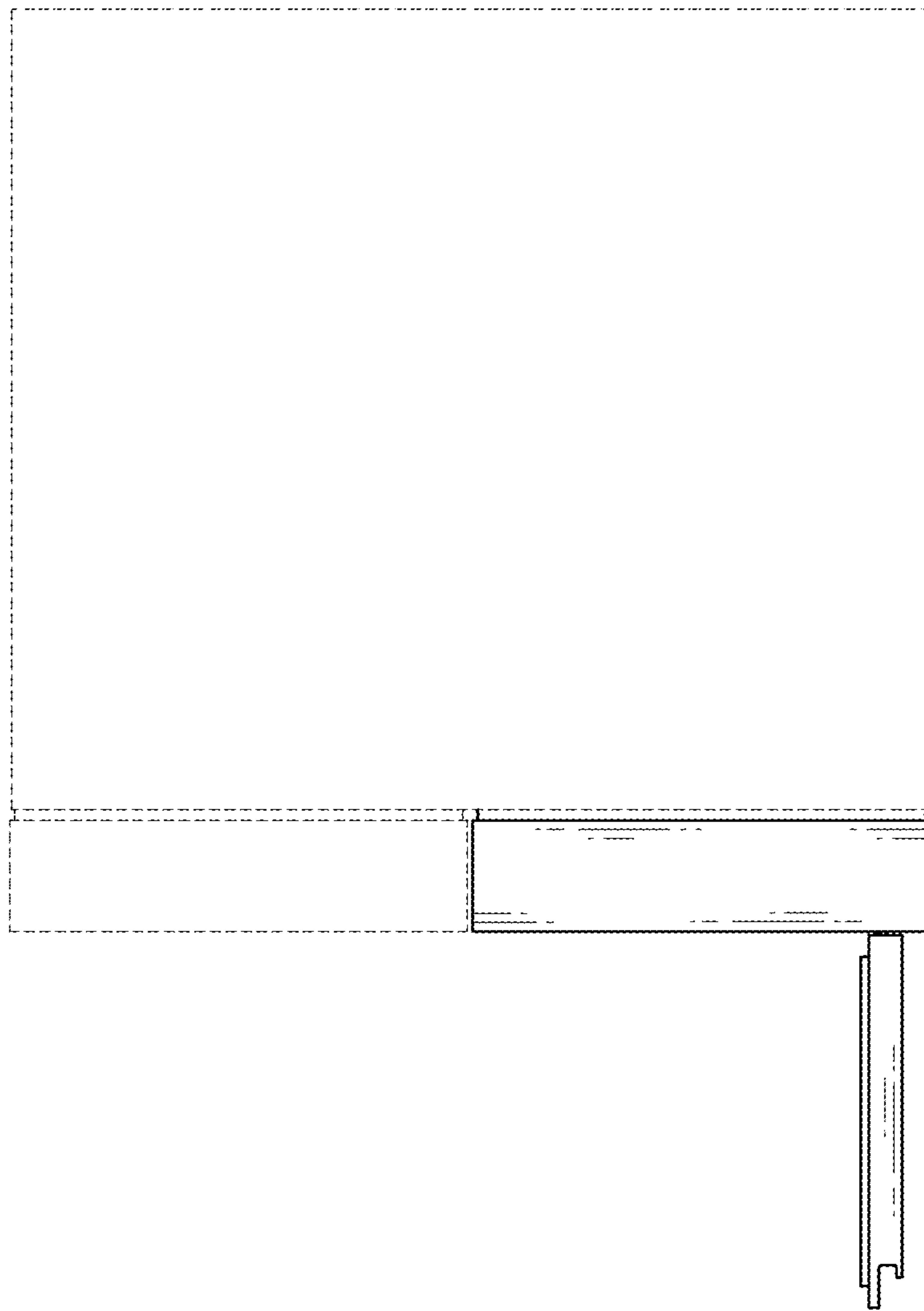

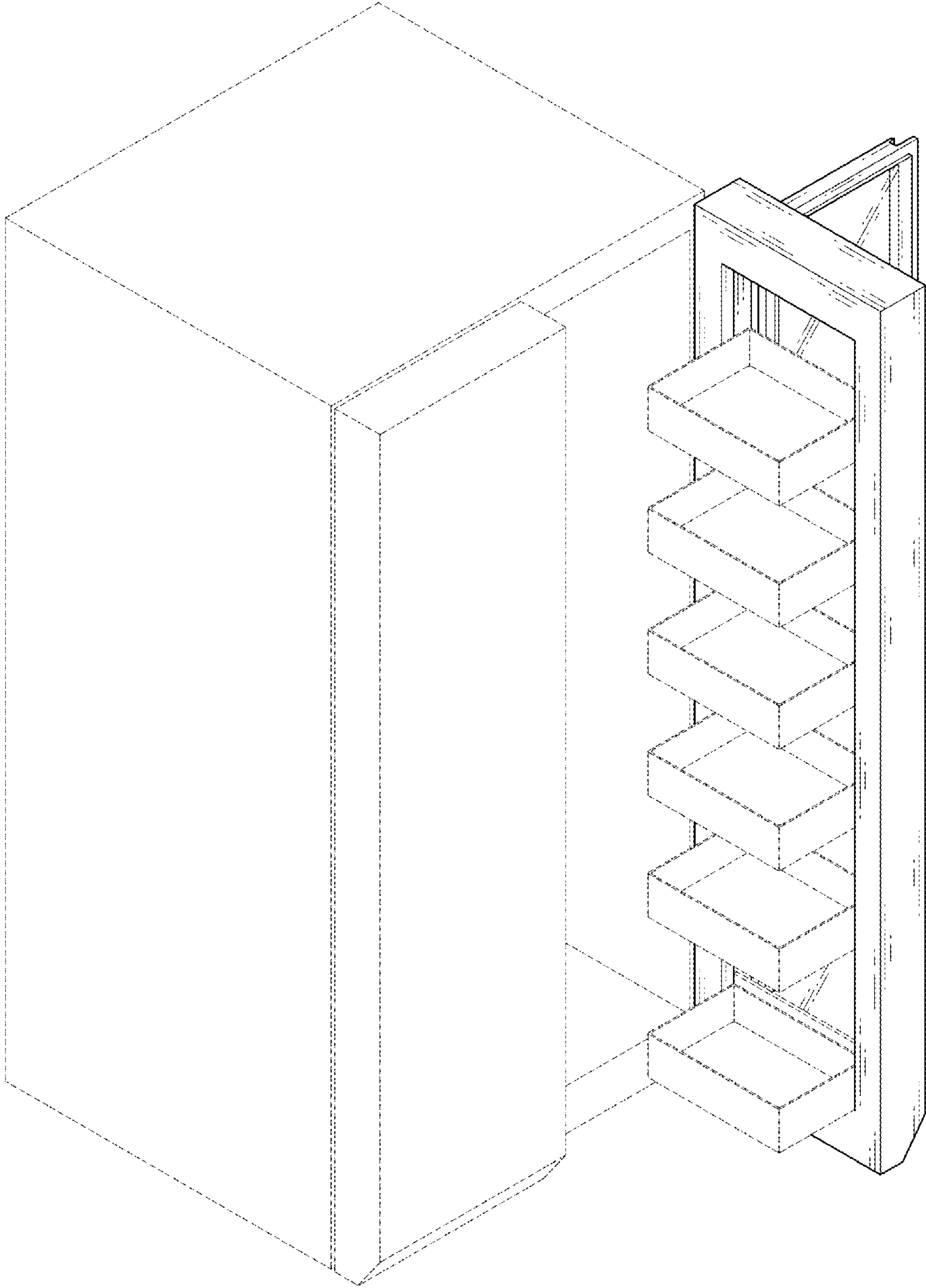

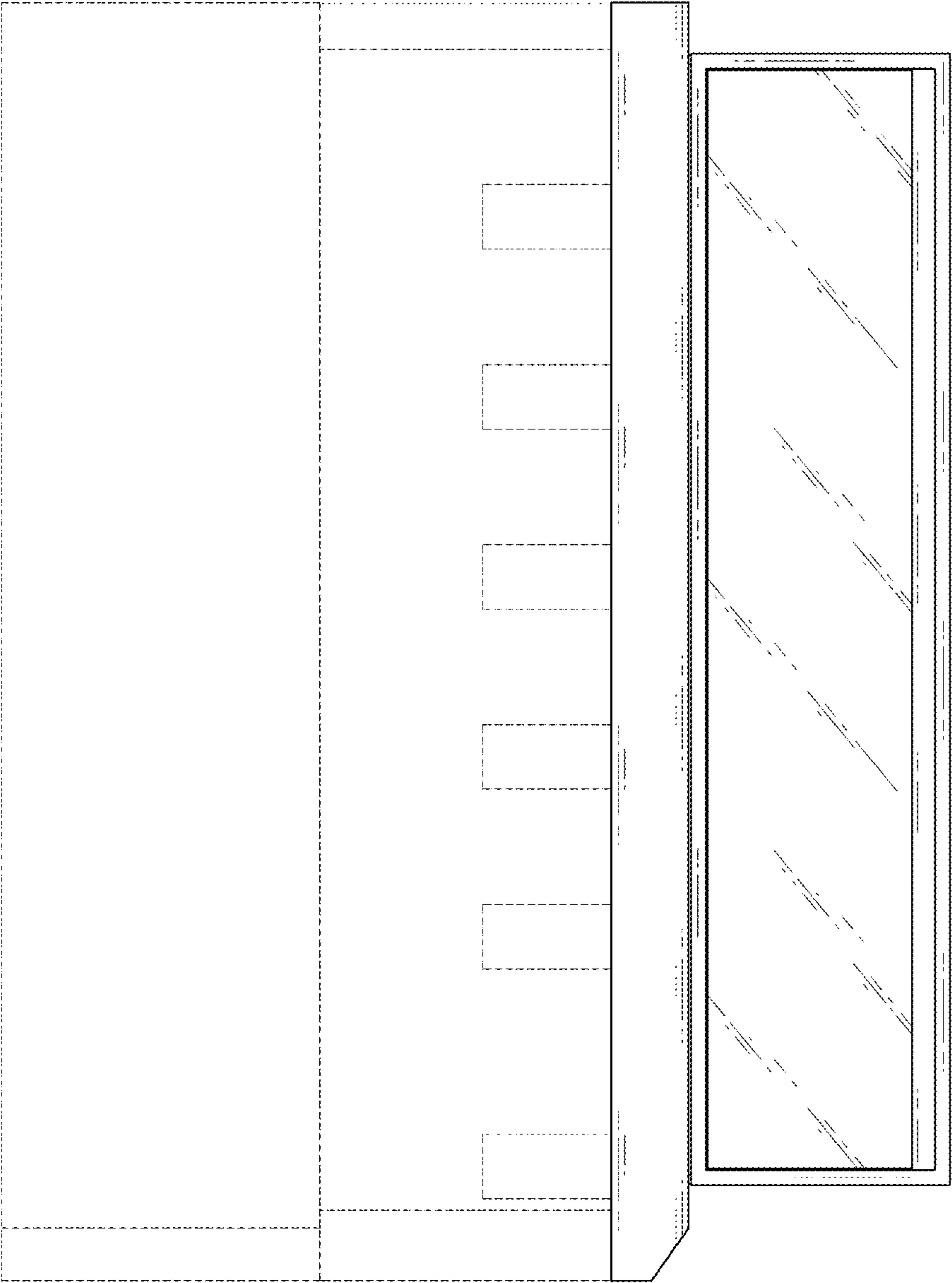

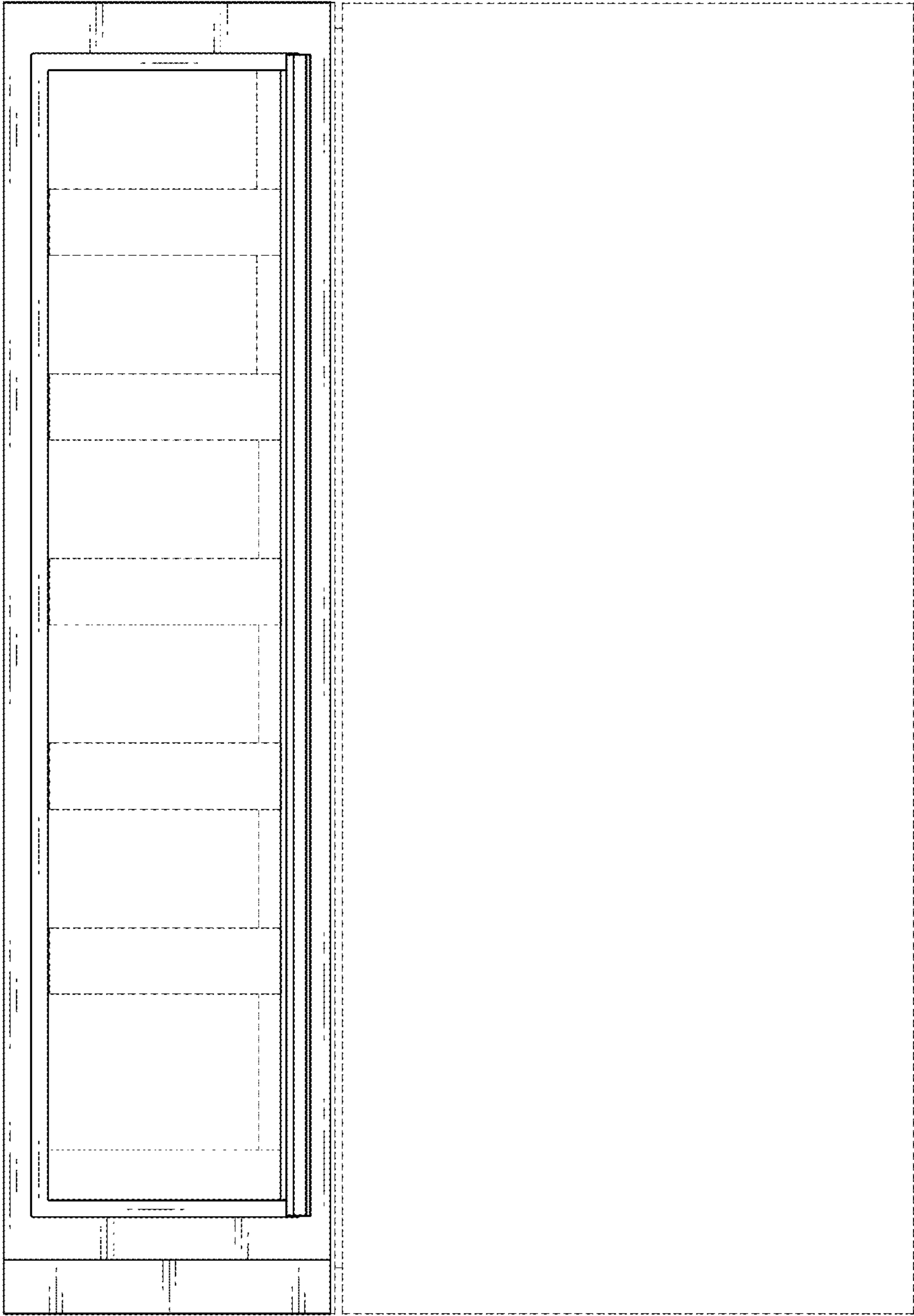

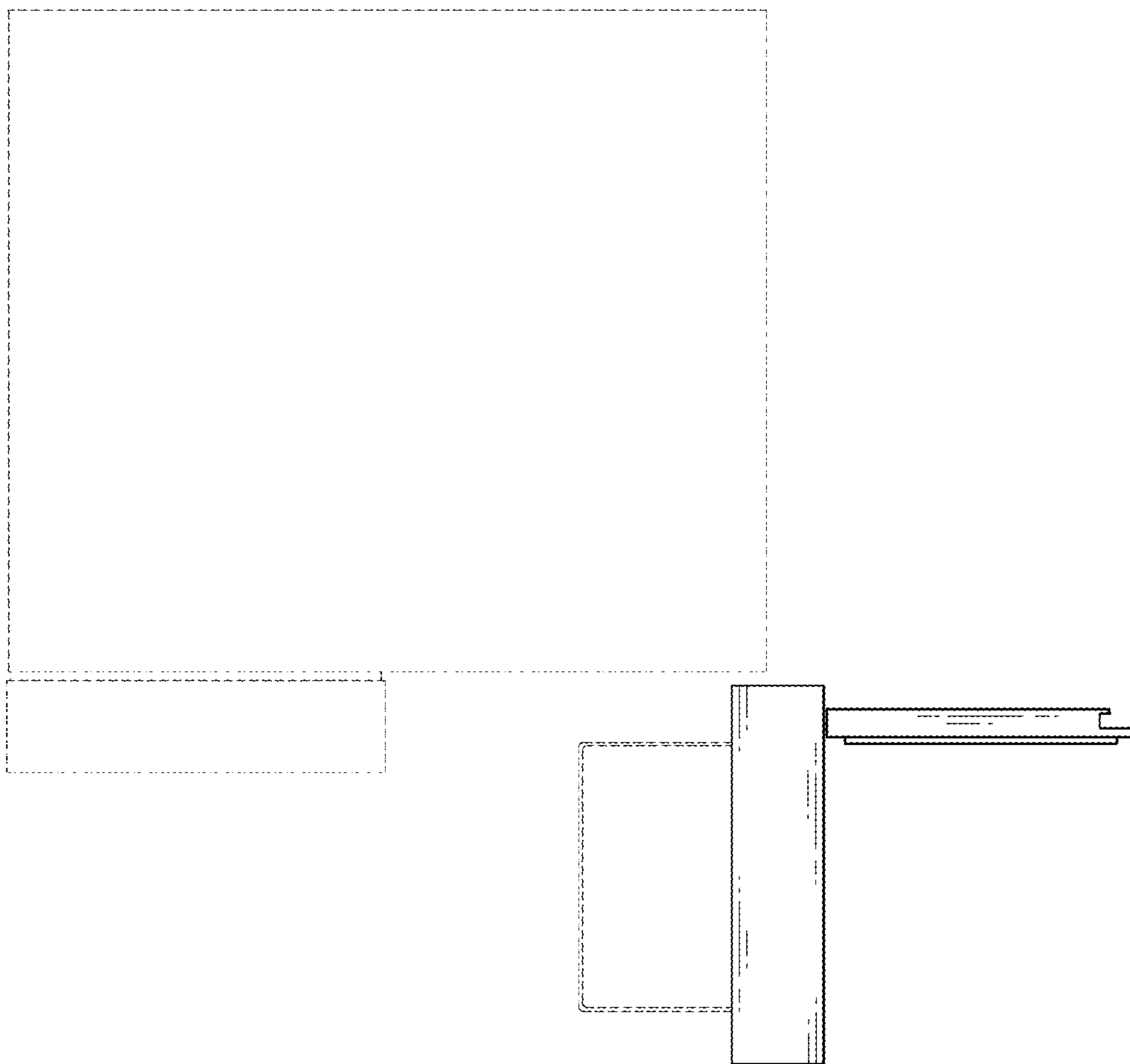
