We claim the ornamental design for a refrigerator, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a refrigerator showing my new design with its double door closed;

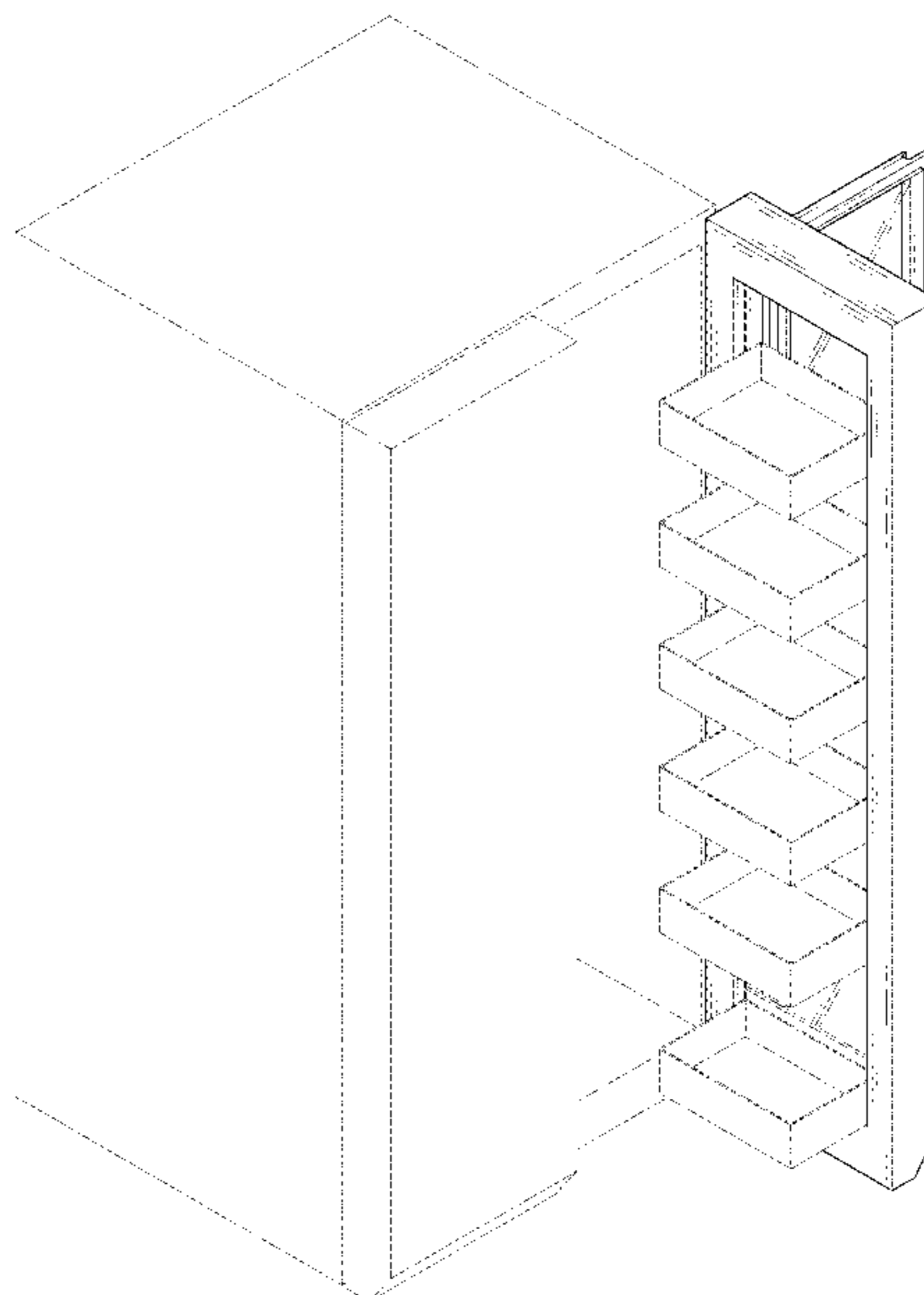
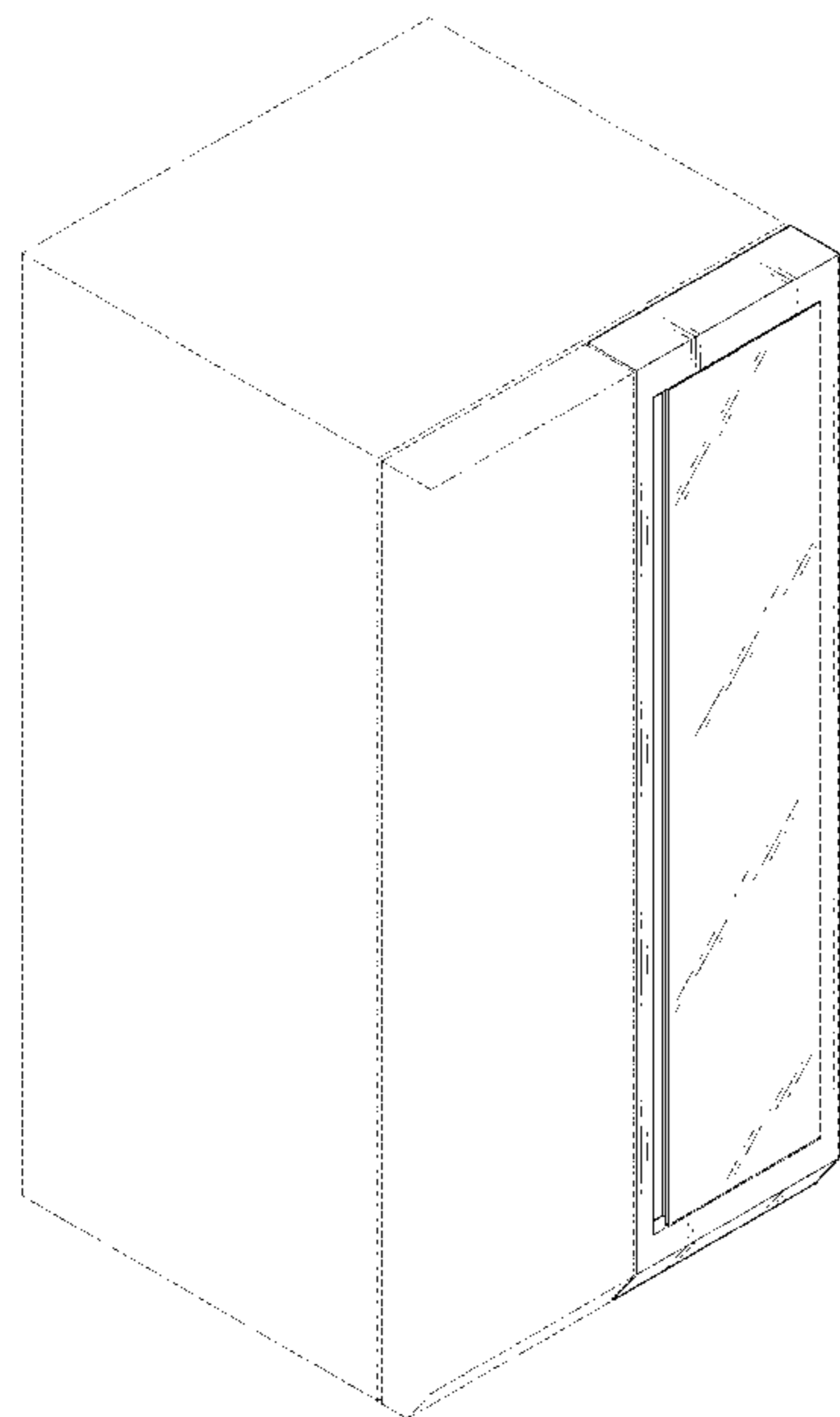

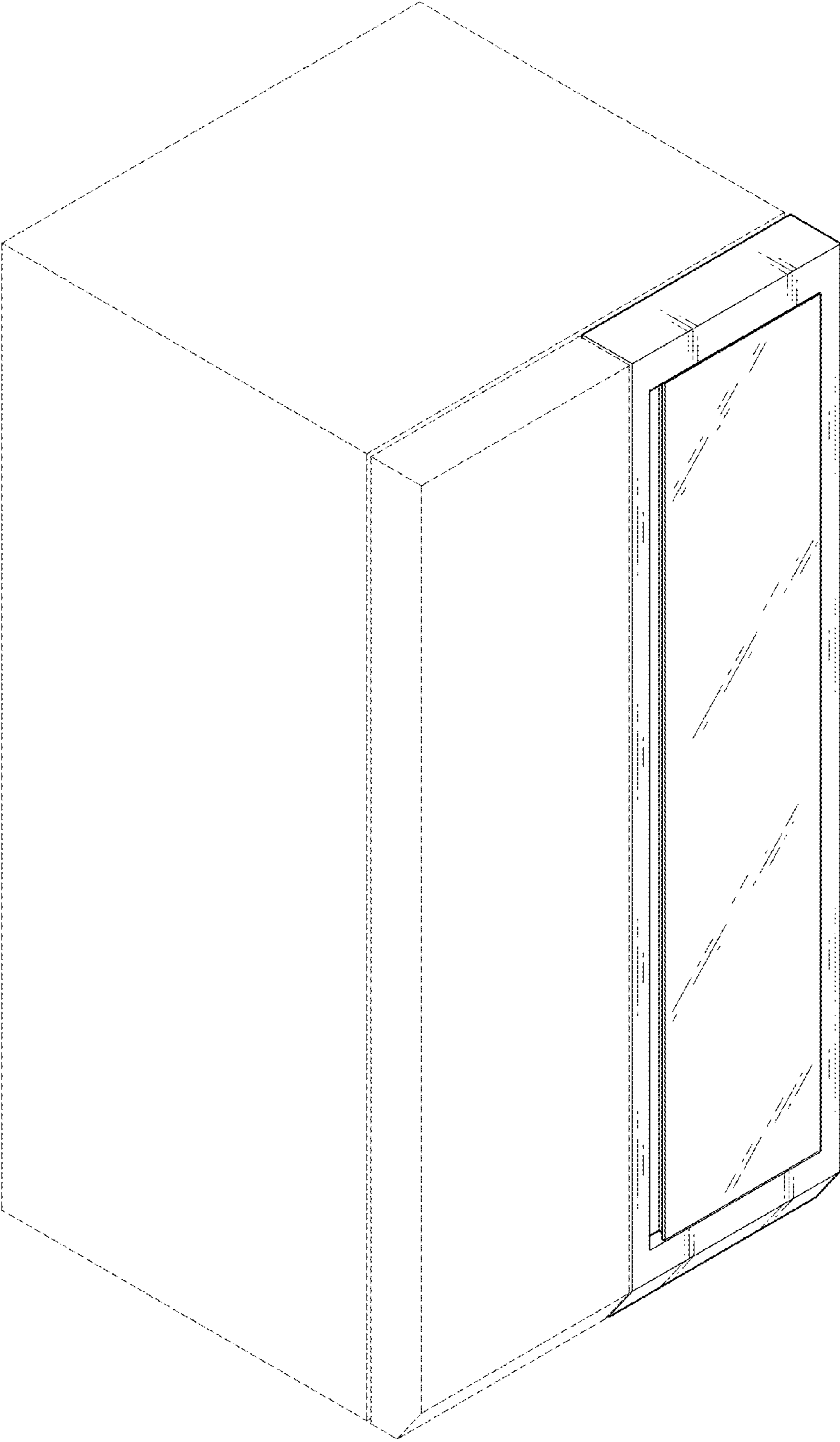

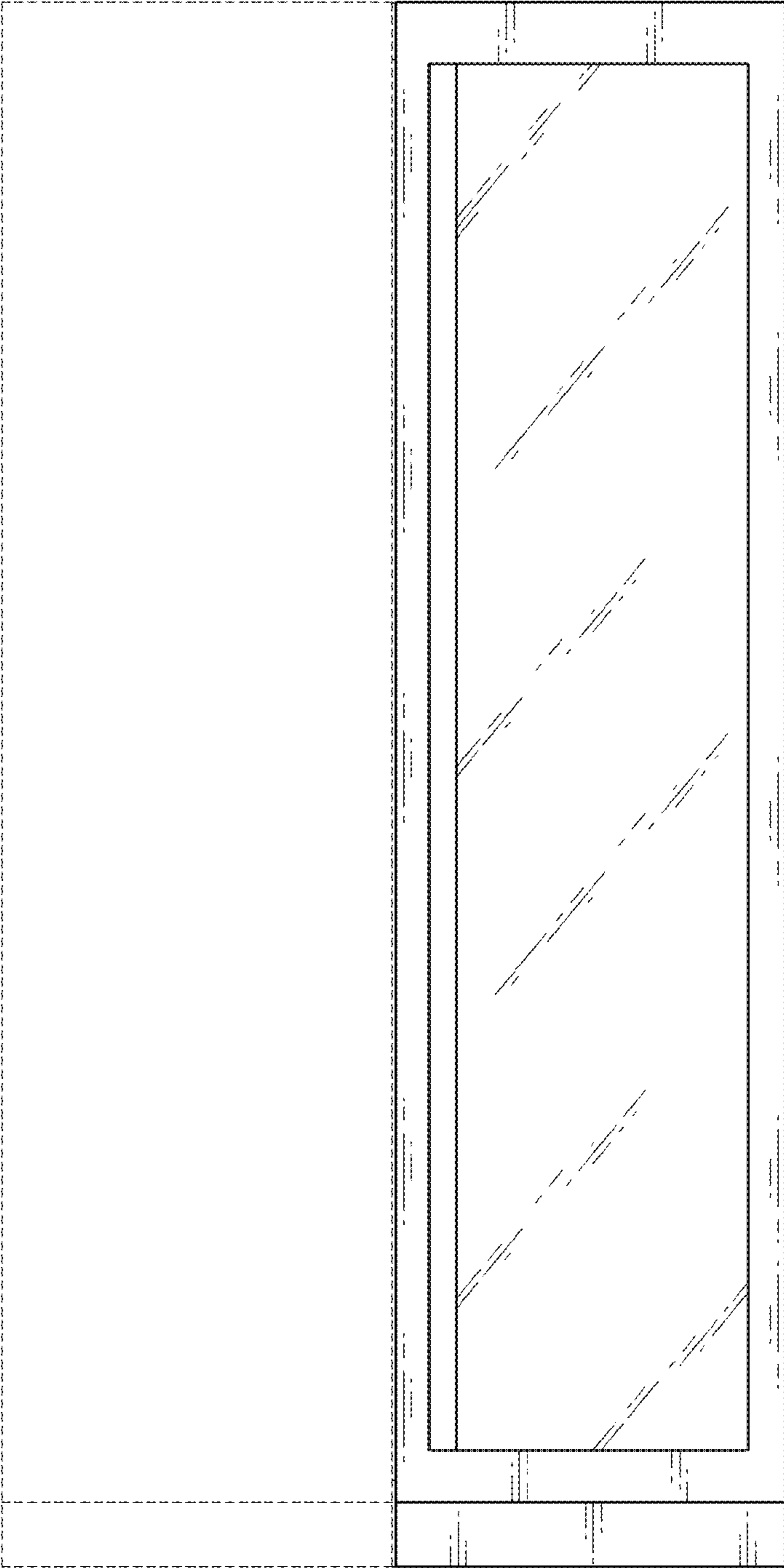

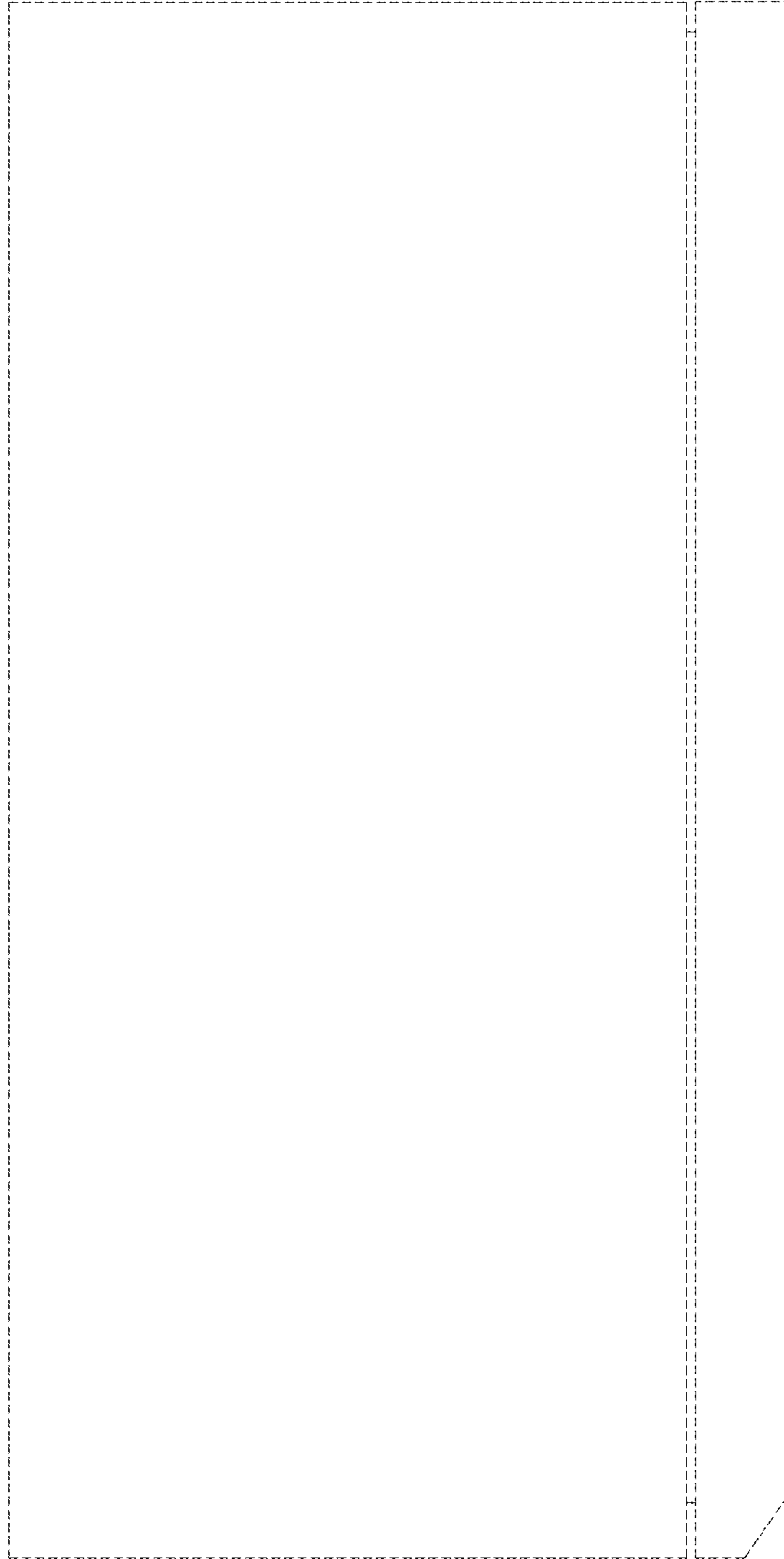

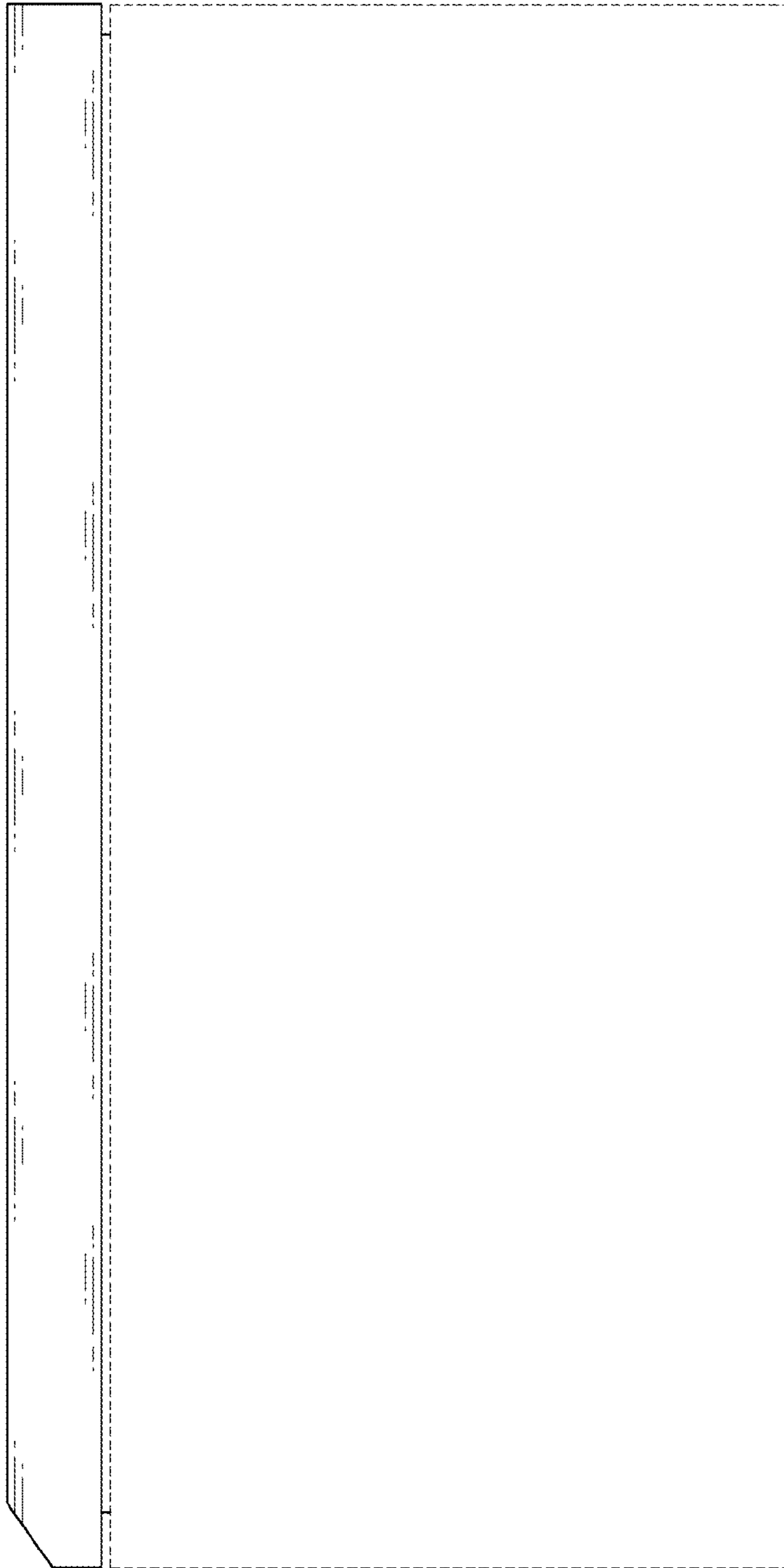

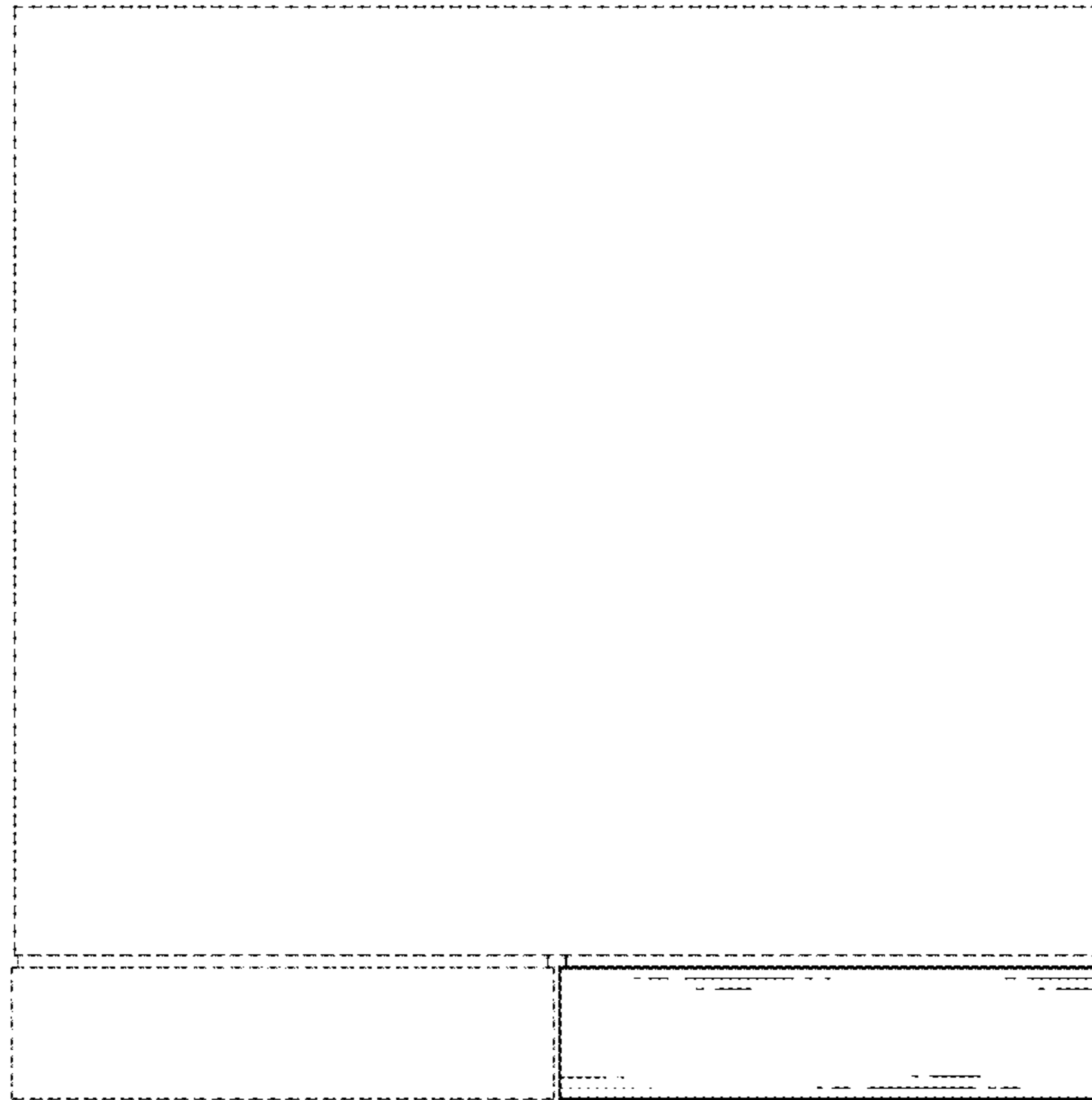

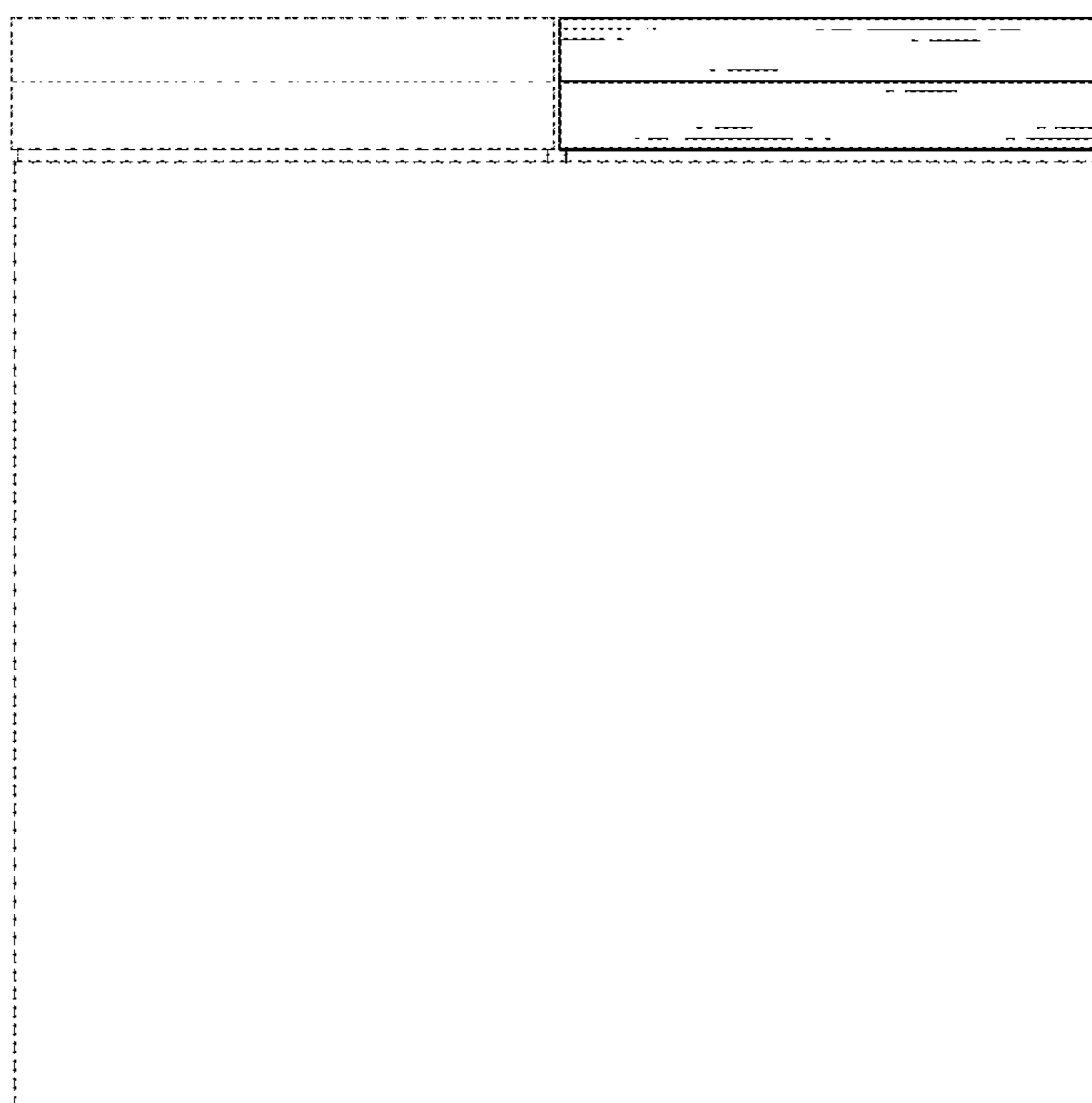

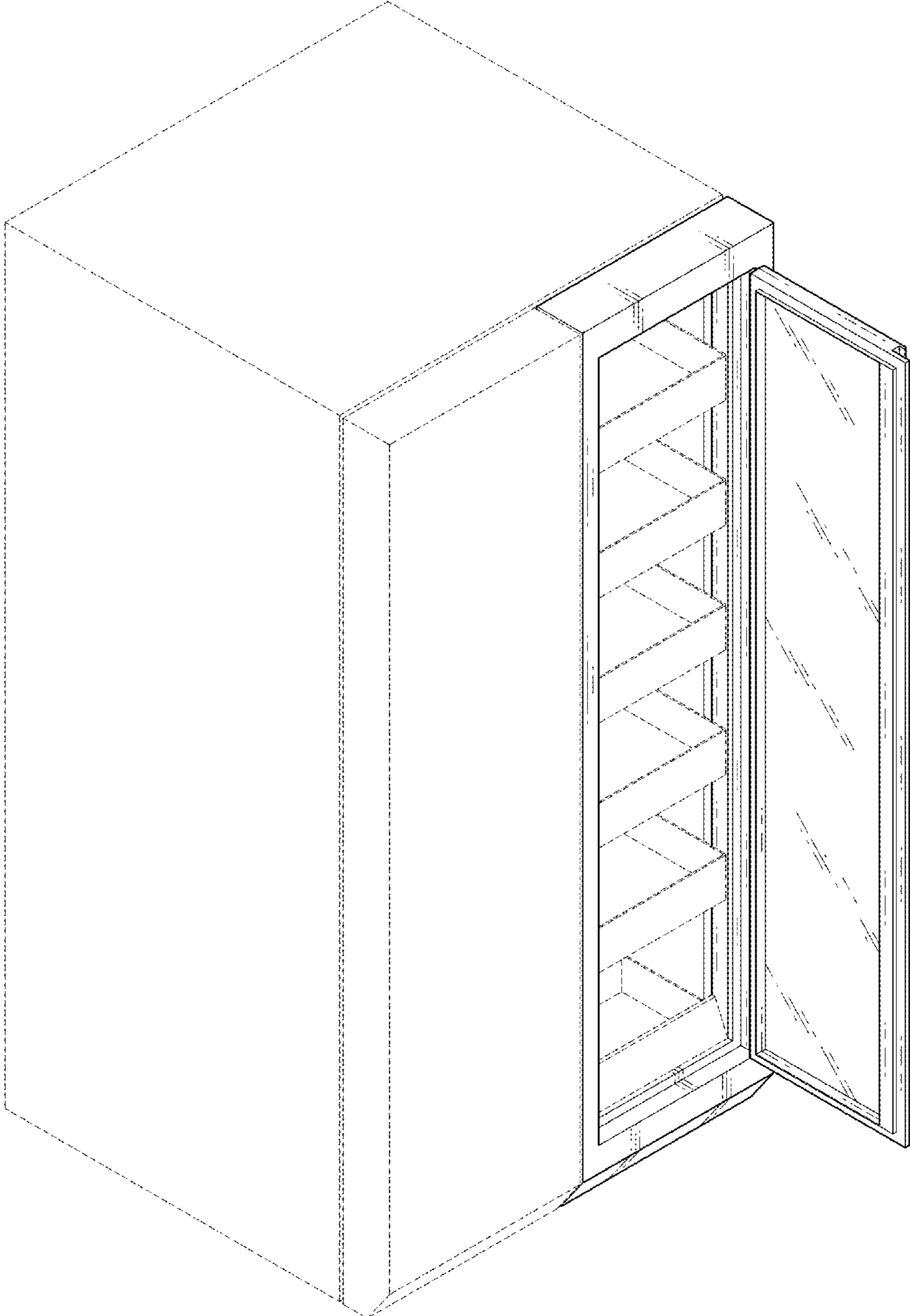

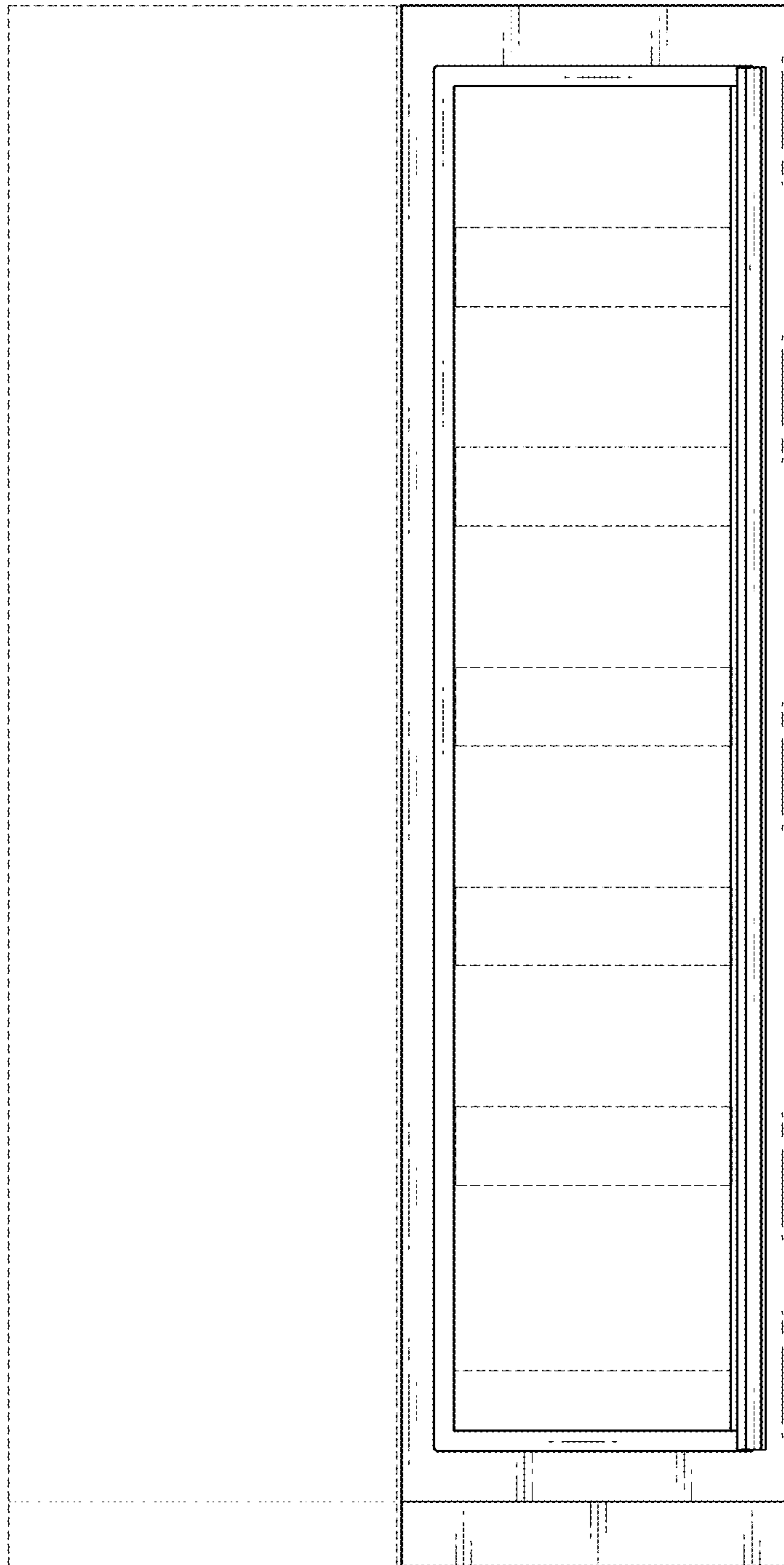

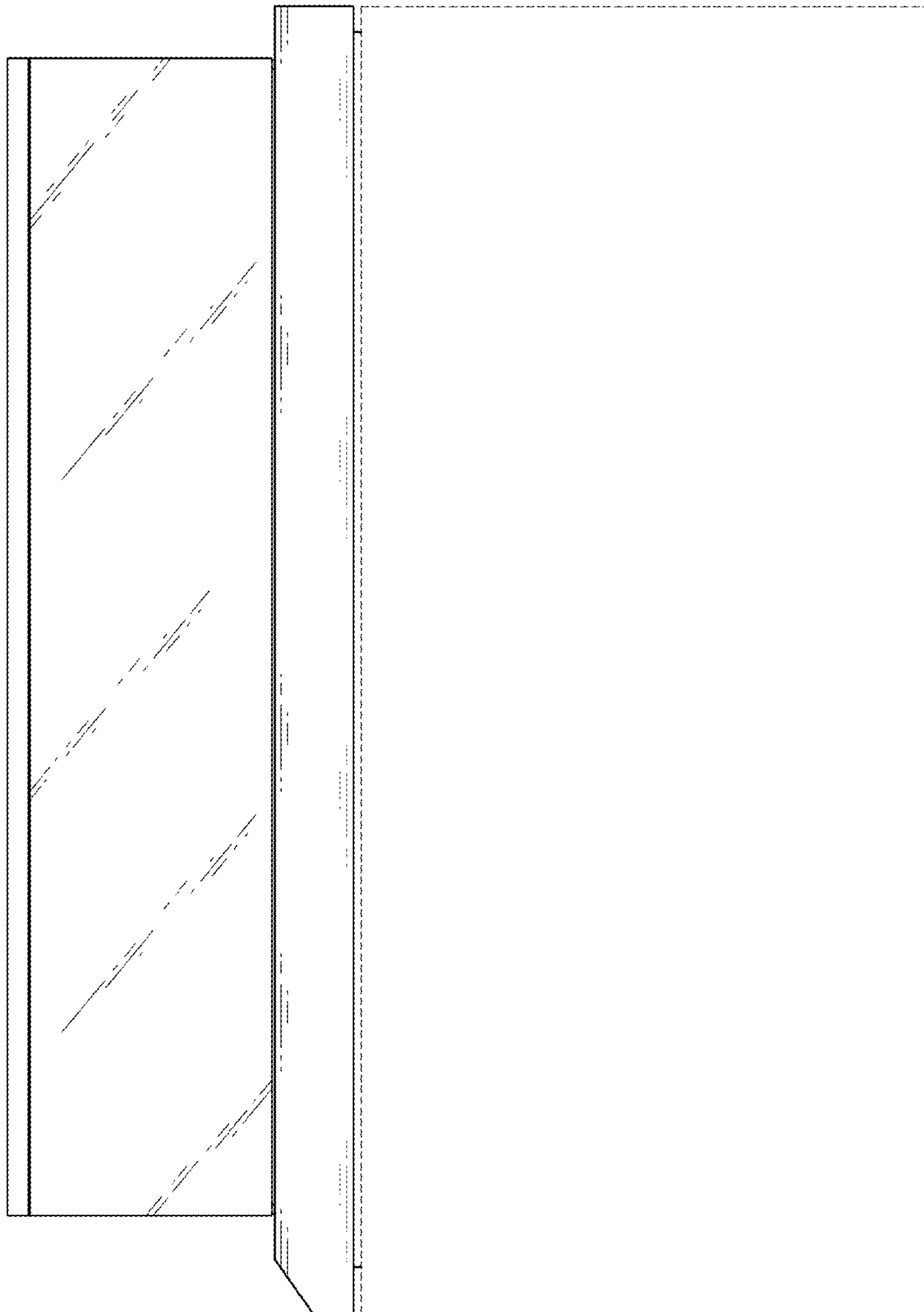

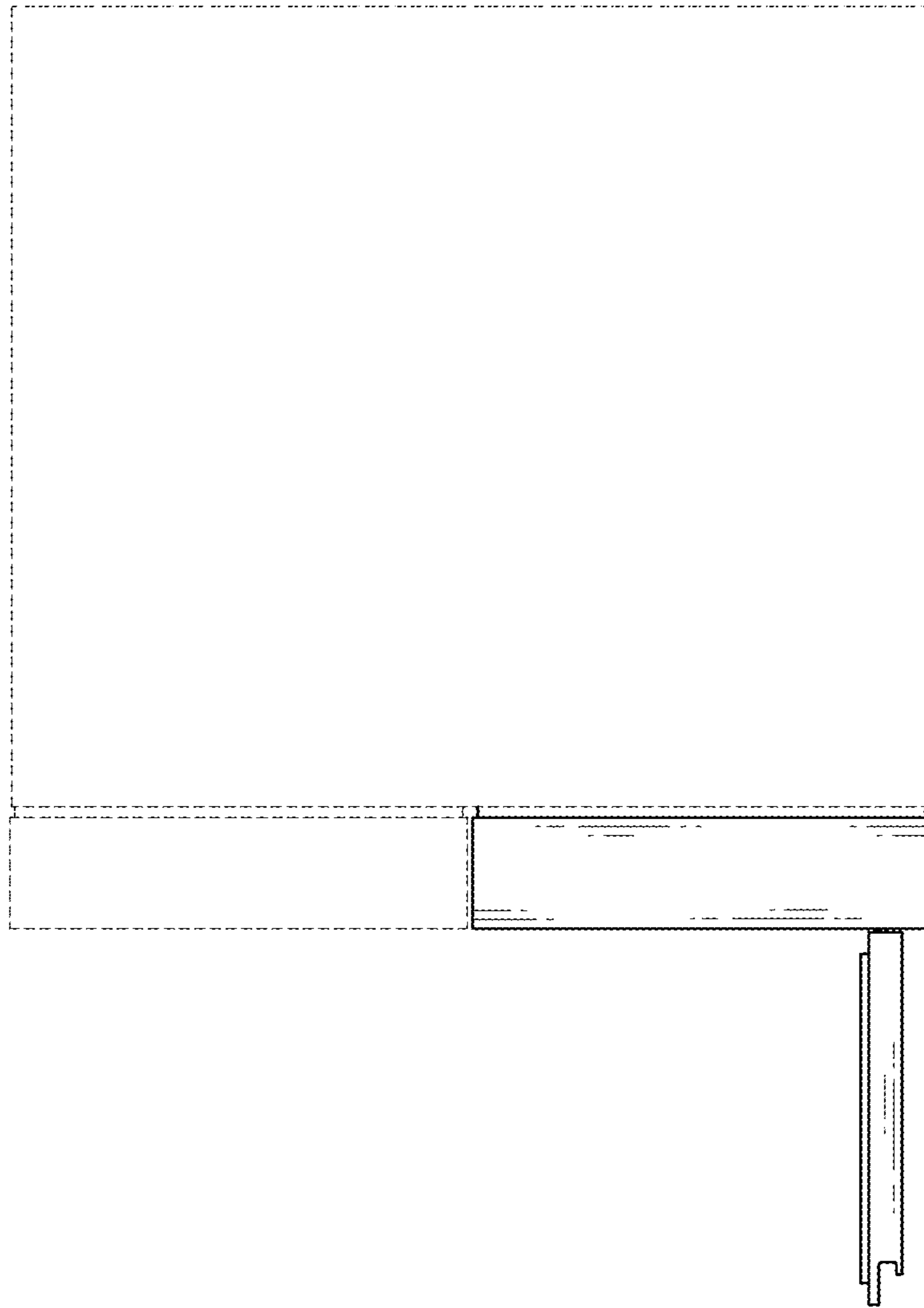

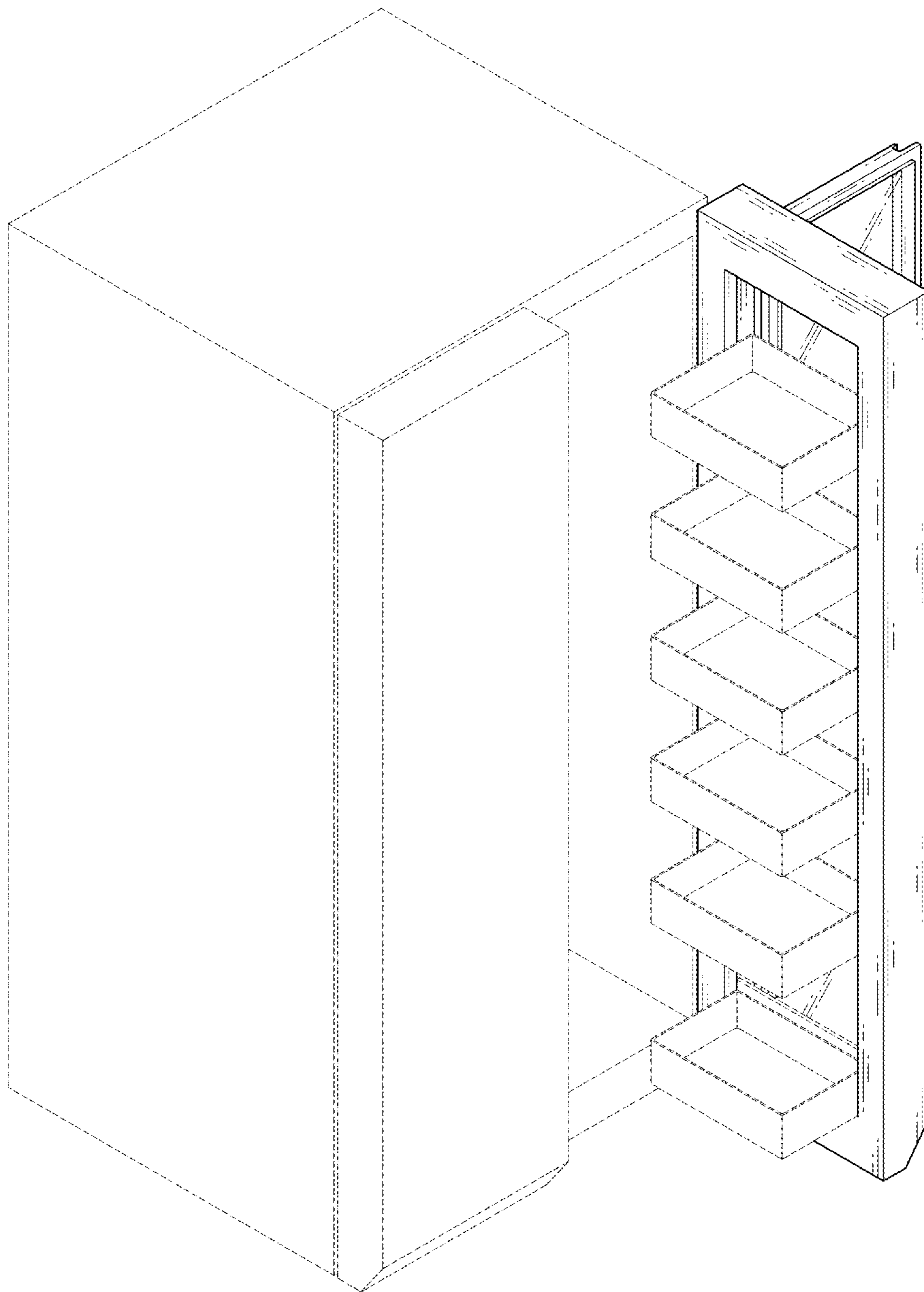

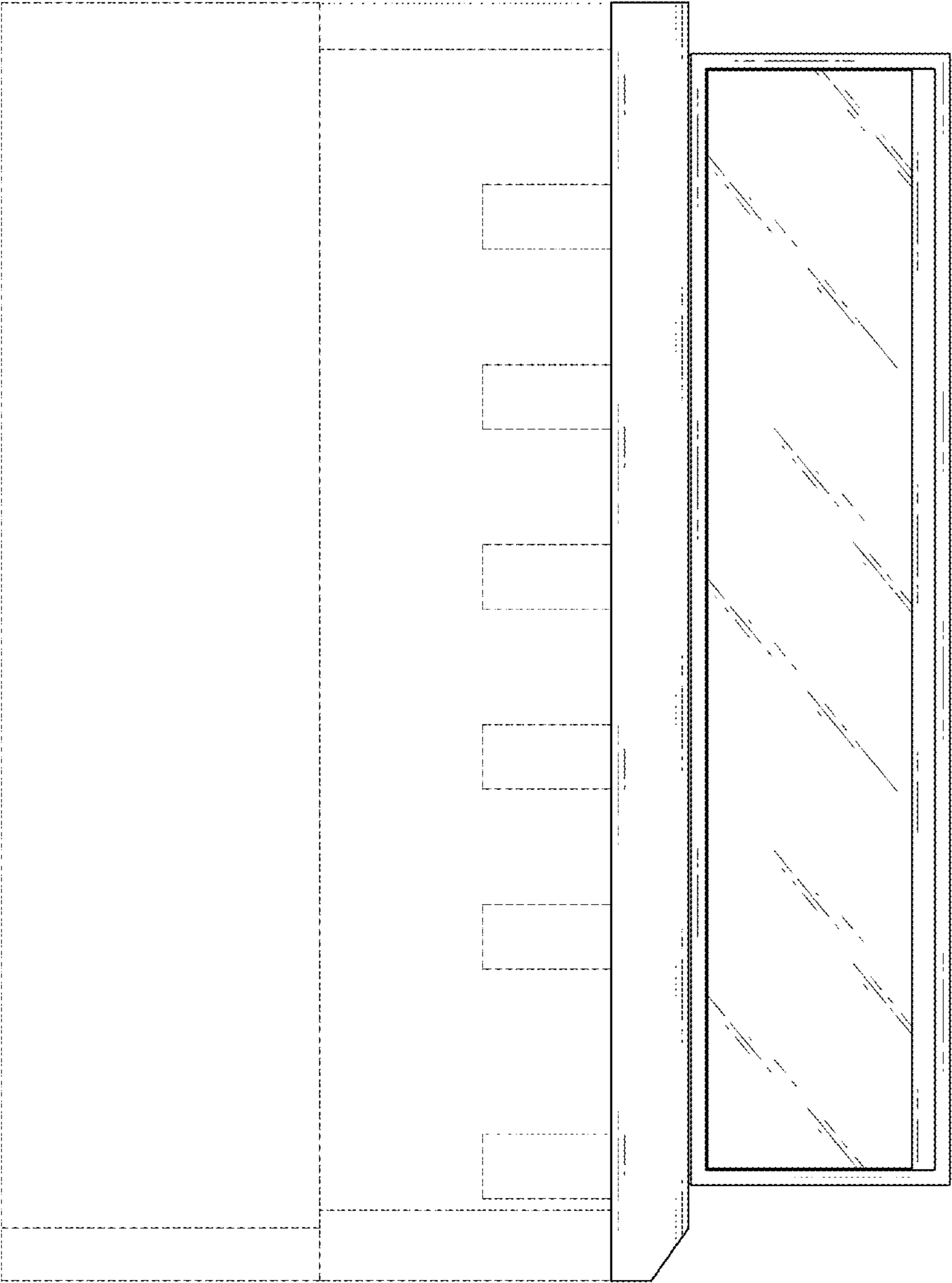

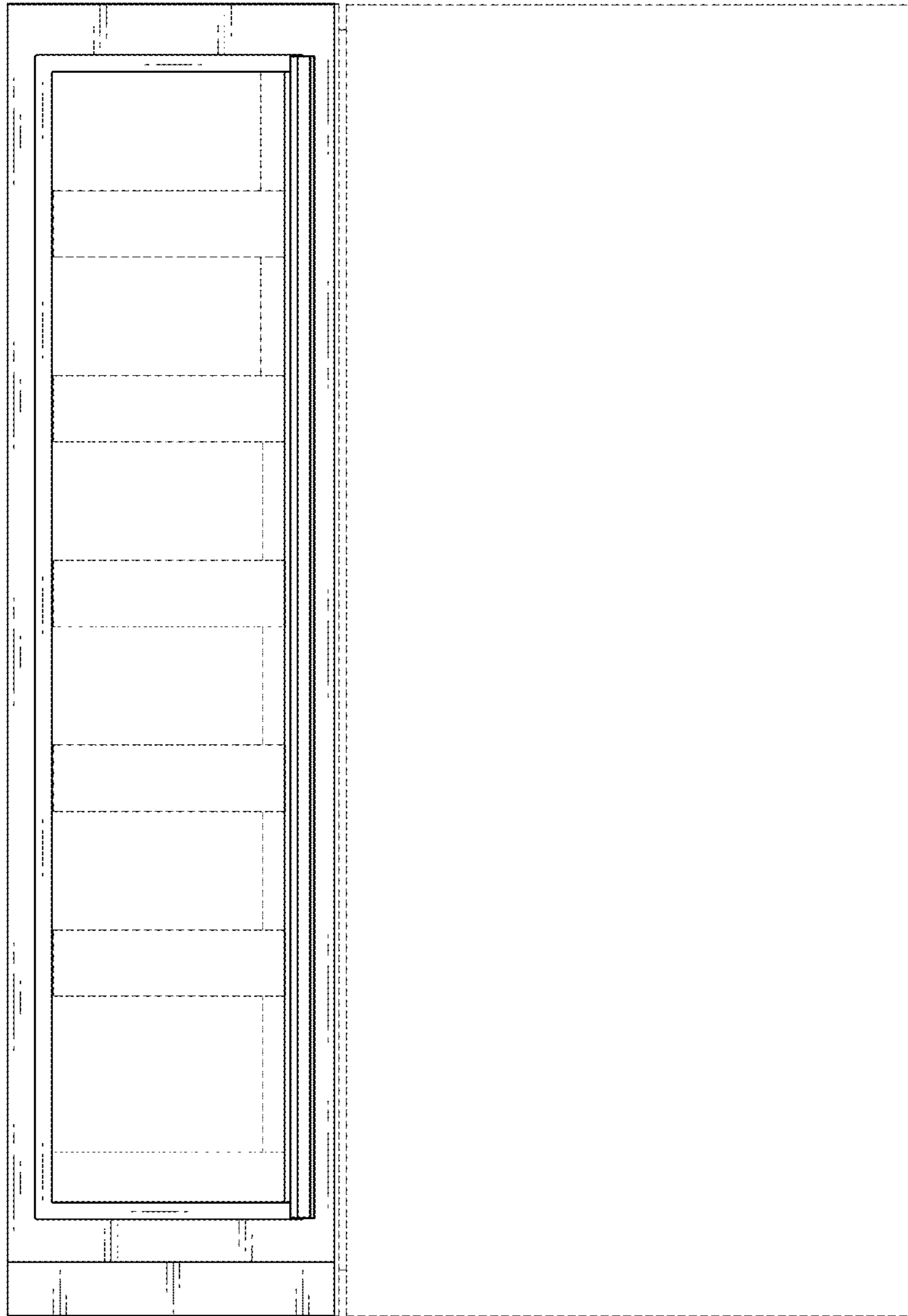

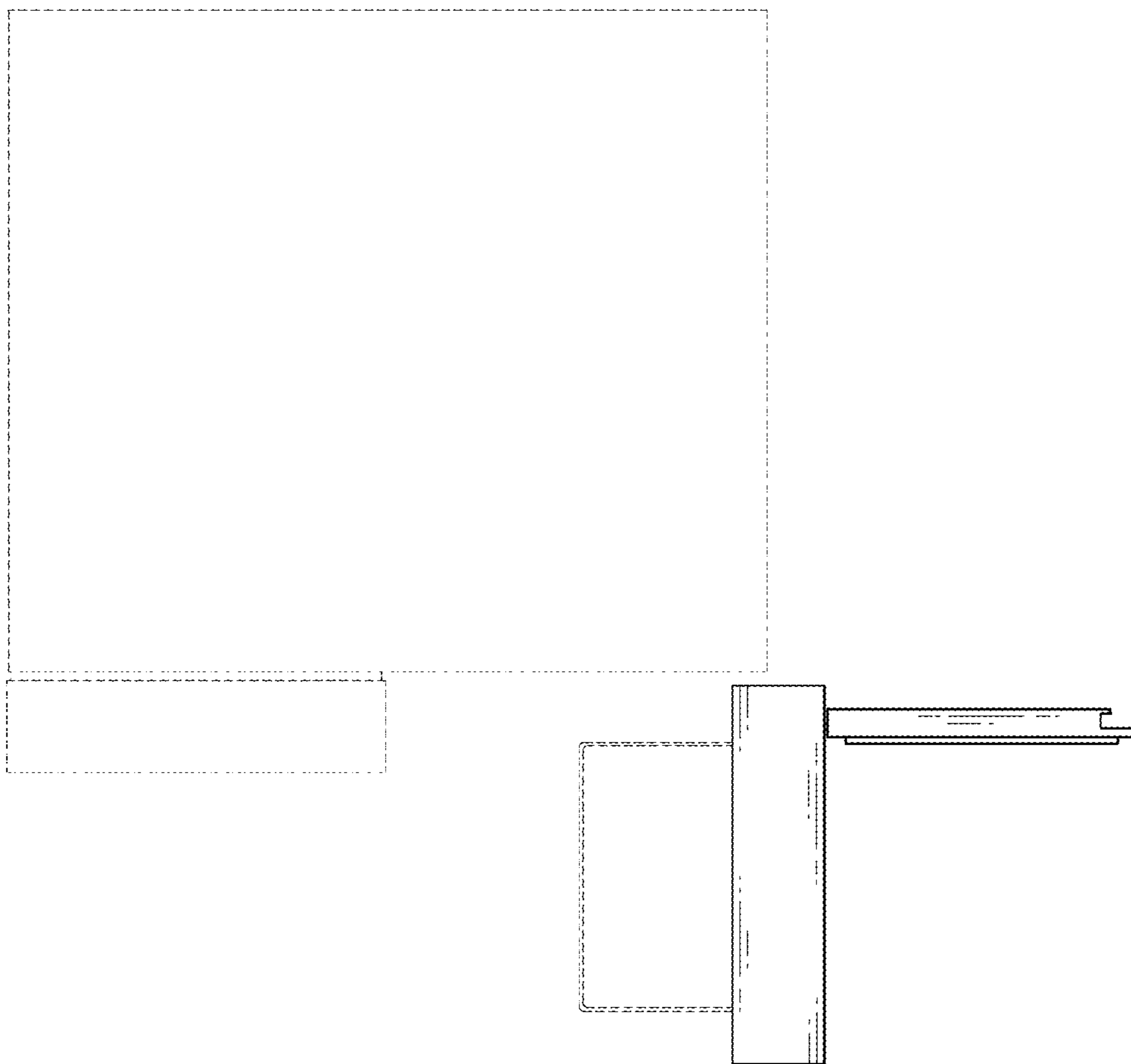
