I claim the ornamental design for a financial transaction card,
as shown and described.

transaction card showing my new design;

transaction card;

FIG. 9 is a front view of a fifth embodiment of a financial
transaction card;

FIG. 10 is a rear view thereof;

FIG. 11 is a front view of a sixth embodiment of a financial
transaction card; and,

FIG. 12 is a rear view thereof.

The broken line showing of portions of the financial transac-
tion card is included for the purpose of illustrating environ-
mental structure and forms no part of the claimed design.

The characteristic feature of the claimed design resides in the
financial transaction card resembling a portion of a vinyl
record.

The transaction is interpreted to be flat with an applied design
and has no appreciable thickness.

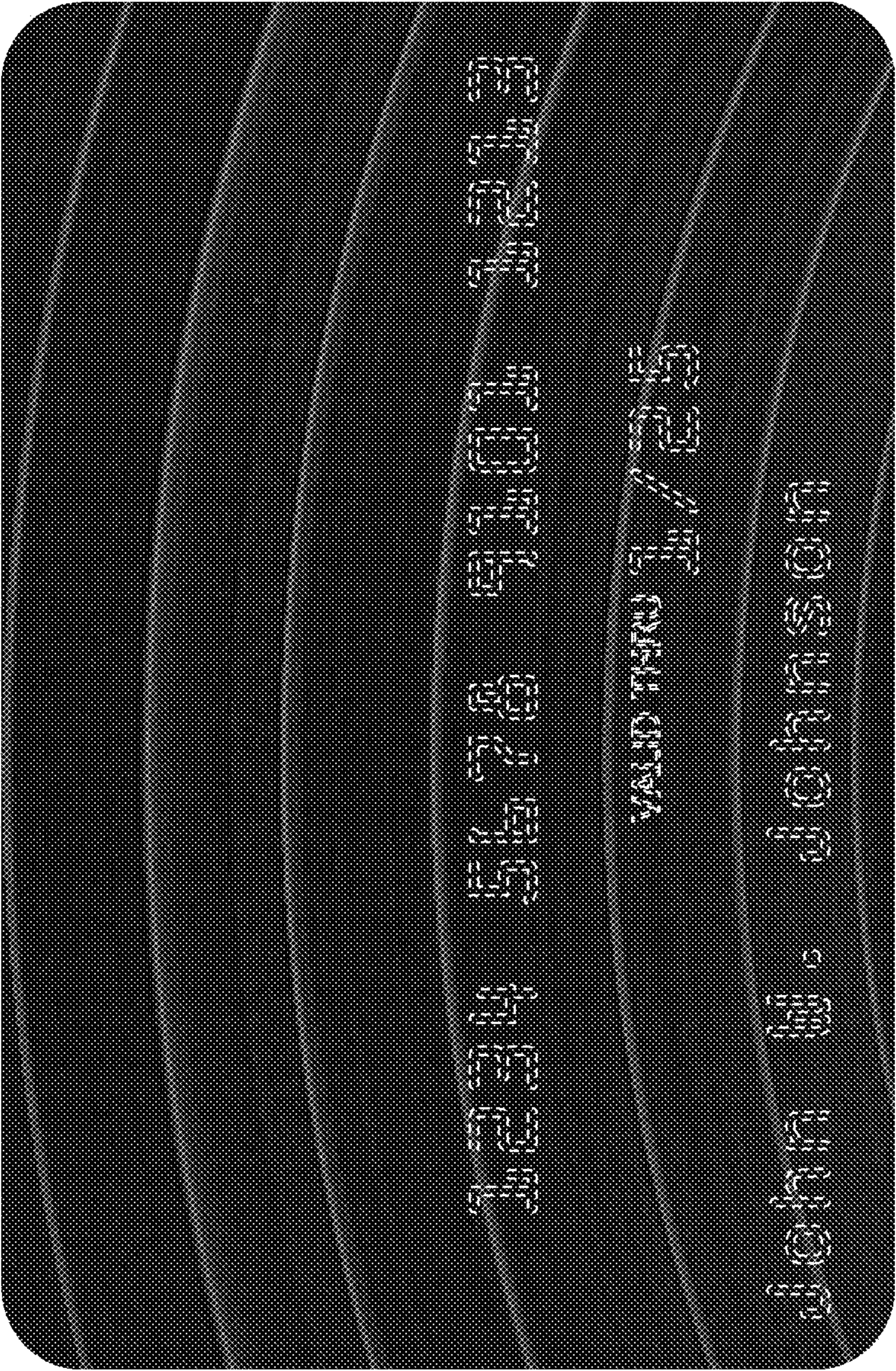

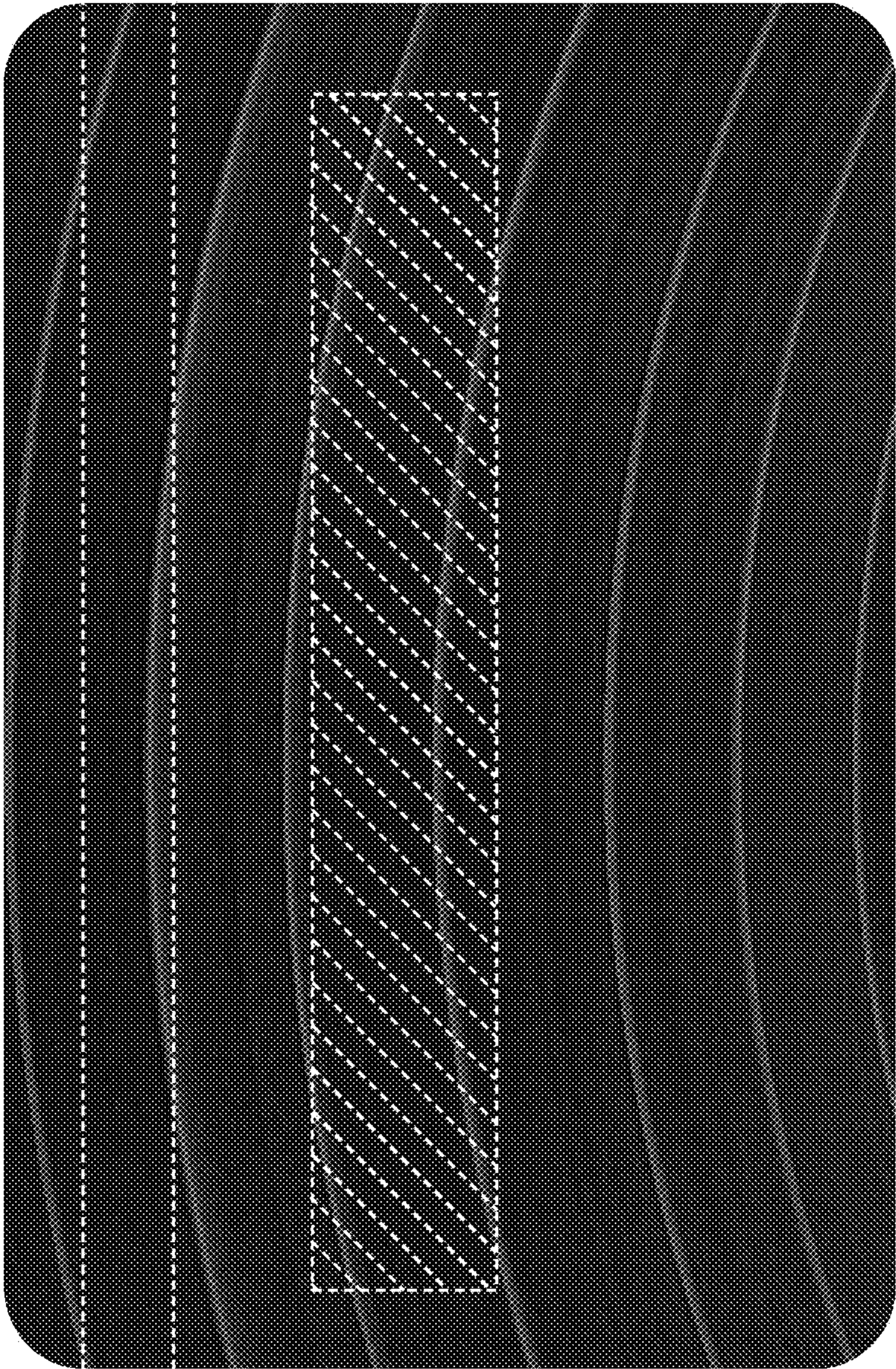

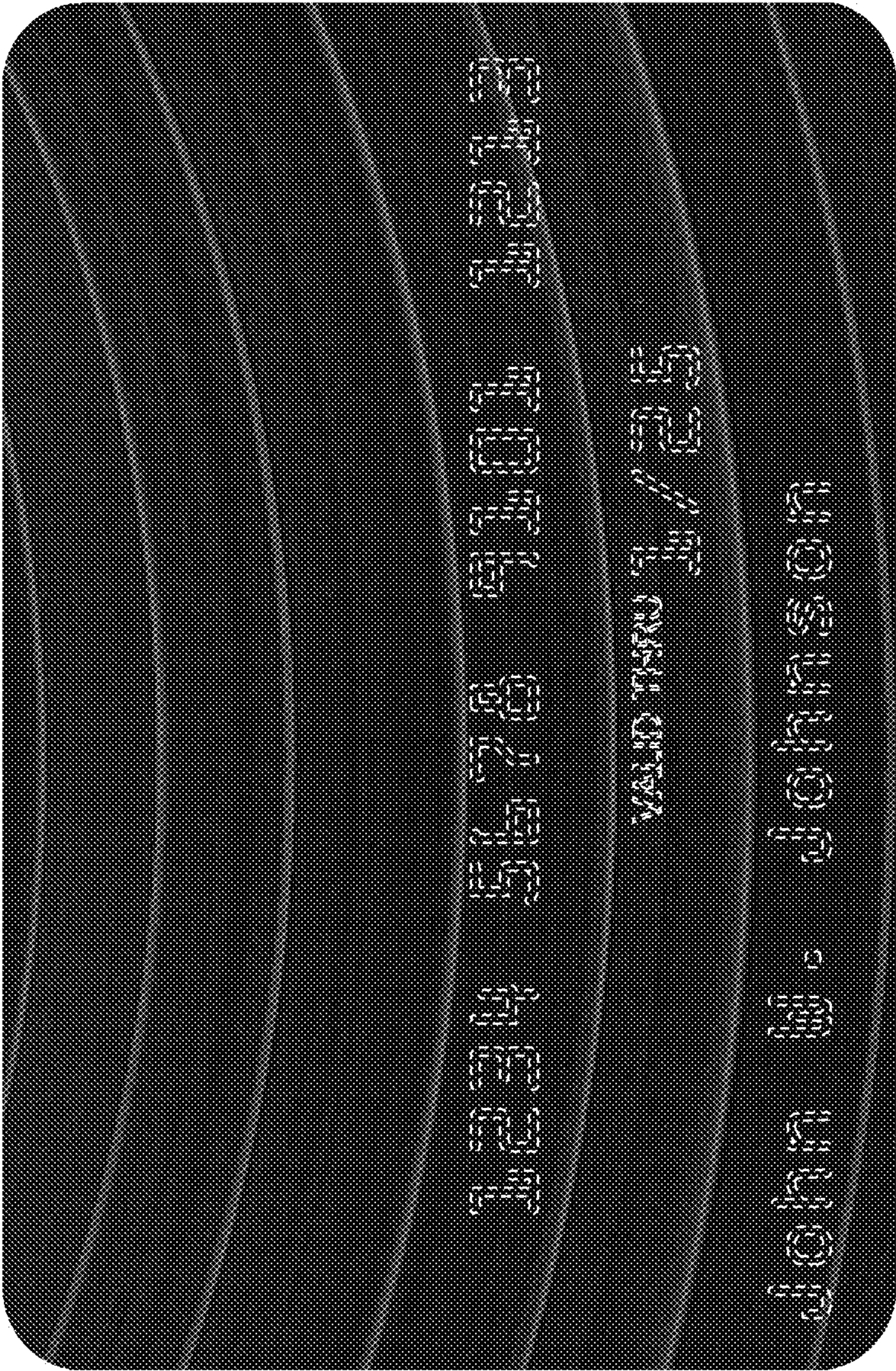

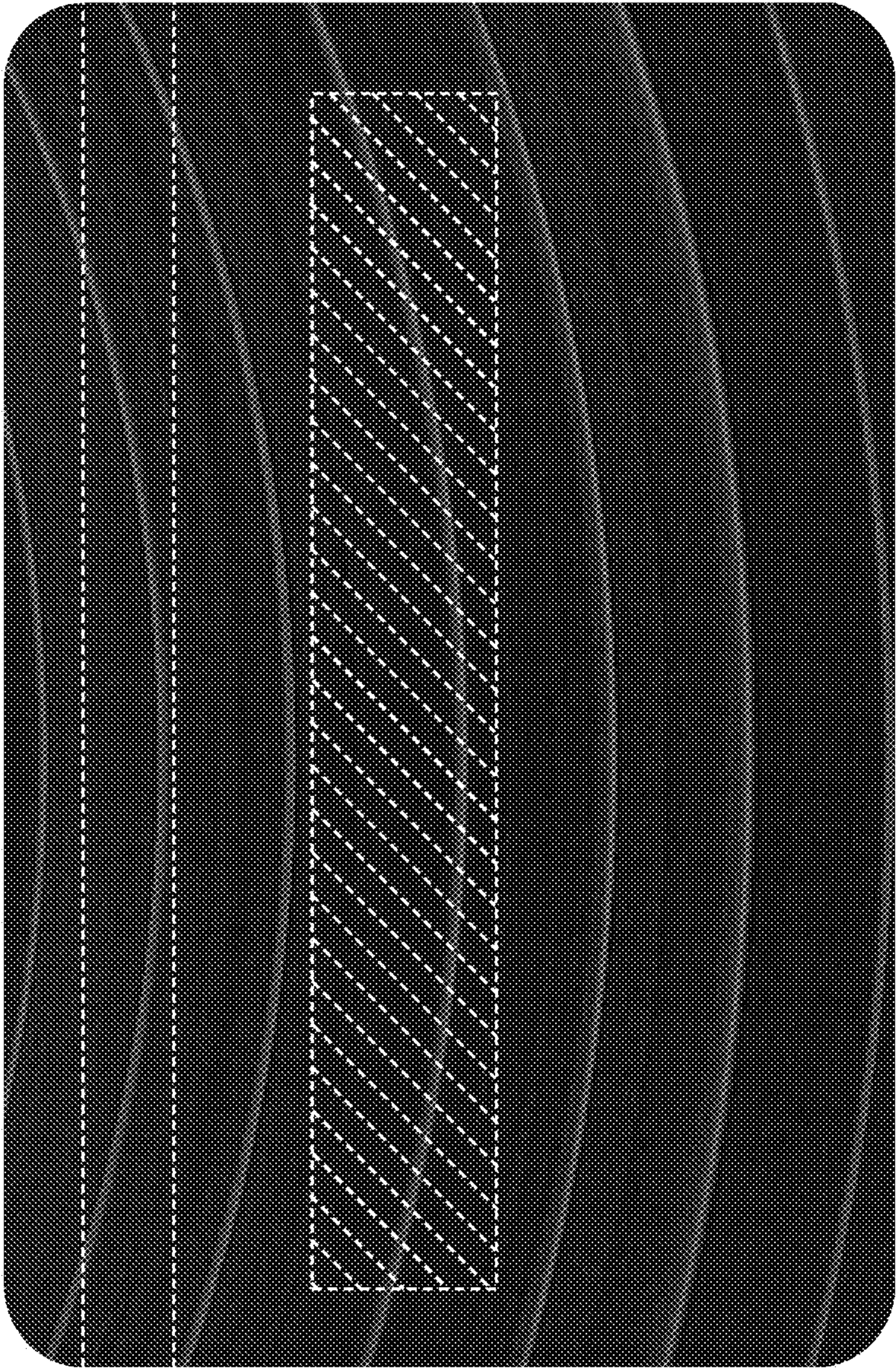

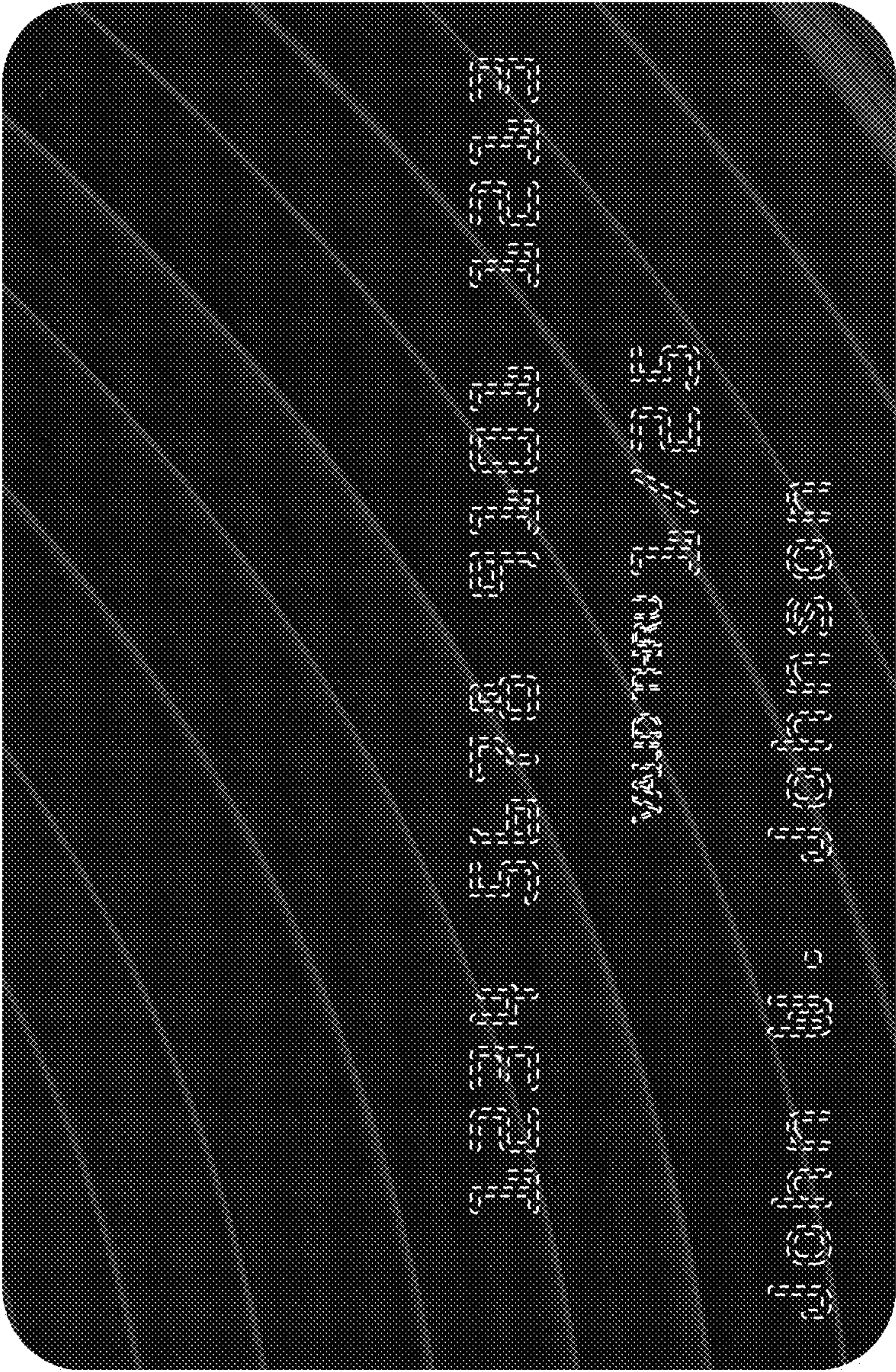

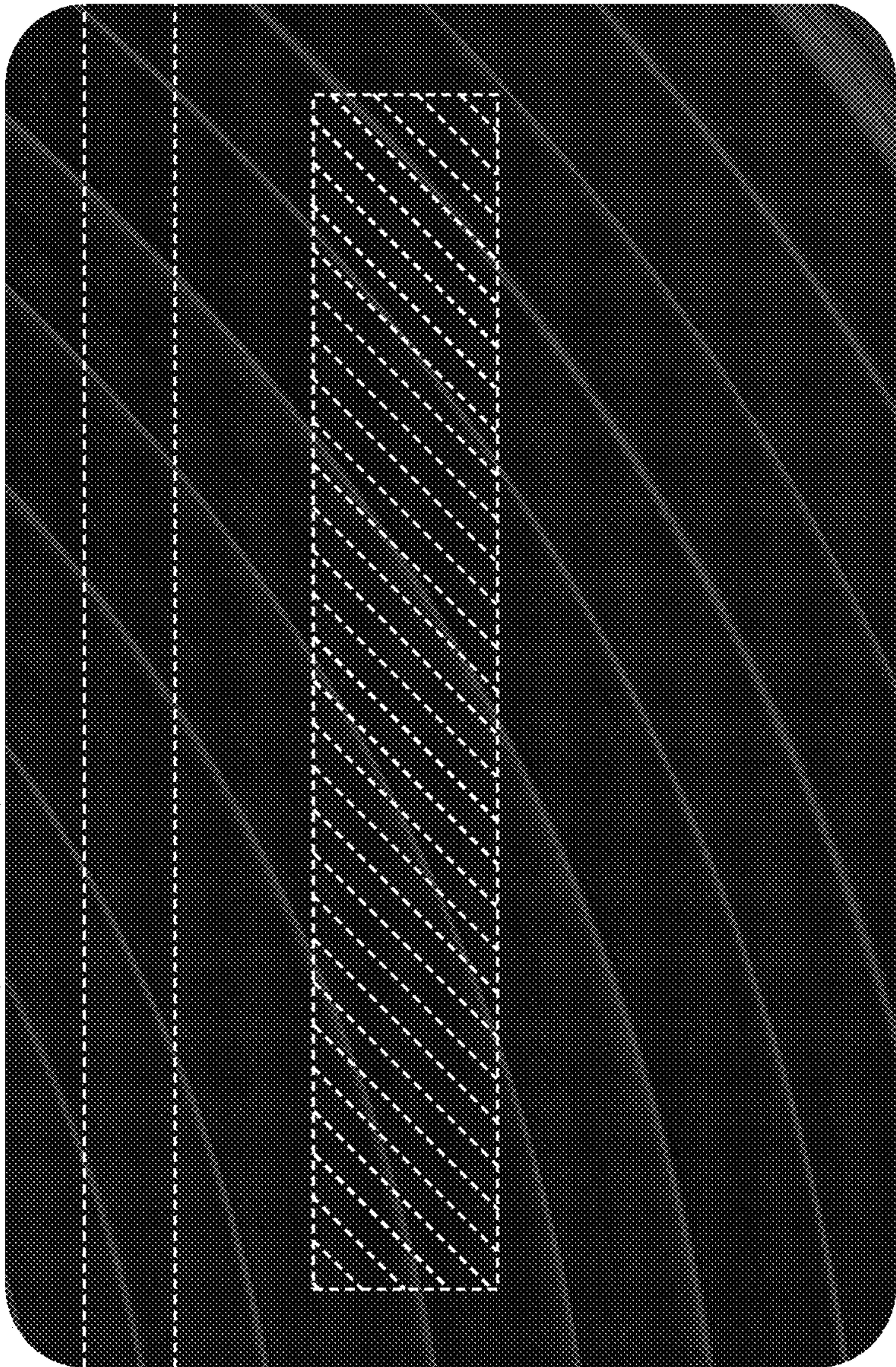

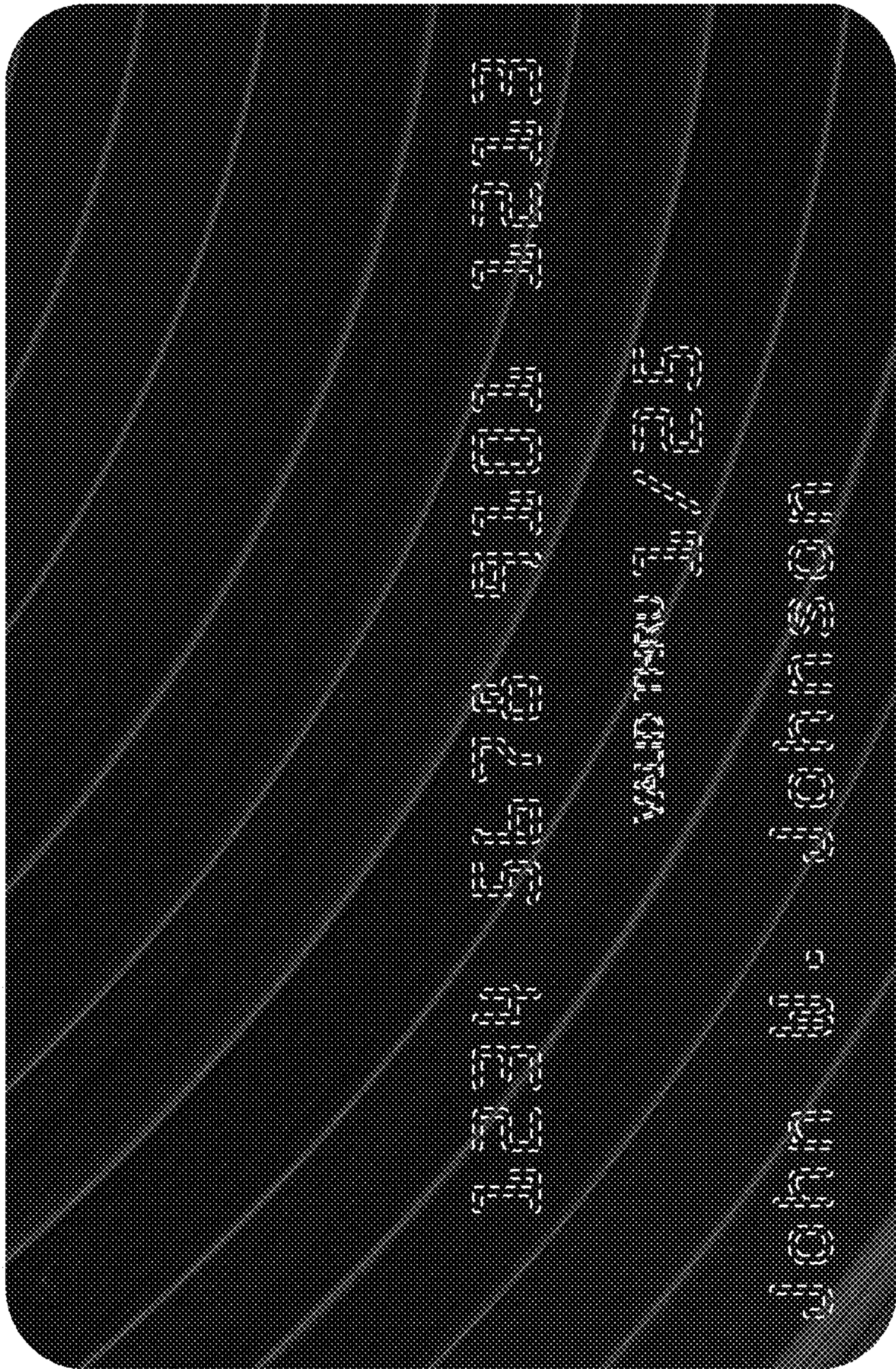

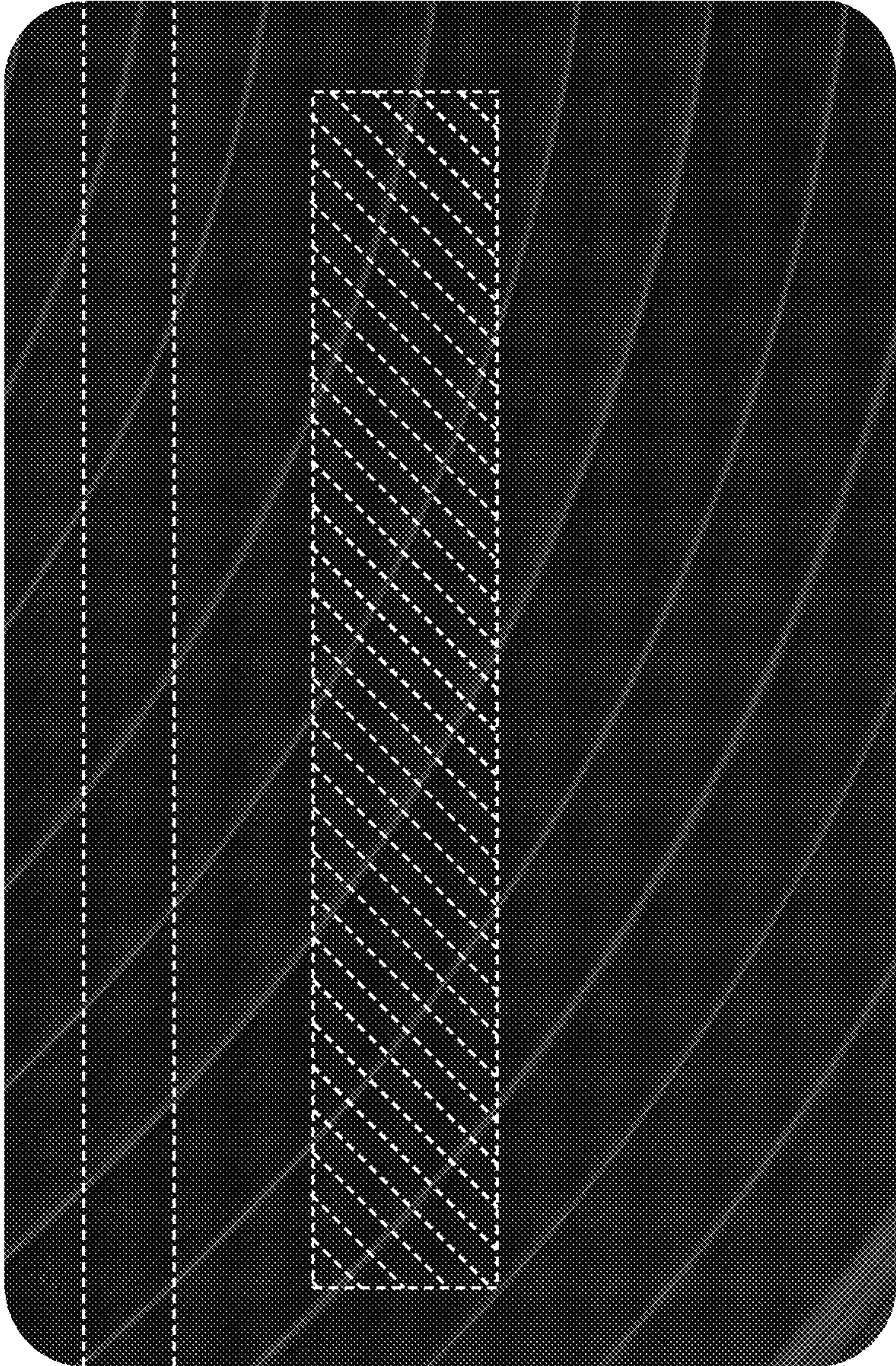

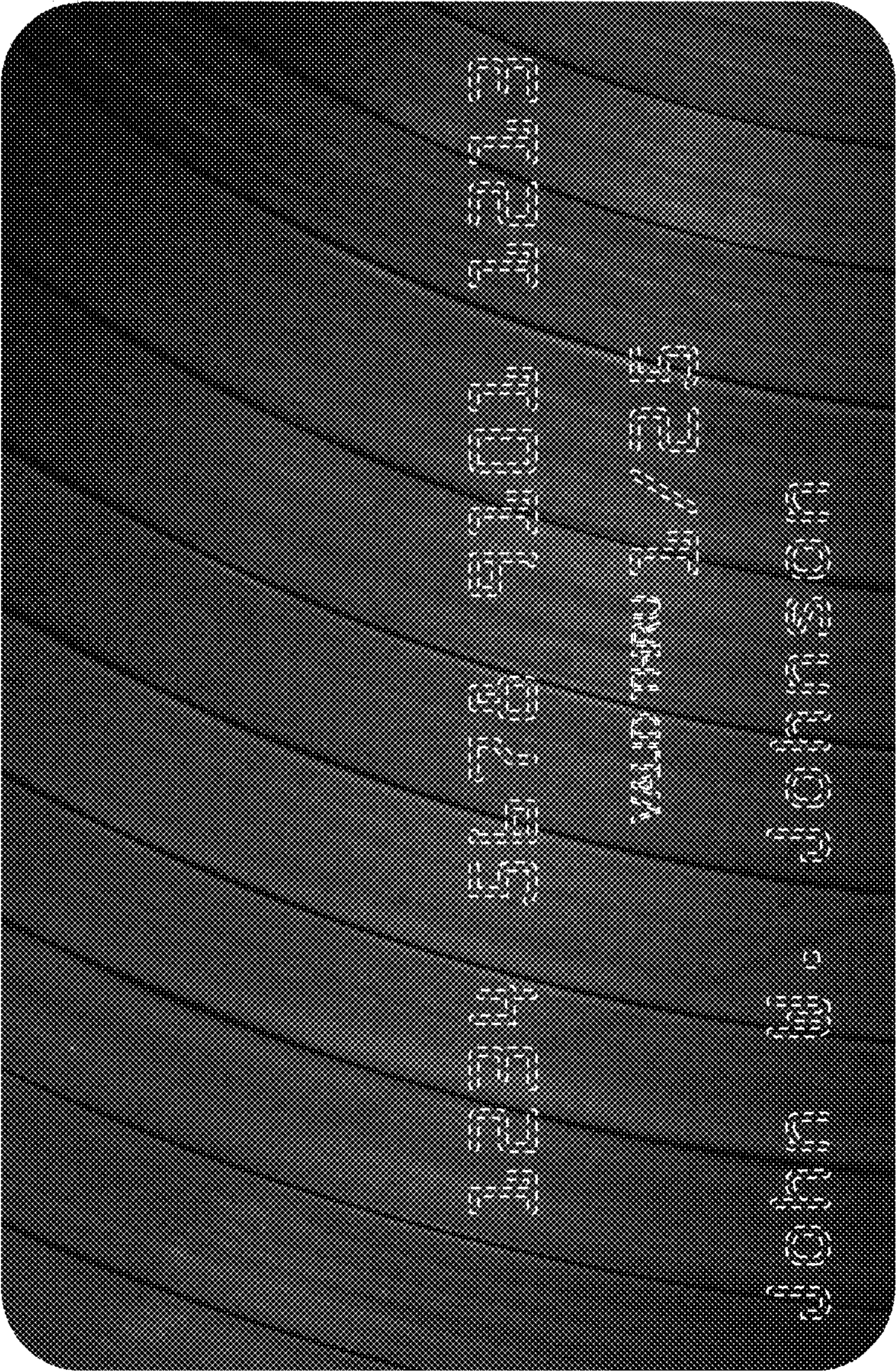

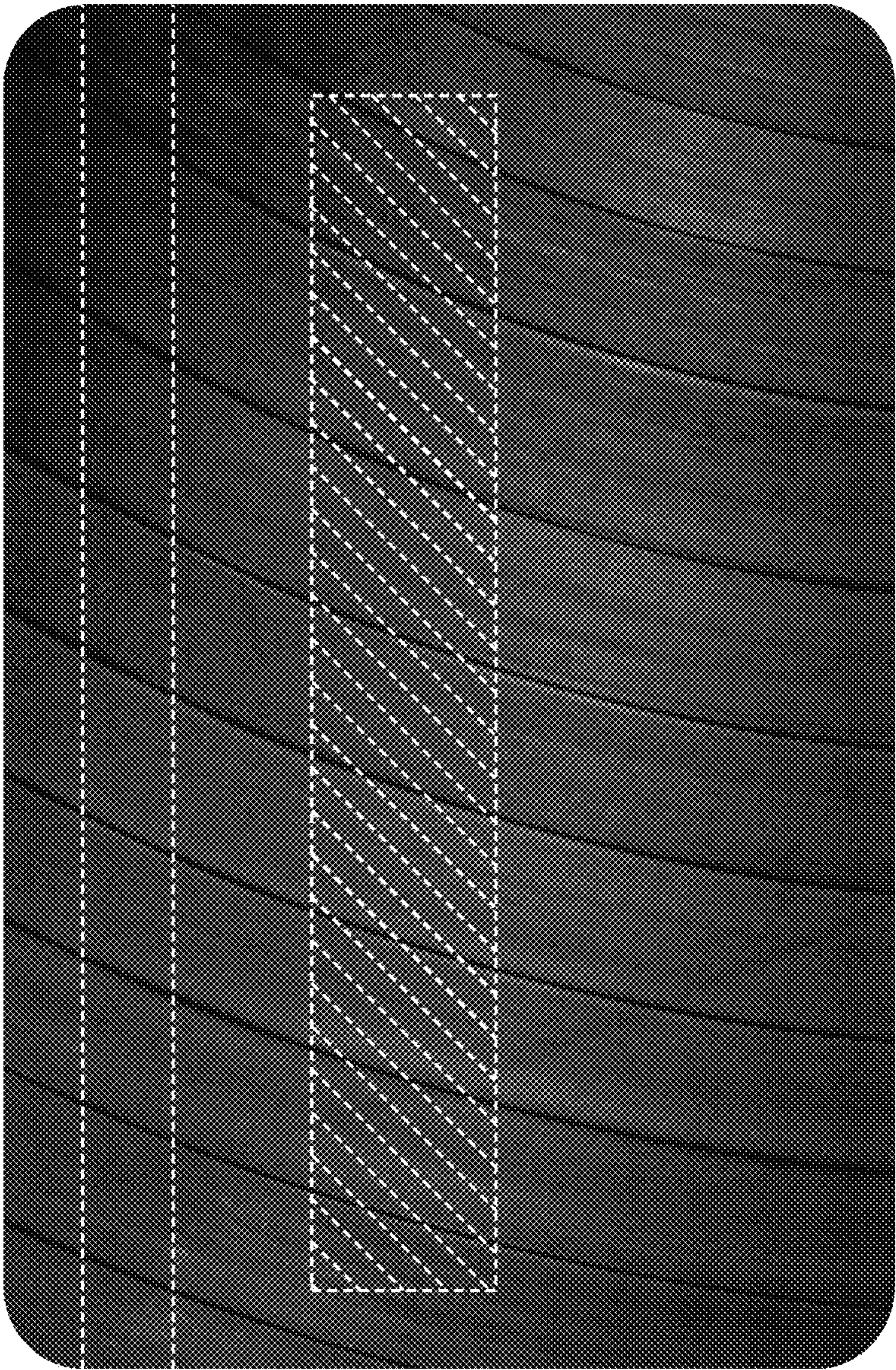

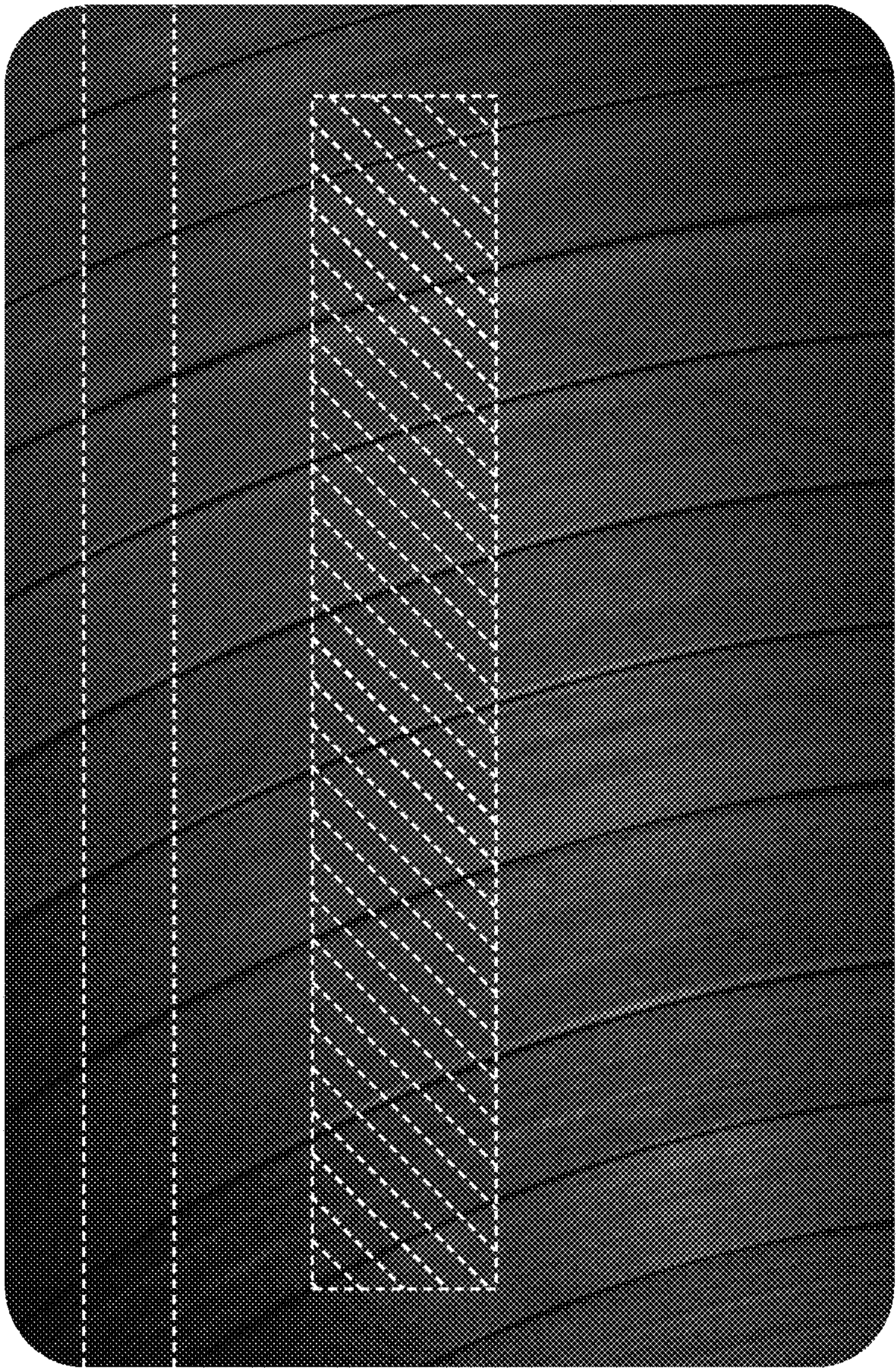
