DESCRIPTION

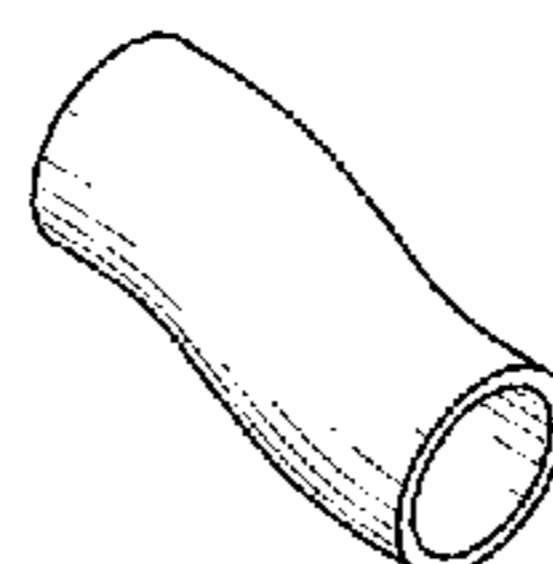
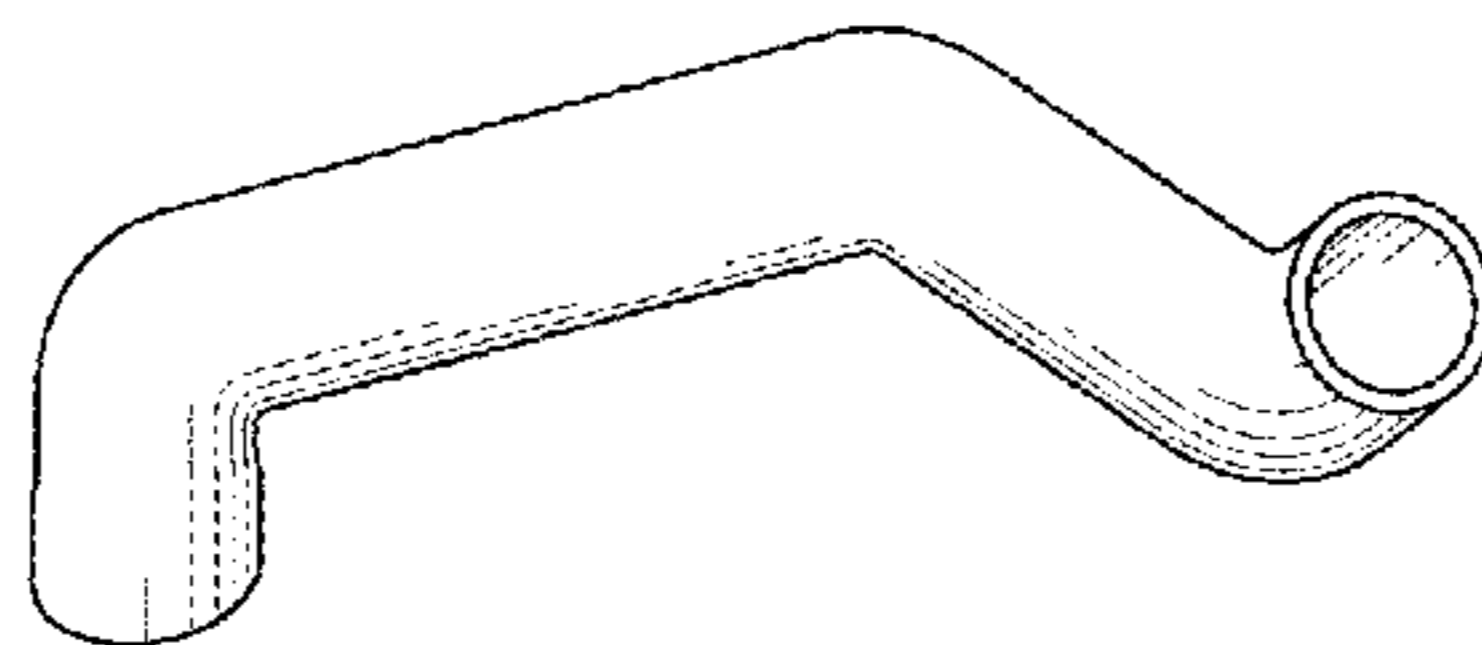
FIG. 1 is a rear perspective view of a radiator hose kit showing my new design;

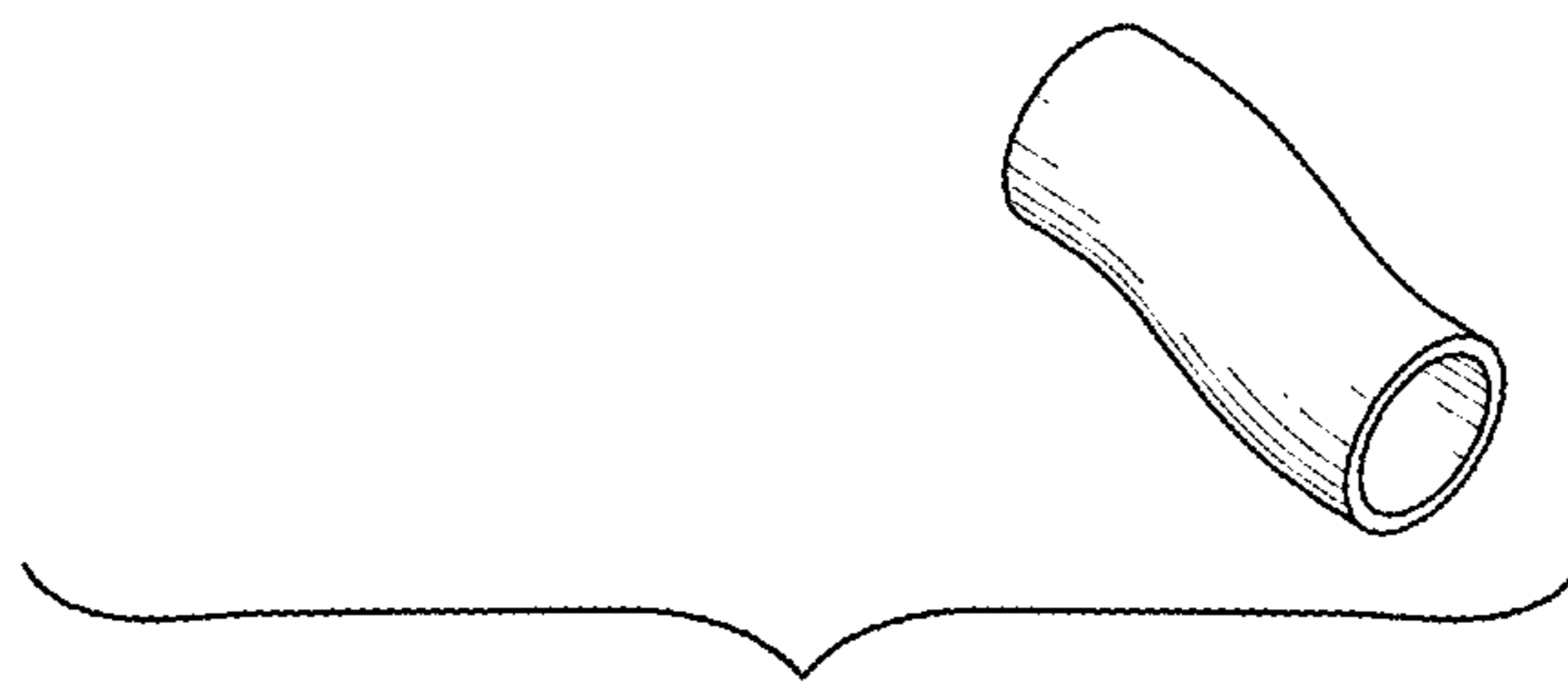
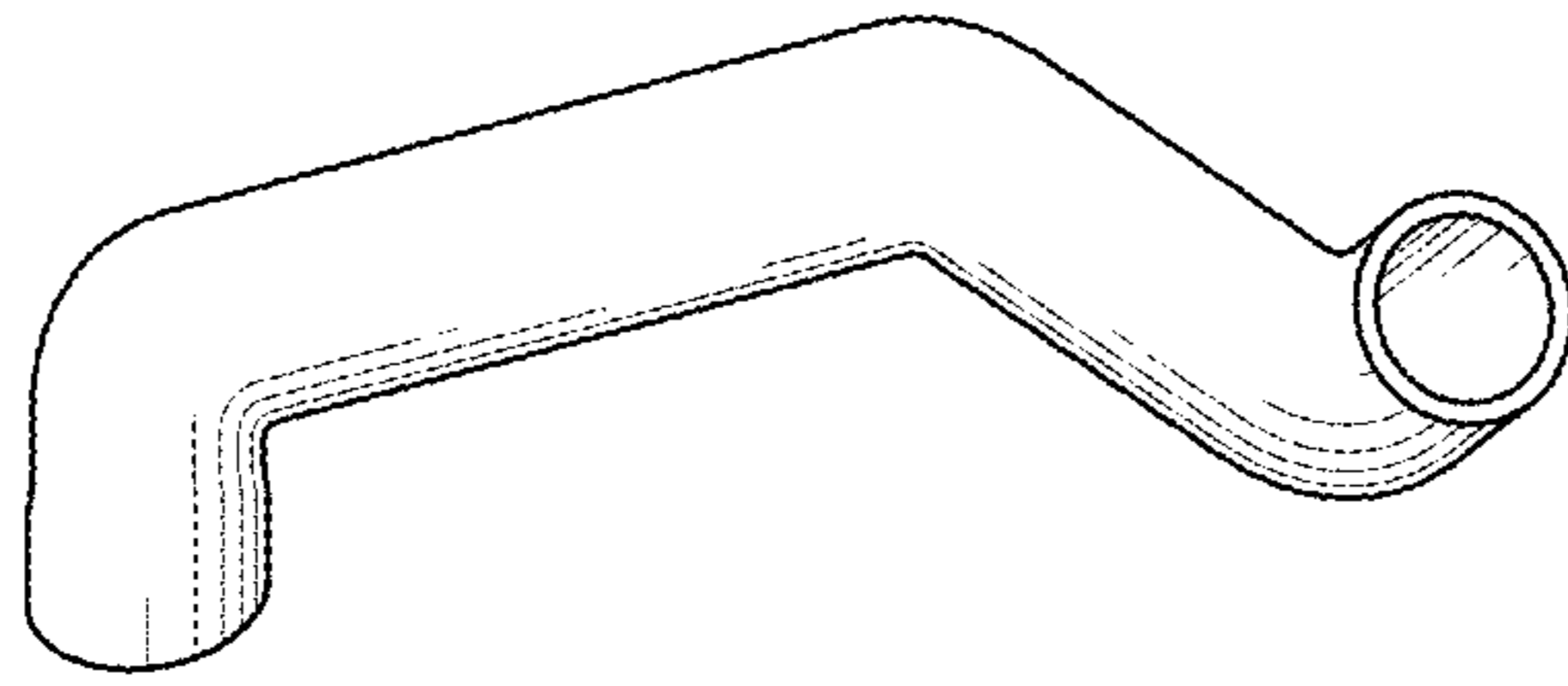

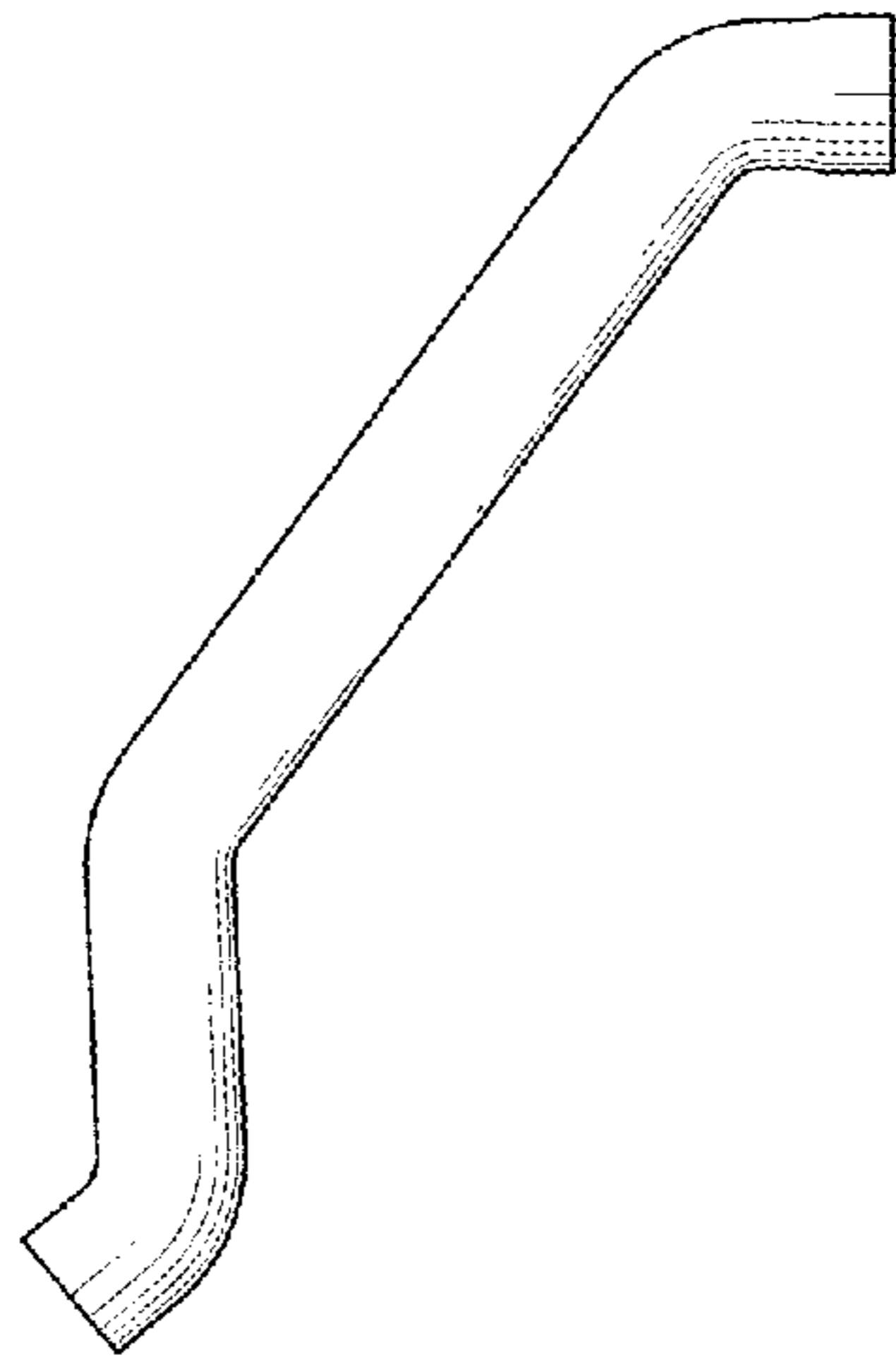

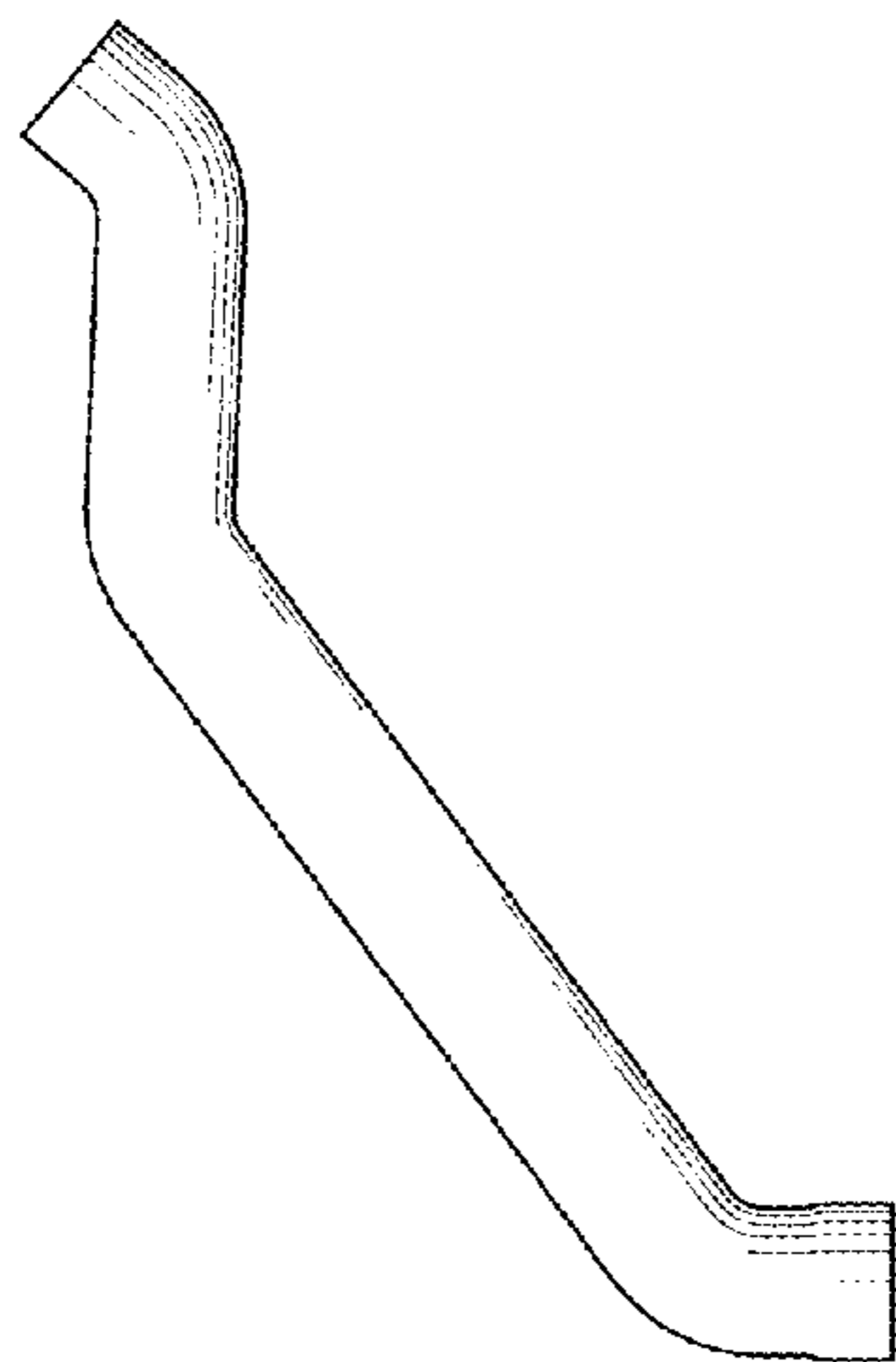

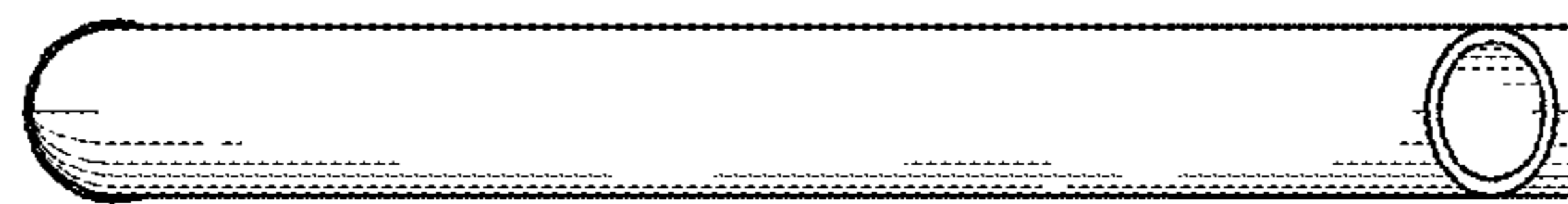
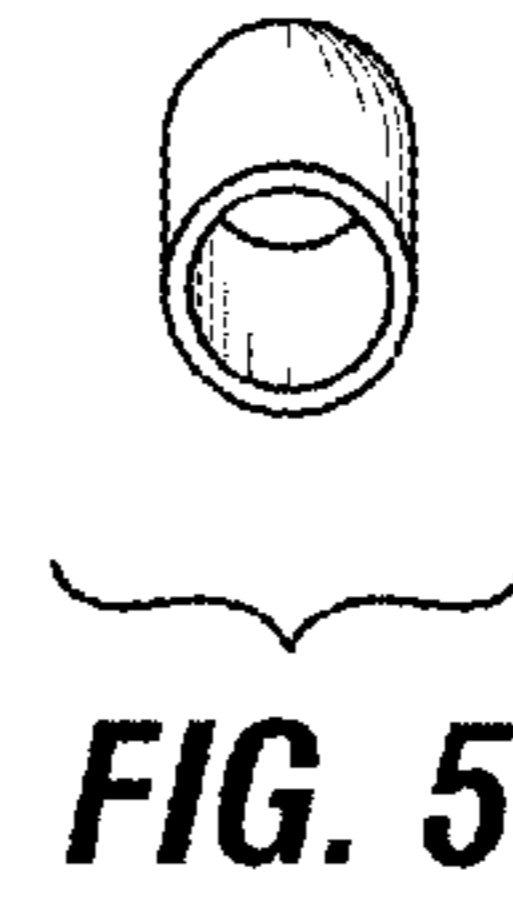
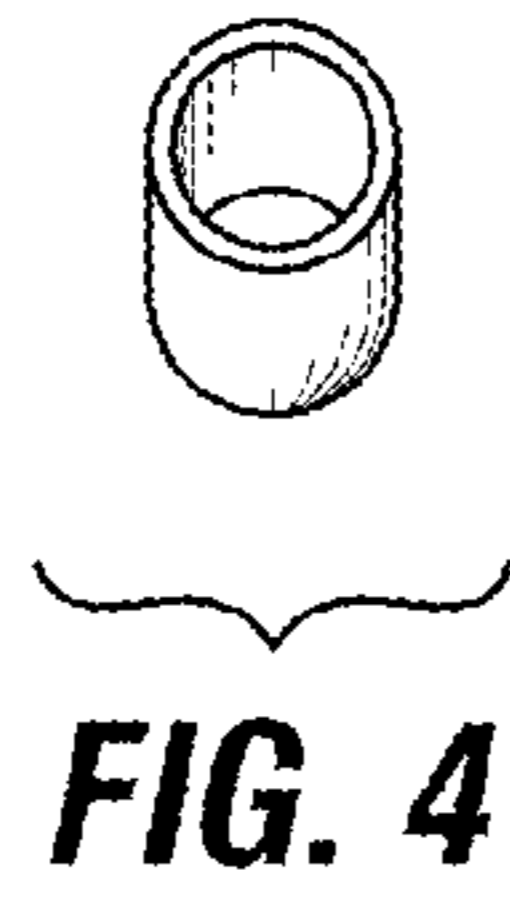
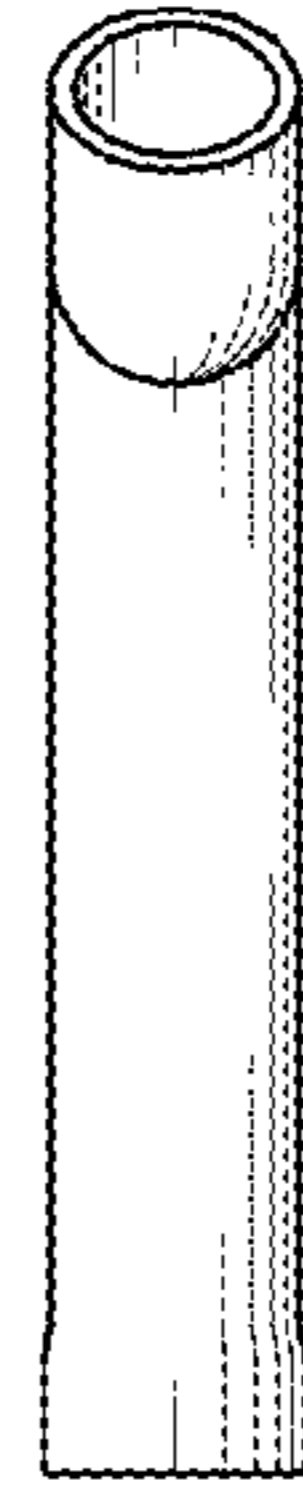
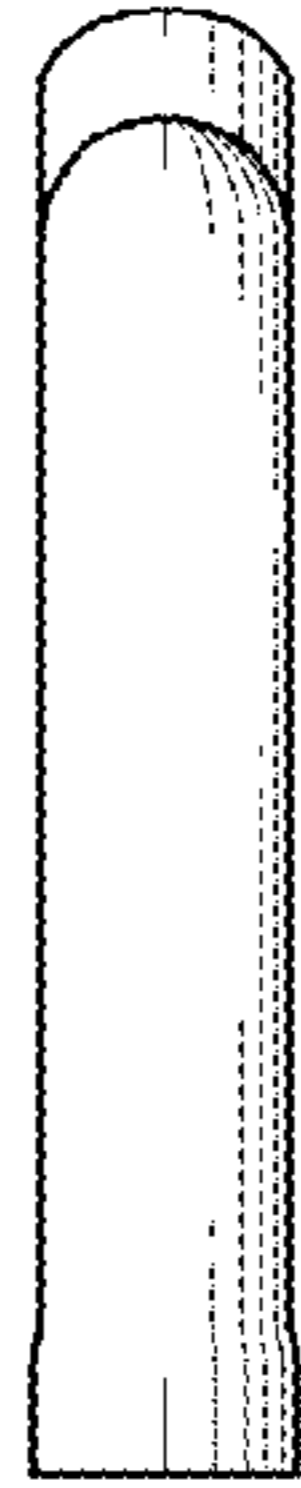

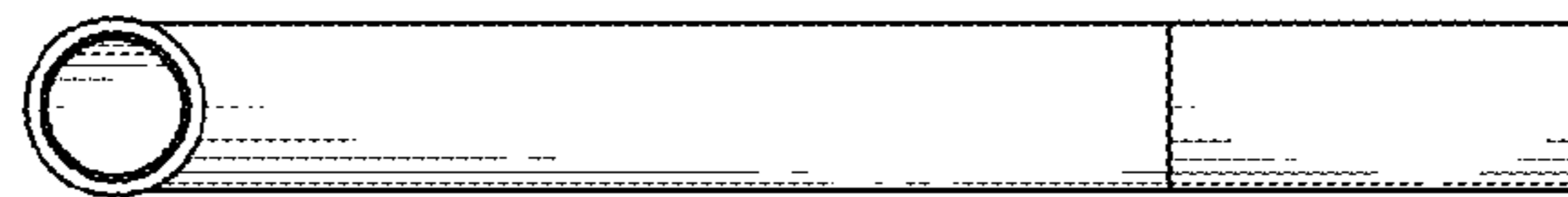

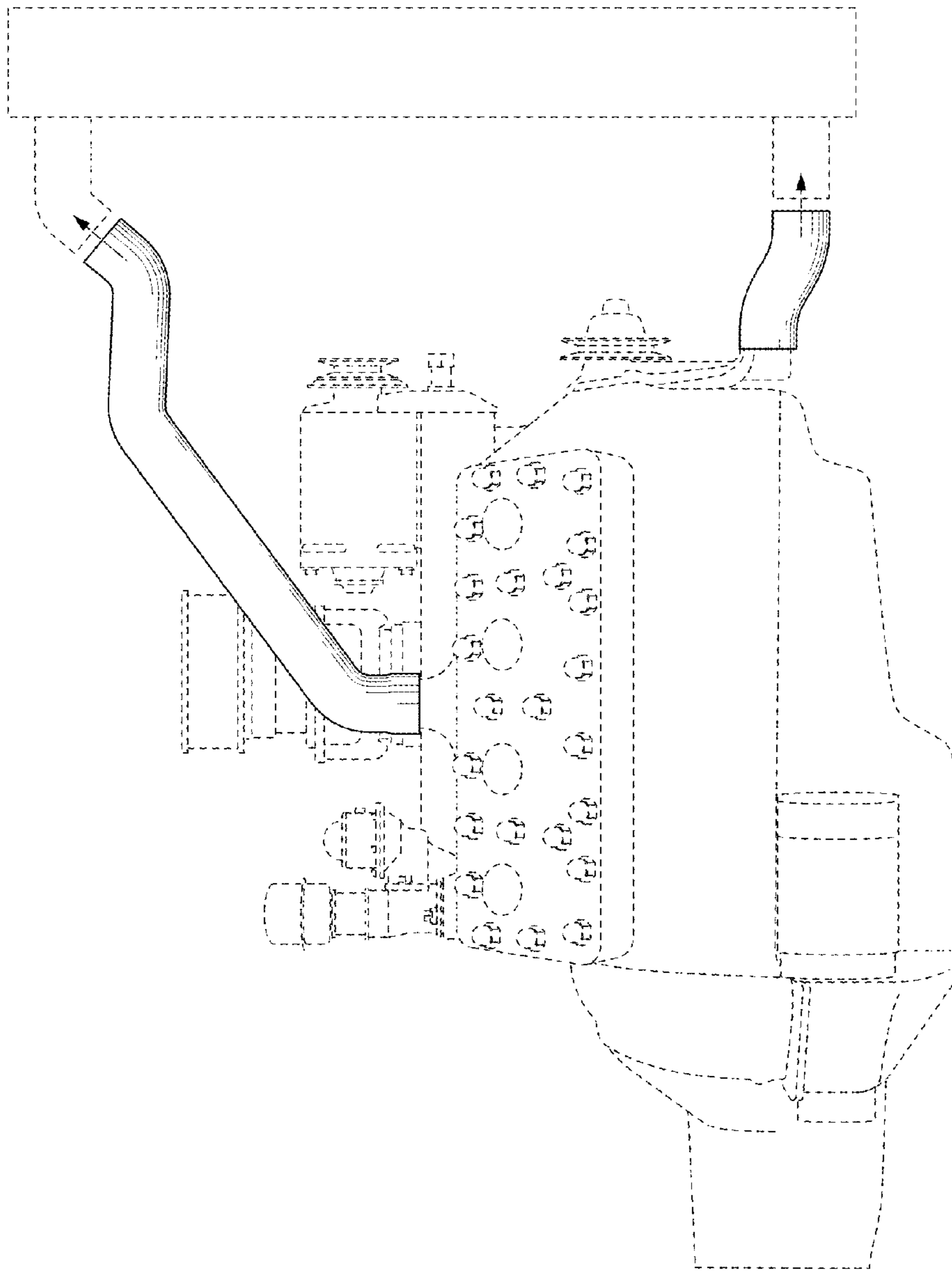
