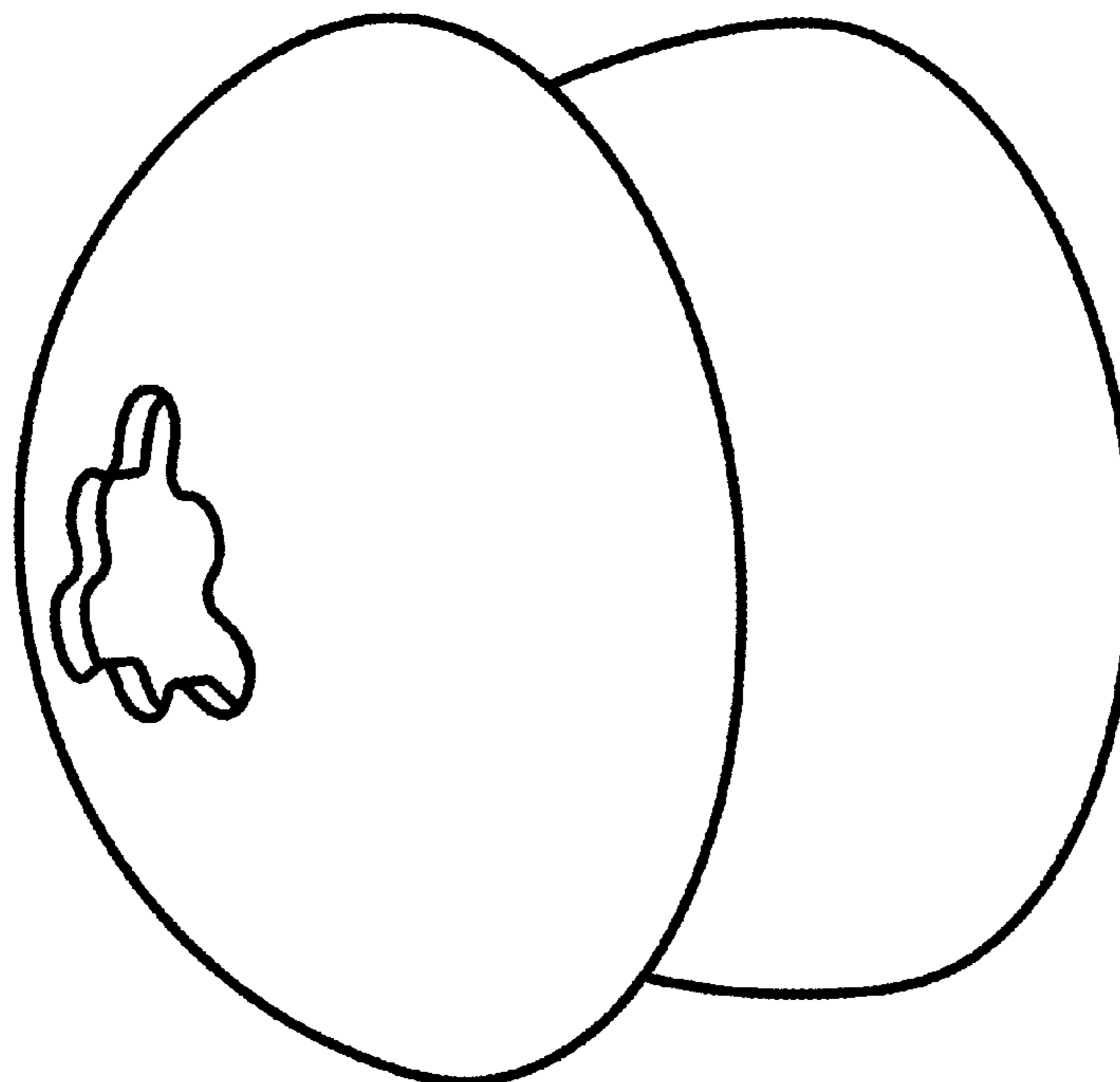
(57) **CLAIM**

The ornamental design for a mushroom form ear tip, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the mushroom form ear tip; FIG. 2 is a right side view of the mushroom form ear tip; FIG. 3 is a left side view of the mushroom form ear tip; FIG. 4 is a front view of the mushroom form ear tip; FIG. 5 is a back view of the mushroom form ear tip; and, FIG. 6 is a cross-section view of the mushroom form ear tip.

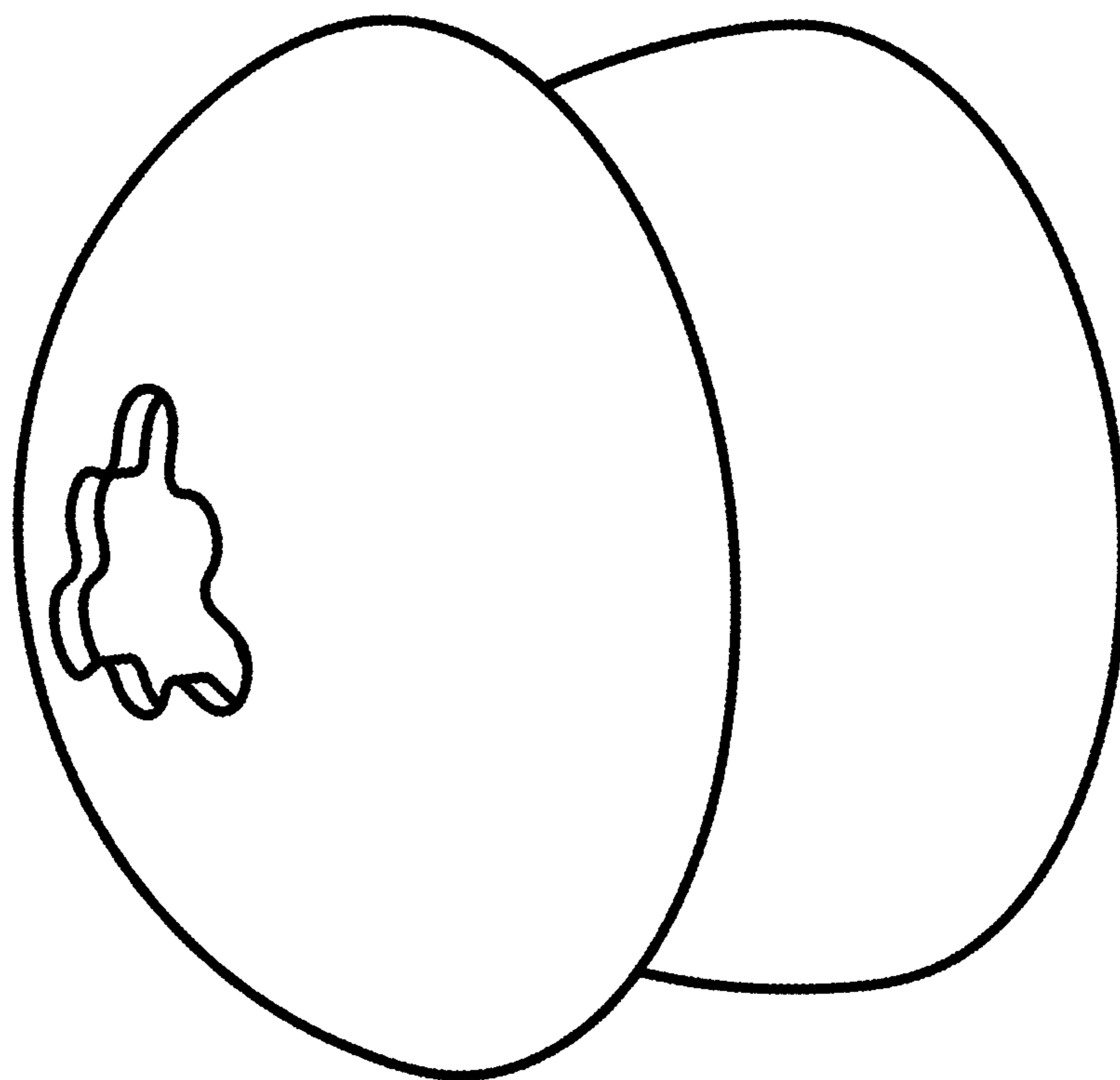

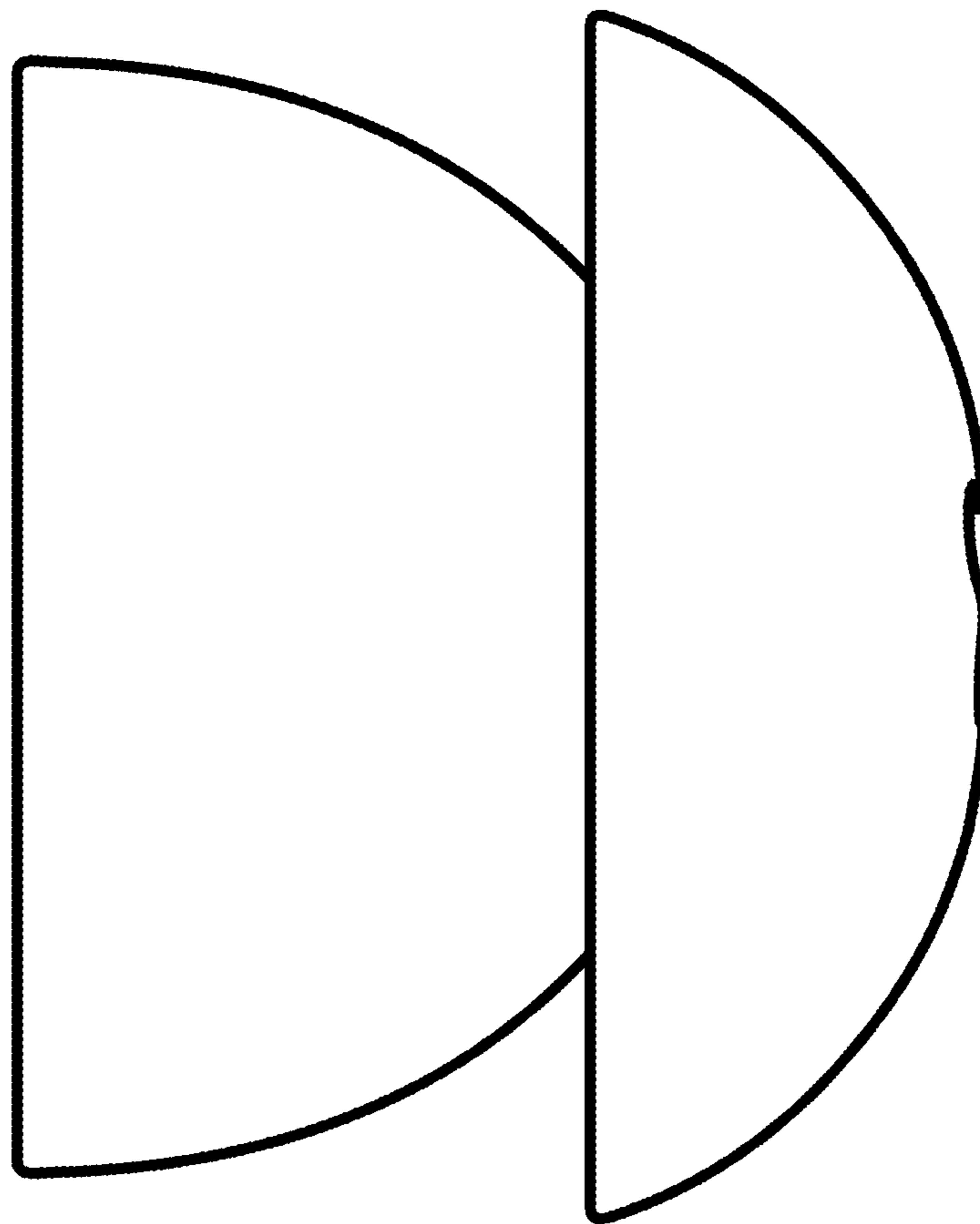

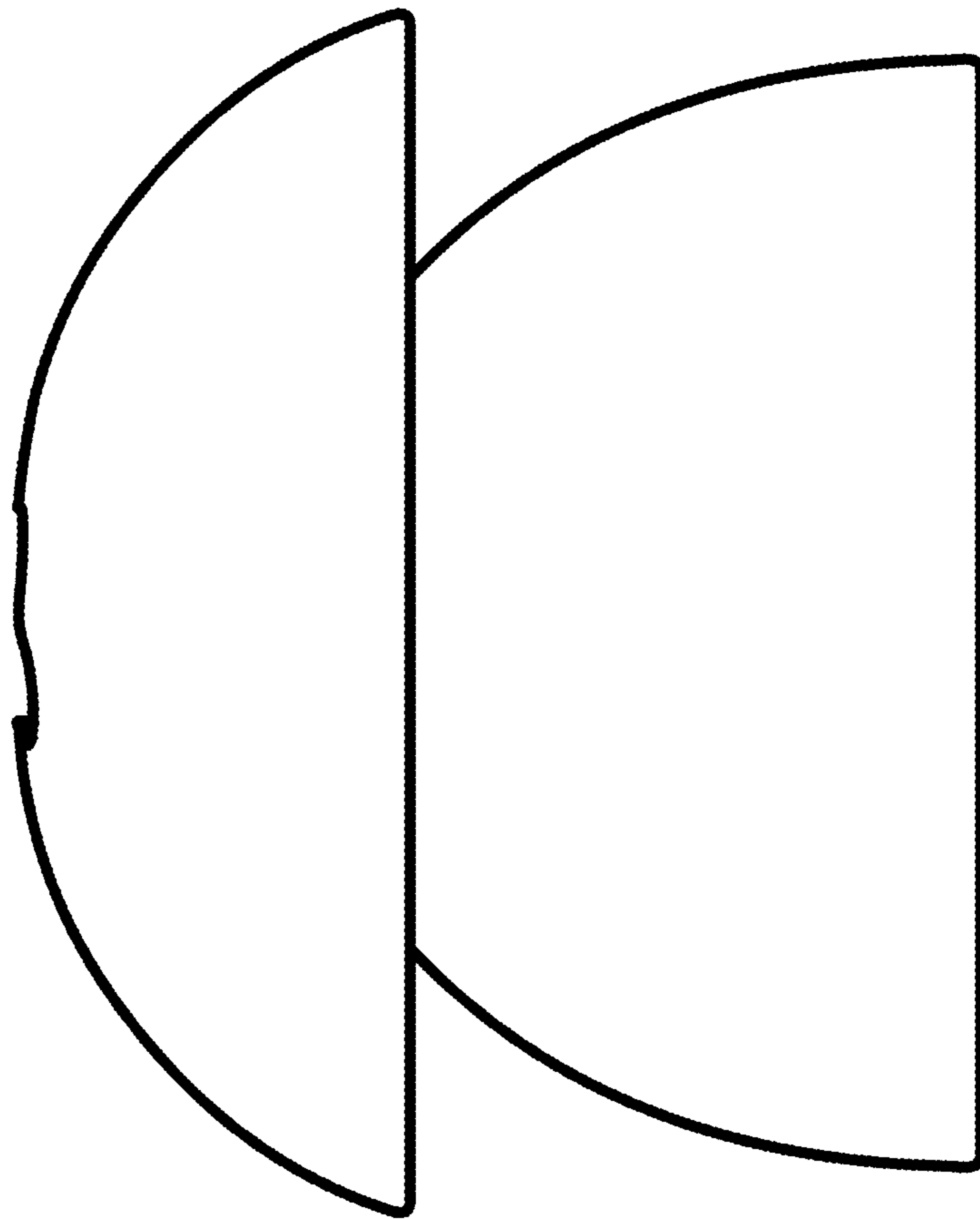

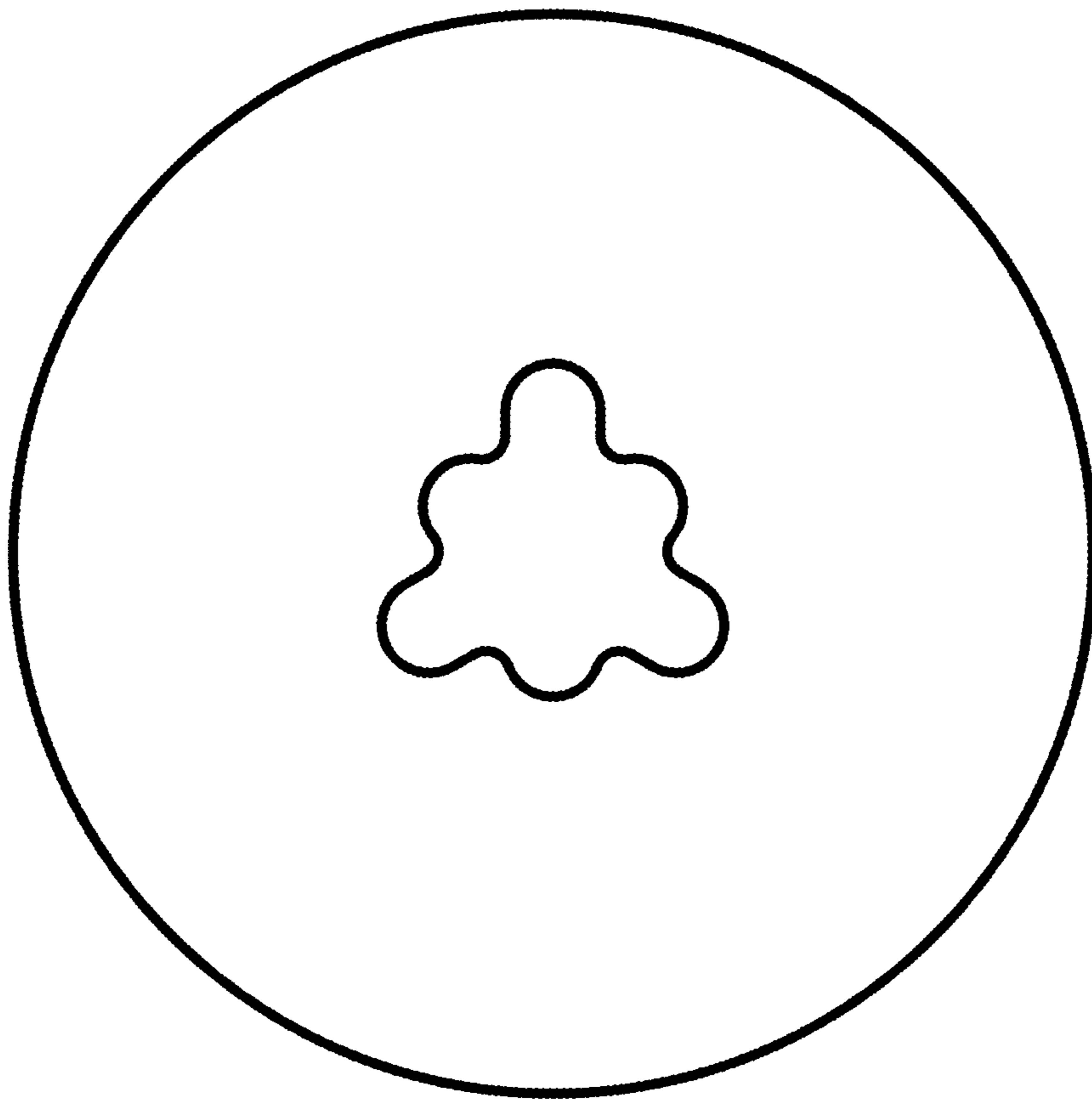

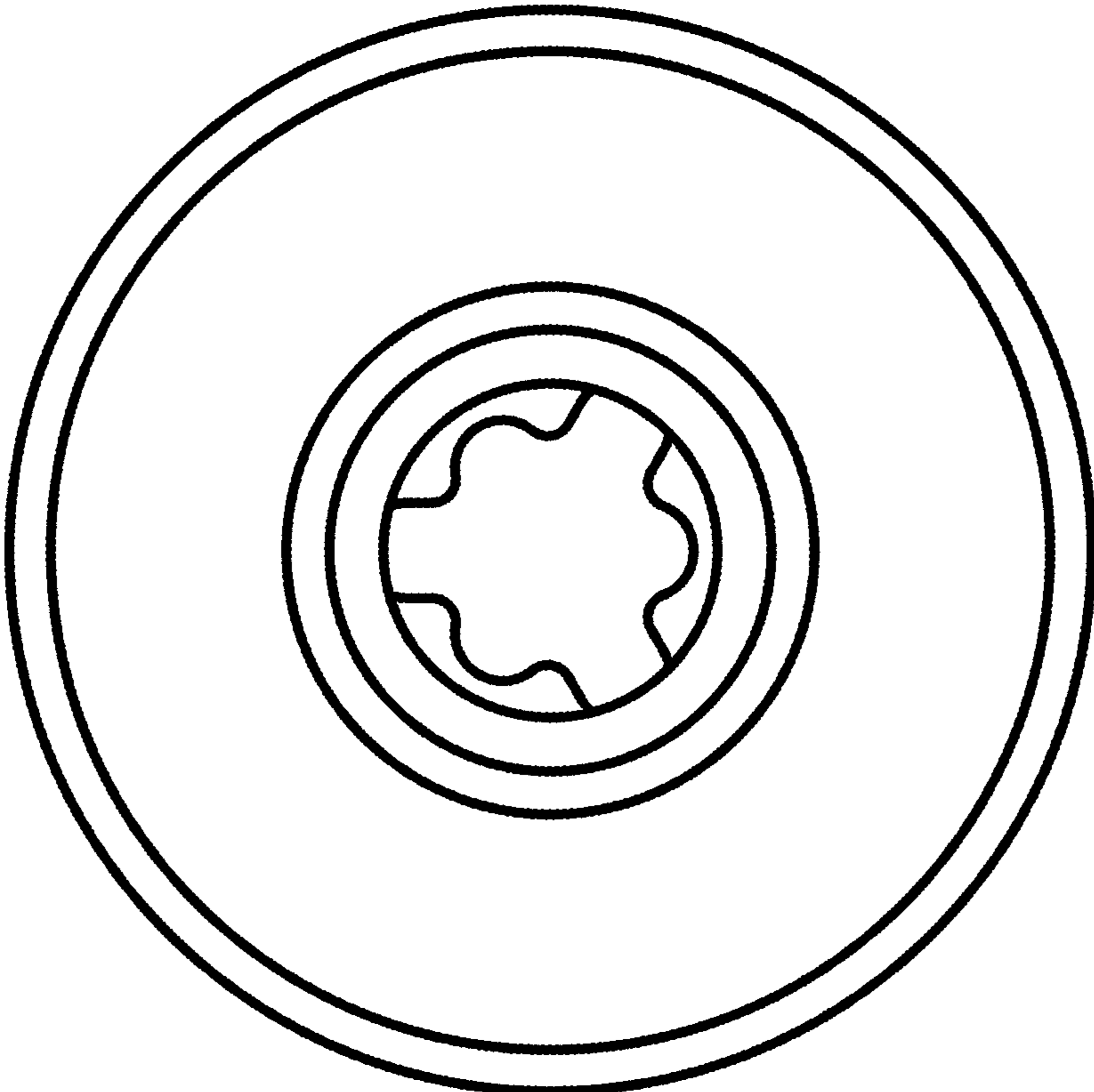

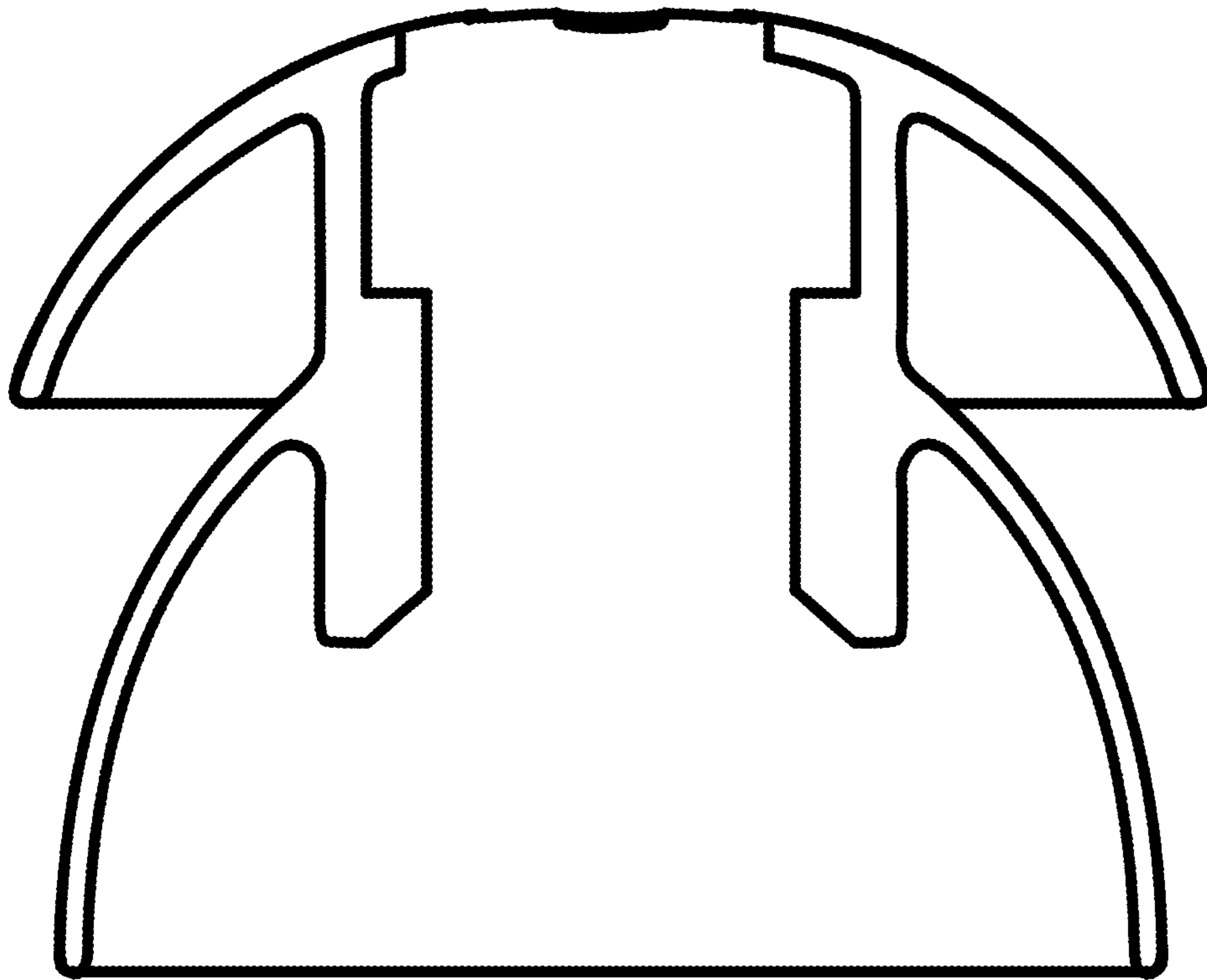
