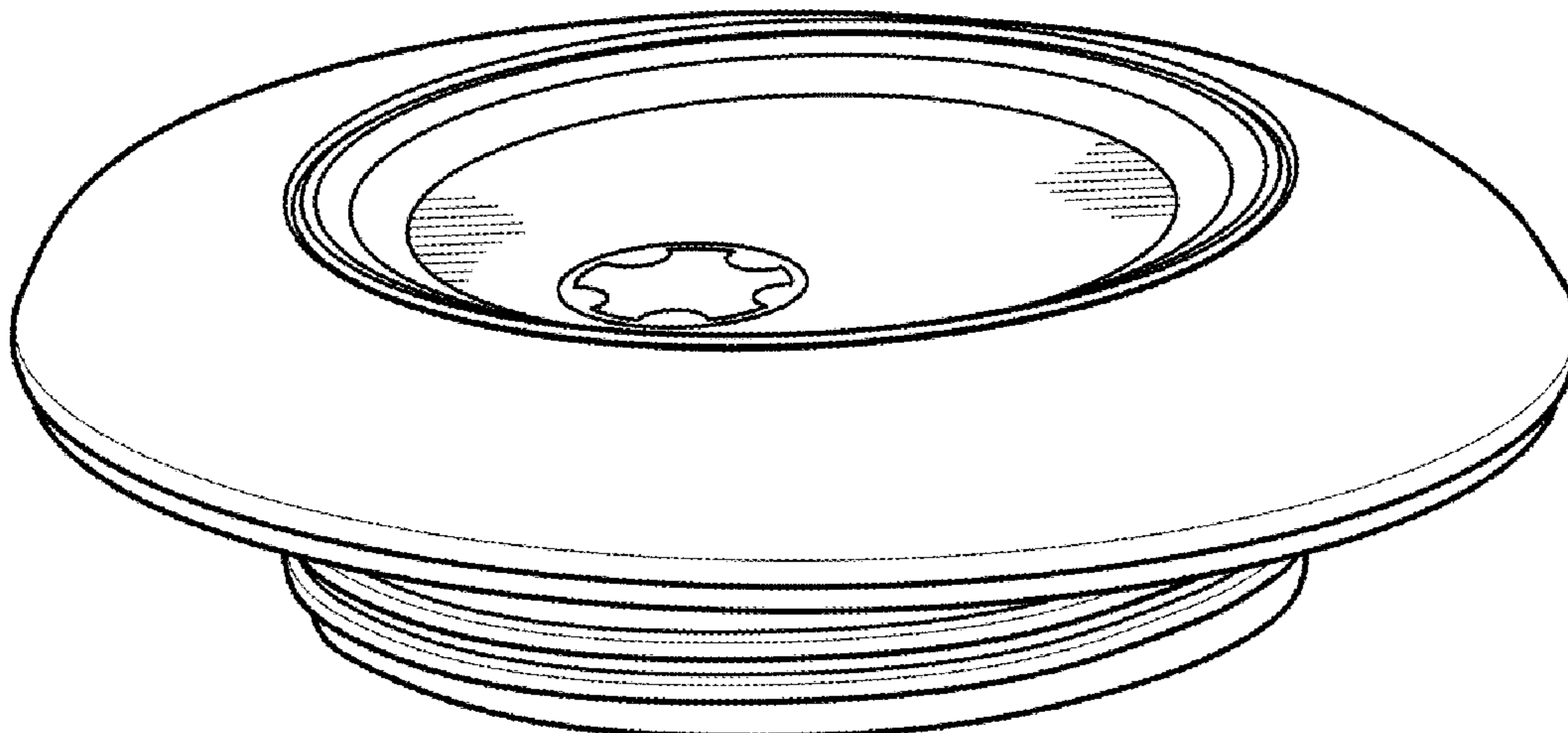
(57) **CLAIM**

The ornamental design for an ice bag cap, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of an ice bag cap; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; and, FIG. 4 is a side elevation view thereof. The broken lines shown in FIG. 3 illustrate portions of the ice bag cap that form no part of the claimed design.

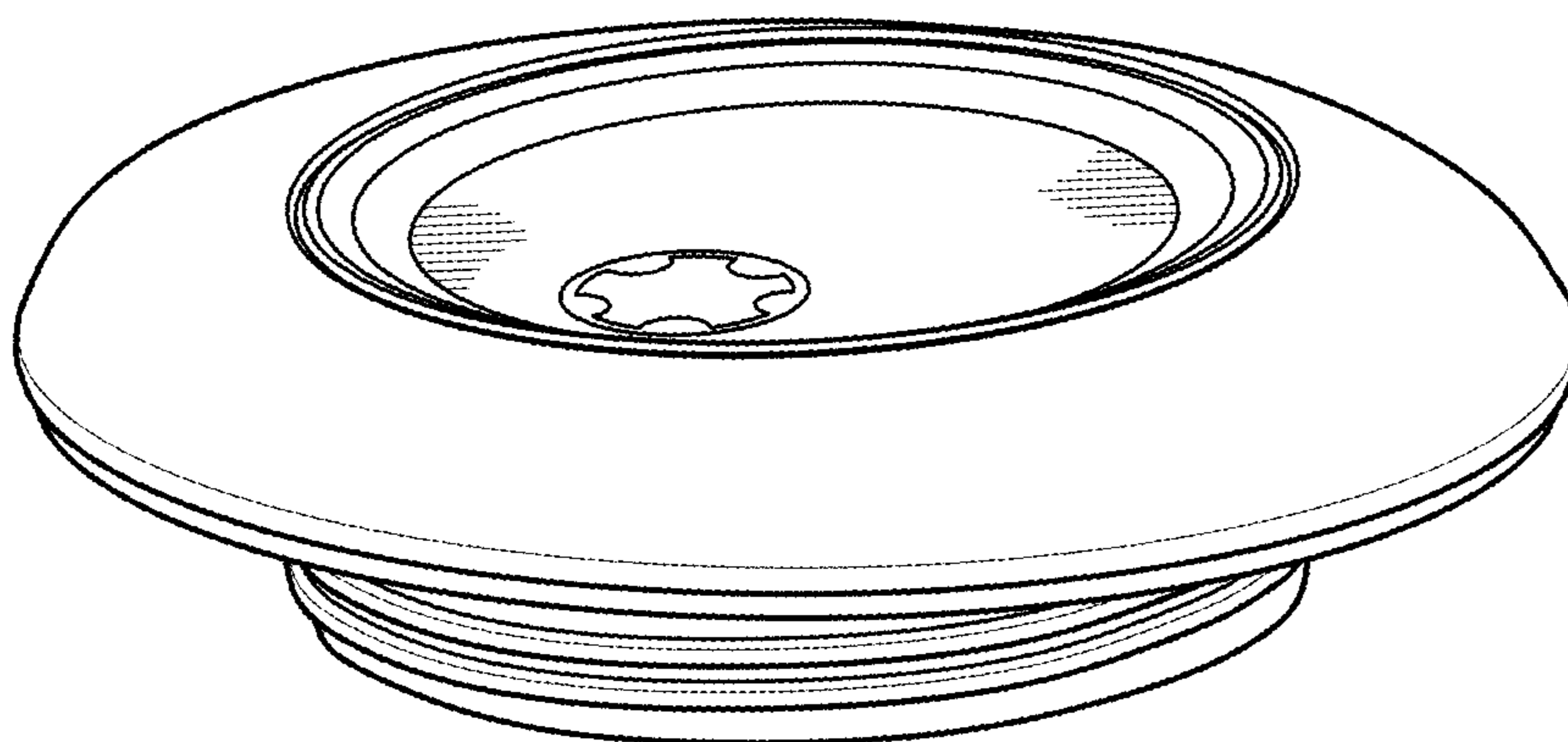

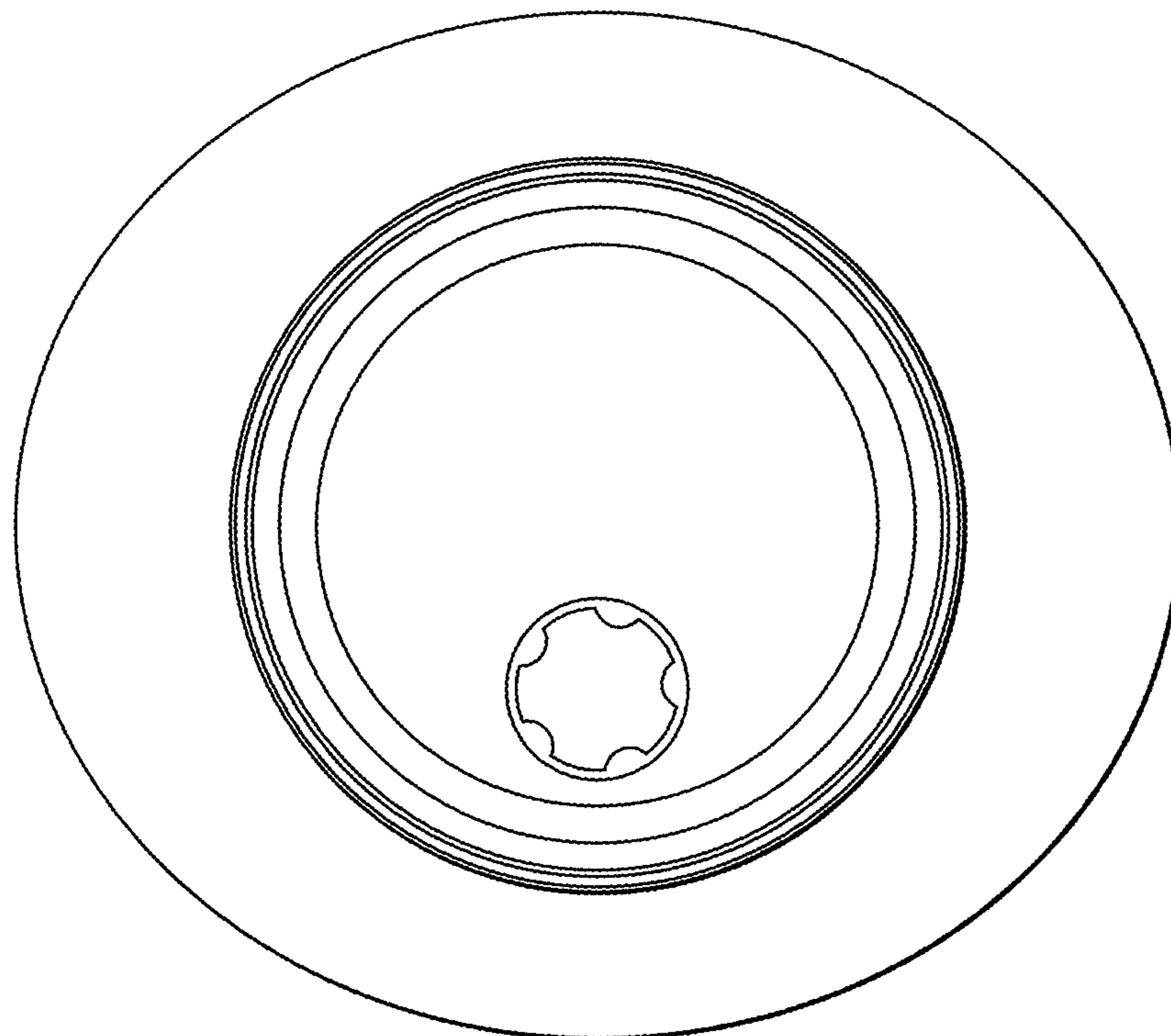

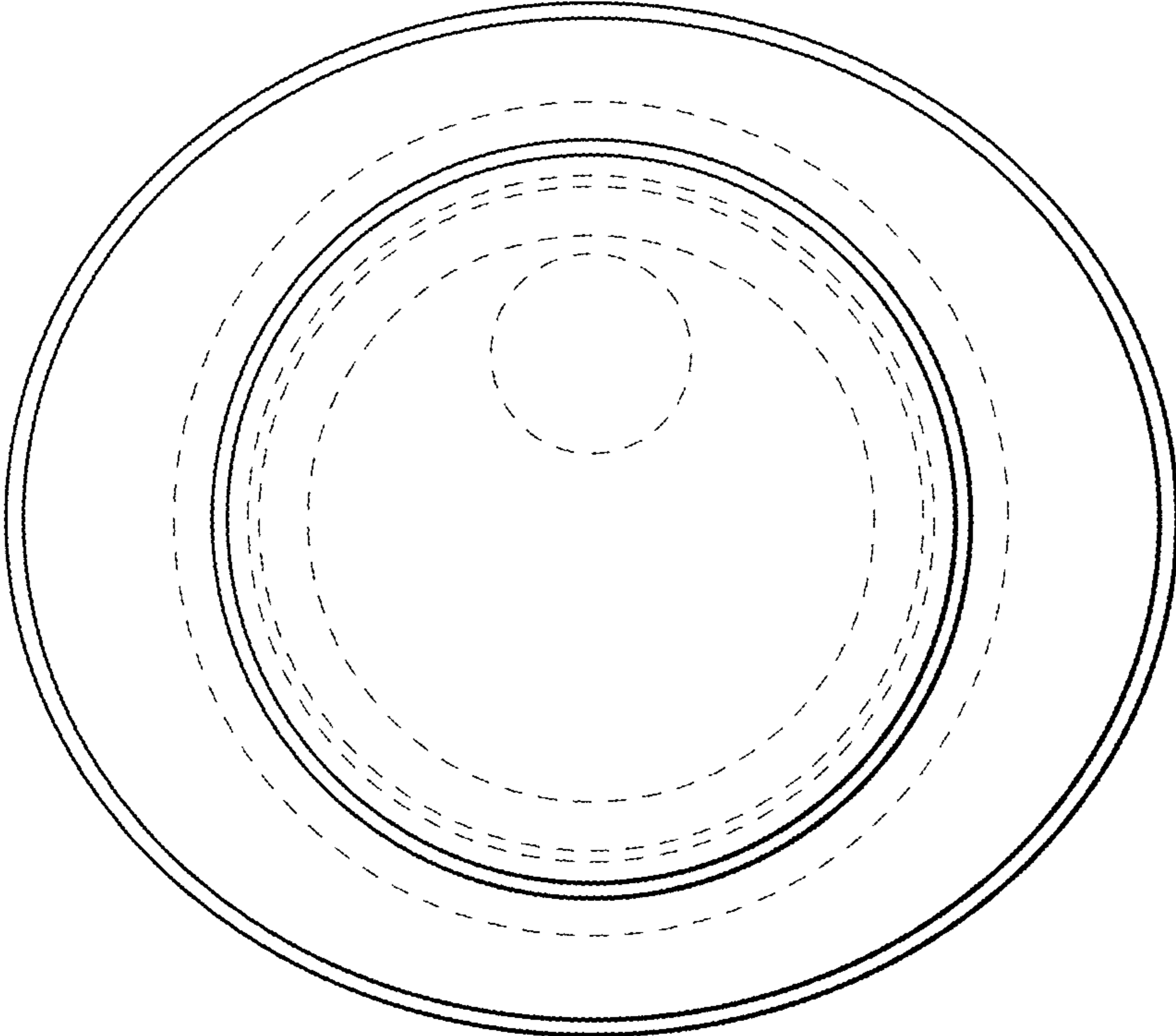

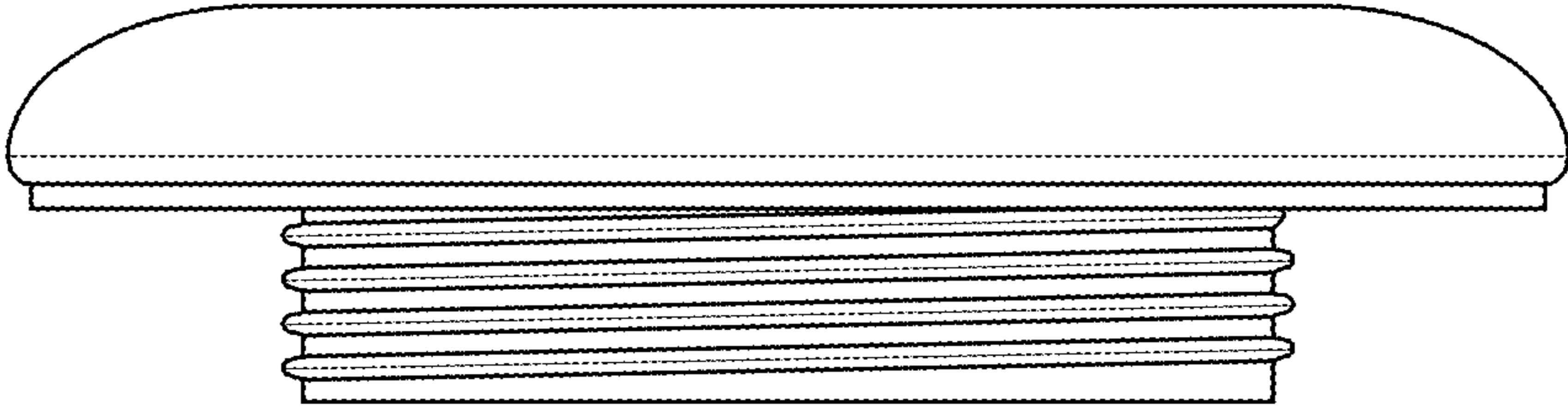
