DESCRIPTION

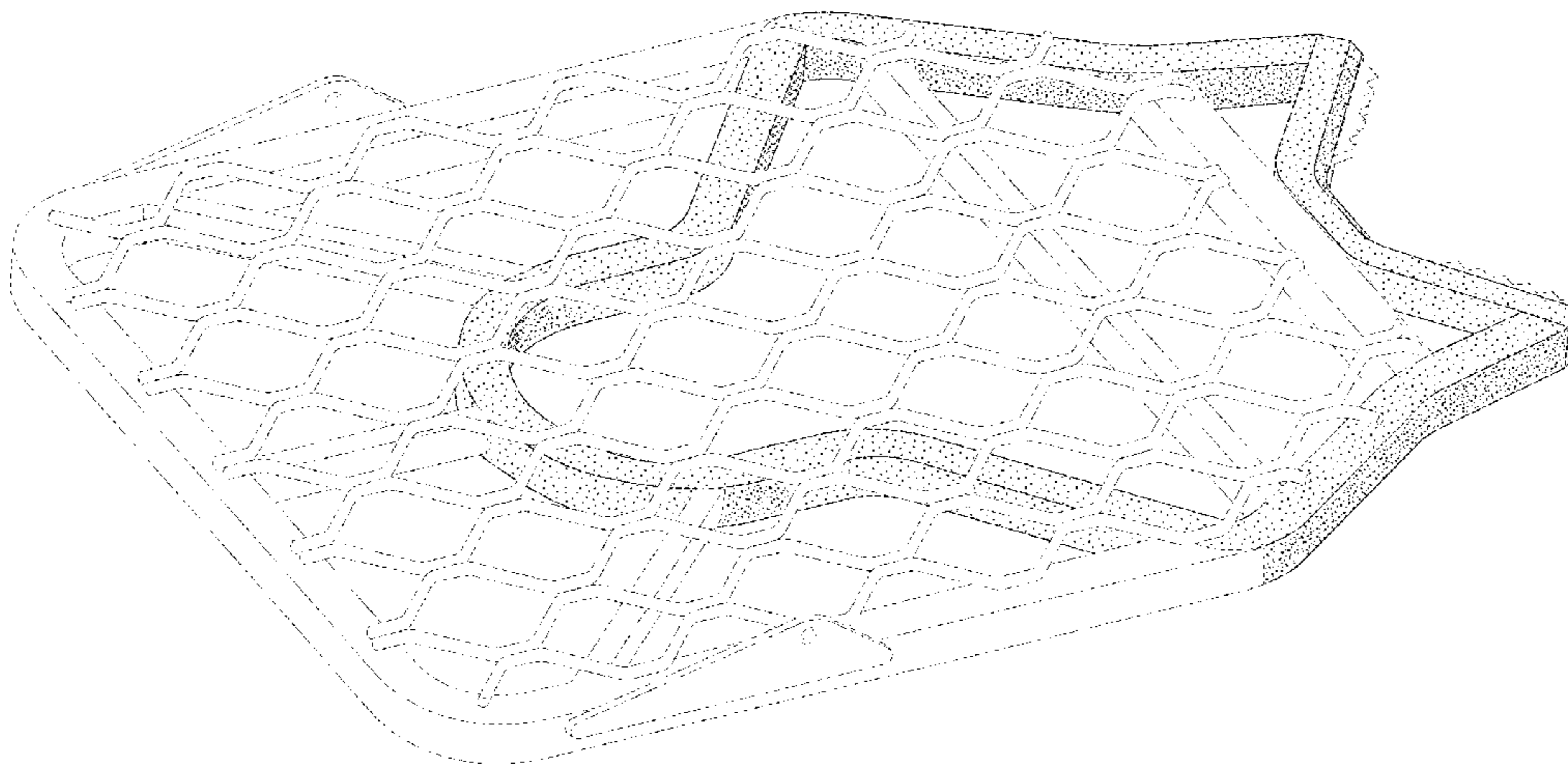
FIG. 1 is a perspective view of the treestand frame element embodying the new design;
FIG. 2 is a top view thereof;
FIG. 3 is a bottom view thereof;
FIG. 4 is a right side view thereof, the left side being a mirror image thereof;
FIG. 5 is a rear view thereof; and,
FIG. 6 is a front view thereof.
FIGS. 1-6 show features of a treestand frame element in phantom lines. These features are shown for environmental purposes and do not form any part of the claimed design. Further, the phantom lines immediately adjacent the solid-line portions of the design form the boundary of the design, with the phantom lines forming no part of the claimed design.

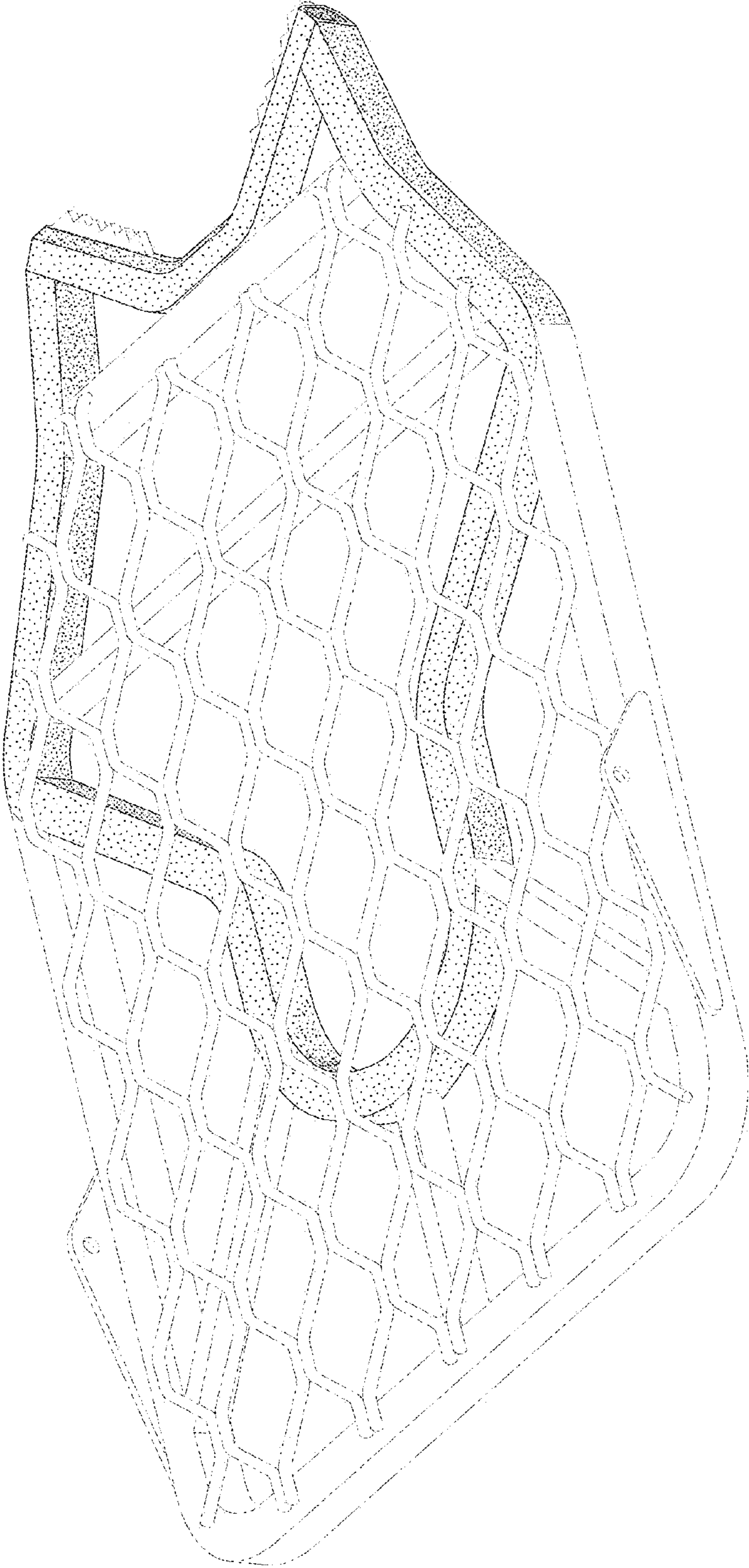

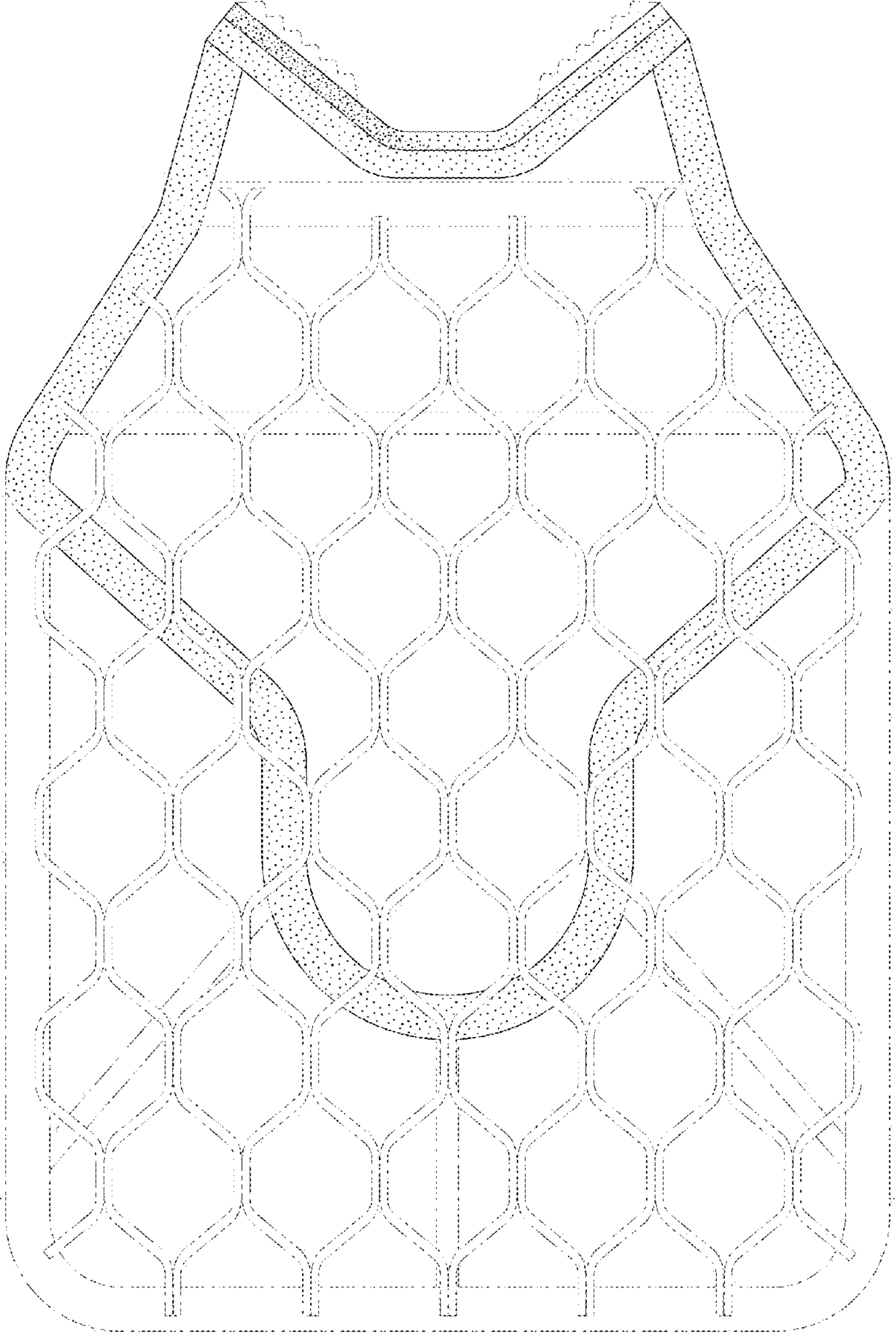

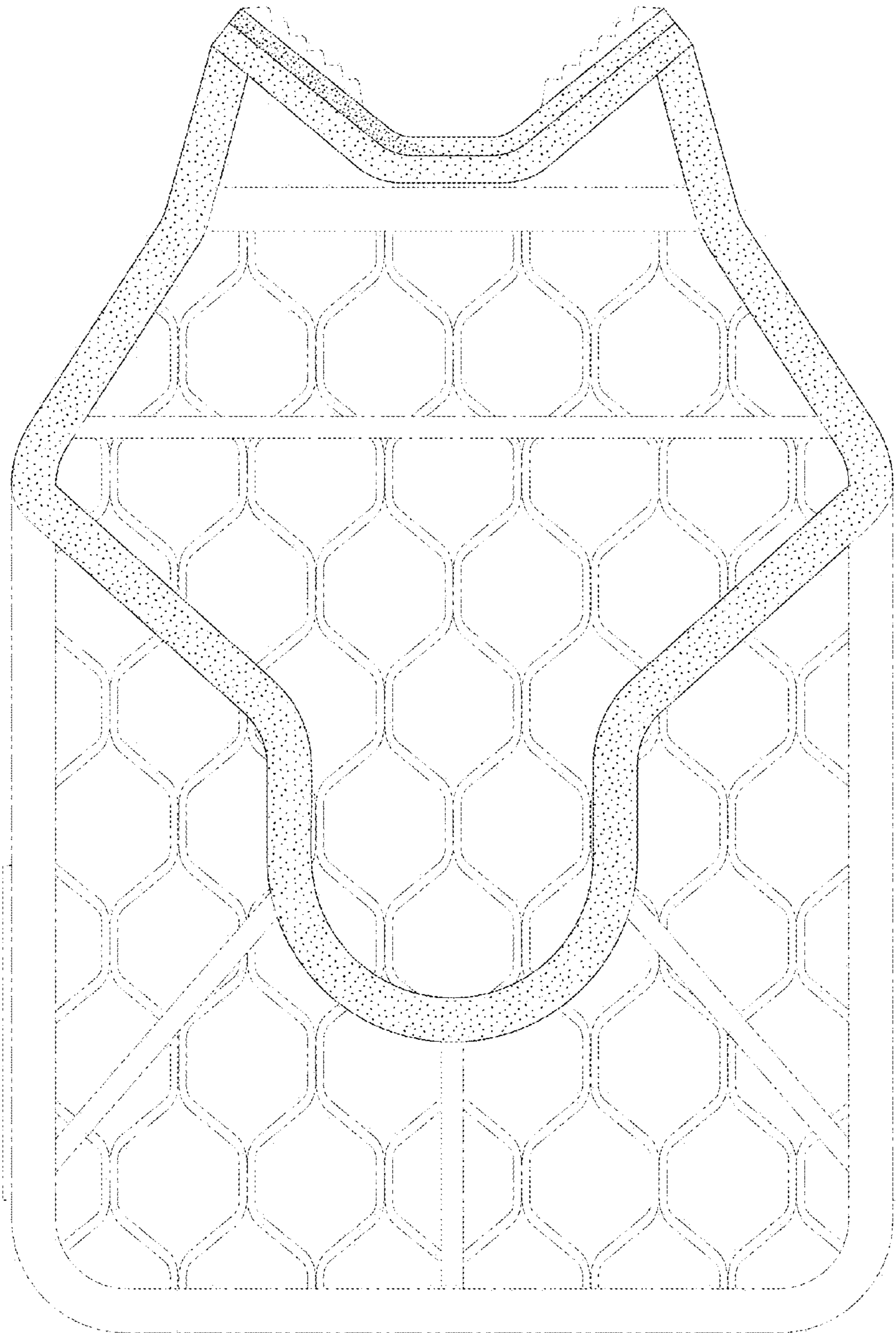

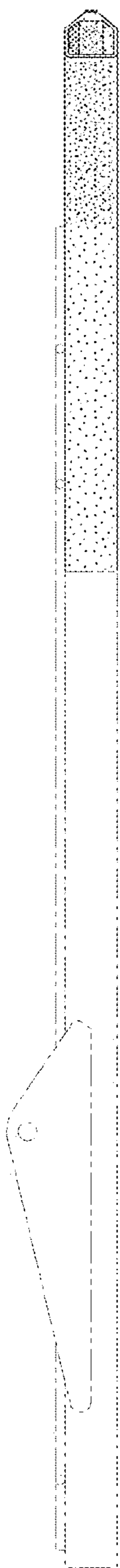

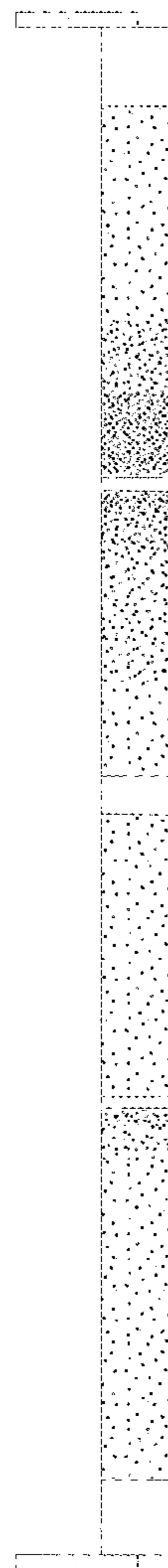
