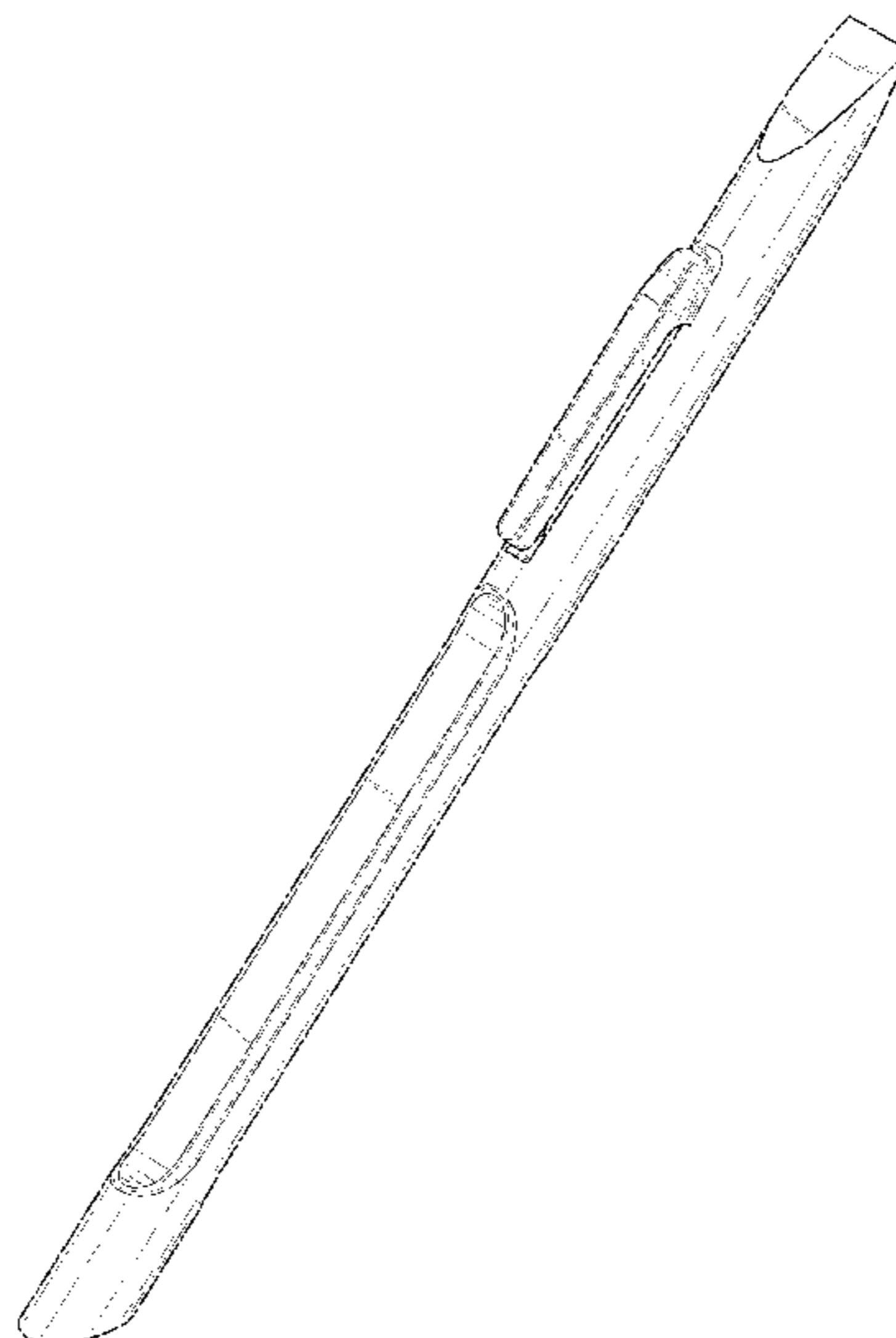
(57) **CLAIM**

The ornamental design for a scraper, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, right perspective view of a scraper showing my new design;  
 FIG. 2 is a bottom view thereof;  
 FIG. 3 is a top view thereof;  
 FIG. 4 is a left side view thereof, the right side view being a mirror image;  
 FIG. 5 is a front view thereof; and,  
 FIG. 6 is a rear view thereof.  
 The drawings include surface shading that represents contour and not surface ornamentation.  
 The broken lines illustrate structure or features which form no part of the claimed design.

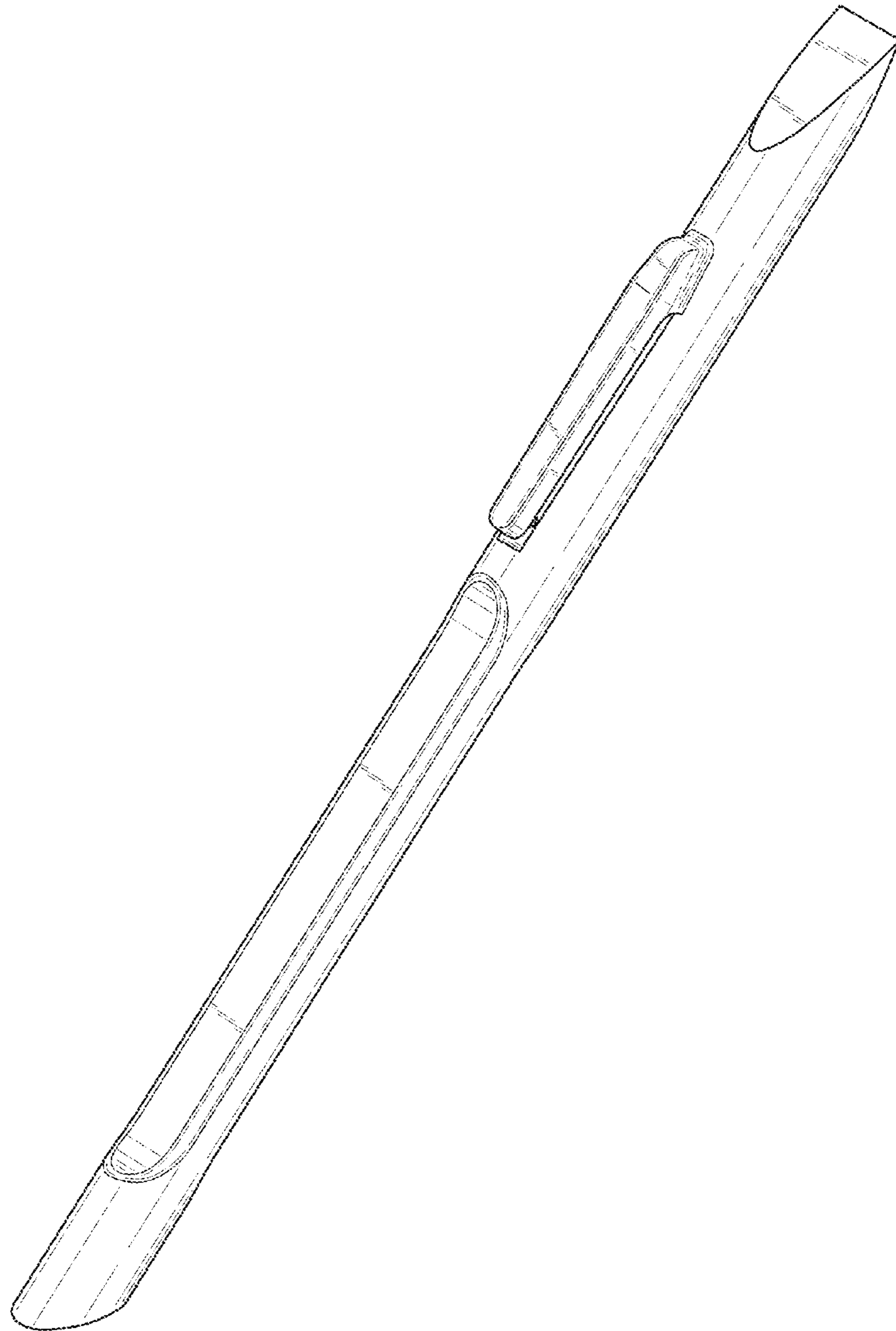

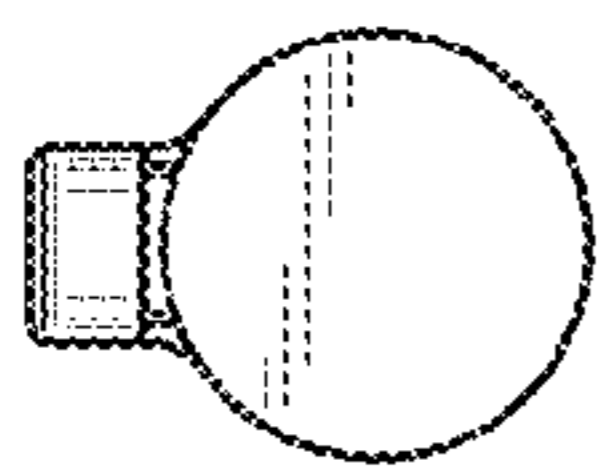

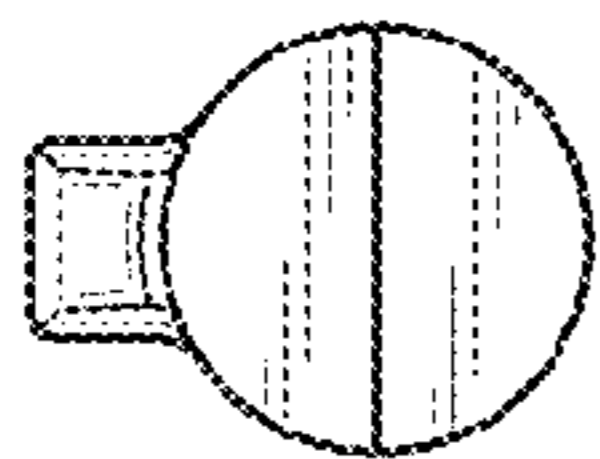

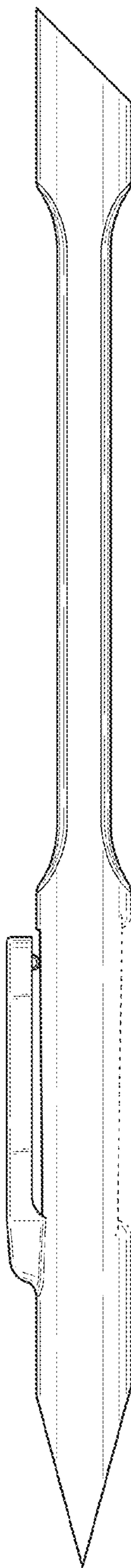
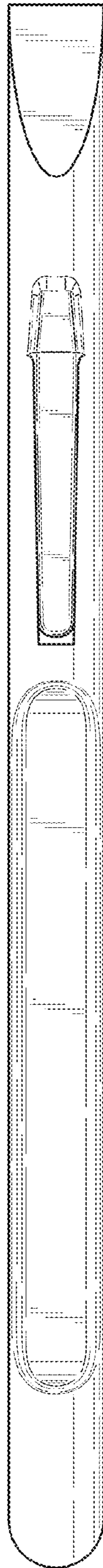
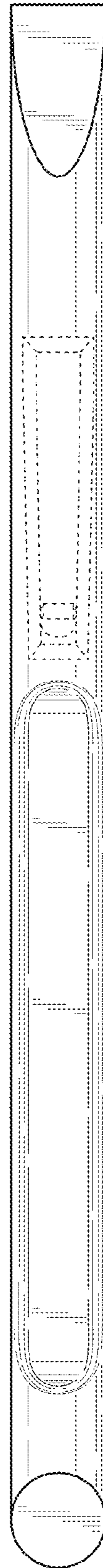
