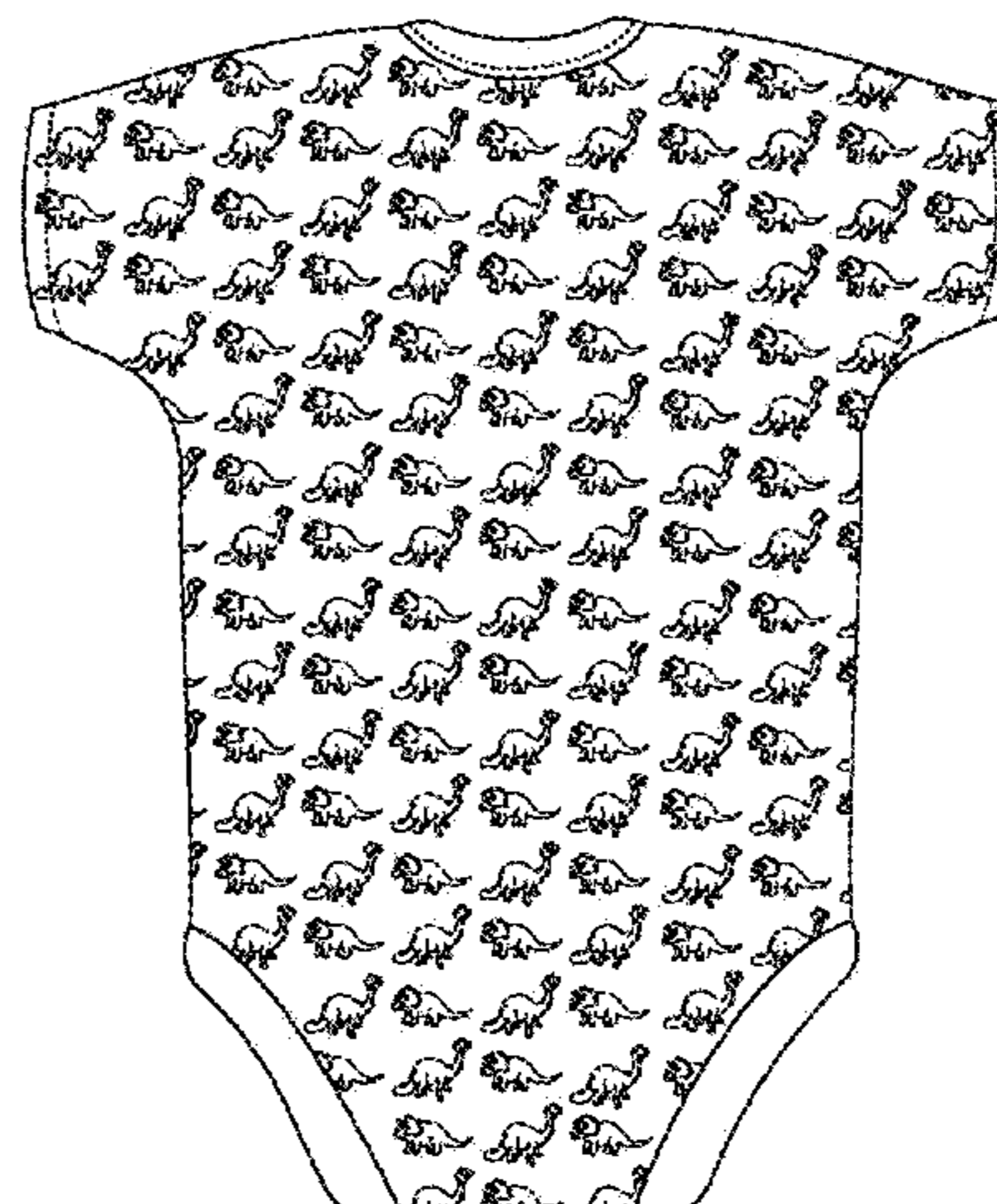
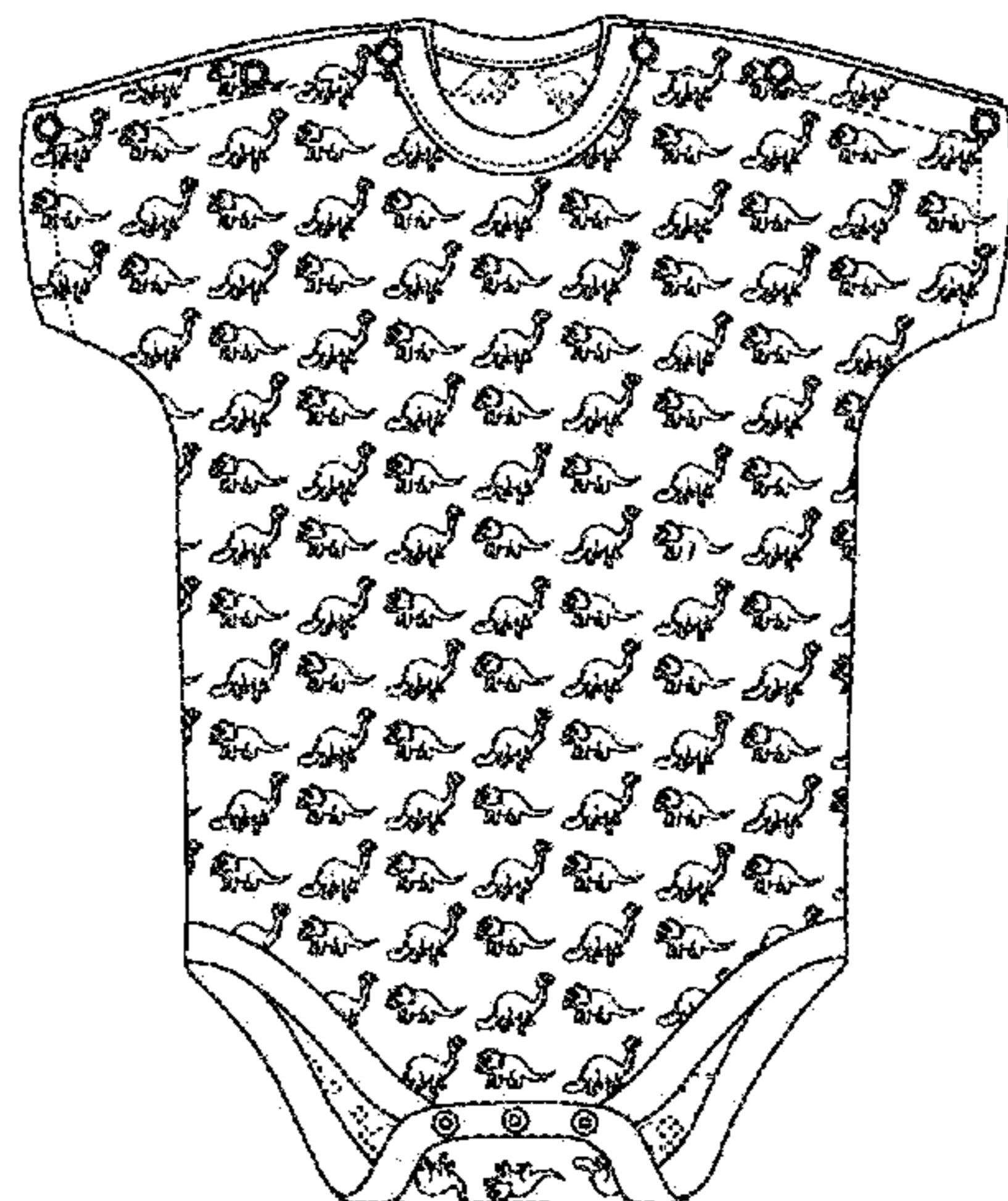
(57) **CLAIM**

The ornamental design for an infant body suit, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of an infant body suit showing my new design;
FIG. 2 is a front elevational view thereof after the right and left shoulder buttons have been unsnapped;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a front elevational detail view thereof, showing the left and right shoulder;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a left side elevational view thereof;
FIG. 7 is a top plan view thereof; and,
FIG. 8 is a bottom plan view thereof.
The broken lines shown in the drawings are lines of stitching and form part of the claimed design.

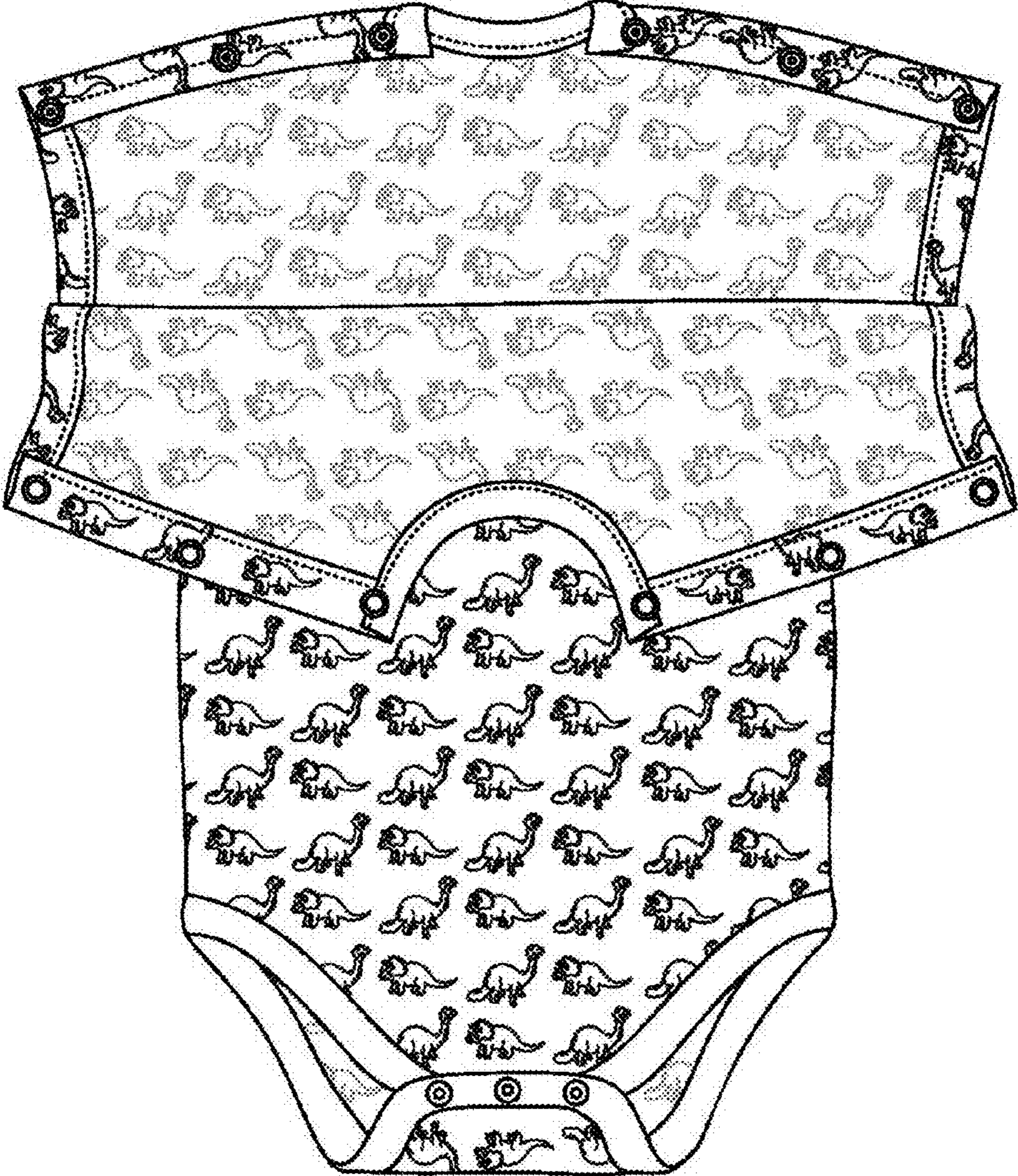

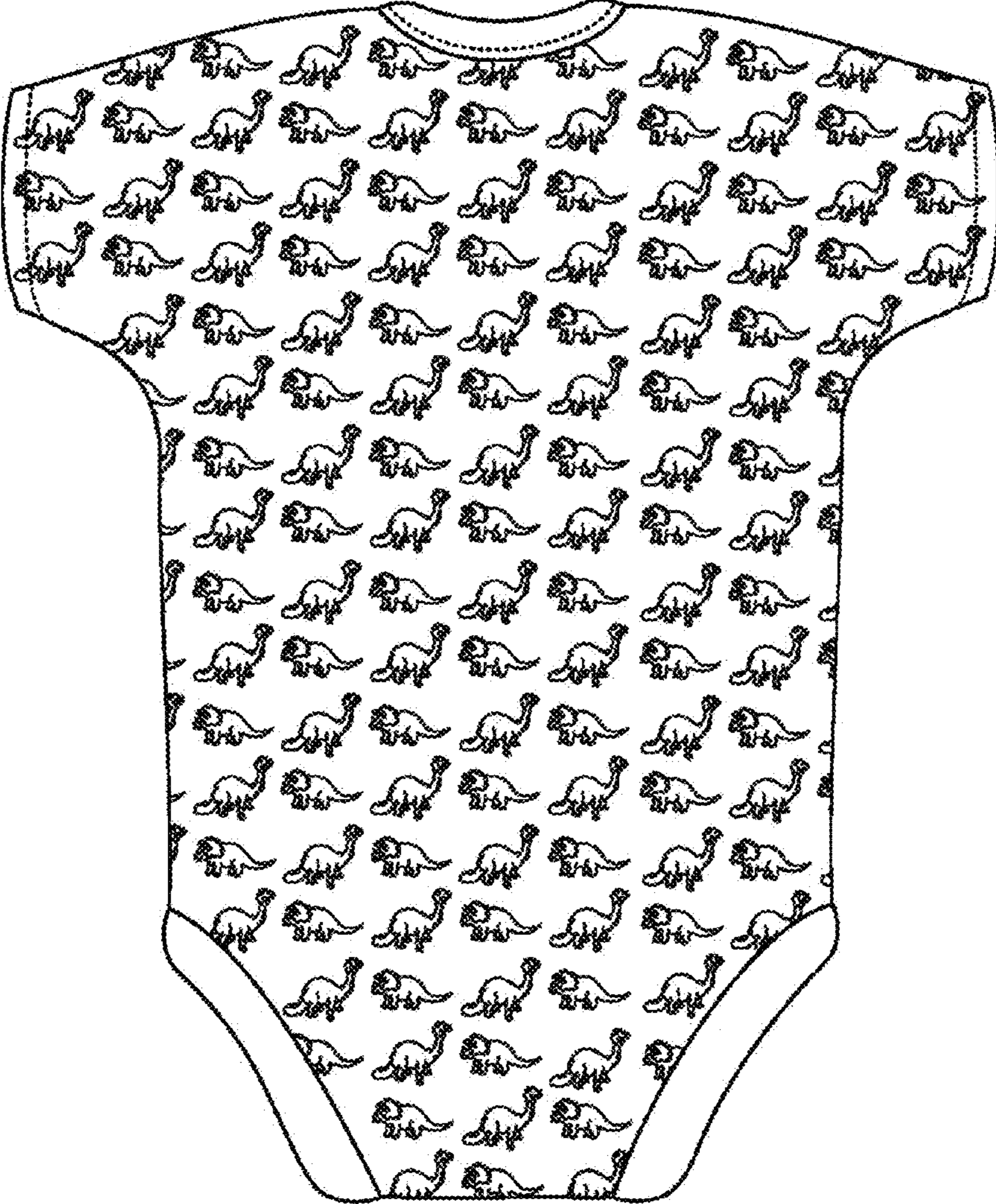

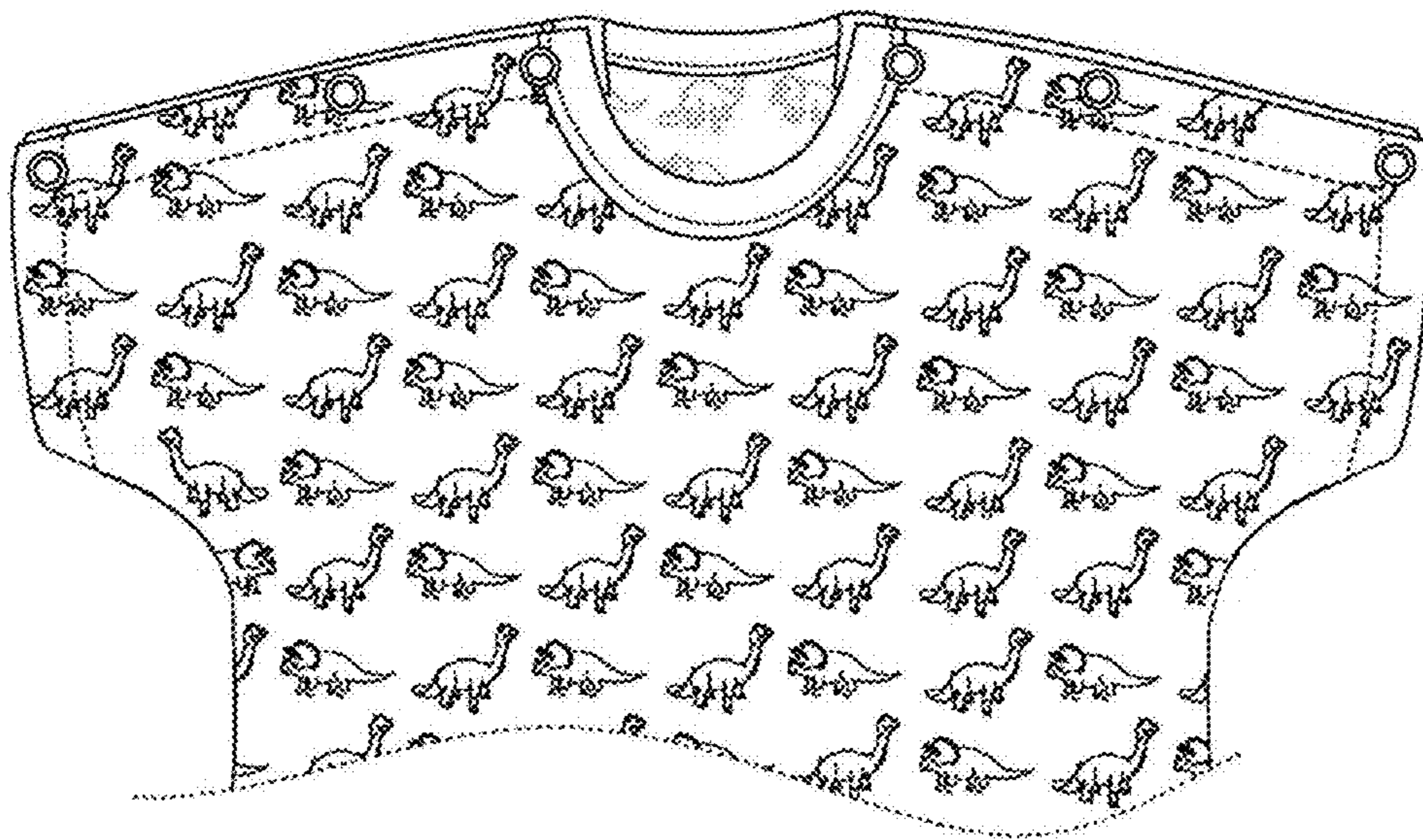

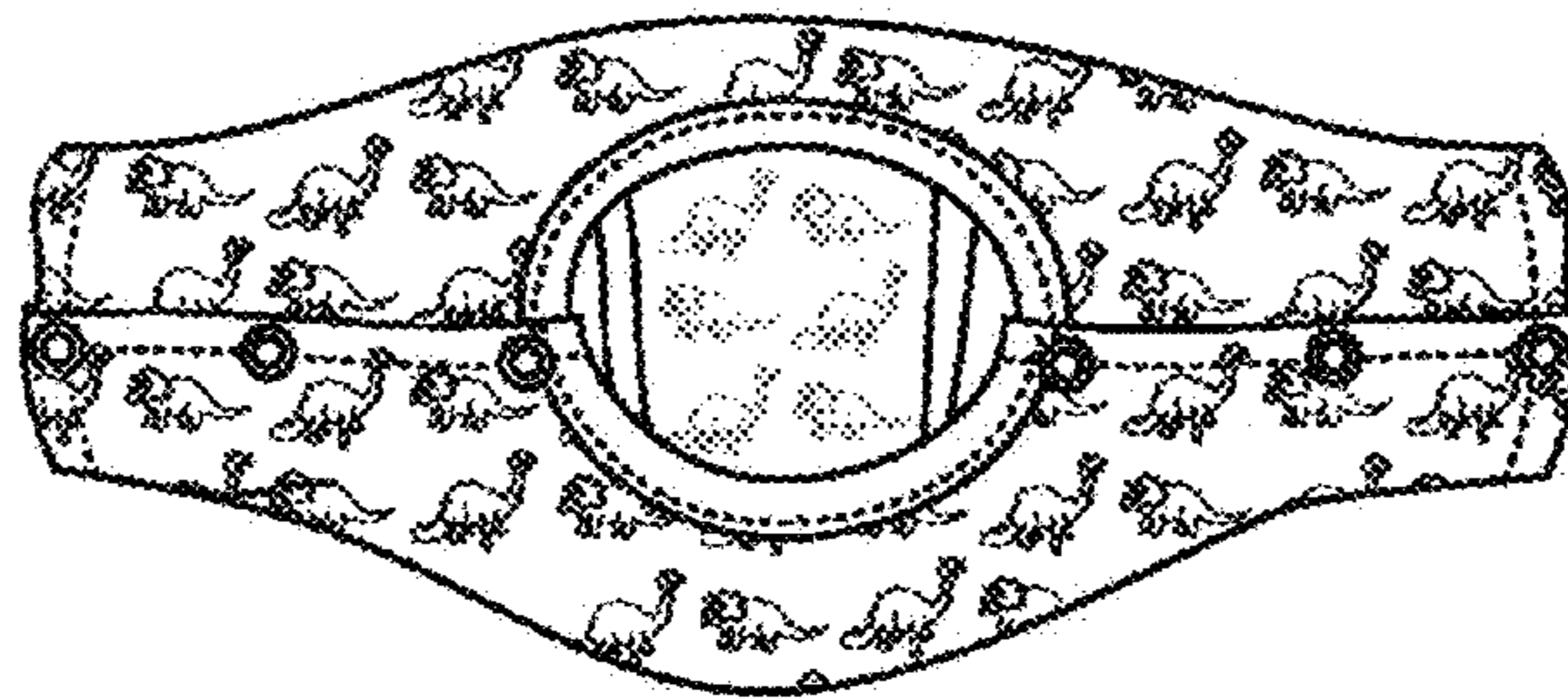

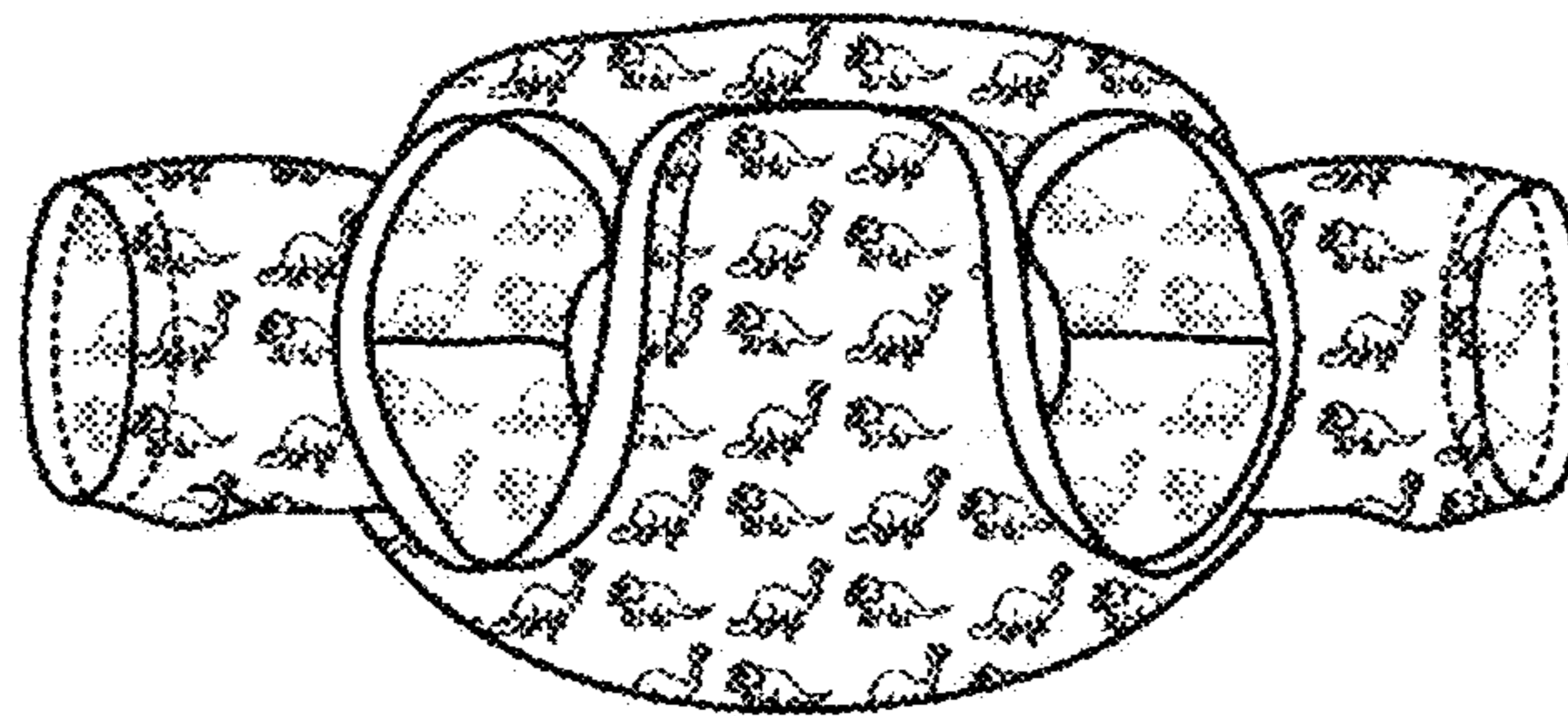
