(57) **CLAIM**

The ornamental design for an attachable pocket, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view showing the new design for an attachable pocket in the closed position;

FIG. 2 is a right side view of the attachable pocket shown in the closed position, with the left side view being a mirror image thereof;

FIG. 3 is an isometric view showing the attachable pocket in the open position;

FIG. 4 is a front view of the attachable pocket in the open position;

FIG. 5 is a top view of the attachable pocket in the open position;

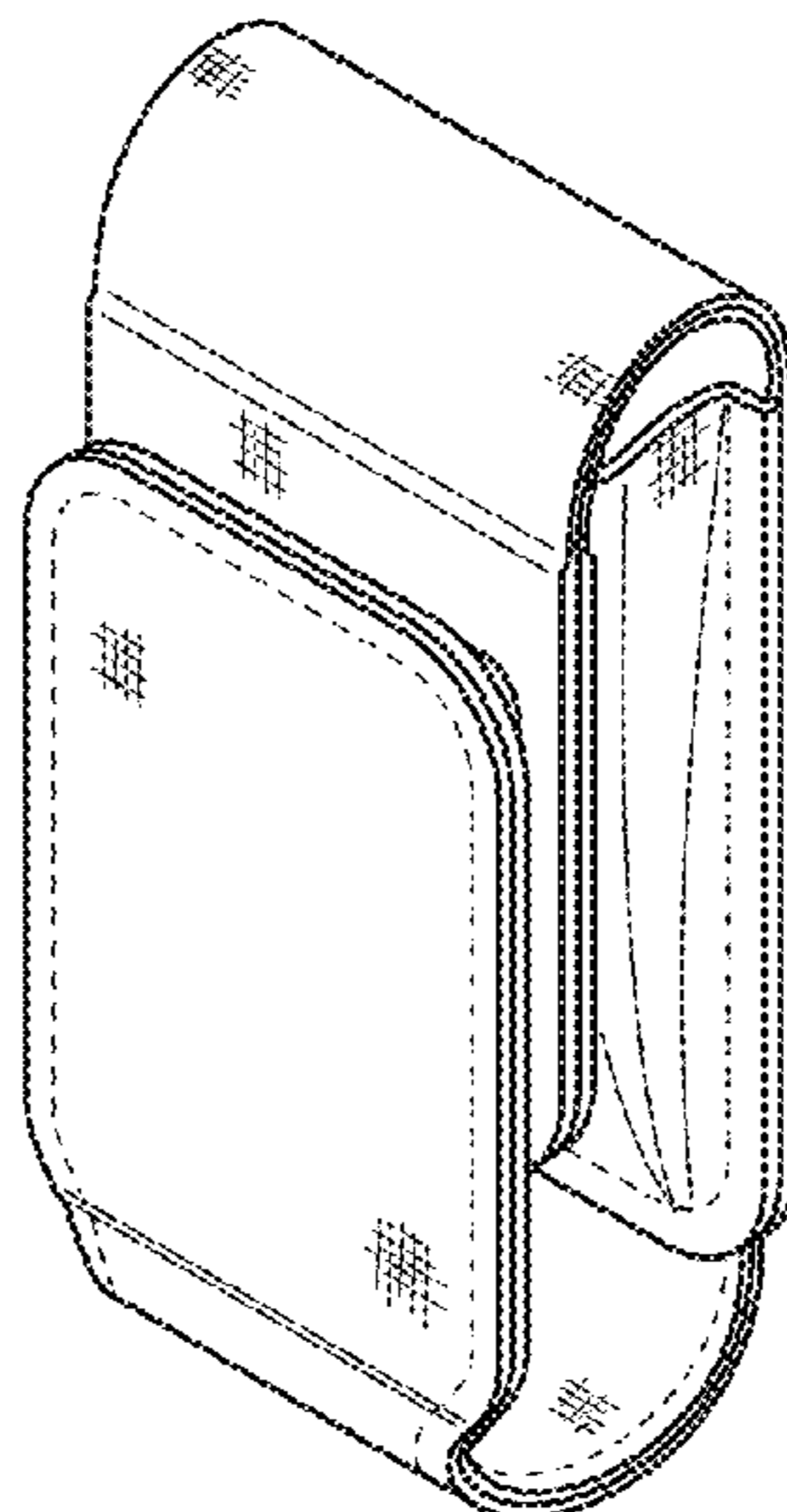
FIG. 6 is a bottom view of the attachable pocket in the open position;

FIG. 7 is a right side view of the attachable pocket shown in the open position, with the left side view being a mirror image thereof; and,

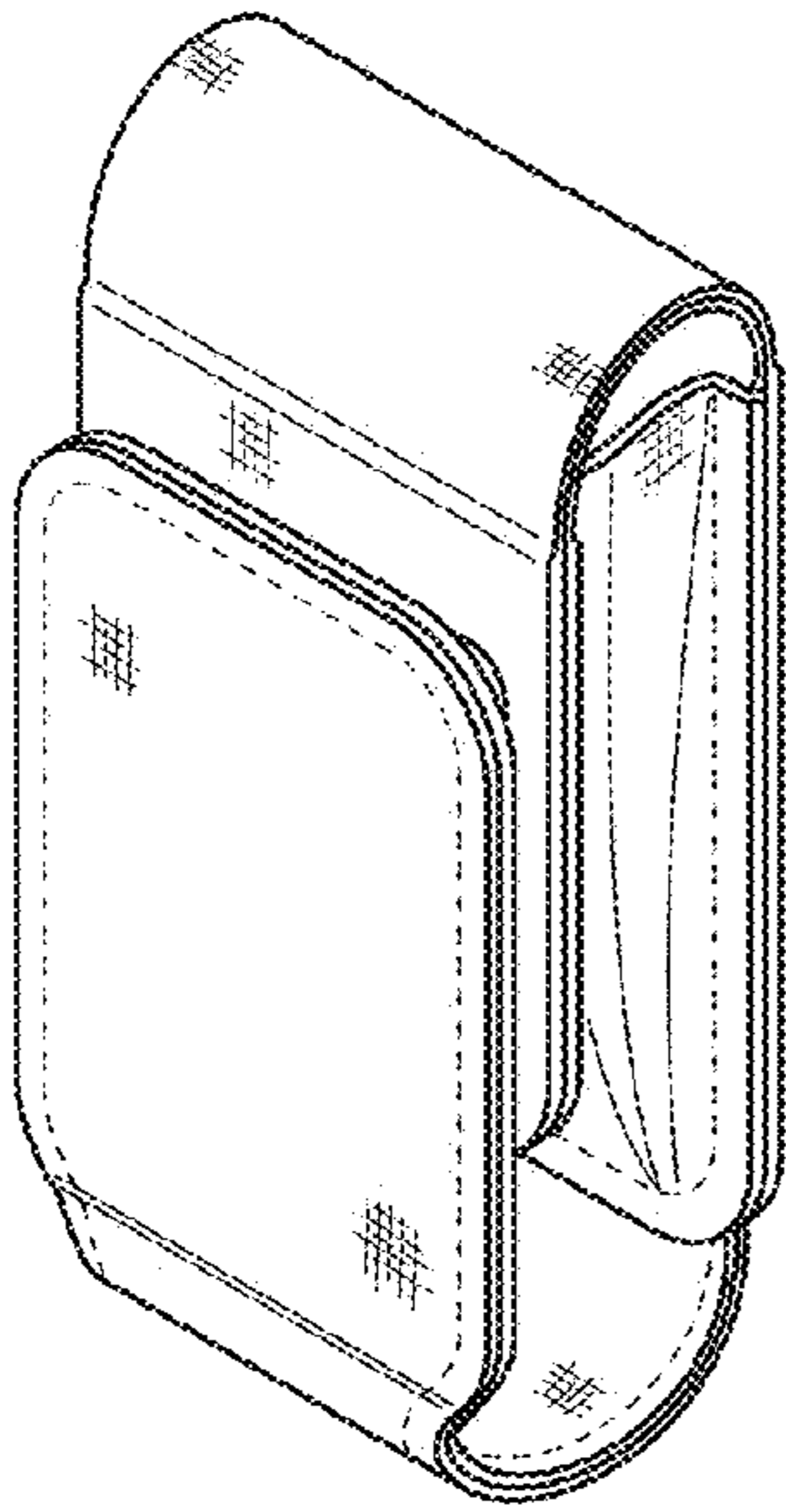

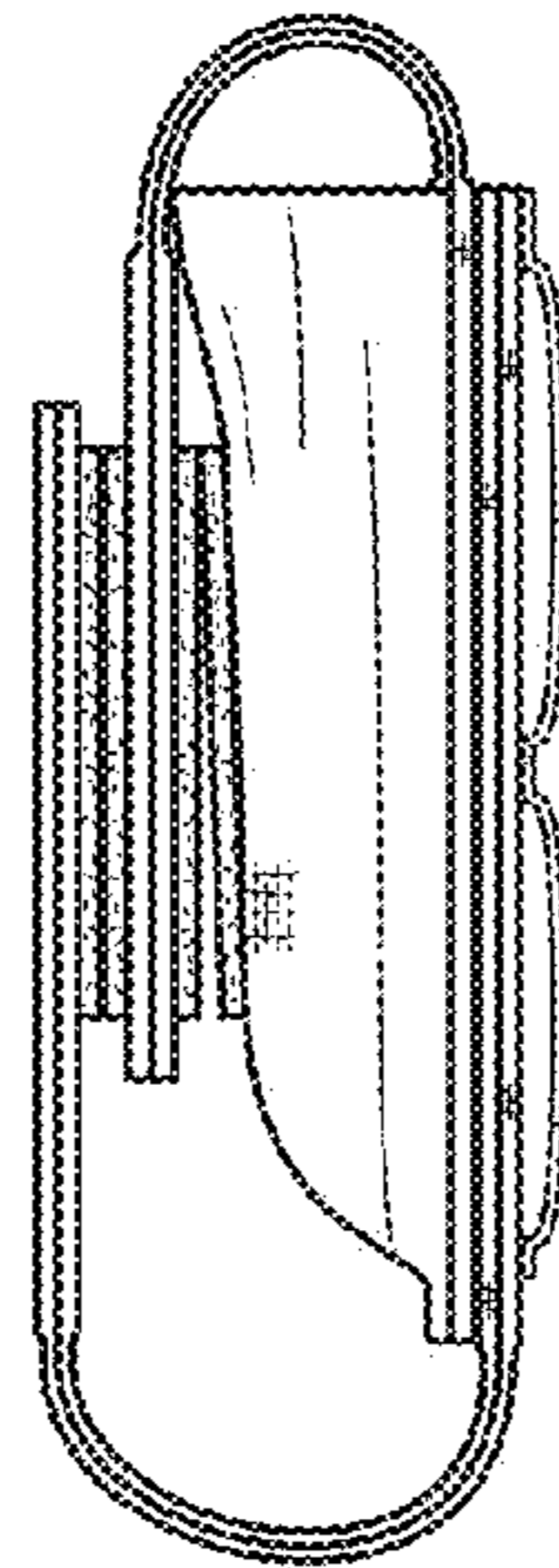

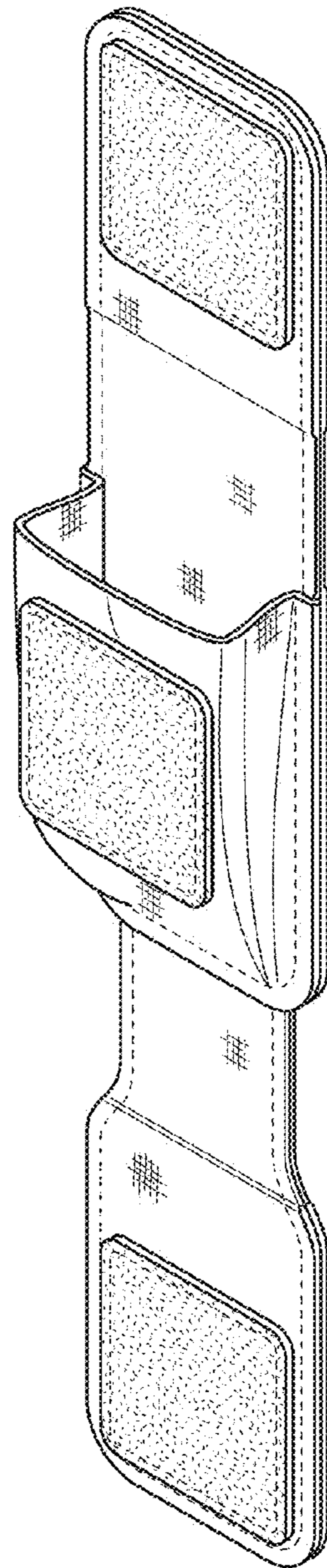

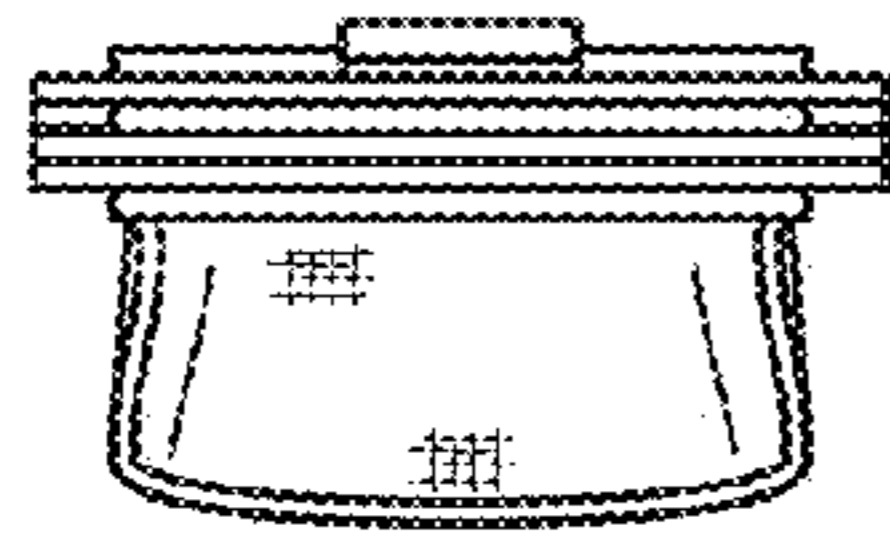

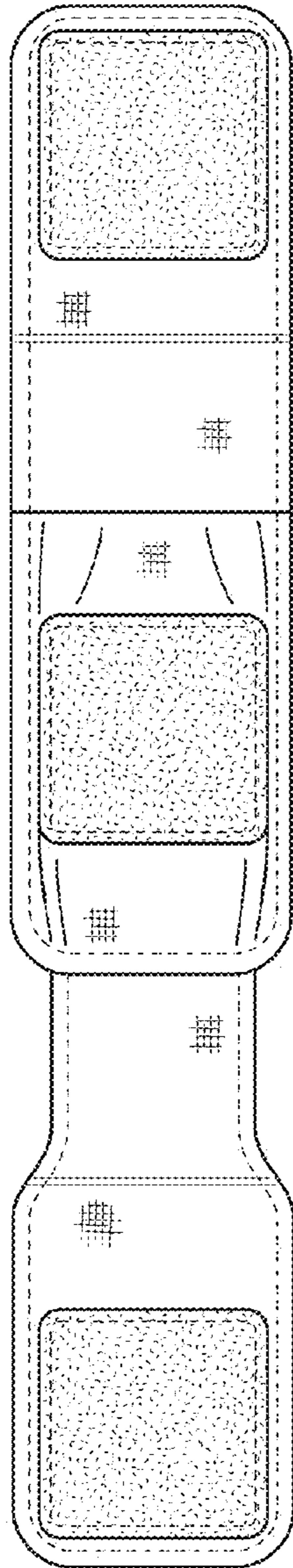

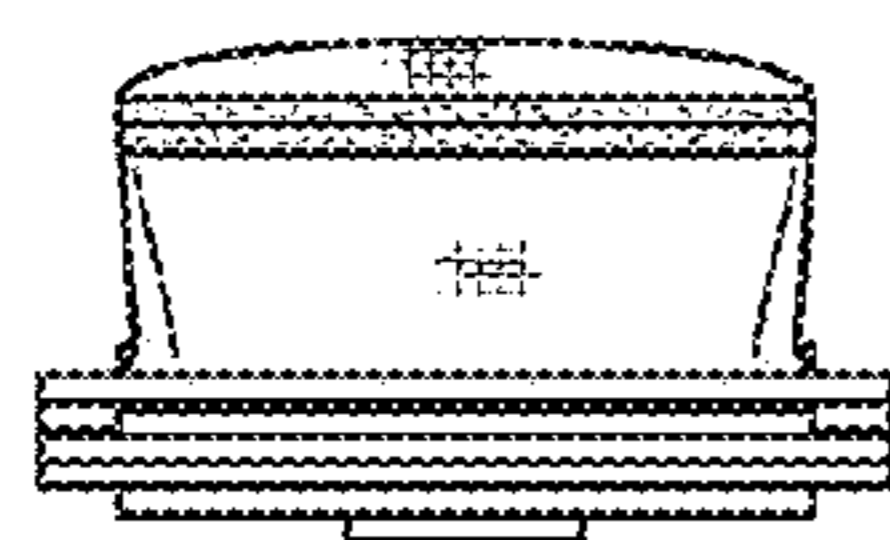

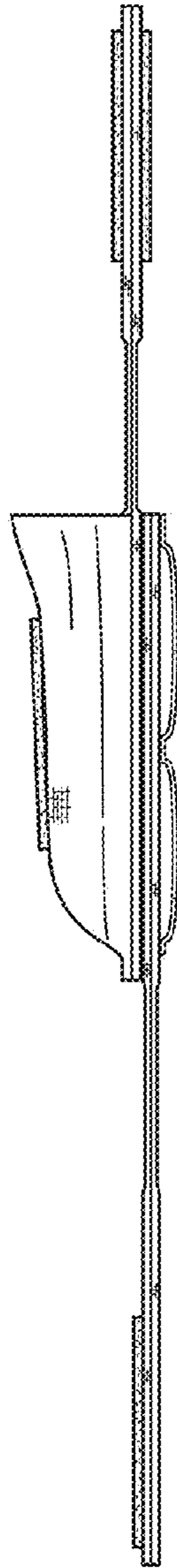

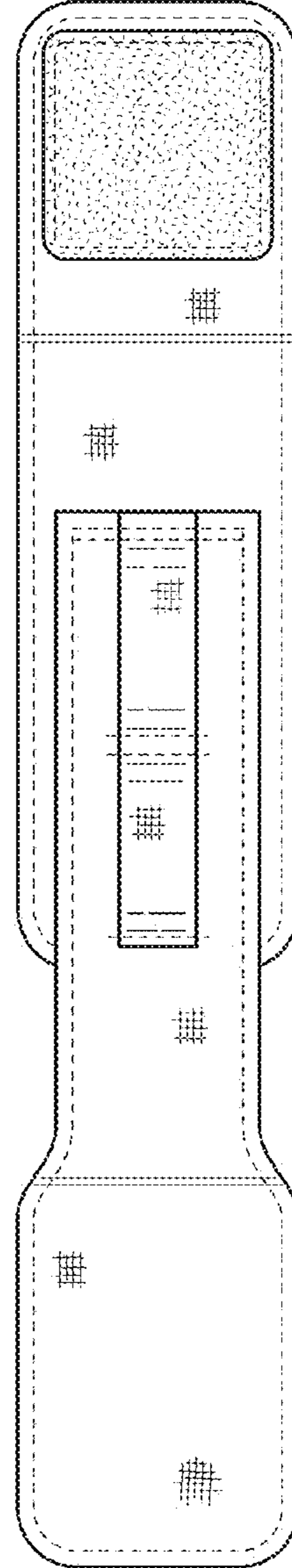
