(57) **CLAIM**

I claim the ornamental design for a paper towel holder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a paper towel holder showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a top elevational view thereof;

FIG. 7 is a bottom elevational view thereof;

FIG. 8 is a bottom elevational view thereof, depicting an alternate embodiment of FIG. 7, additional FIGS. 1-6 applied there to;

FIG. 9 is a perspective view thereof, depicting the flashlights in an unattached and displaced state;

FIG. 10 is a front elevational view thereof;

FIG. 11 is a rear elevational view thereof;

FIG. 12 is a left side elevational view thereof;

FIG. 13 is a right side elevational view thereof;

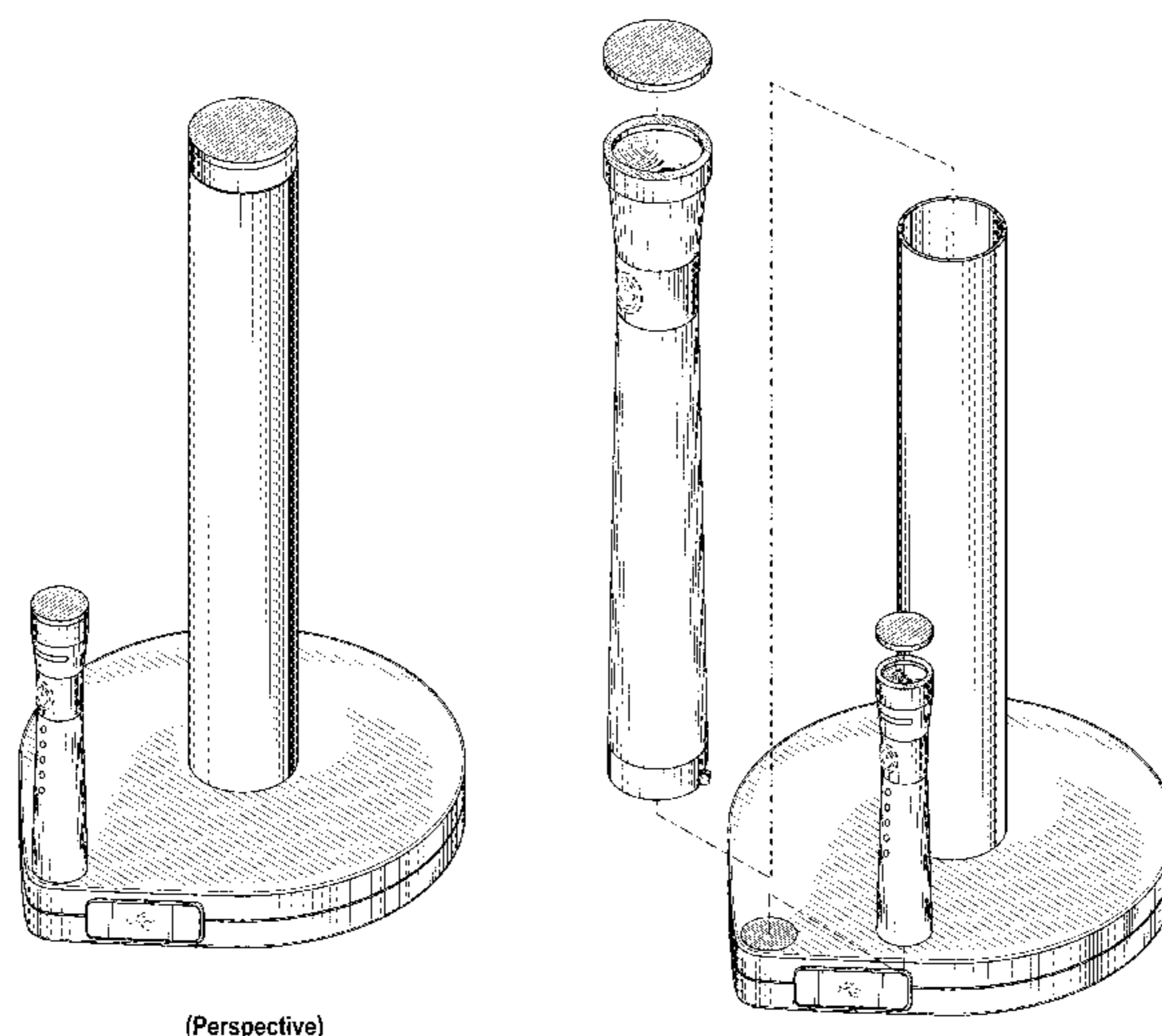
FIG. 14 is a top elevational view thereof; and,

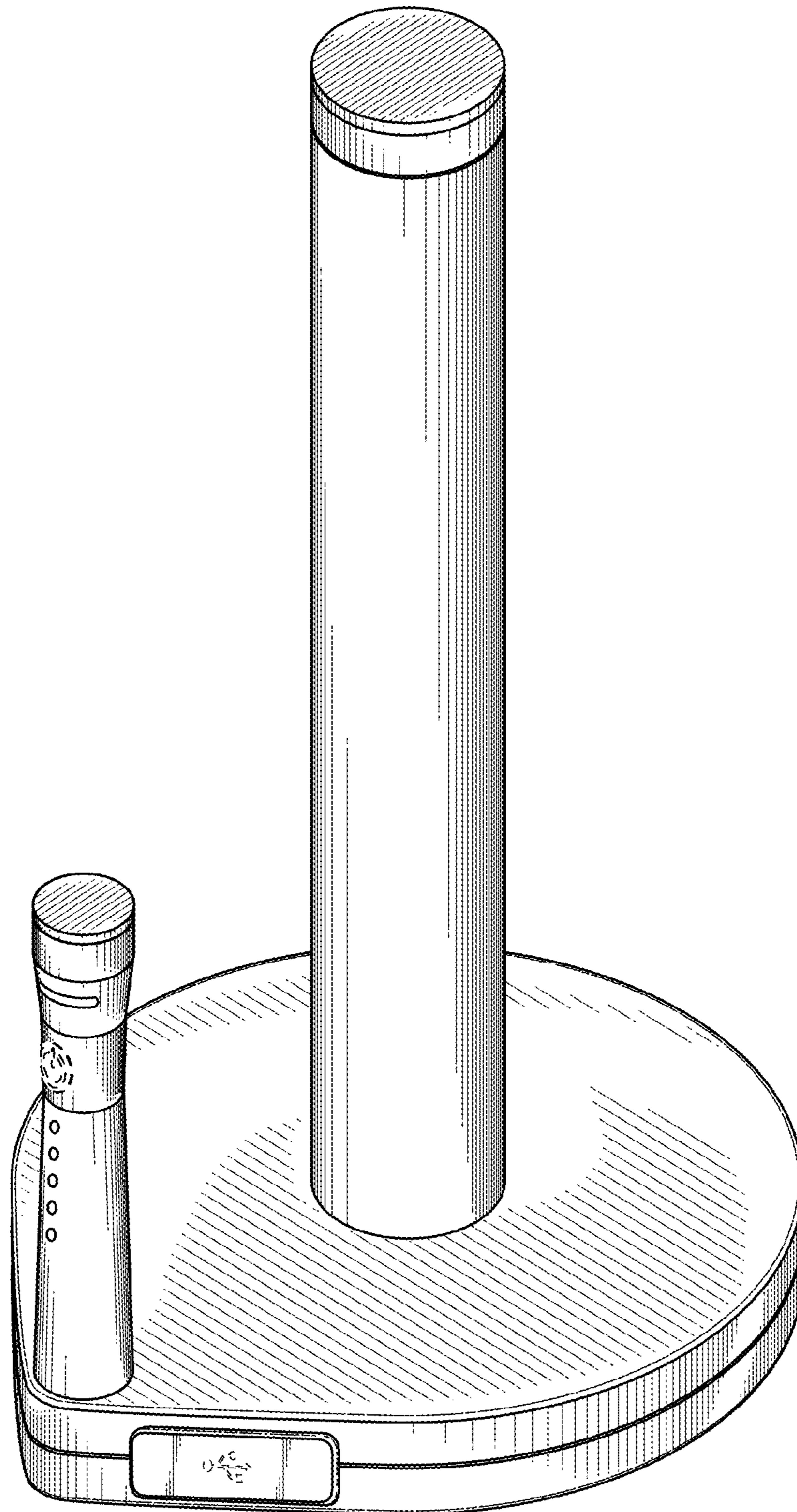

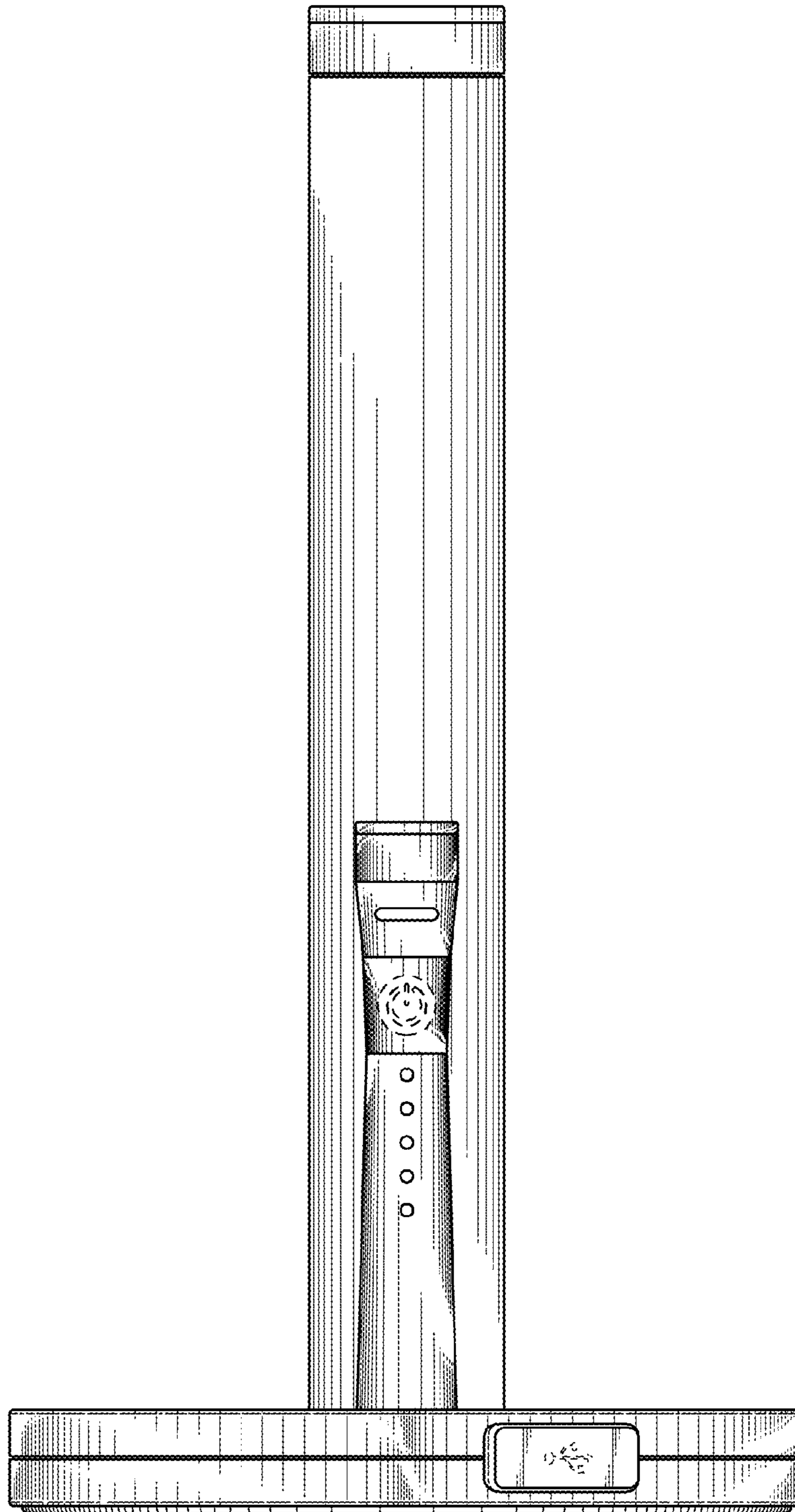

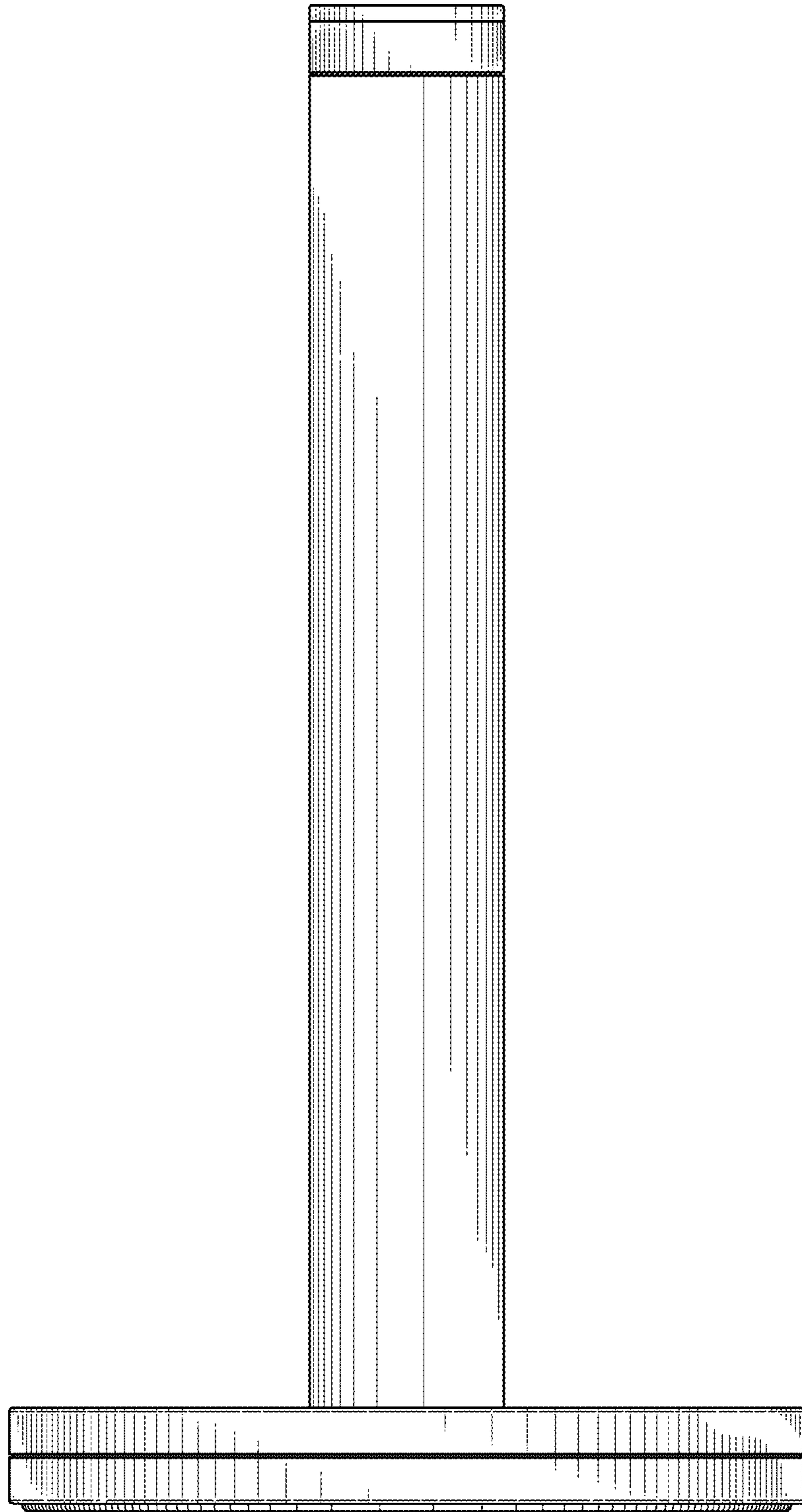

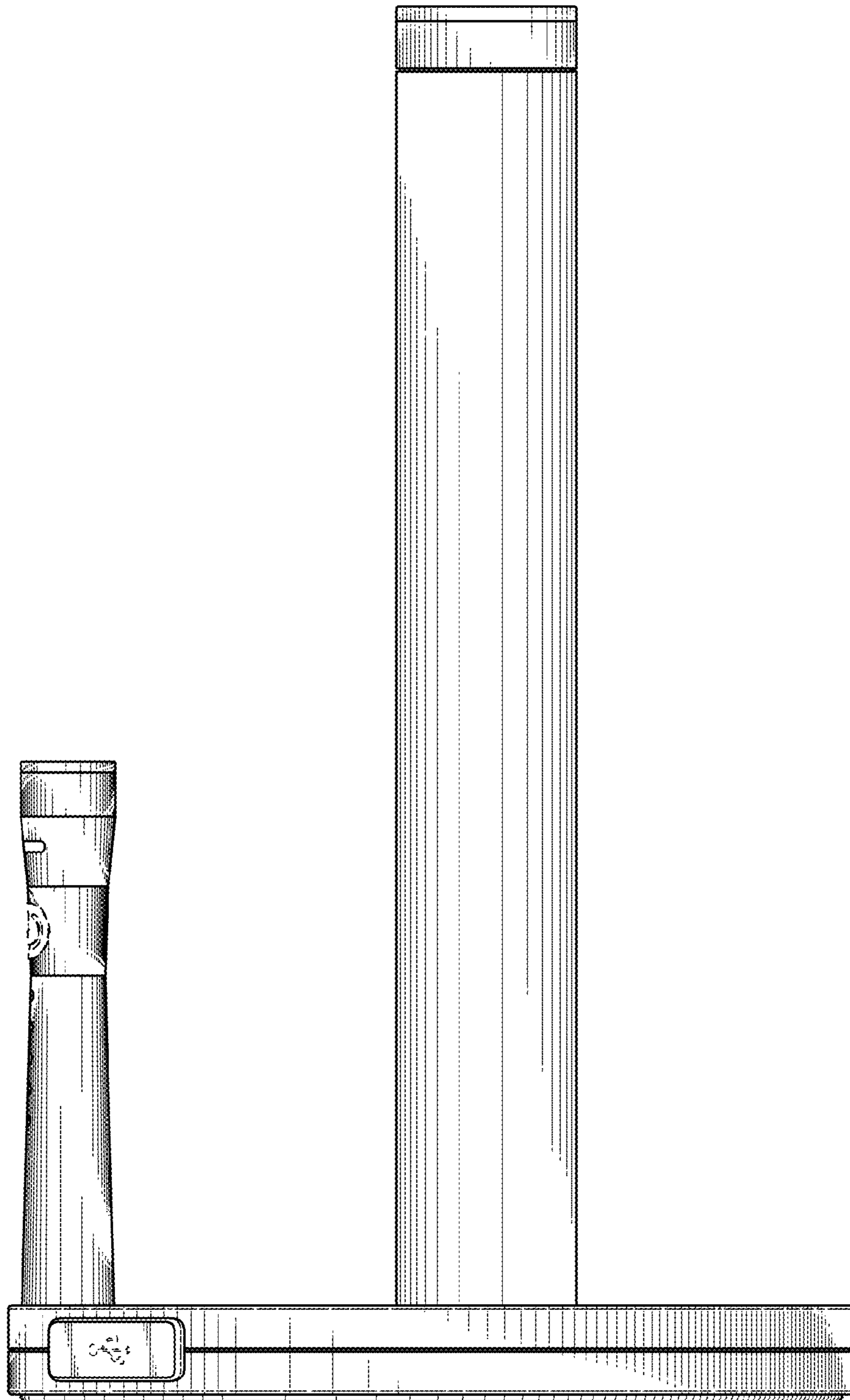

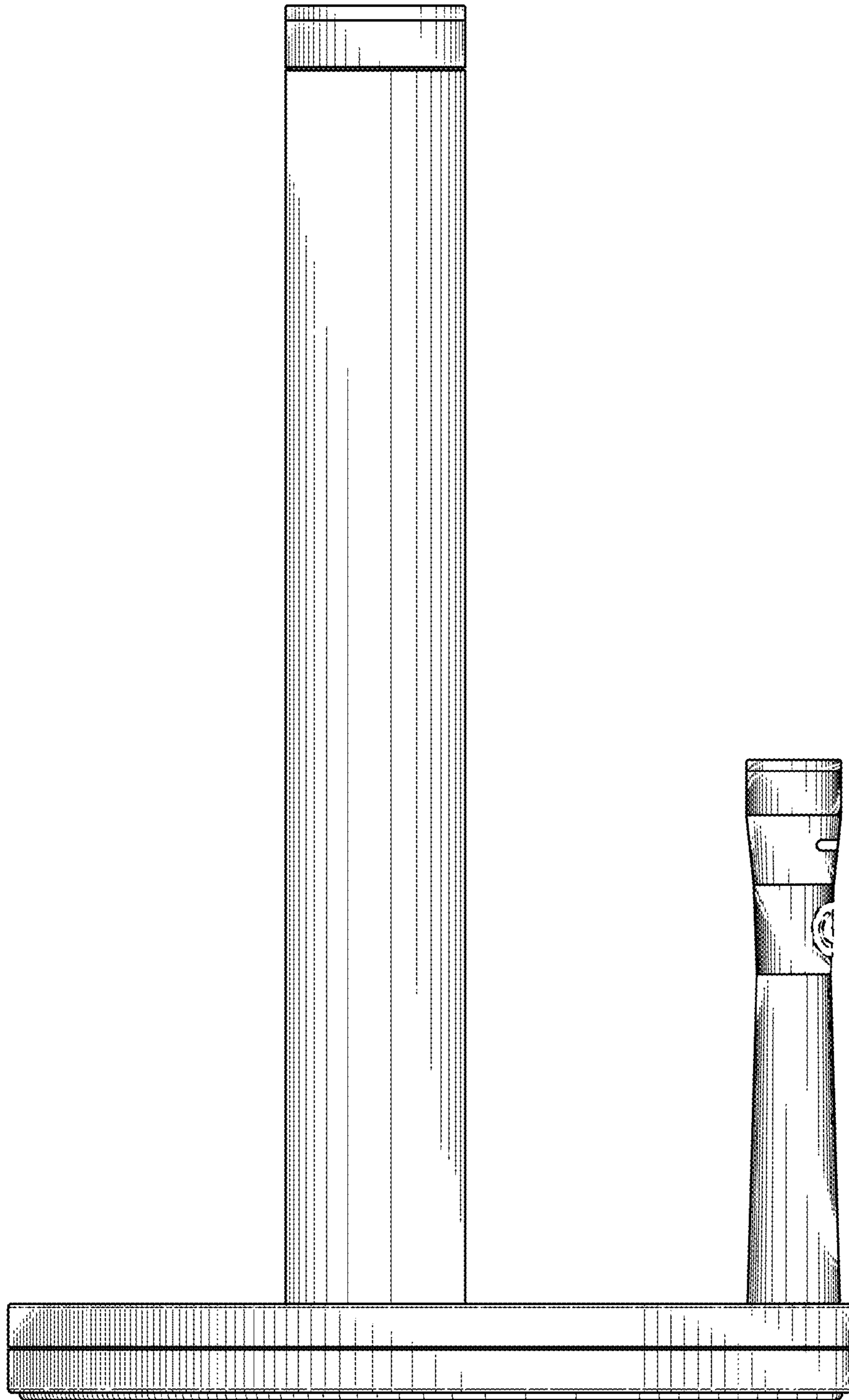

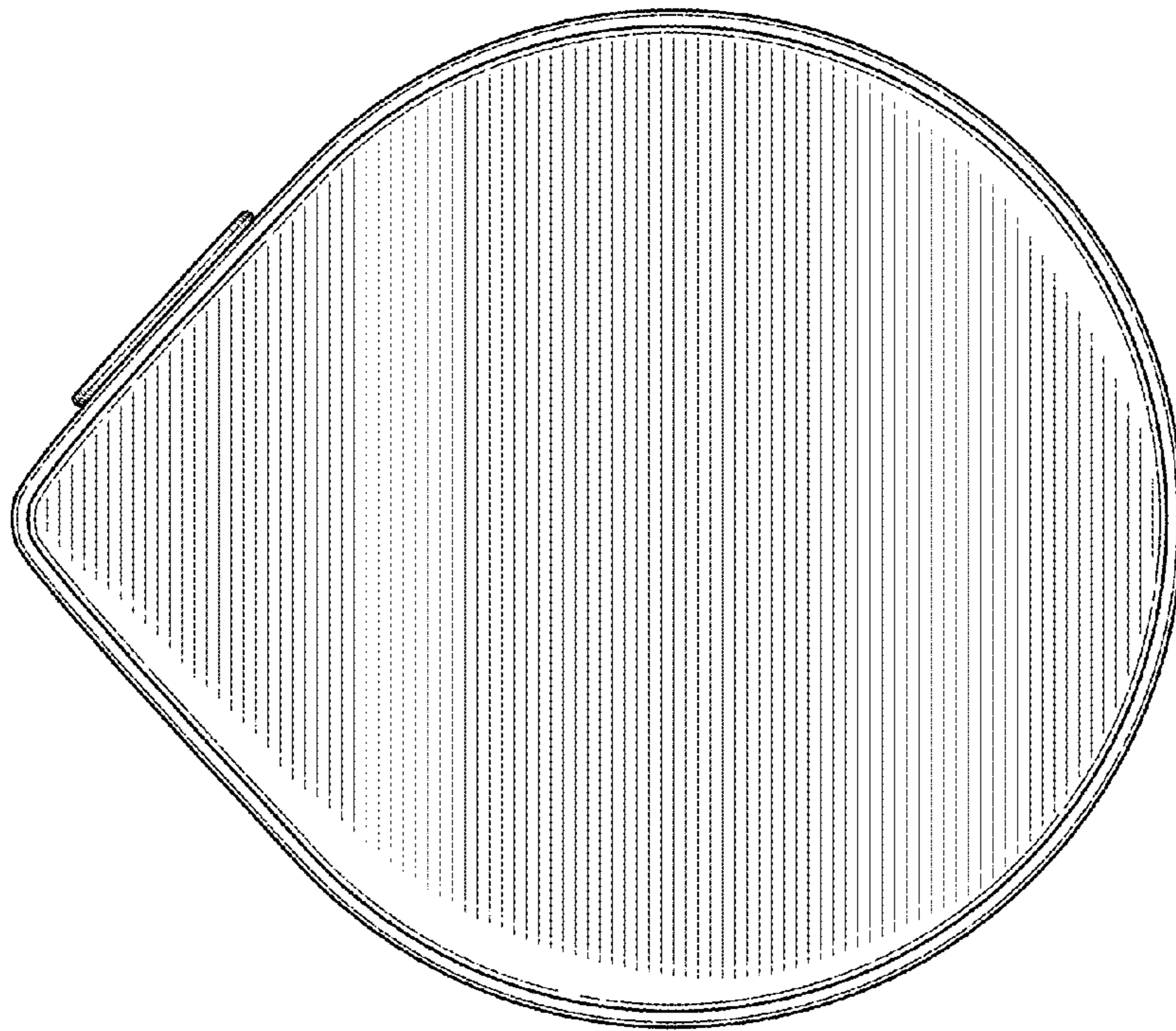

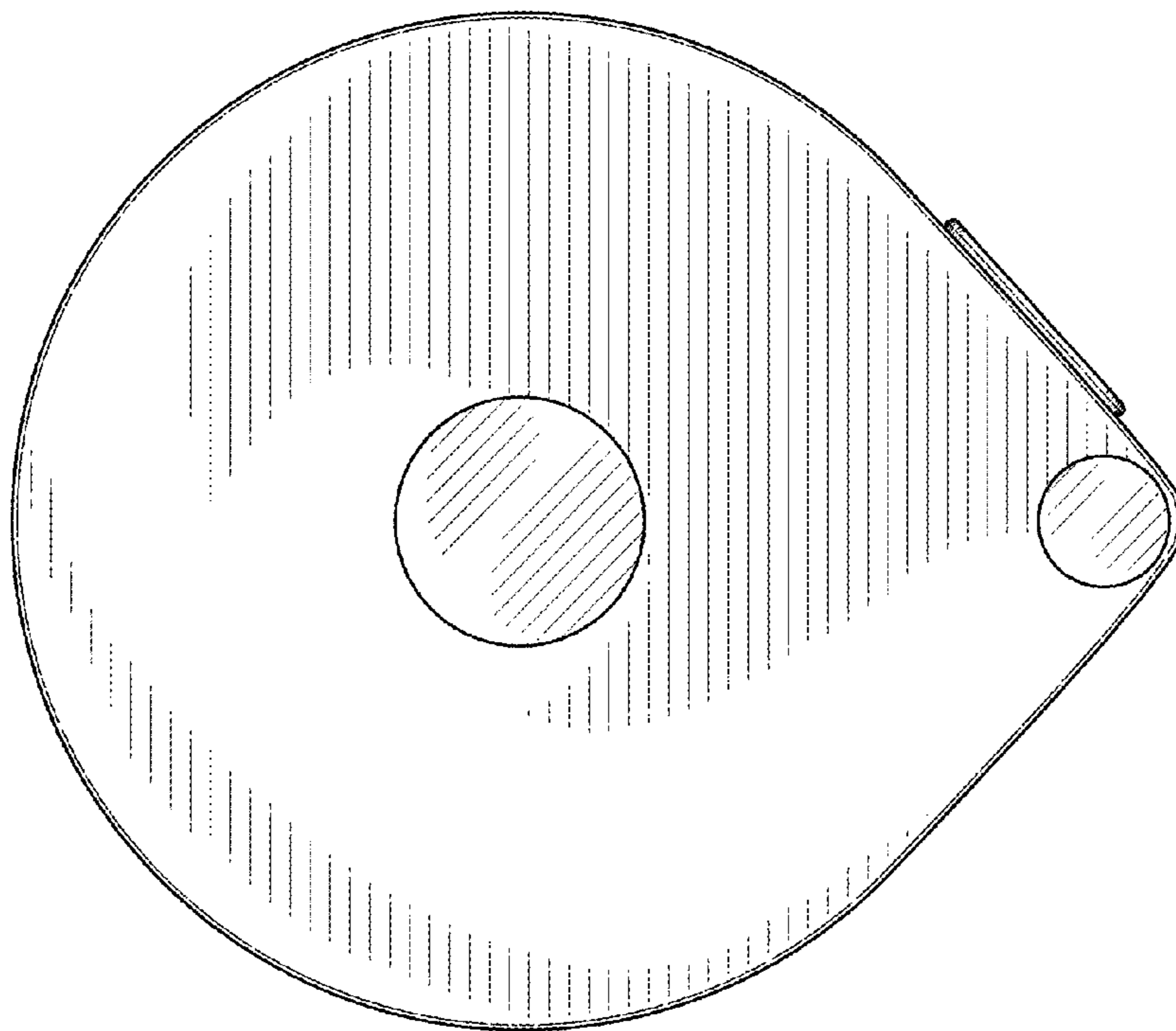

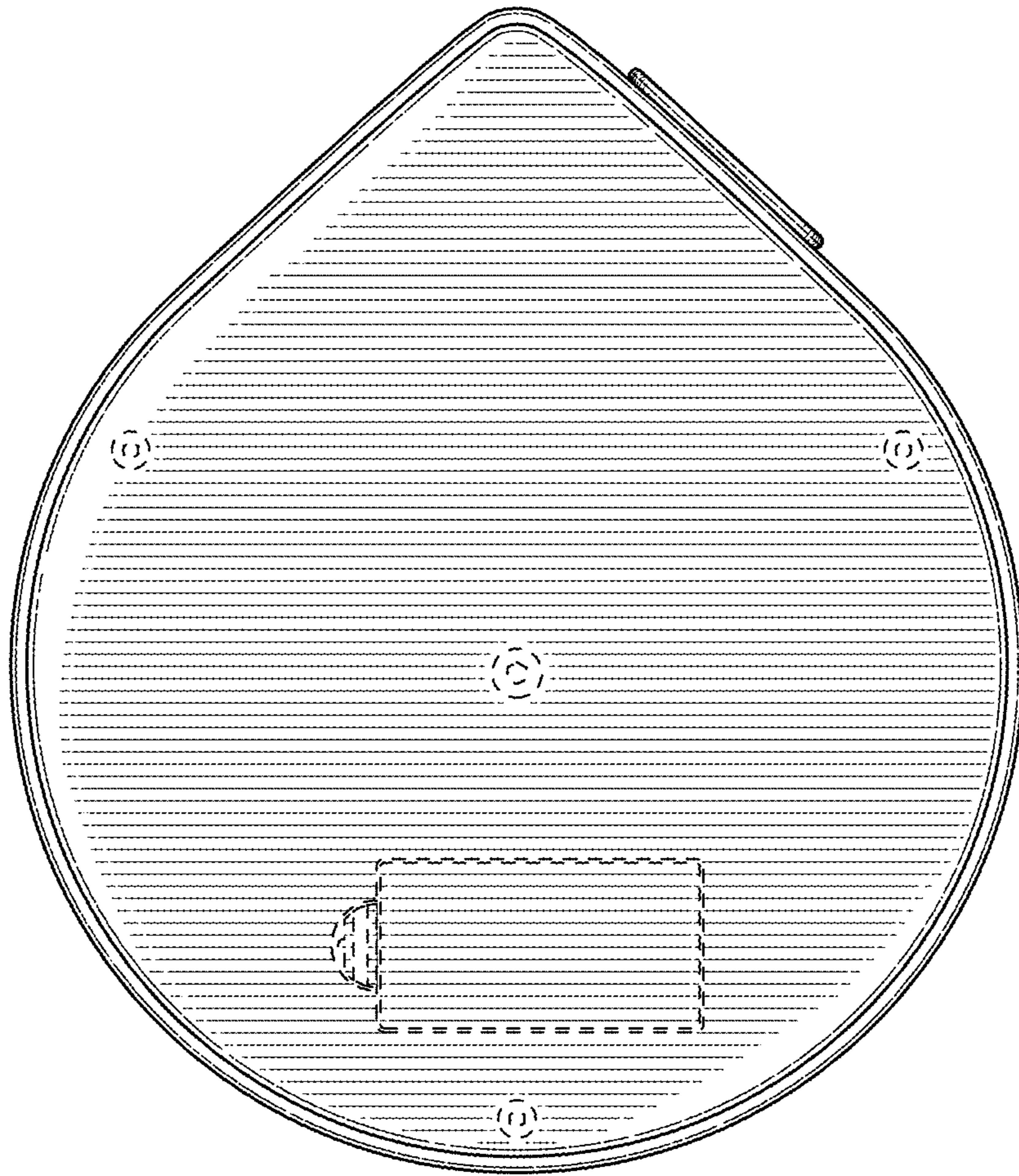

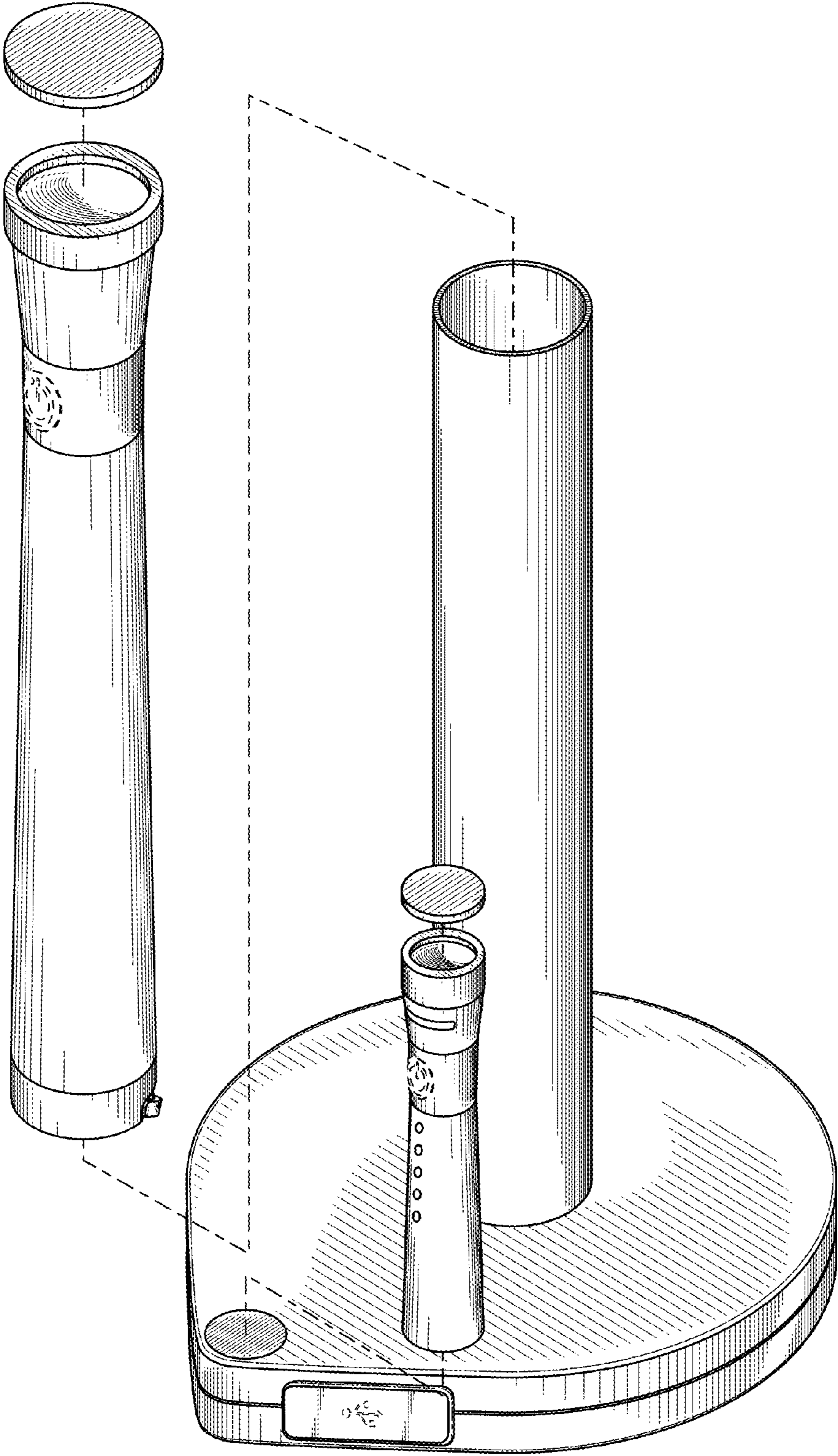

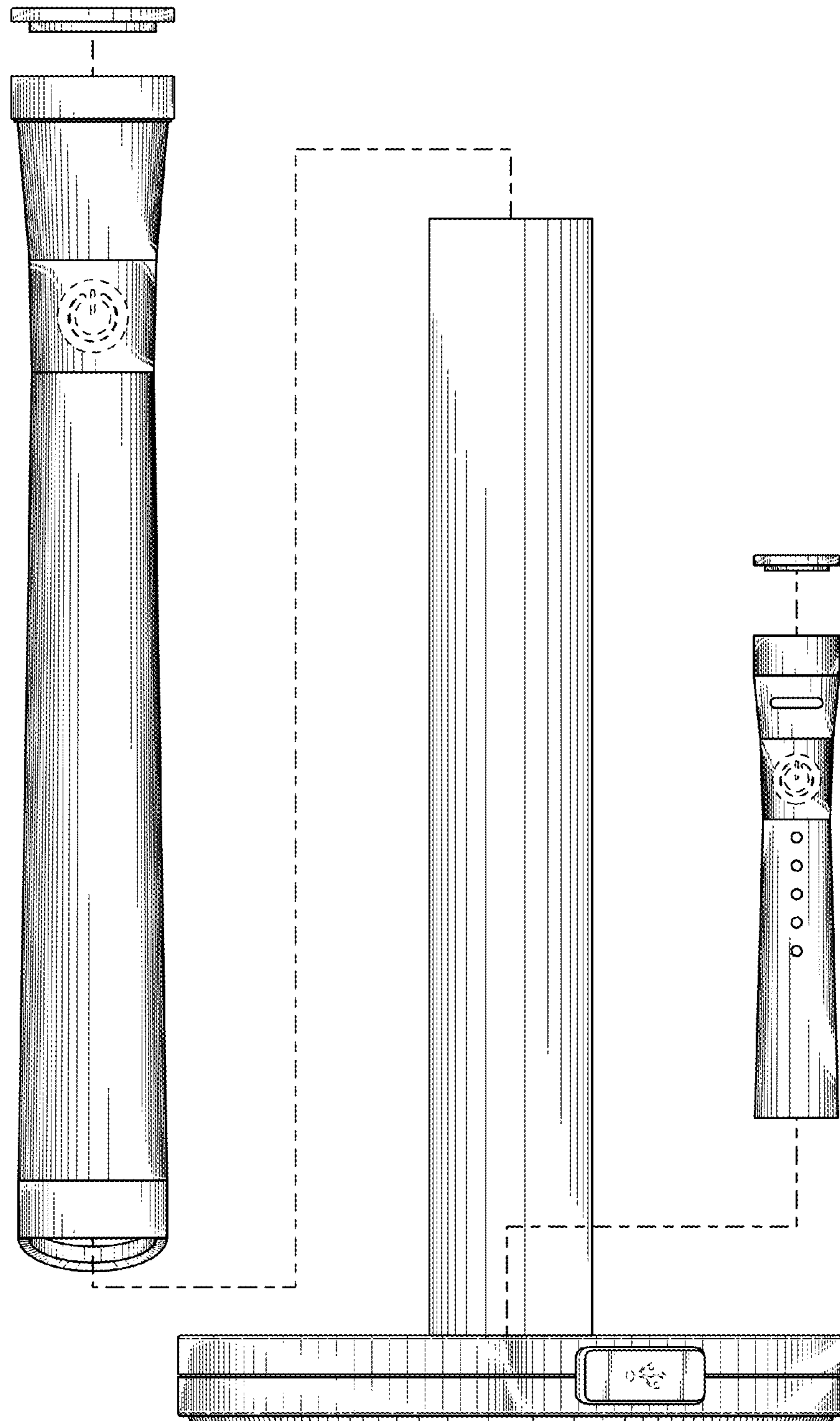

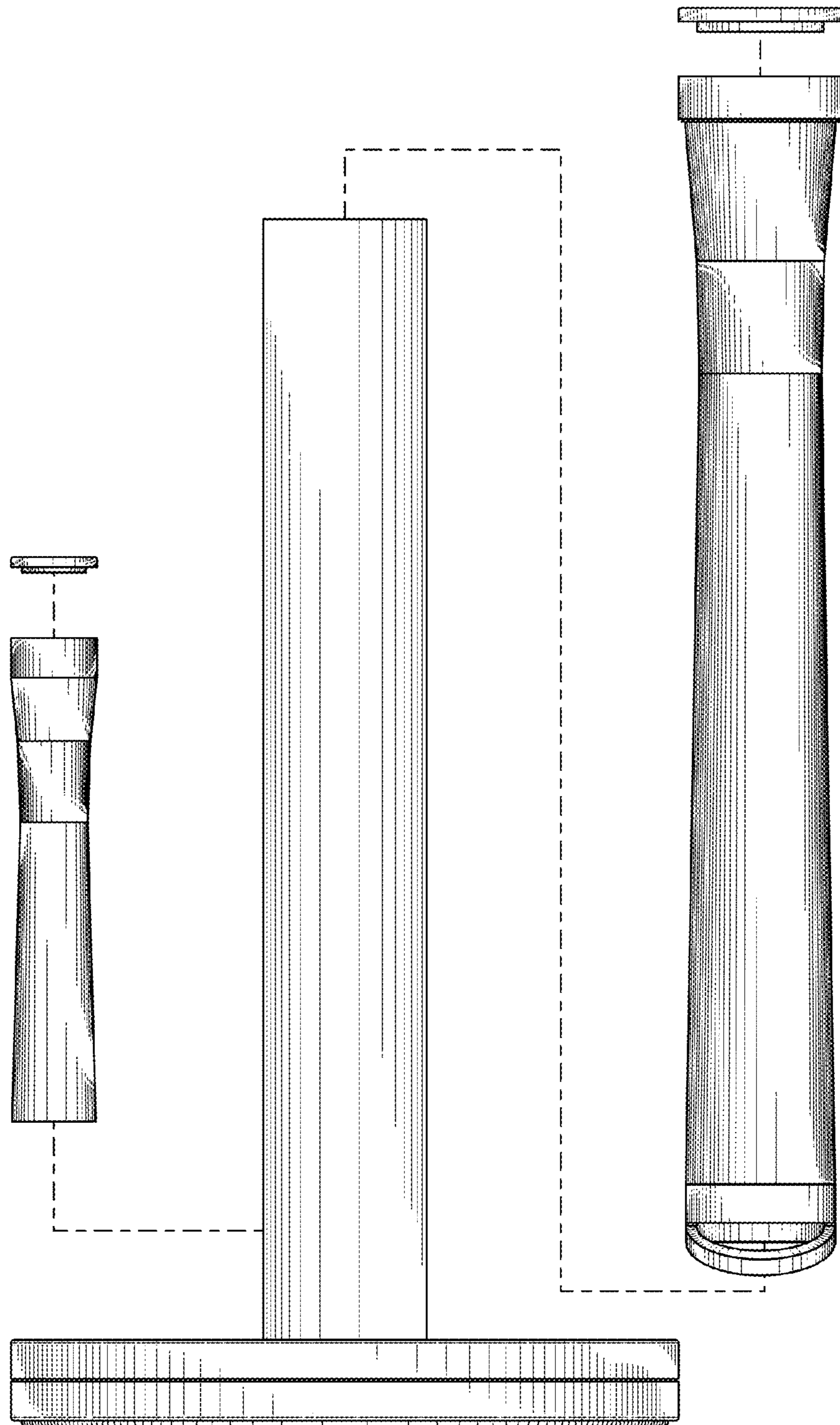

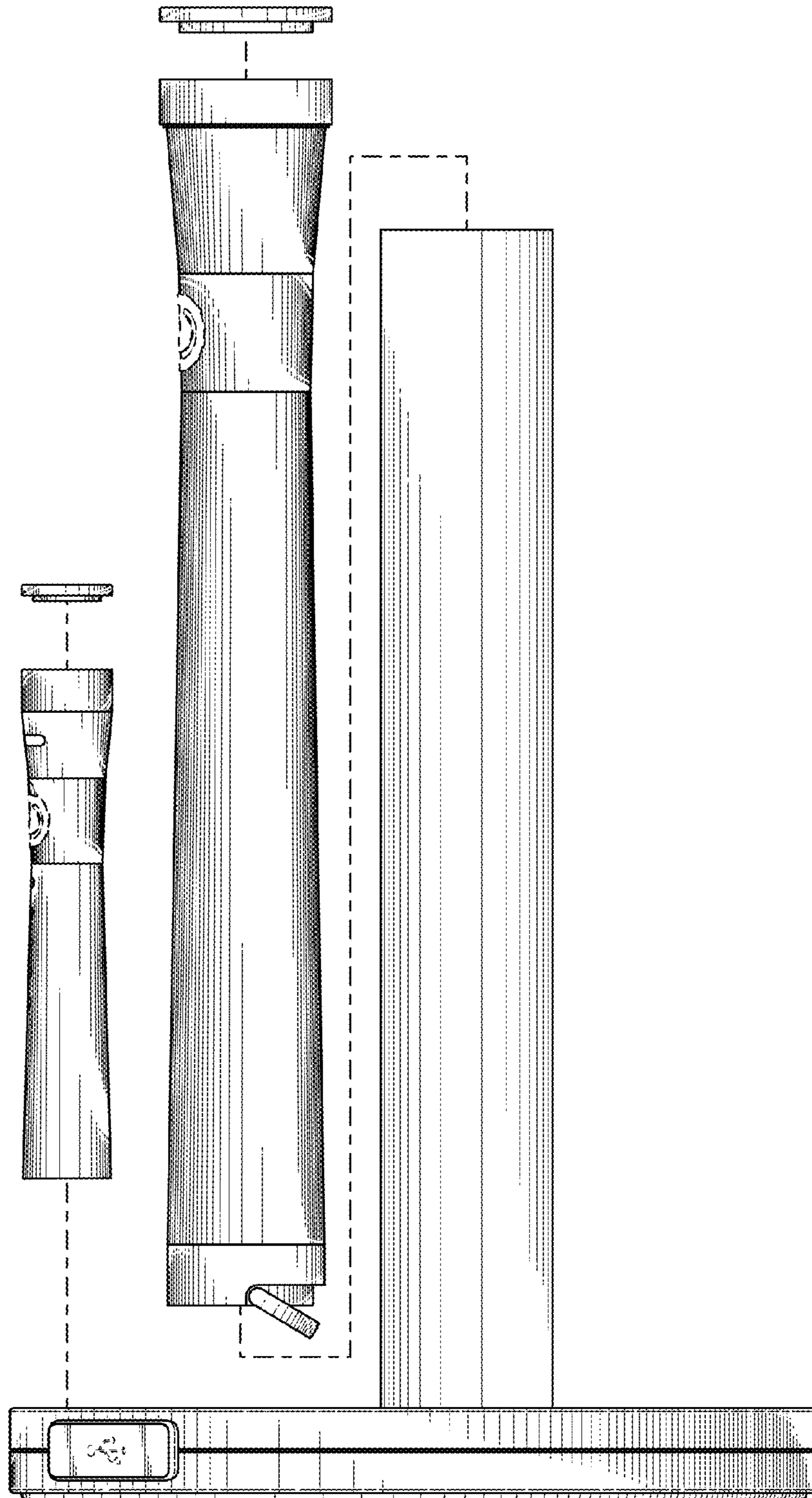

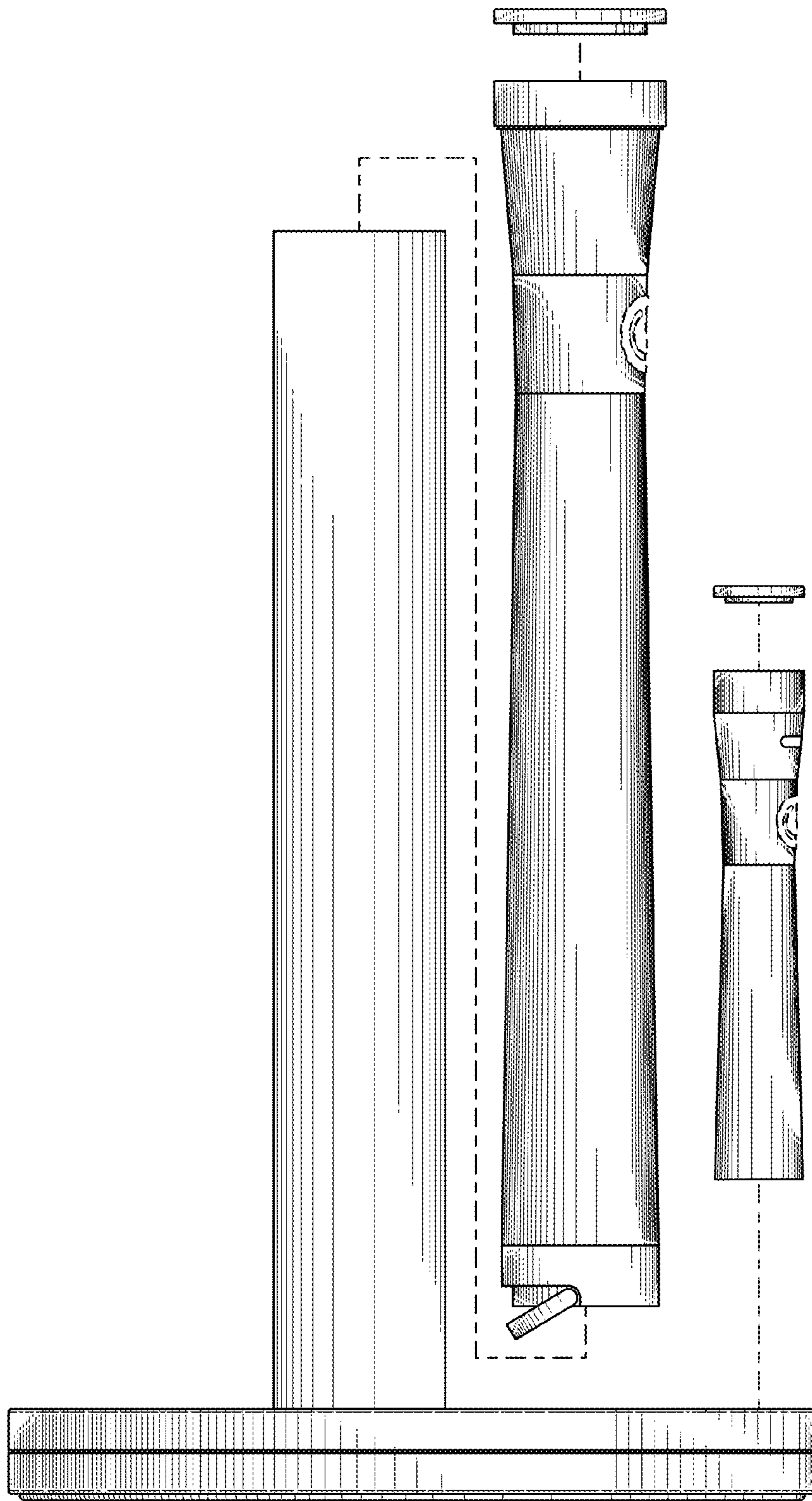

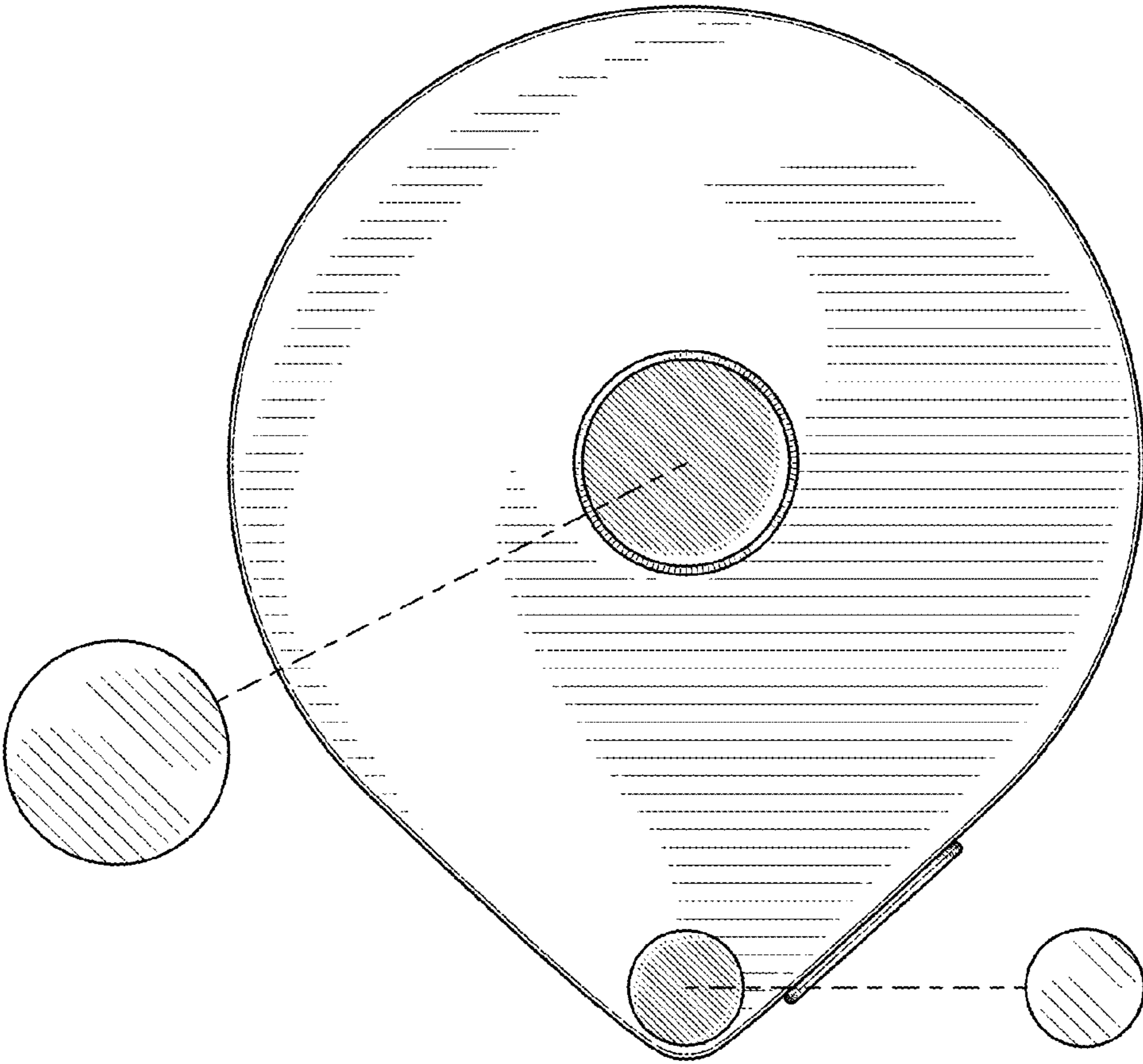

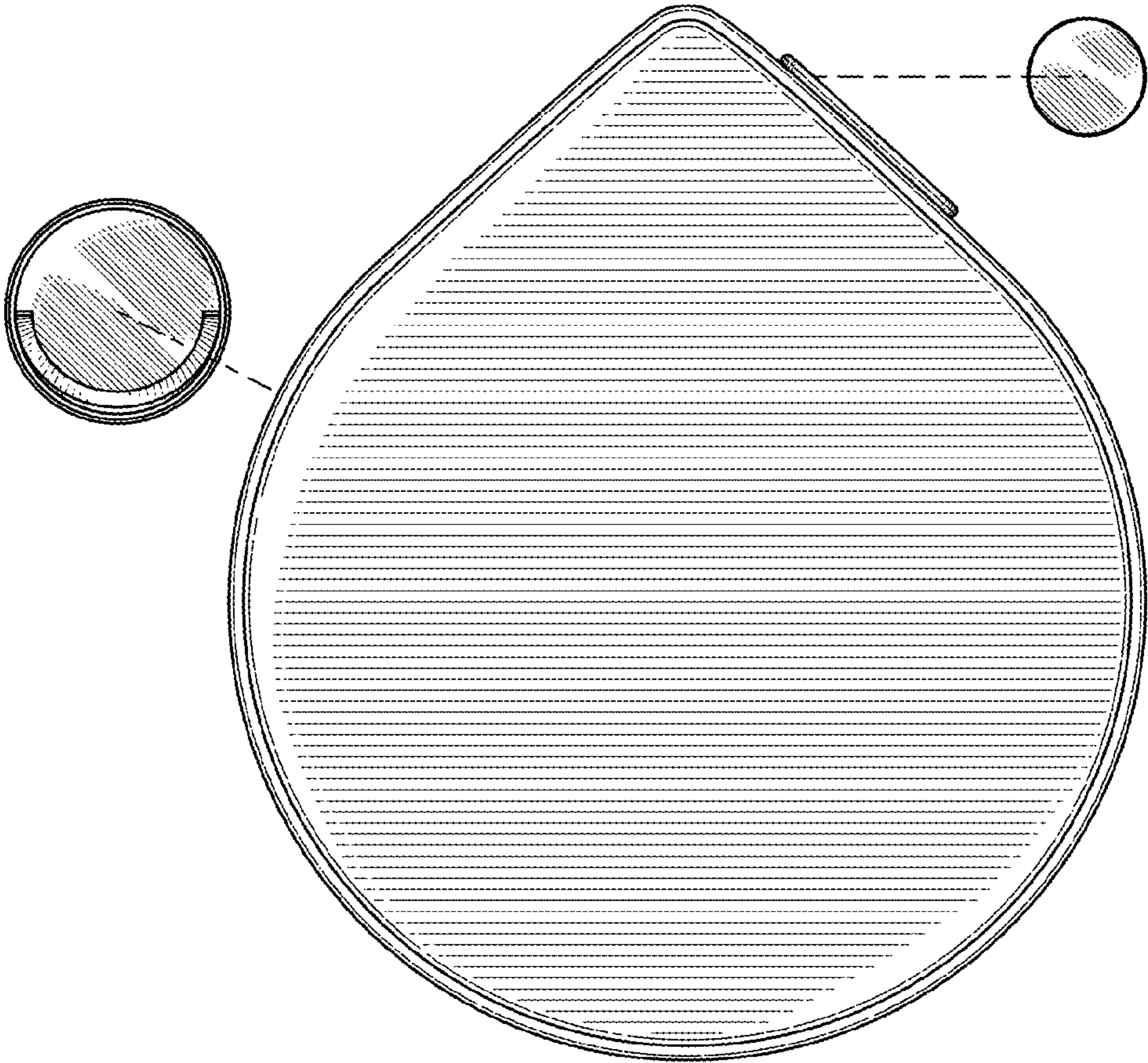
