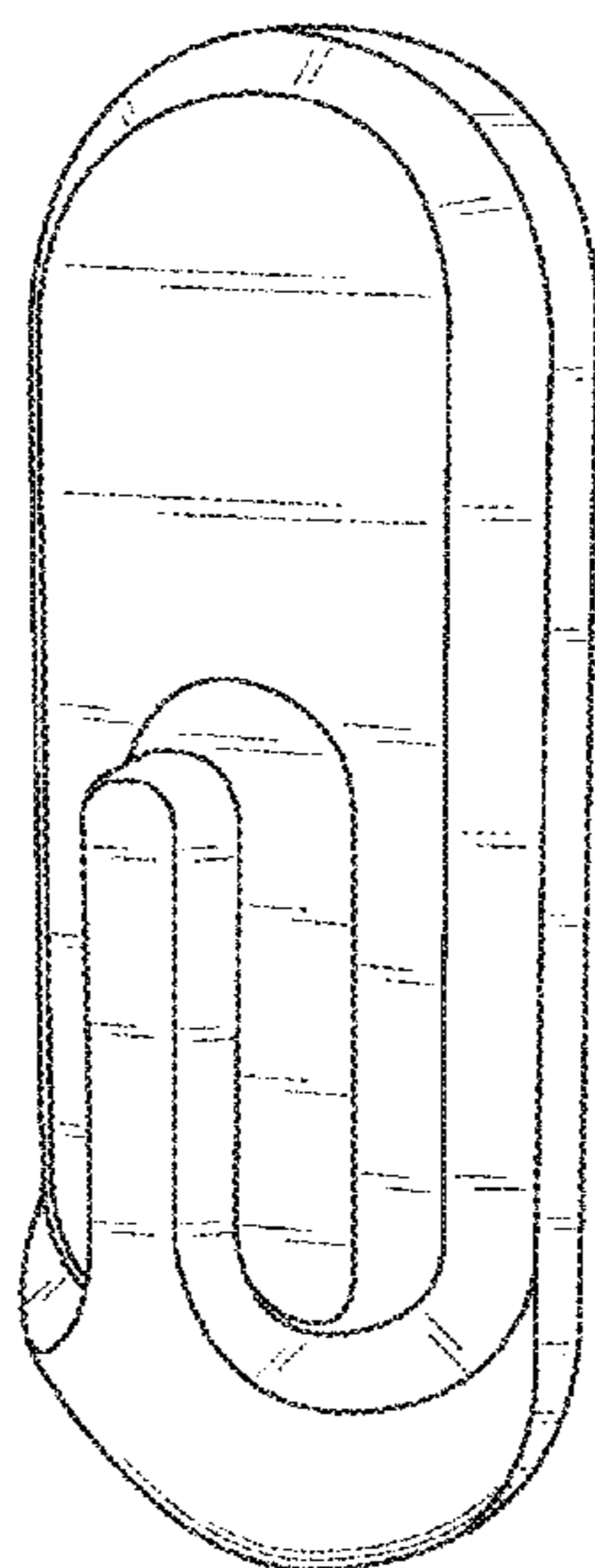

DESCRIPTION

FIG. 1 is a perspective view of a cutter with our new design.
FIG. 2 is a front view of the cutter of FIG. 1.
FIG. 3 is a back view of the cutter of FIG. 1.
FIG. 4 is a left side view of the cutter of FIG. 1; and,
FIG. 5 is a right side view of the cutter of FIG. 1.

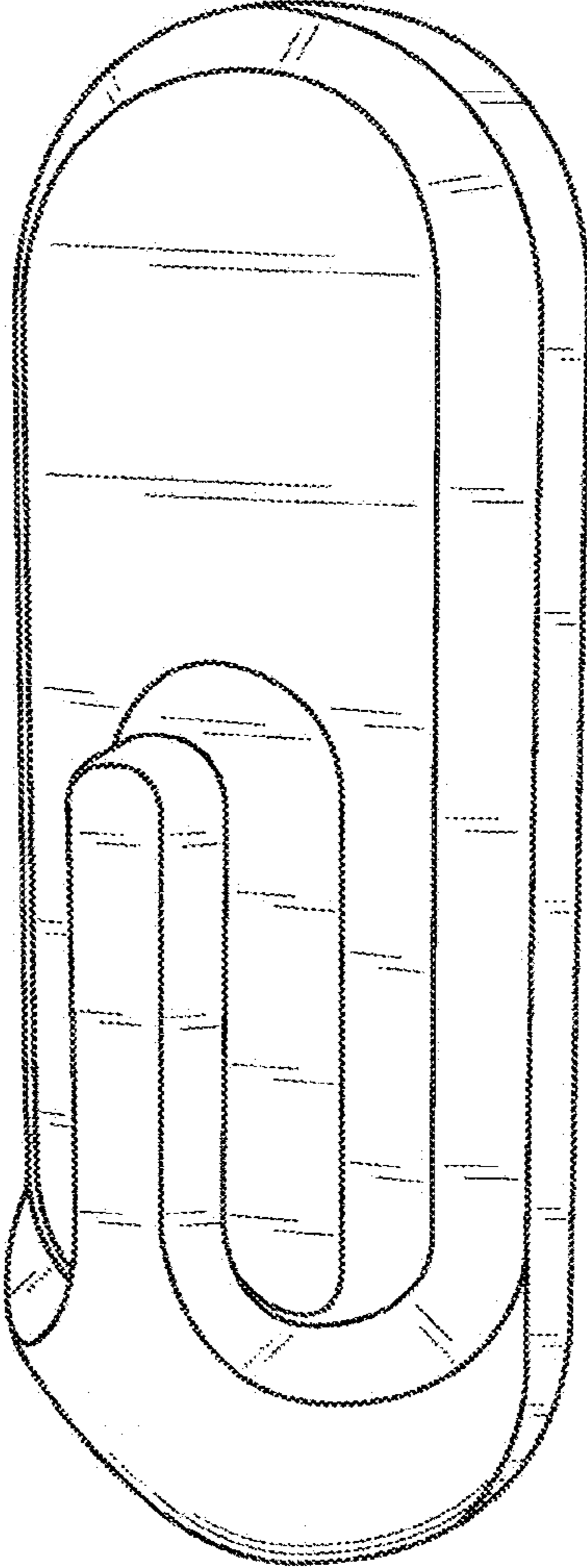

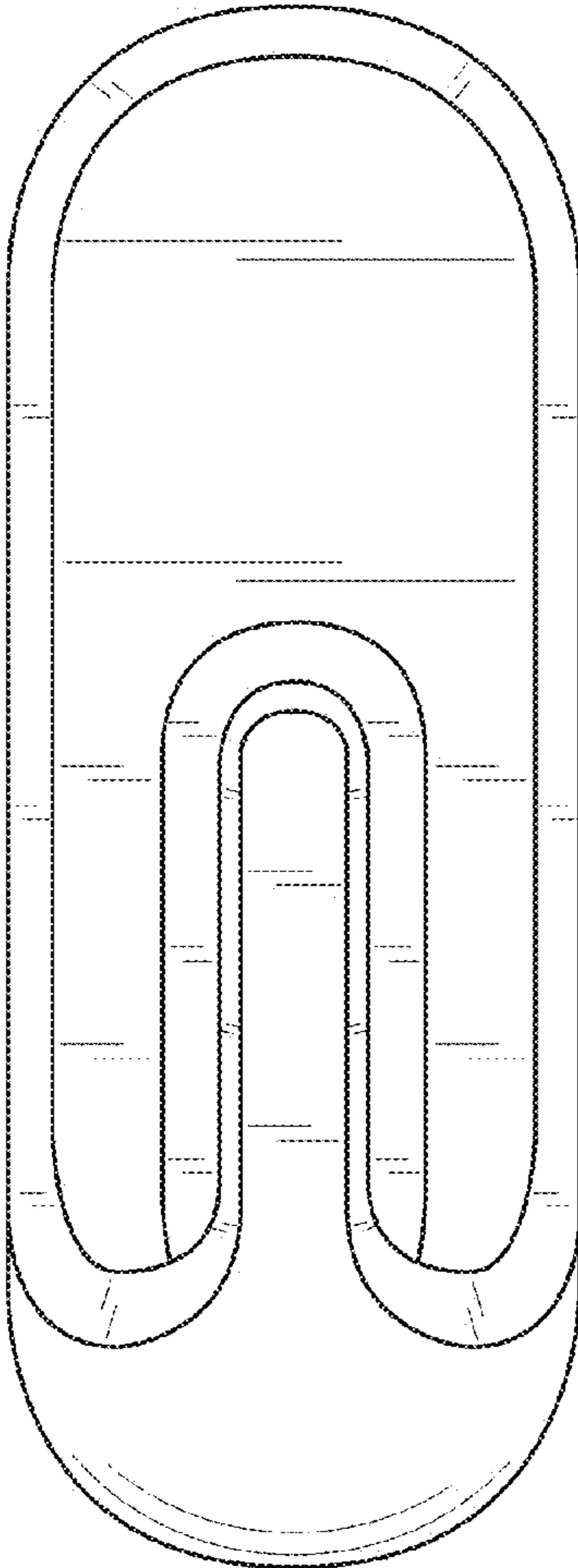

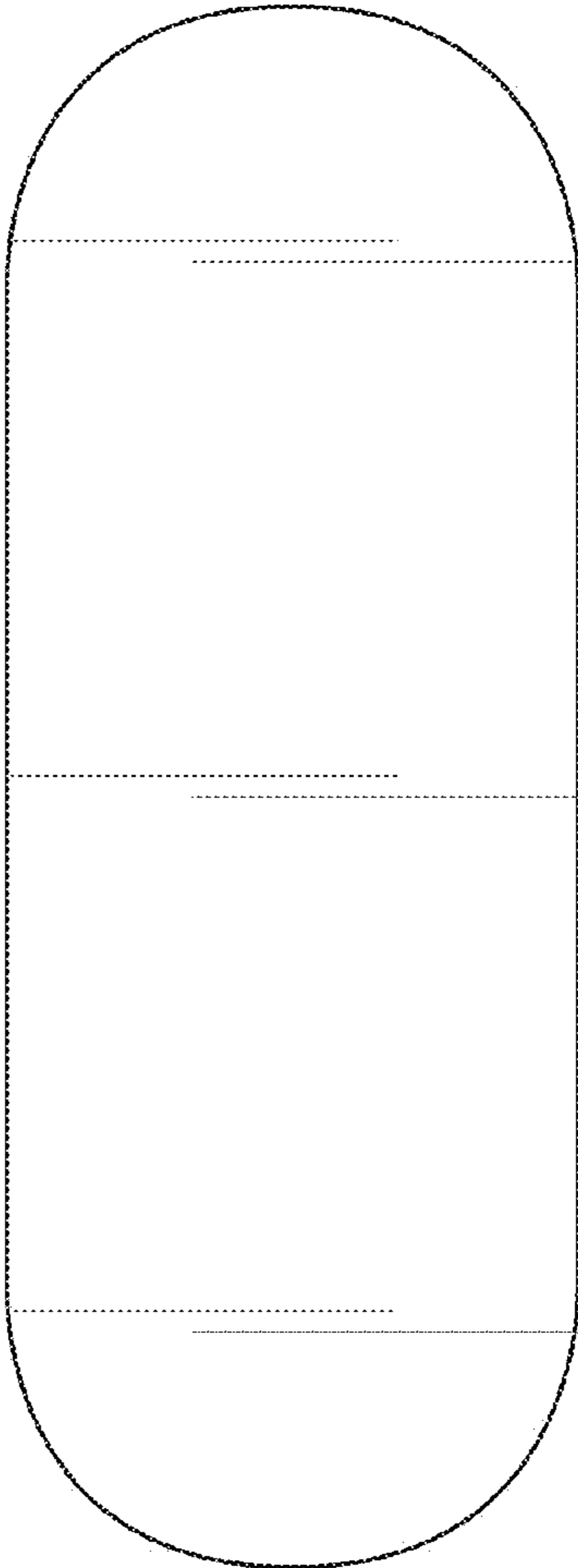

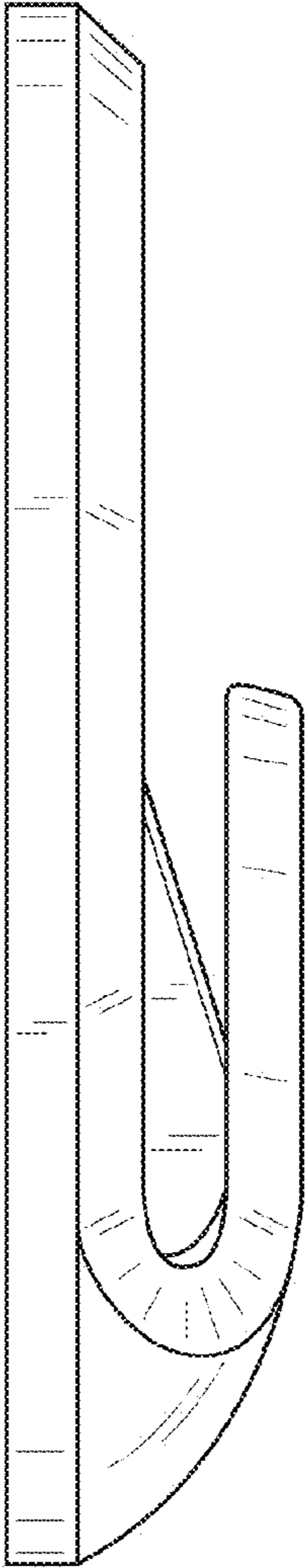

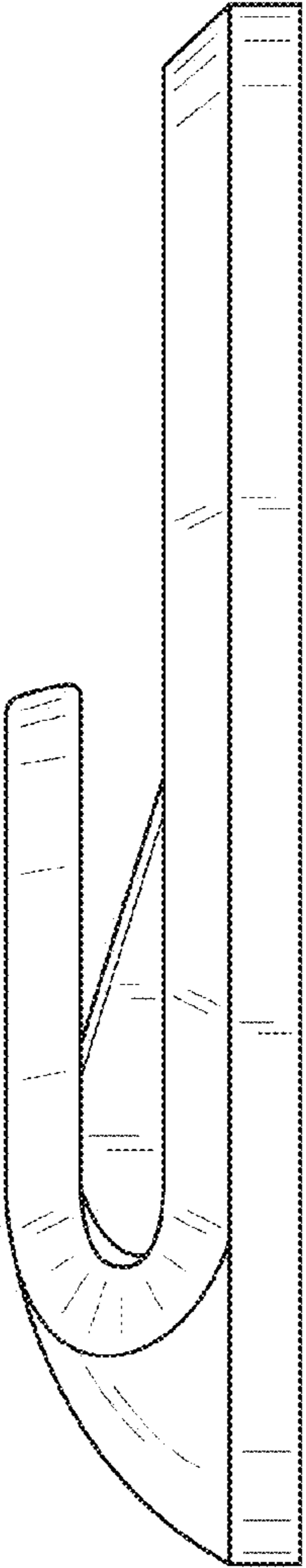
