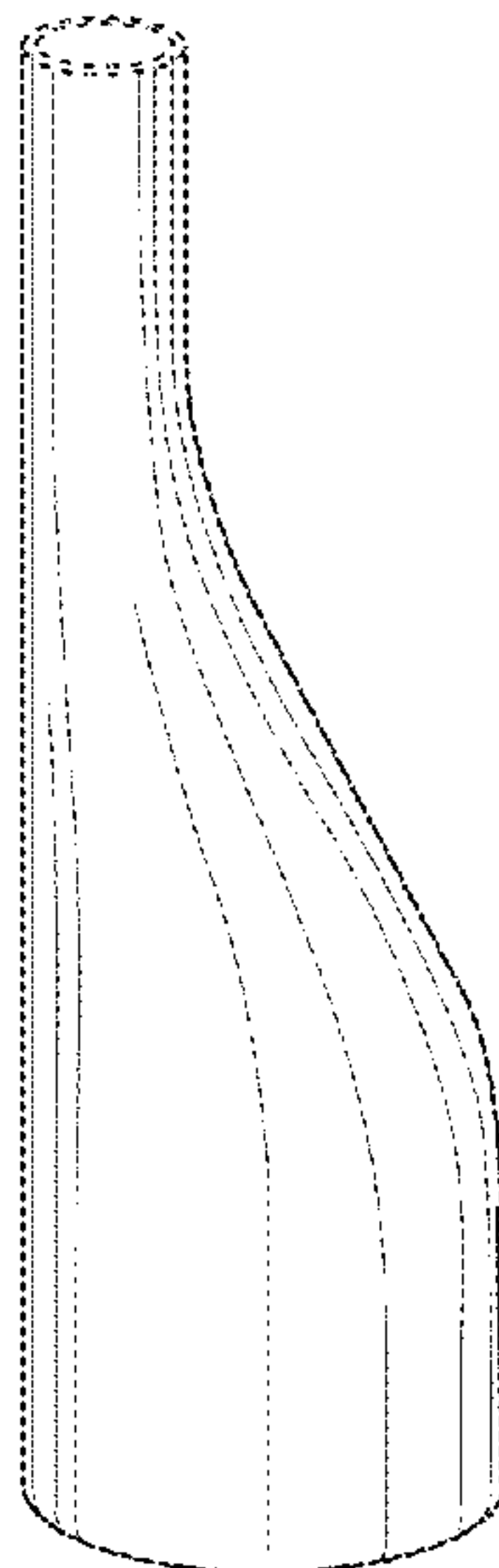
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front left perspective view of a bottle showing my new design;
FIG. 2 is a front right perspective view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a right elevation view thereof;
FIG. 6 is a left elevation view thereof;
FIG. 7 is a top plan view thereof; and,
FIG. 8 is a bottom plan view thereof.

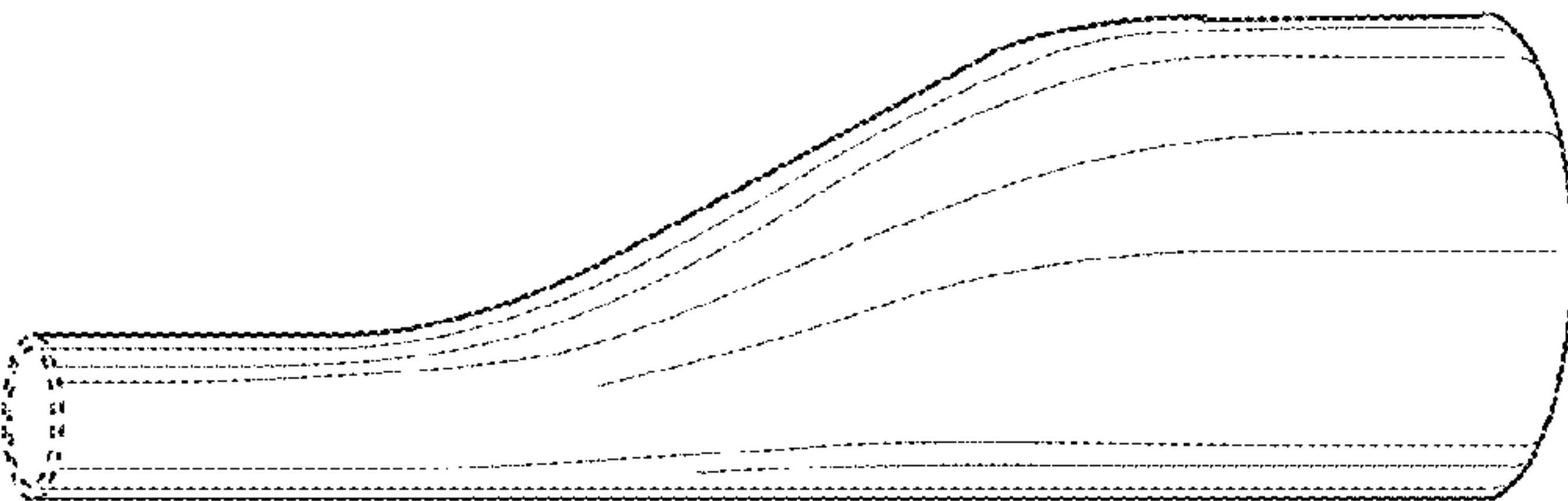

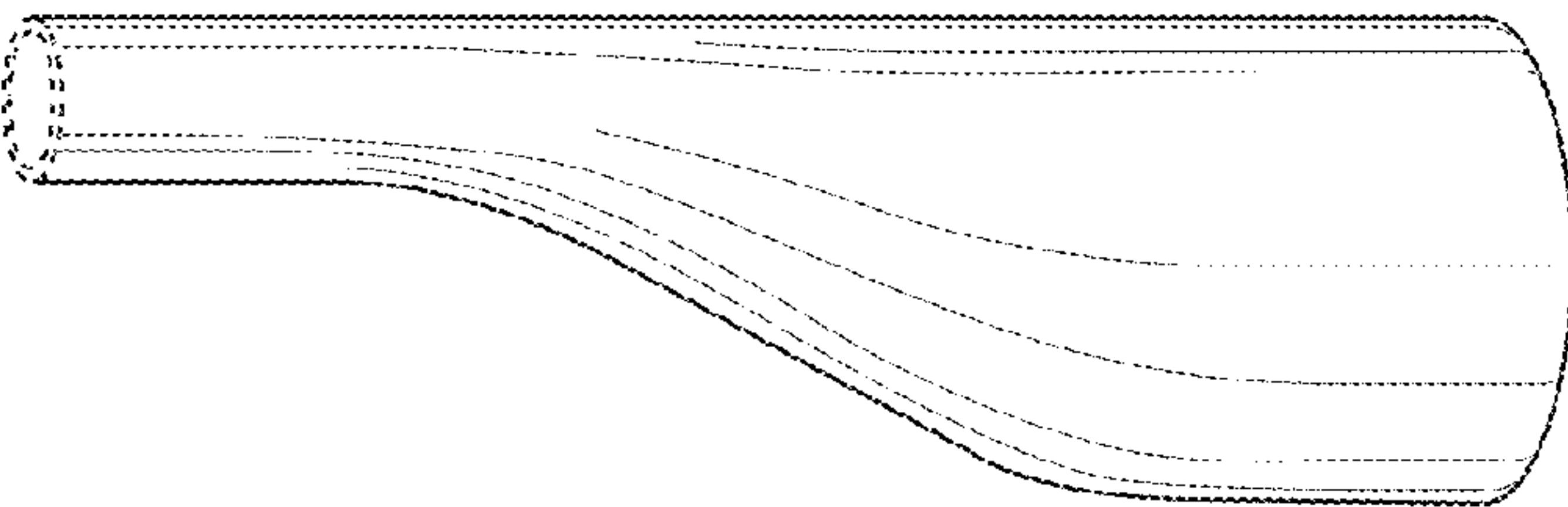

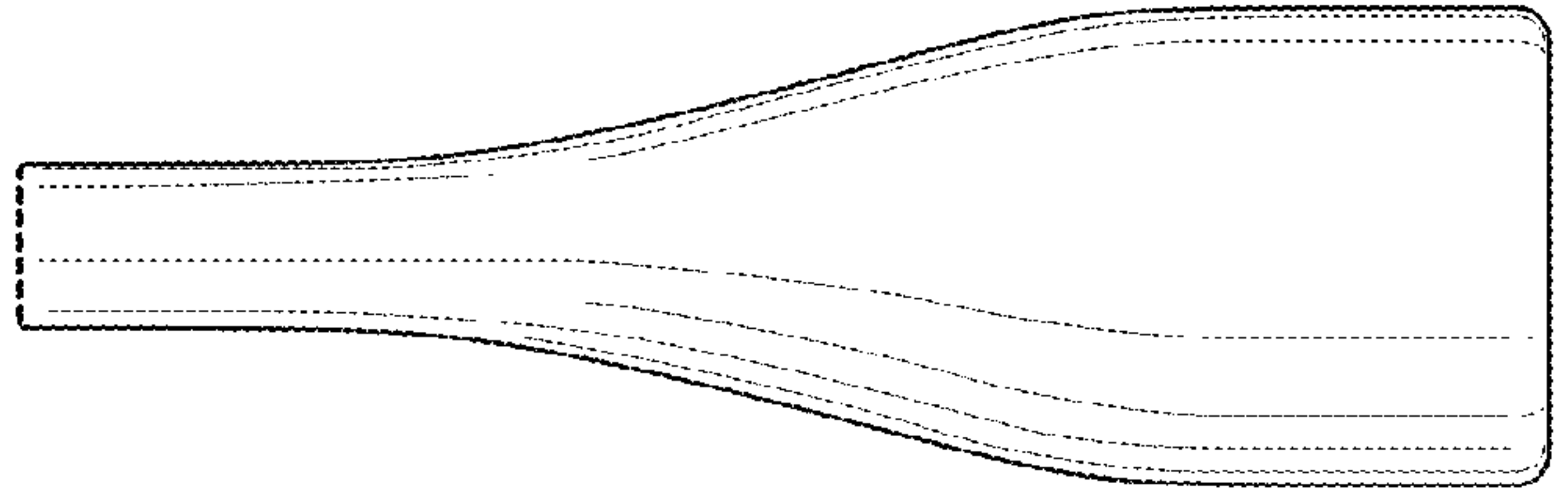

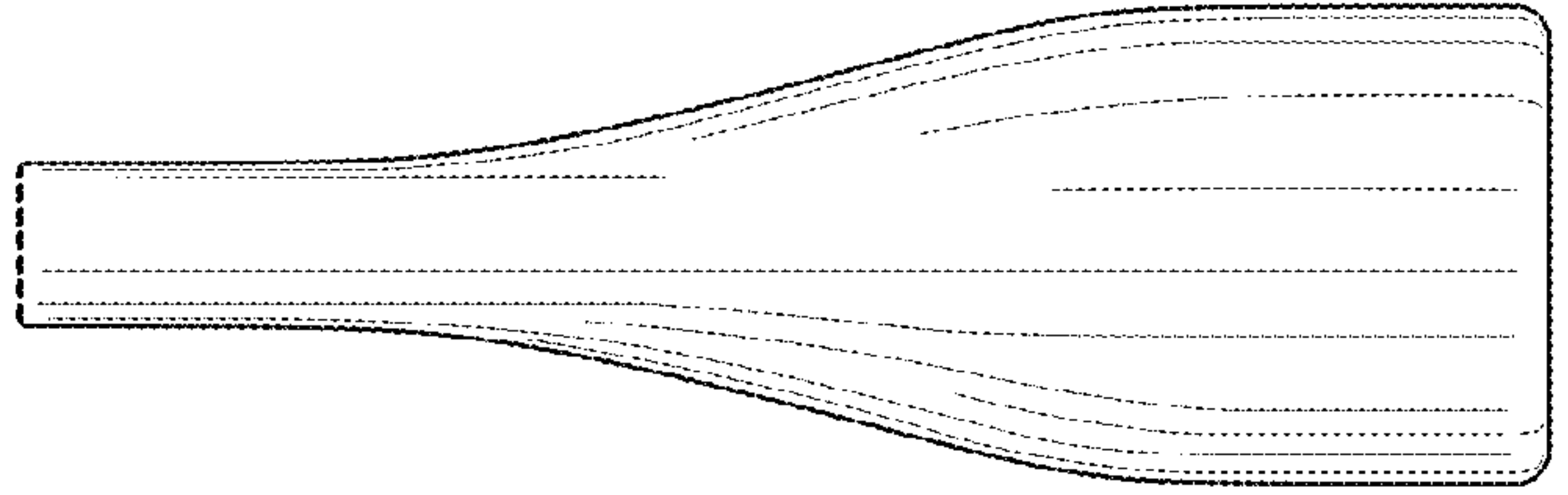

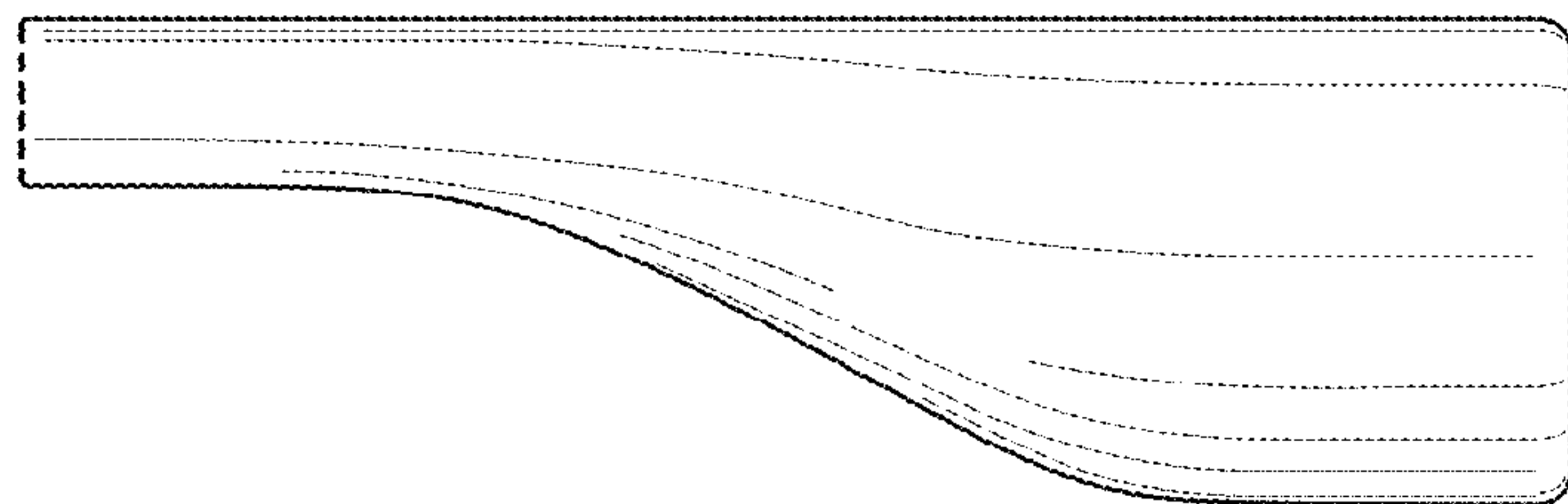

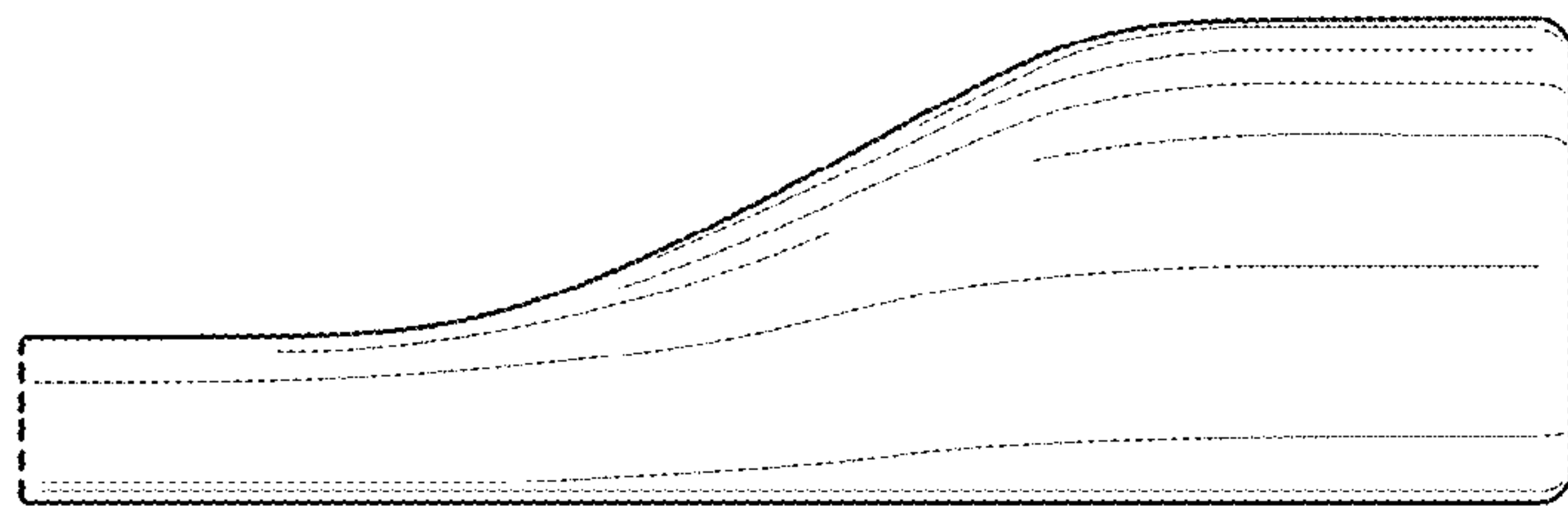

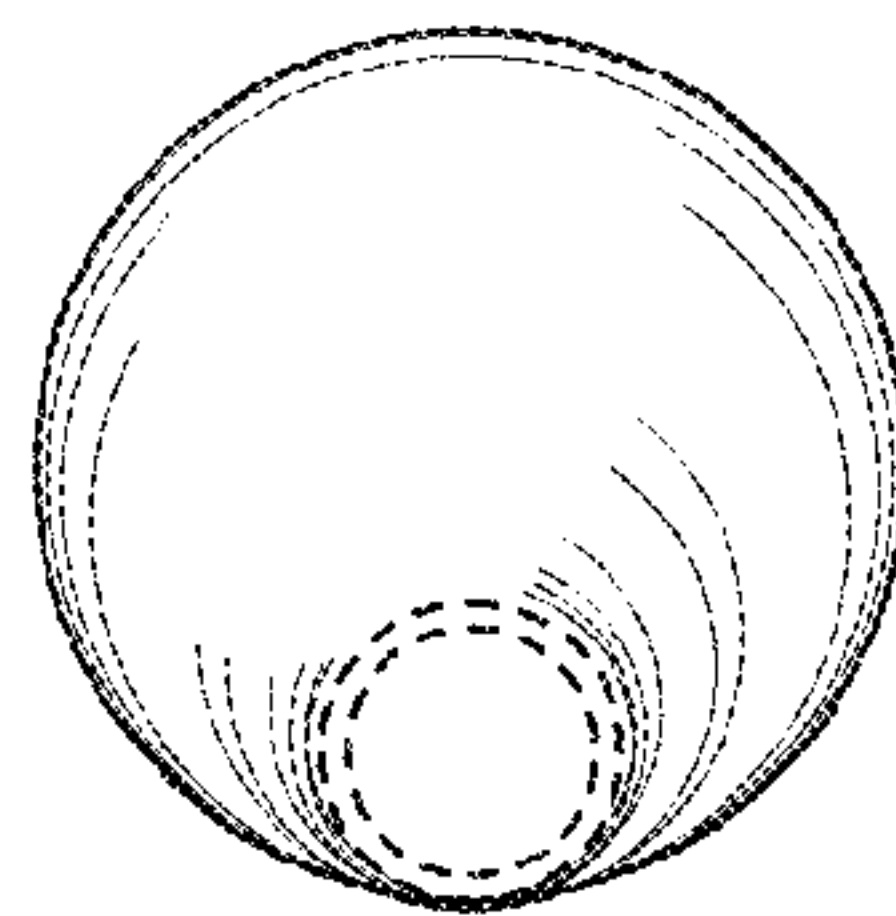

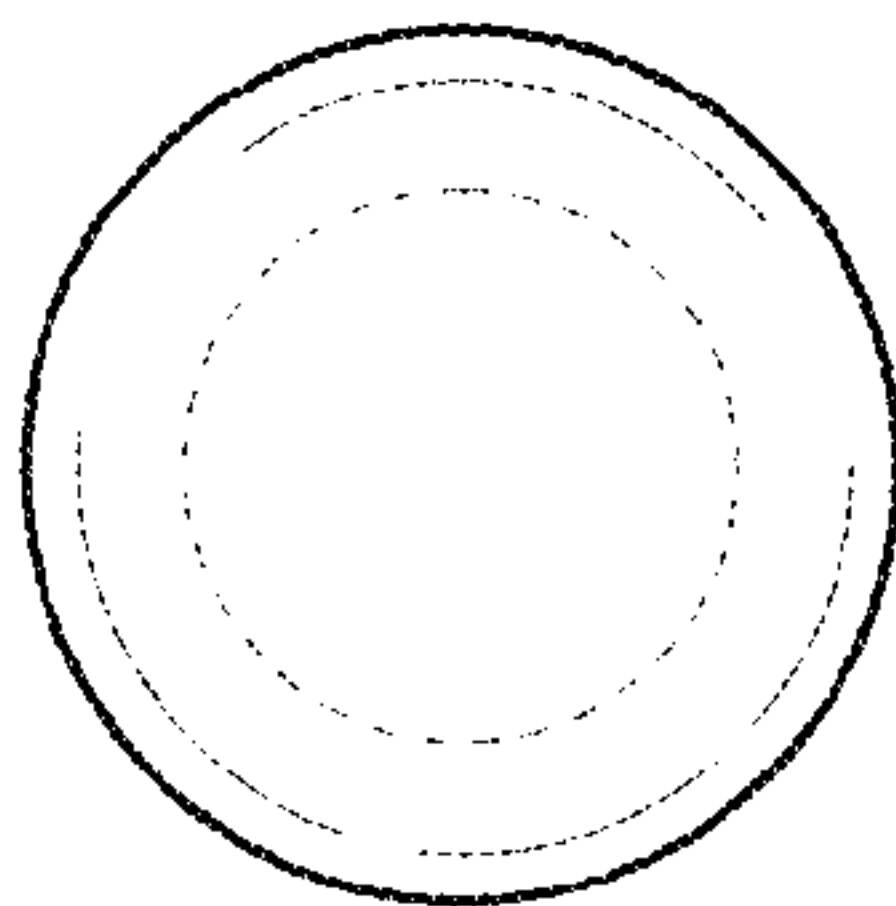
