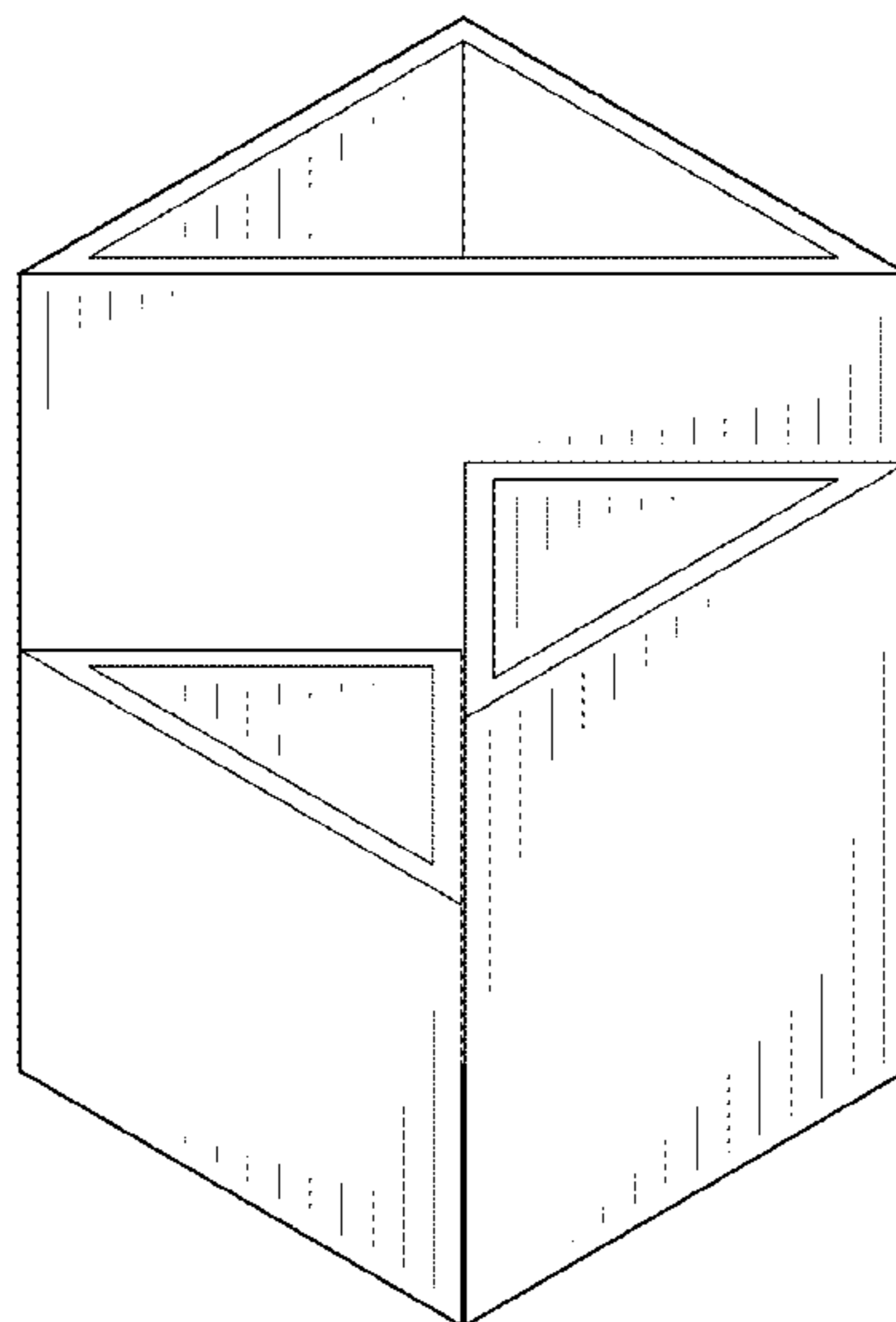
(57) **CLAIM**
The ornamental design for a planter, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a planter showing my new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a right side elevation thereof;
FIG. 4 is a left side elevation view thereof;
FIG. 5 is a back elevation view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
The broken lines in FIG. 6 are included for the purpose of showing portions of the planter that form no part of the claimed design.

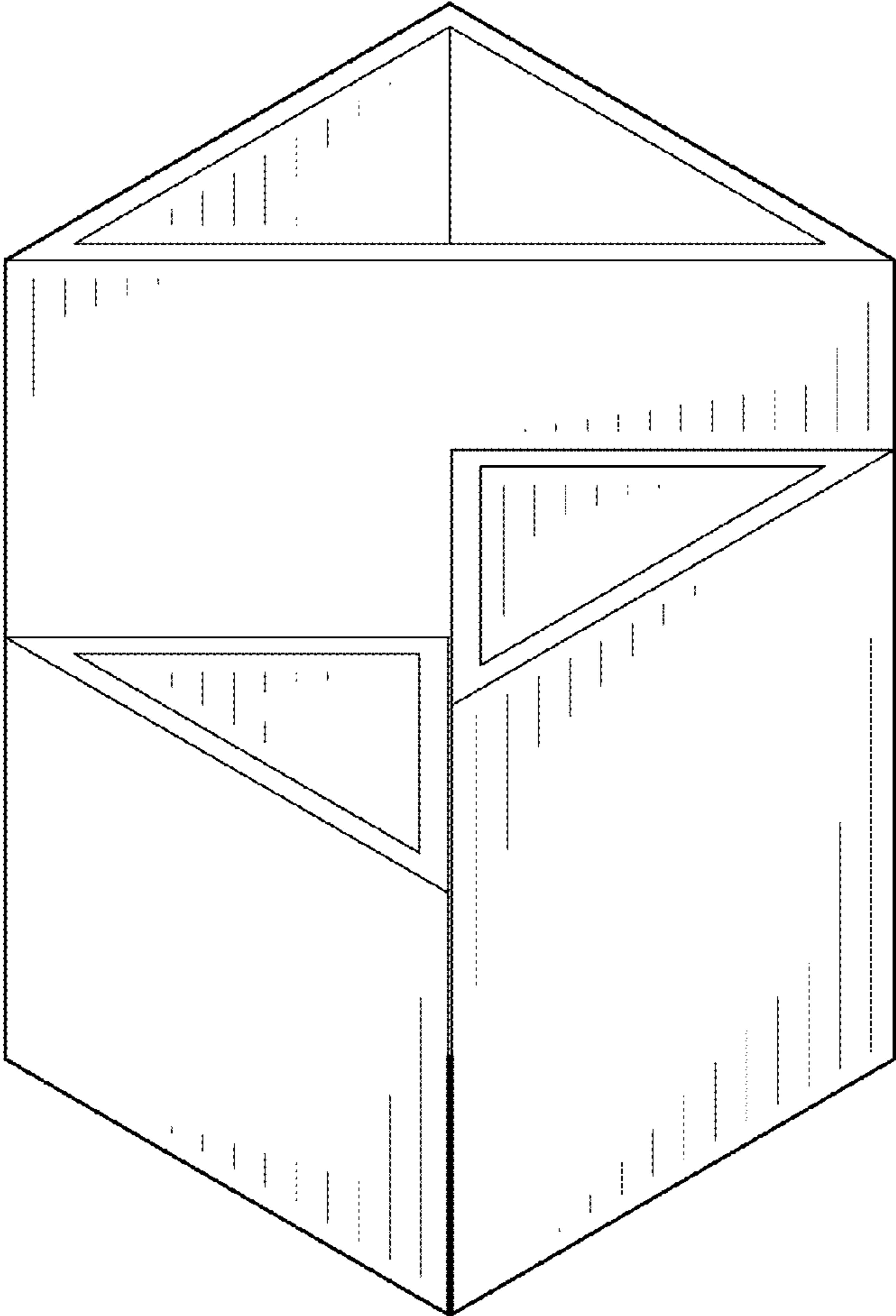

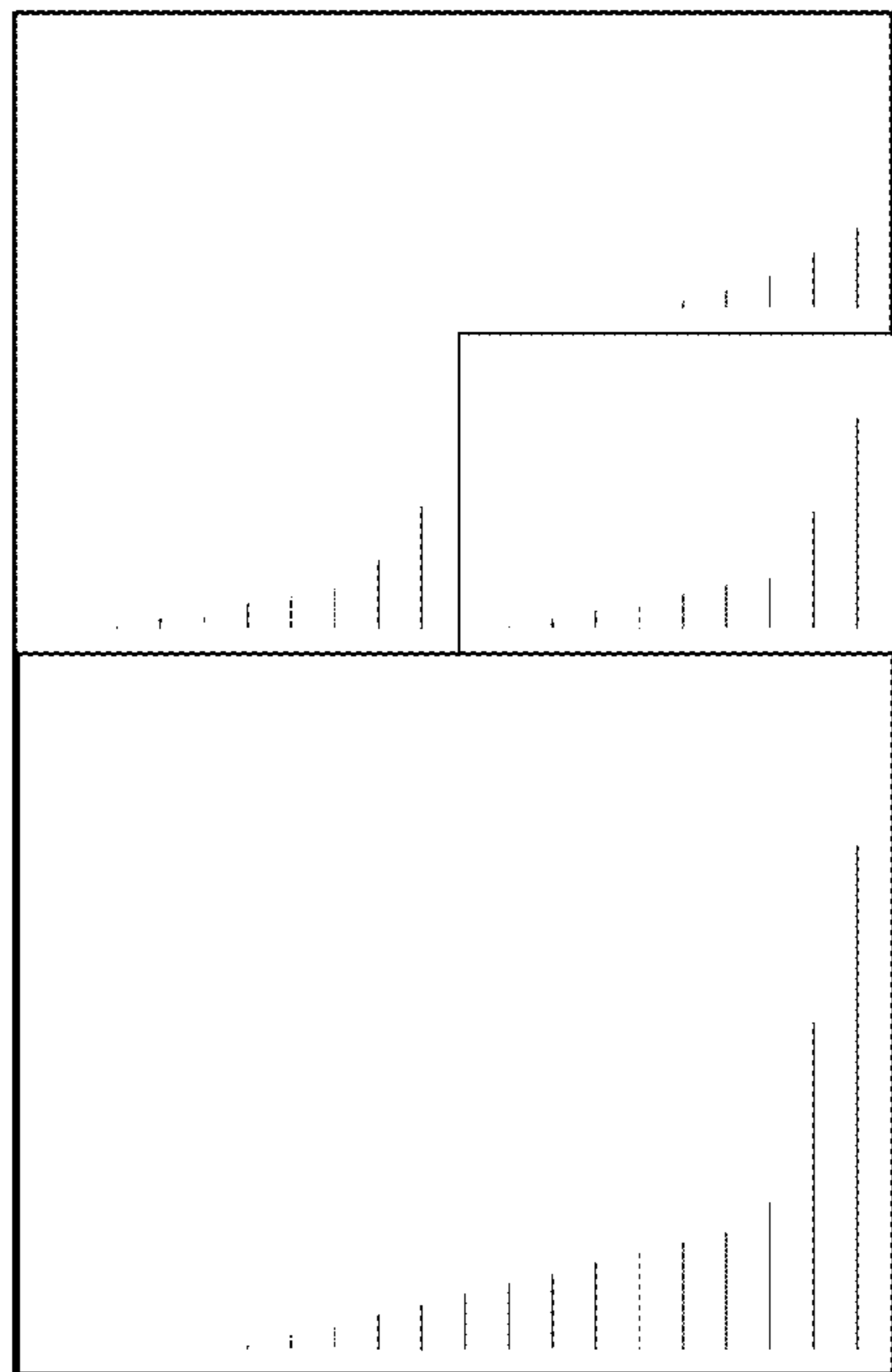

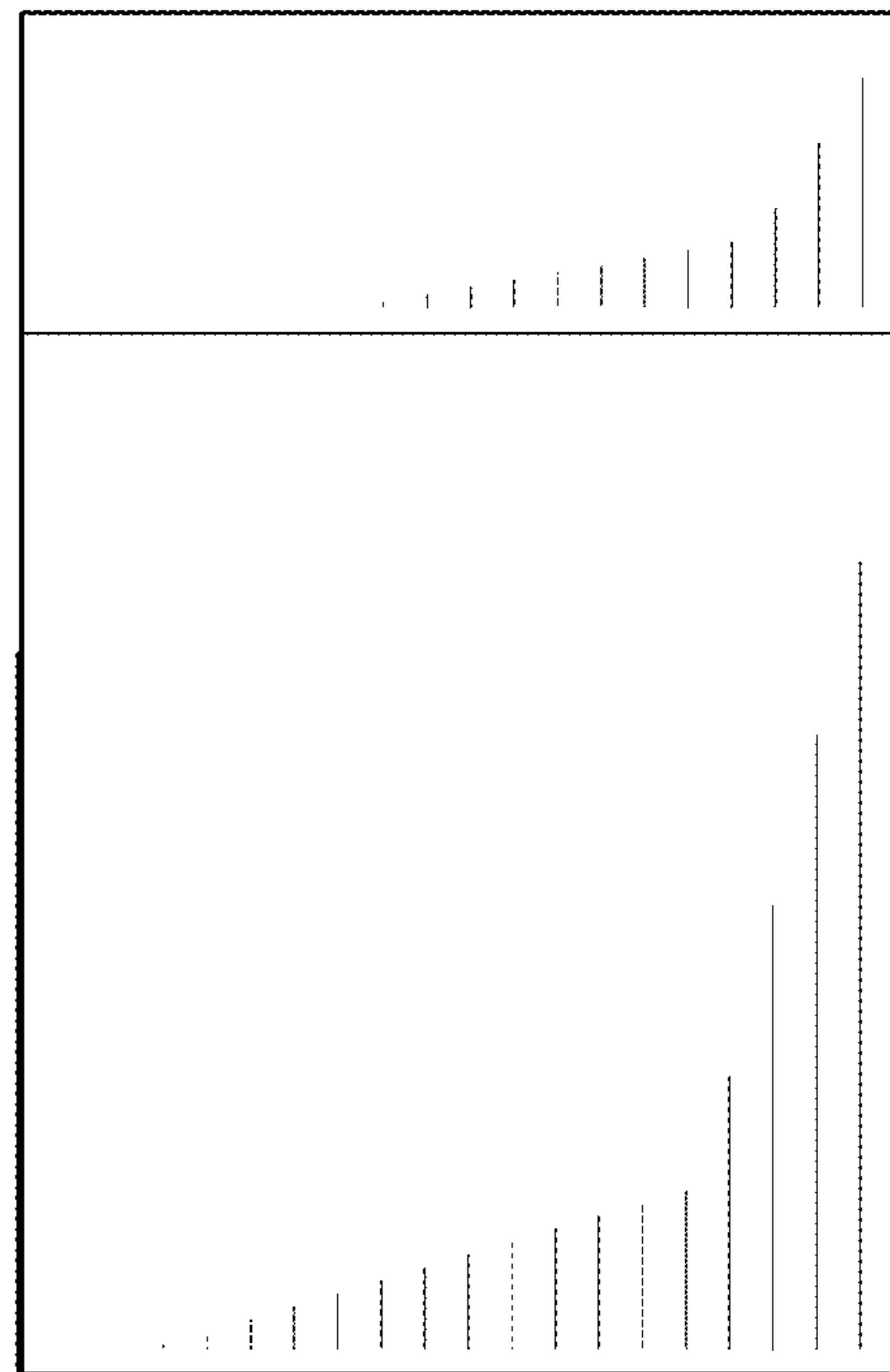

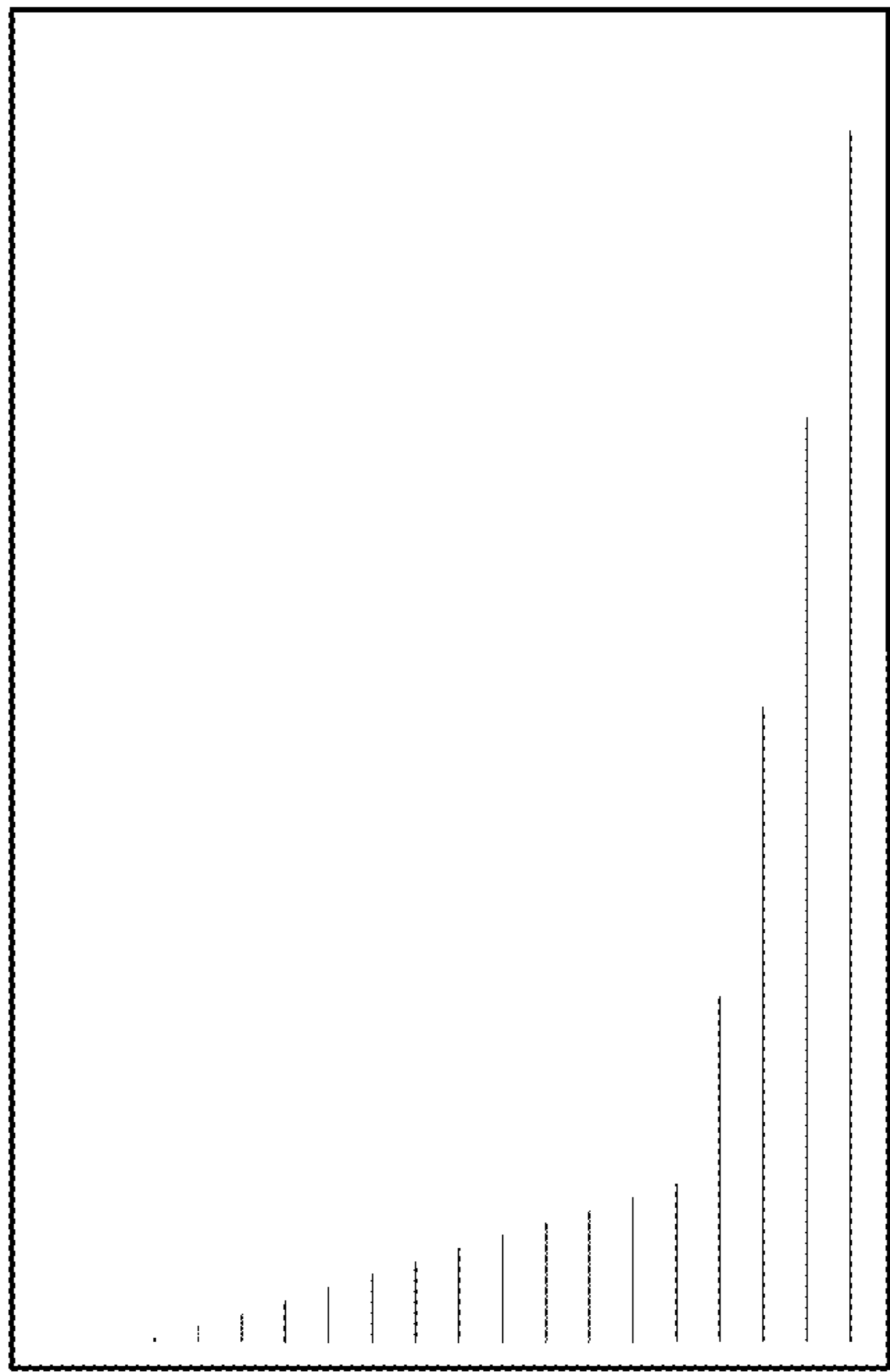

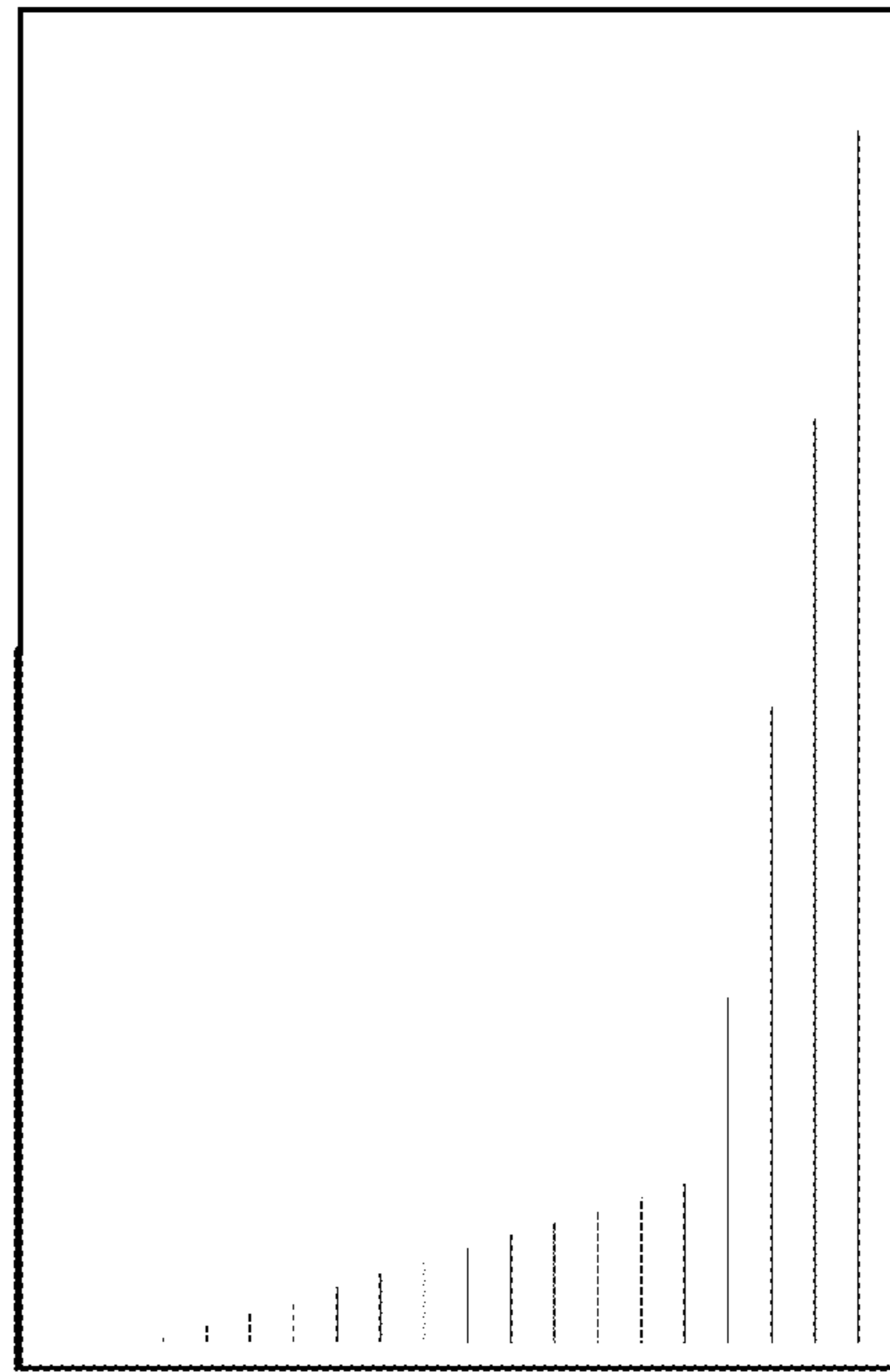

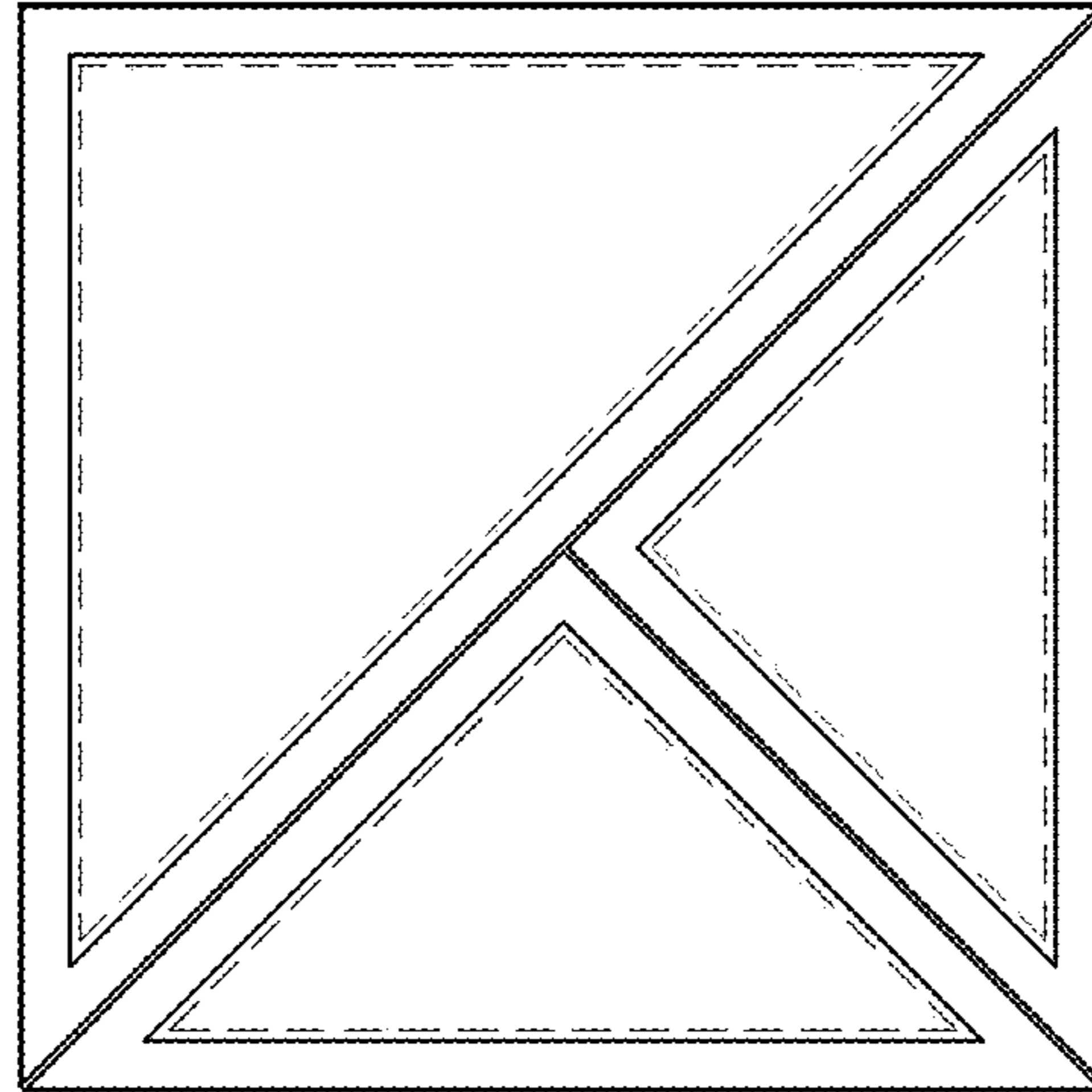

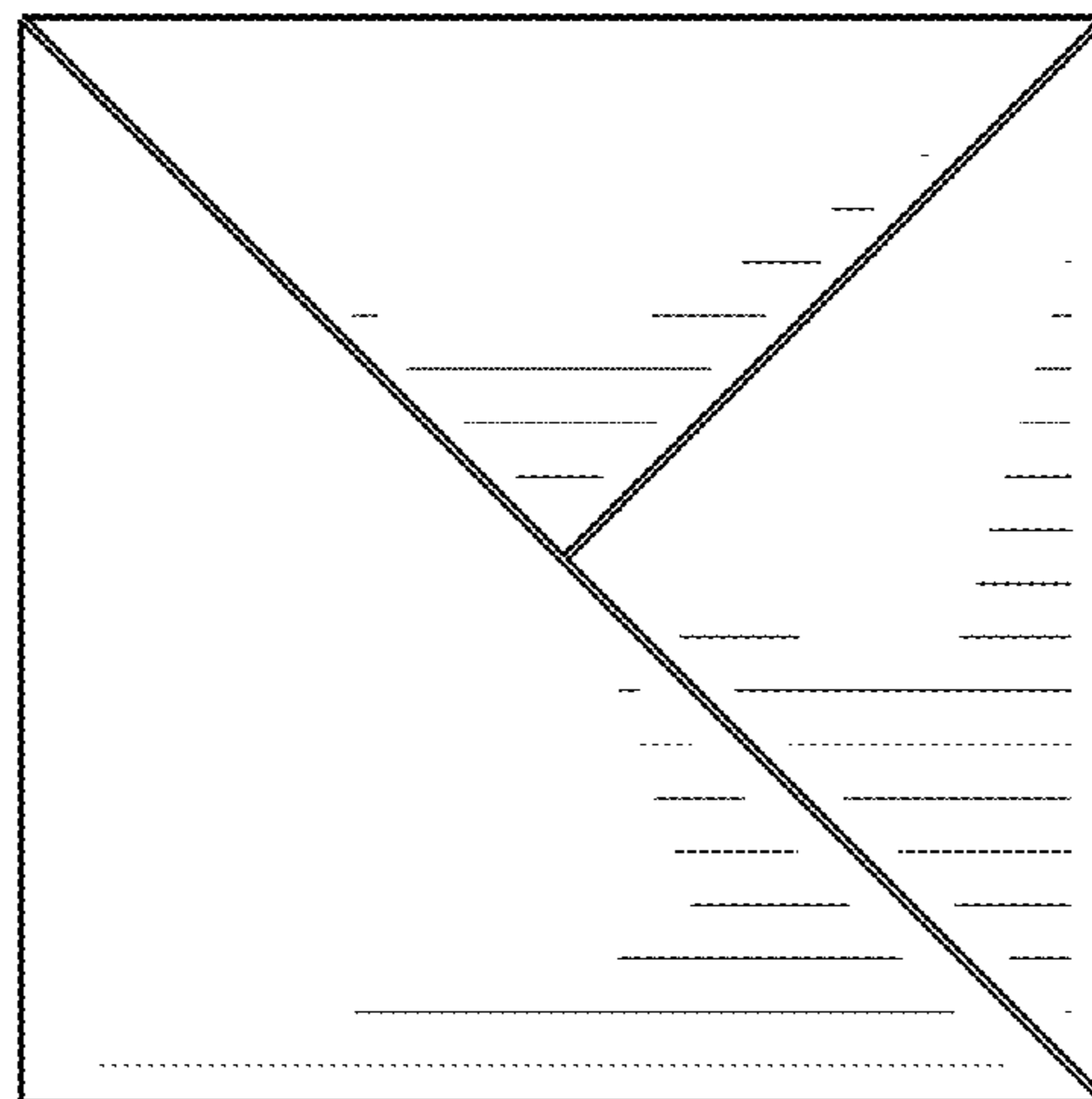
