8.

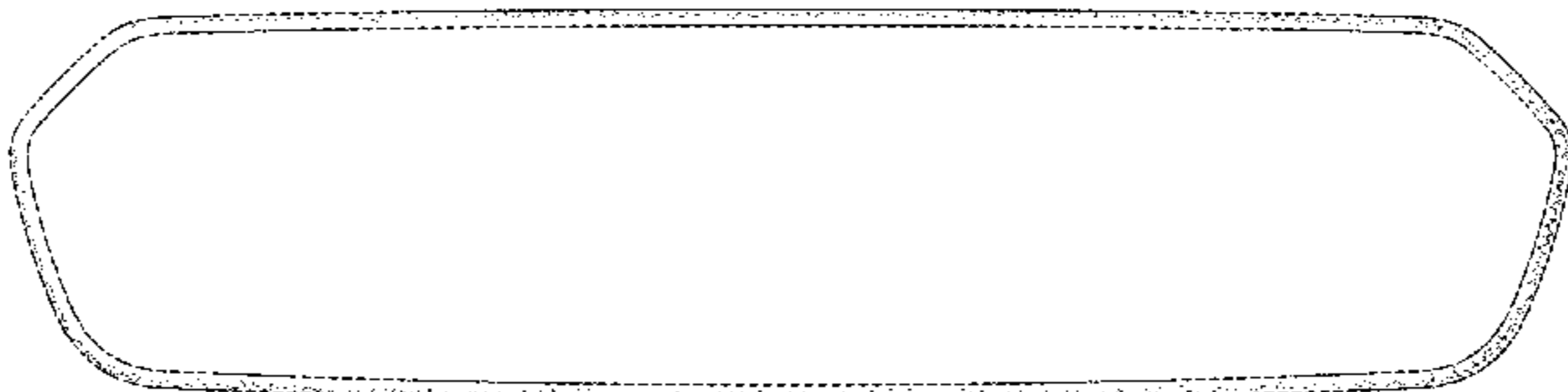

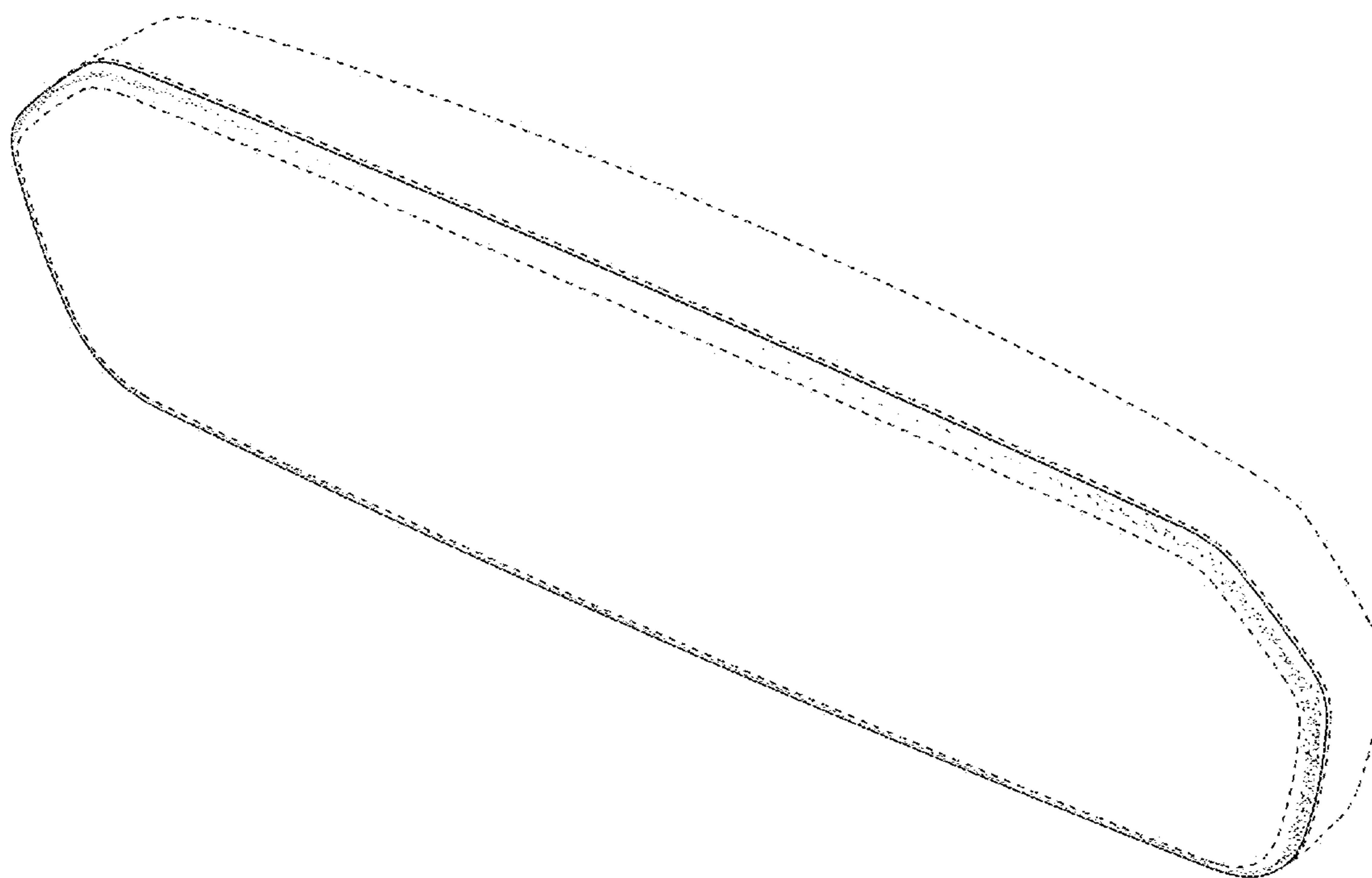

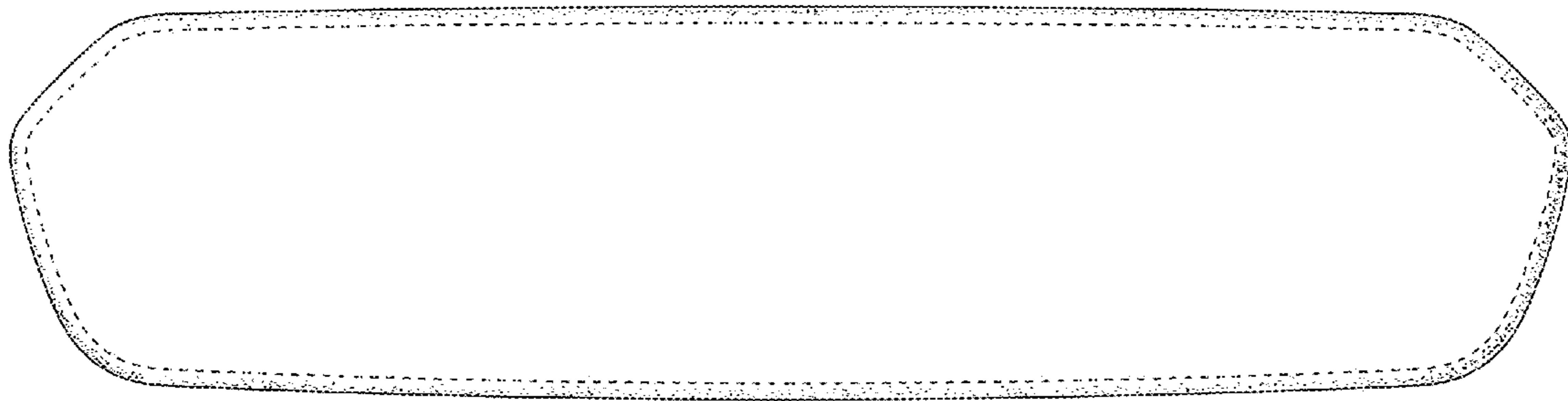

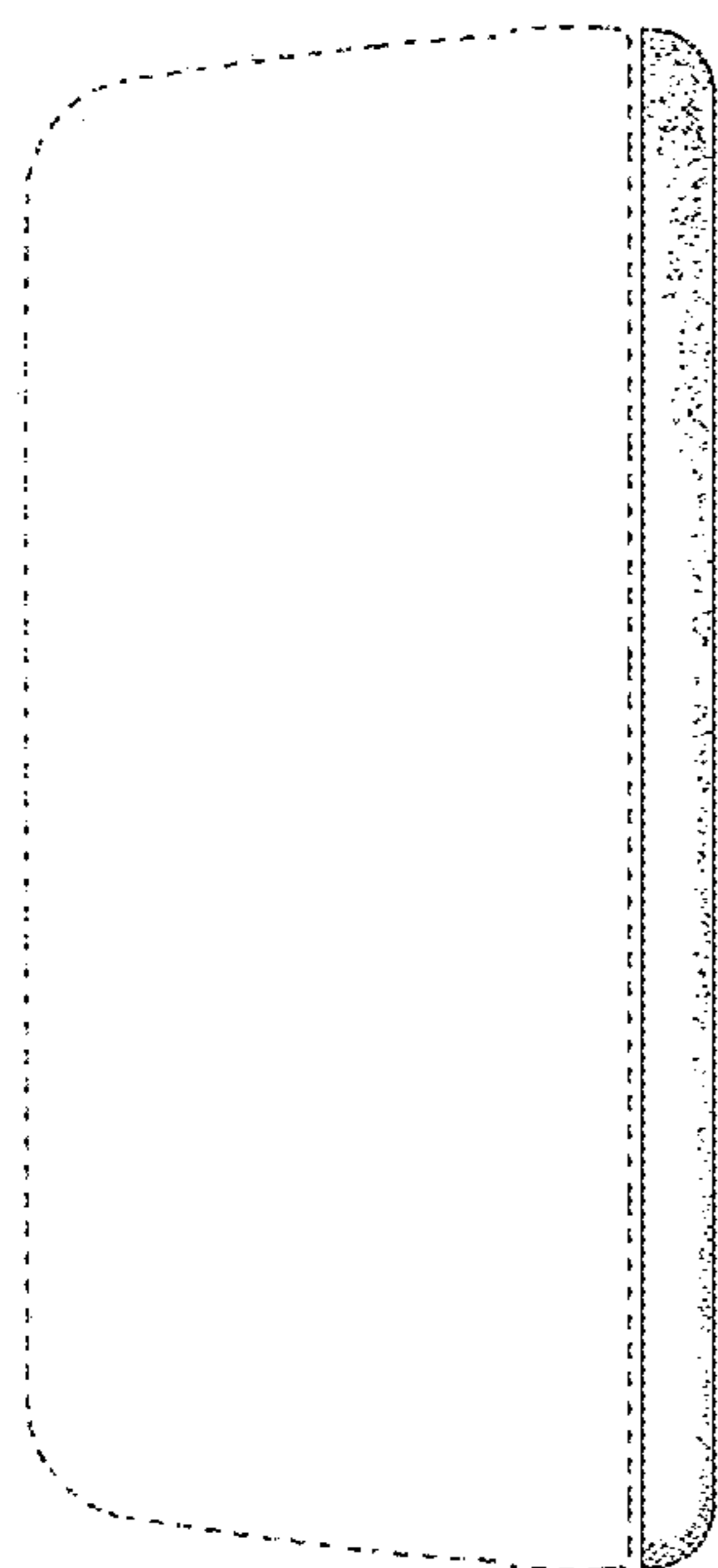

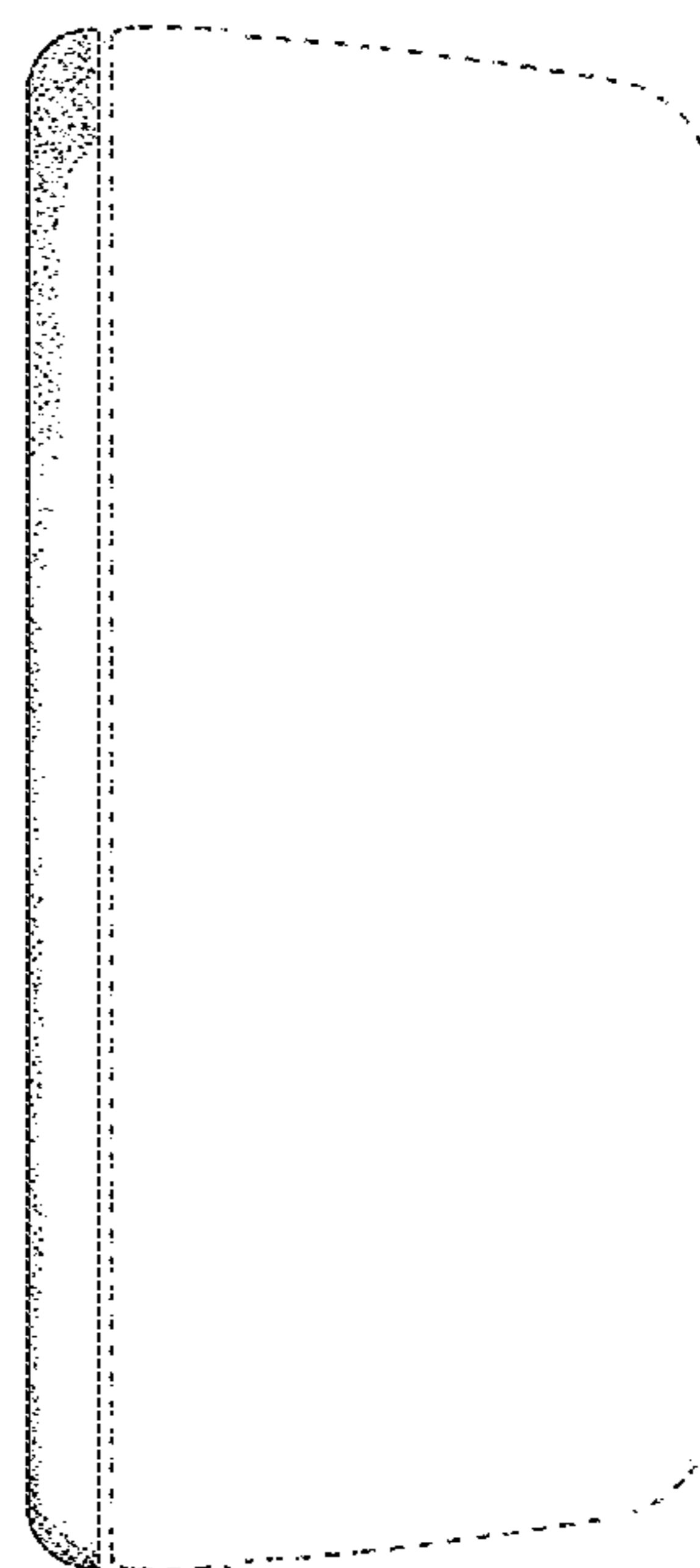

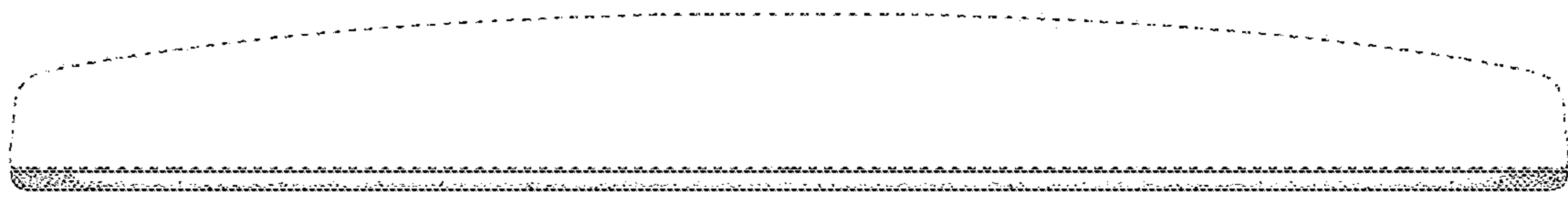

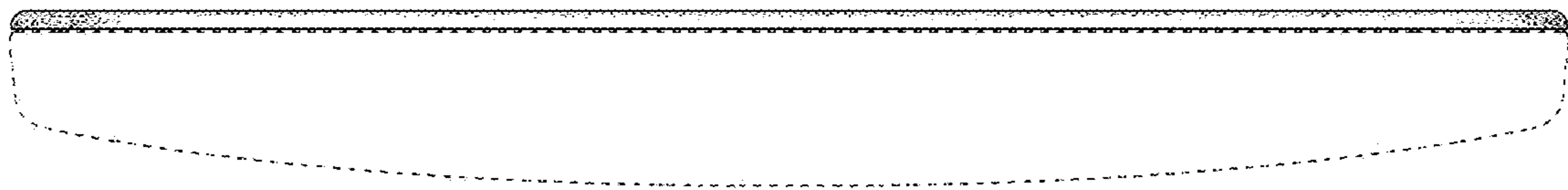

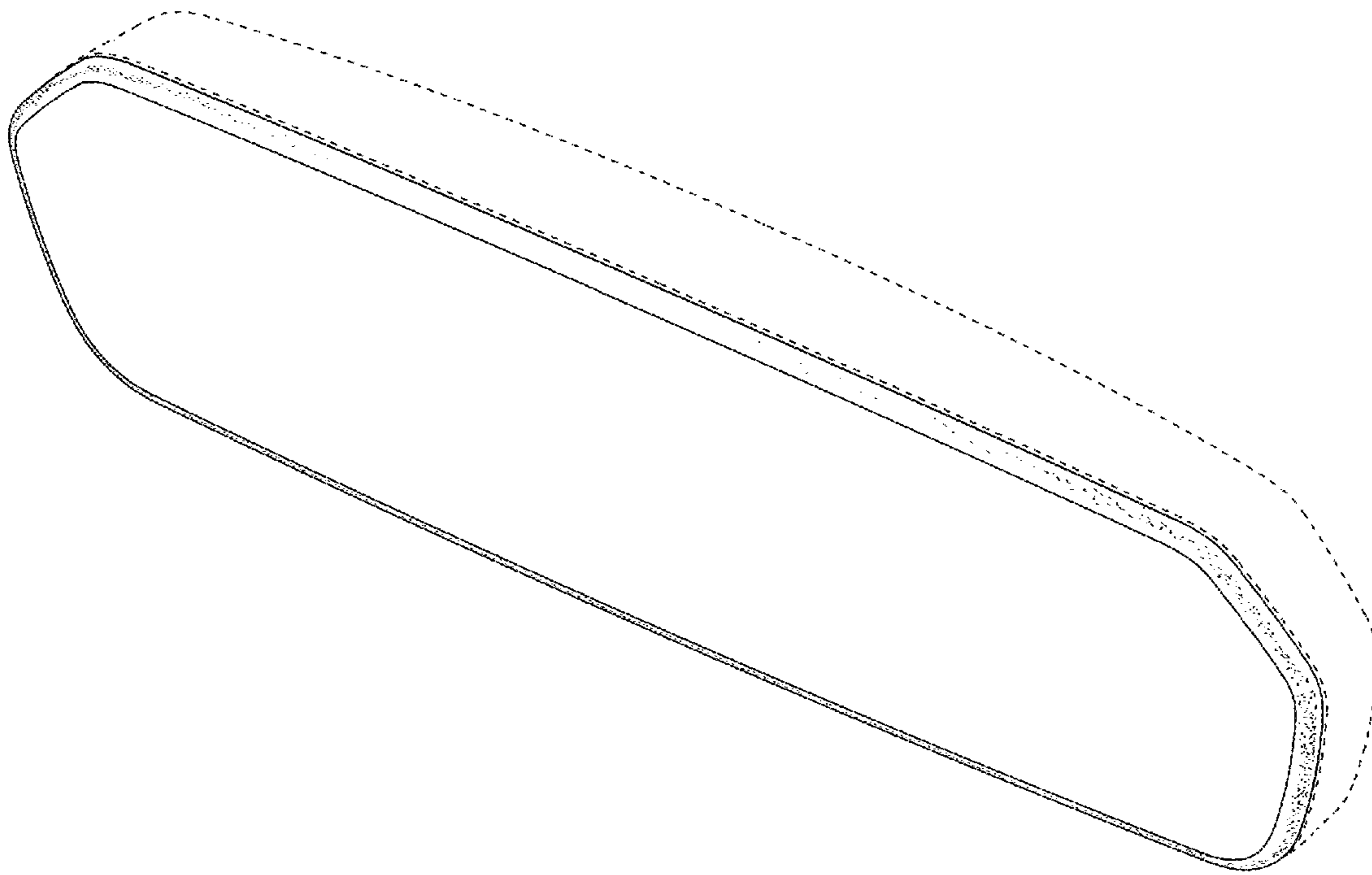

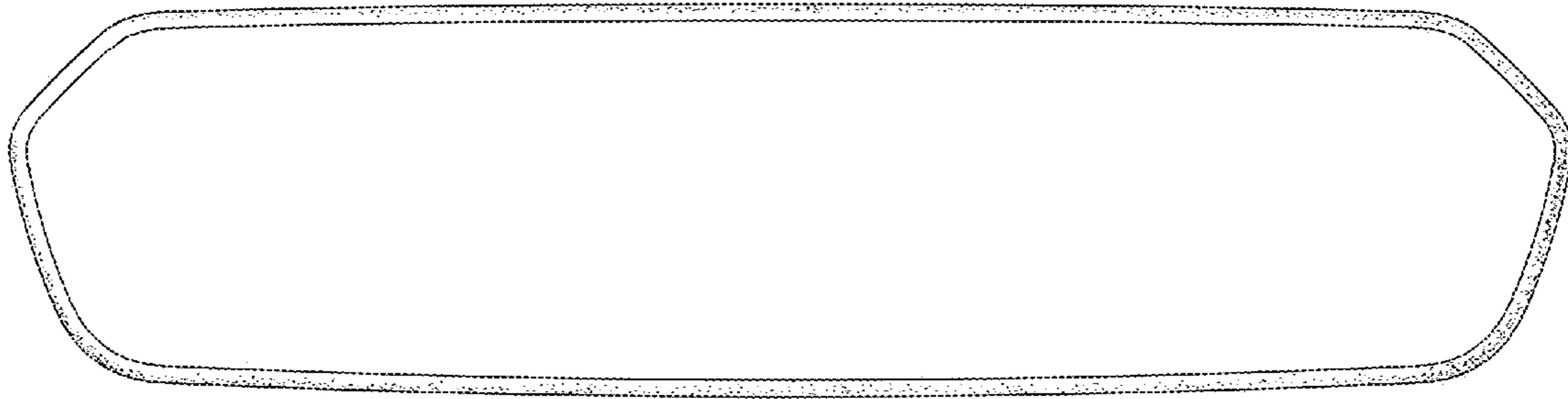

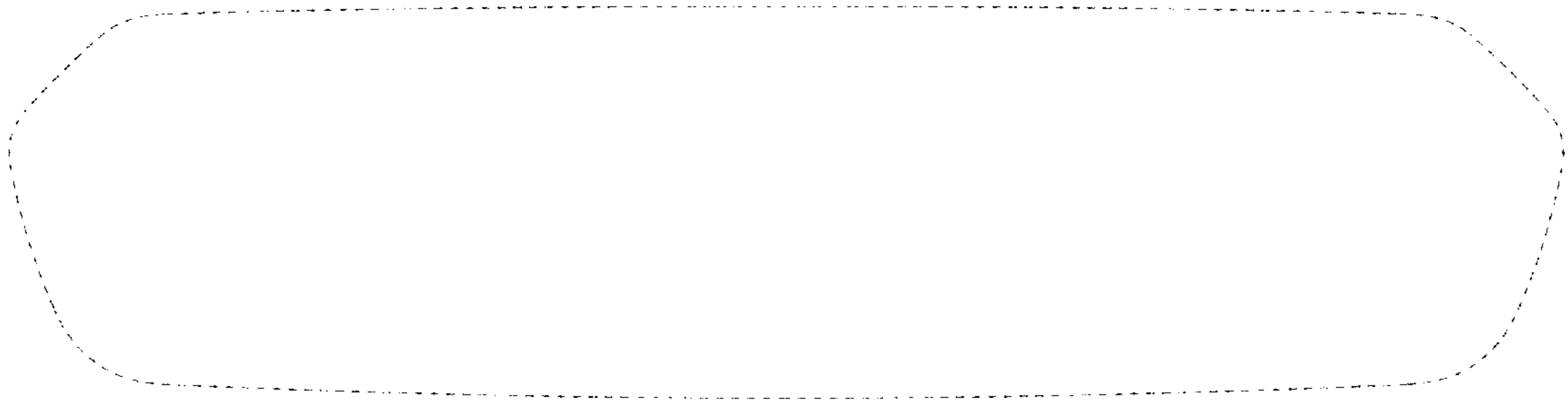

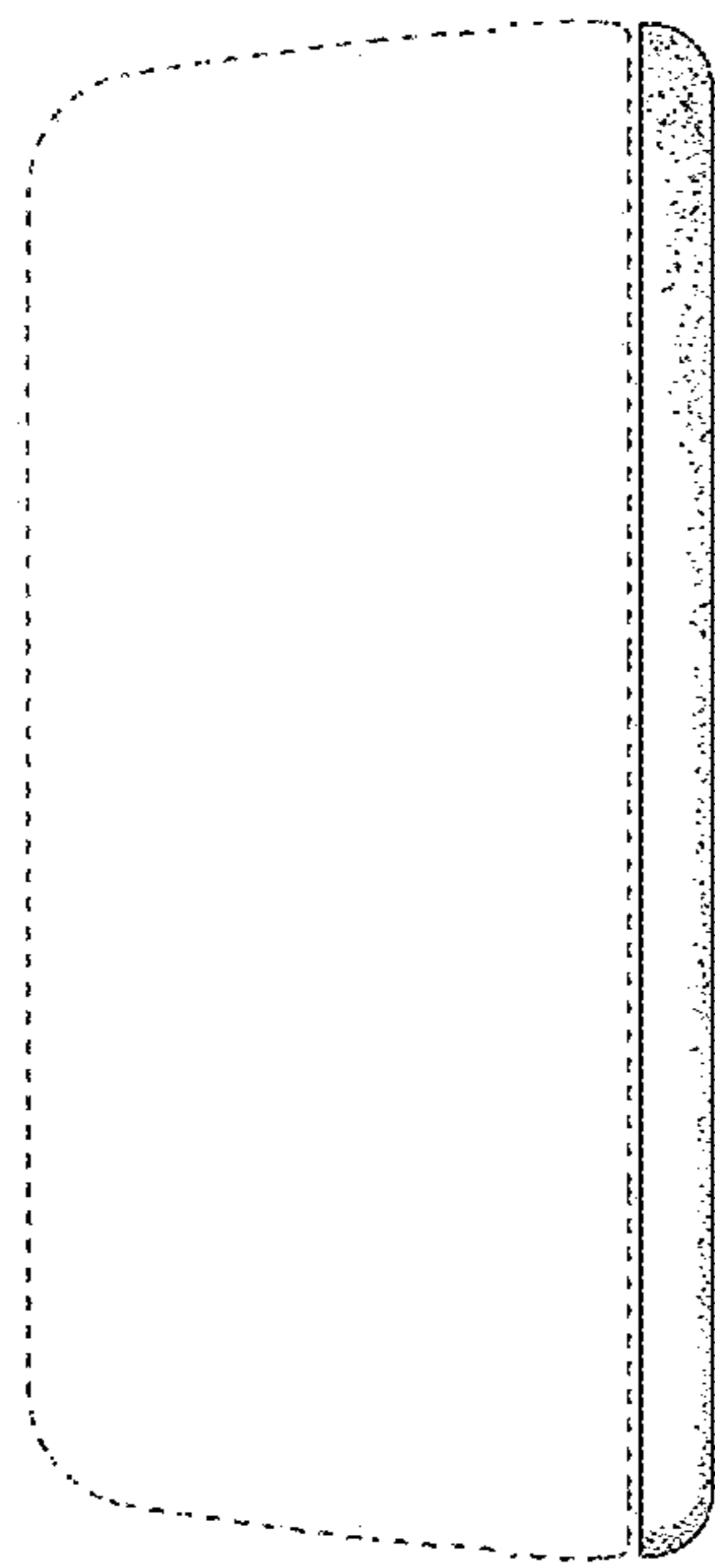

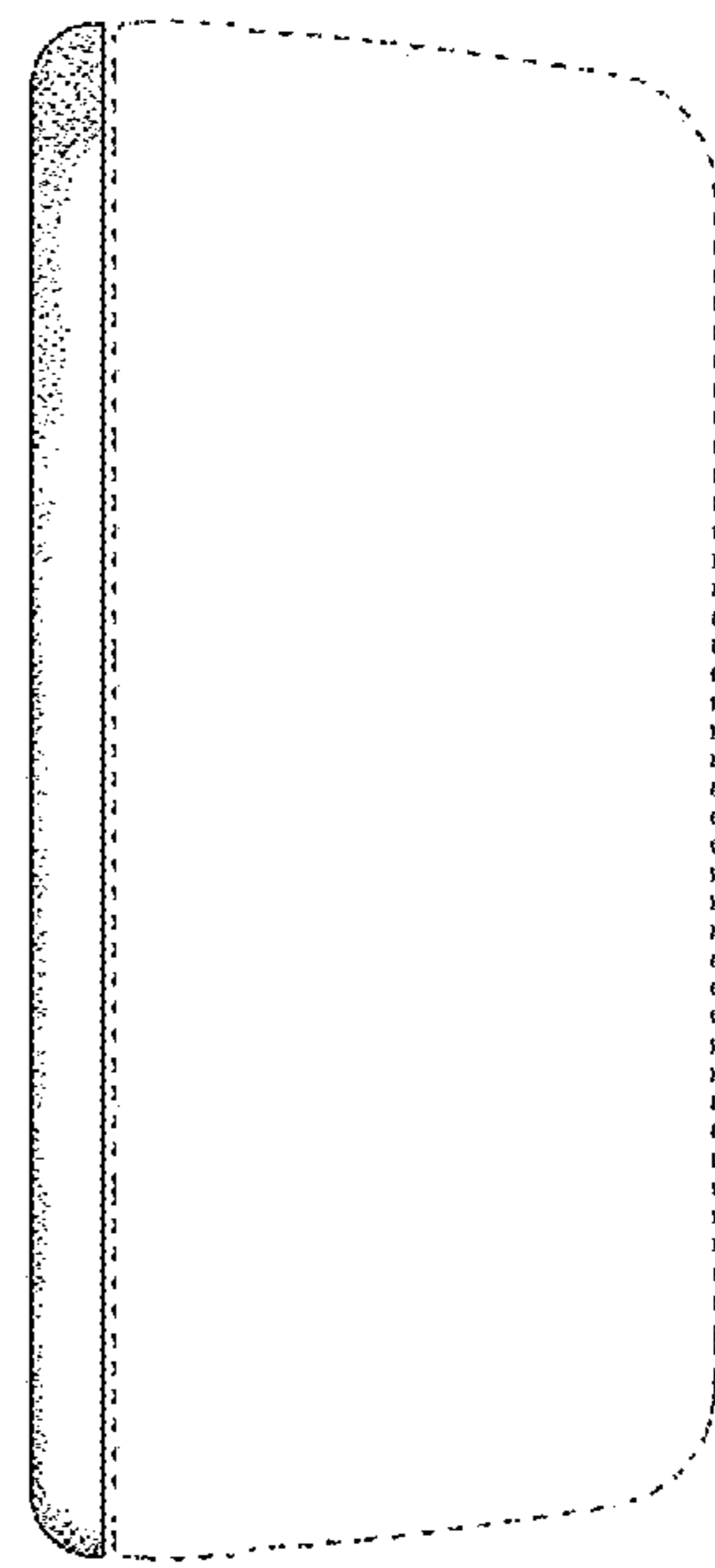

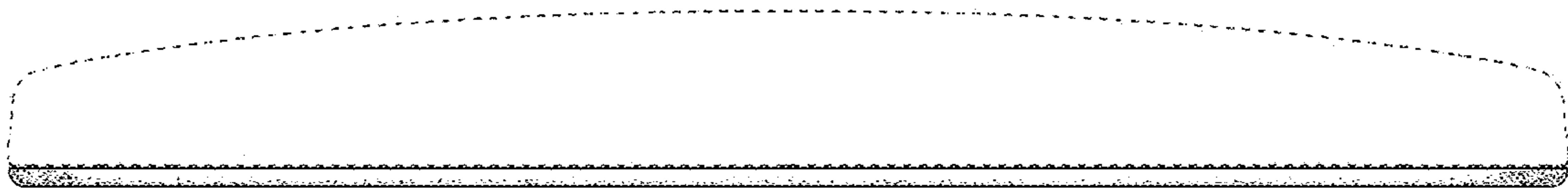

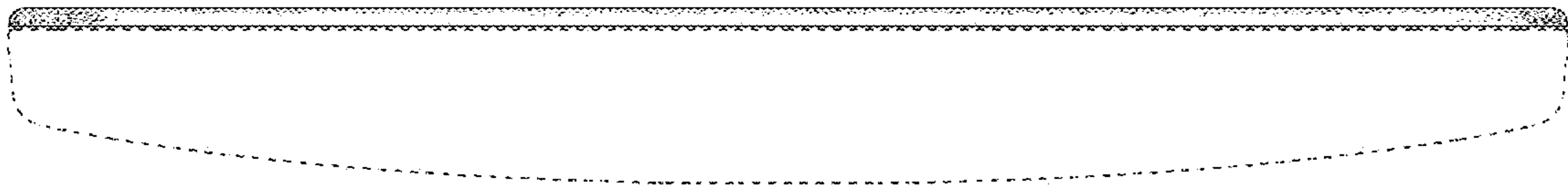
