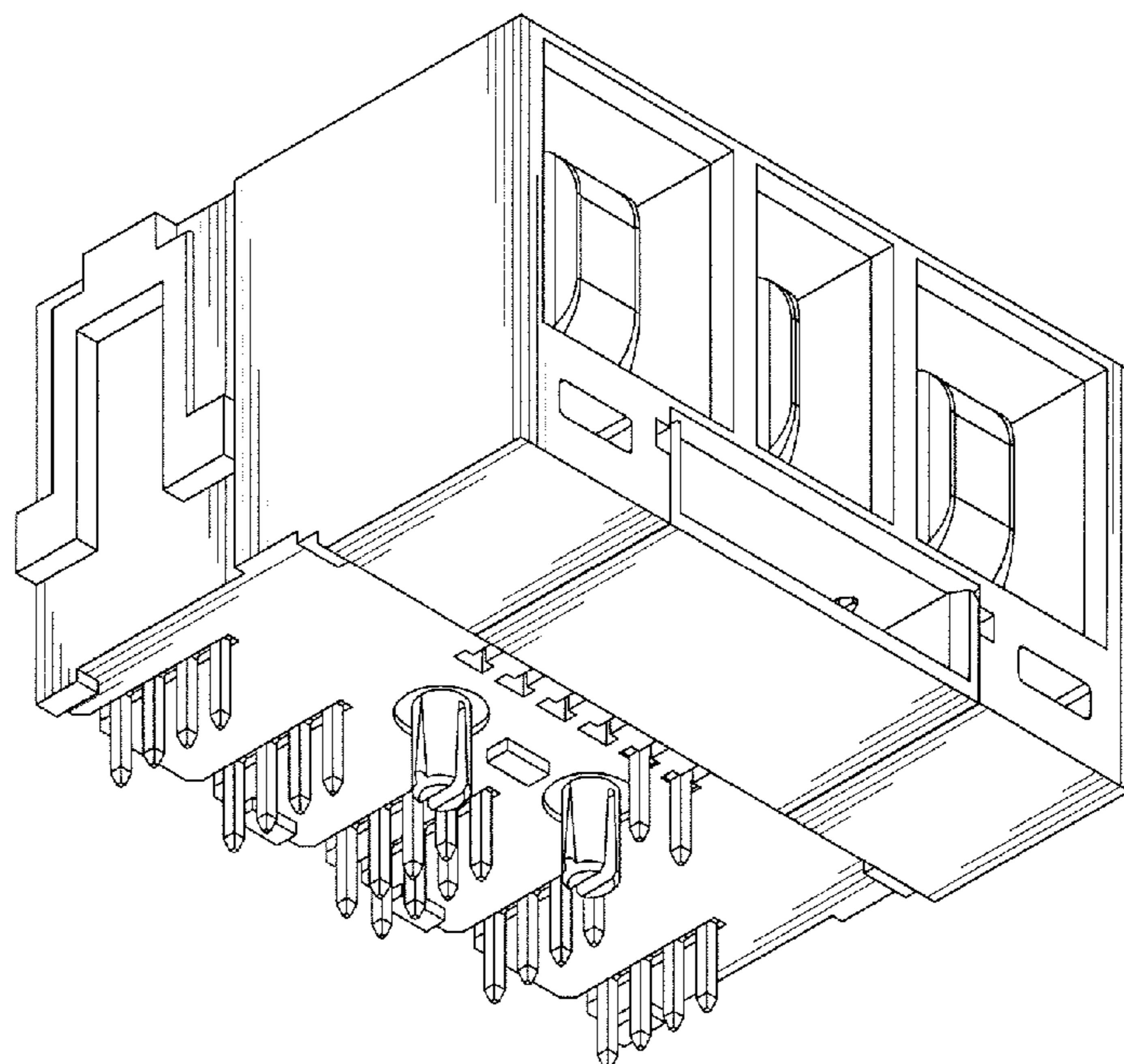
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, bottom, and left side perspective view of a power male connector showing my new design;

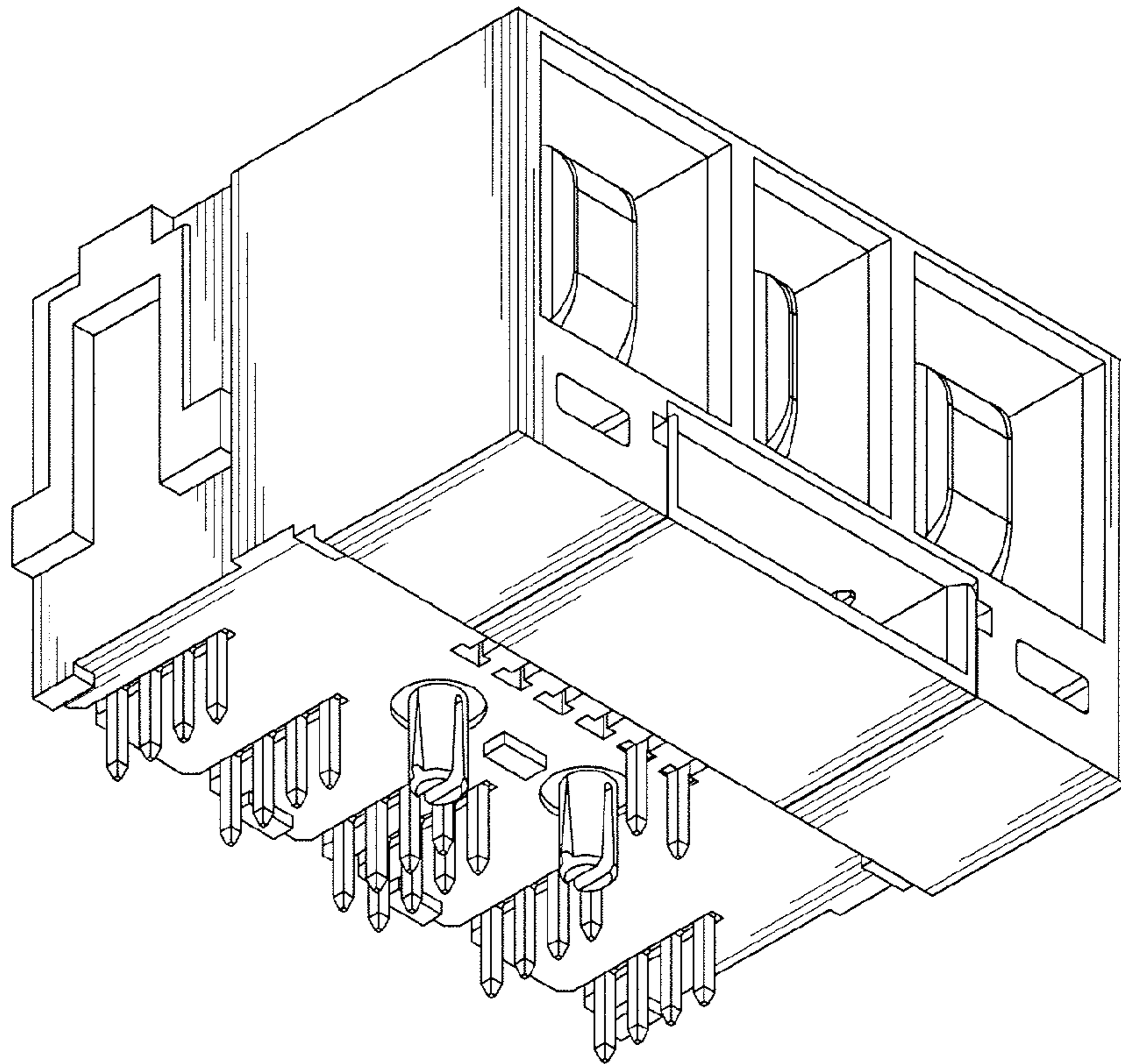

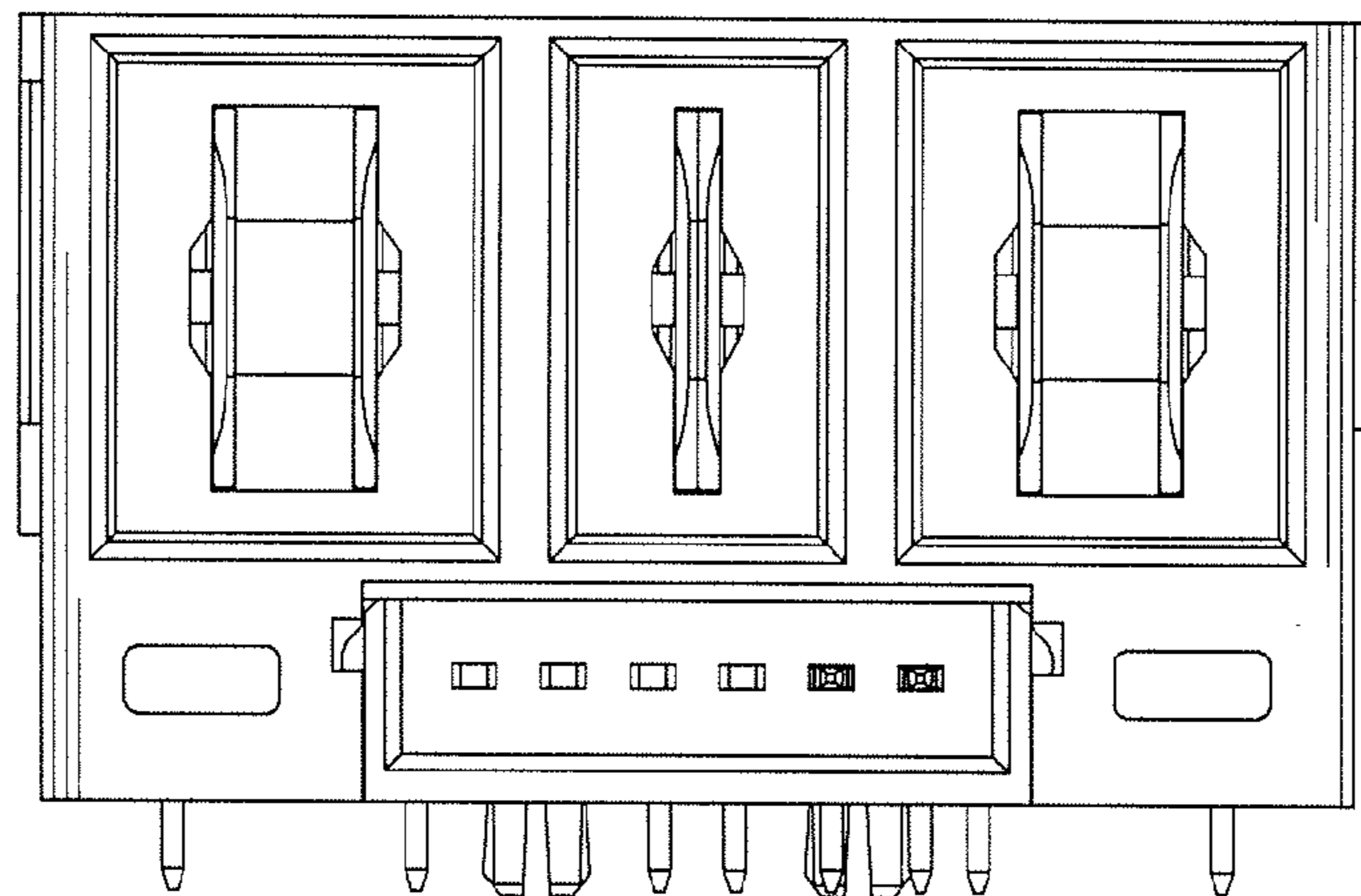

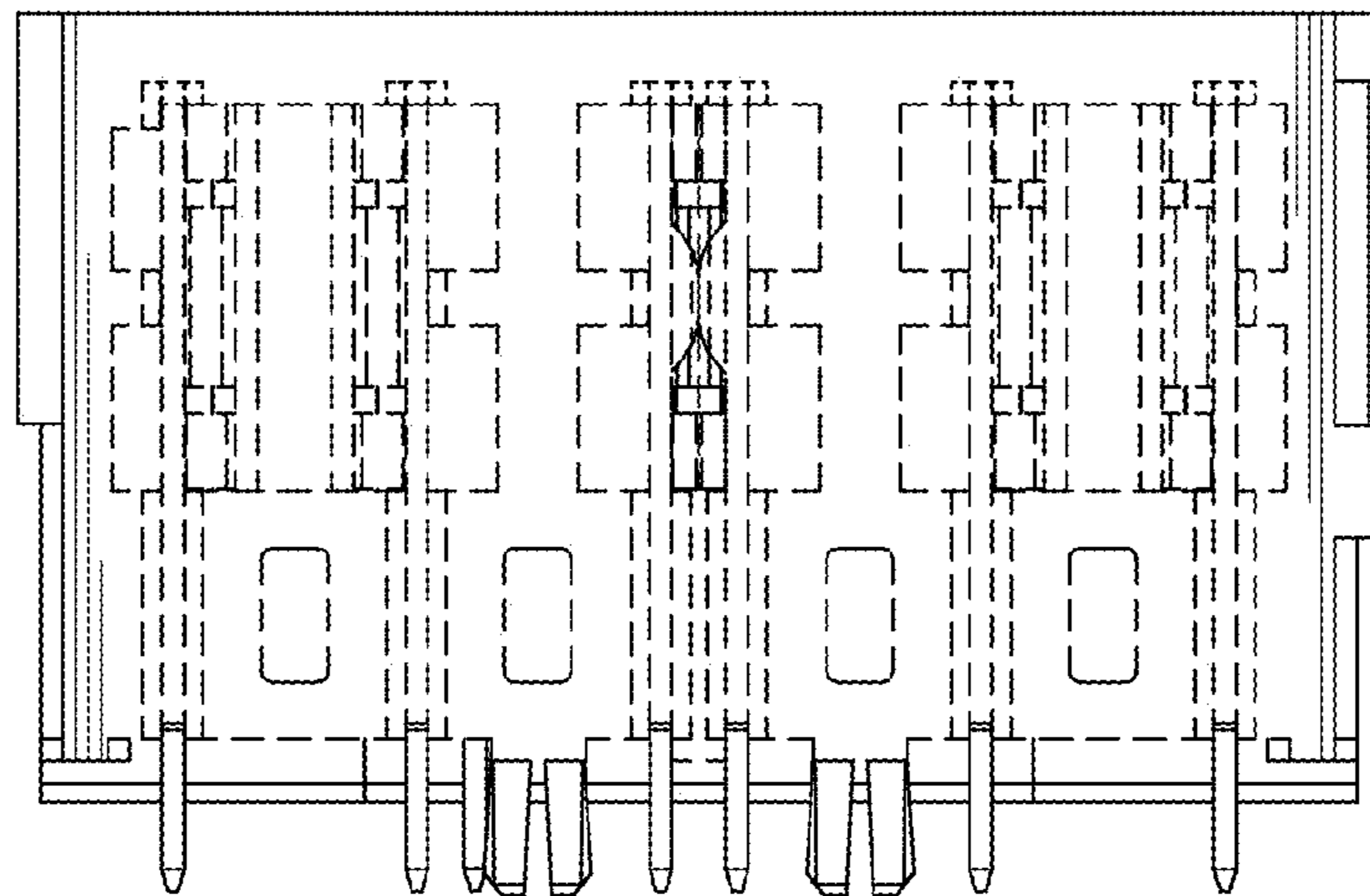

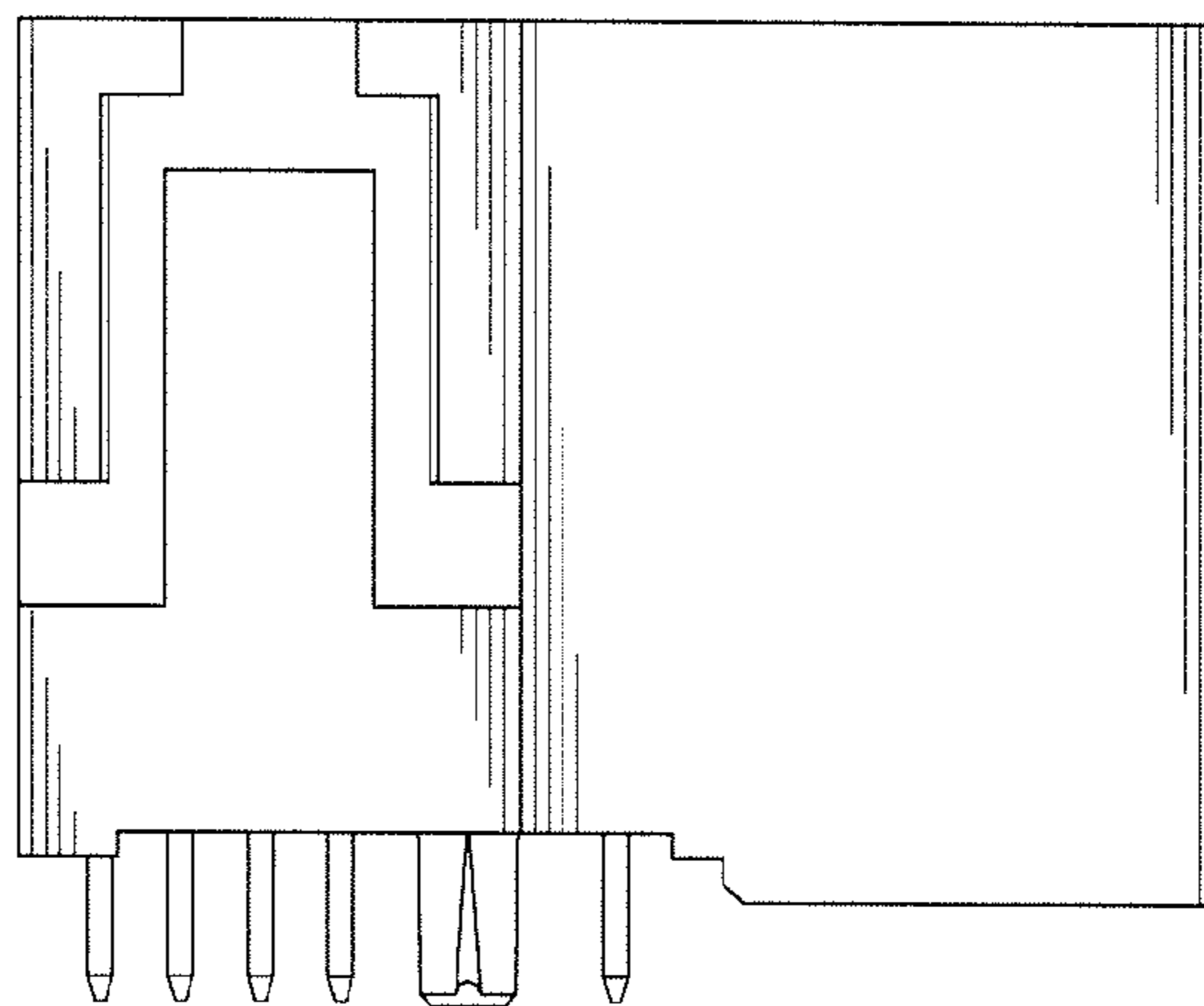

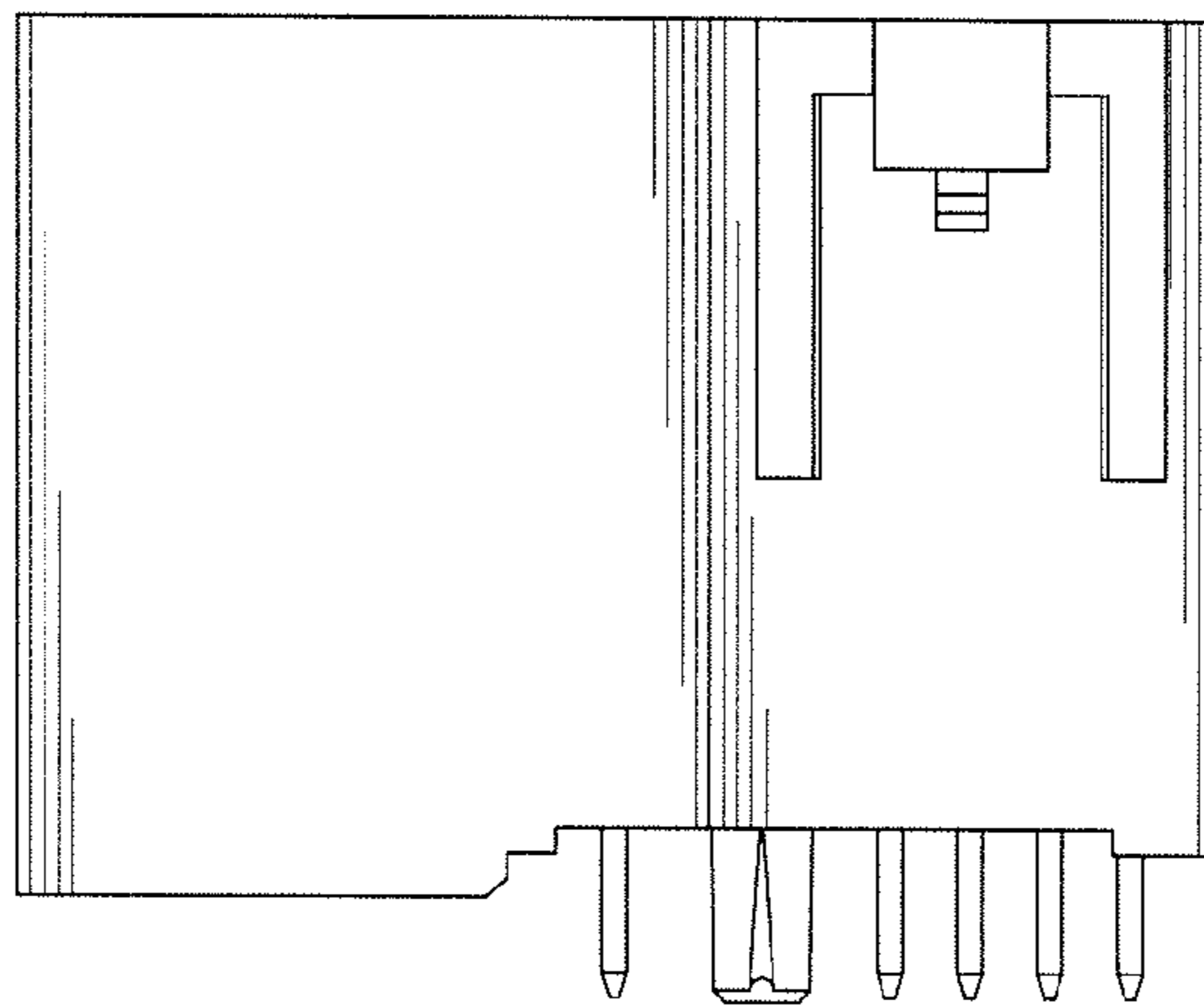

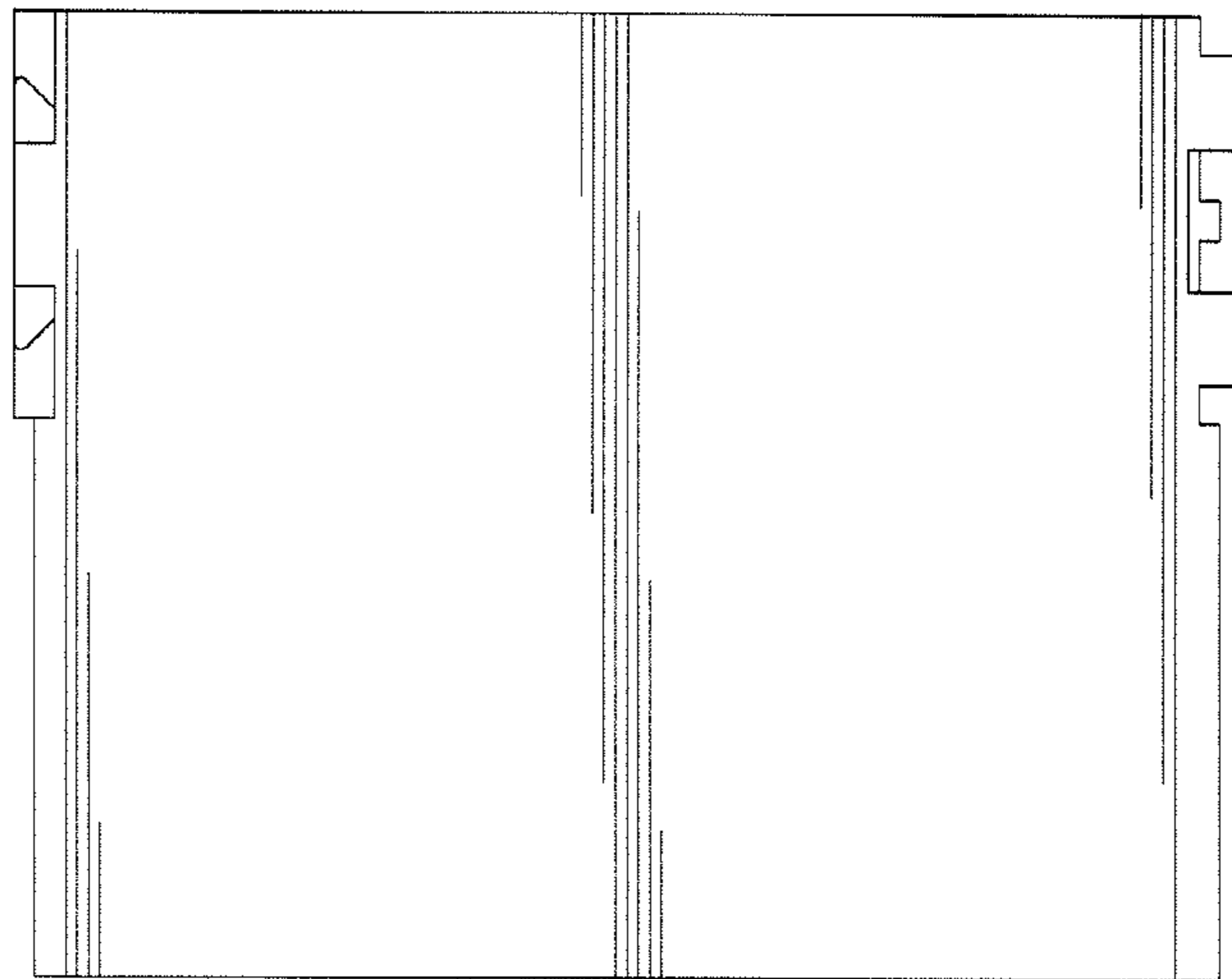

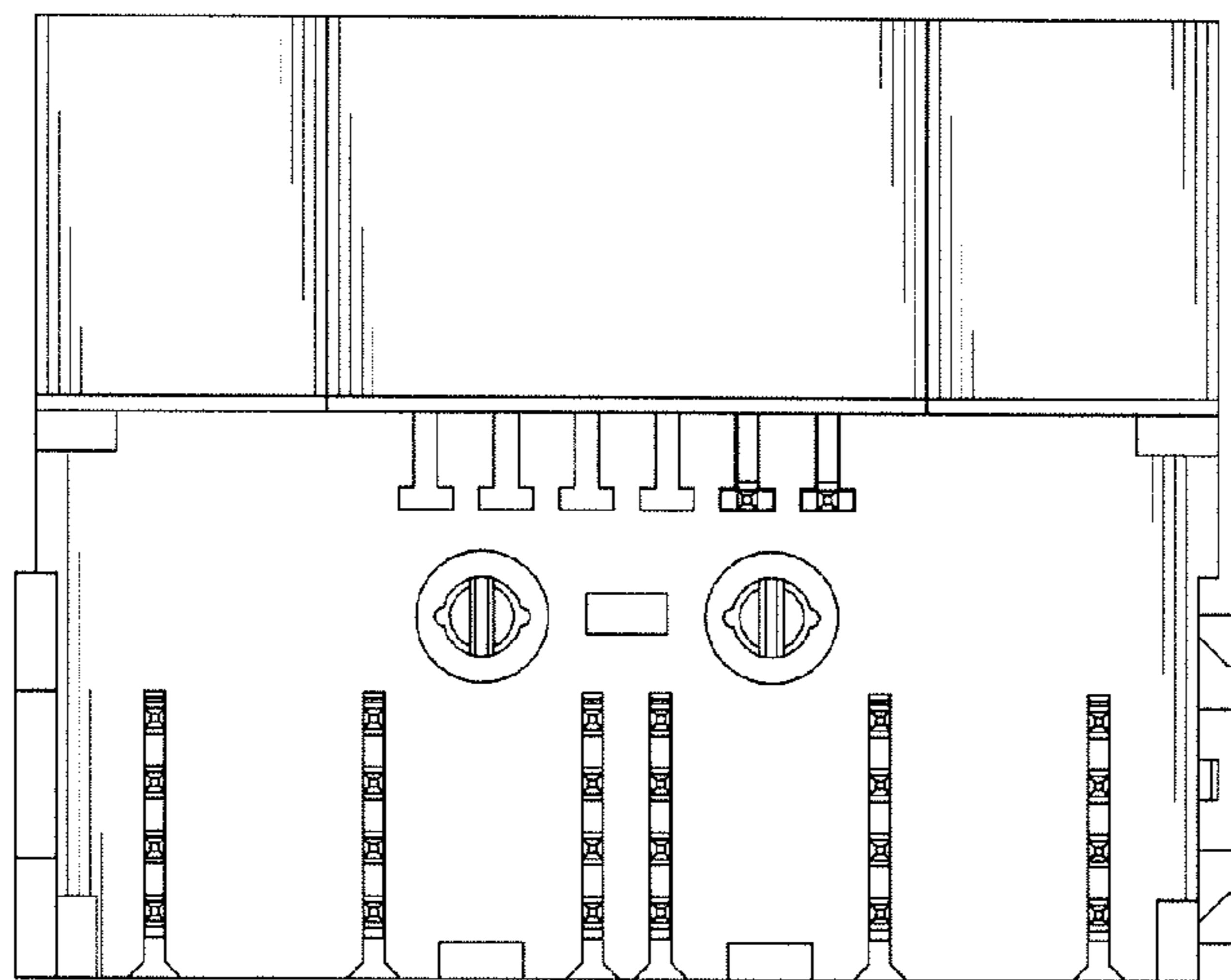
