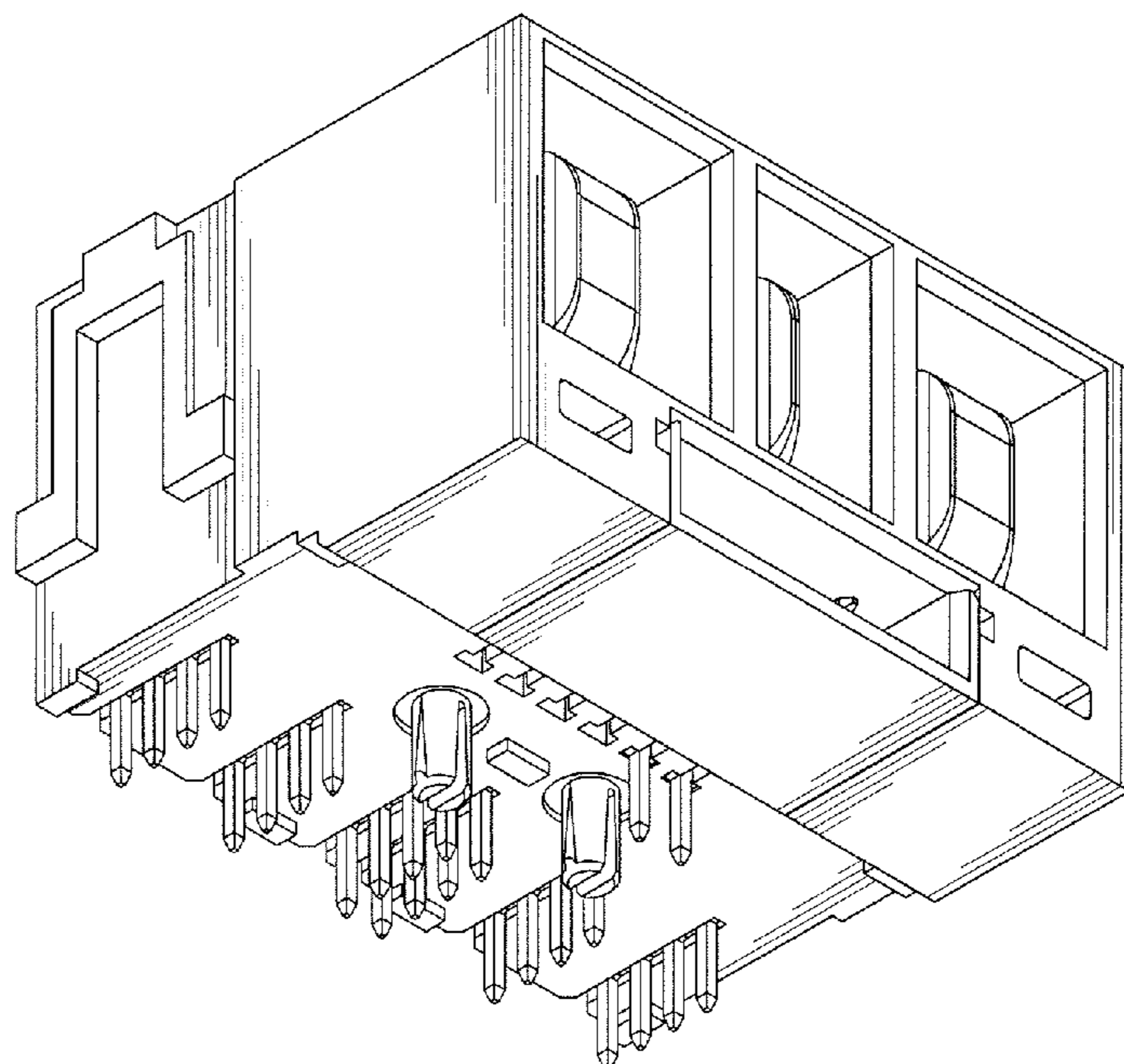
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front, bottom, and left side perspective view of a power male connector showing my new design;  
FIG. 2 is a front plane view thereof;

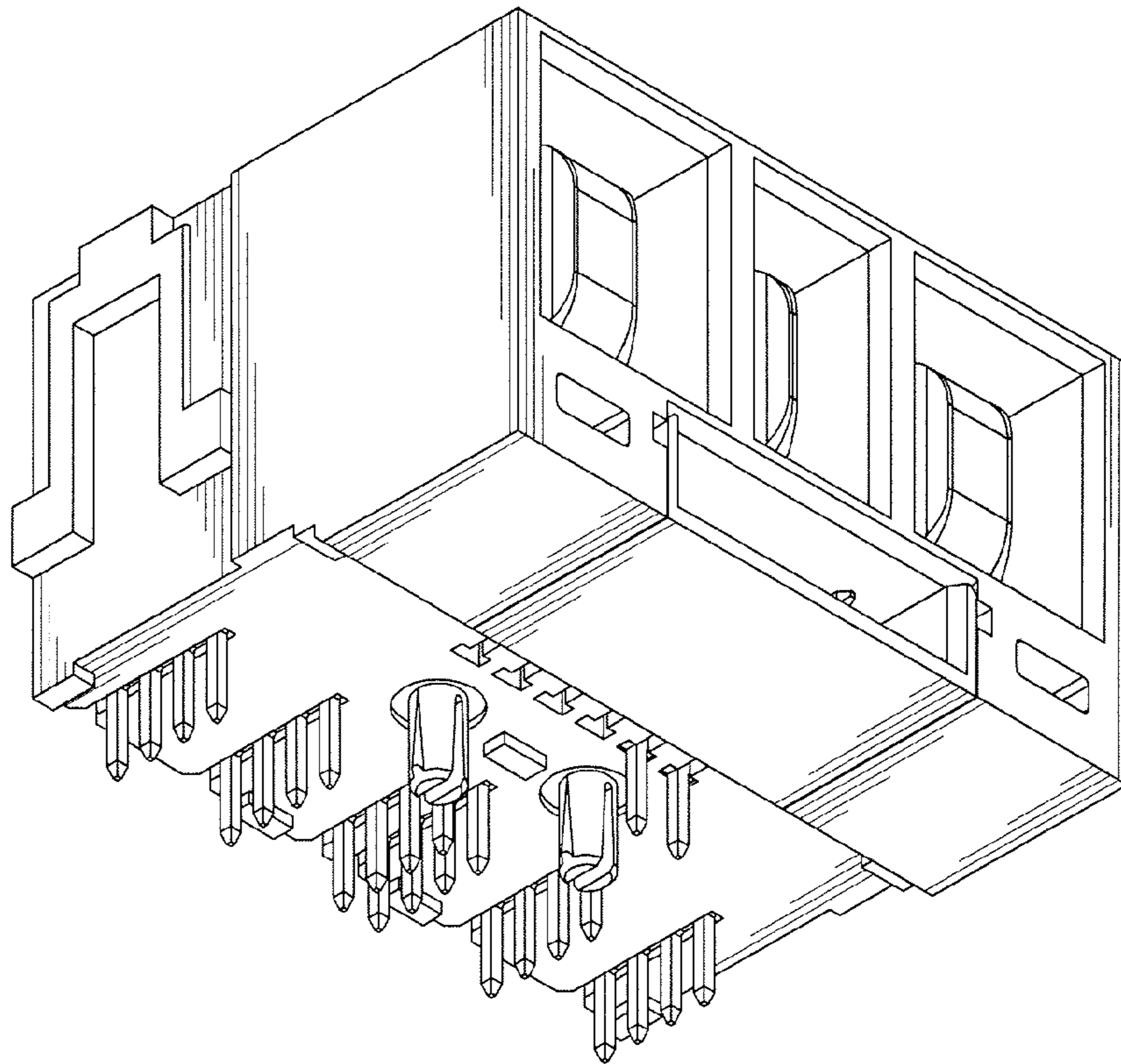

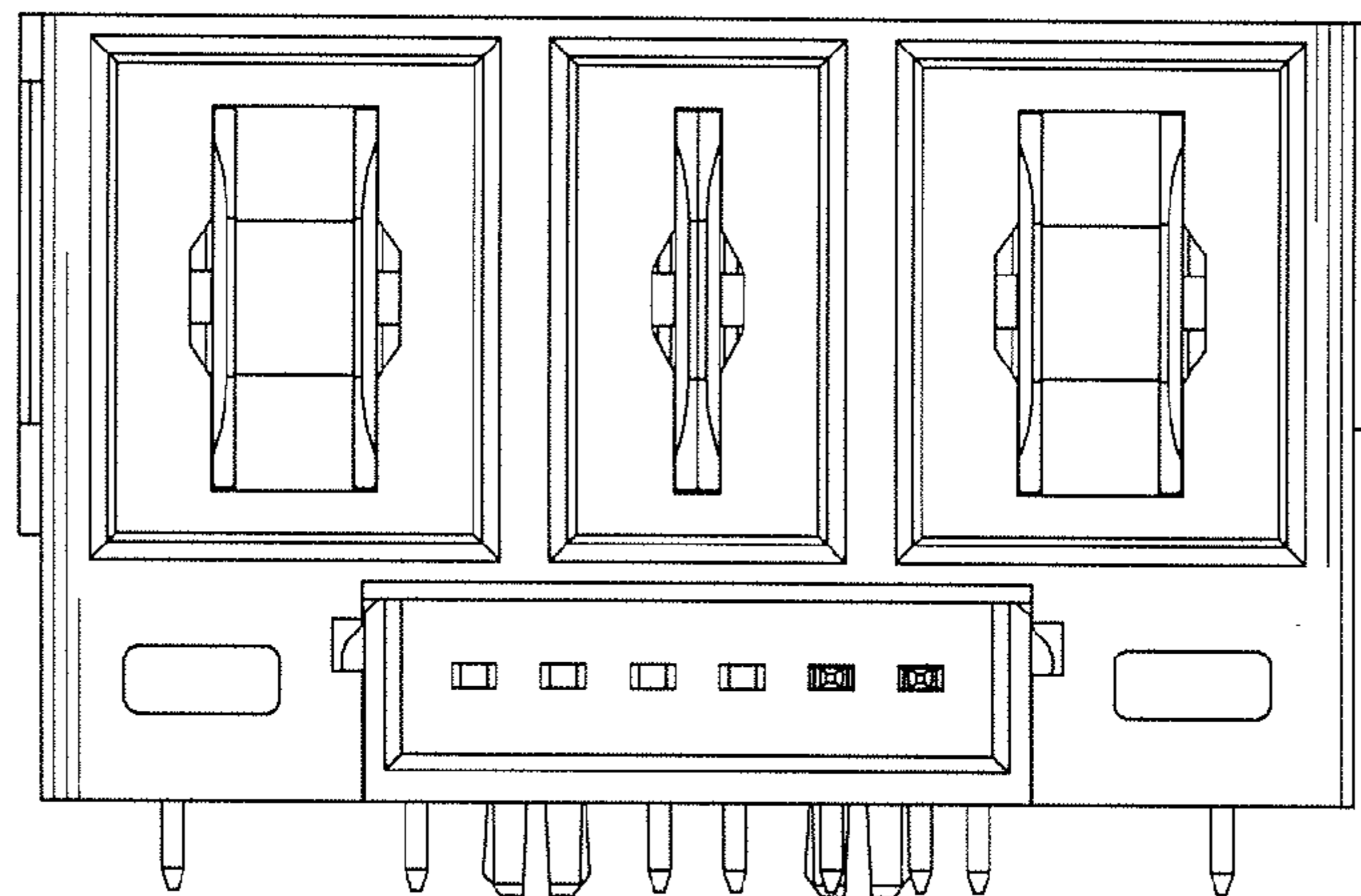

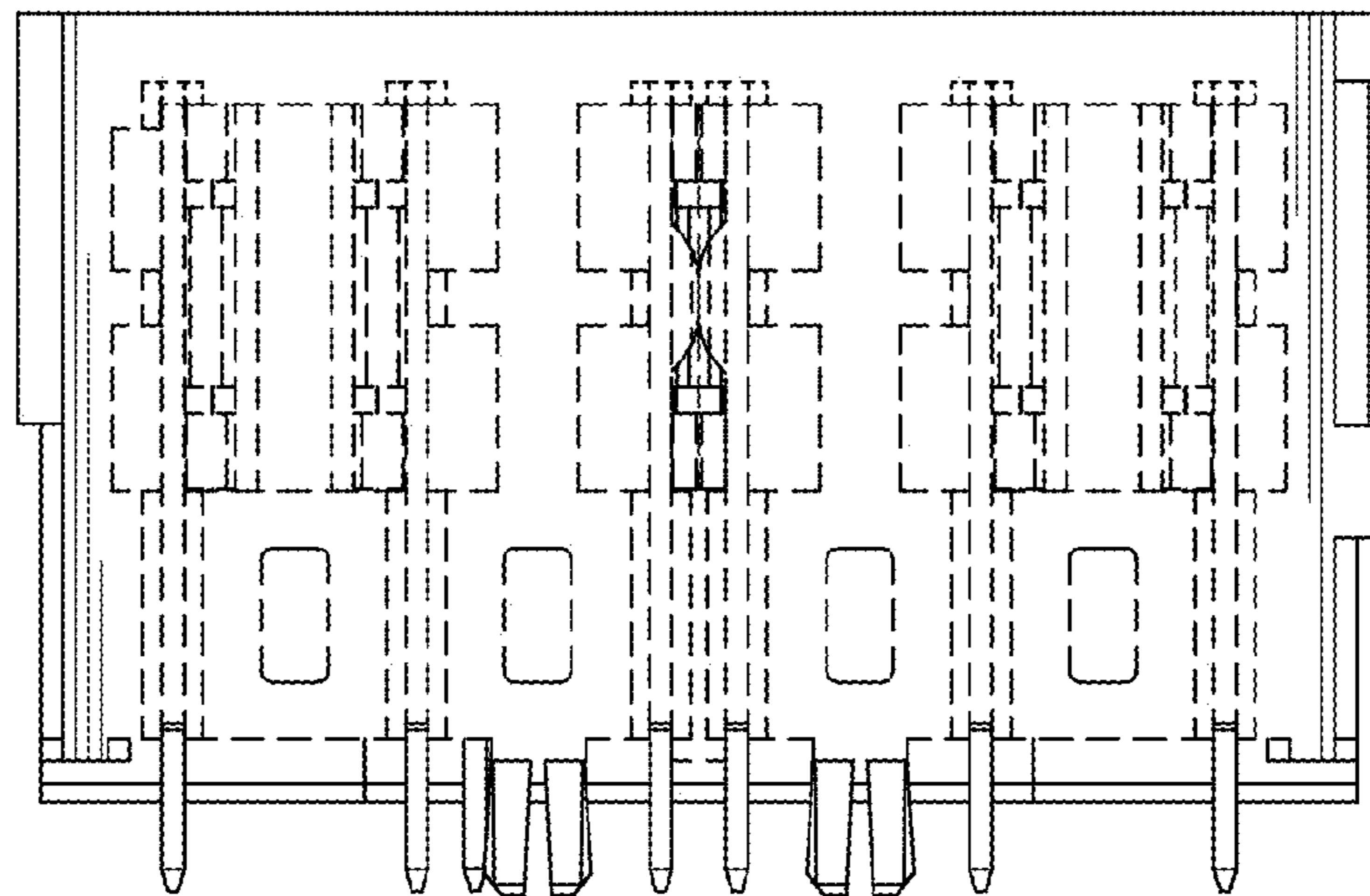

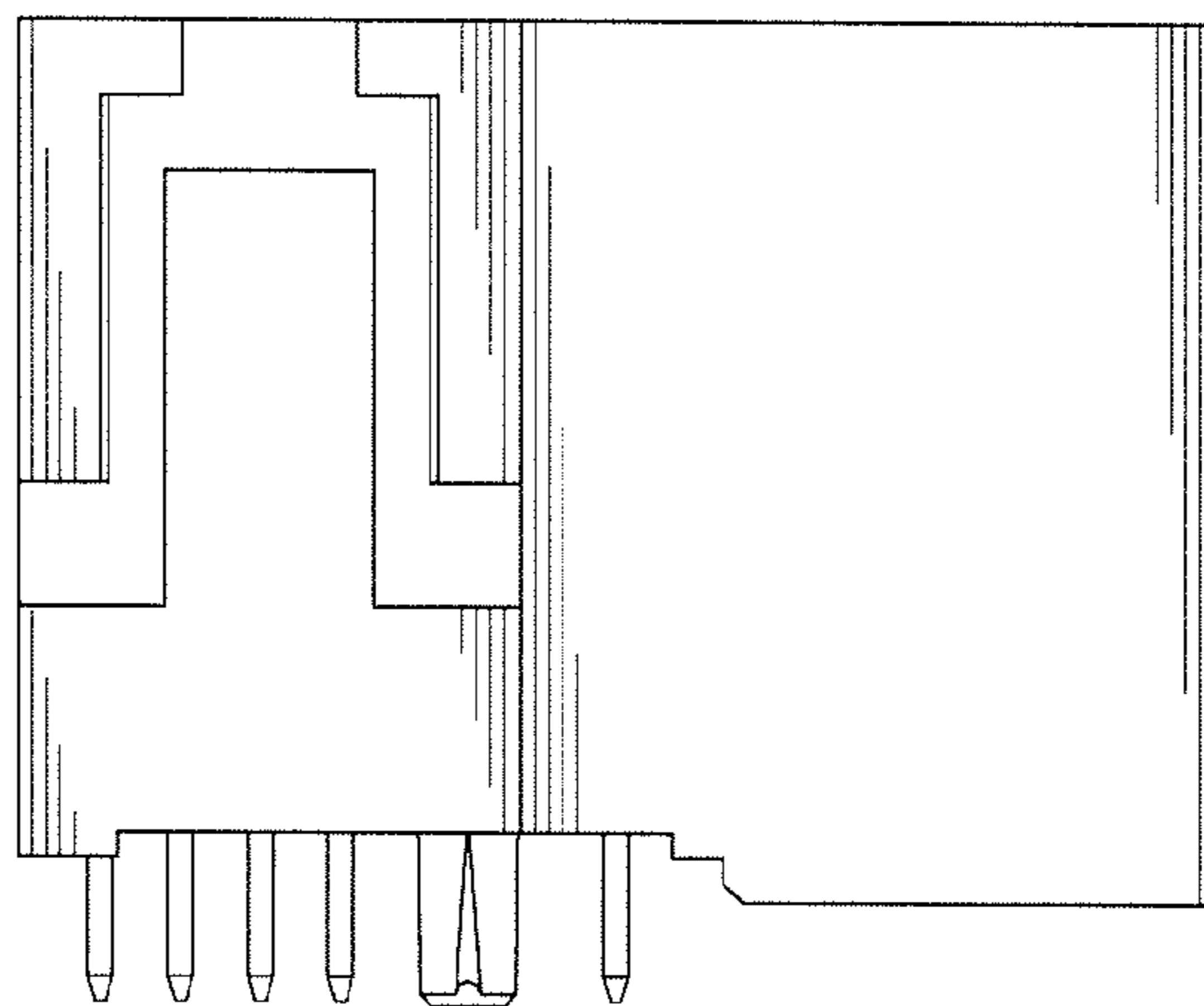

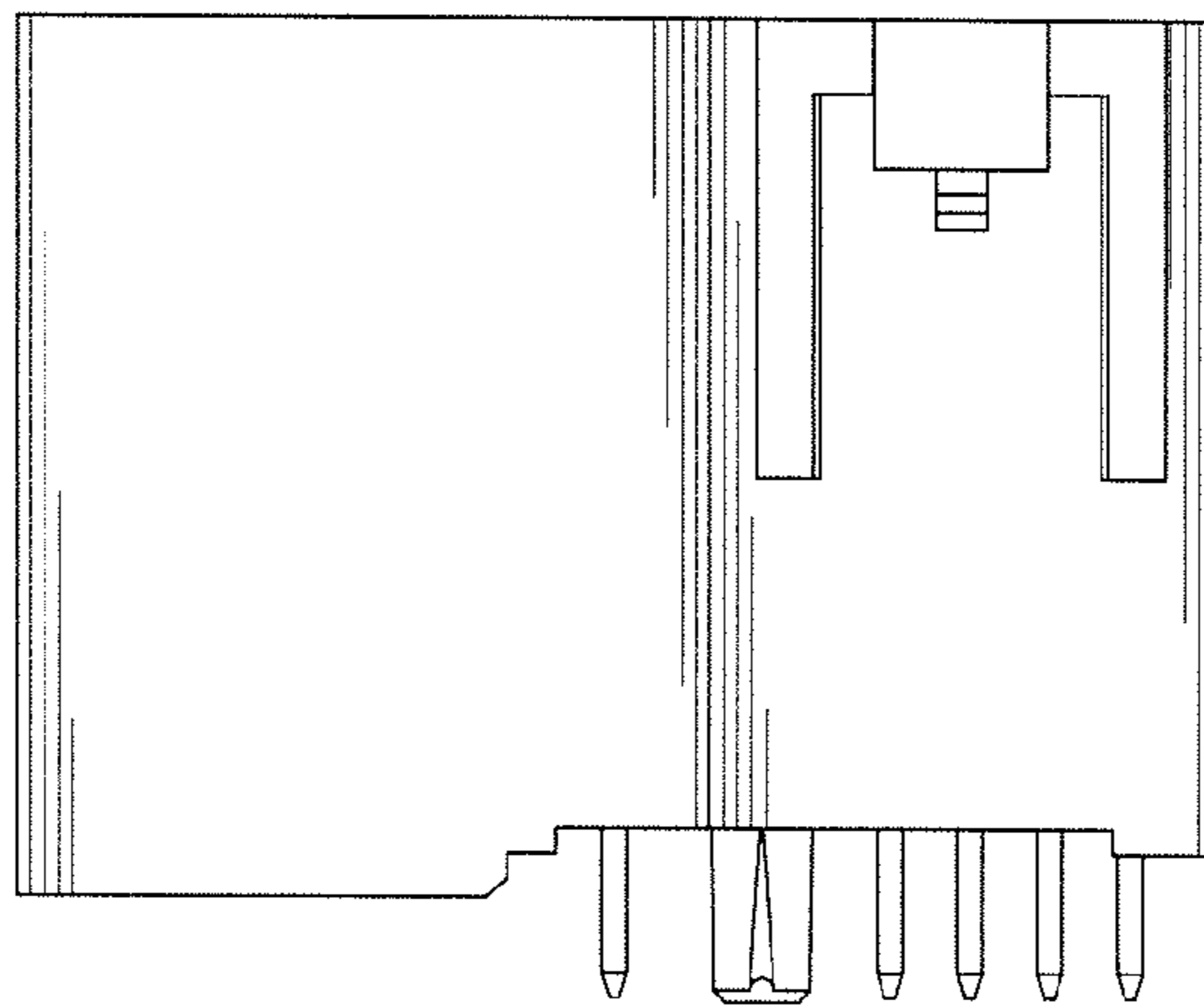

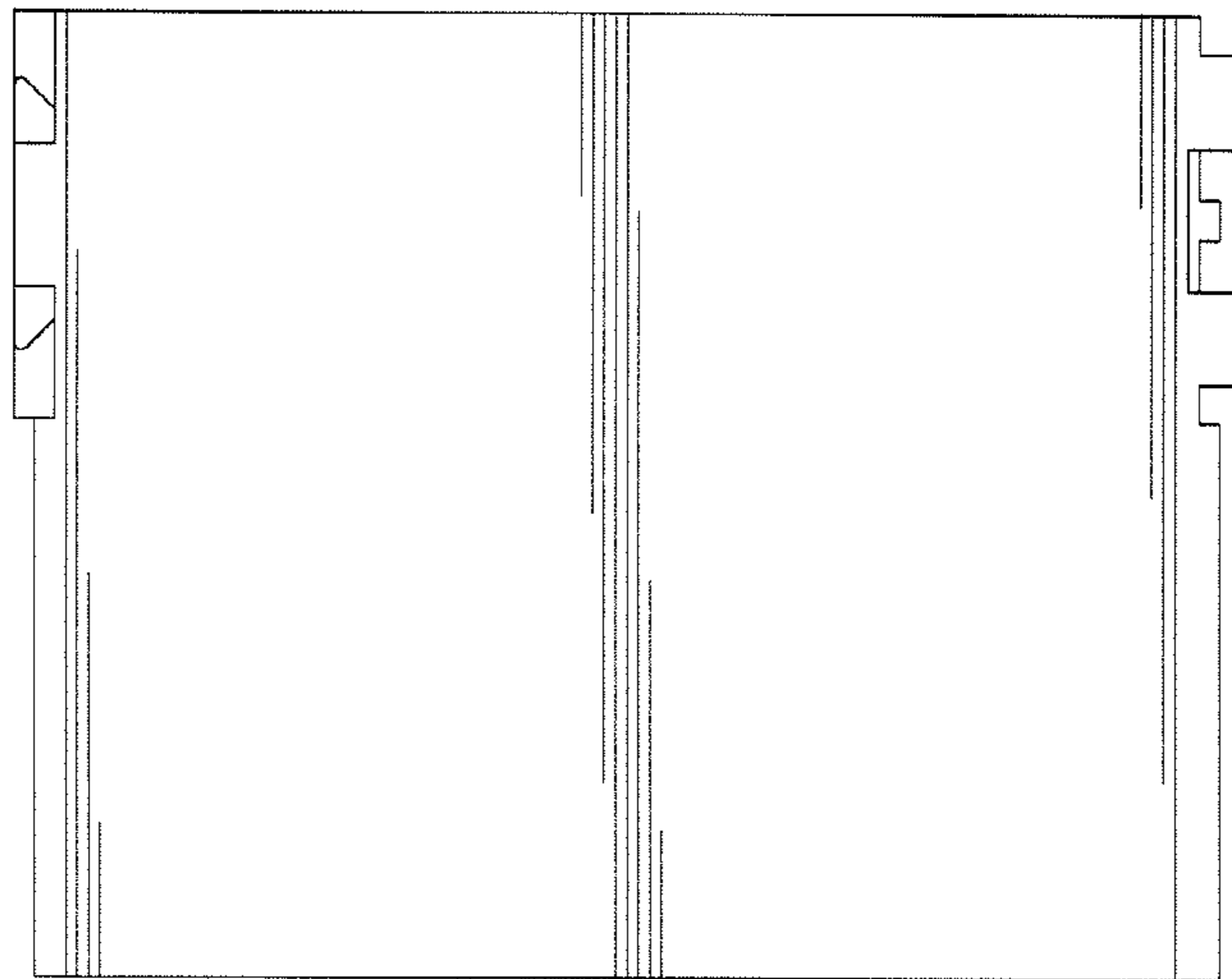

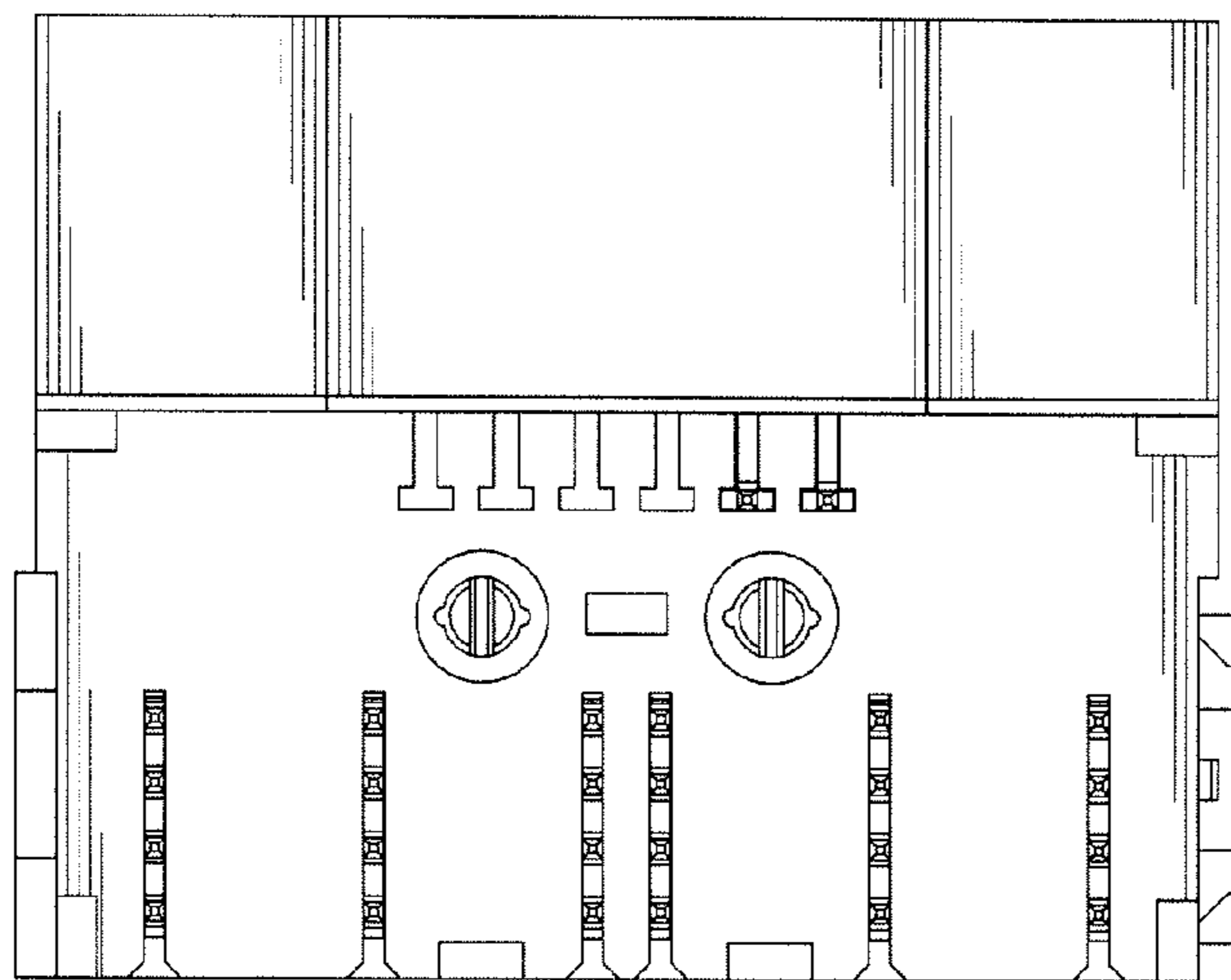
