(57) **CLAIM**  
The ornamental design for a fuse, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of a fuse showing our new design; FIG. 2 is front view thereof, the rear view being identical to the front view; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a right side view of the design thereof, the left side view being identical to the right side view; and, FIG. 6 is a cross-sectional view taken along line 6-6 in FIG. 3. The oblique shade lines shown in the drawings represent that the housing is transparent.

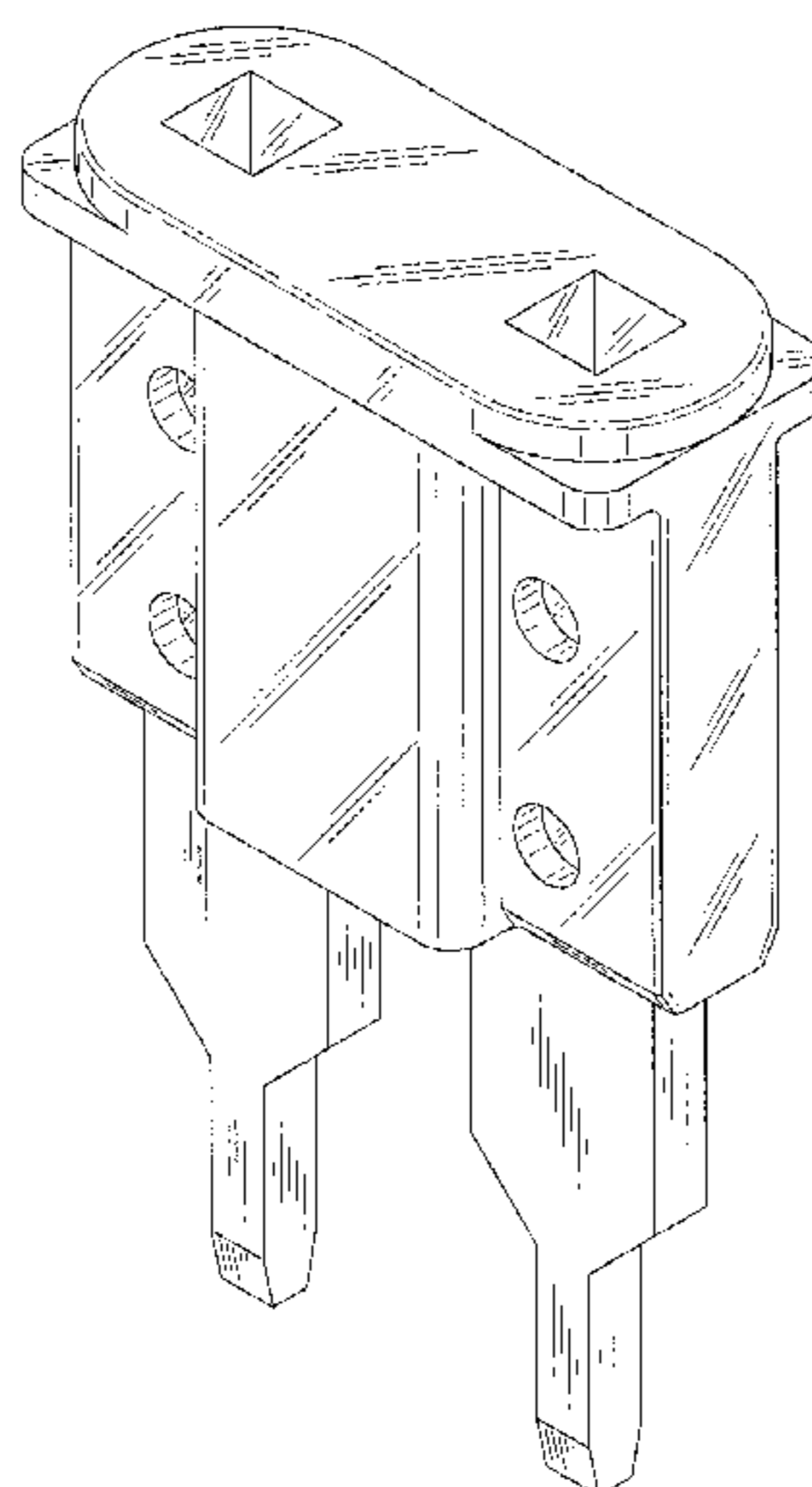

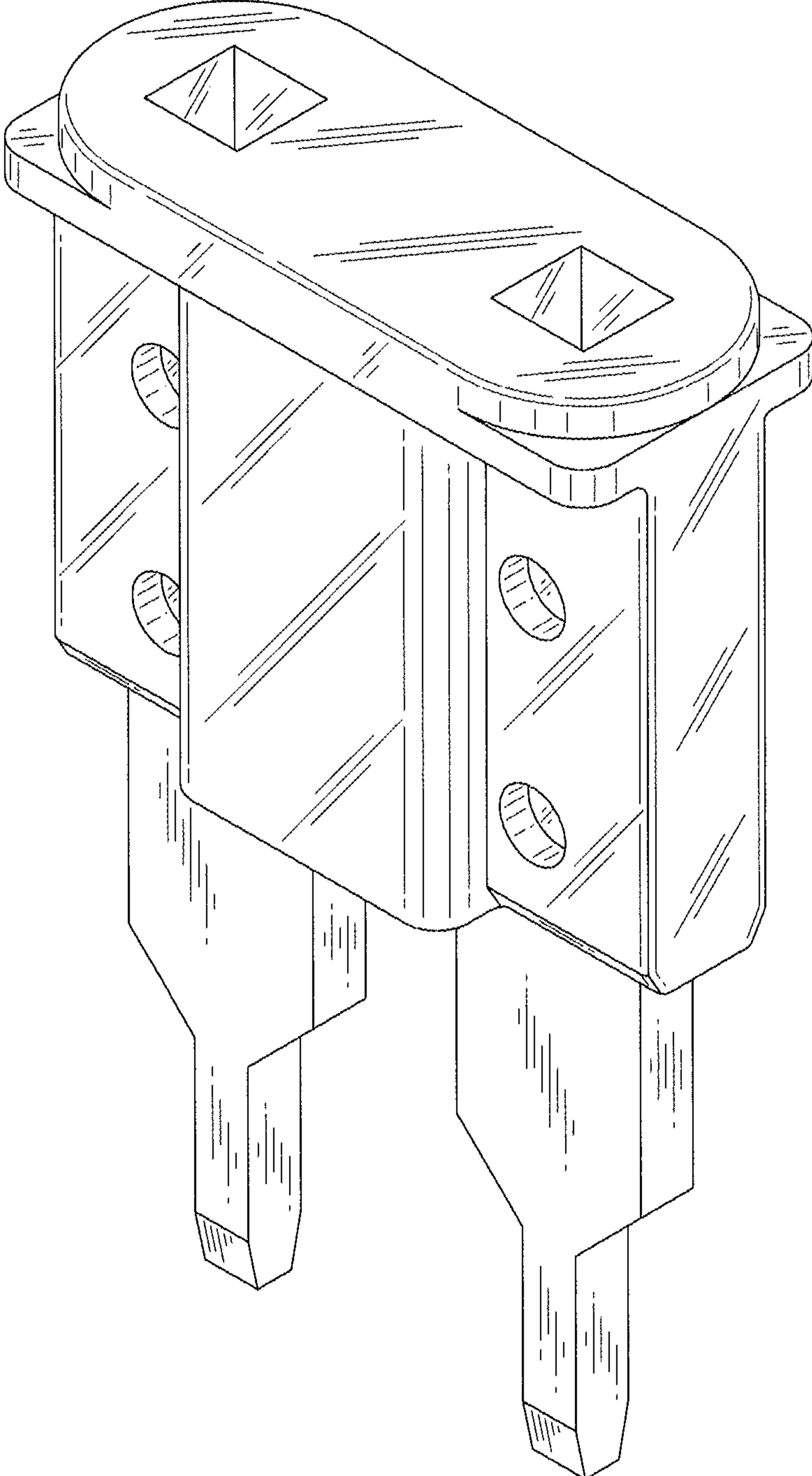

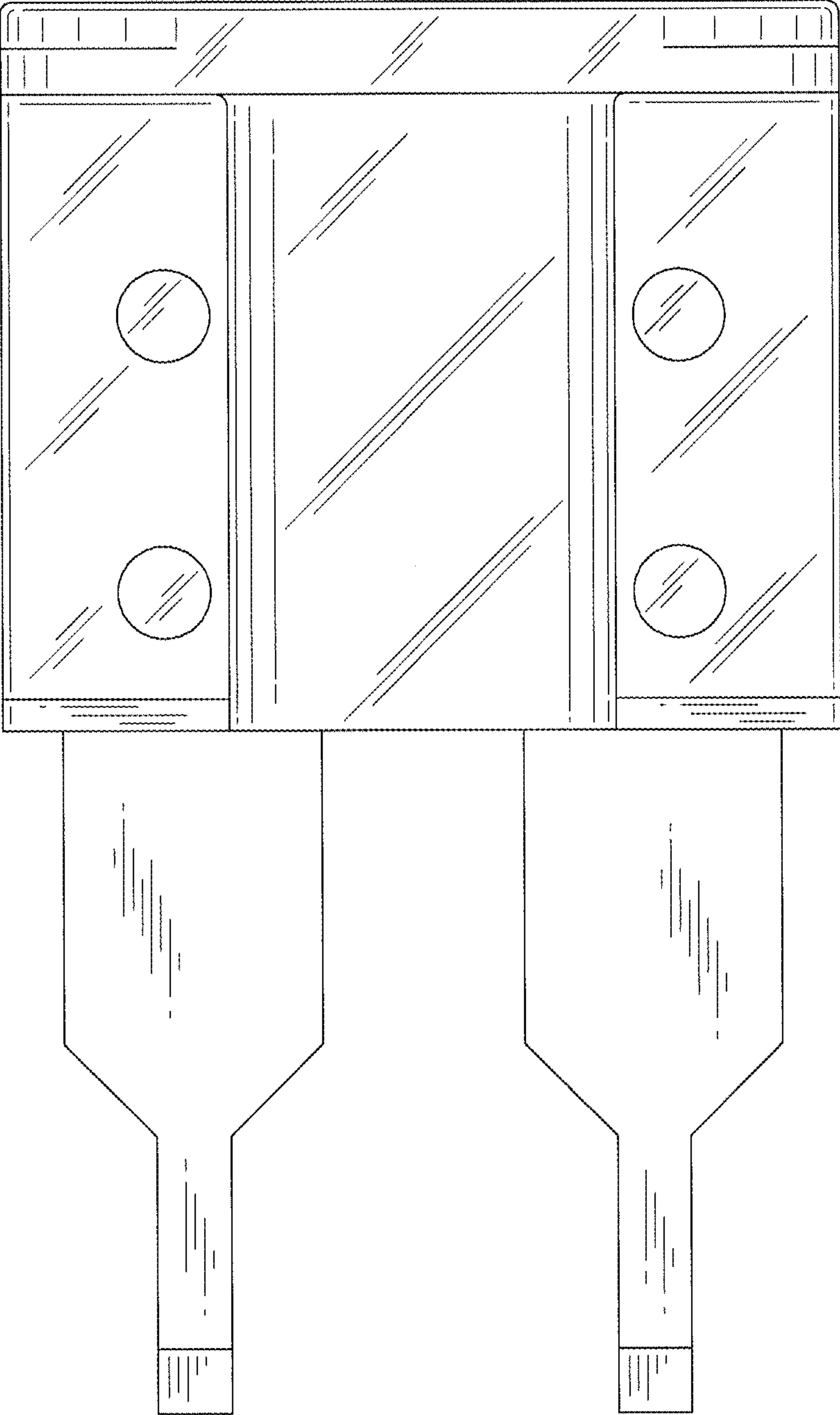

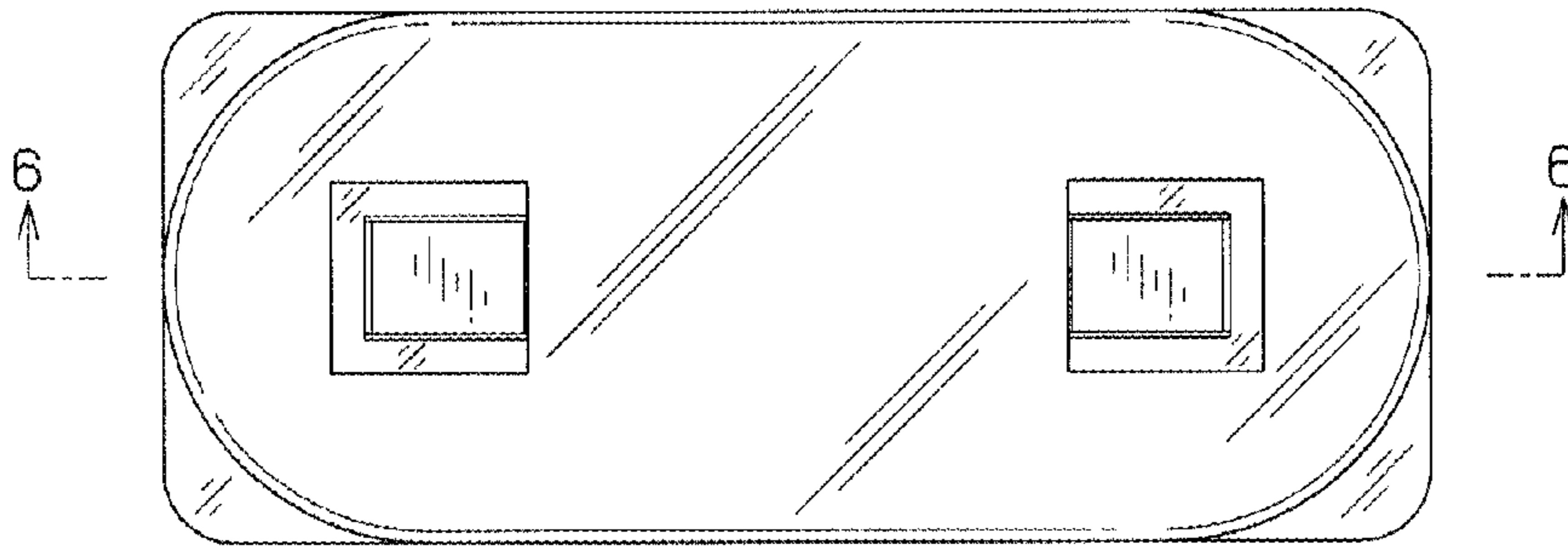

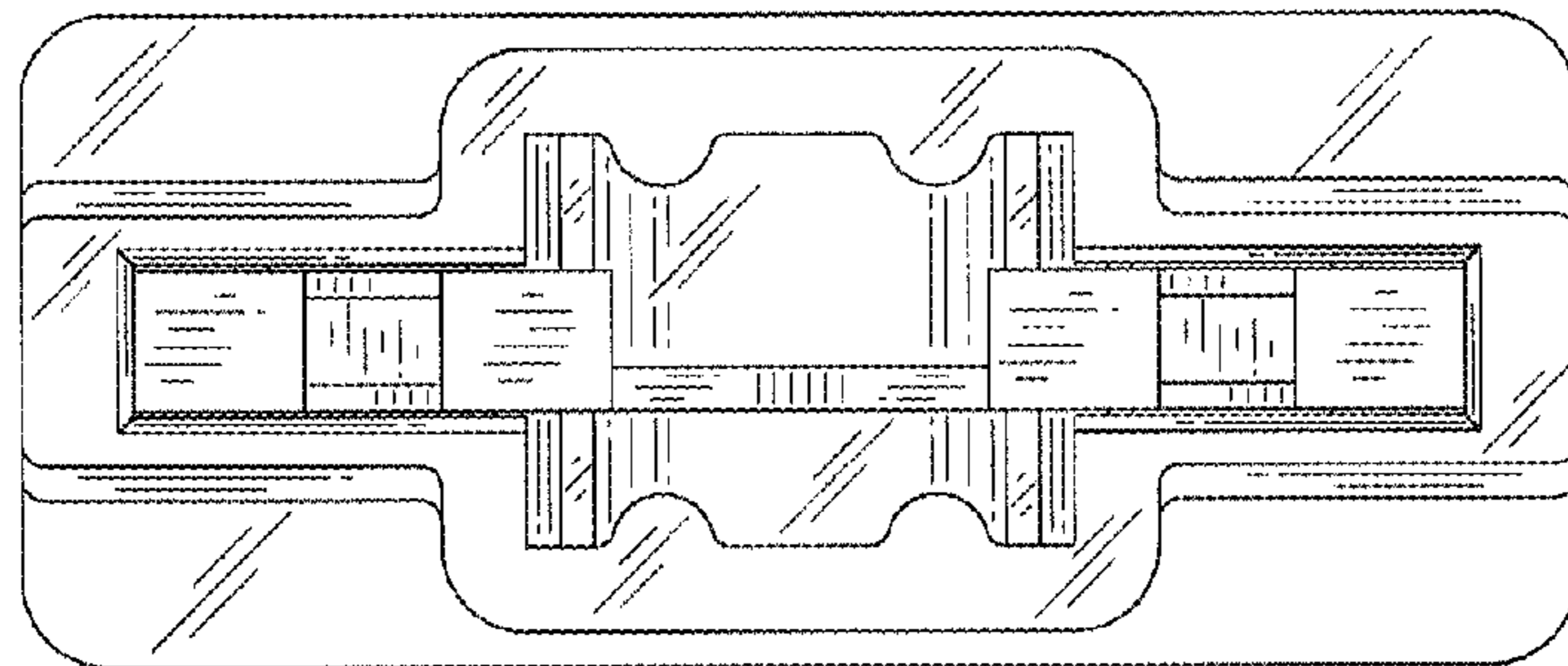

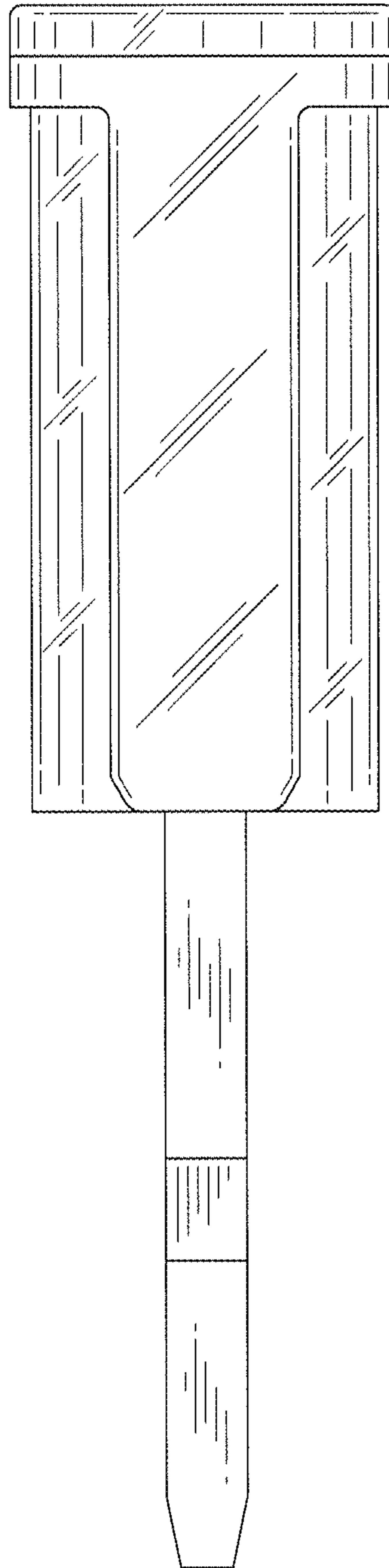
