The ornamental design for sound reproduction equipment, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of sound reproduction equipment showing our new design;

FIG. 2 is a right side elevational view showing the sound reproduction equipment of FIG. 1;

FIG. 3 is a left side elevational view showing the sound reproduction equipment of FIG. 1;

FIG. 4 is a front elevational view showing the sound reproduction equipment of FIG. 1;

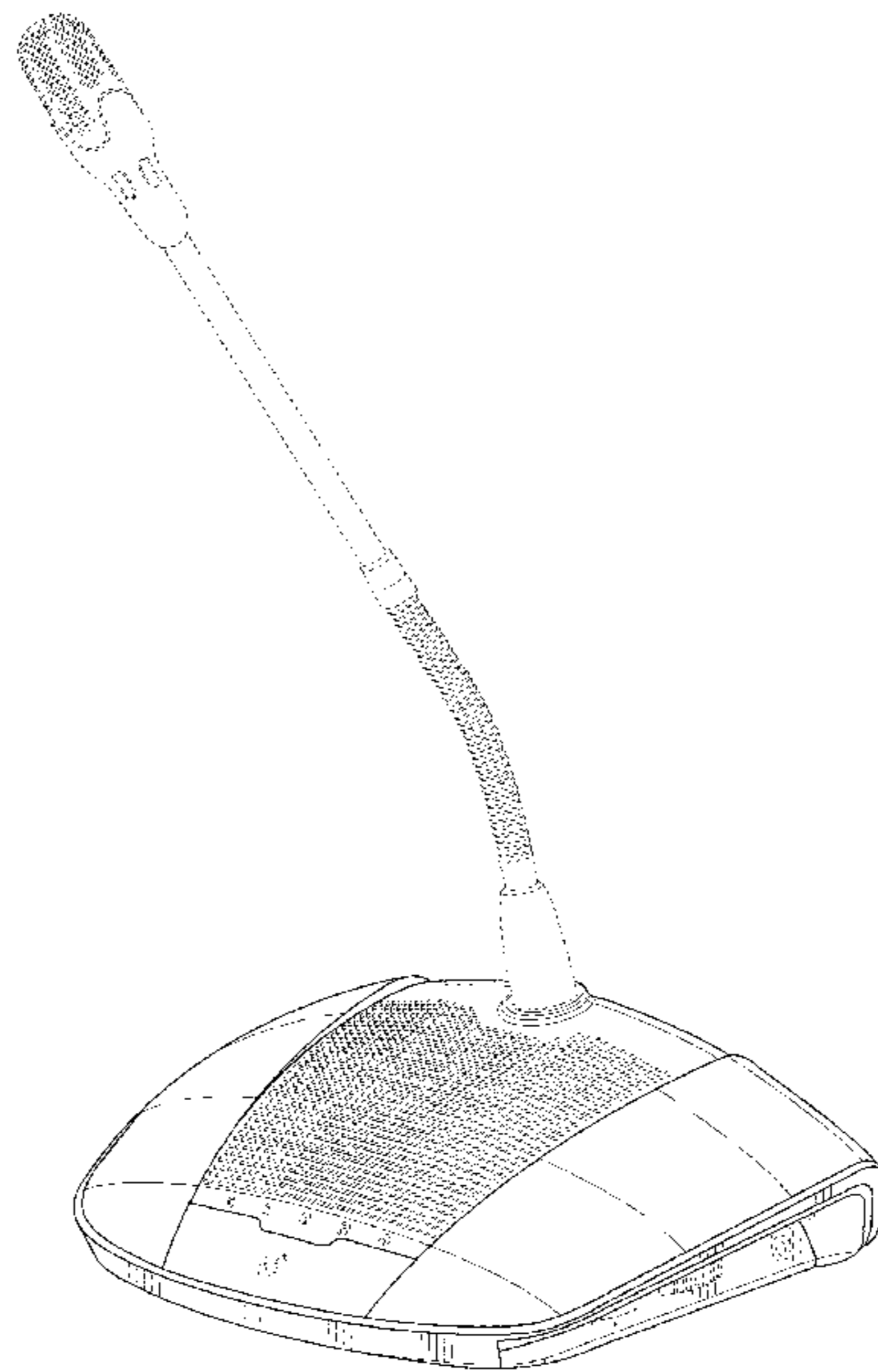
FIG. 5 is a rear elevational view showing the sound reproduction equipment of FIG. 1;

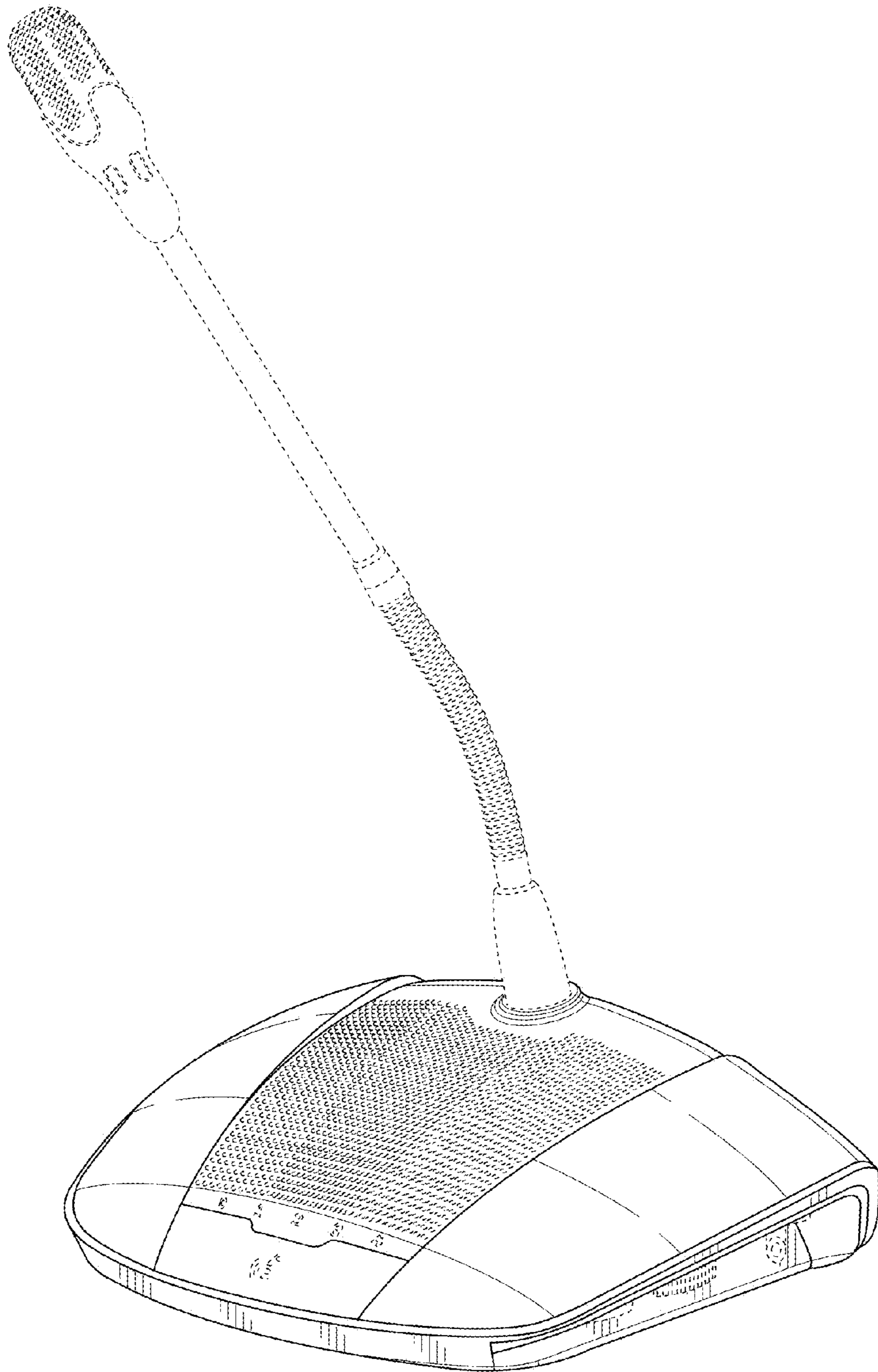

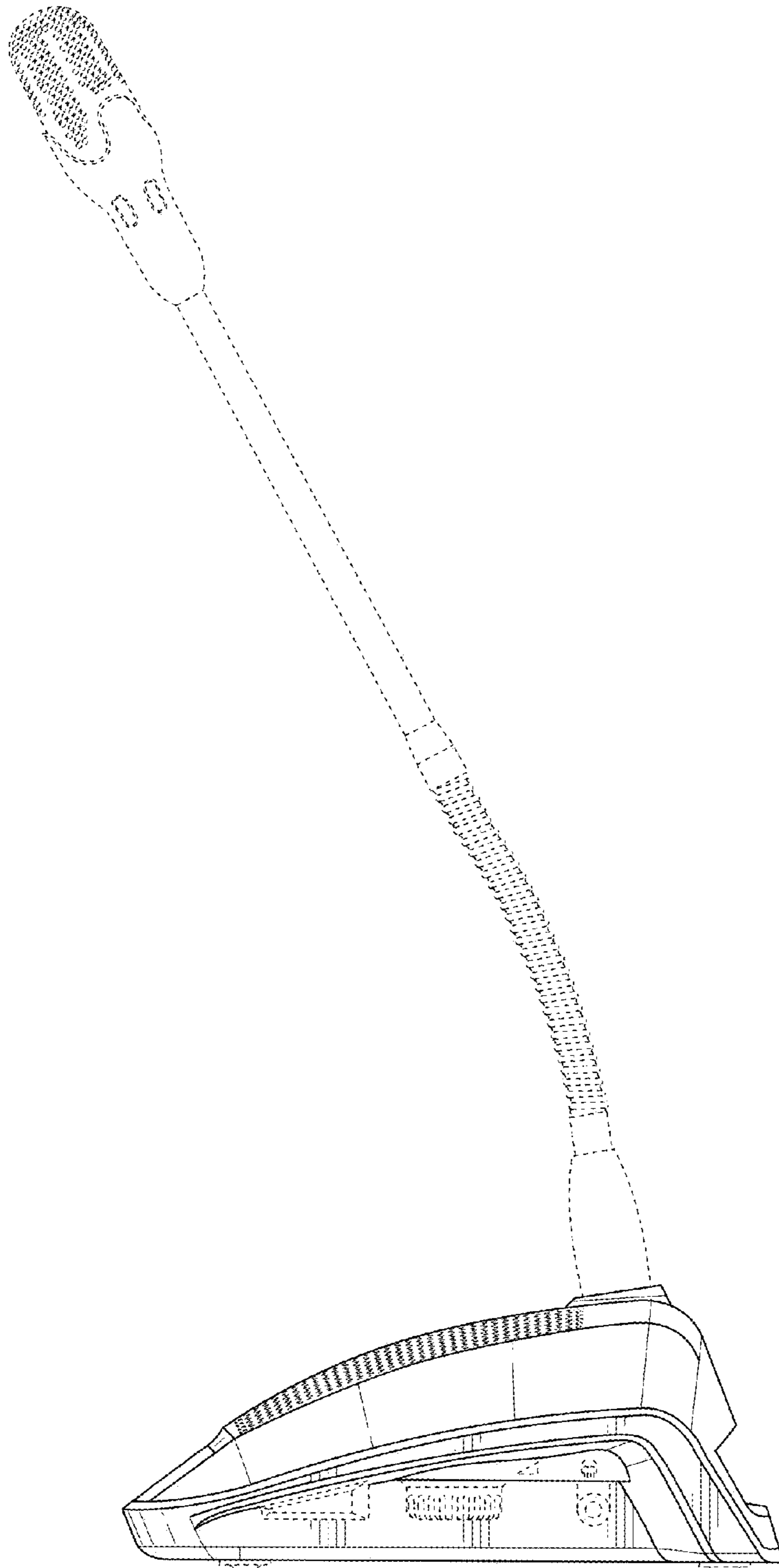

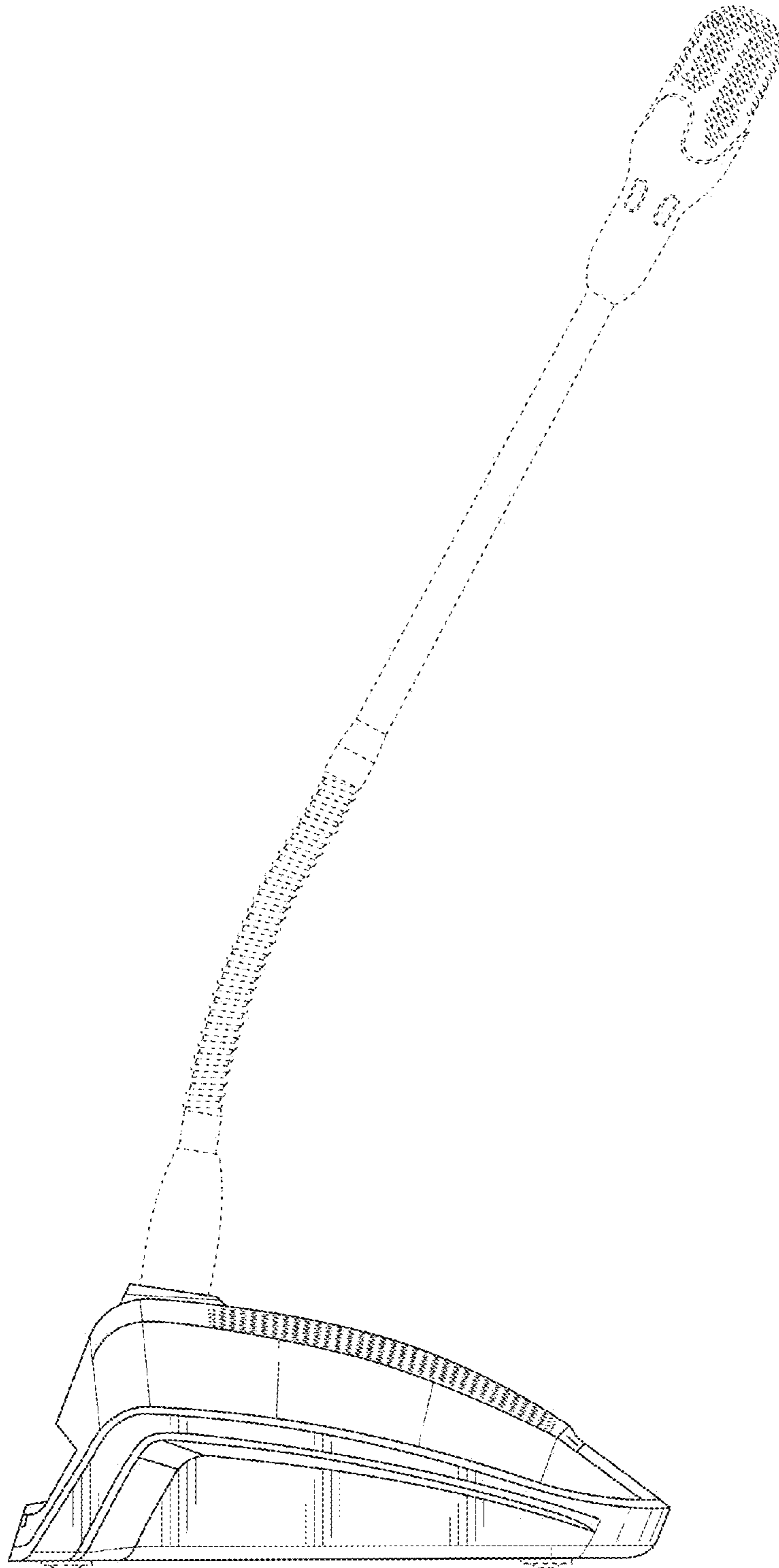

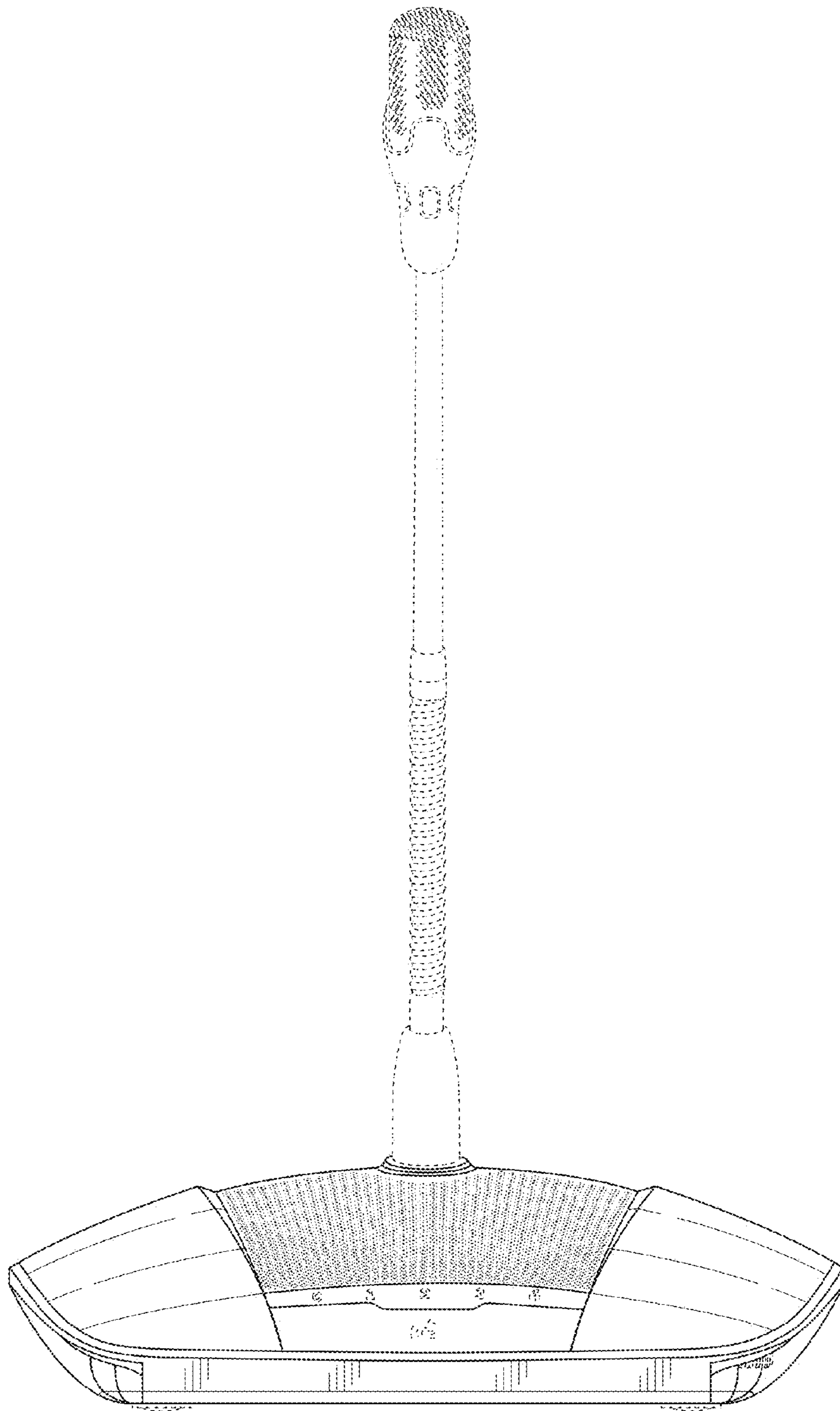

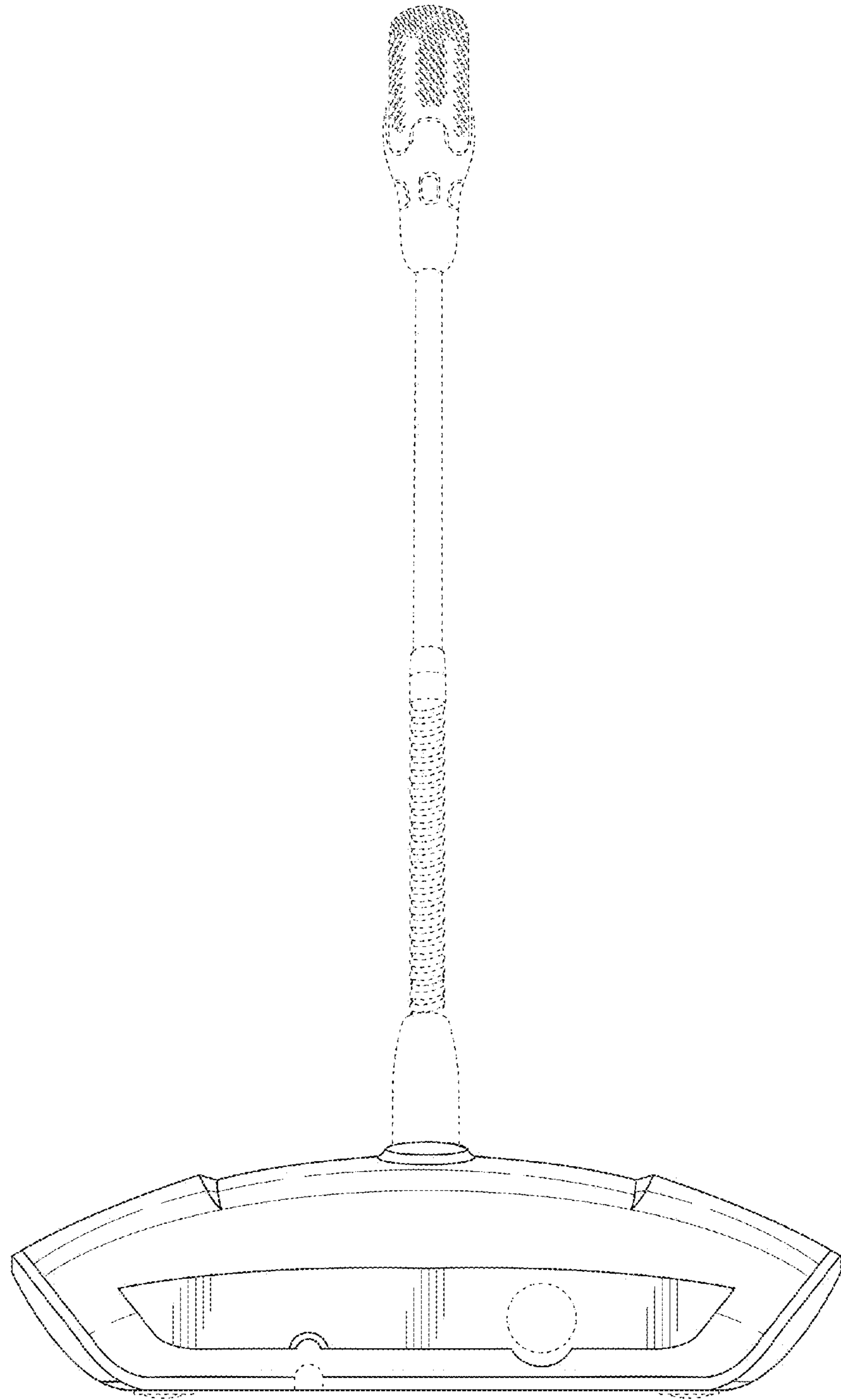

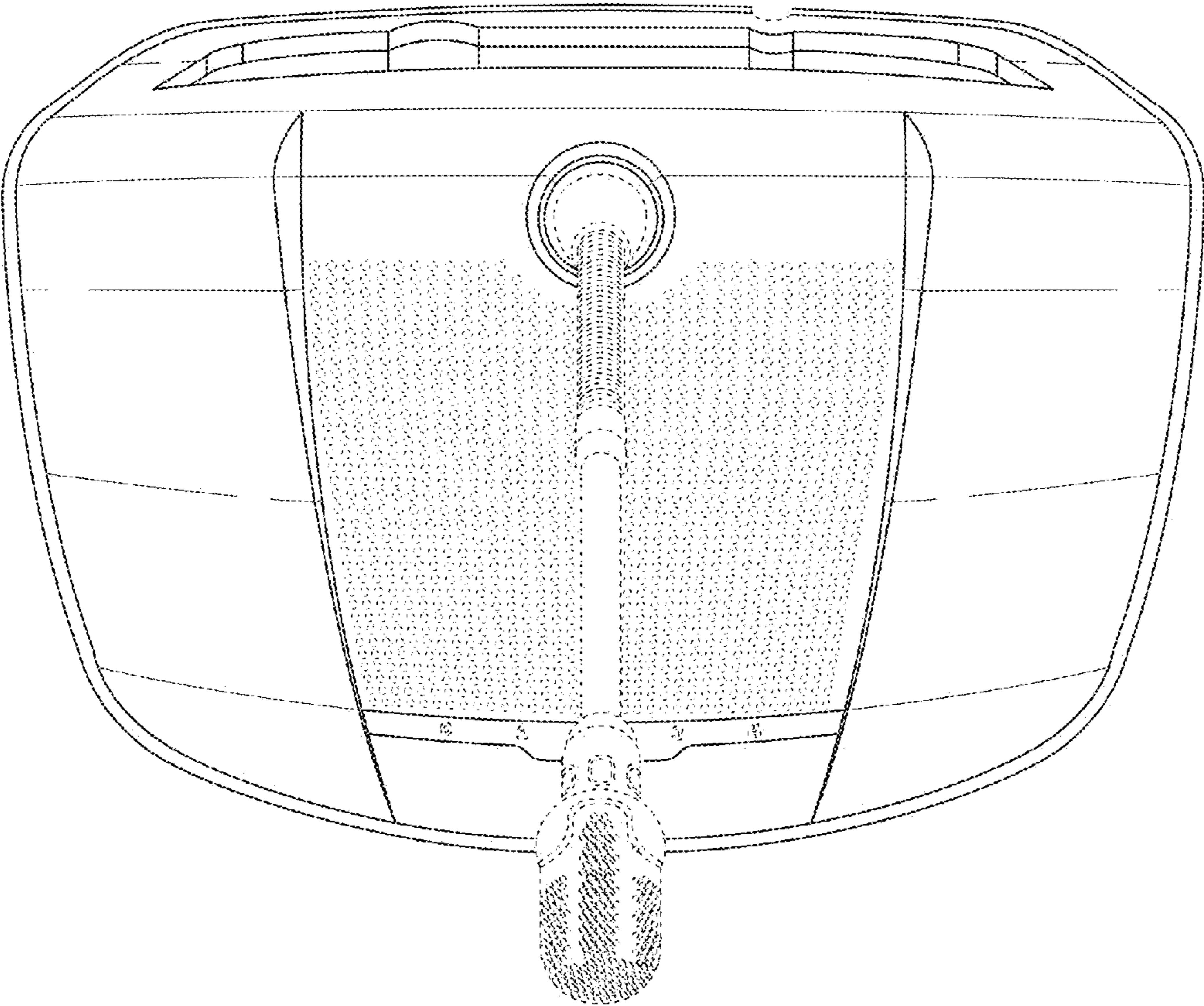

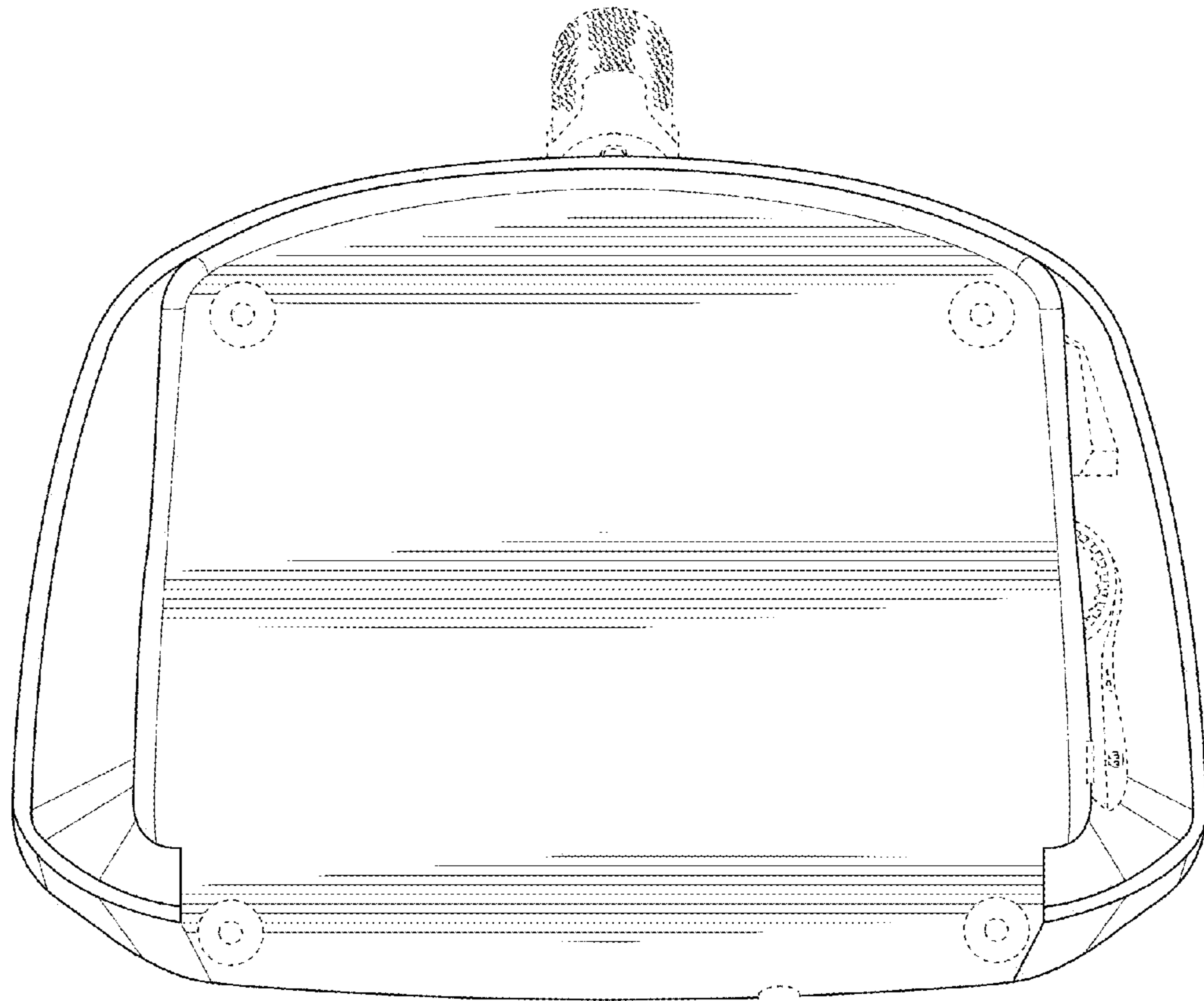
