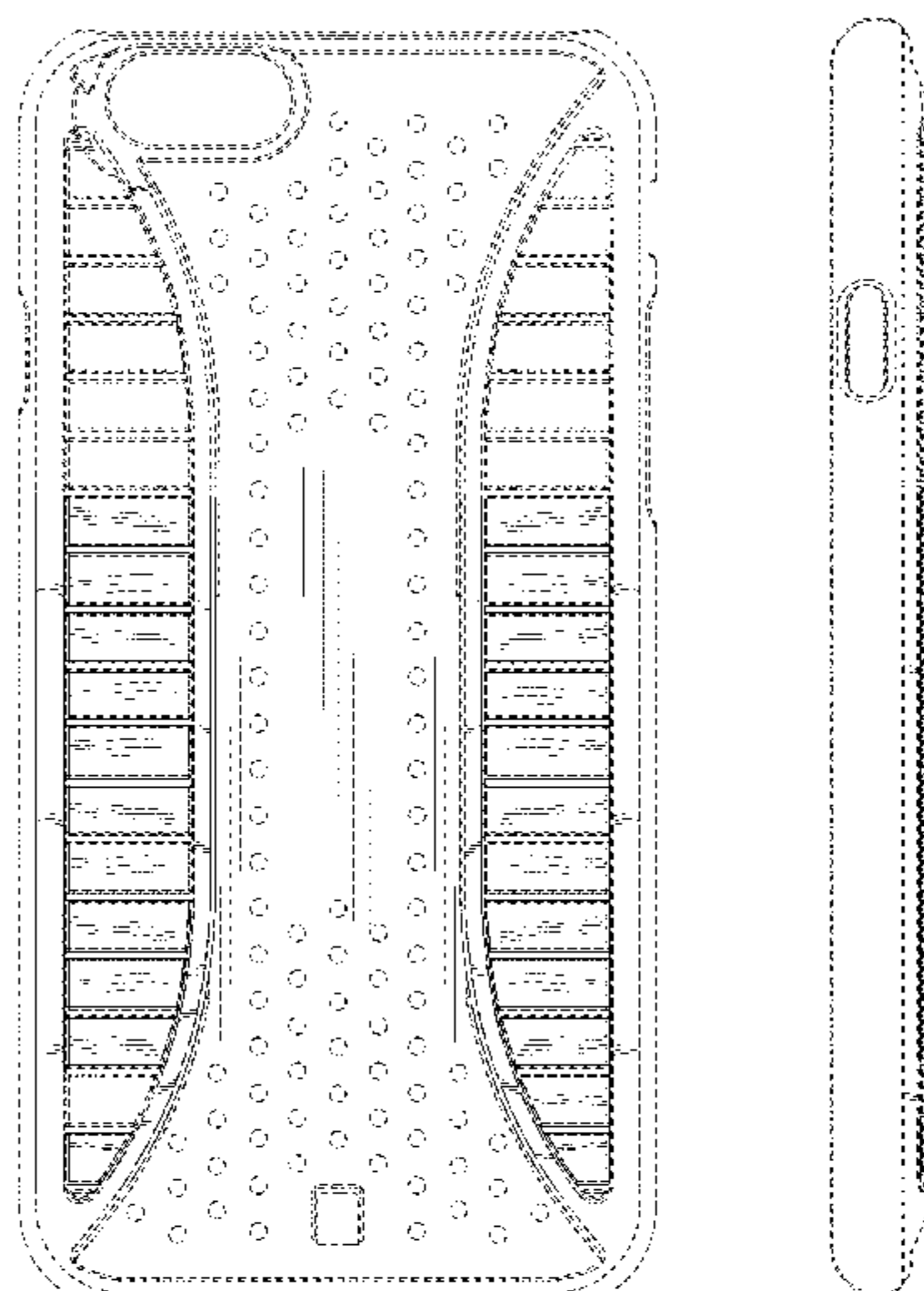
(57) **CLAIM**

The ornamental design for a case for a mobile phone, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of a case for a mobile phone showing our new design;
 FIG. 2 is a front perspective view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a front elevational view thereof;
 FIG. 5 is a left side elevational view thereof;
 FIG. 6 is a right side elevational view thereof;
 FIG. 7 is a top plan view thereof; and
 FIG. 8 is a bottom plan view thereof; and
 FIG. 9 is a front perspective view of the case with an environmental mobile phone.

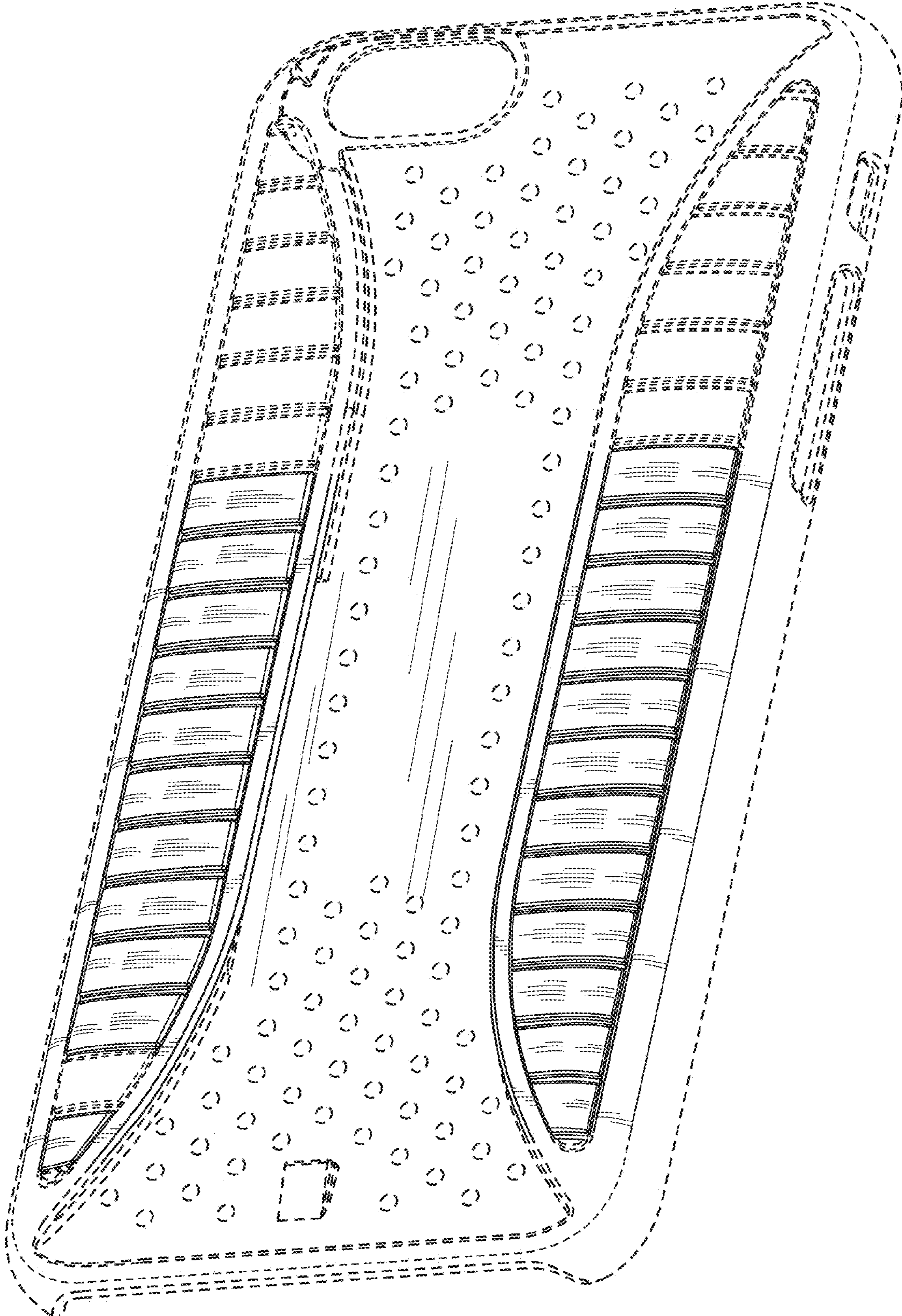

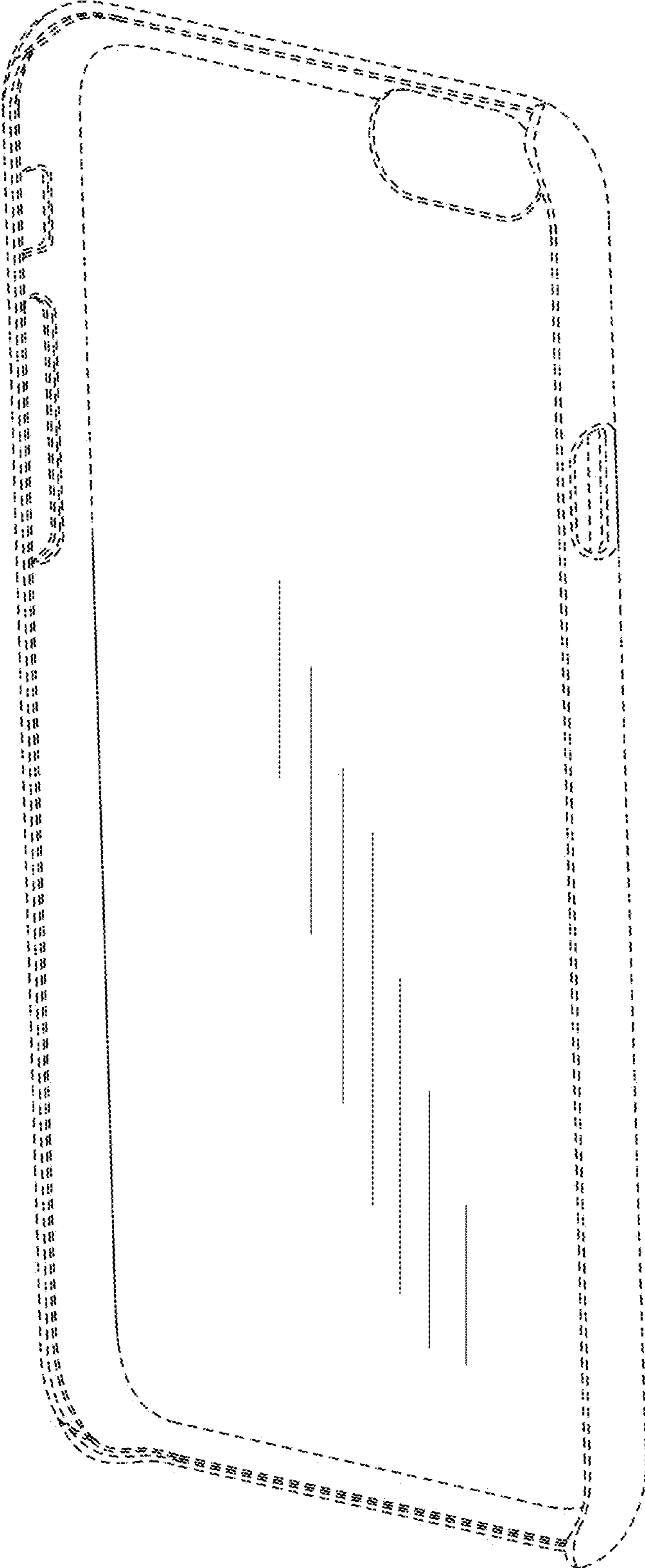

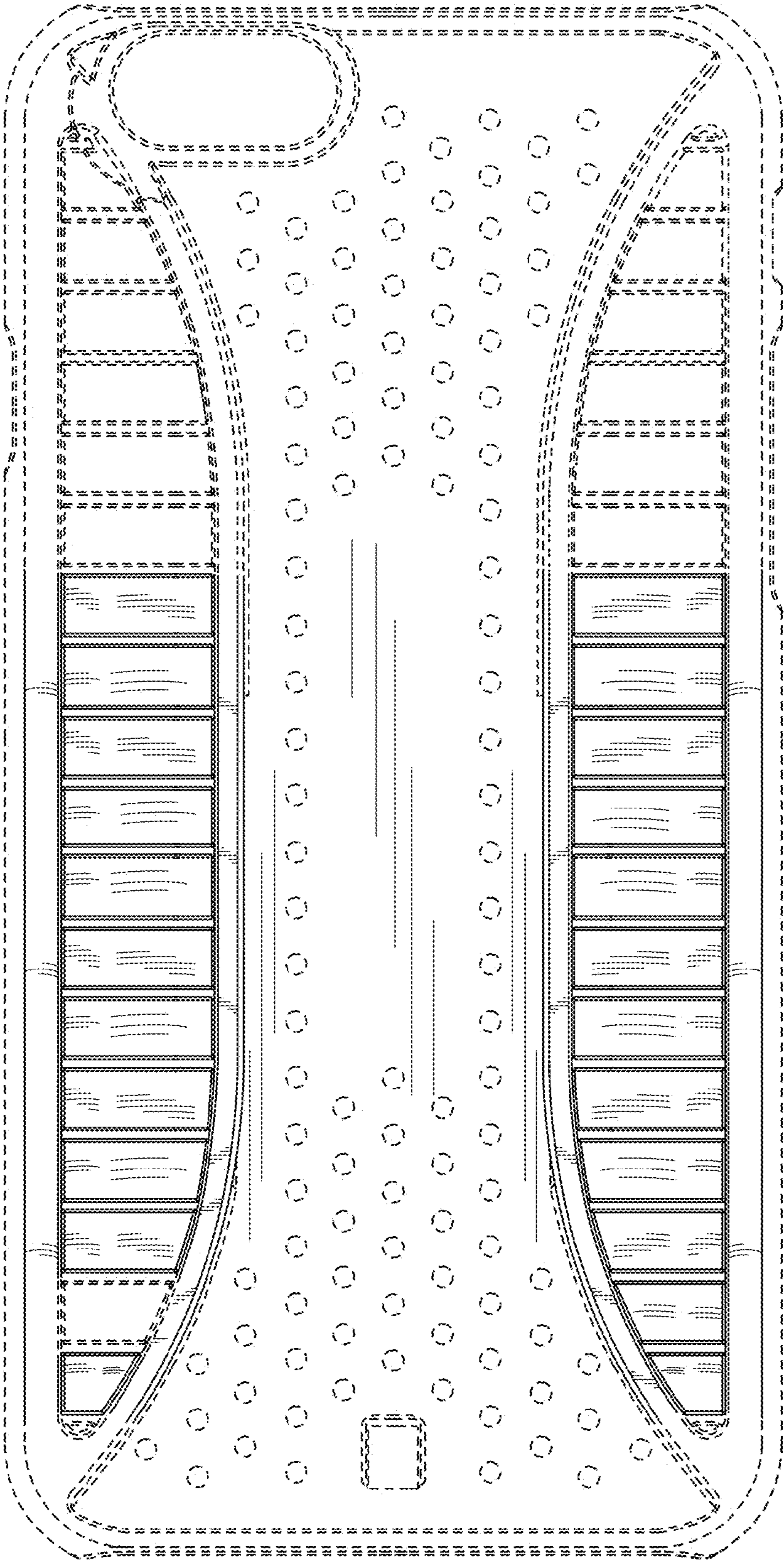

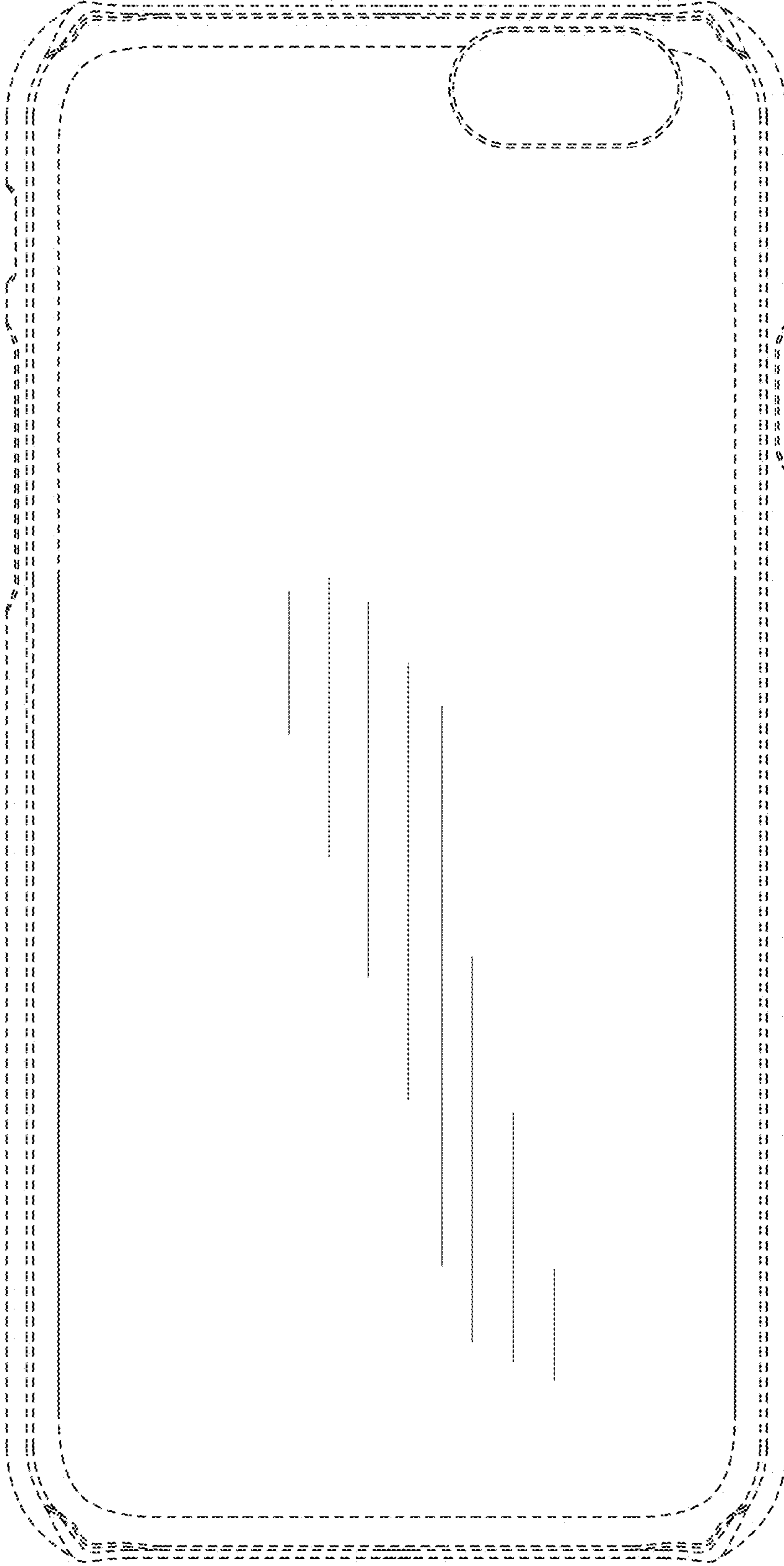

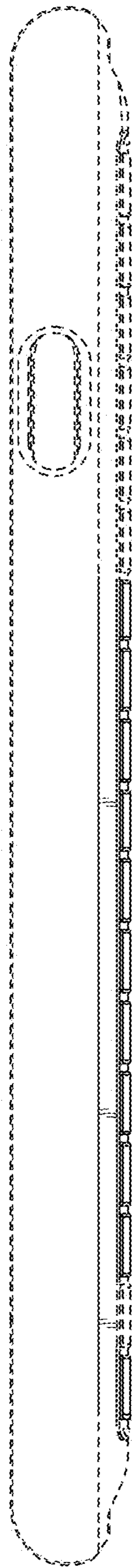

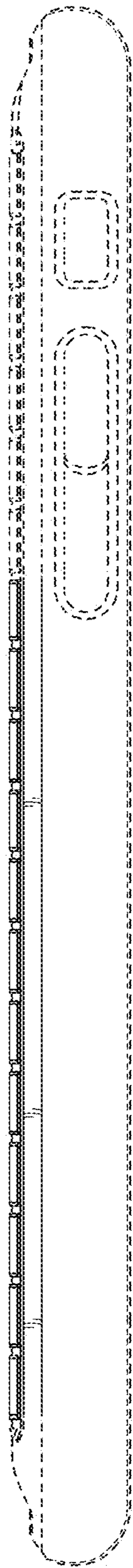

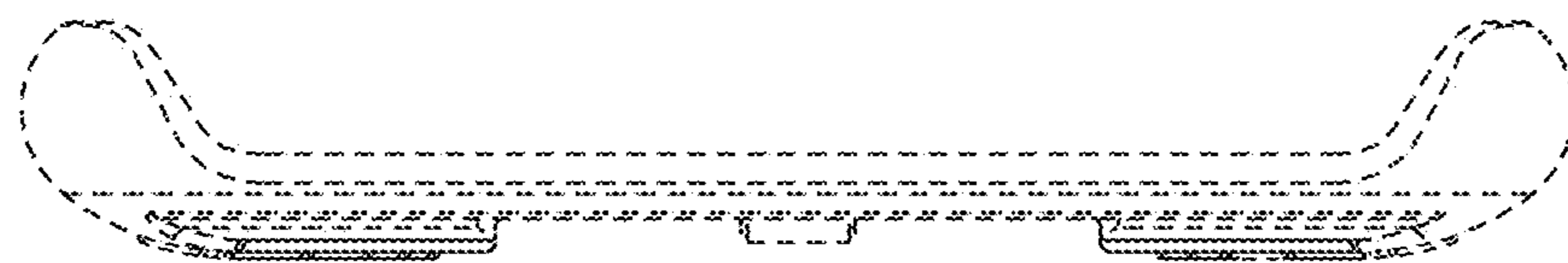

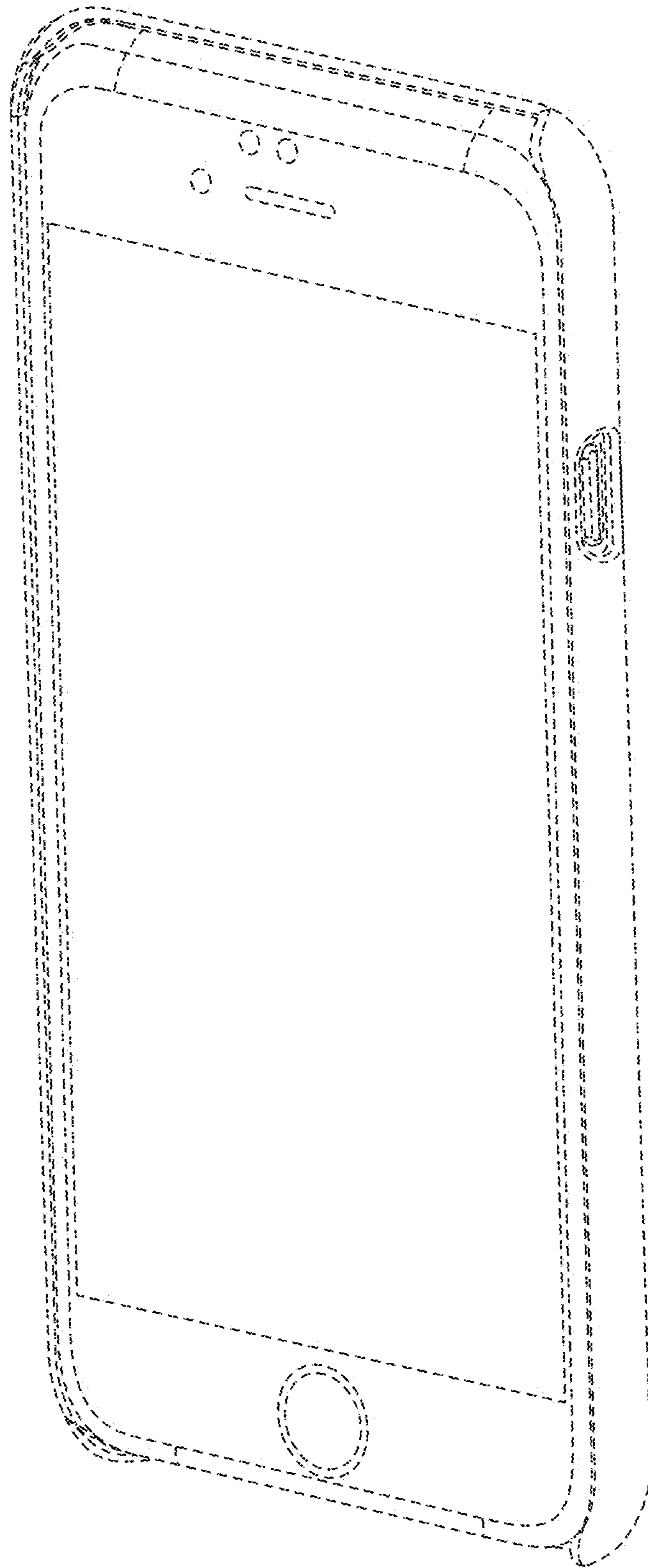
