FIG. 2 is a second image in a sequence thereof;

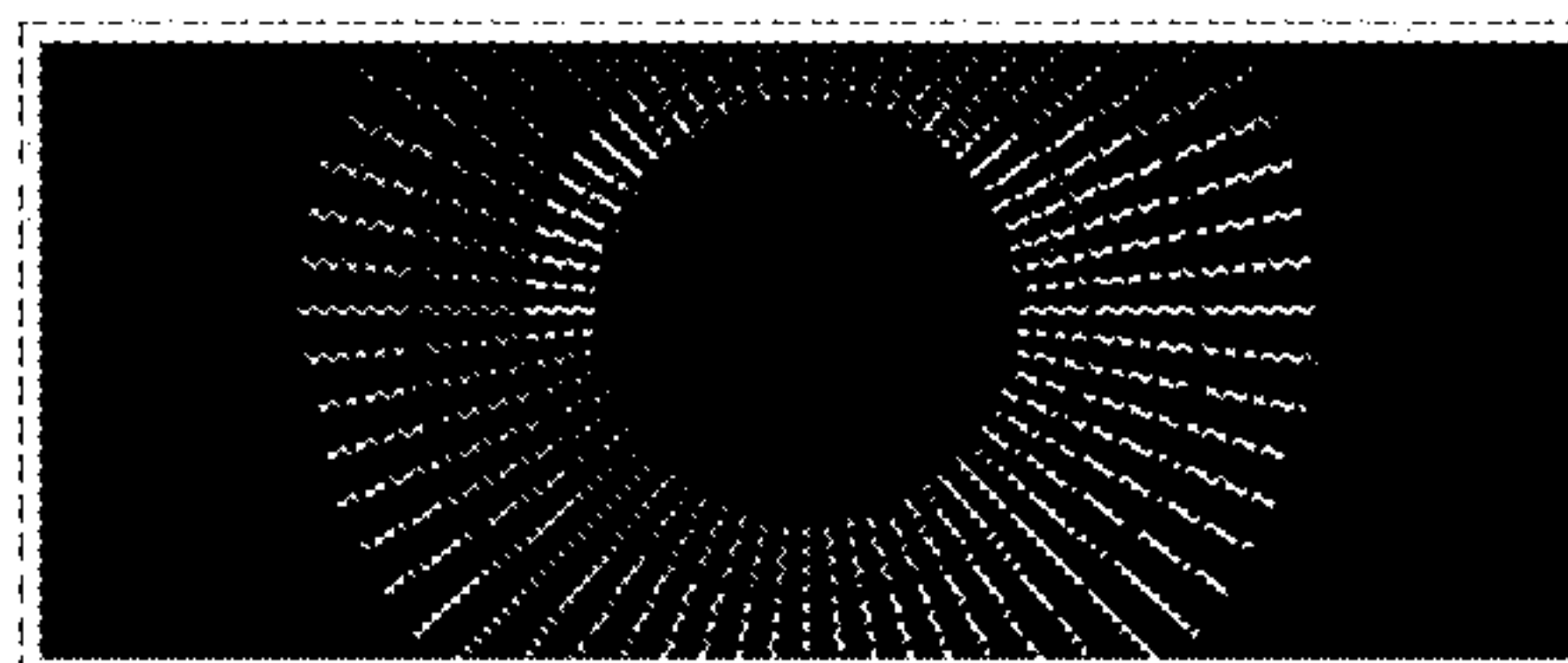
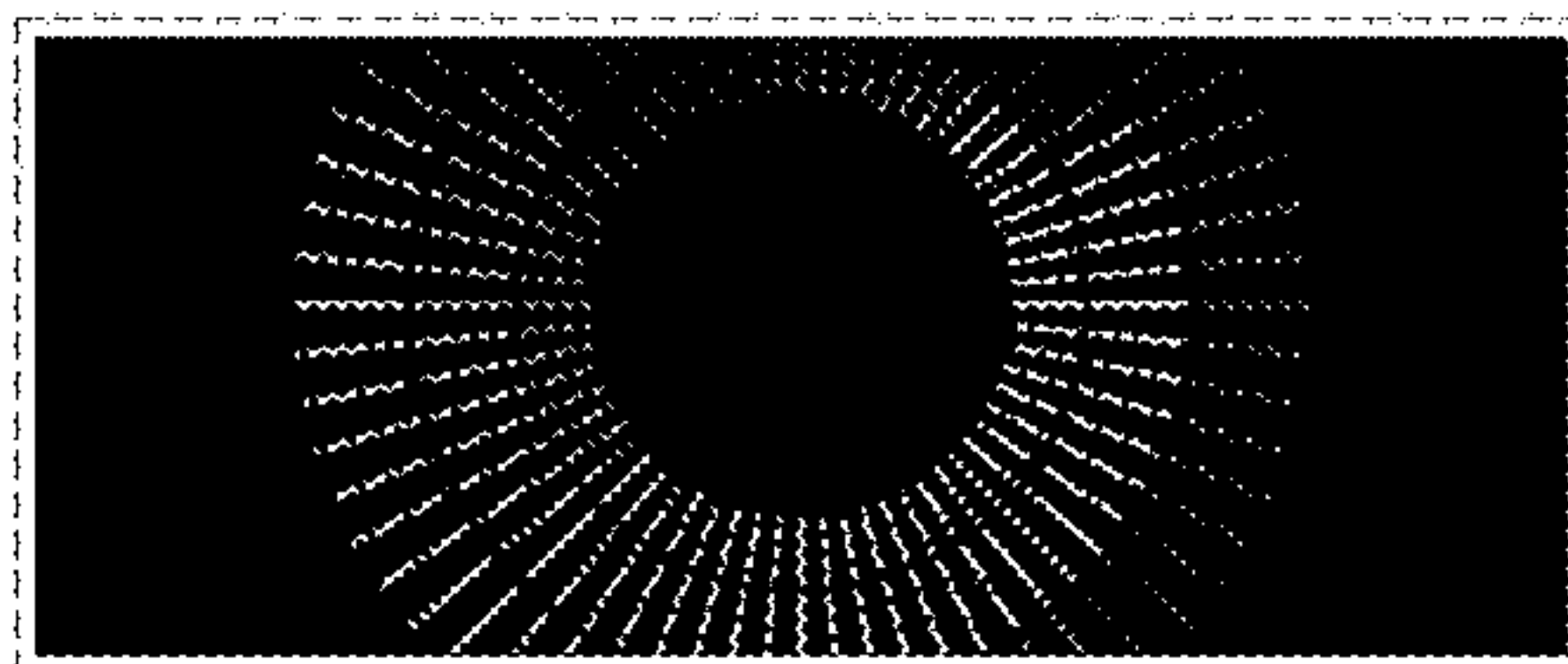
FIG. 3 is a third image in a sequence thereof;

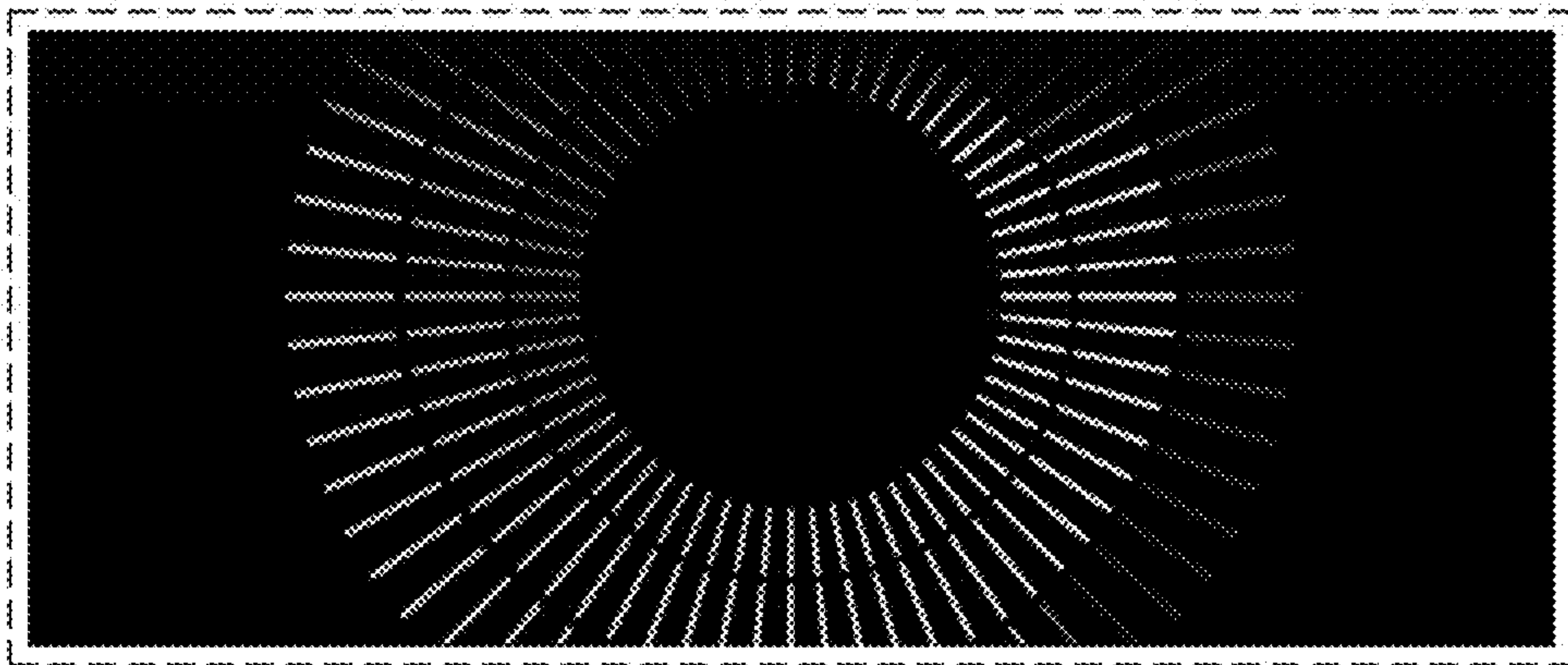

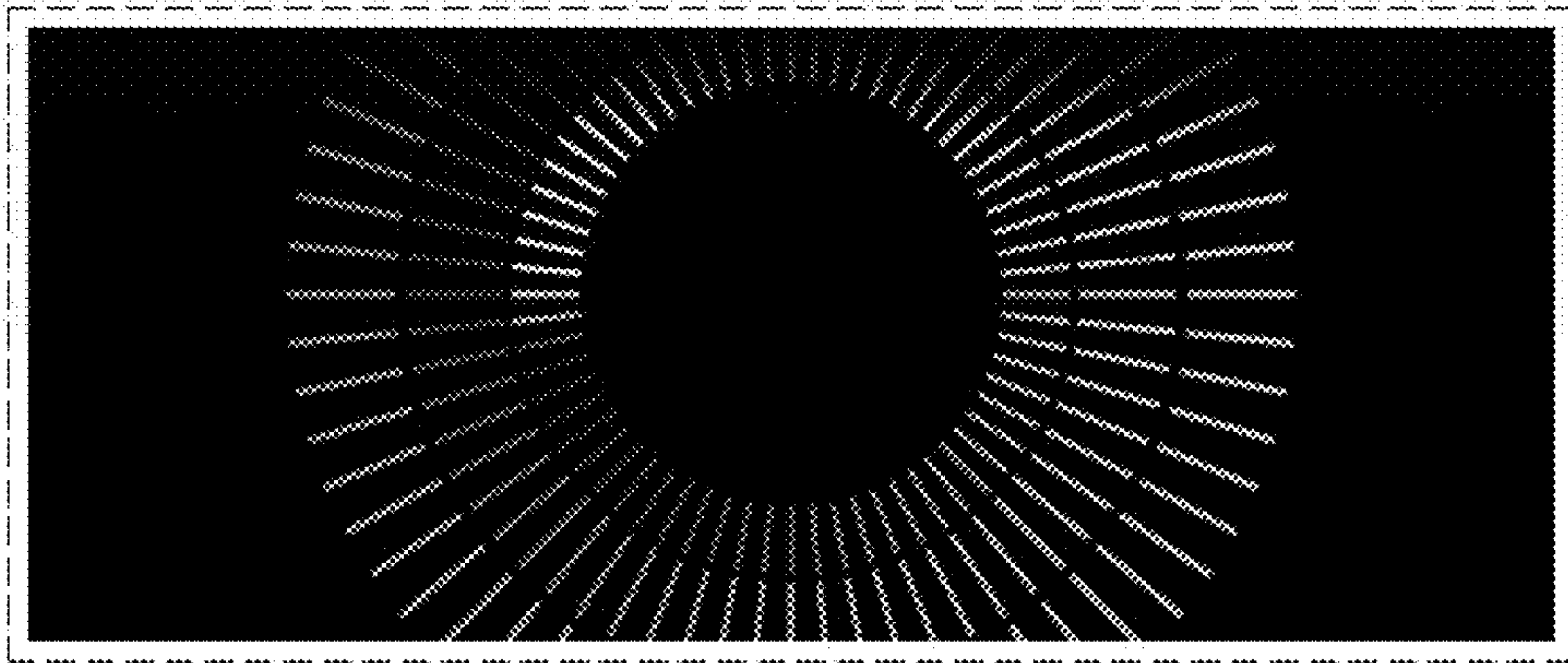

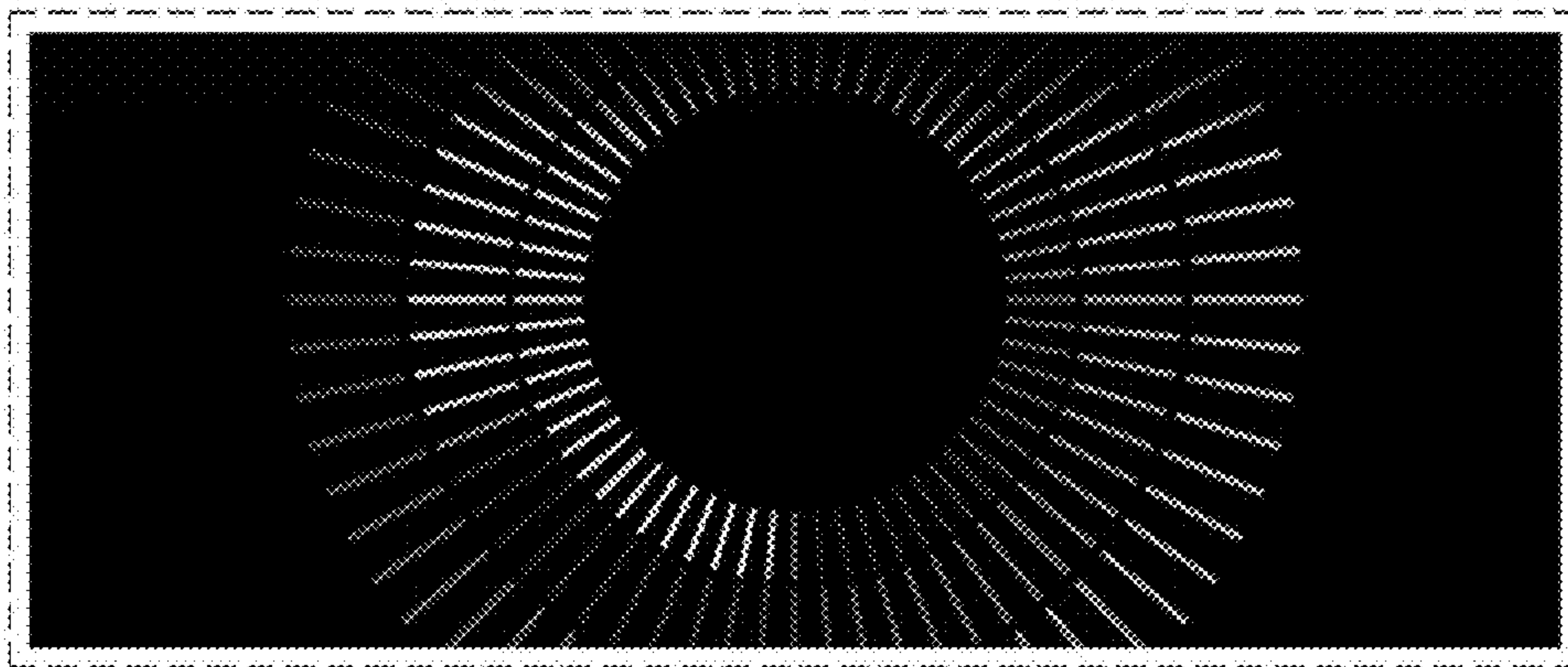

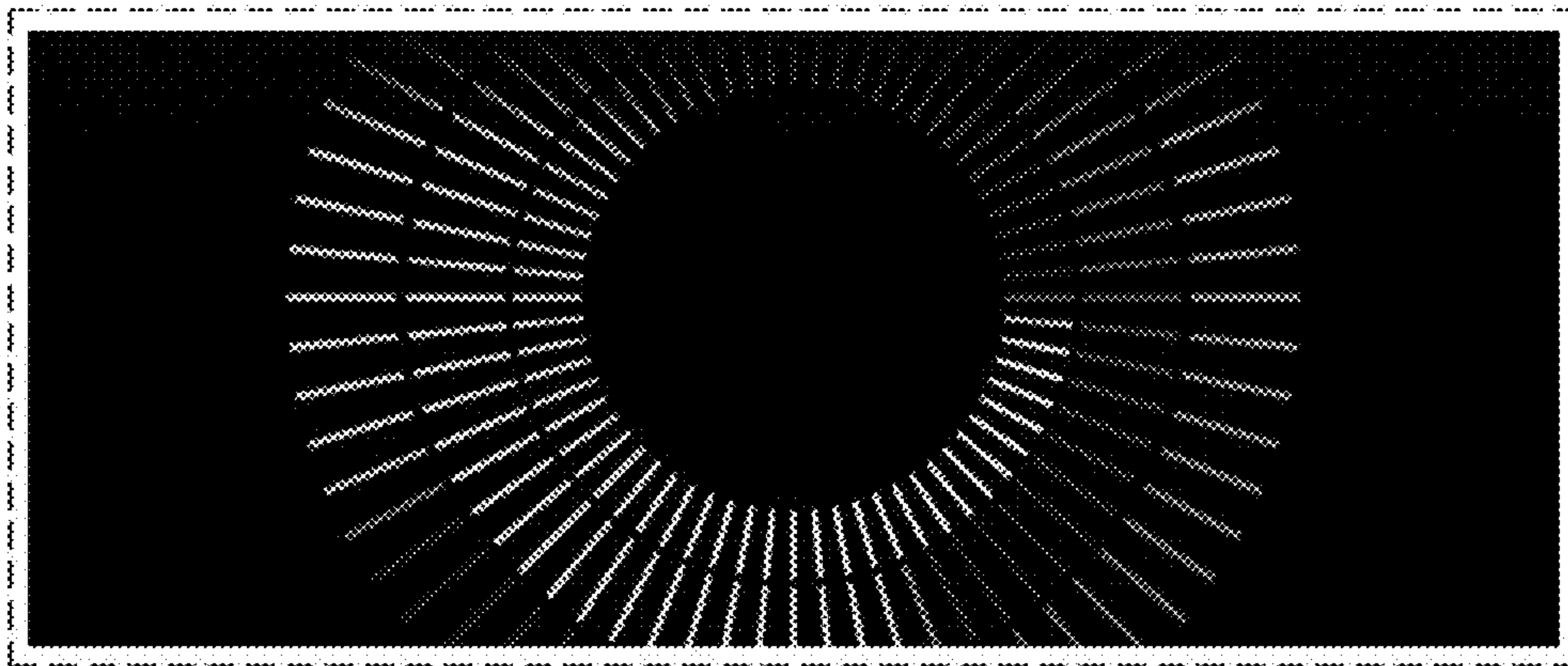
