(57) **CLAIM**

We claim, the ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen or portion thereof with graphical user interface, showing our new design; and, FIG. 2 is another front view thereof, in which an entire display screen is illustrated.

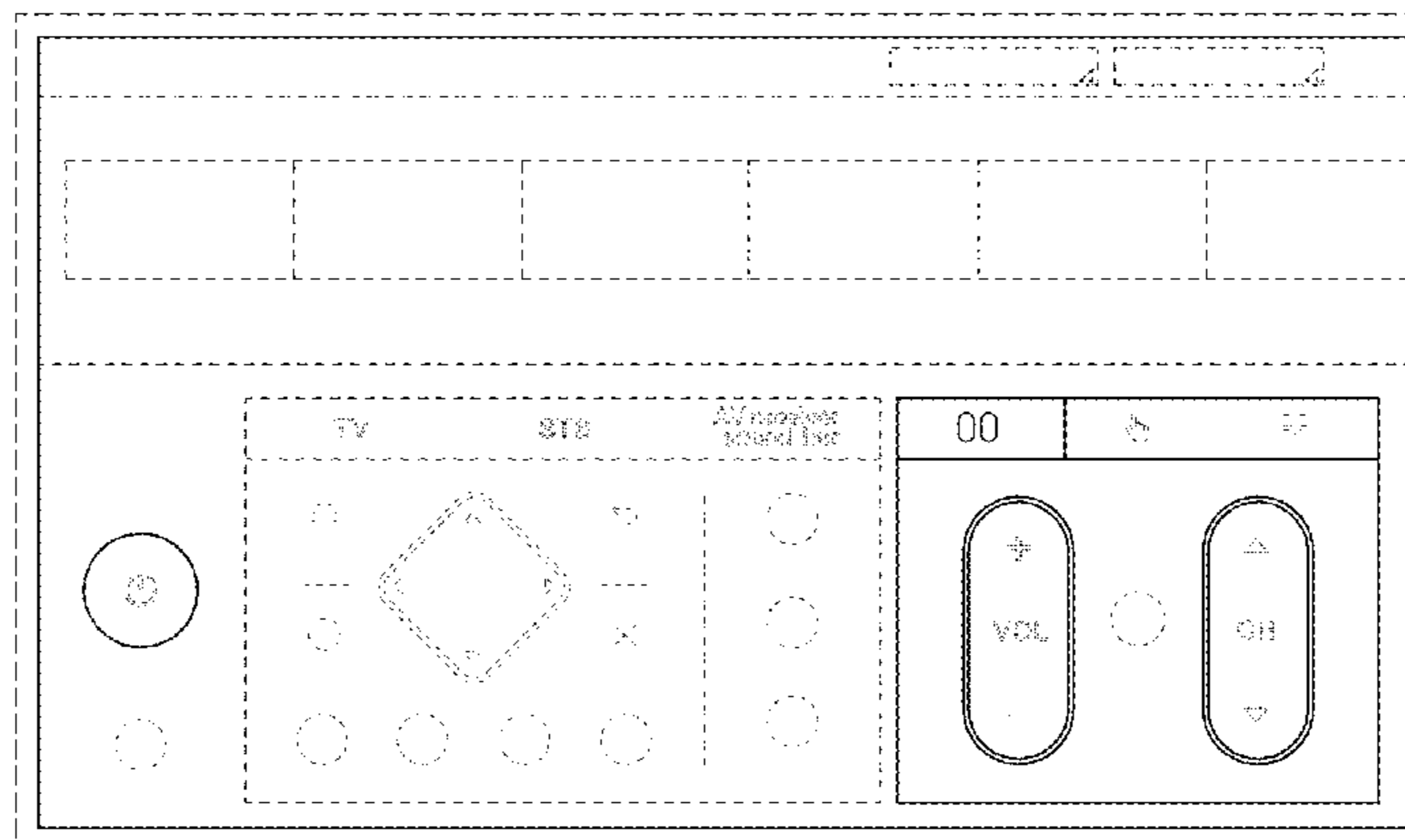

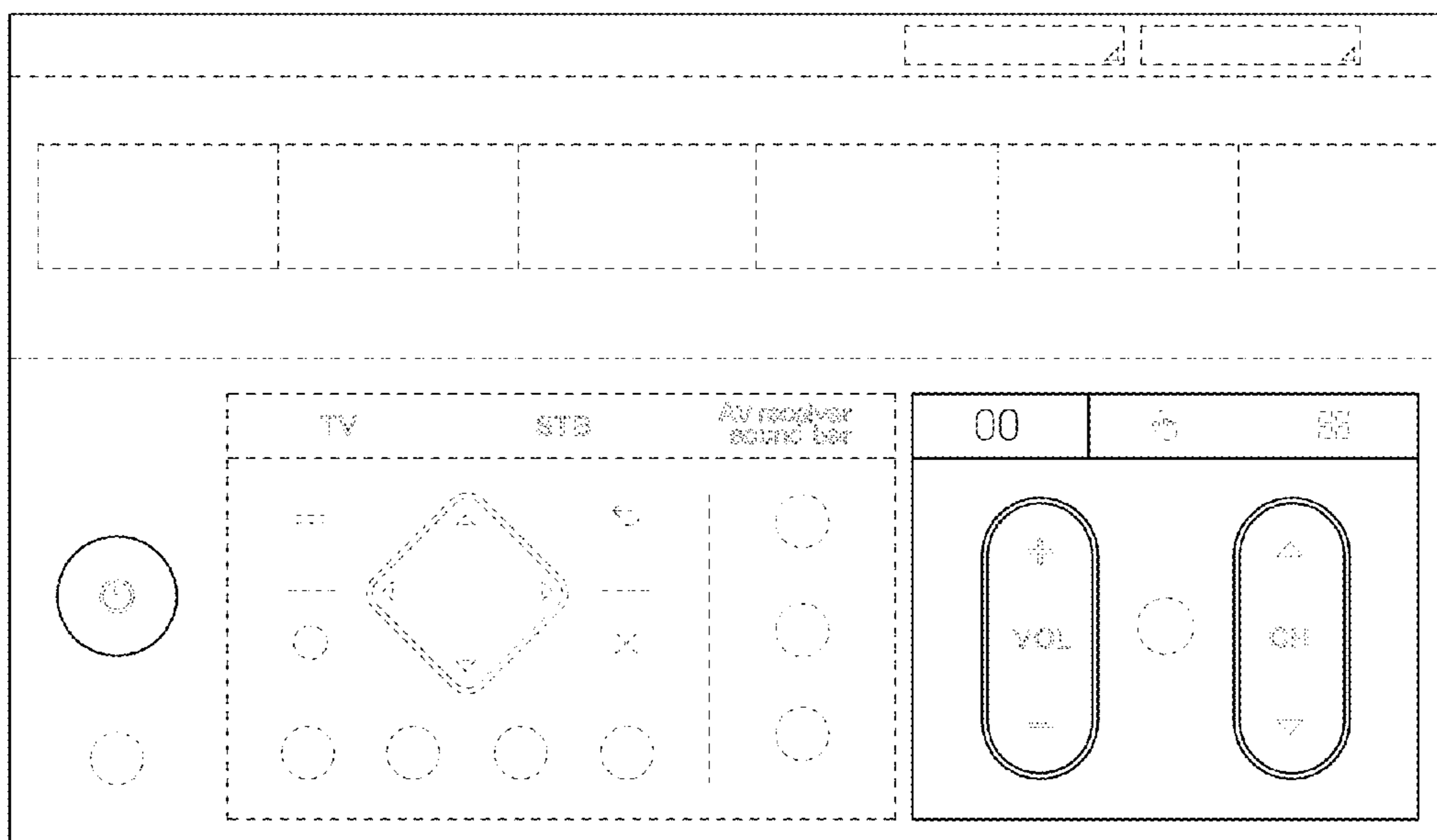
