The ornamental design for a display screen or portion thereof with device management function icon, as shown and described.

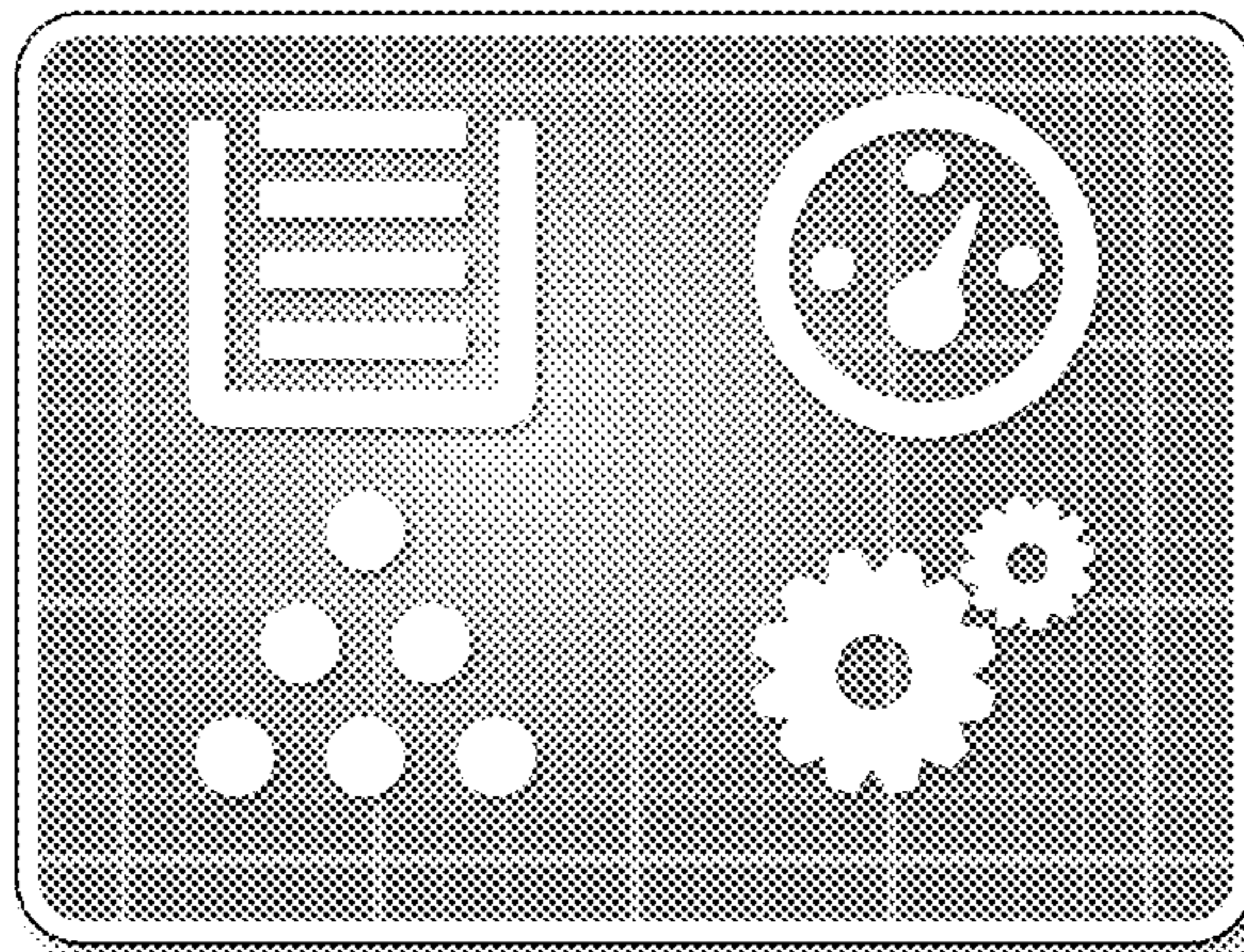
DESCRIPTION

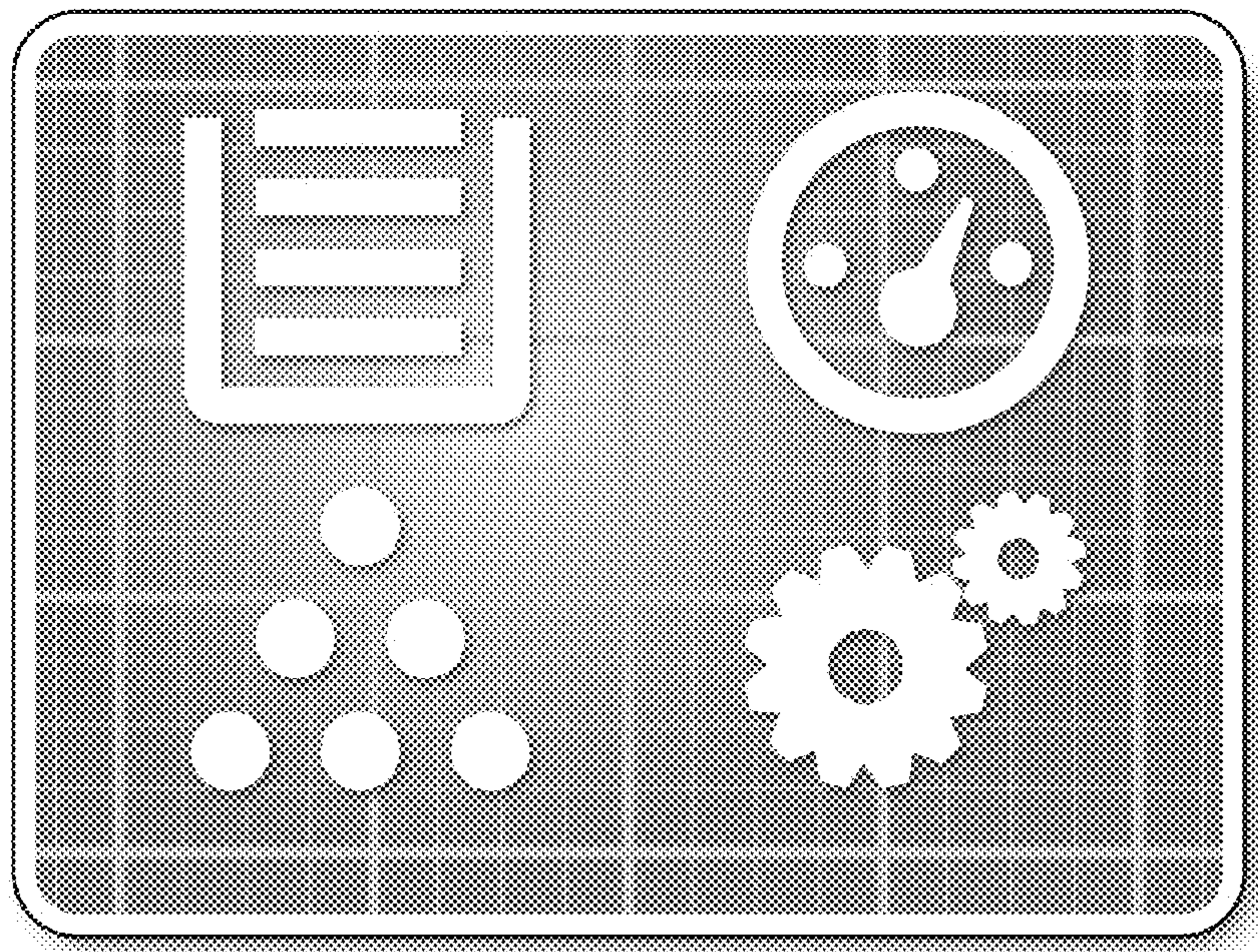

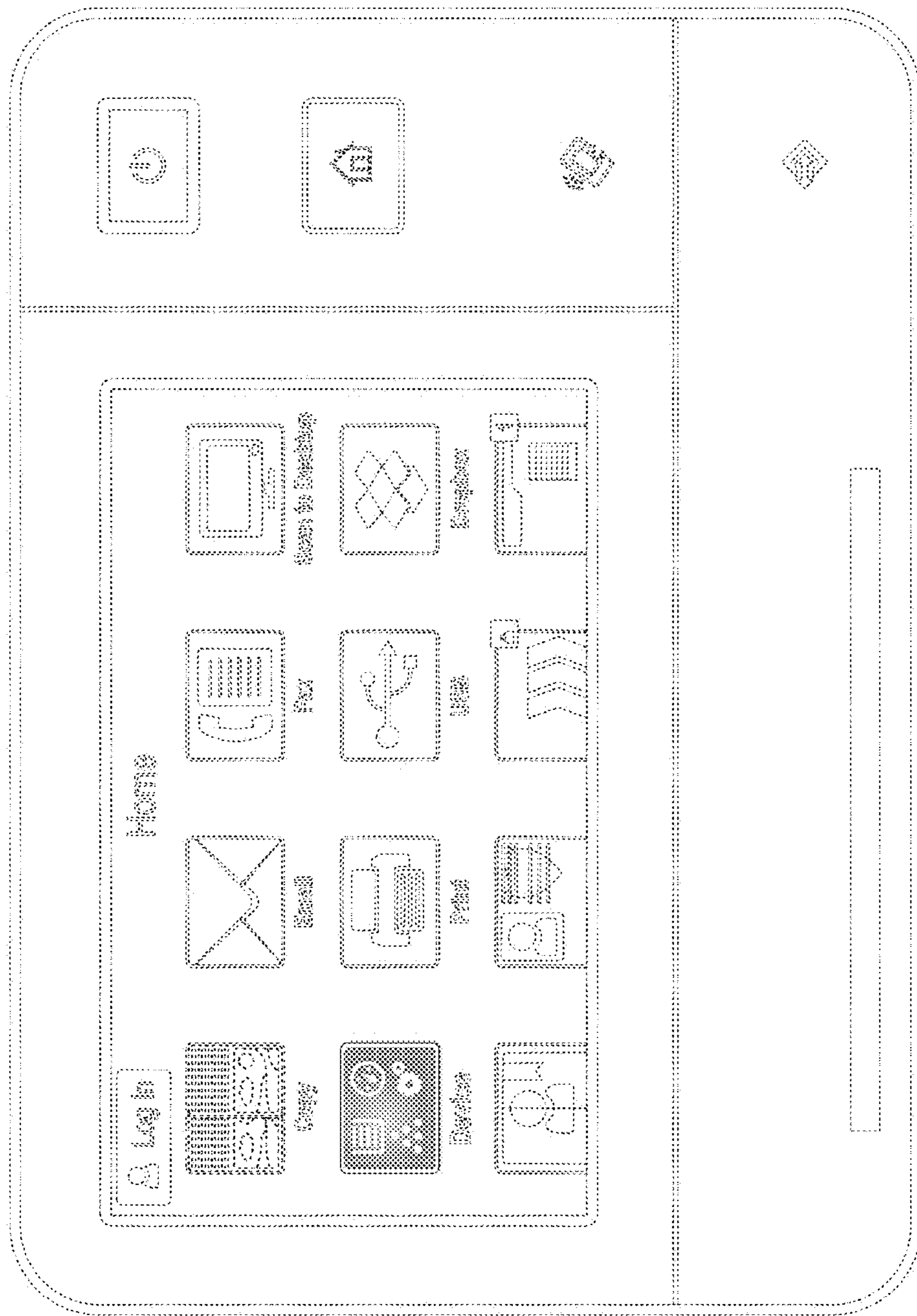
