(57) **CLAIM**

The ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen or portion thereof with graphical user interface, showing my new design; and, FIG. 2 is a front view thereof, in which a mobile terminal in broken line is provided to illustrate an example environment. The broken lines are for illustrative purposes only and form no part of the claimed design.

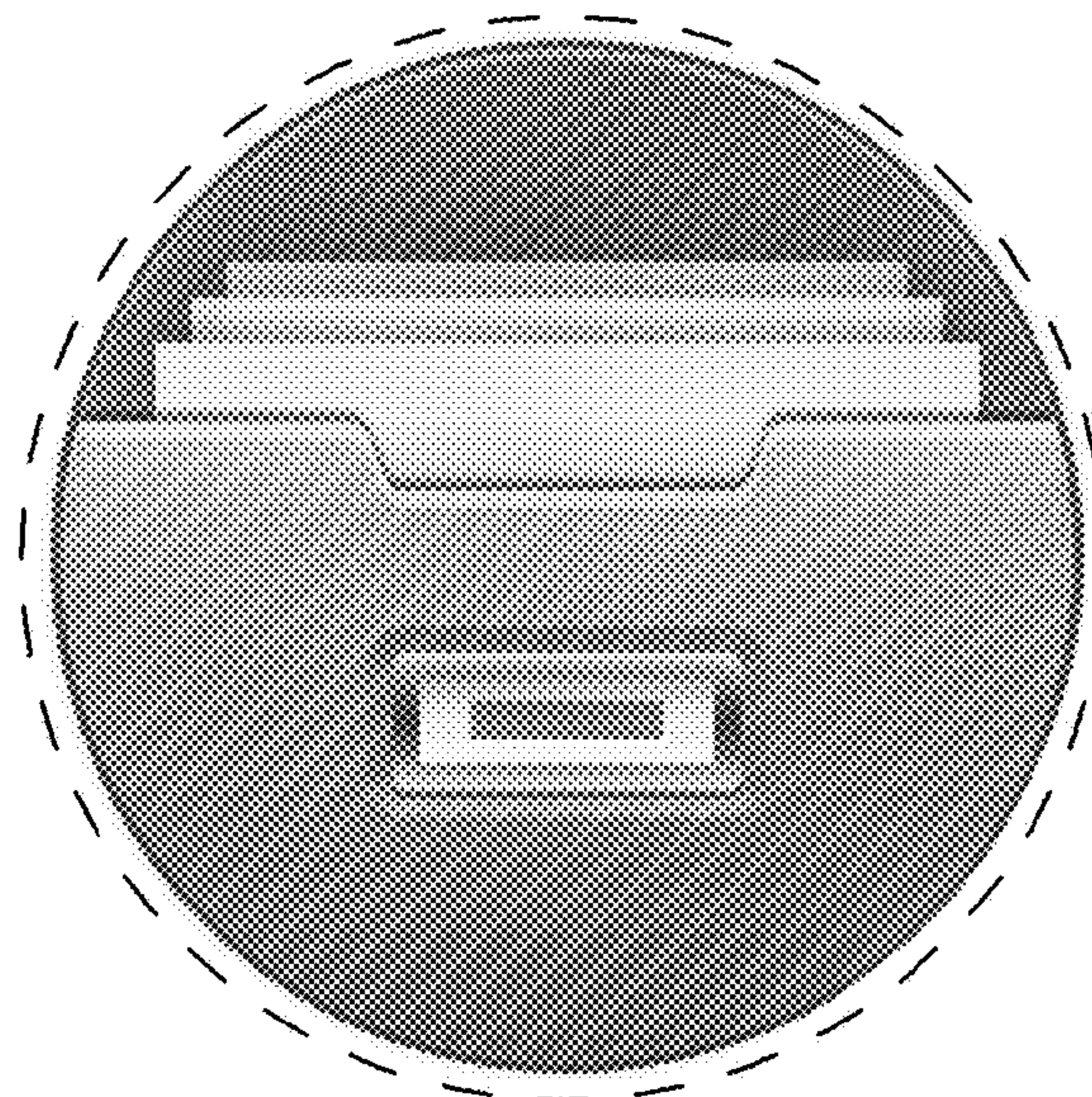

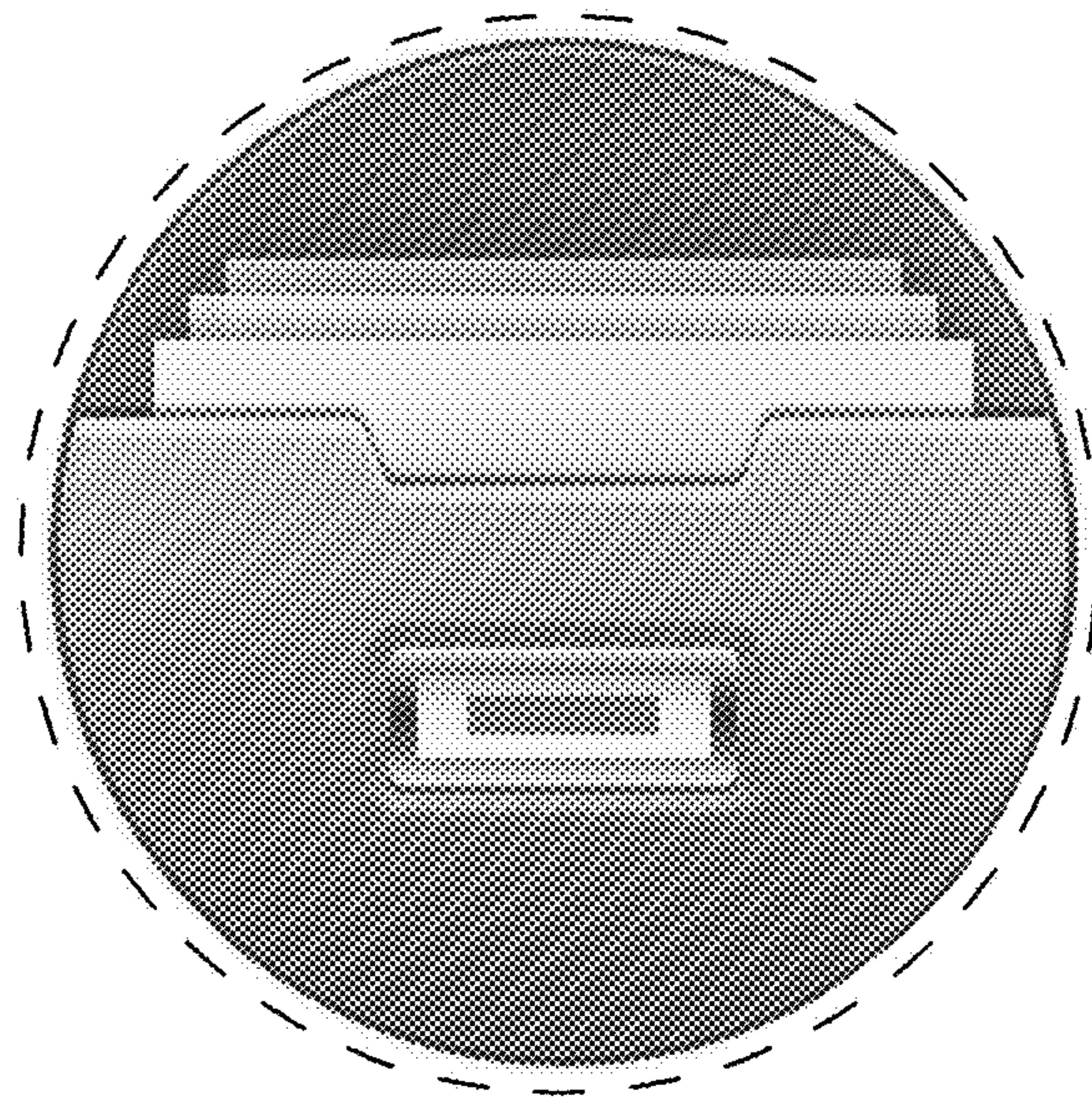
