FIG. 6 is a top view thereof;

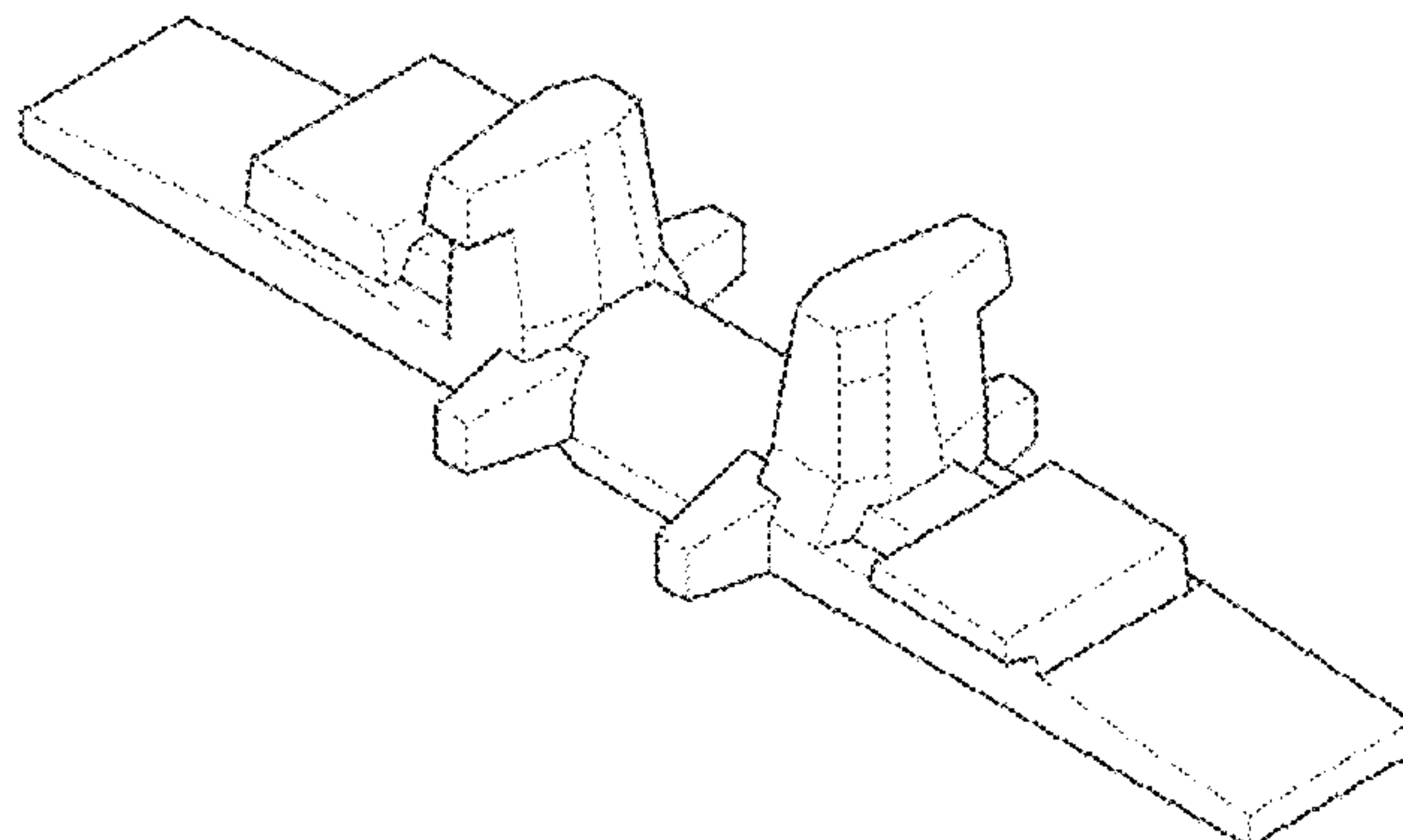
FIG. 7 is a bottom view thereof;

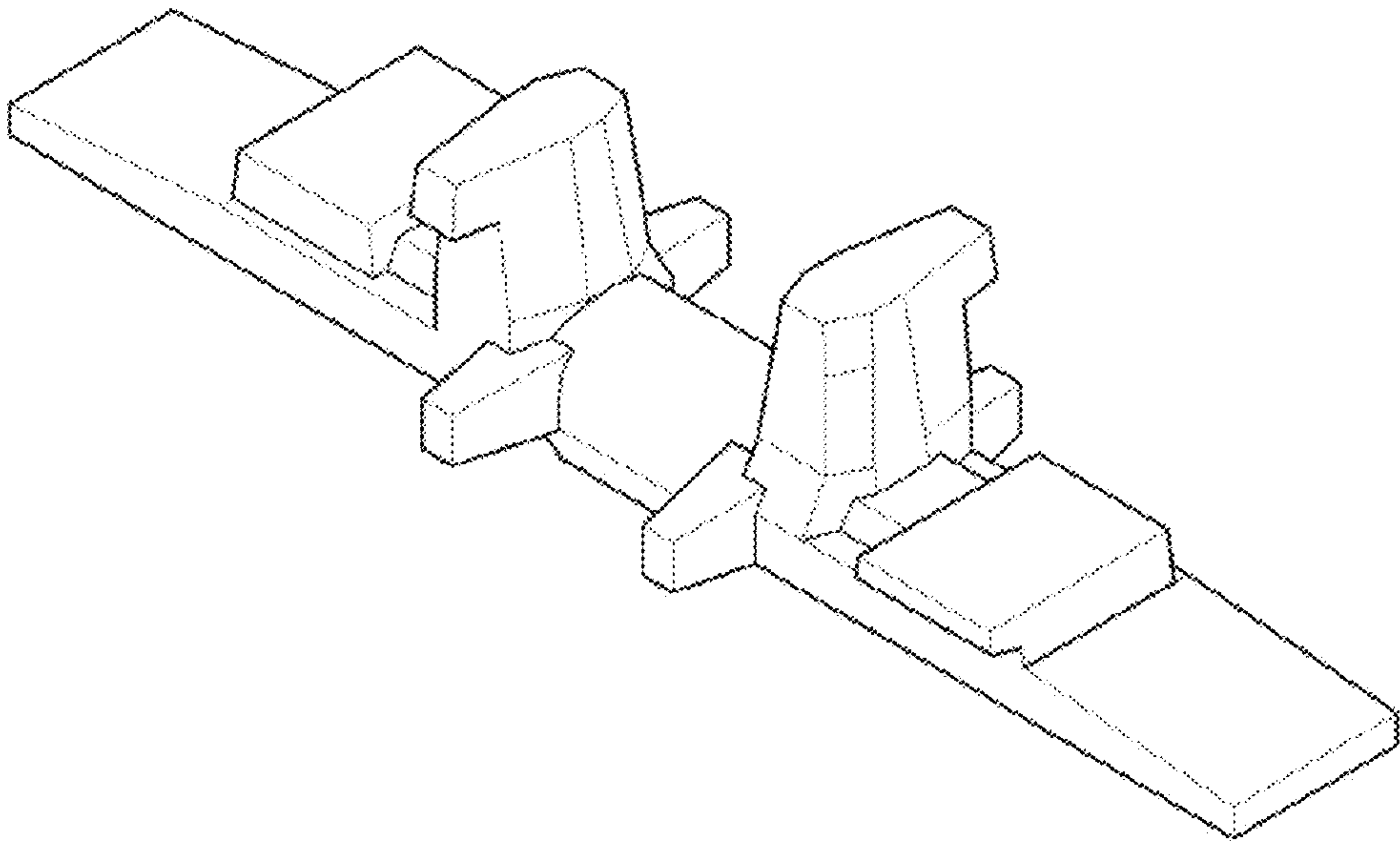

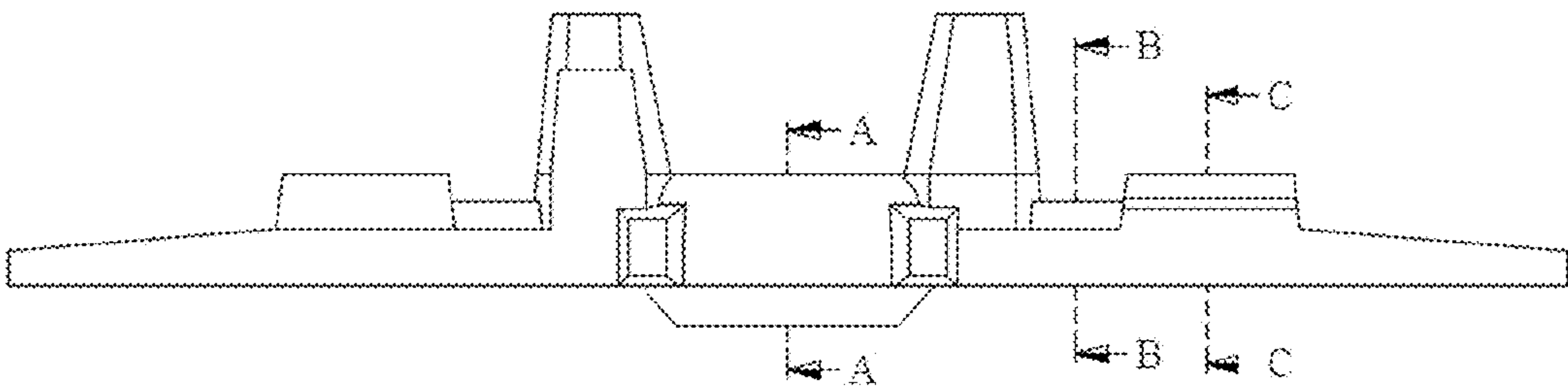

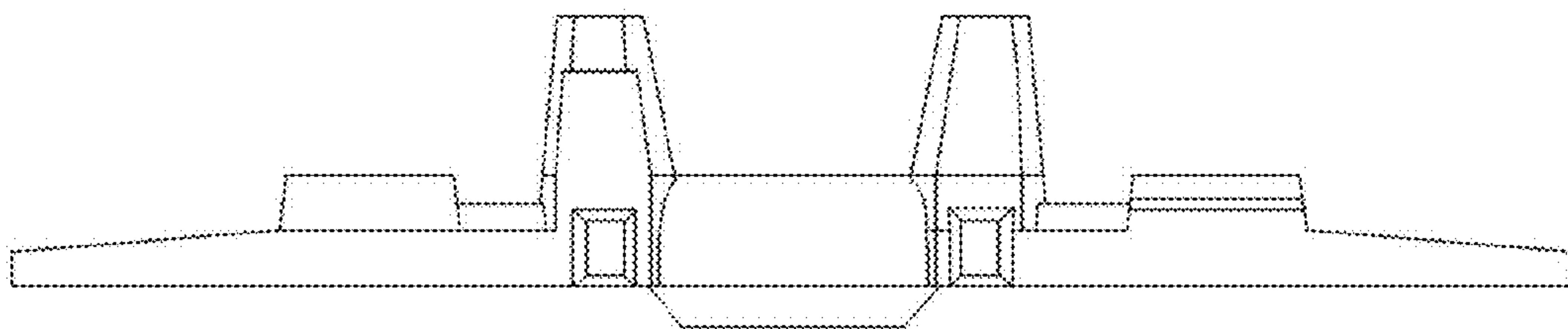

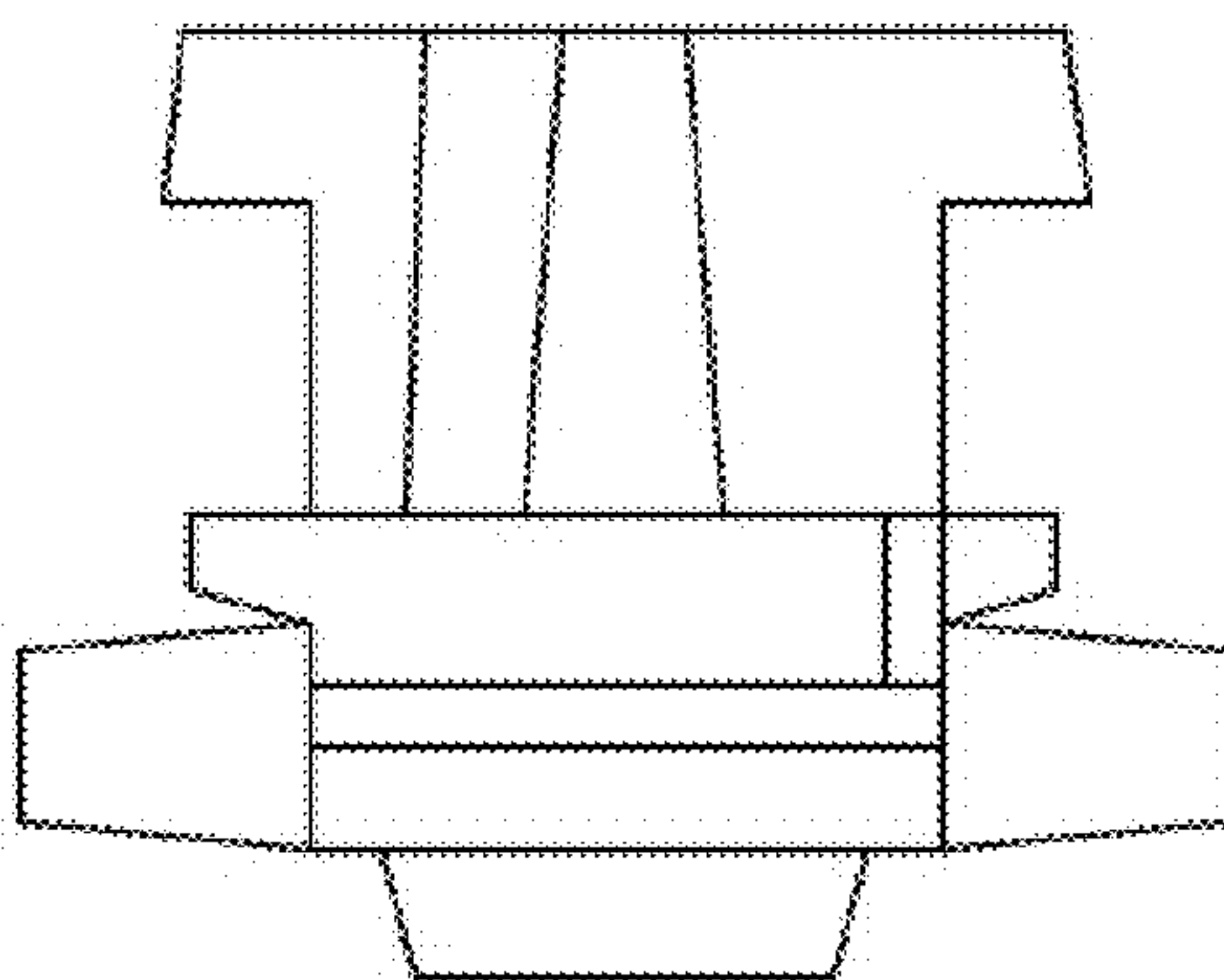

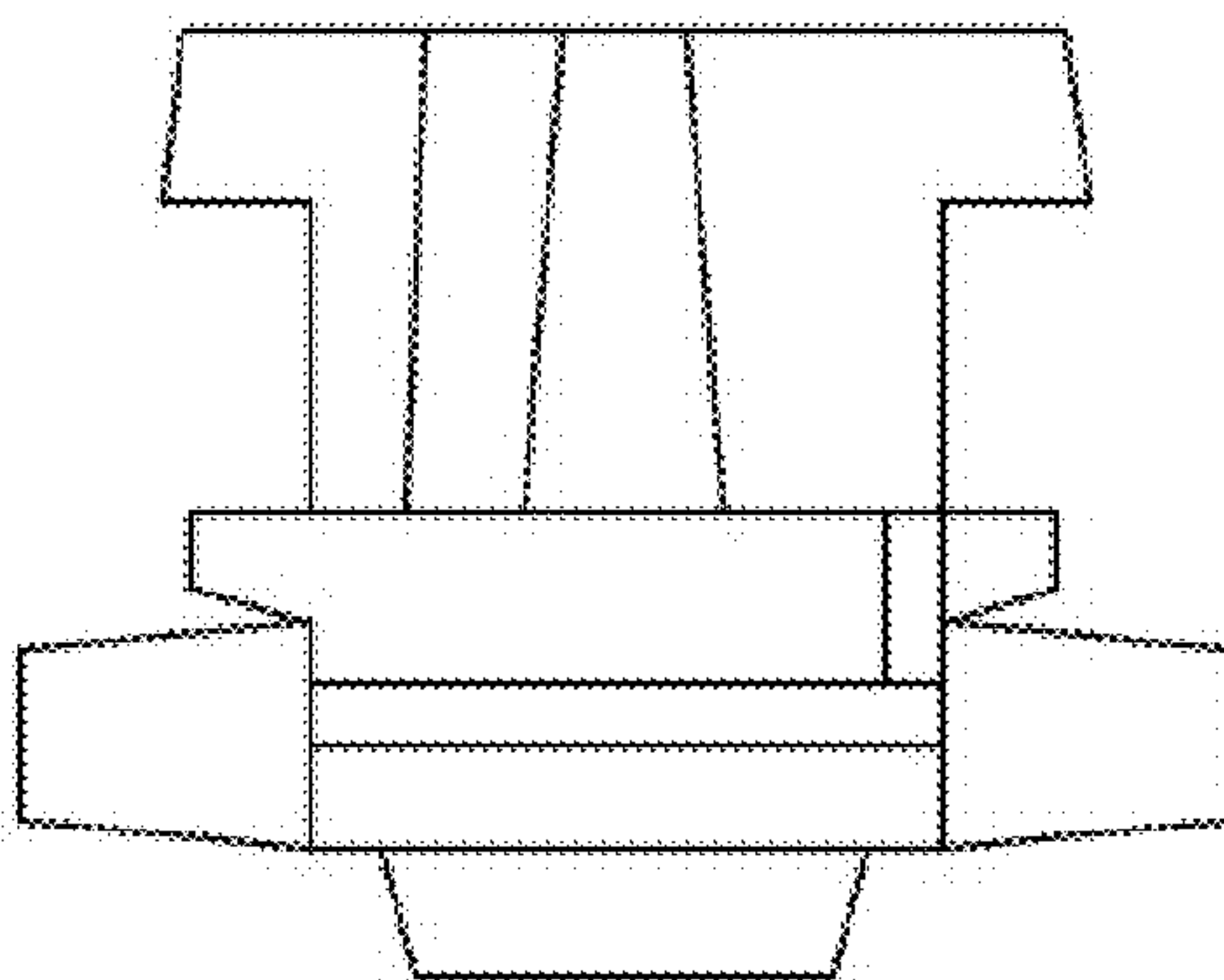

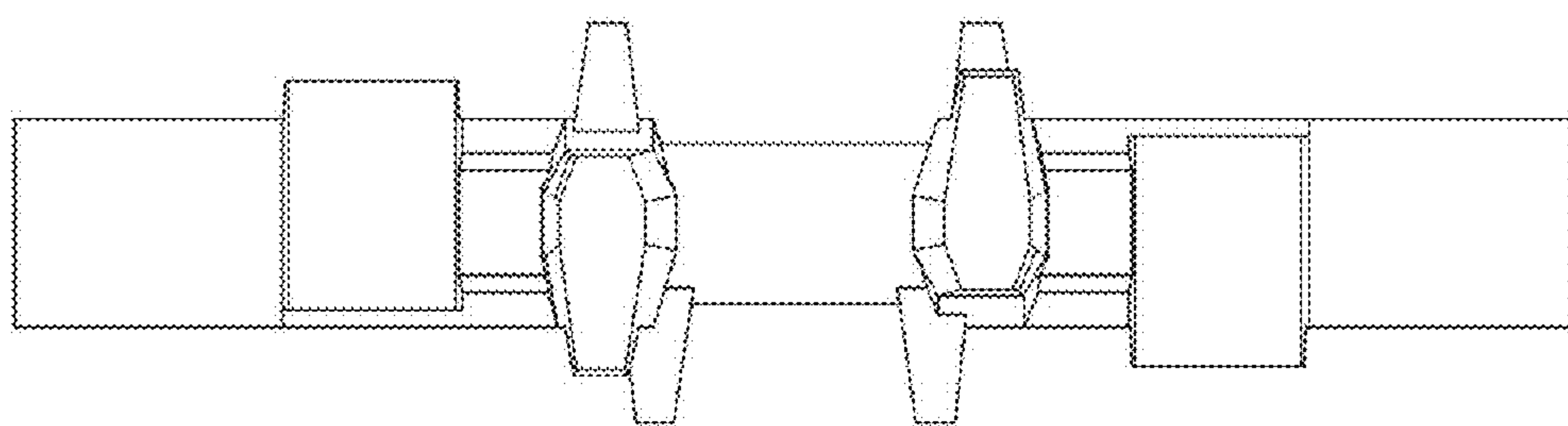

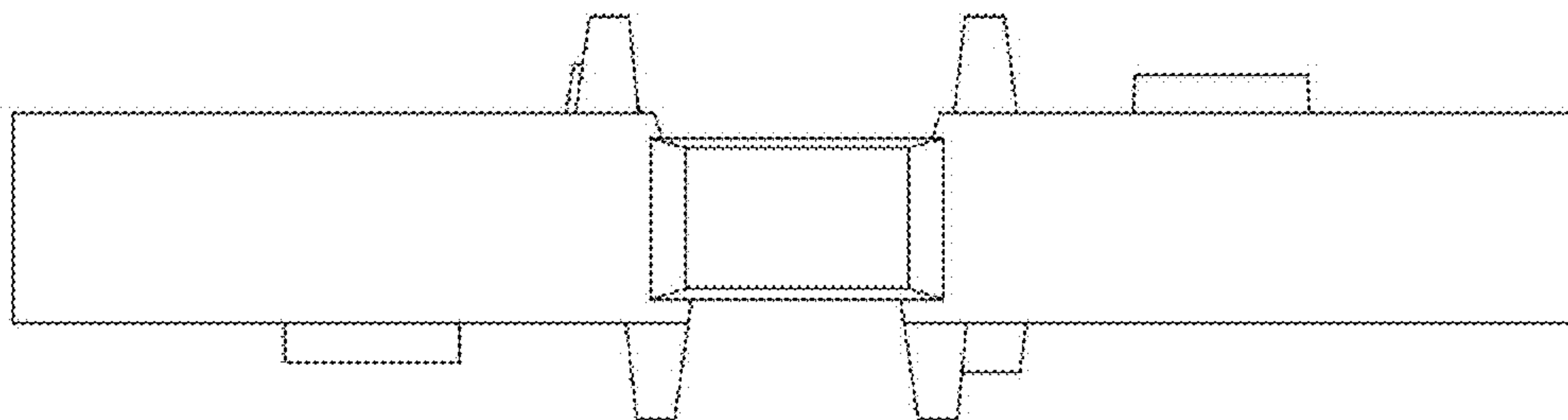

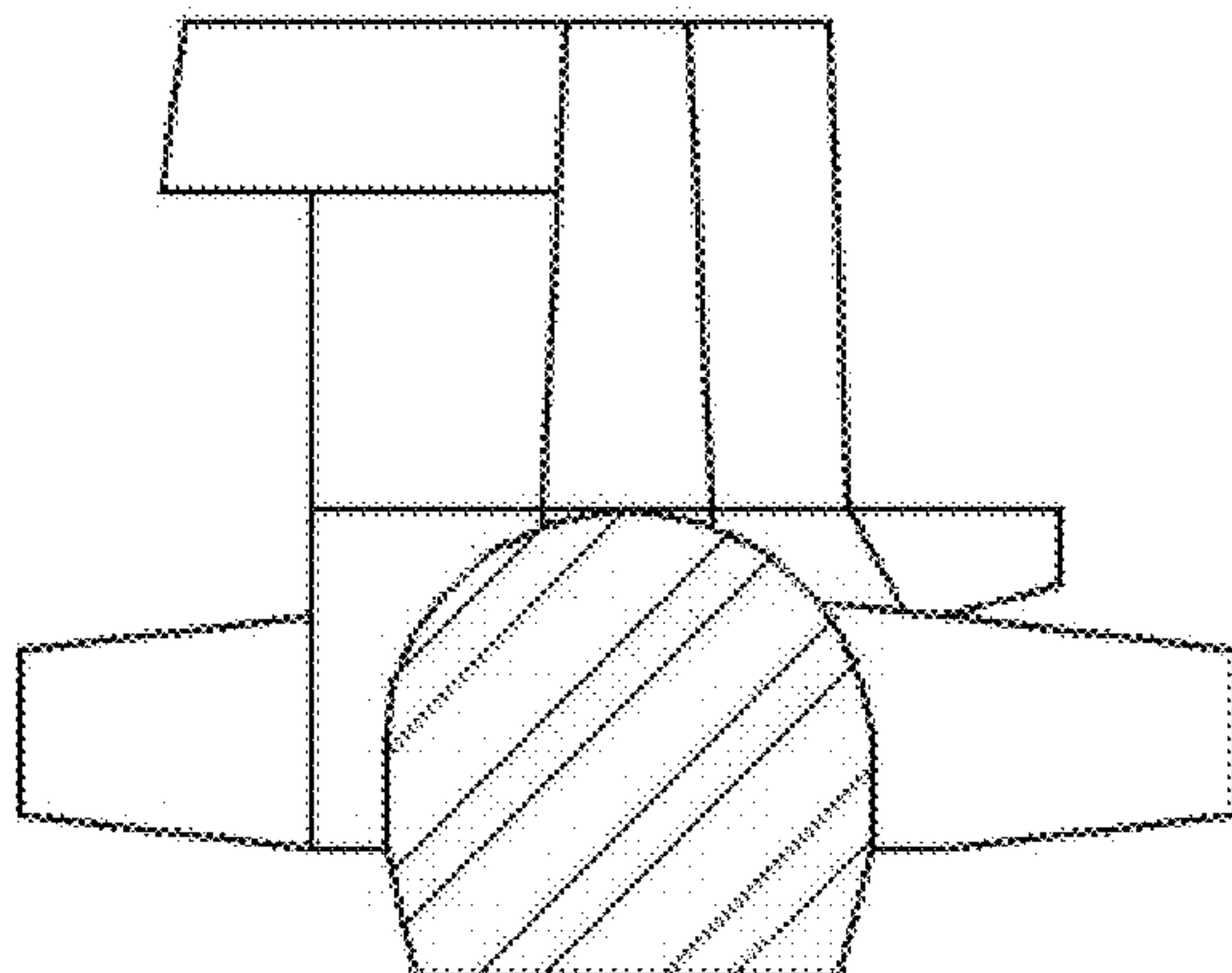

(A-A Cross-sectional view)

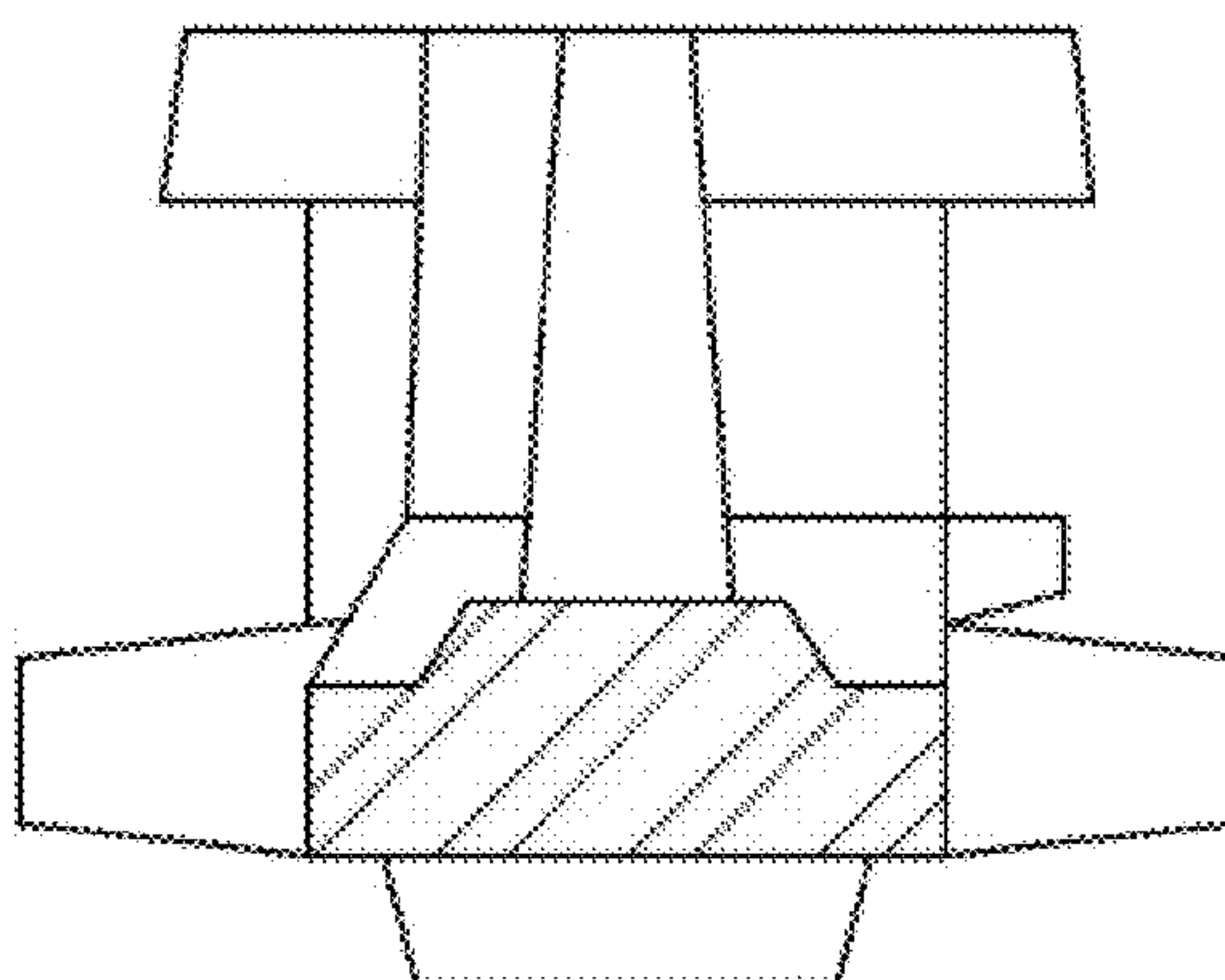

(B-B Cross Sectional view)

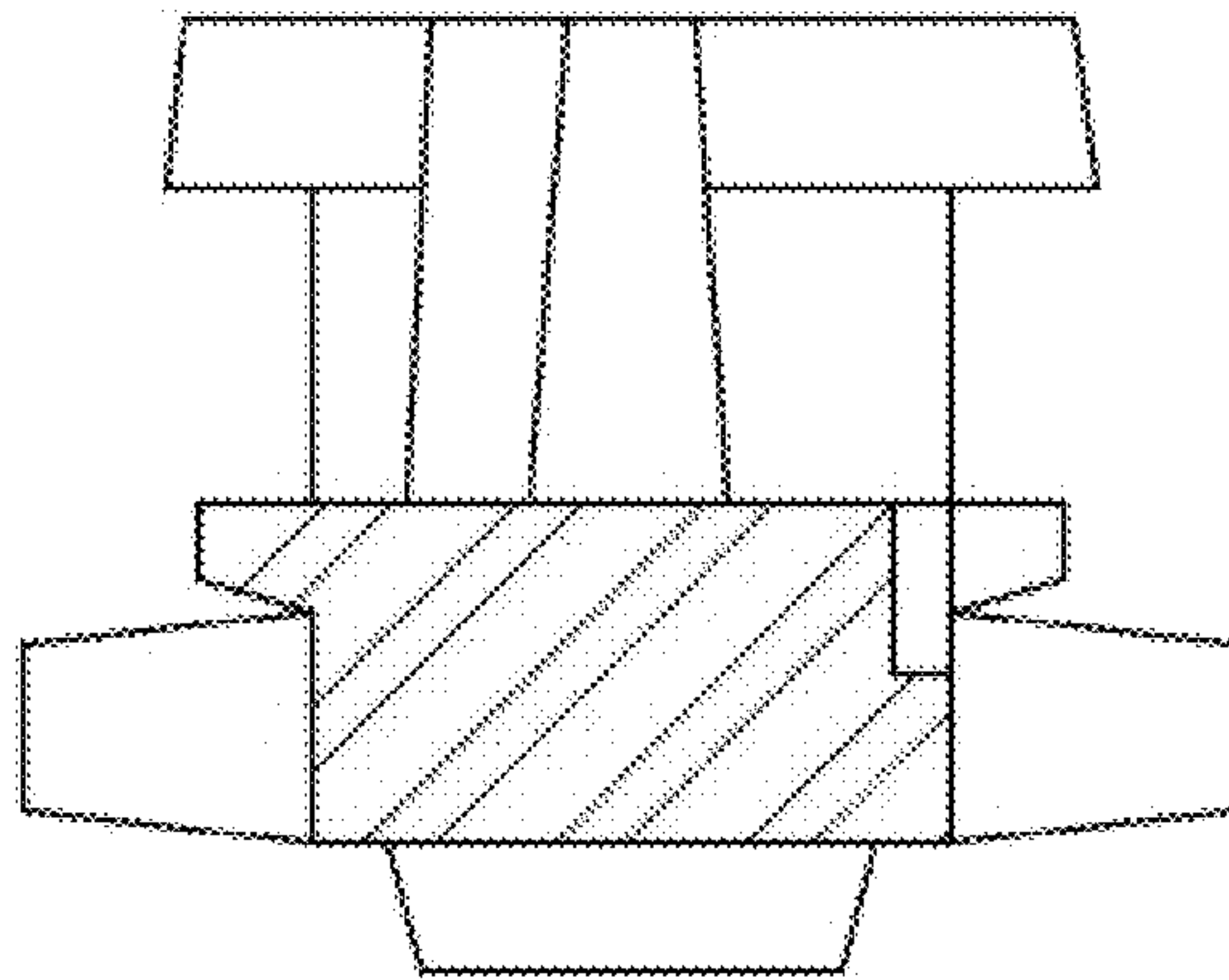
