FIG. 5 is a right side view.

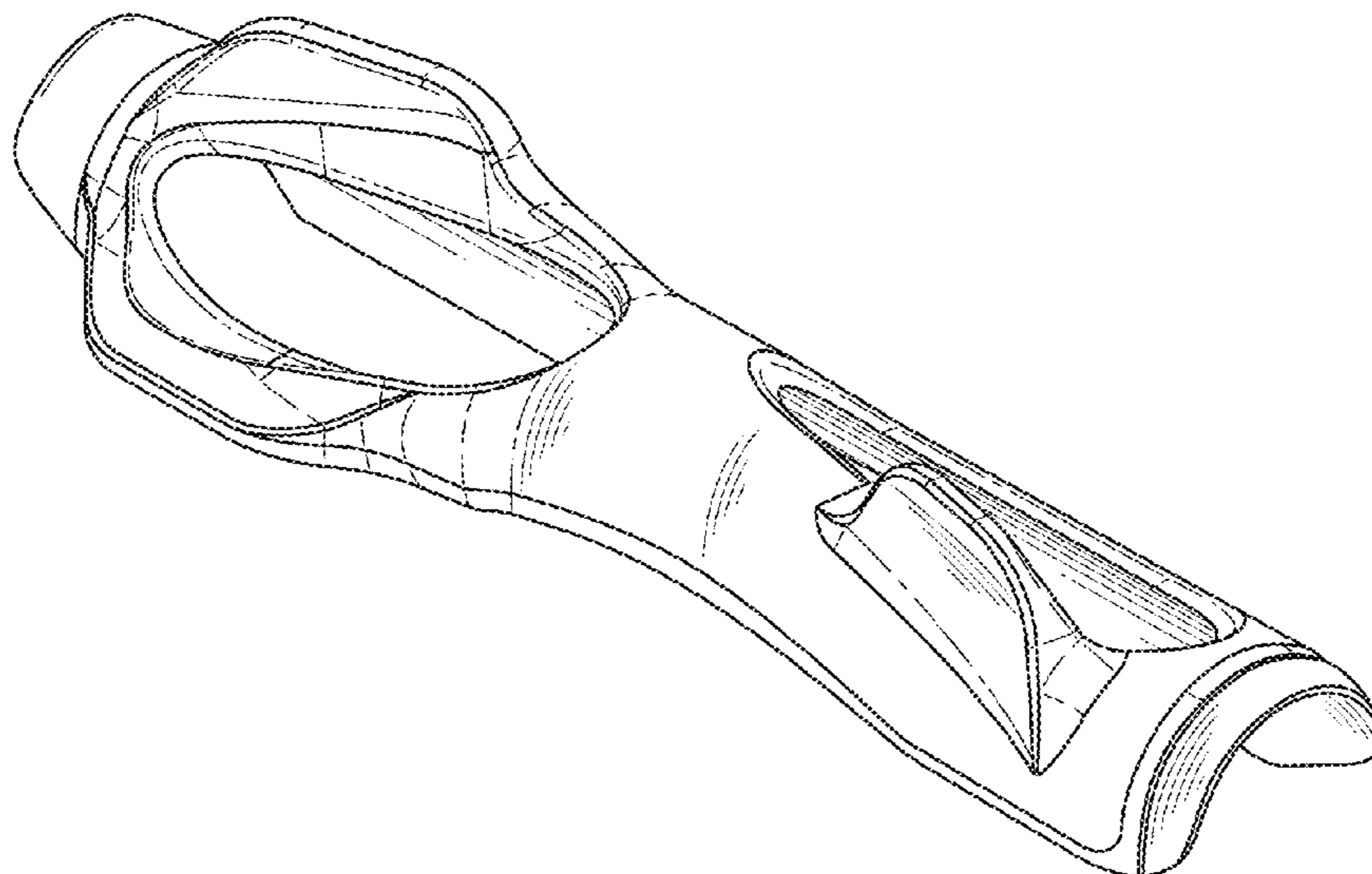
FIG. 6 is a front end view; and,

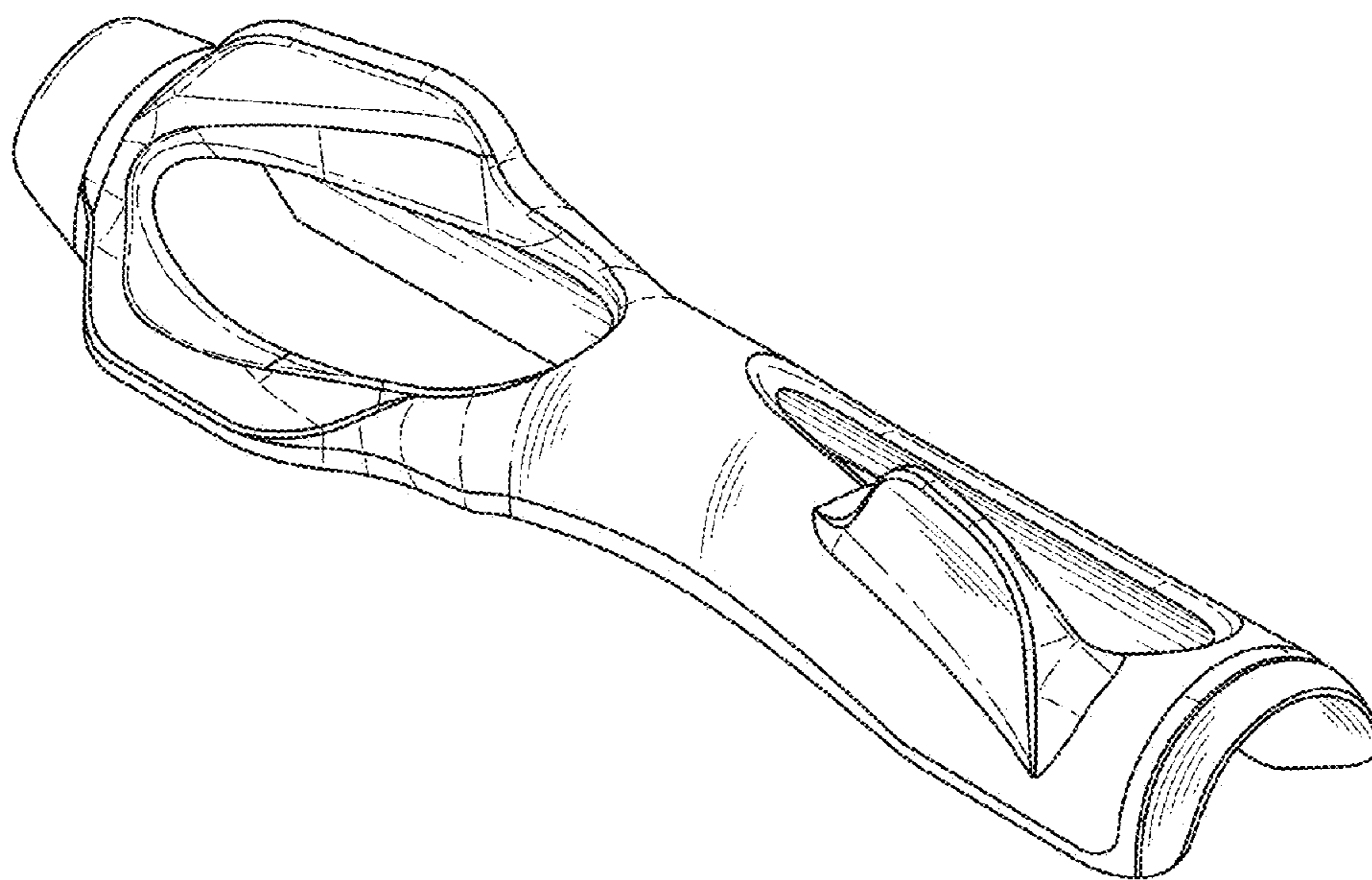

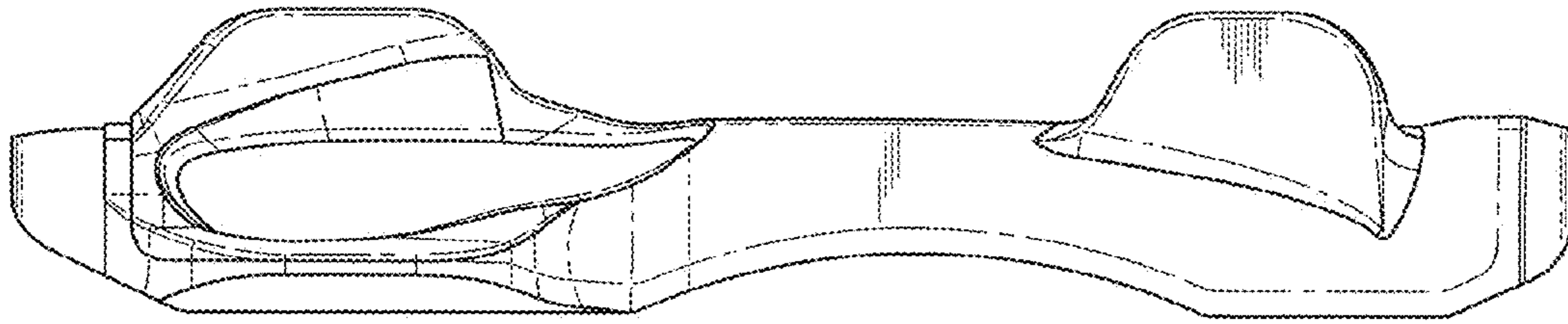

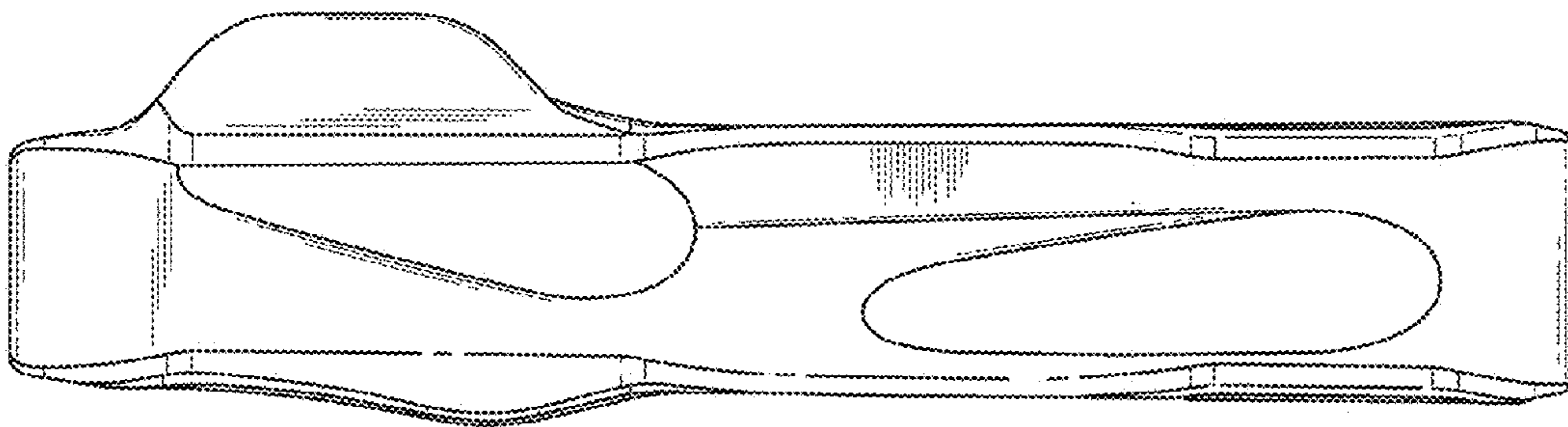

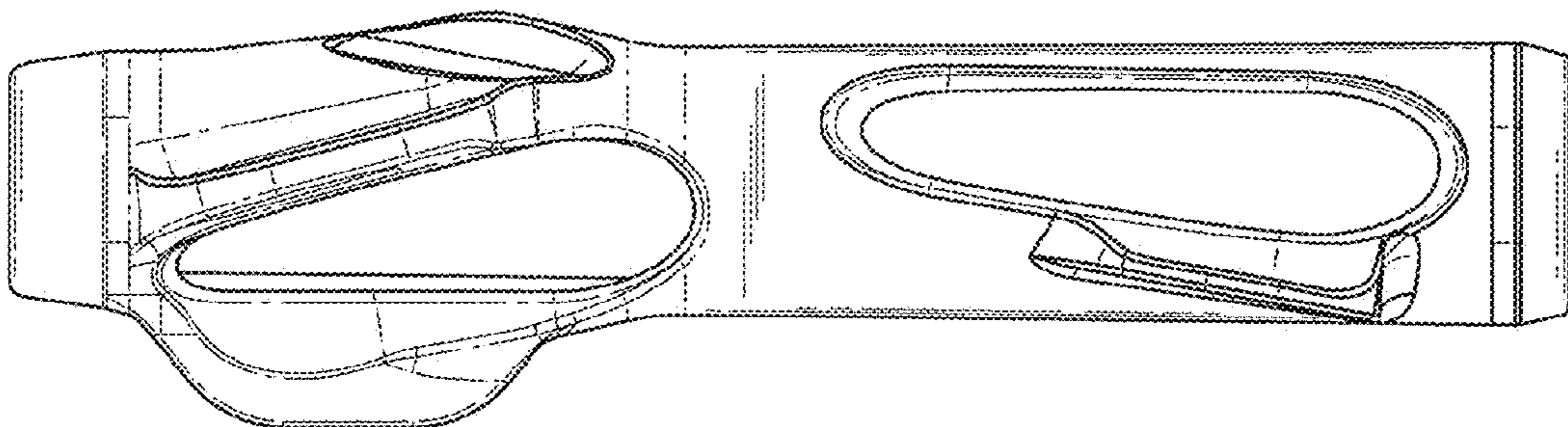

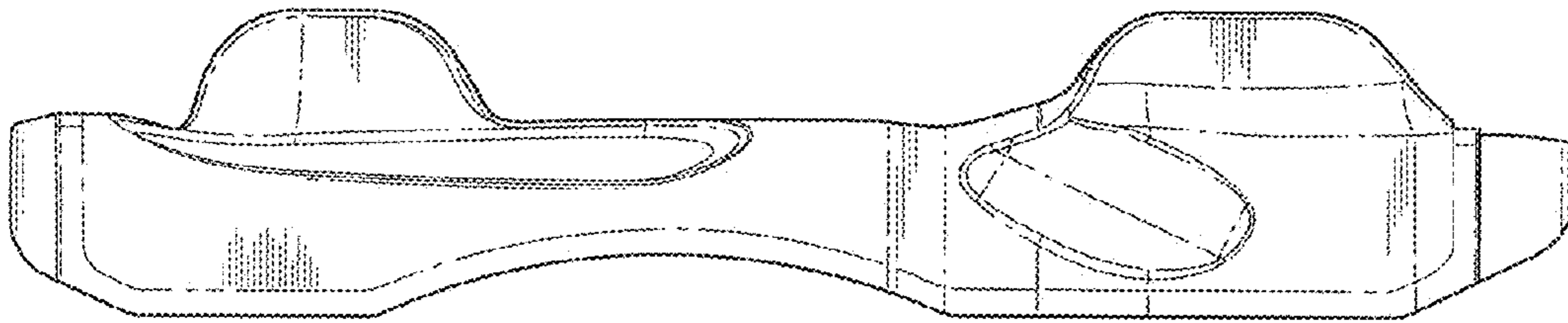

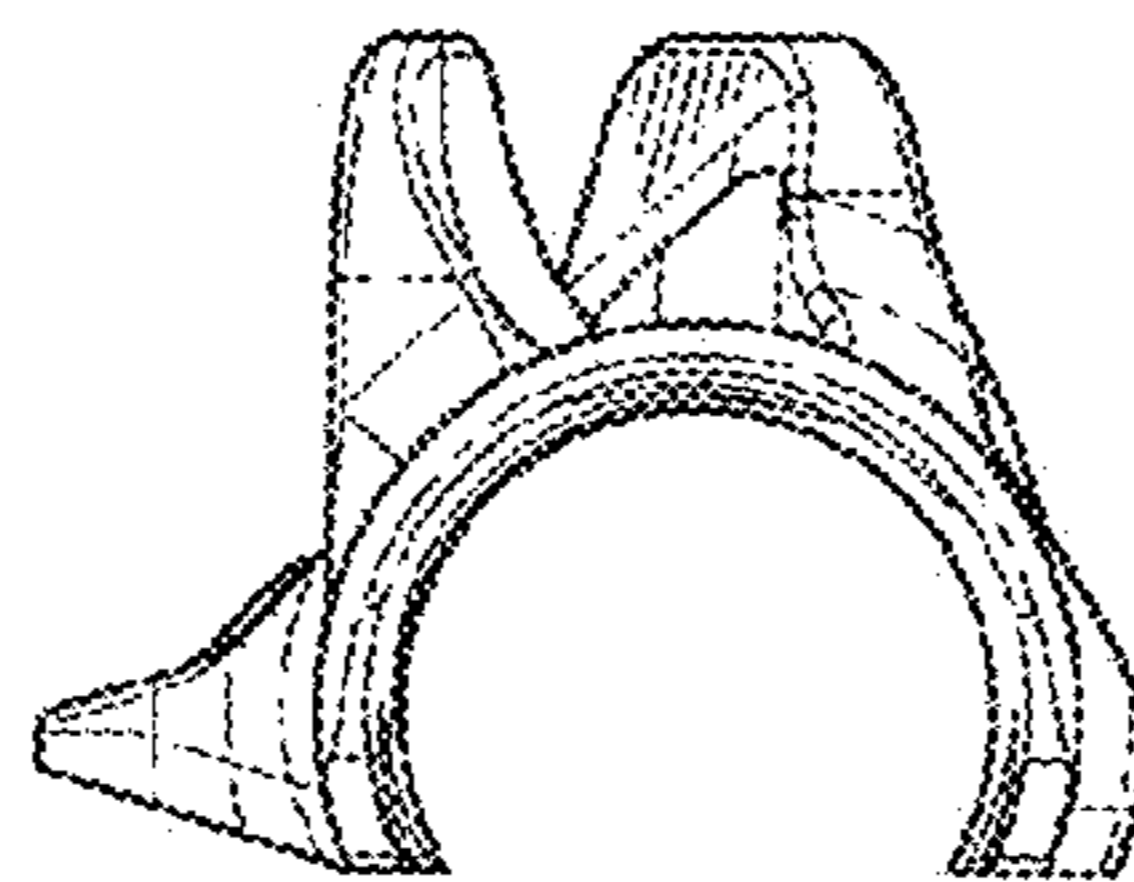

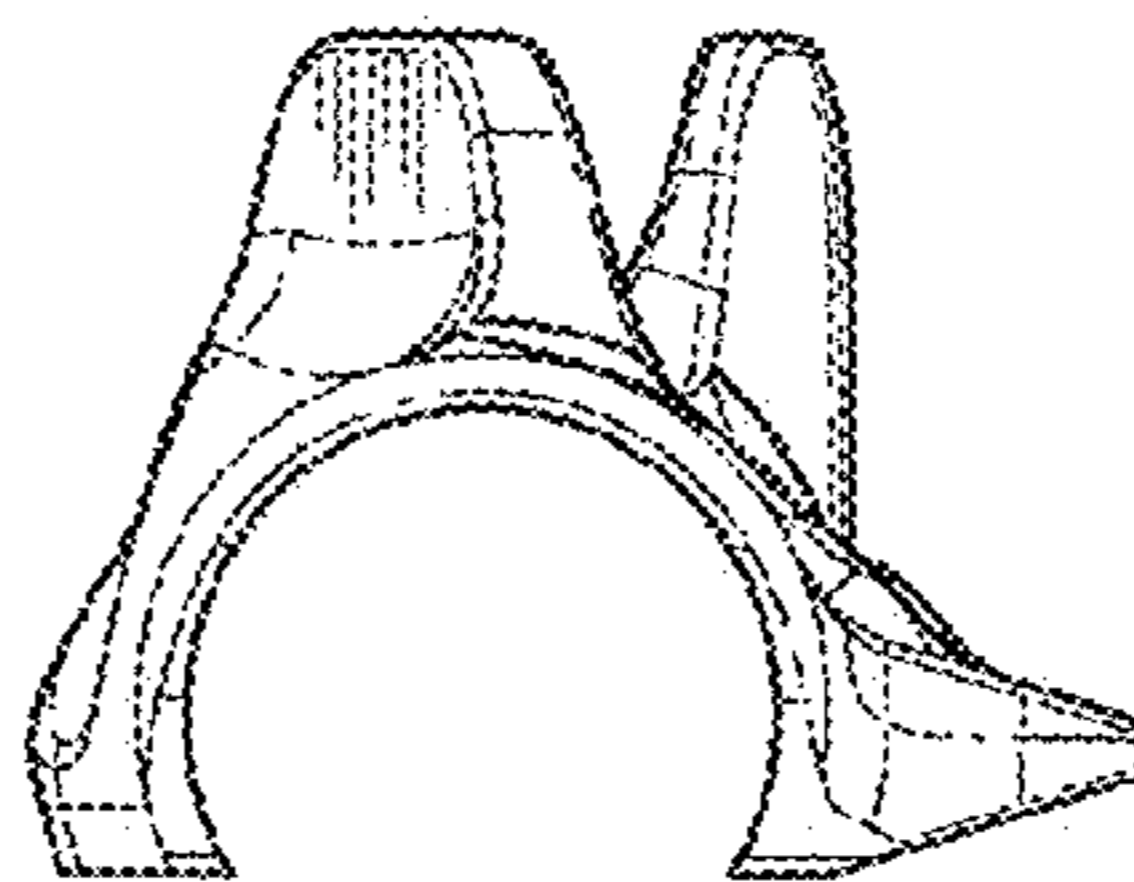
