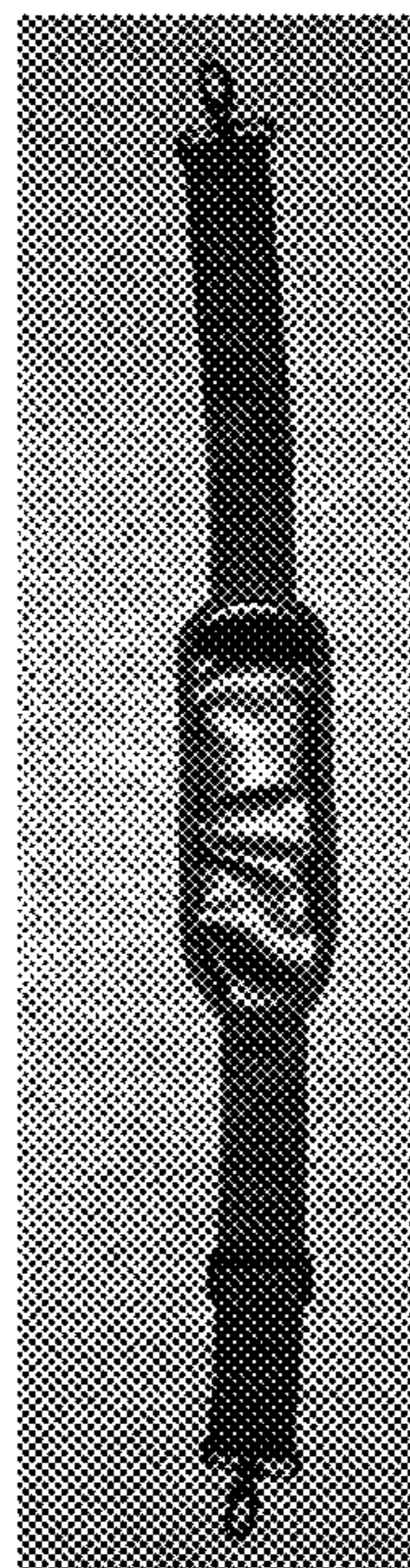
(57) **CLAIM**
The ornamental design for a small game sling, as shown and
described.

DESCRIPTION

FIG. 1 is a front elevation view of the small game sling
showing the new design;
FIG. 2 is a rear view thereof;
FIG. 3 is a side perspective view thereof;
FIG. 4 is a side elevation view, with the opposite side eleva-
tion view being a mirror image thereof; and,
FIG. 5 is an enlarged side view showing the buckle and clip on
one of the extended ends.
The small game sling comprises a strap that extends through
a sleeve of a pad portion, clips configured on either extended
end of the strap and a buckle configured to change the length
of the strap.

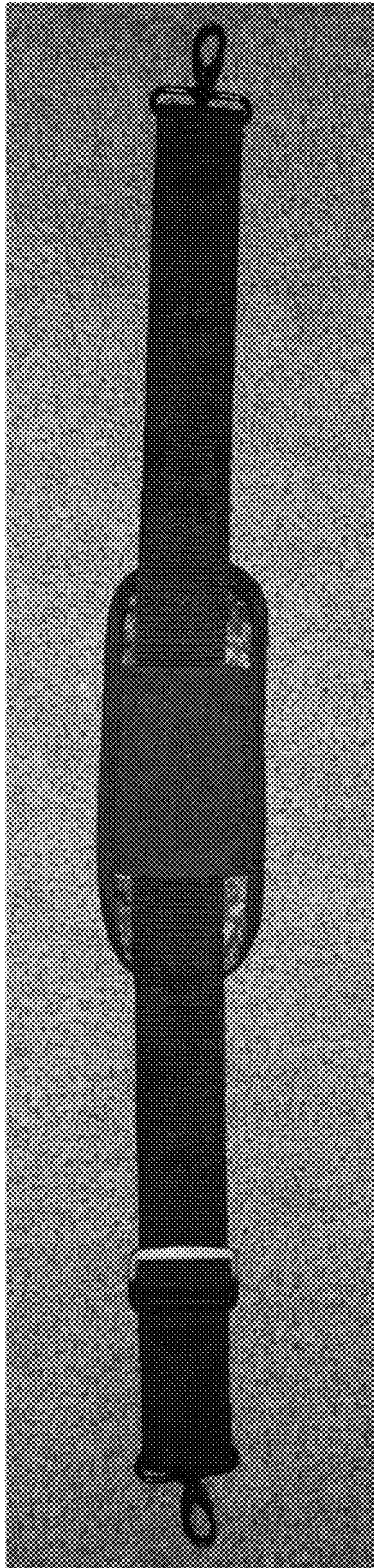

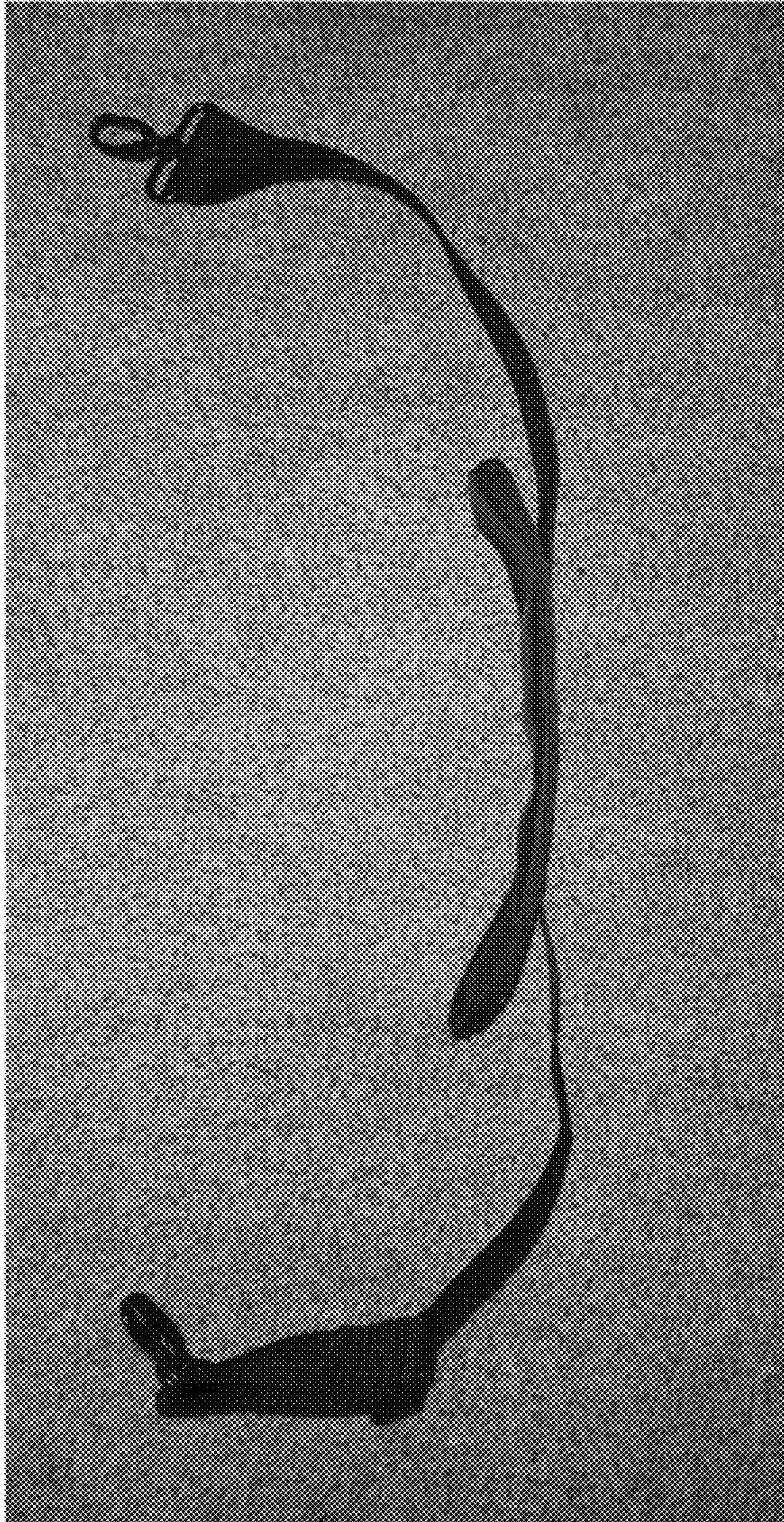
