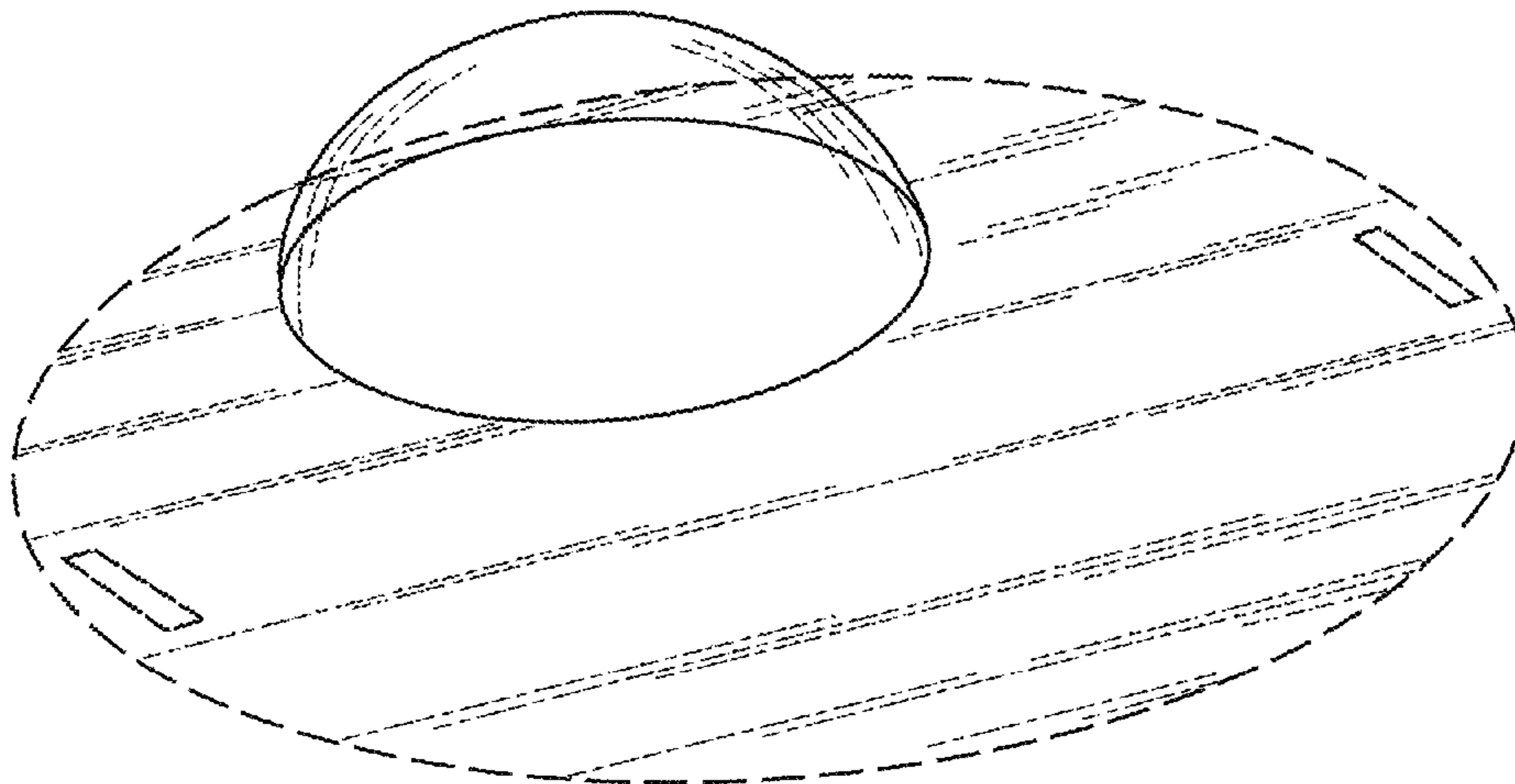
(57) **CLAIM**

The ornamental design for a sink grooming cover, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a sink grooming cover showing my design;
 FIG. 2 is a top or bottom view thereof;
 FIG. 3 is a front or back side view thereof;
 FIG. 4 is a left or right side view thereof;
 FIG. 5 is a top view thereof with the dome shaped section shown applied over the raised faucet parts and the remainder of the cover applied over the sink basin;
 FIG. 6 is a perspective view thereof with the dome shaped section shown collapsed;
 FIG. 7 is a top or bottom view thereof FIG. 6;
 FIG. 8 is a front or back side view thereof FIG. 6;
 FIG. 9 is a left or right side view thereof FIG. 6;
 FIG. 10 is a perspective view of a sink basin area cover with a flat top raised section to accommodate raised faucet parts showing my design;
 FIG. 11 is a top or bottom view thereof;
 FIG. 12 is a front or back side view thereof;
 FIG. 13 is a left or right side view thereof;
 FIG. 14 is a top view thereof with the flat top raised section shown applied over the raised faucet parts and the remainder of the cover applied over the sink basin;
 FIG. 15 is a perspective view thereof with the flat top raised section shown collapsed;
 FIG. 16 is a top or bottom view thereof FIG. 15;
 FIG. 17 is a front or back side view thereof FIG. 15; and,
 FIG. 18 is a left or right side view thereof FIG. 15.

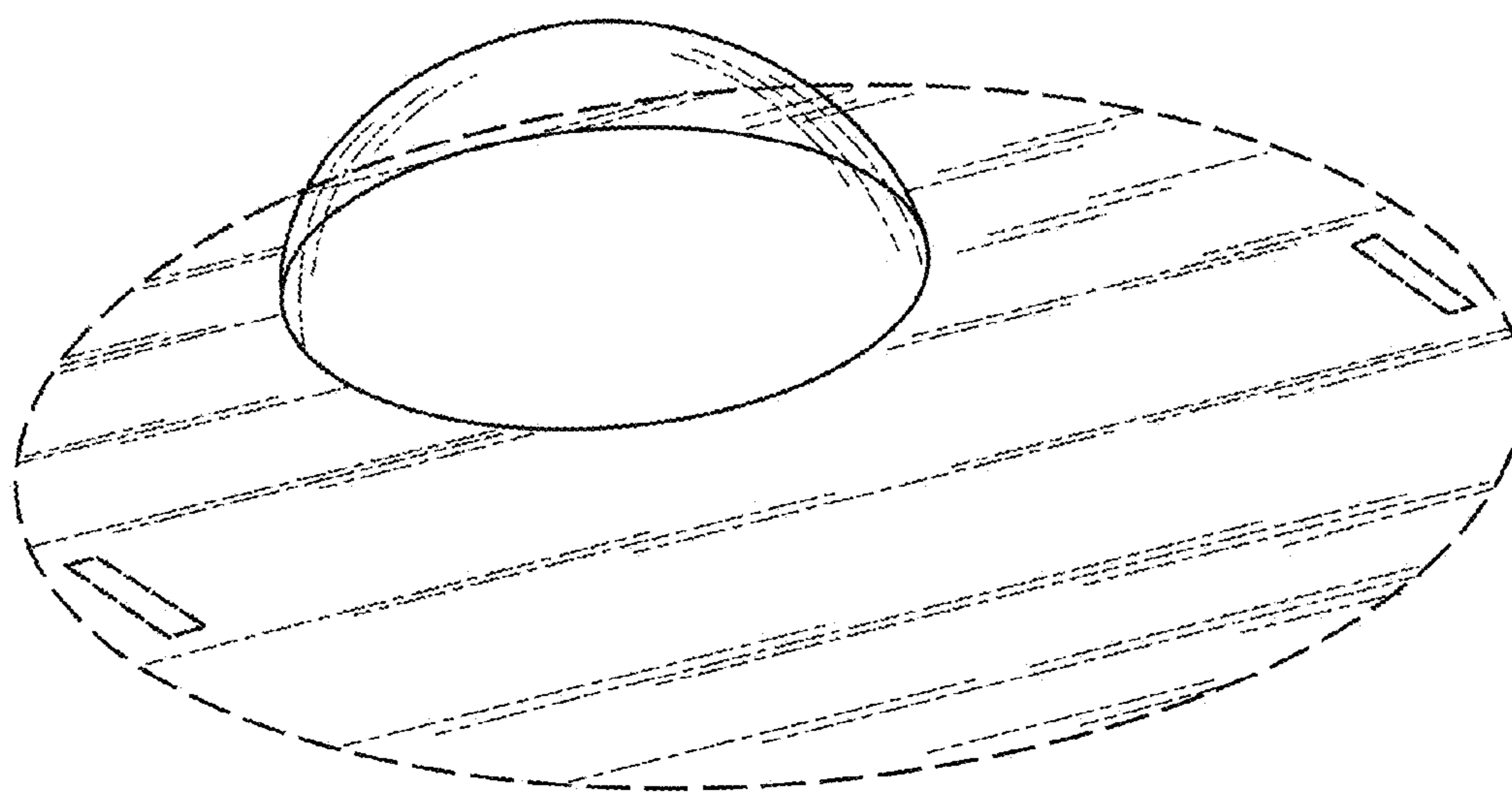

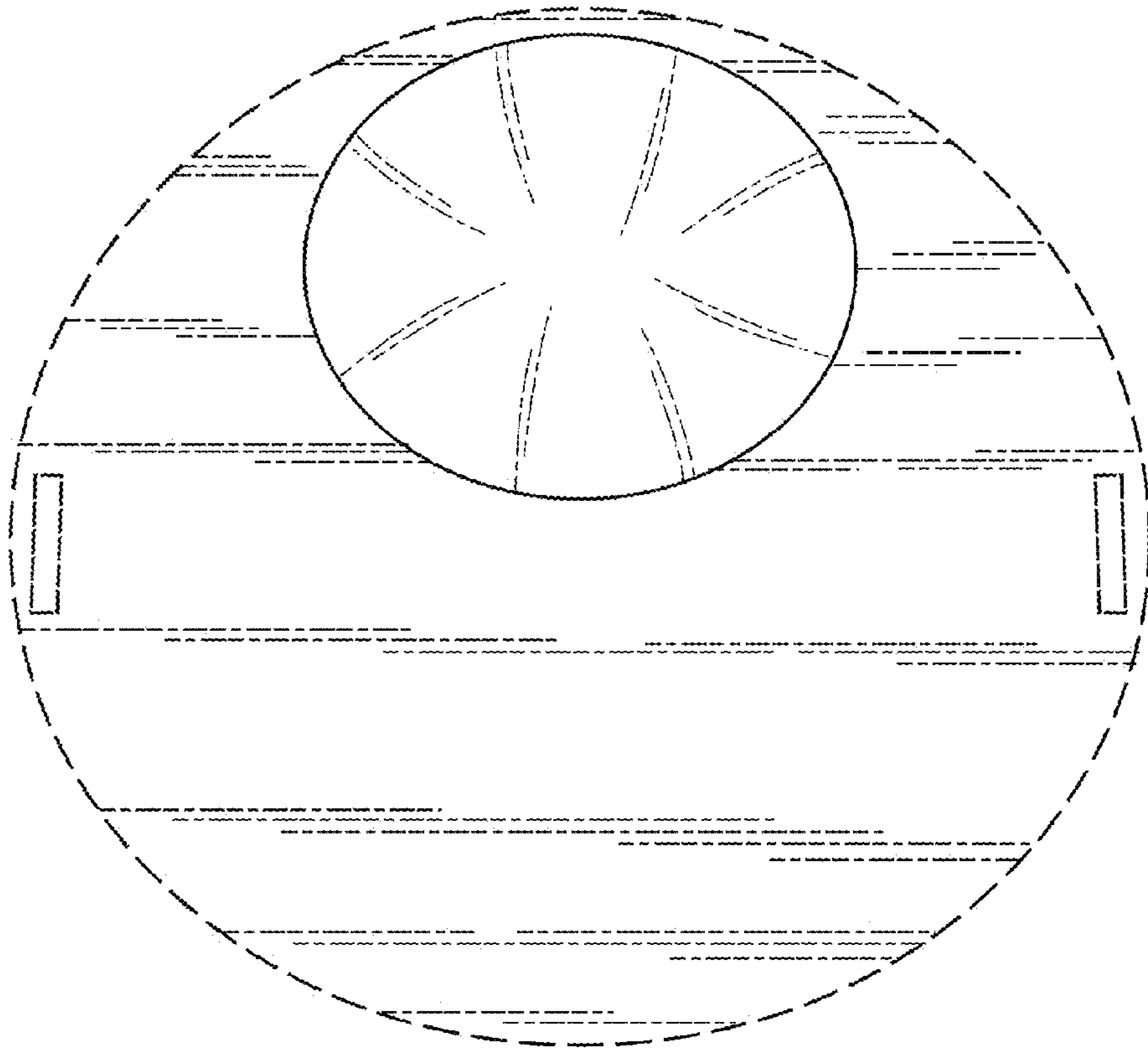

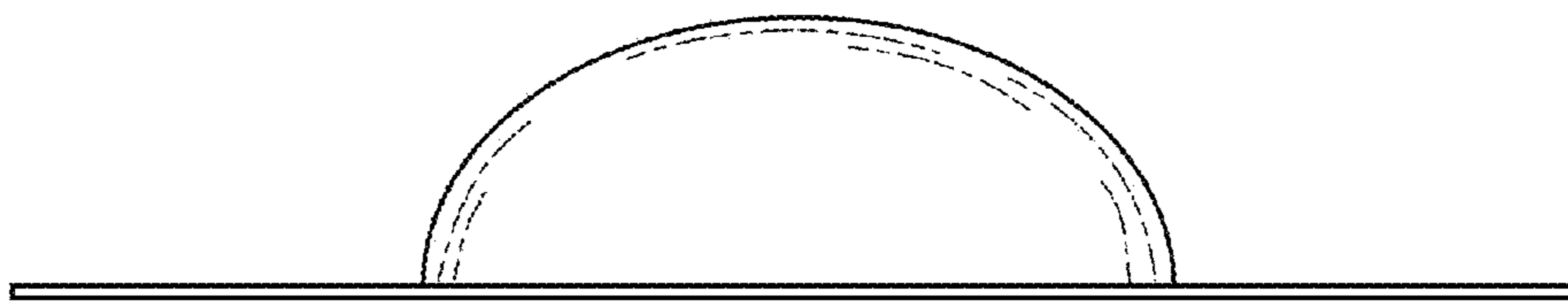

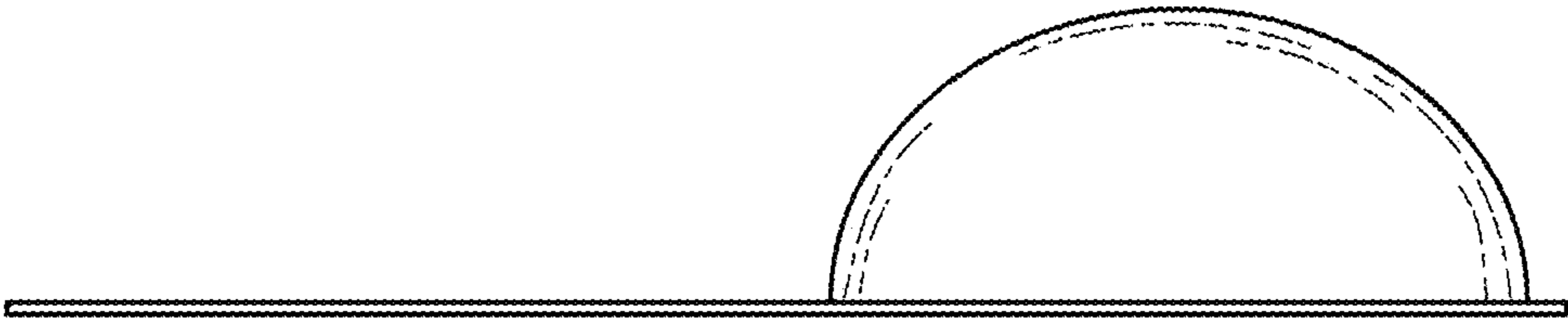

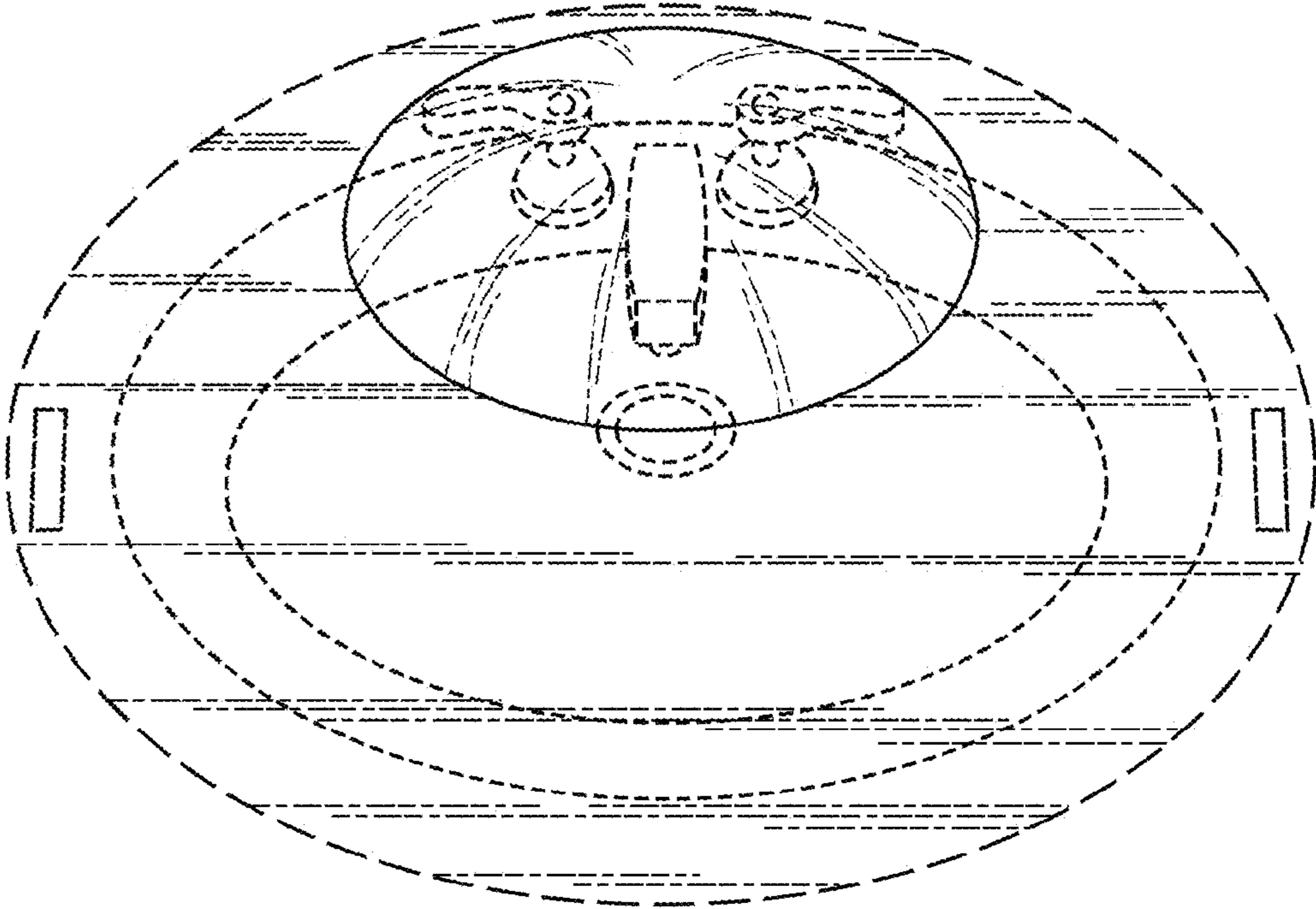

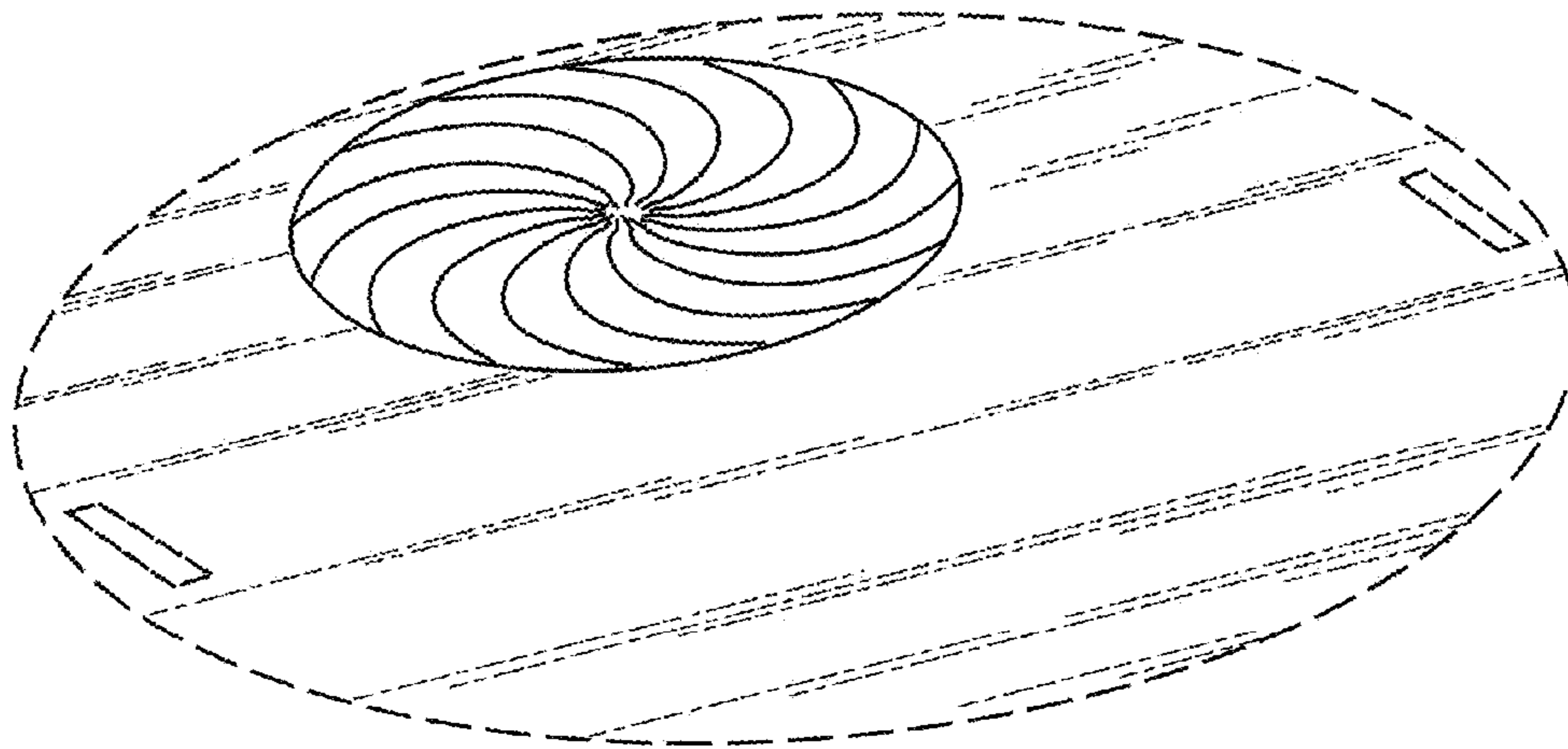

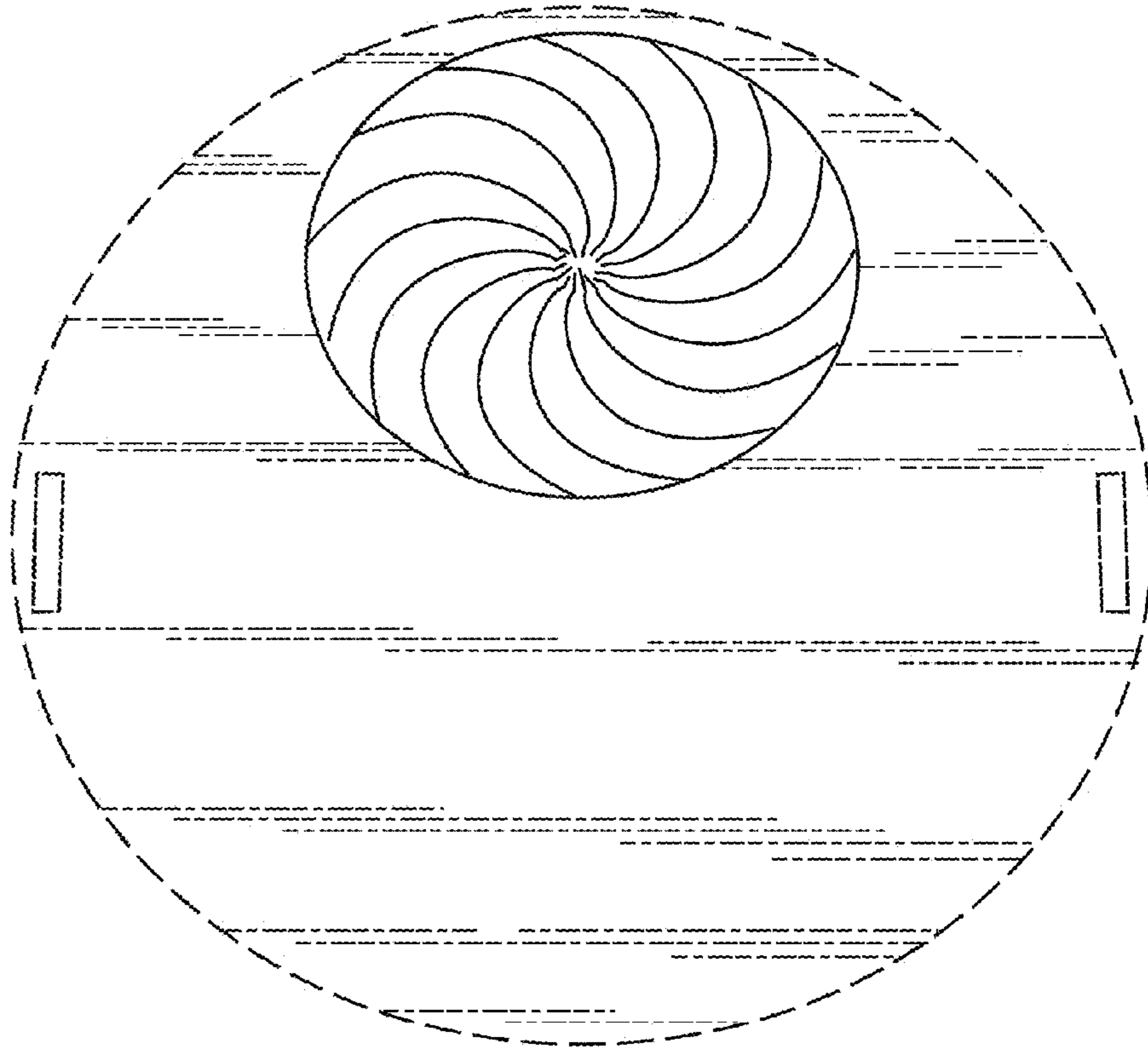

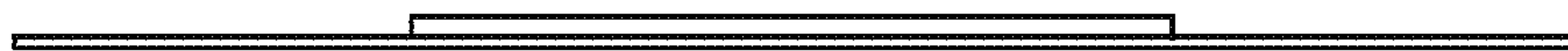

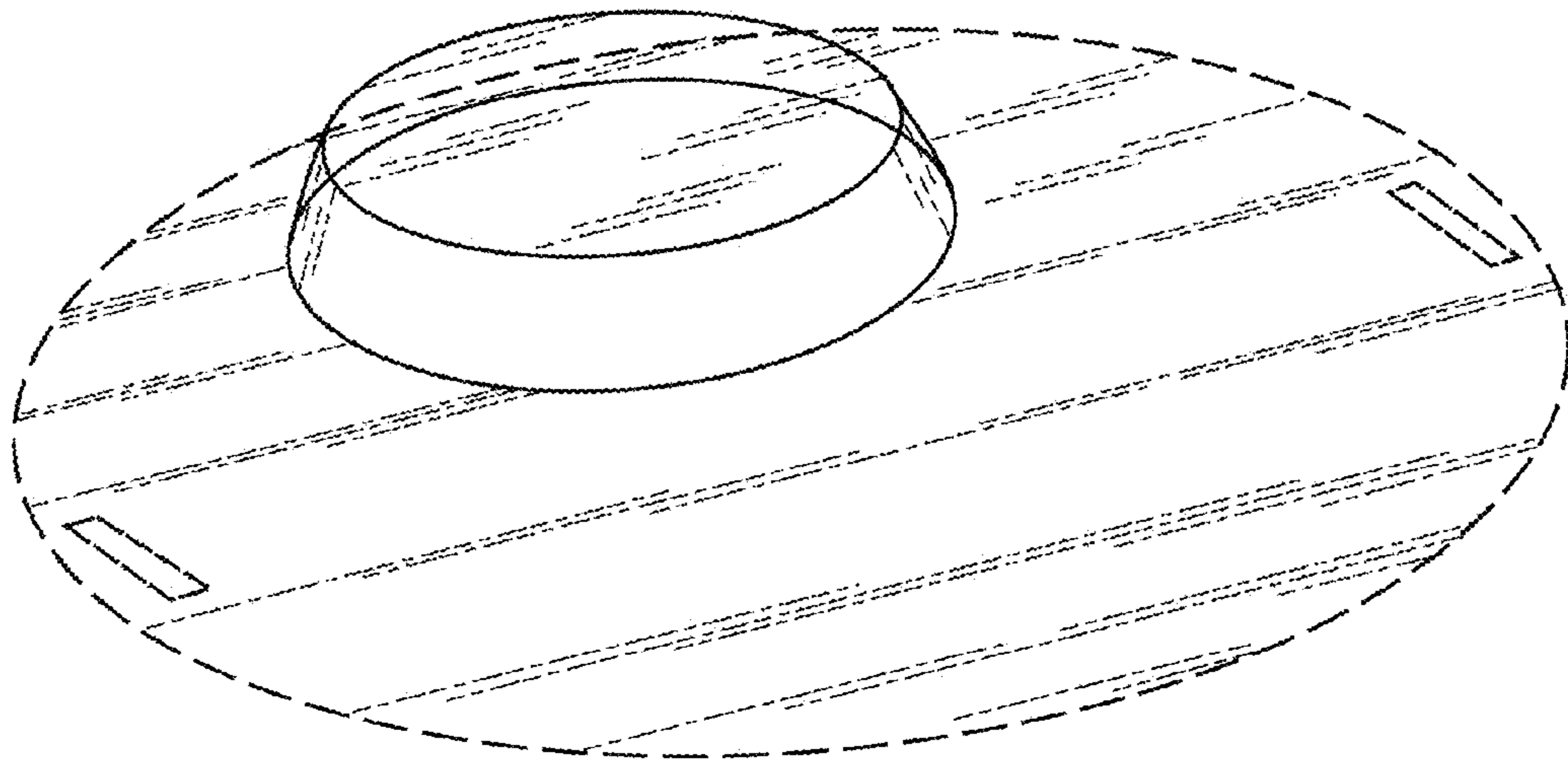

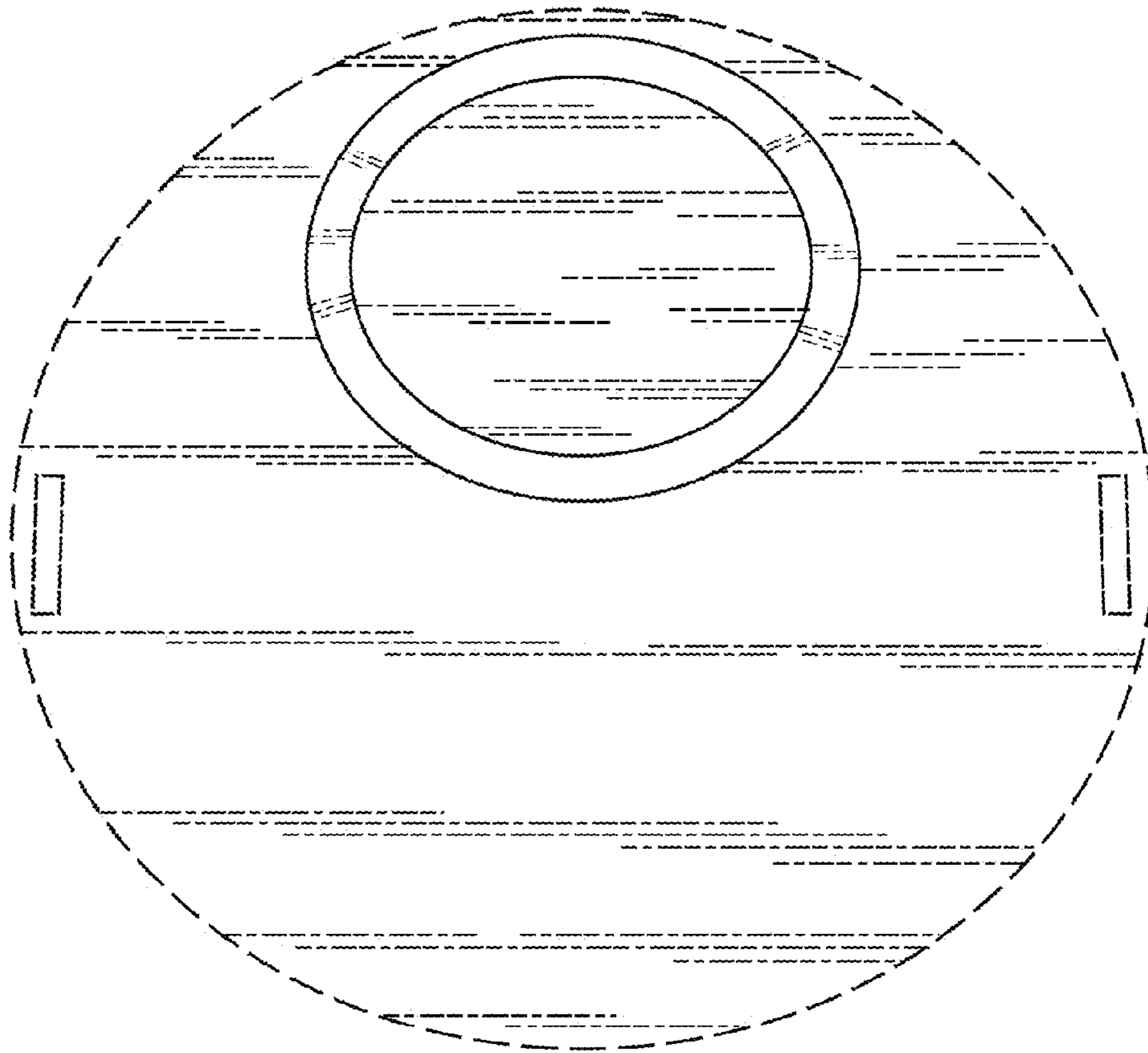

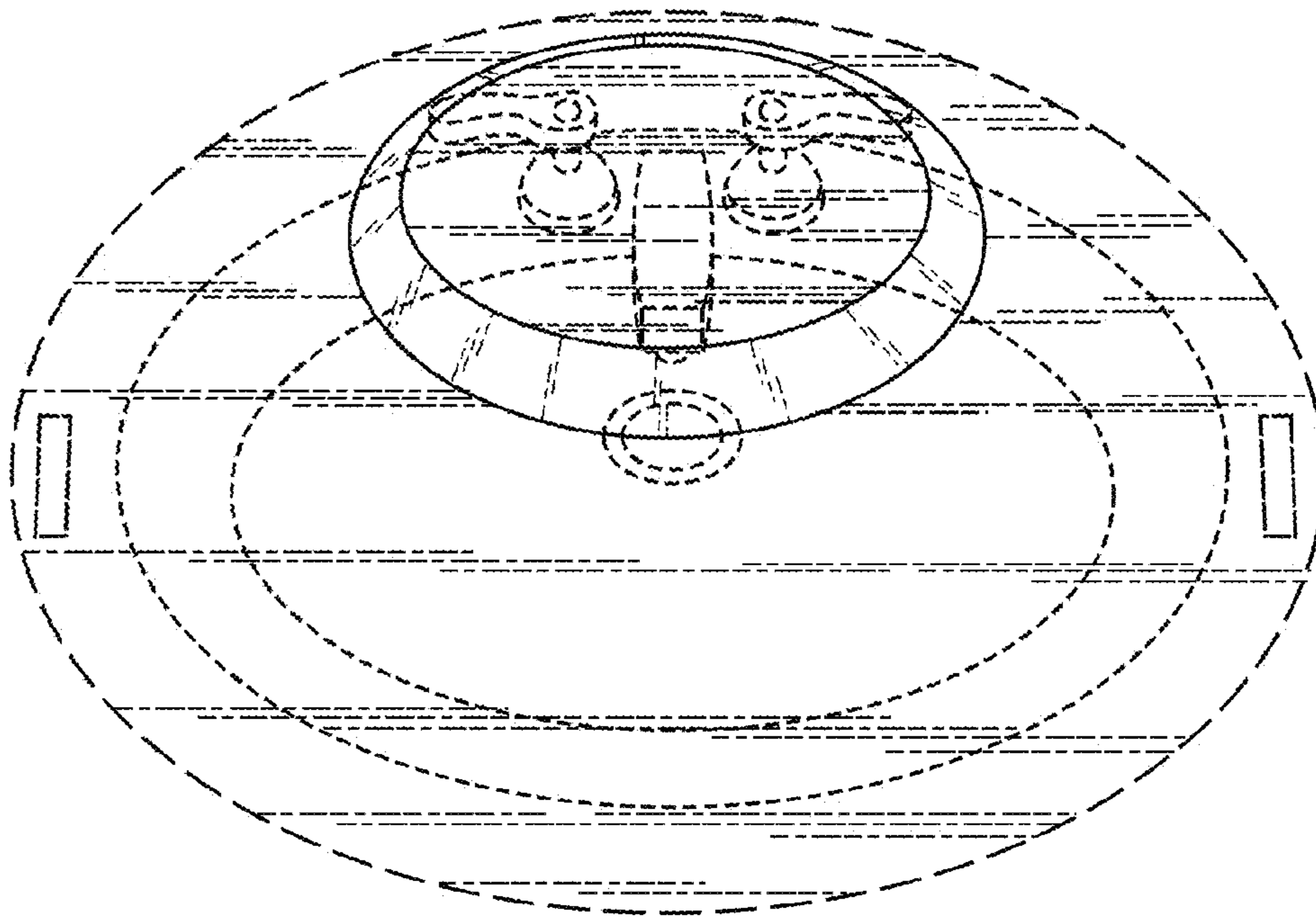

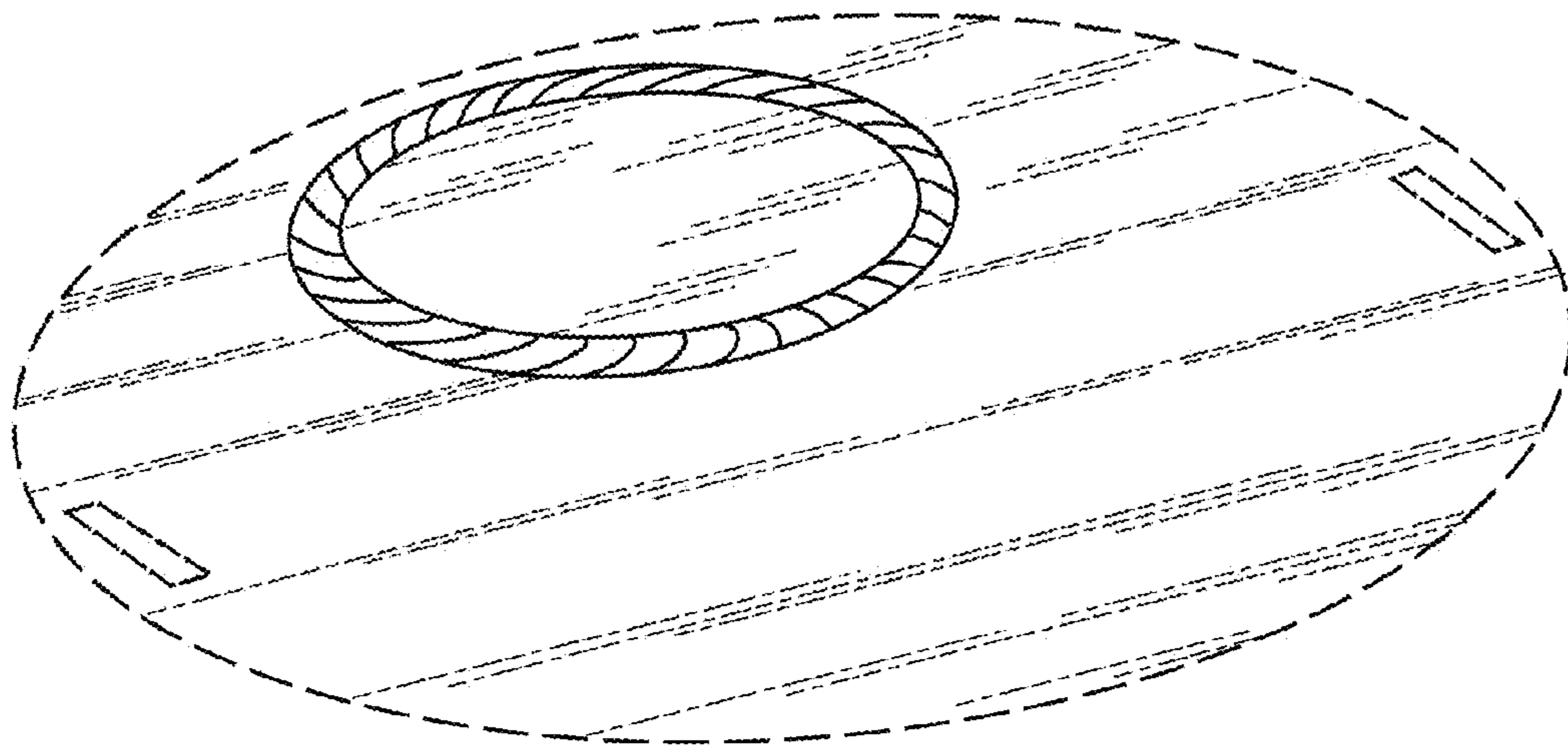

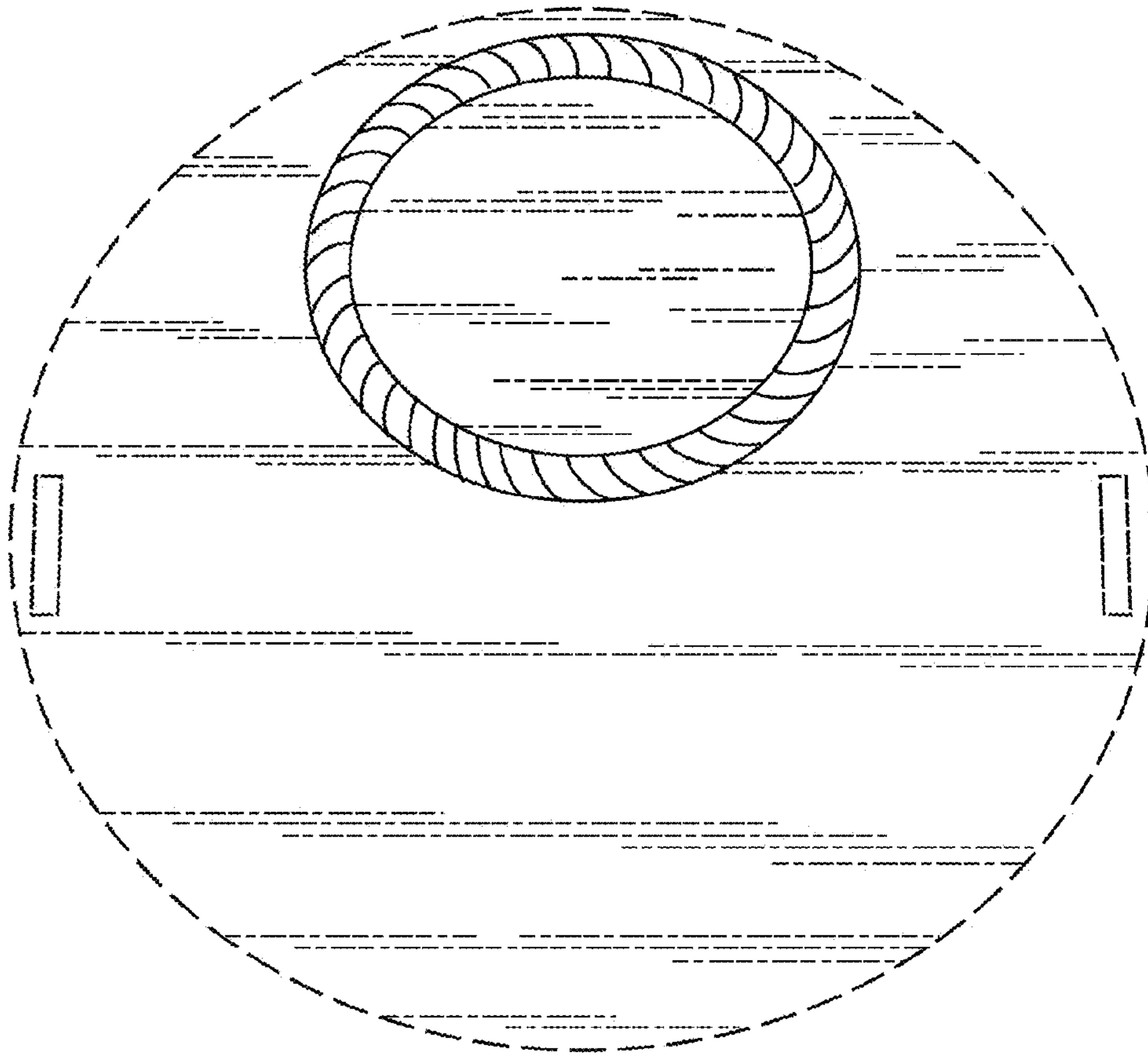

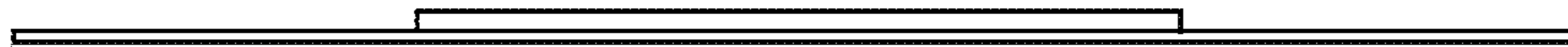
