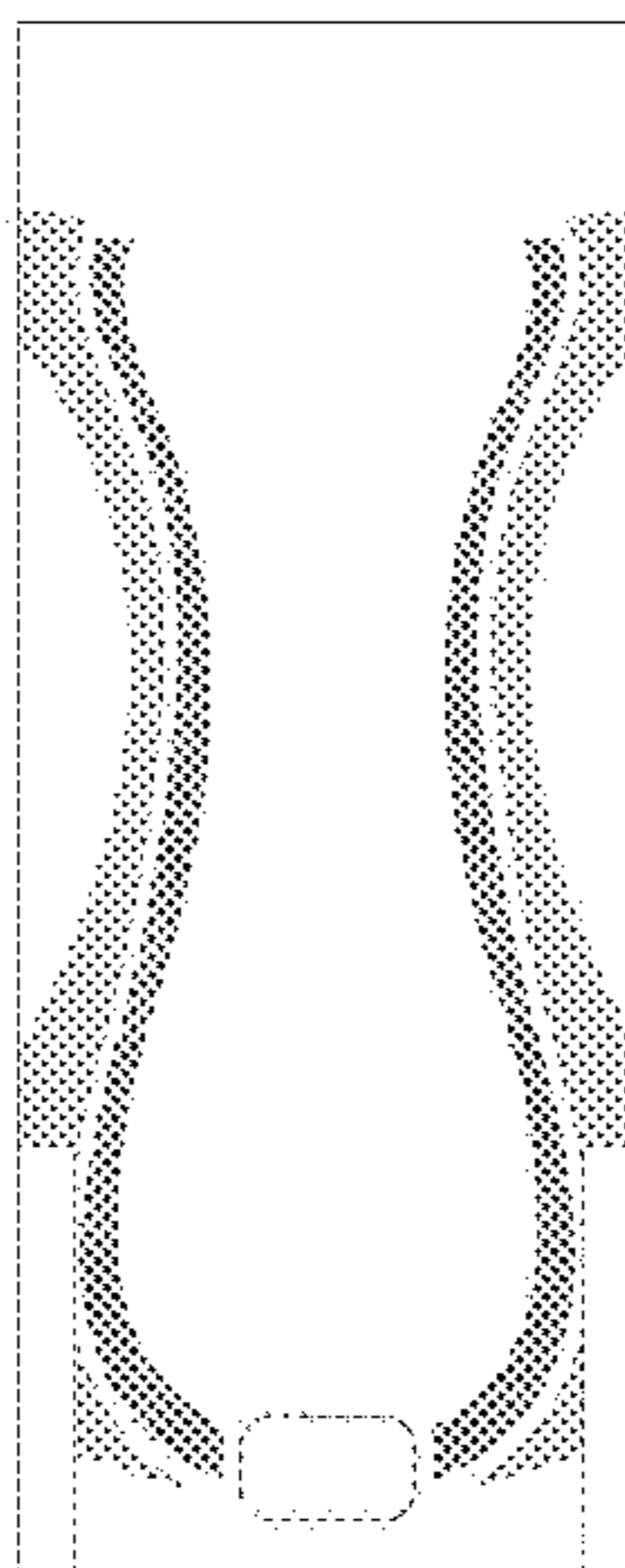
FIG. 1 is a development view of an absorbent article with a

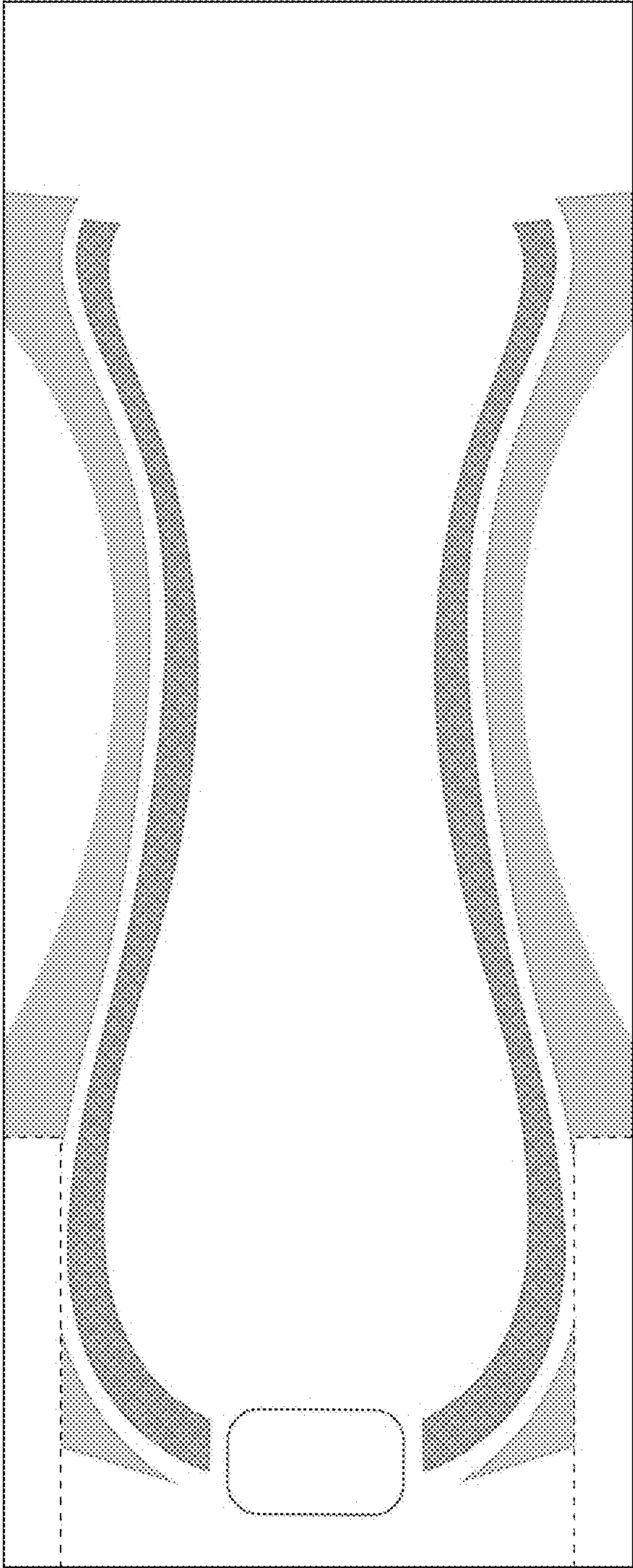

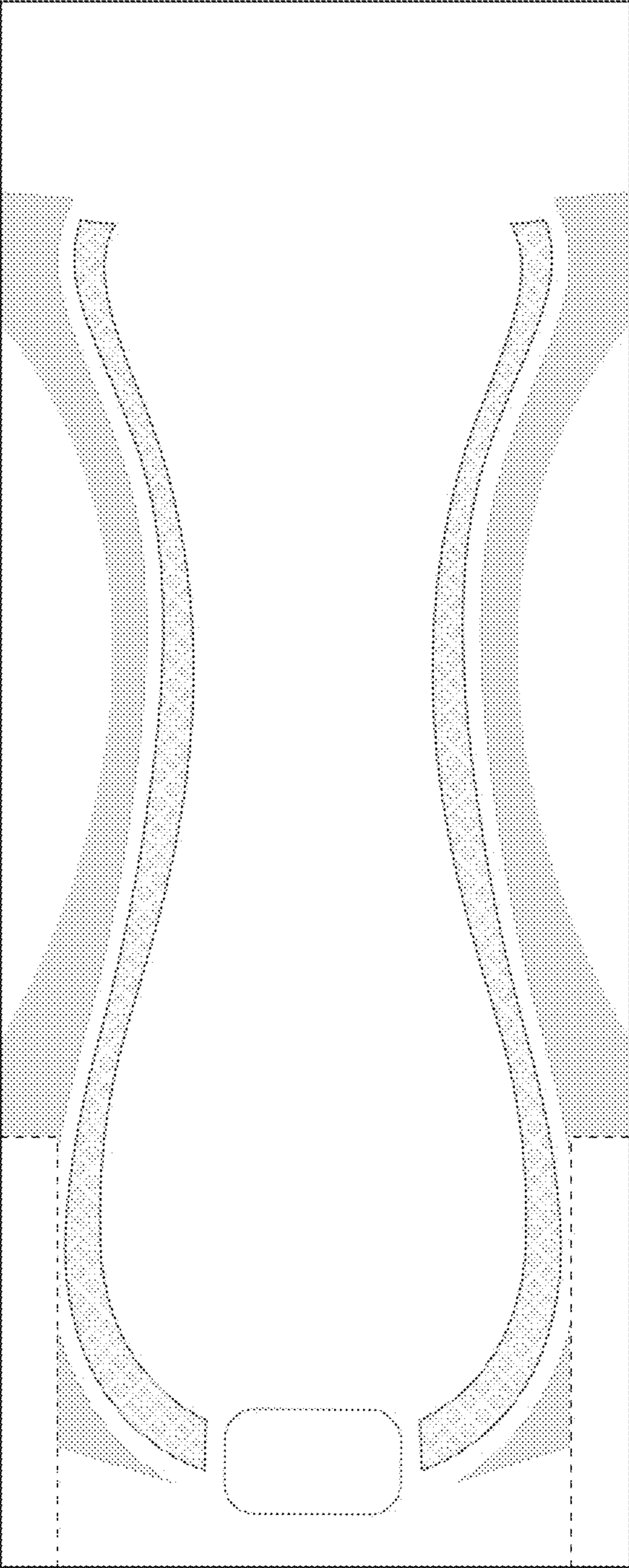
