(57) **CLAIM**

I claim the ornamental design for a medical tape for preventing blisters, as shown.

DESCRIPTION

FIG. 1 is a top view of a medical tape for preventing blisters according to the present invention;
FIG. 2 is a bottom view of the medical tape for preventing blisters FIG. 1; and,
FIG. 3 is a perspective view of the medical tape for preventing blisters of FIG. 1.
The broken line showing of the bottom portion of the medical tape illustrates the environment of the claimed design and forms no part thereof.

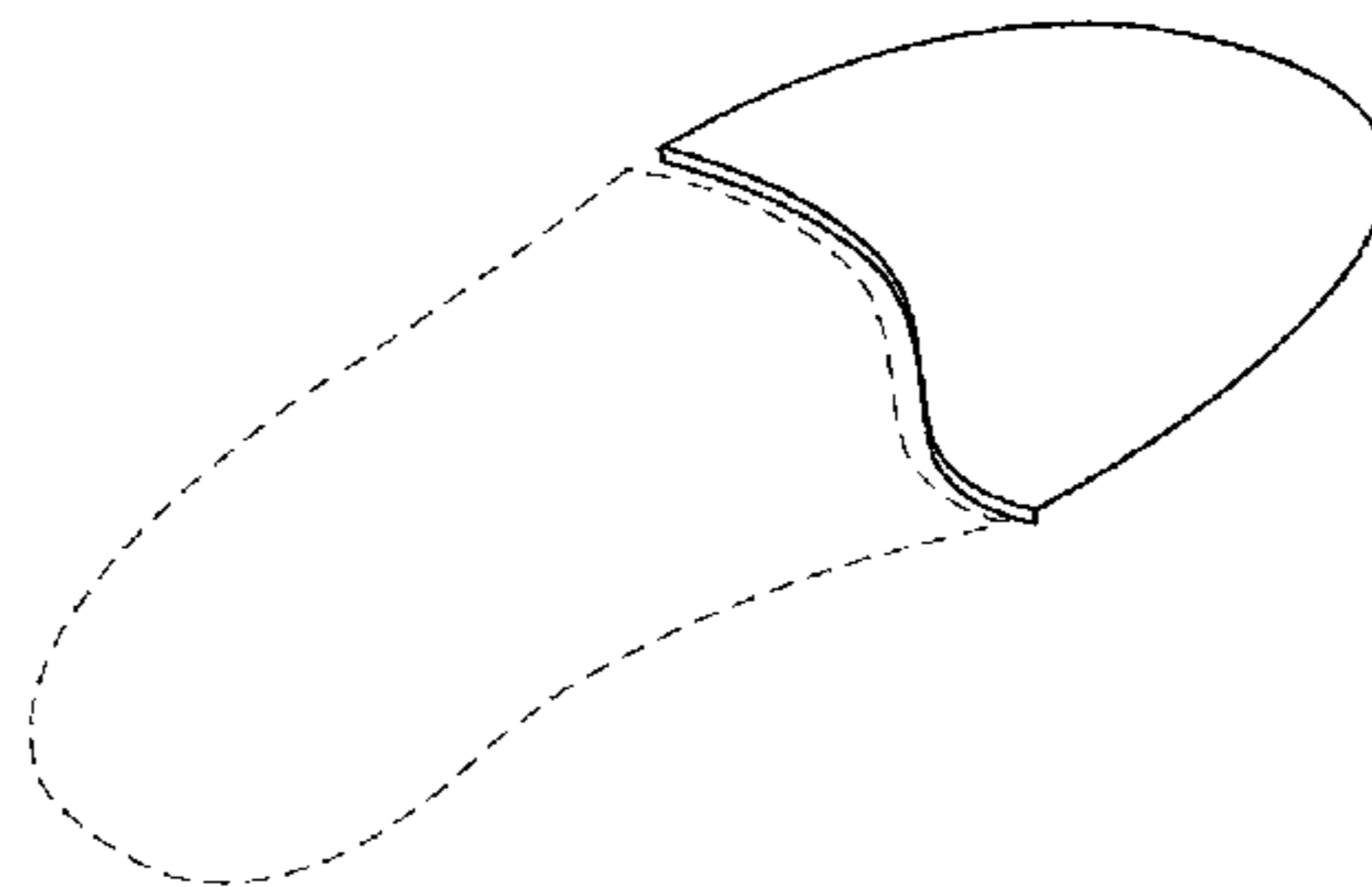
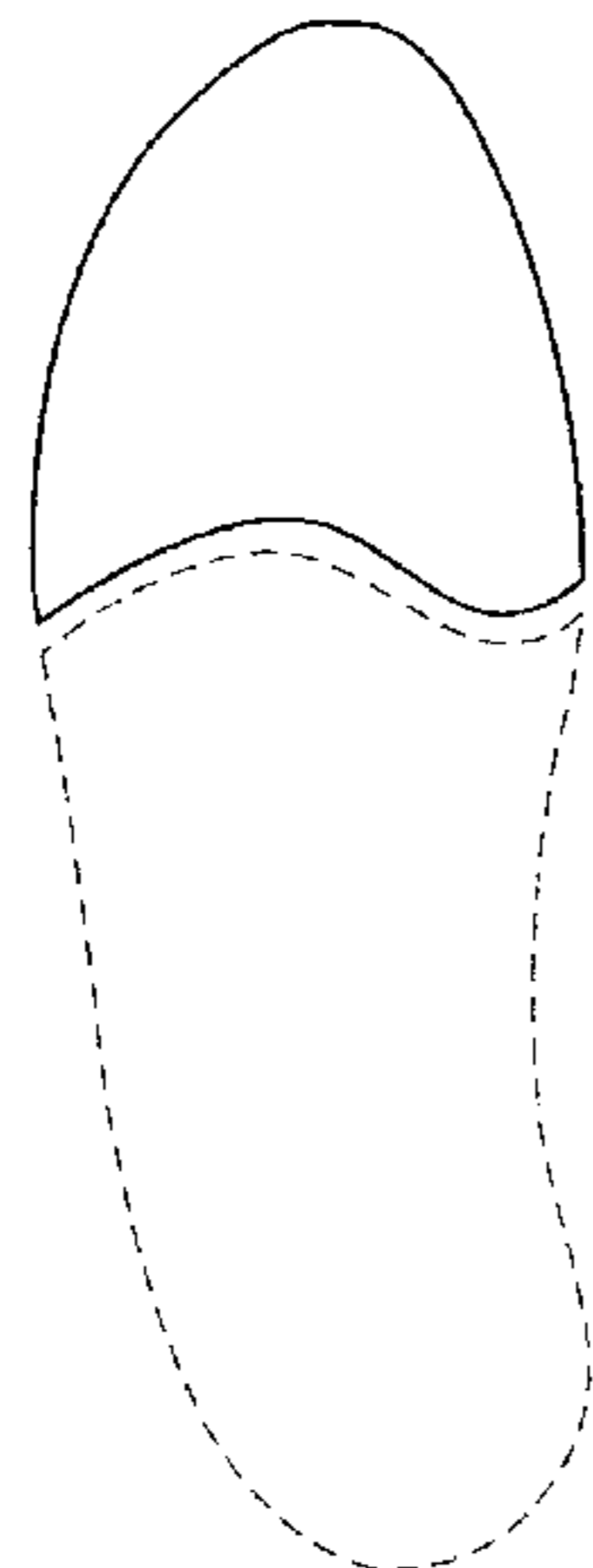

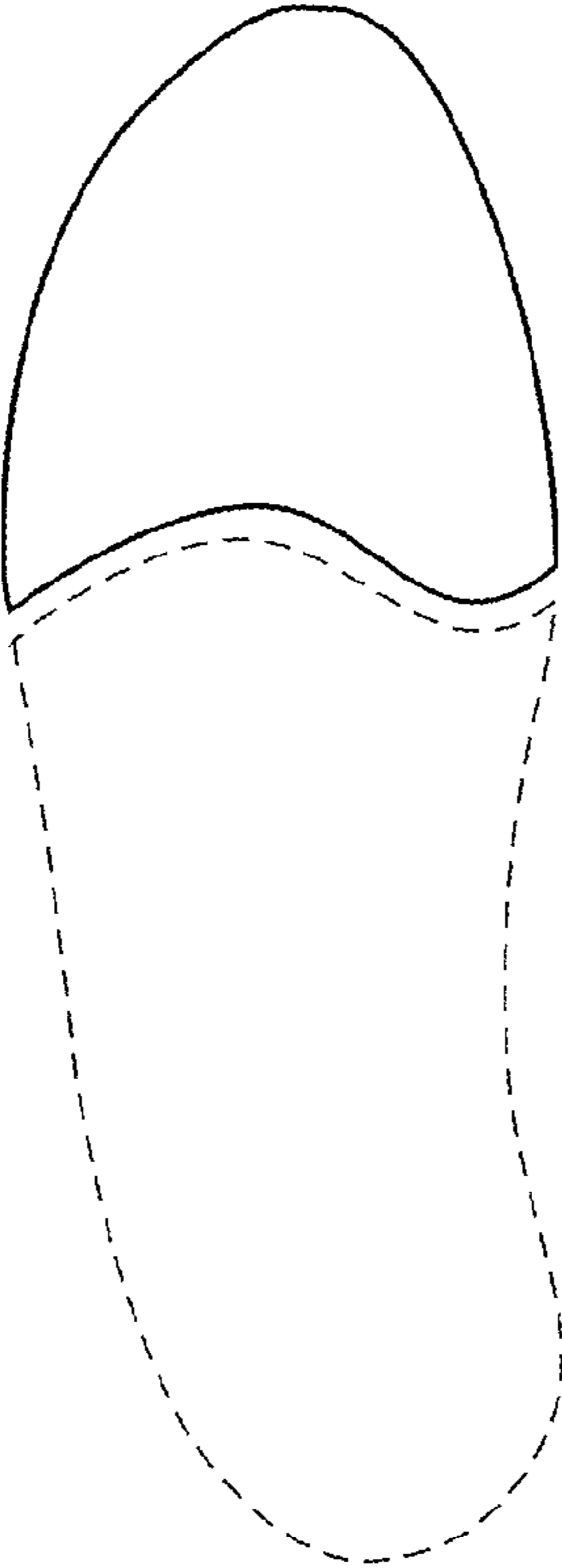

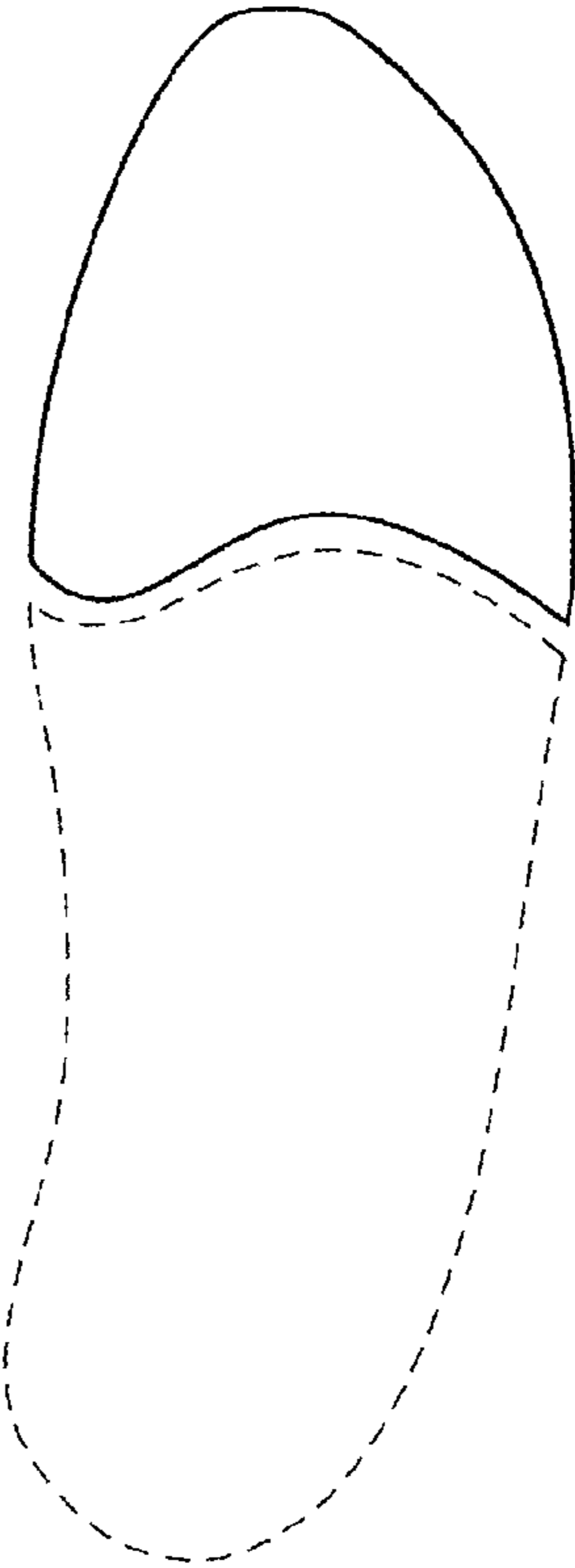
