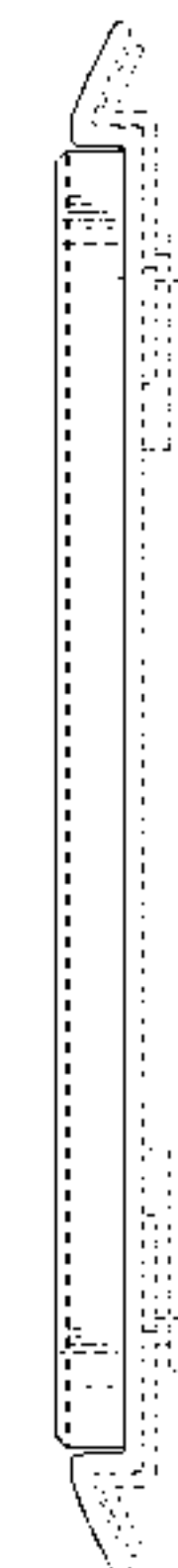
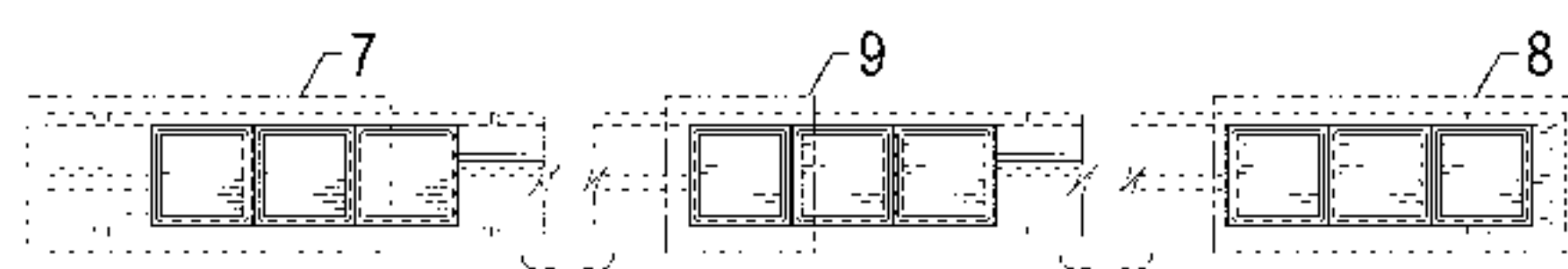
FIG. 1 is a front elevational view of the light bar for a motor vehicle, with the center portions broken away to indicate indeterminate length;

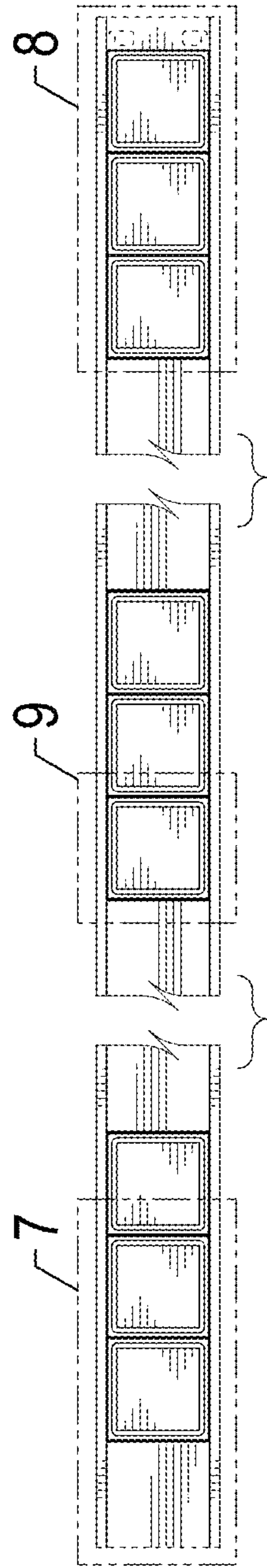

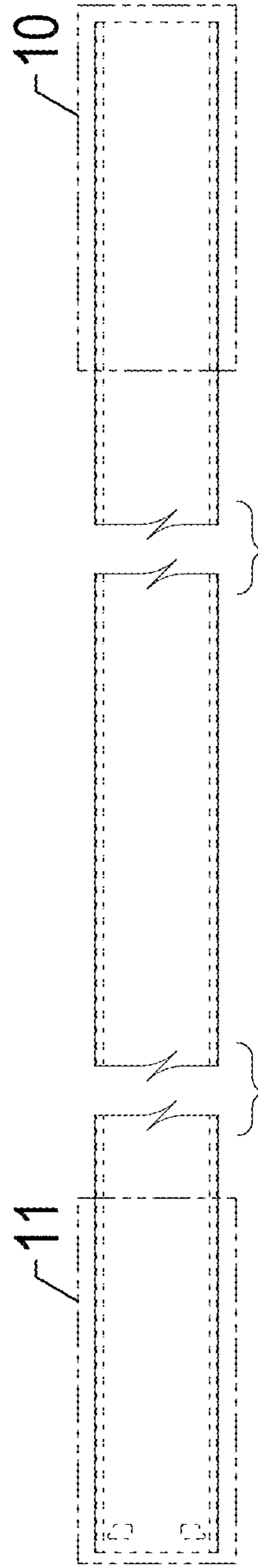

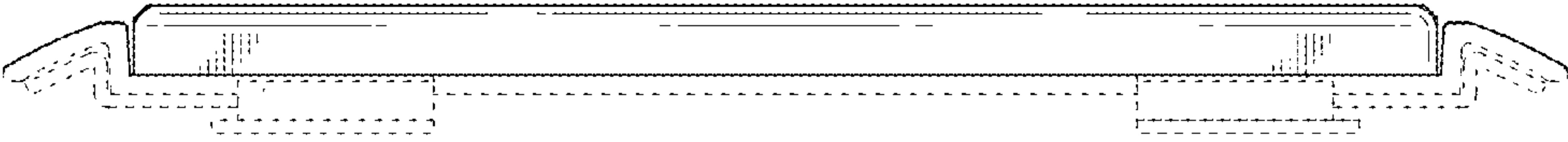
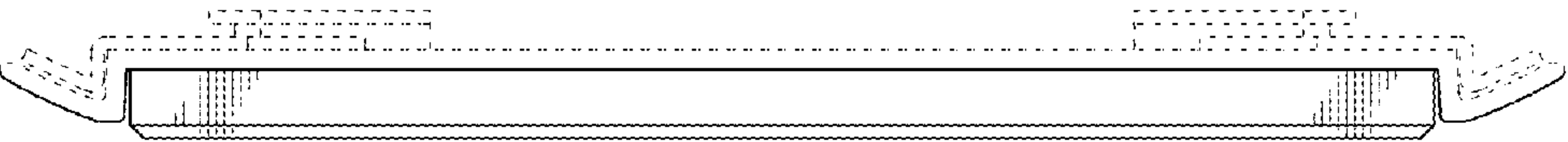

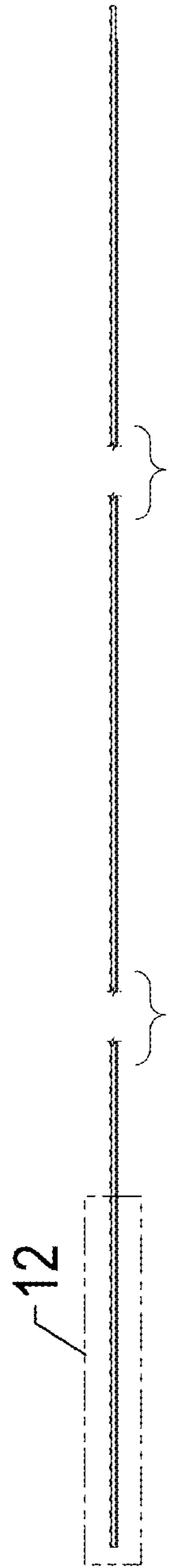

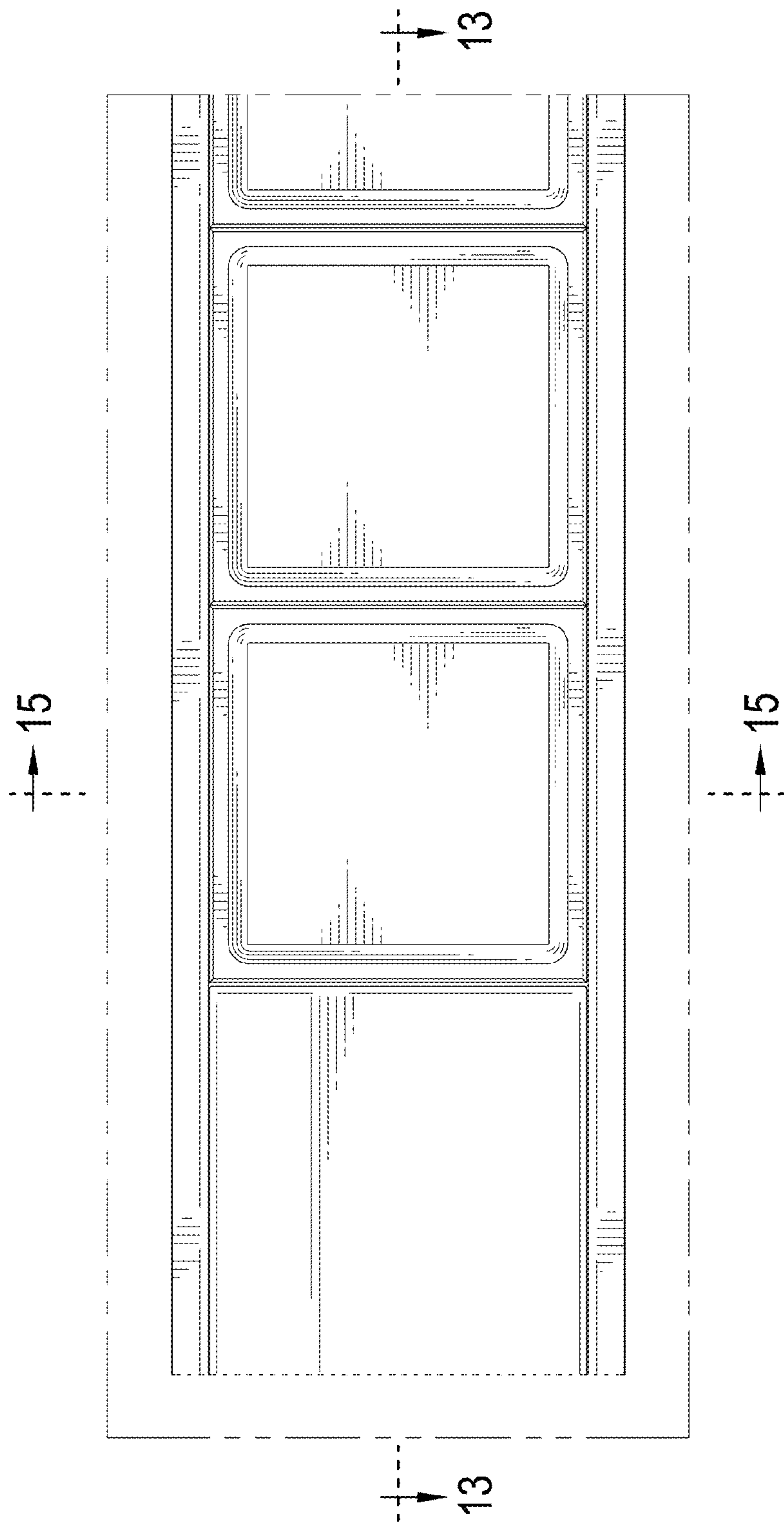

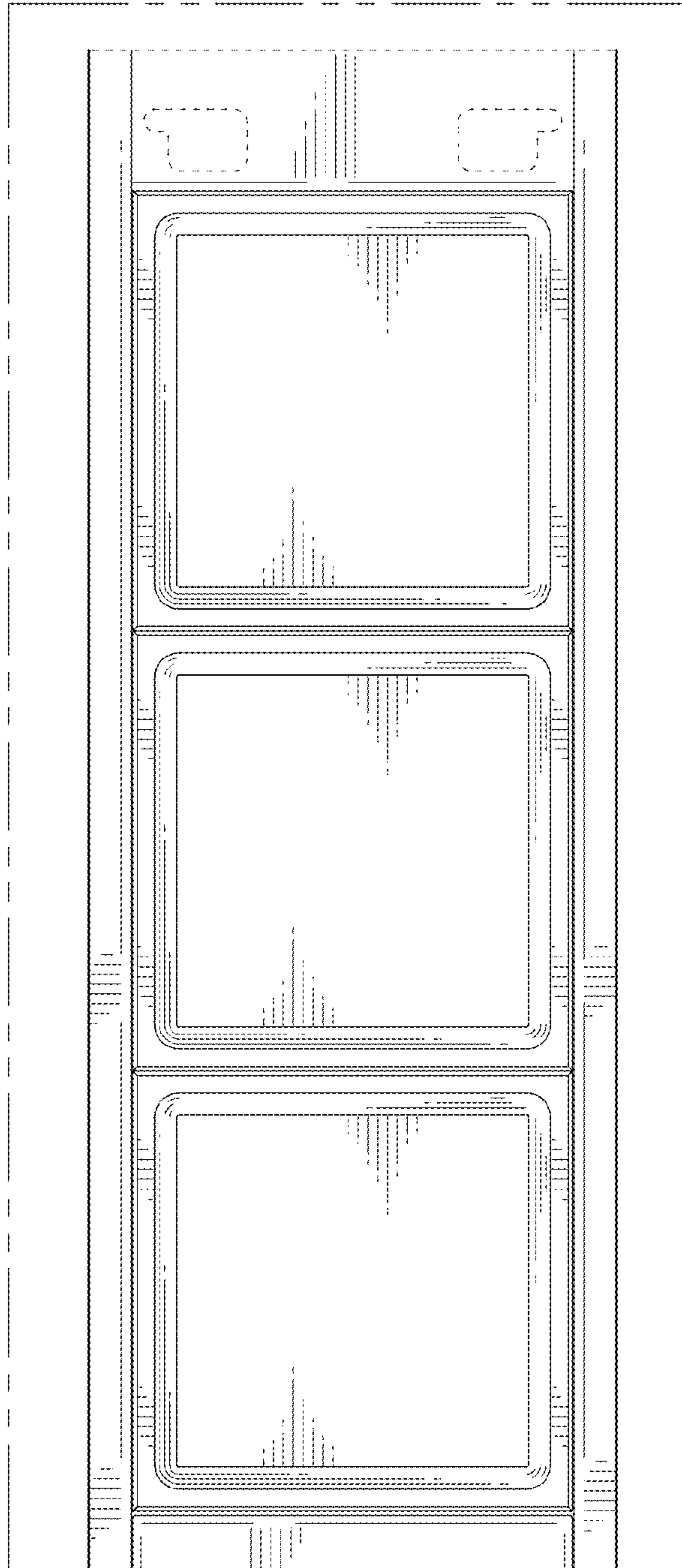

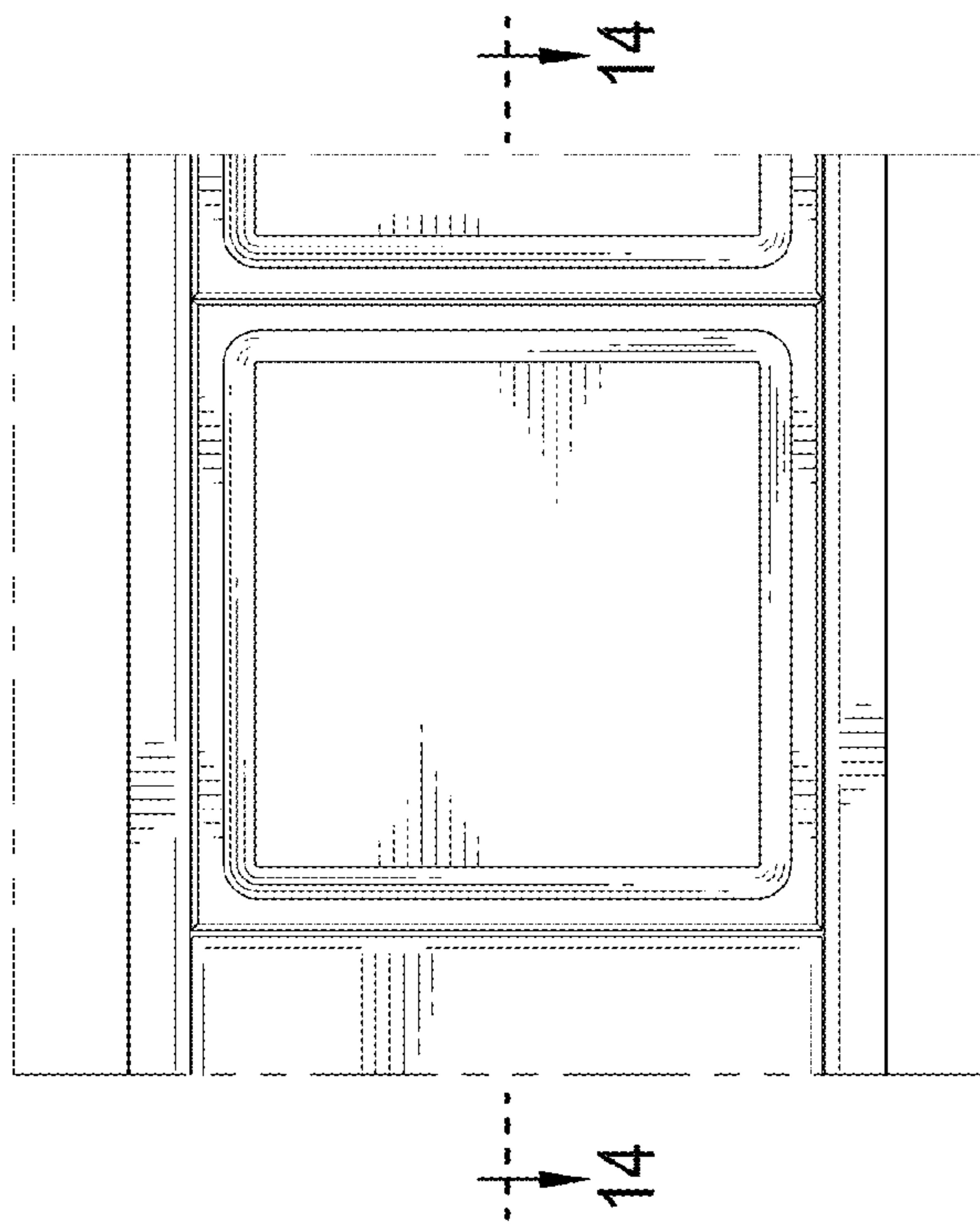

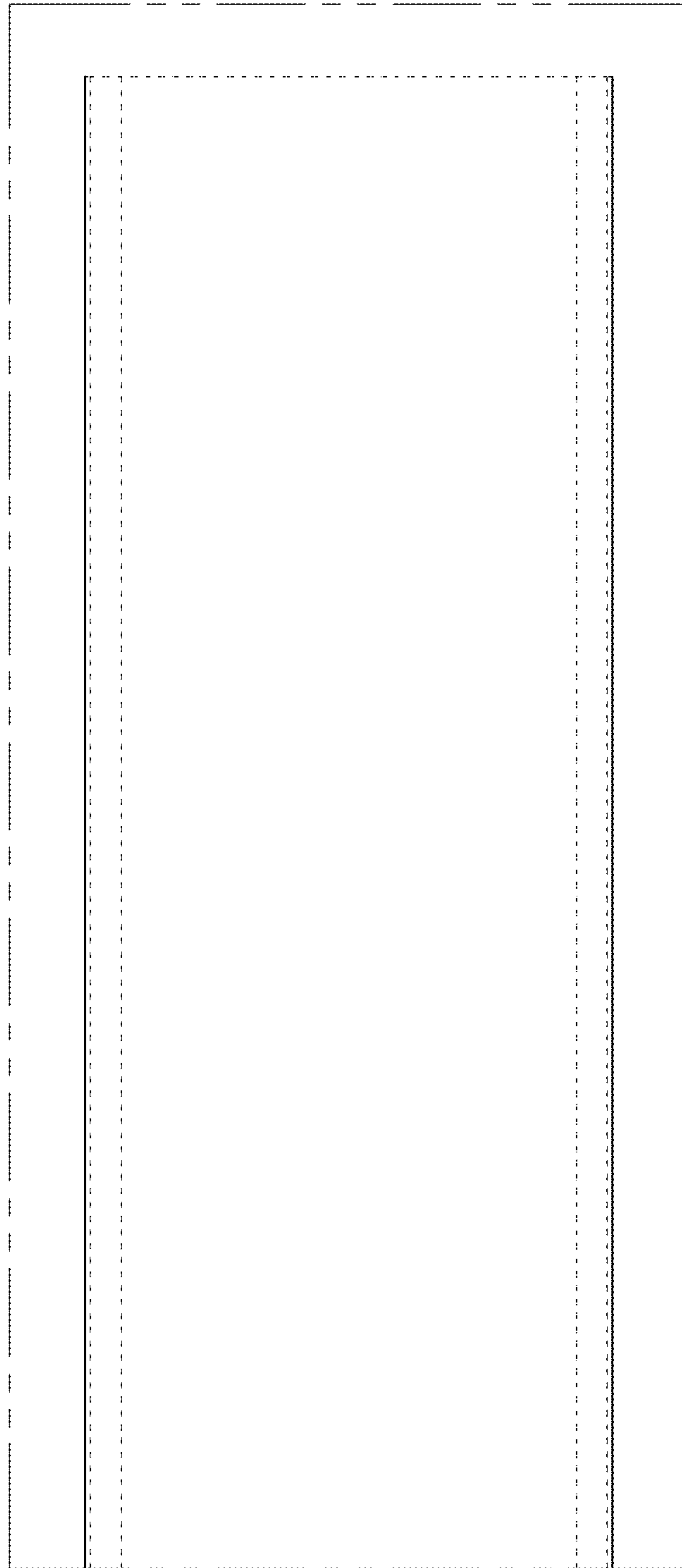

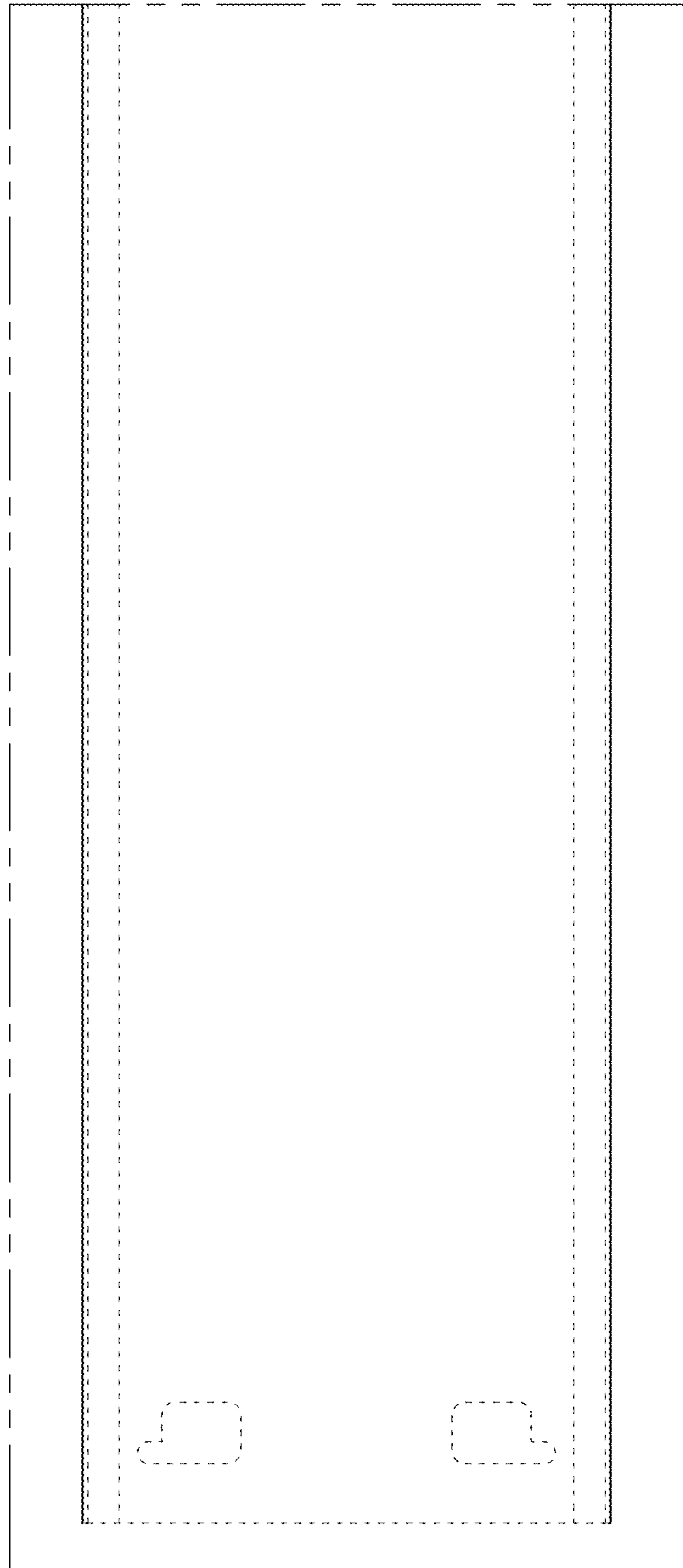

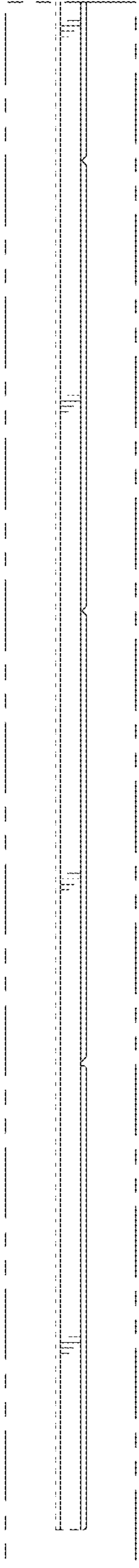

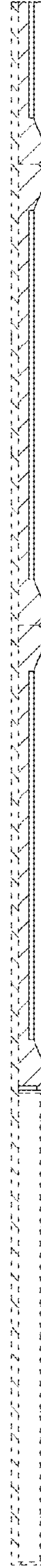

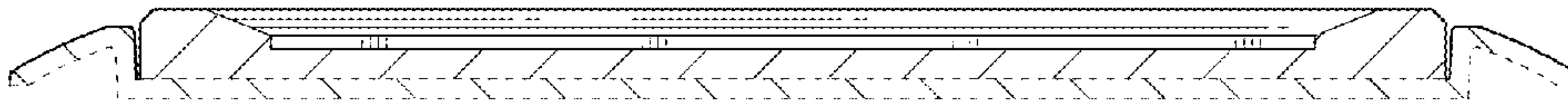

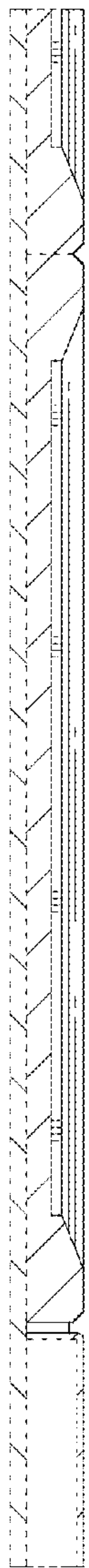
