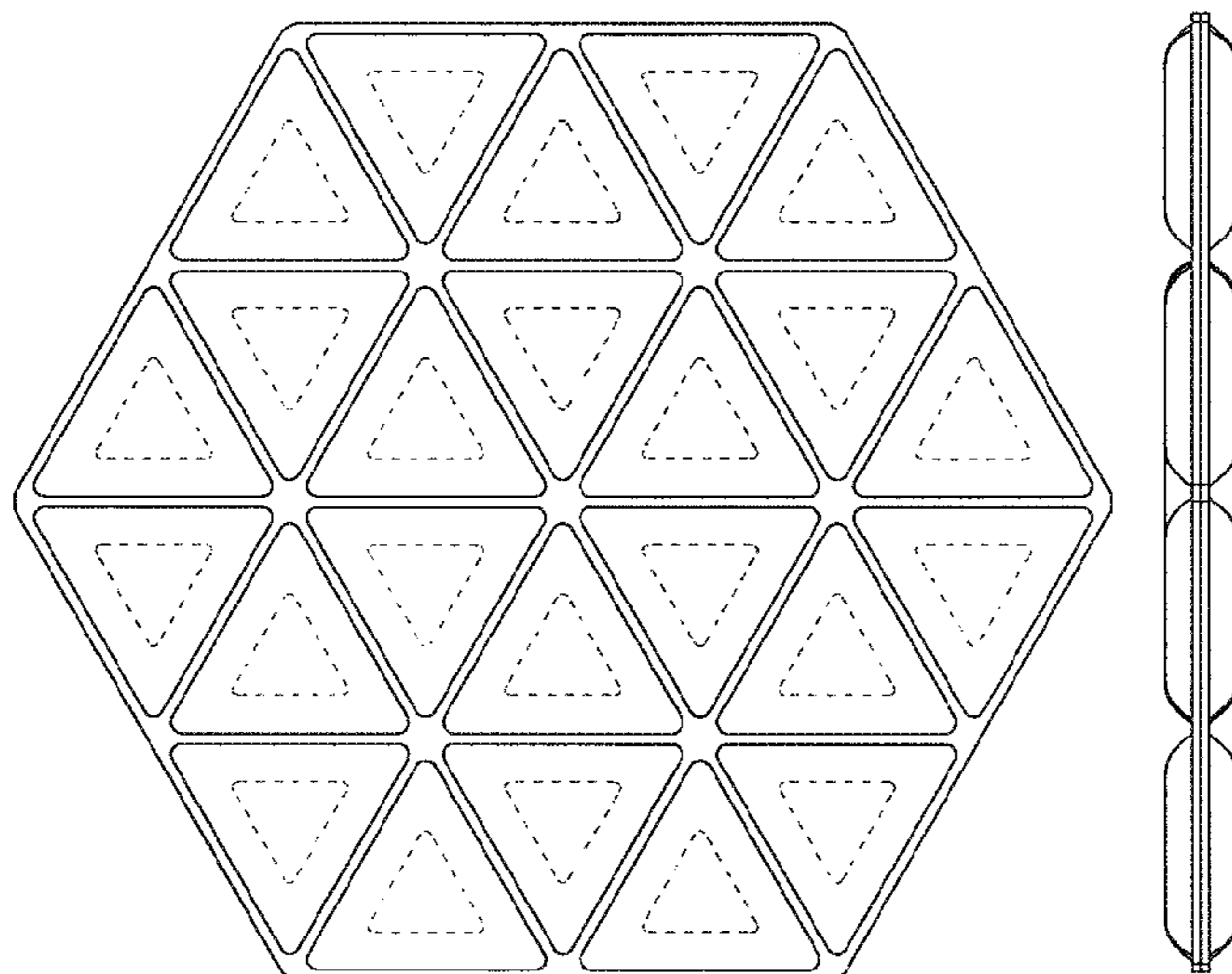
(57) **CLAIM**

I claim the ornamental design for a bag light, as shown and described.

DESCRIPTION

FIG. 1 is a top view of the bag light;
FIG. 2 is a bottom view of FIG. 1;
FIG. 3 shows a front view of FIG. 1;
FIG. 4 shows a left side view of FIG. 1;
FIG. 5 shows a right side view of FIG. 1;
FIG. 6 shows a back view of FIG. 1; and,
FIG. 7 shows an enlargement of an area of FIG. 5.

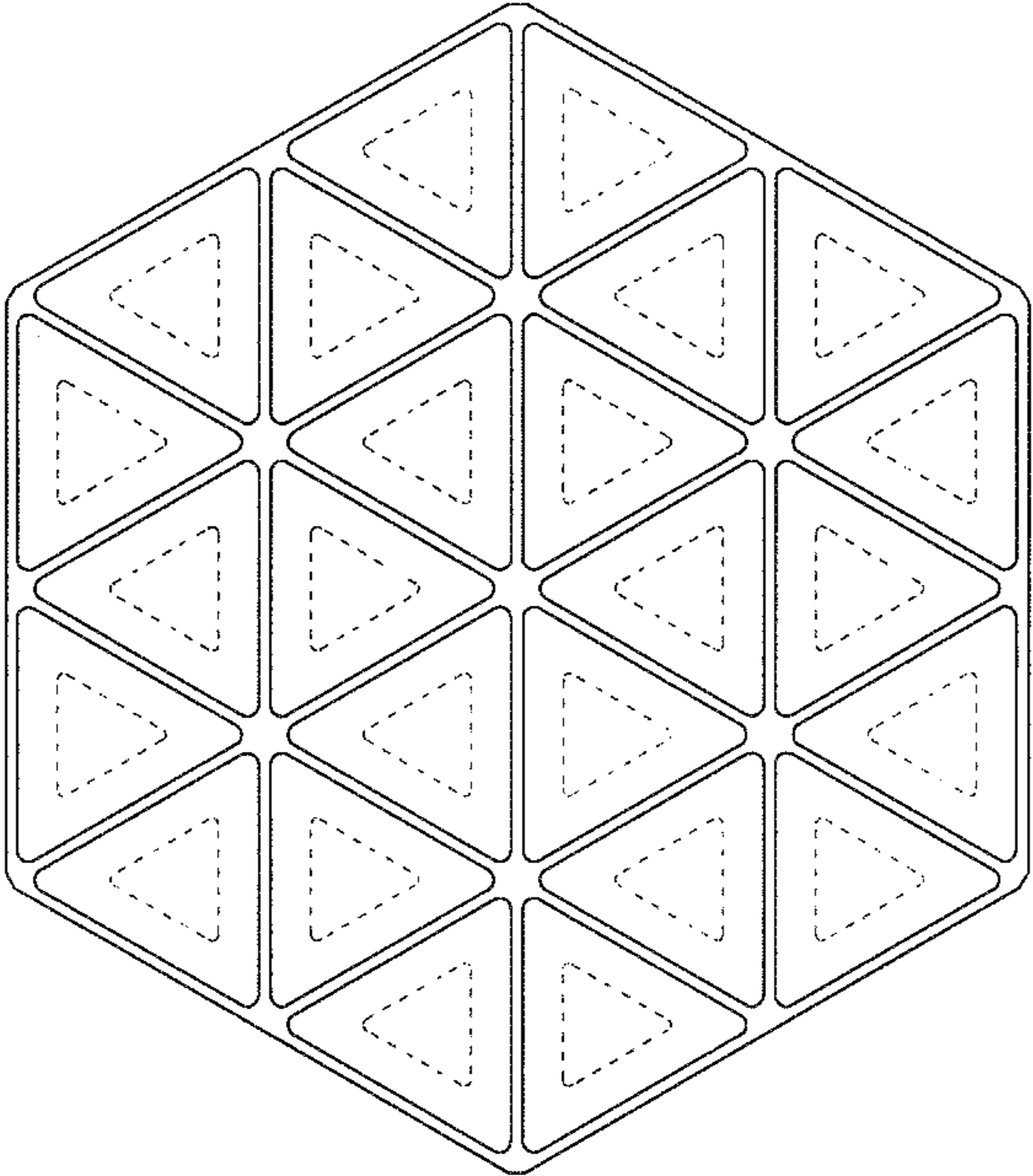

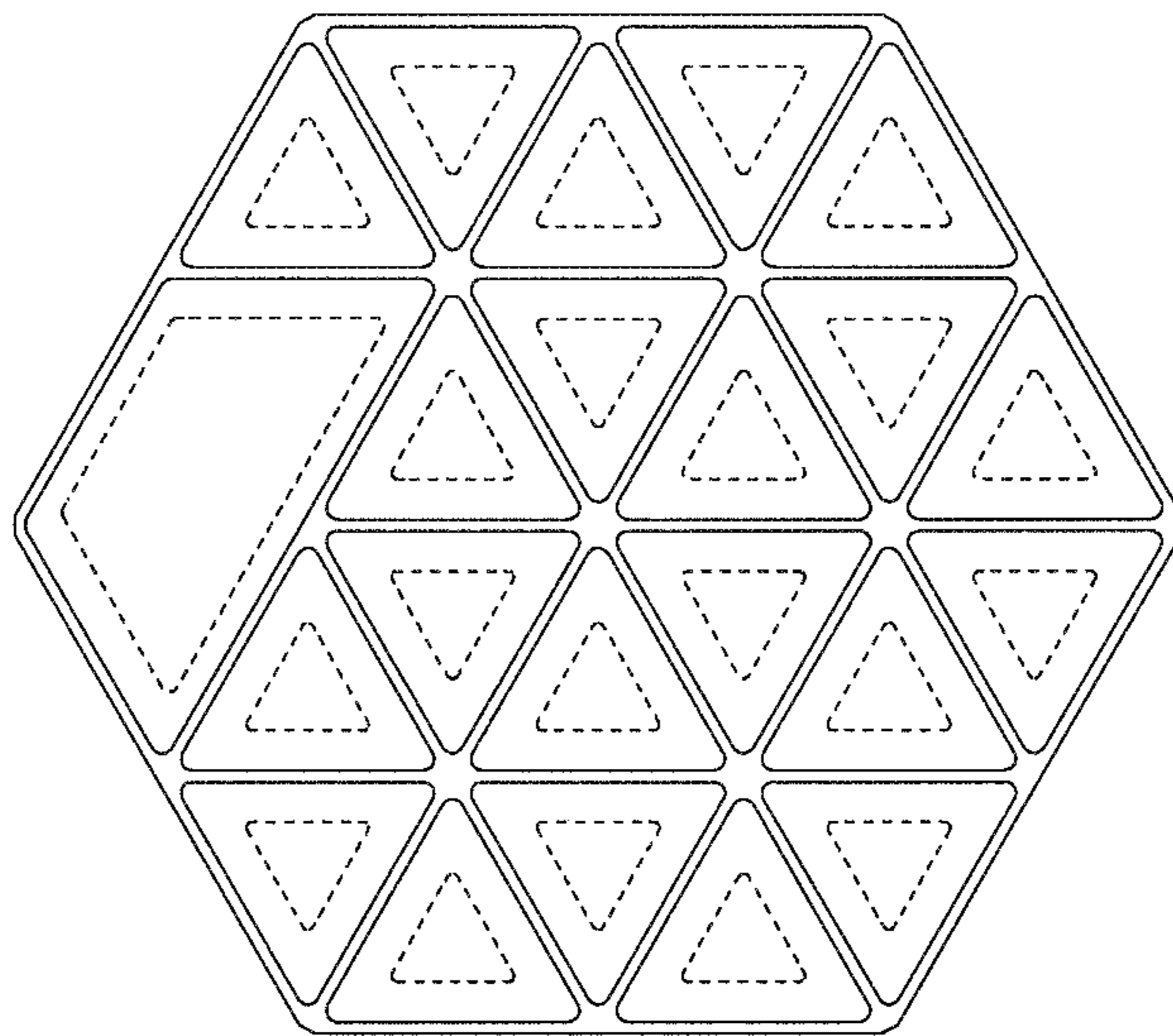
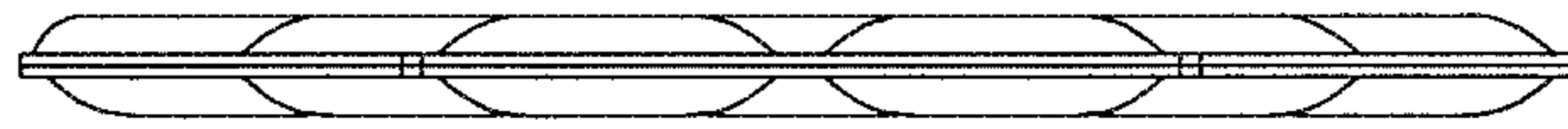
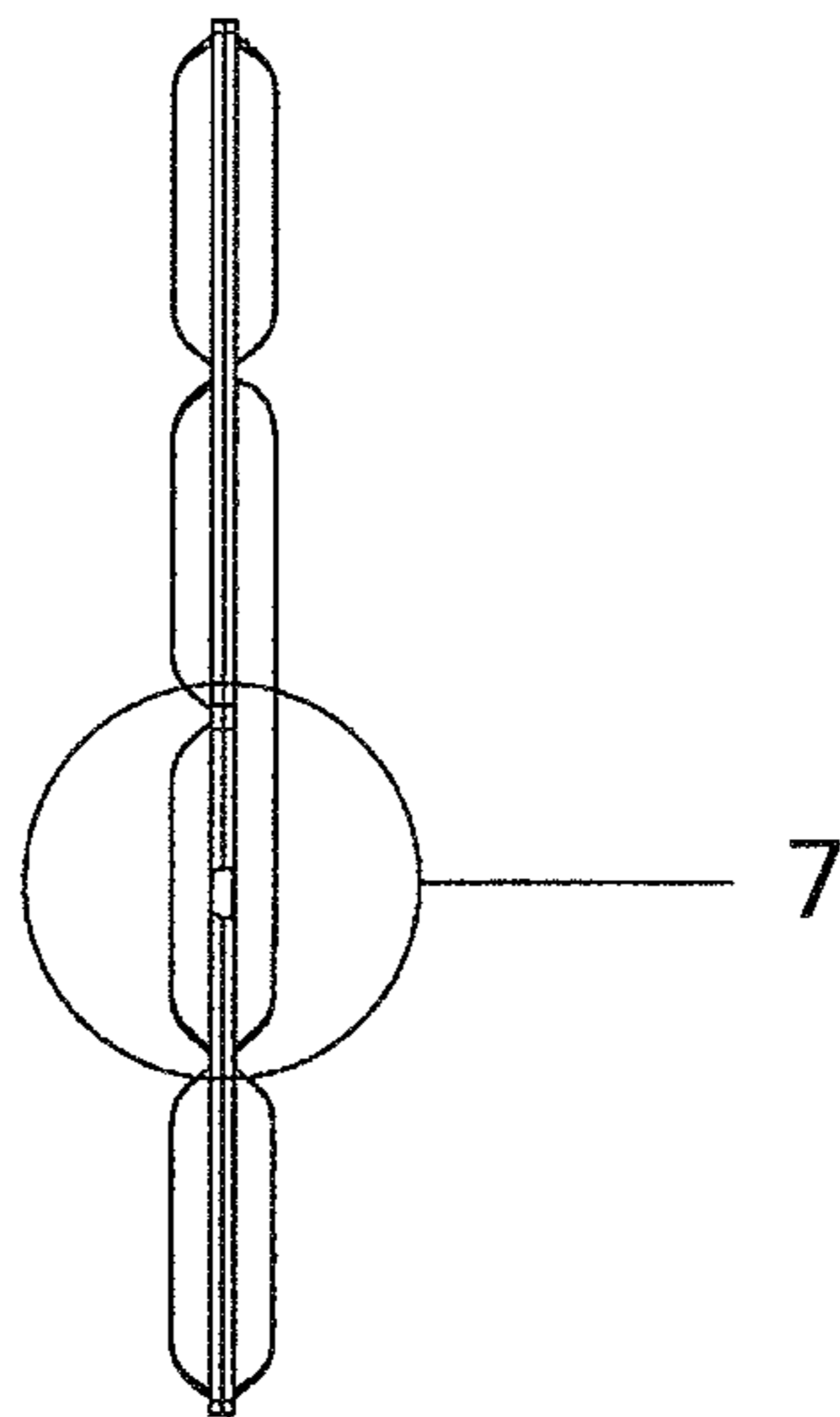

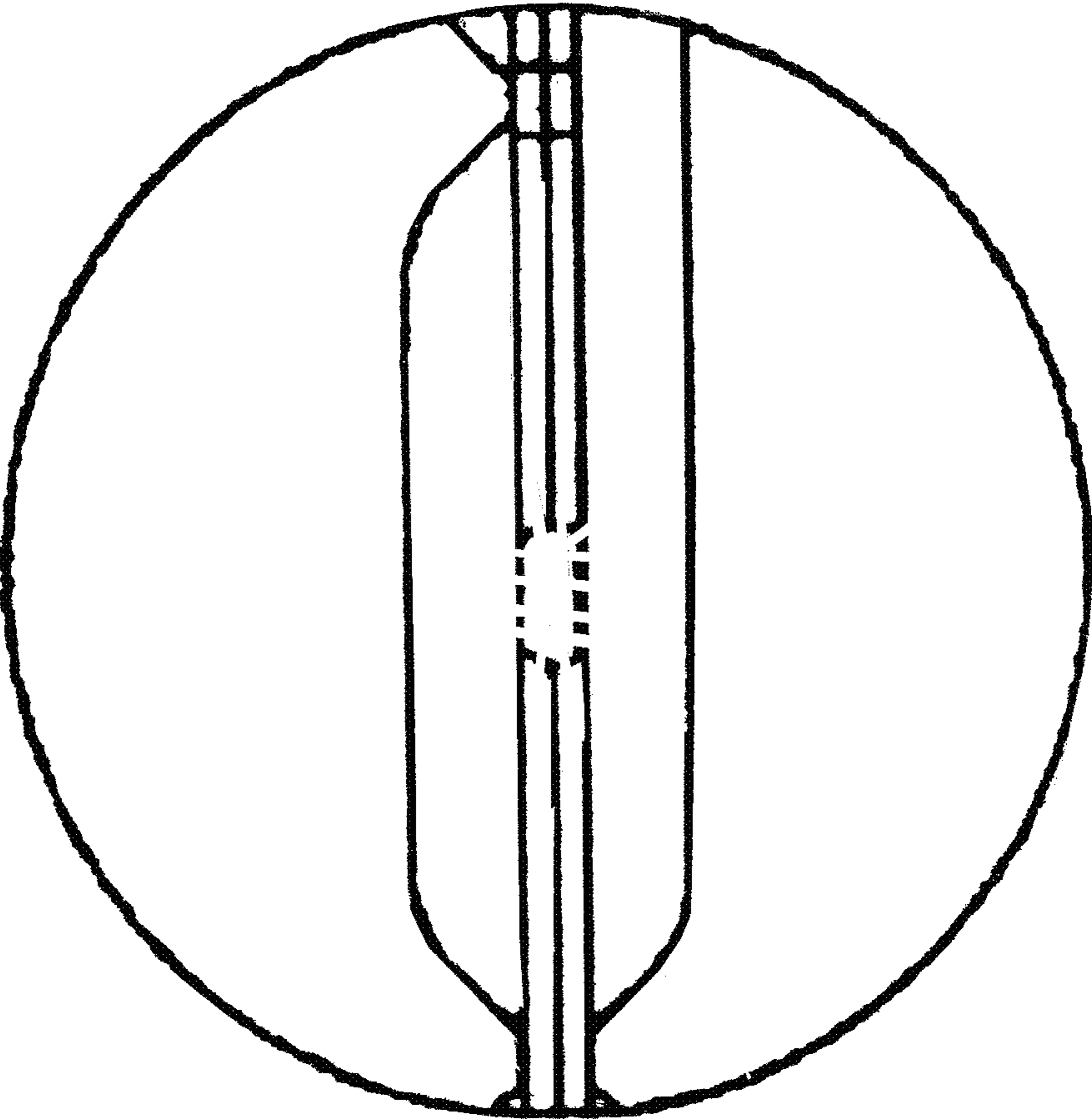
